(57) **CLAIM**

I claim the ornamental design for a rawhide pet chew, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view looking downwardly at the top, front, and right end of the rawhide pet chew of the present invention;

FIG. 2 is a top plan view of the rawhide pet chew of FIG. 1;

FIG. 3 is a front elevation of the rawhide pet chew of FIG. 1;

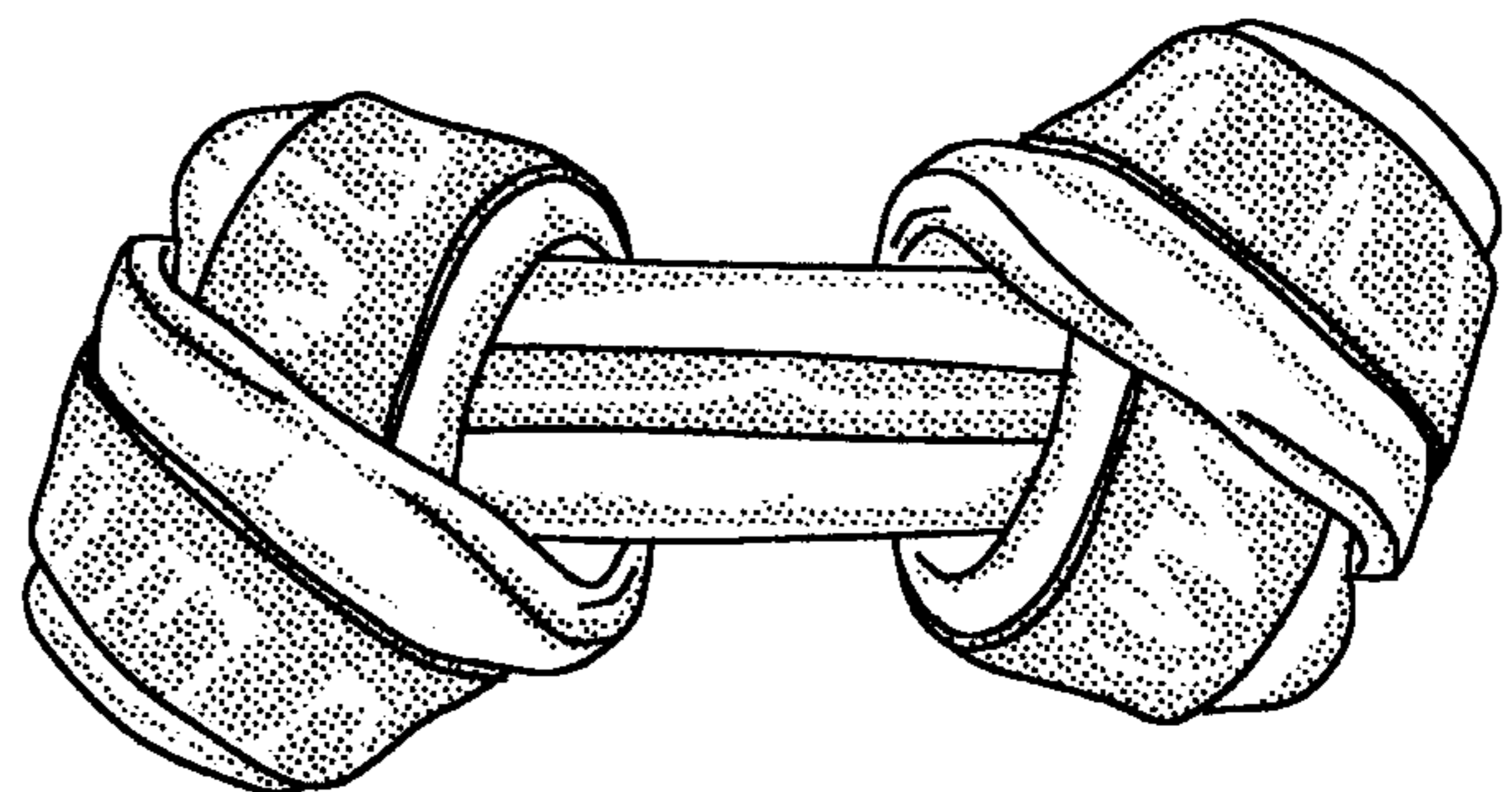
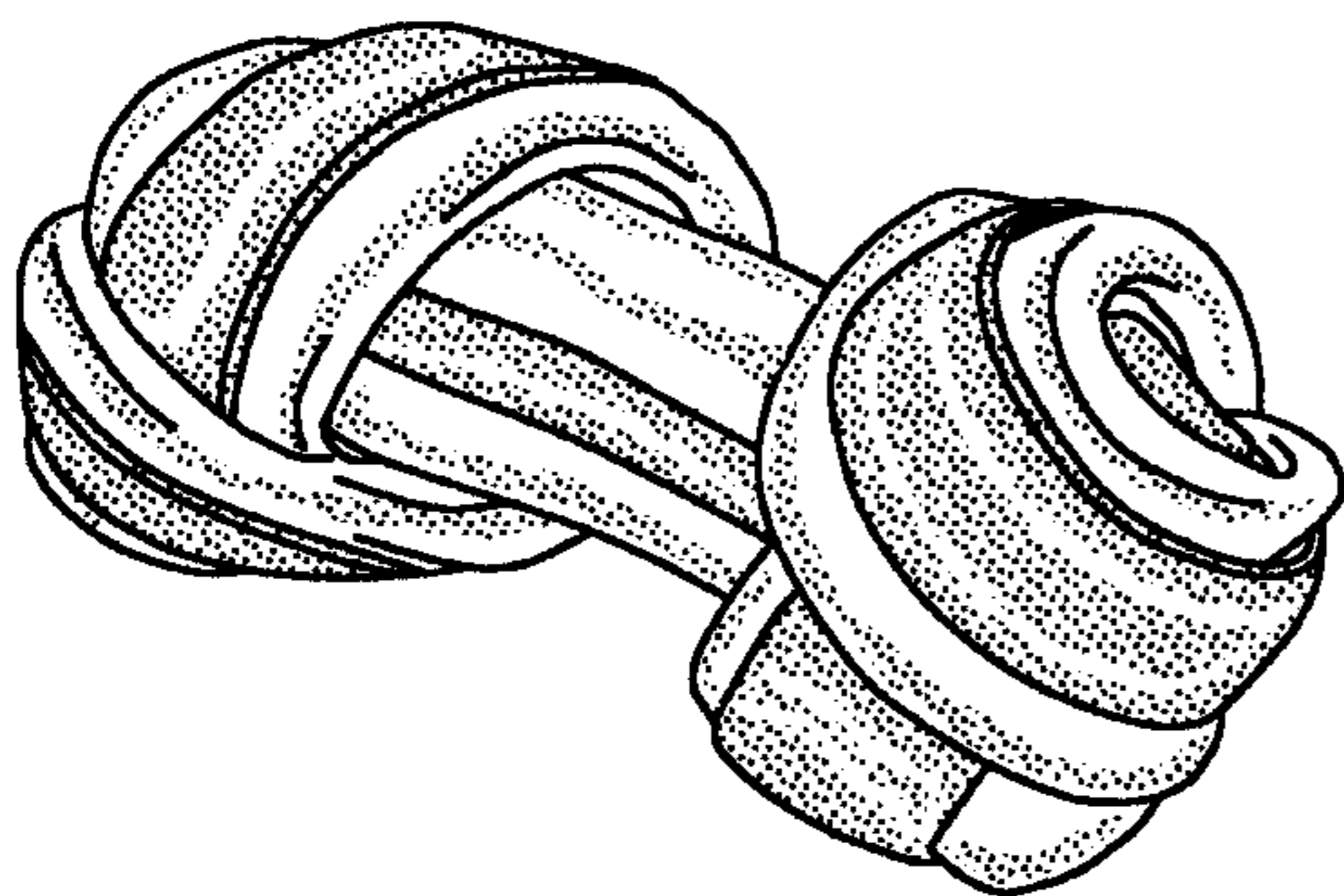
FIG. 4 is a bottom plan view of the rawhide pet chew of FIG. 1;

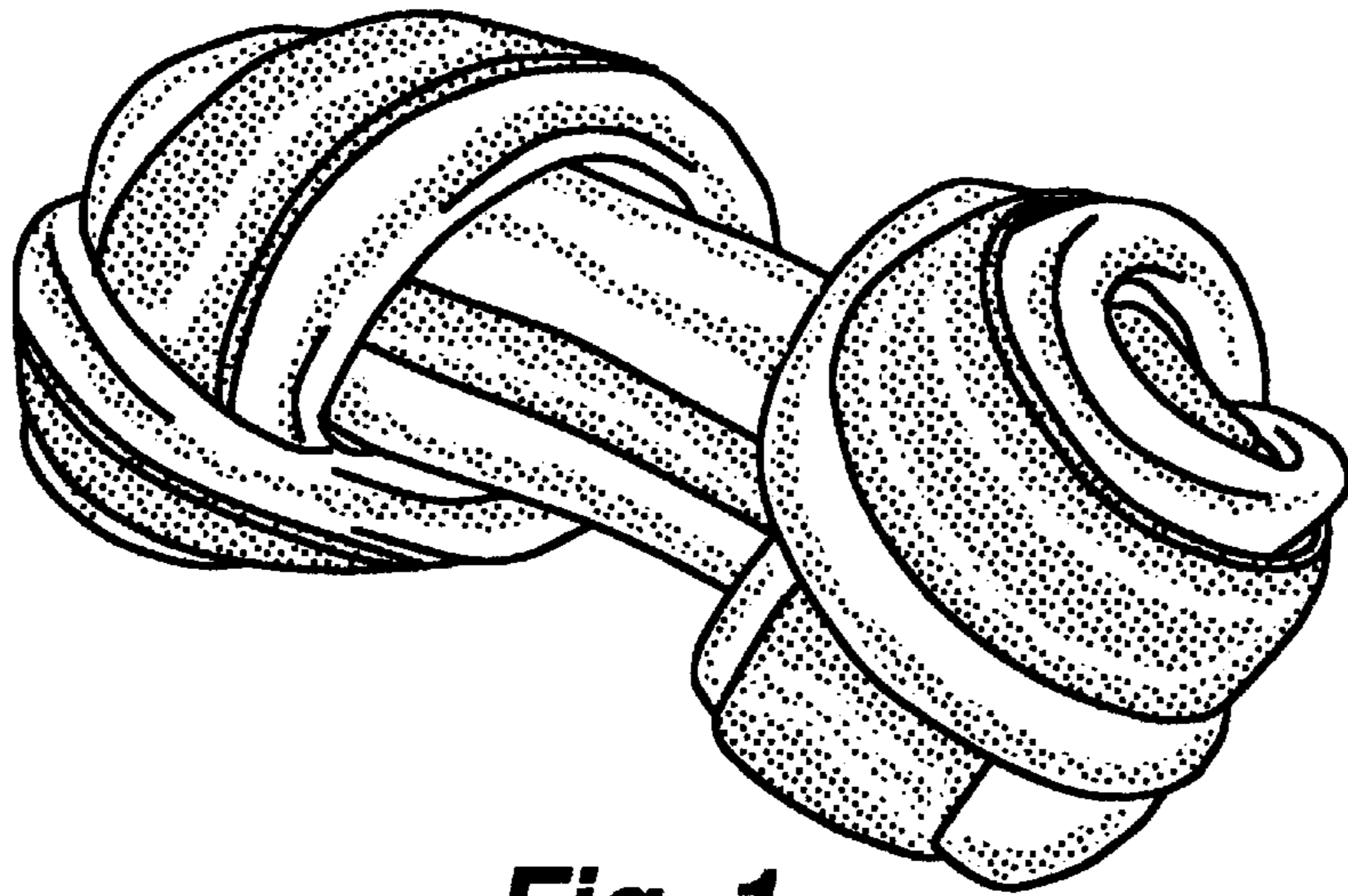

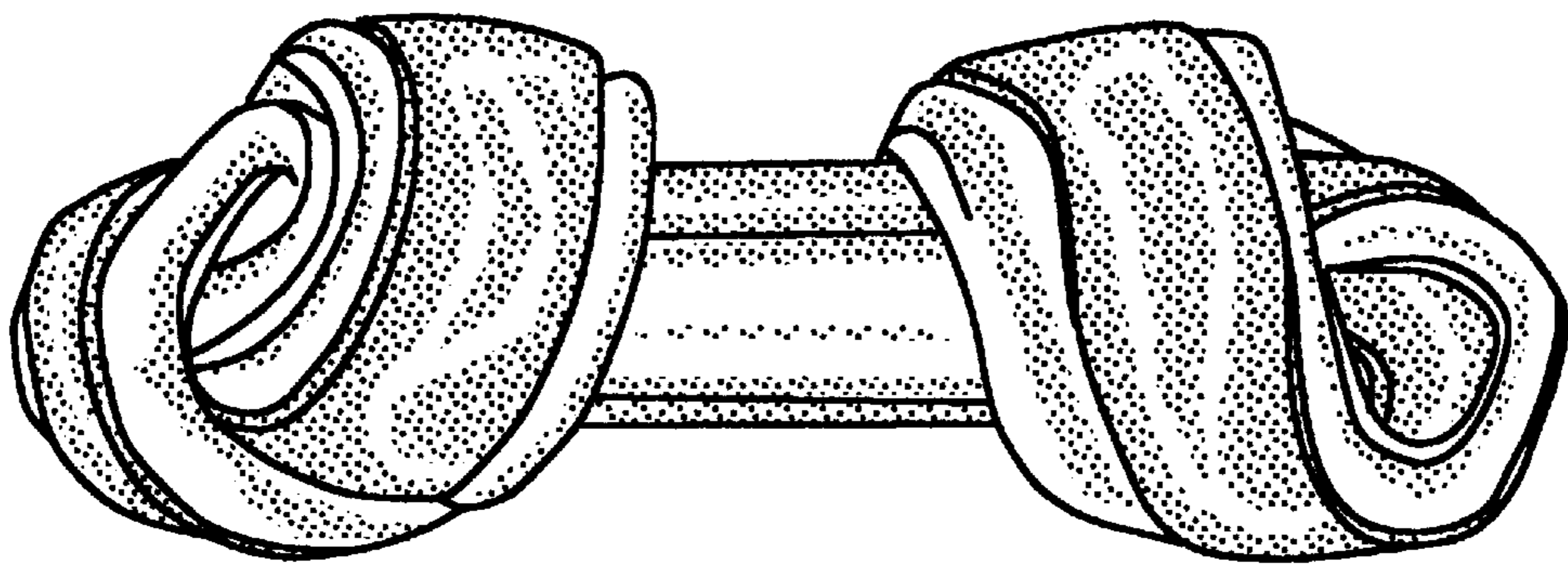

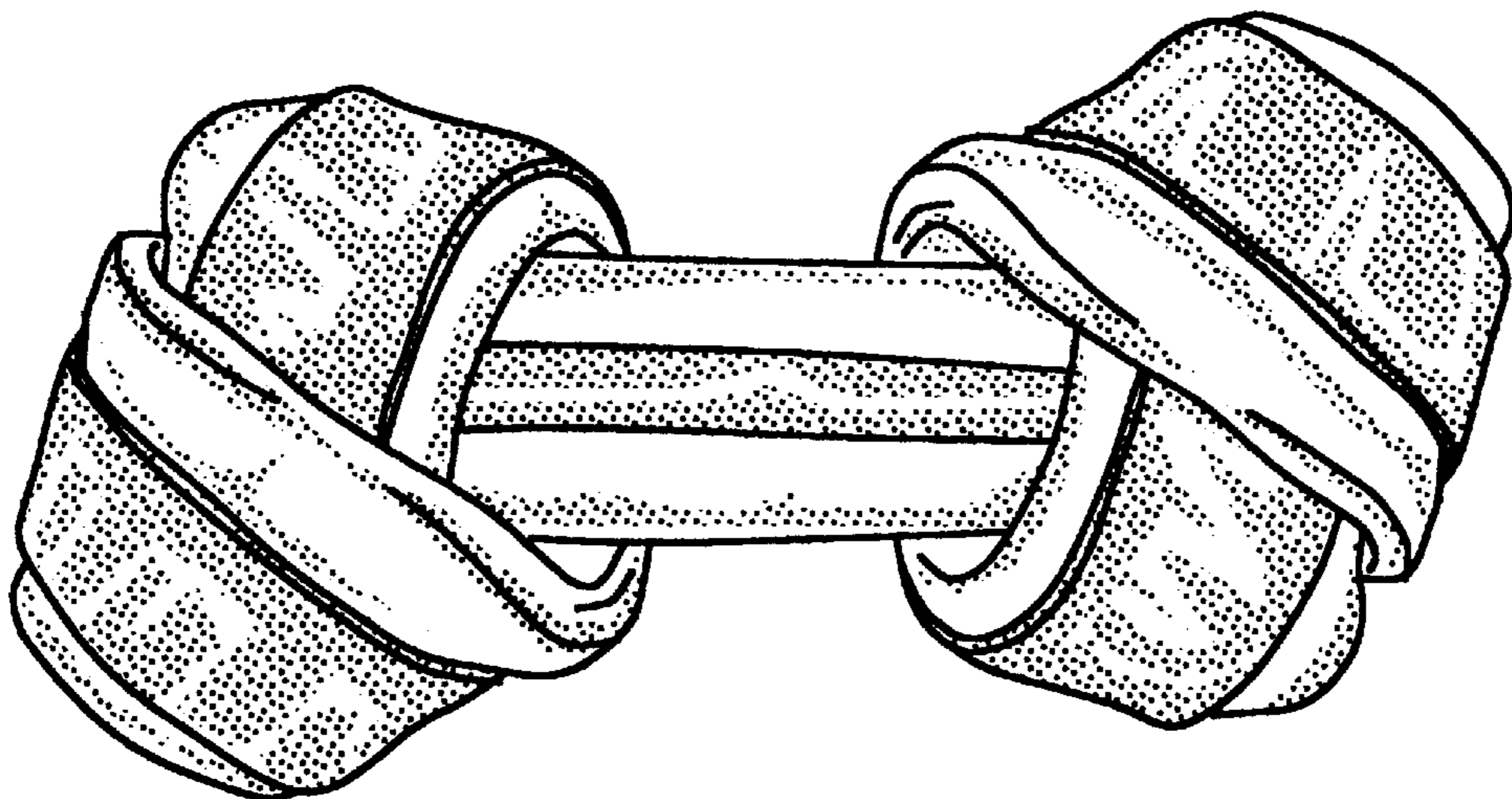

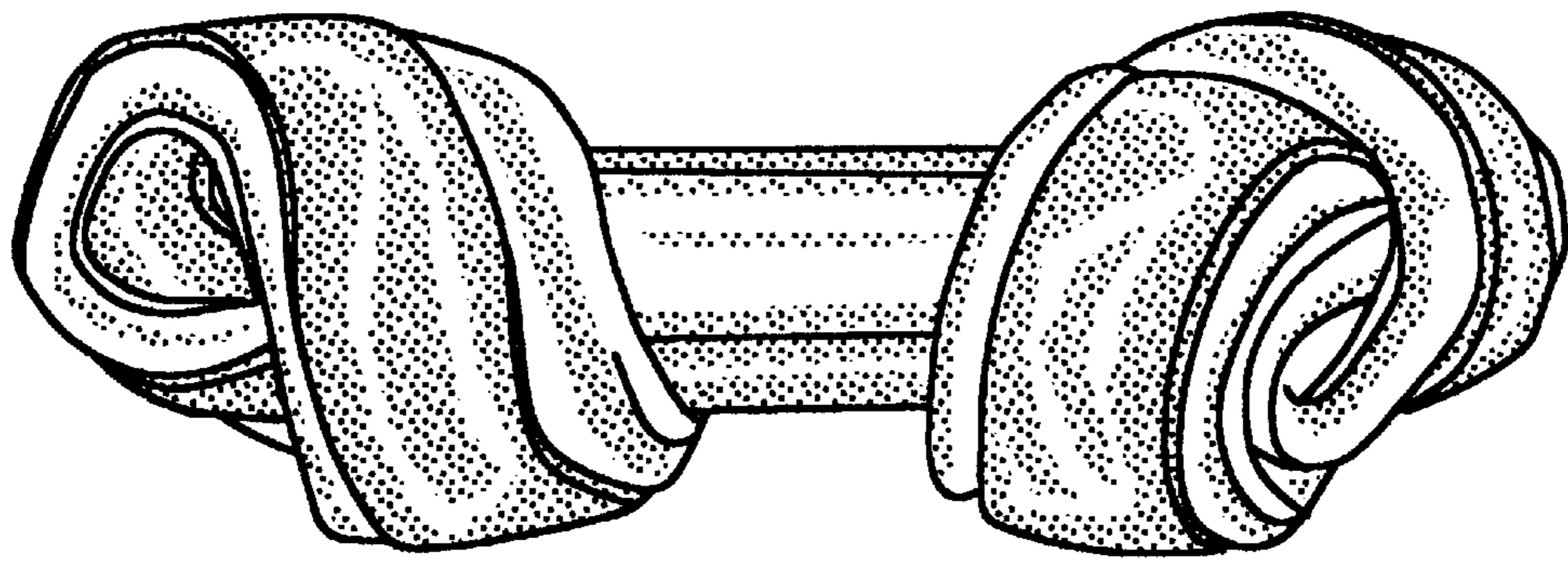

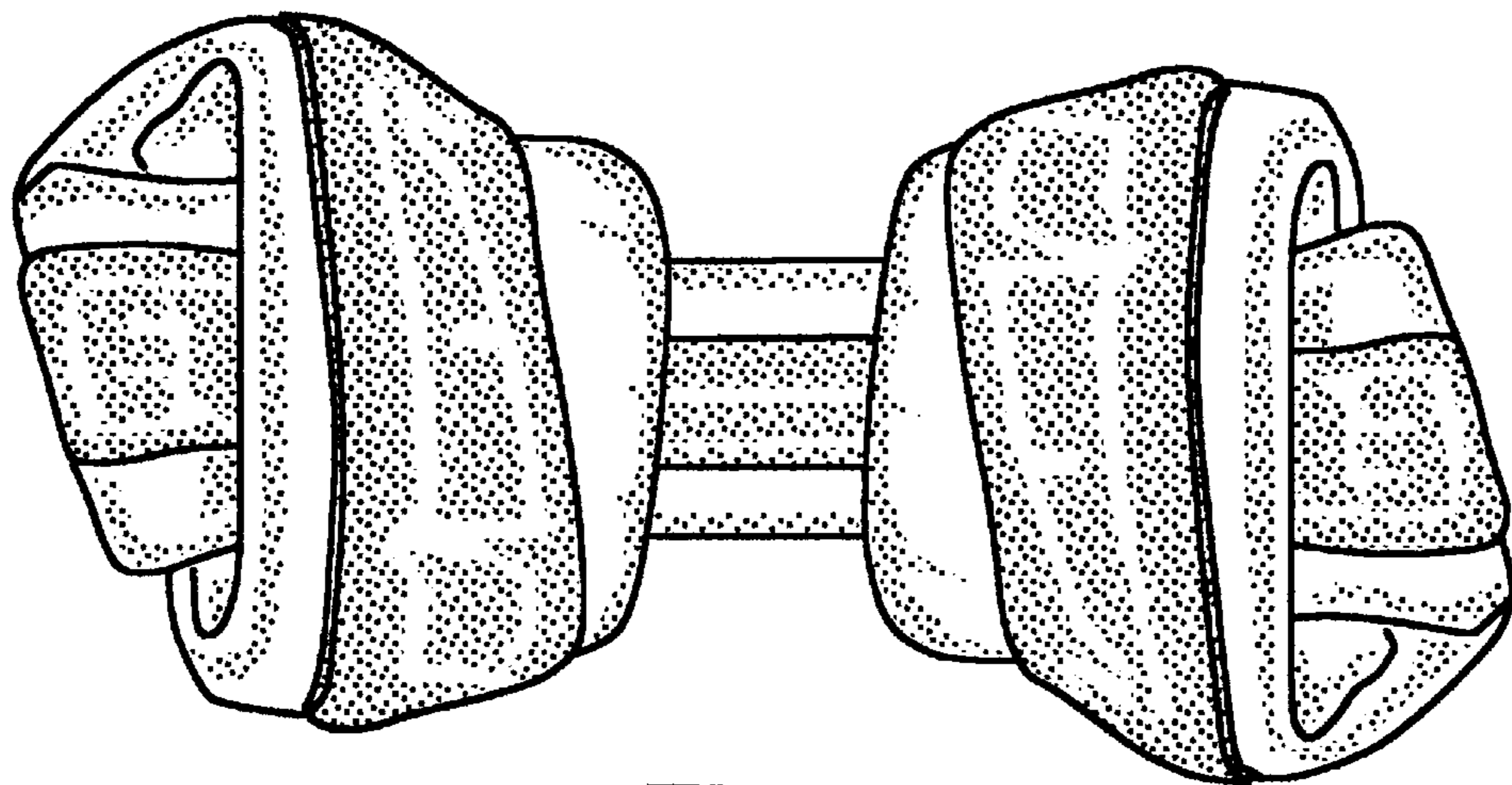

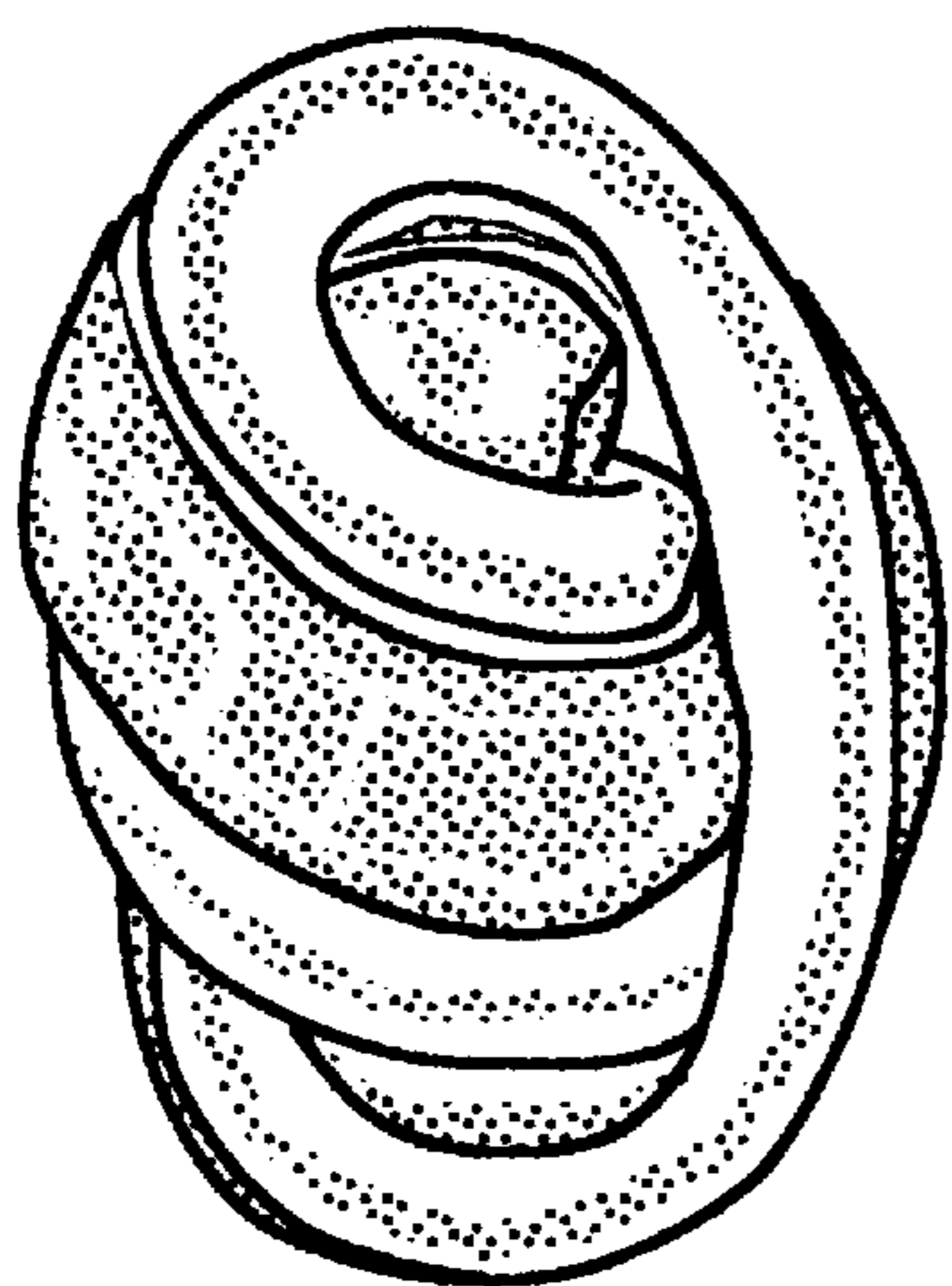

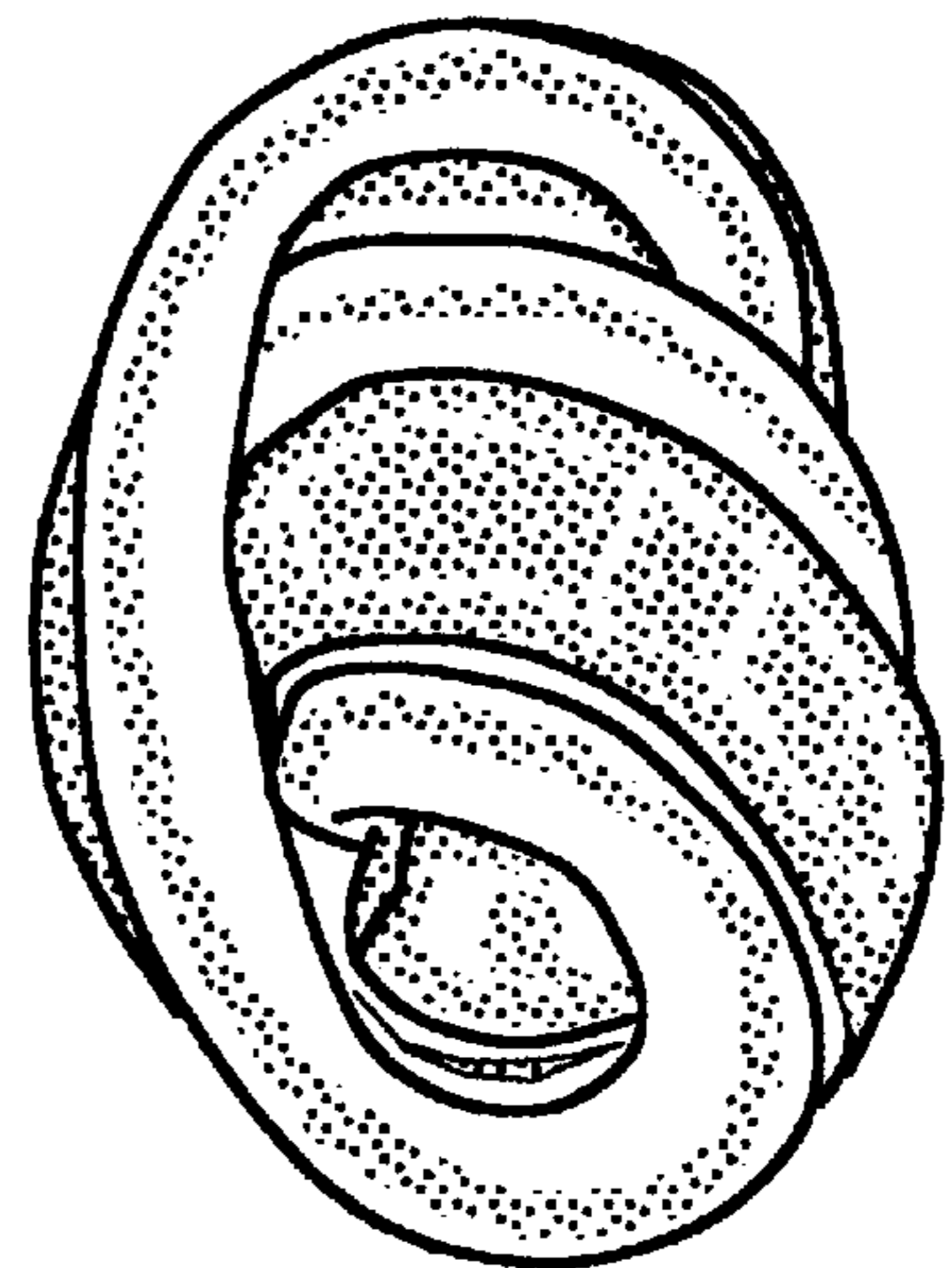
