The design for a shopping cart child seat cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shopping cart child seat cover showing my new design;

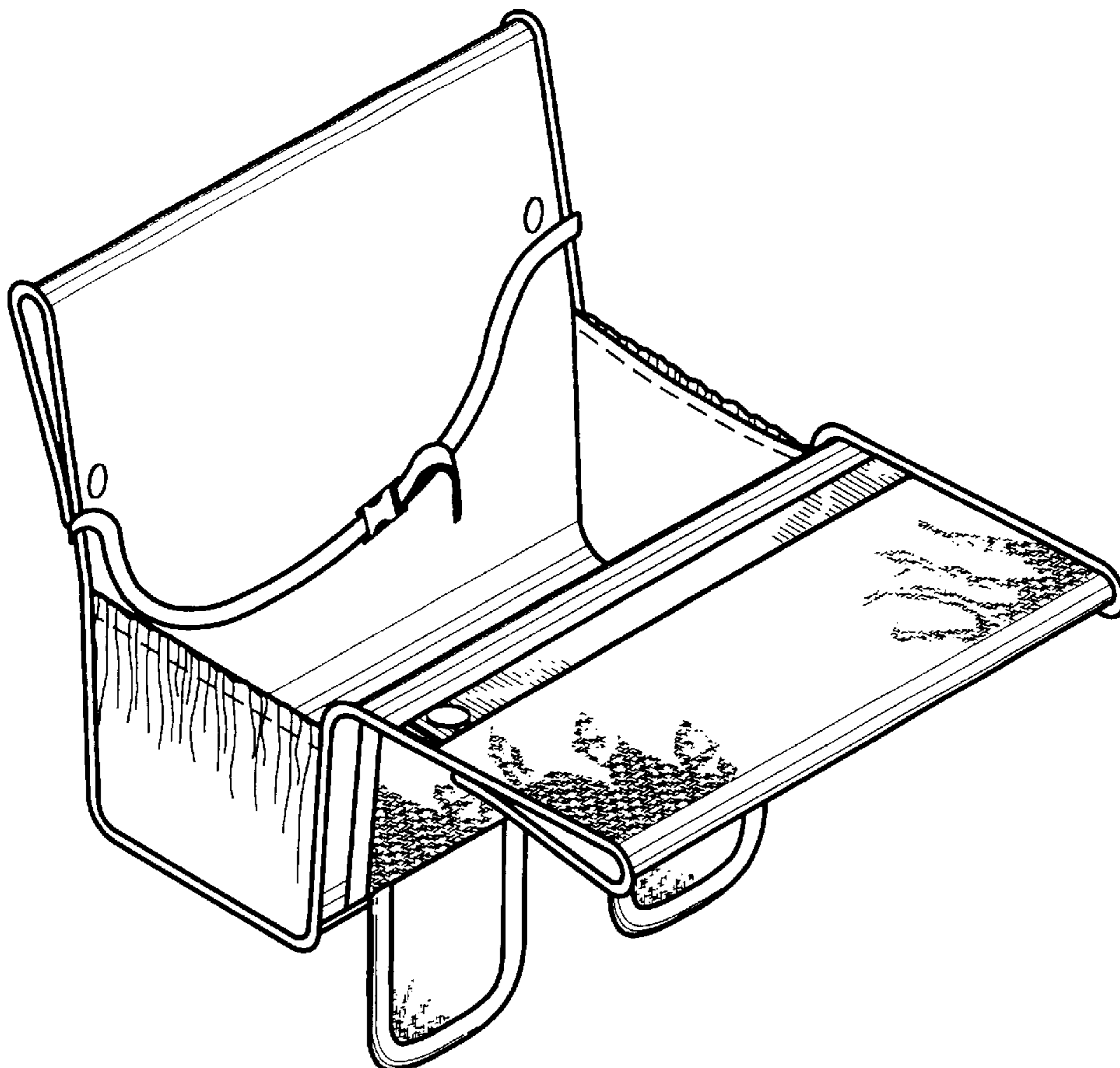

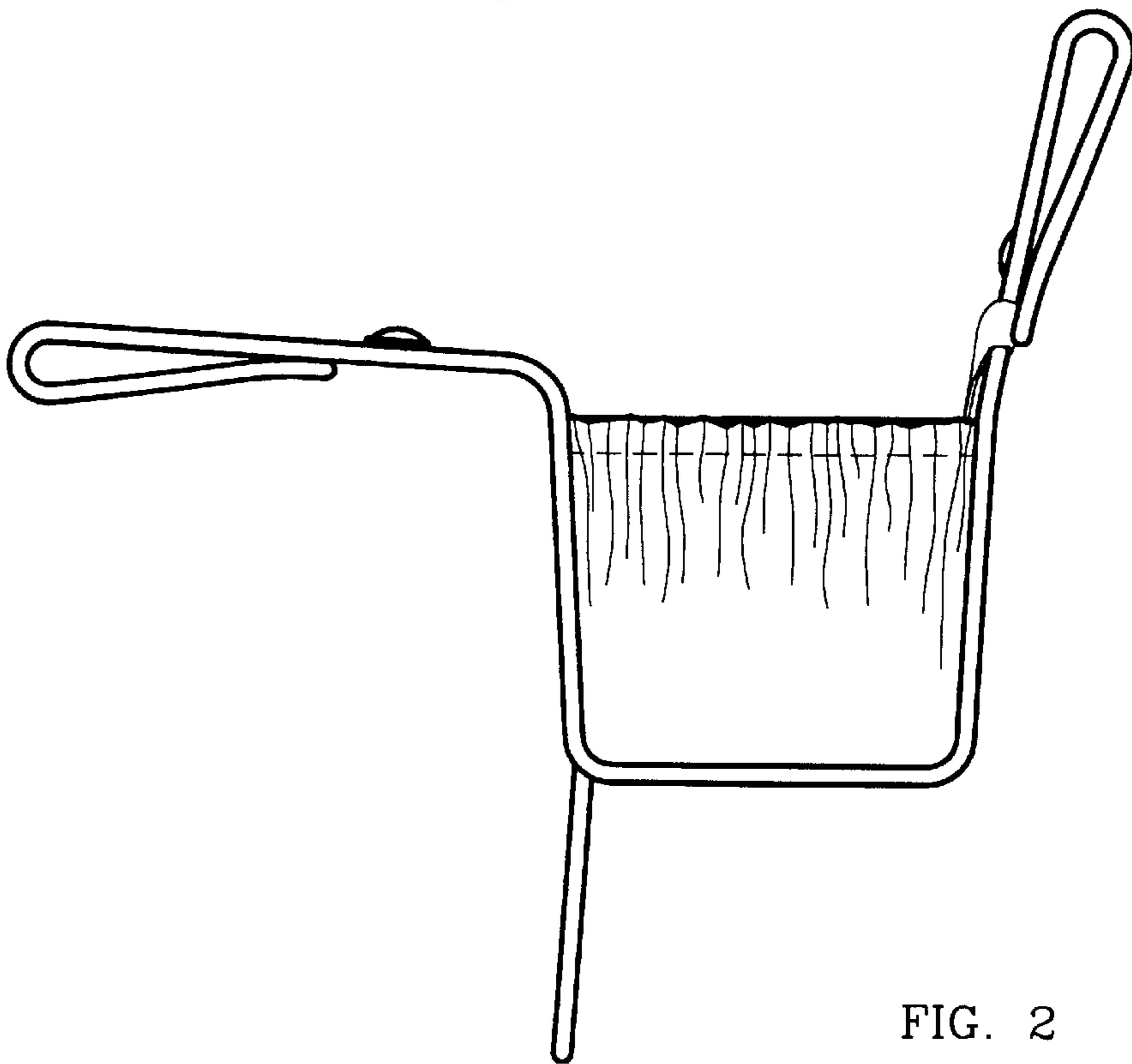
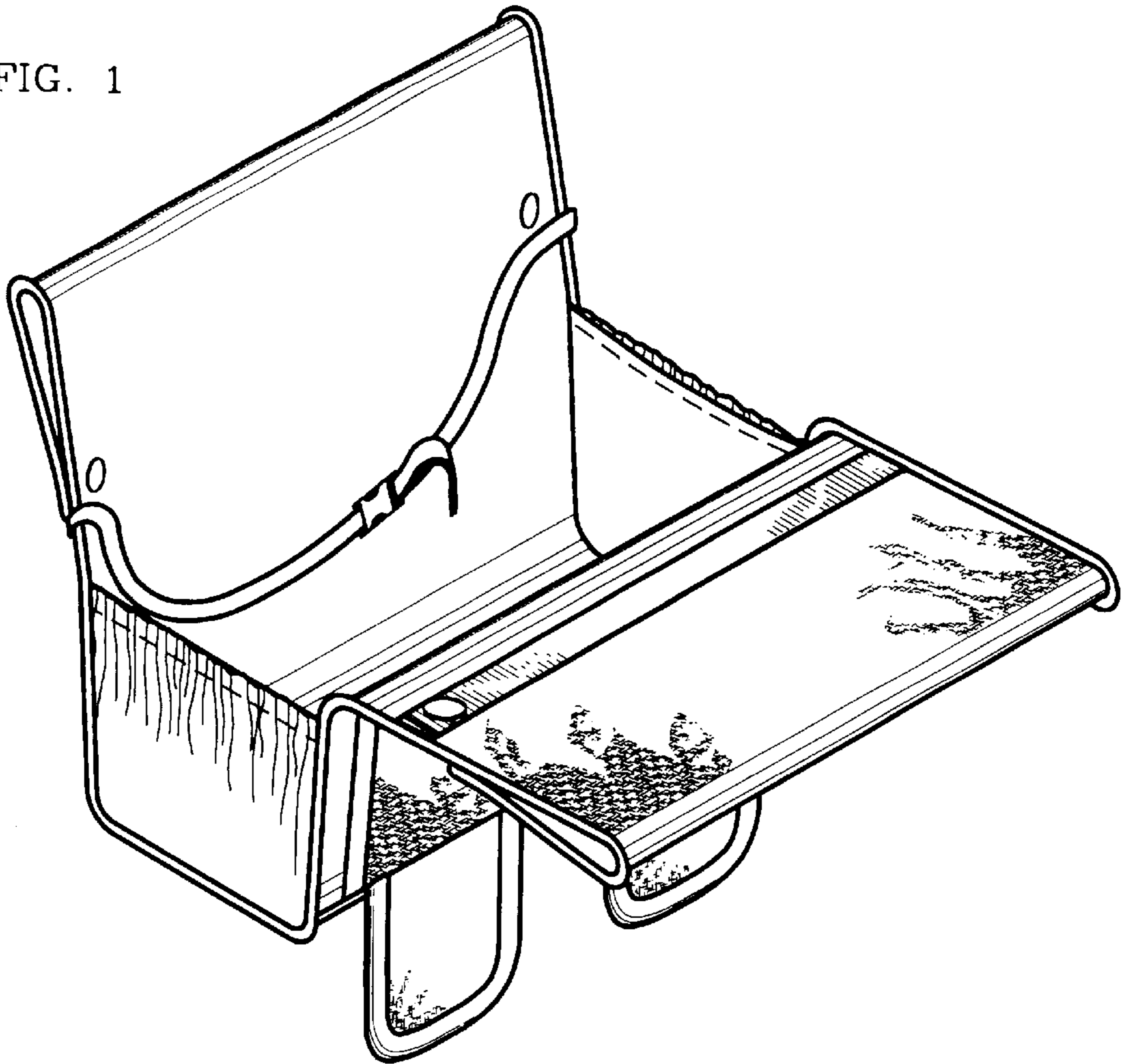

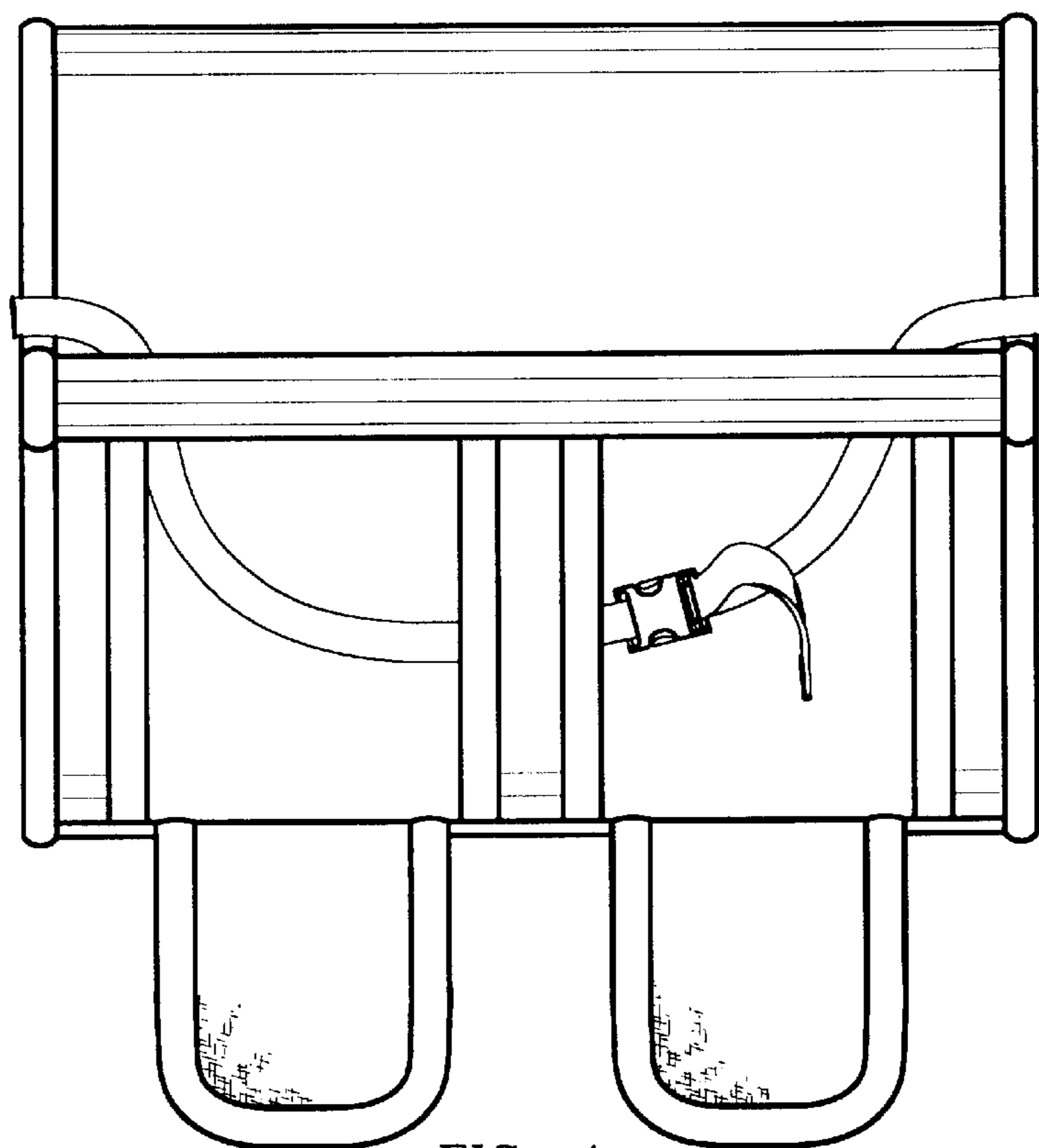
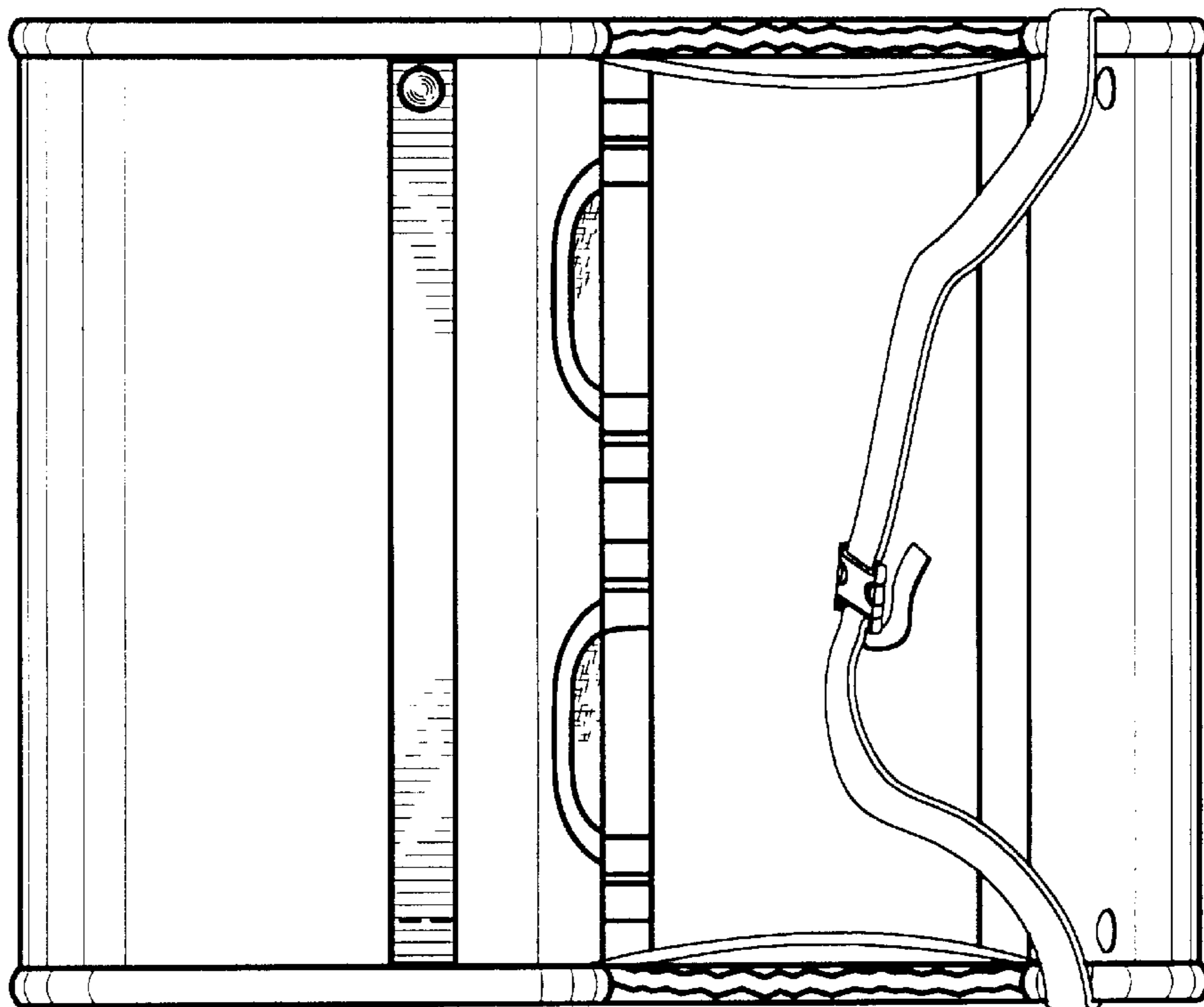

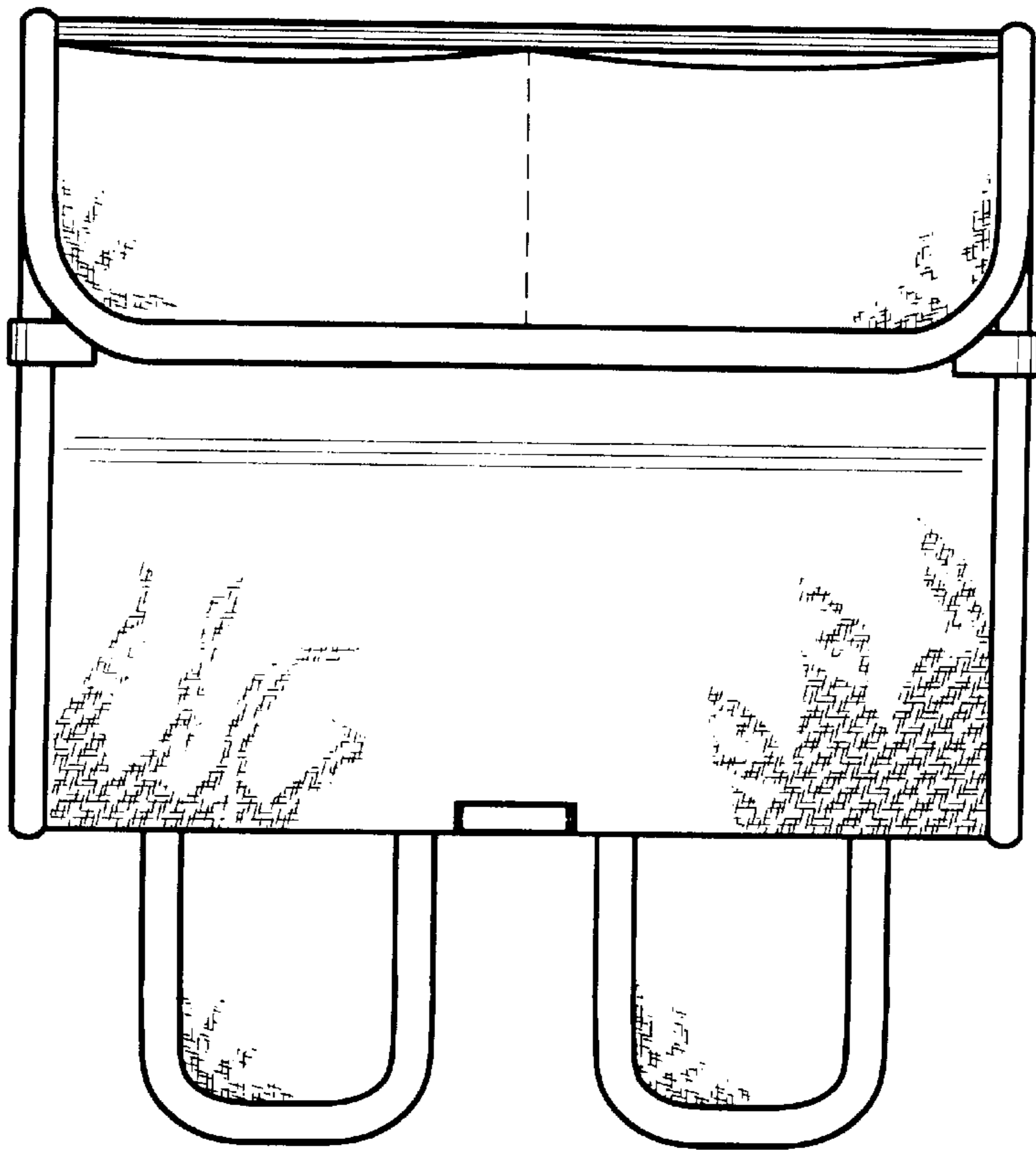

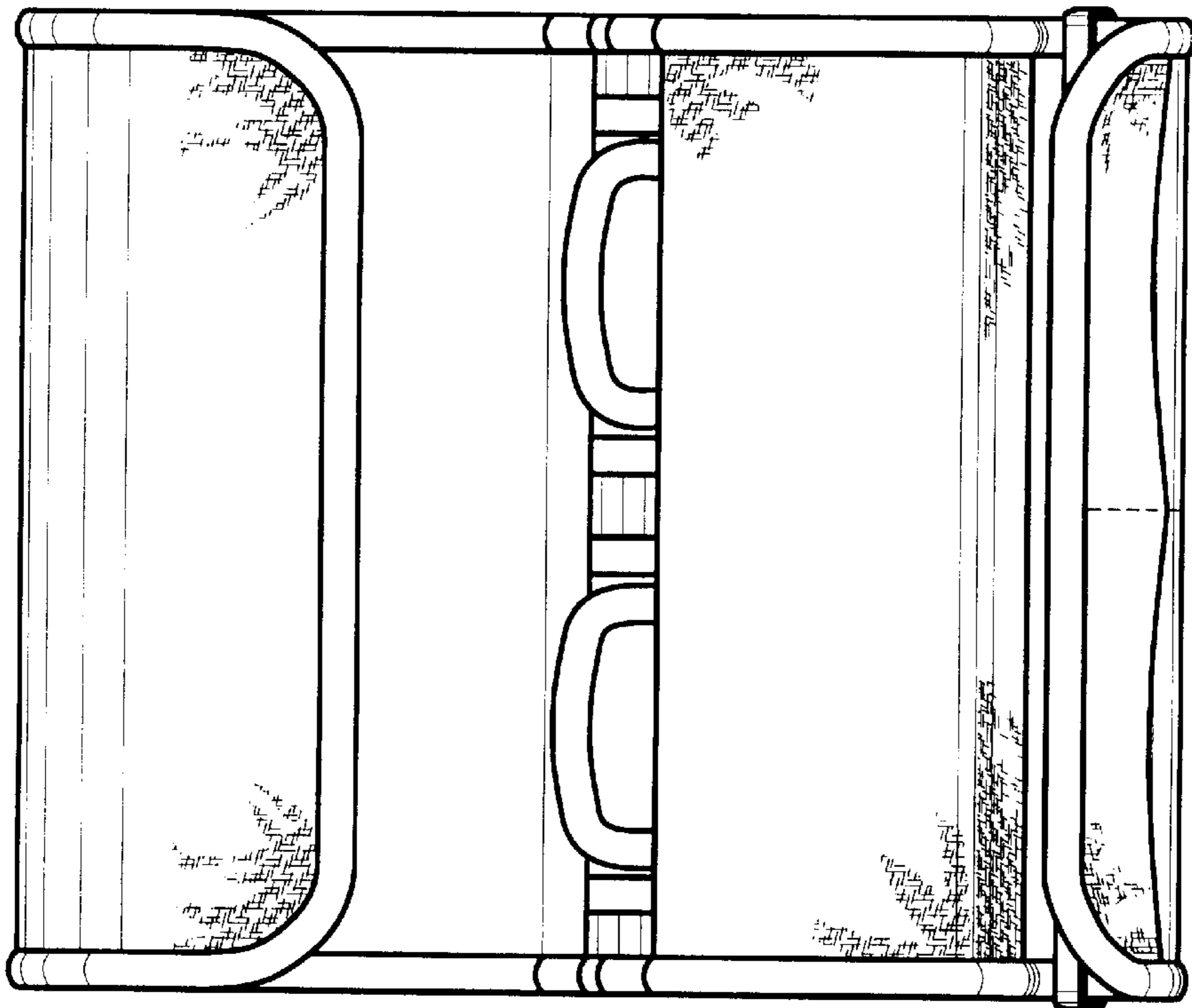
