FIG. 3 is an opposite side view of my tool box simulating dresser shown in FIG. 1;

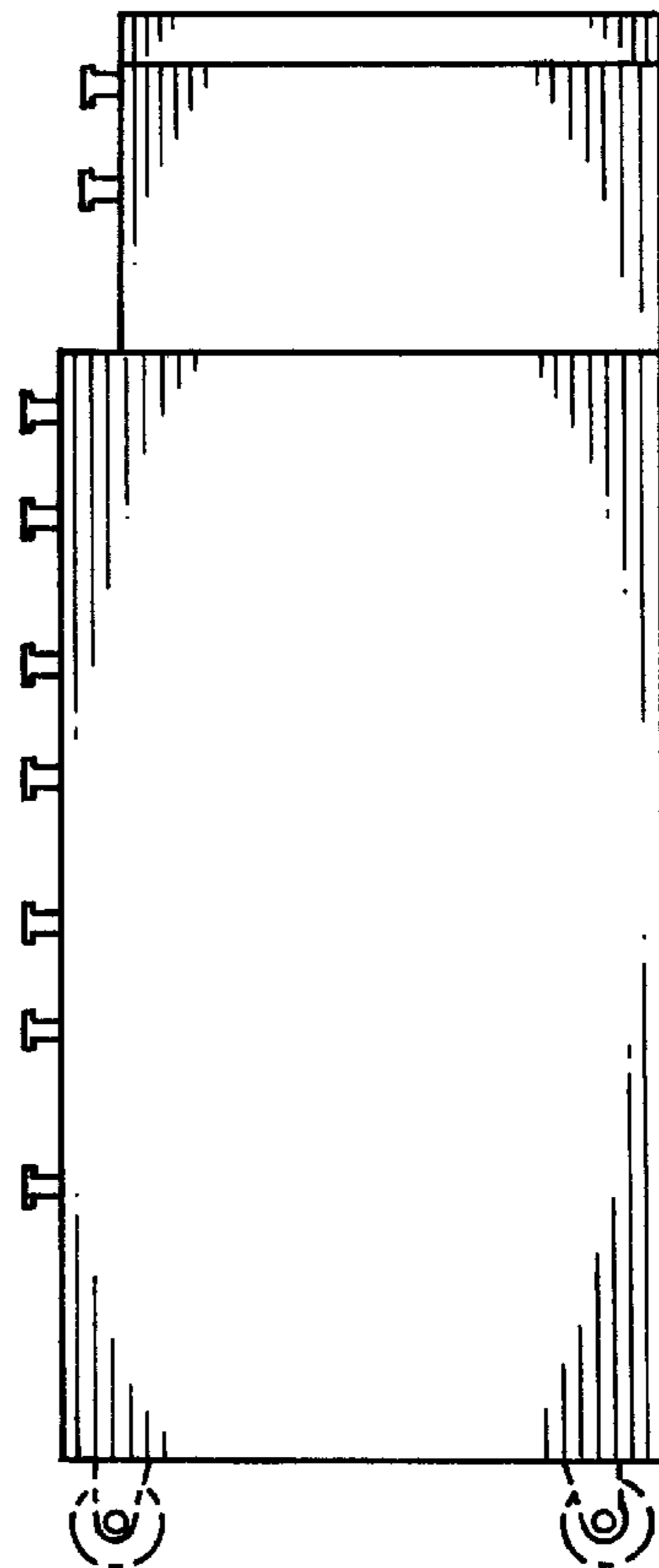
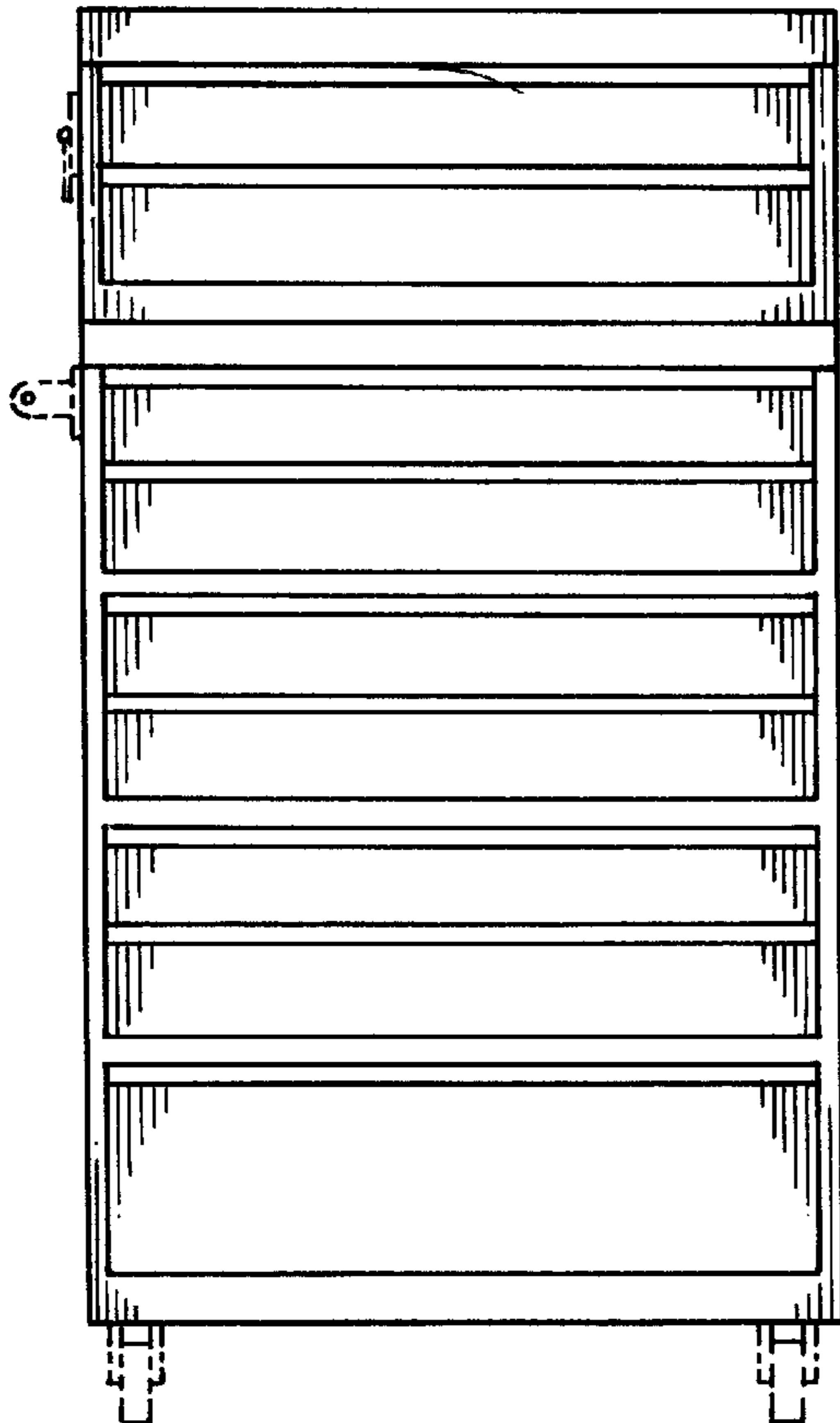
FIG. 4 is a top plan view of my tool box simulating dresser shown in FIG. 1;

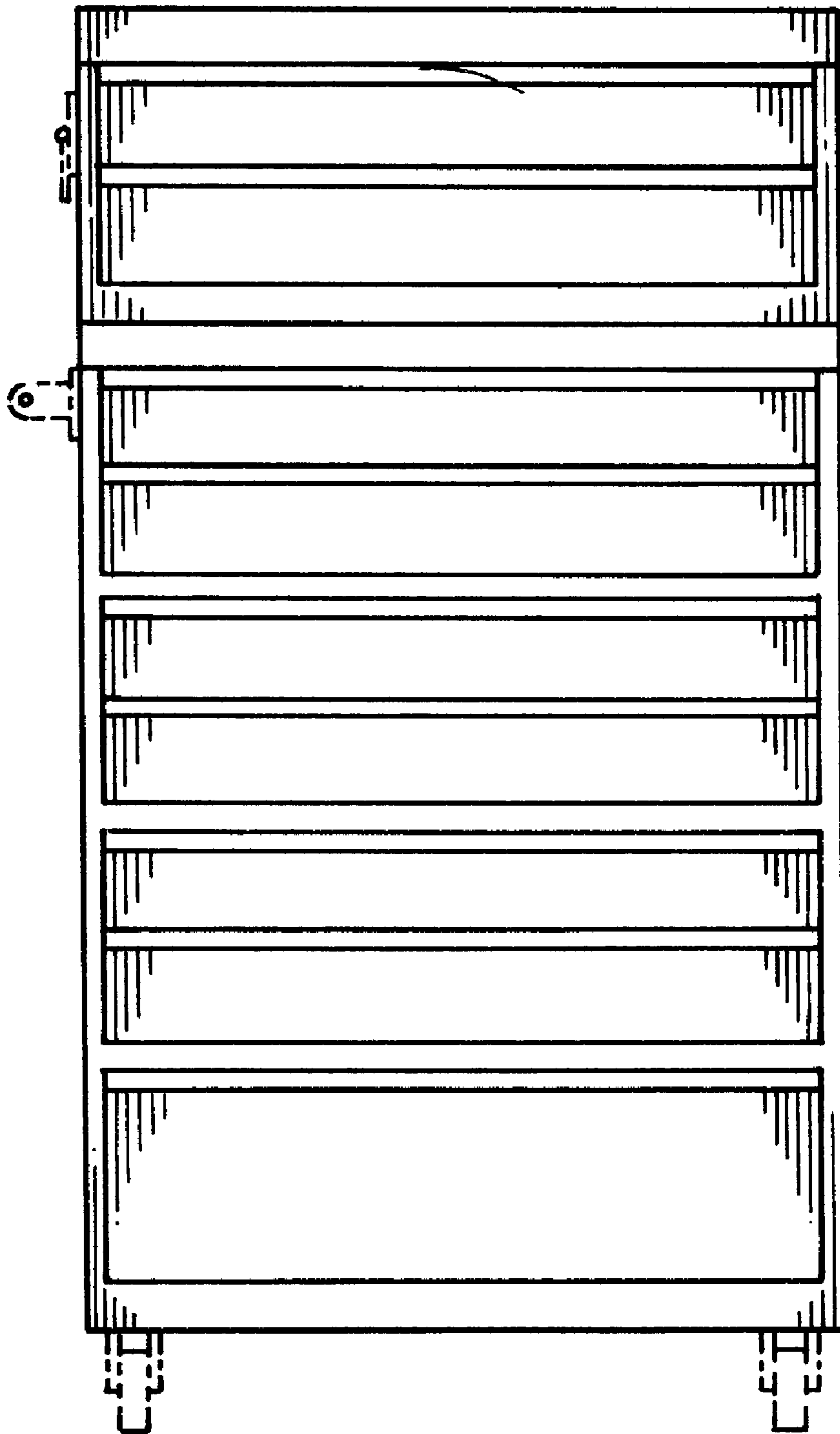
FIG. 5 is a bottom plan view of tool box simulating dresser shown in FIG. 1; and,

FIG. 6 is a rear view of my tool box simulating dresser shown in FIG. 1.

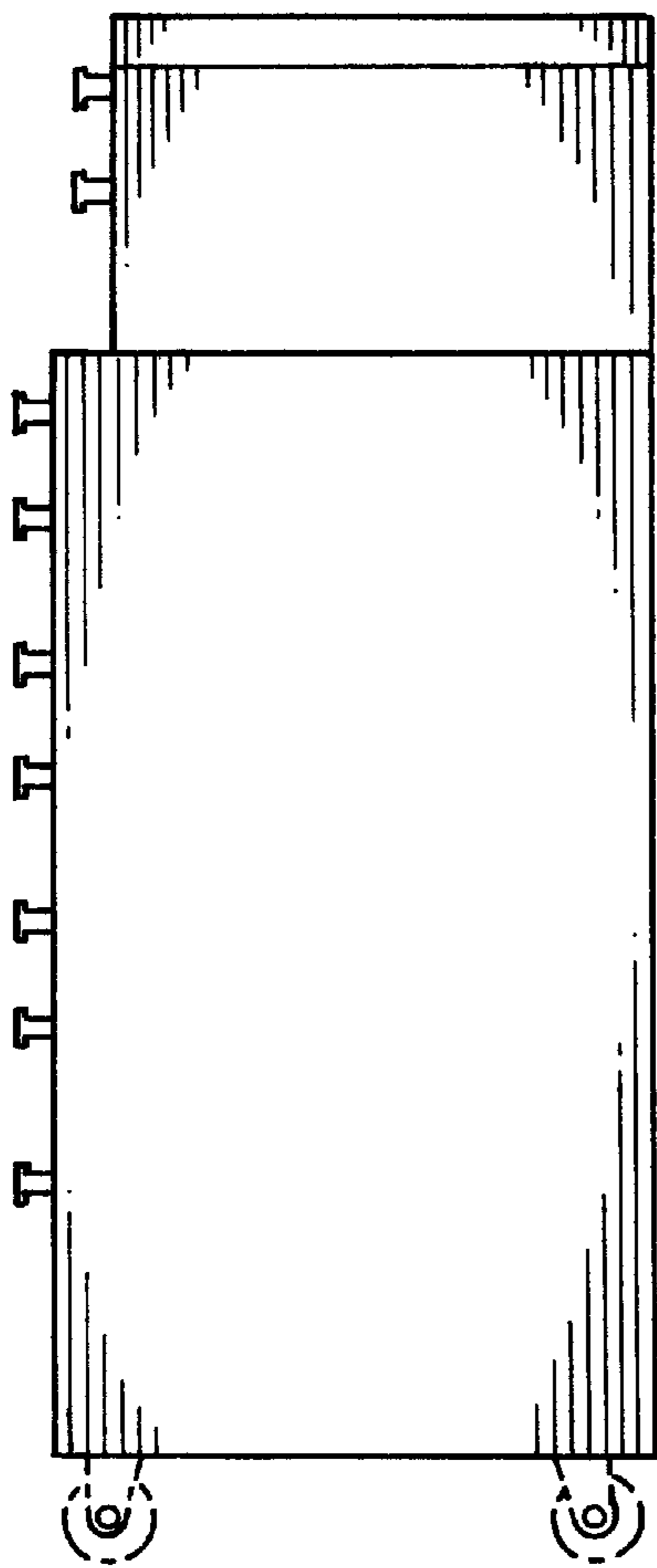

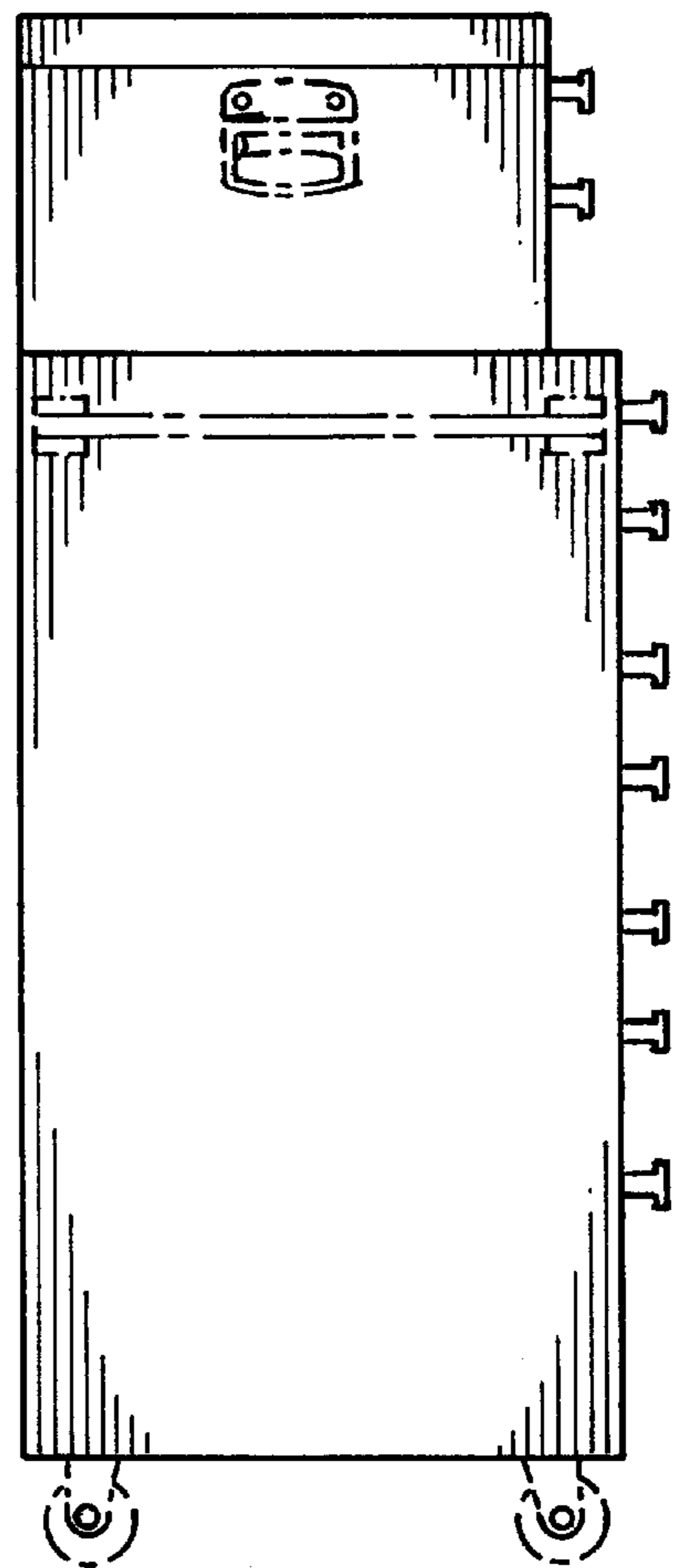




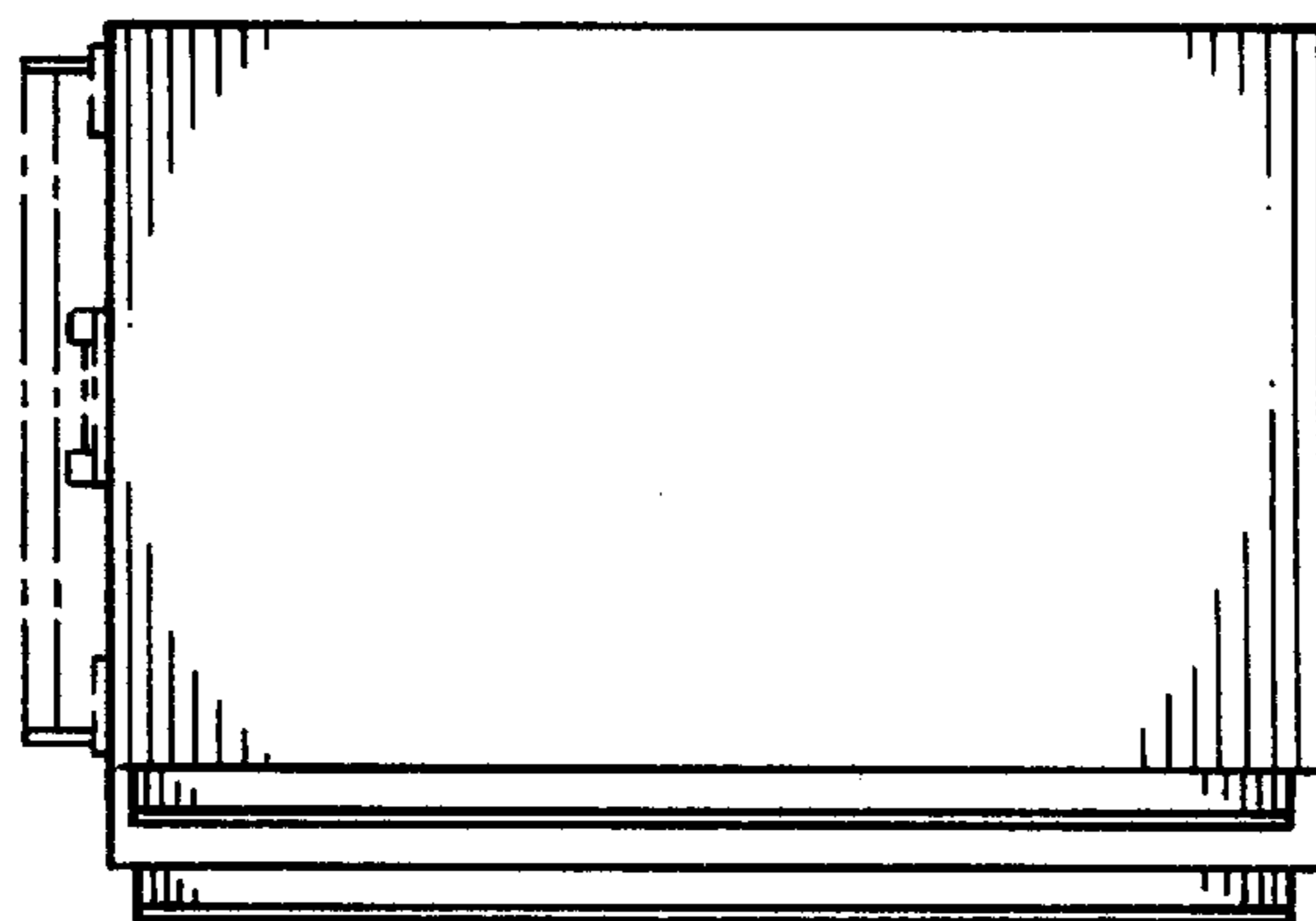

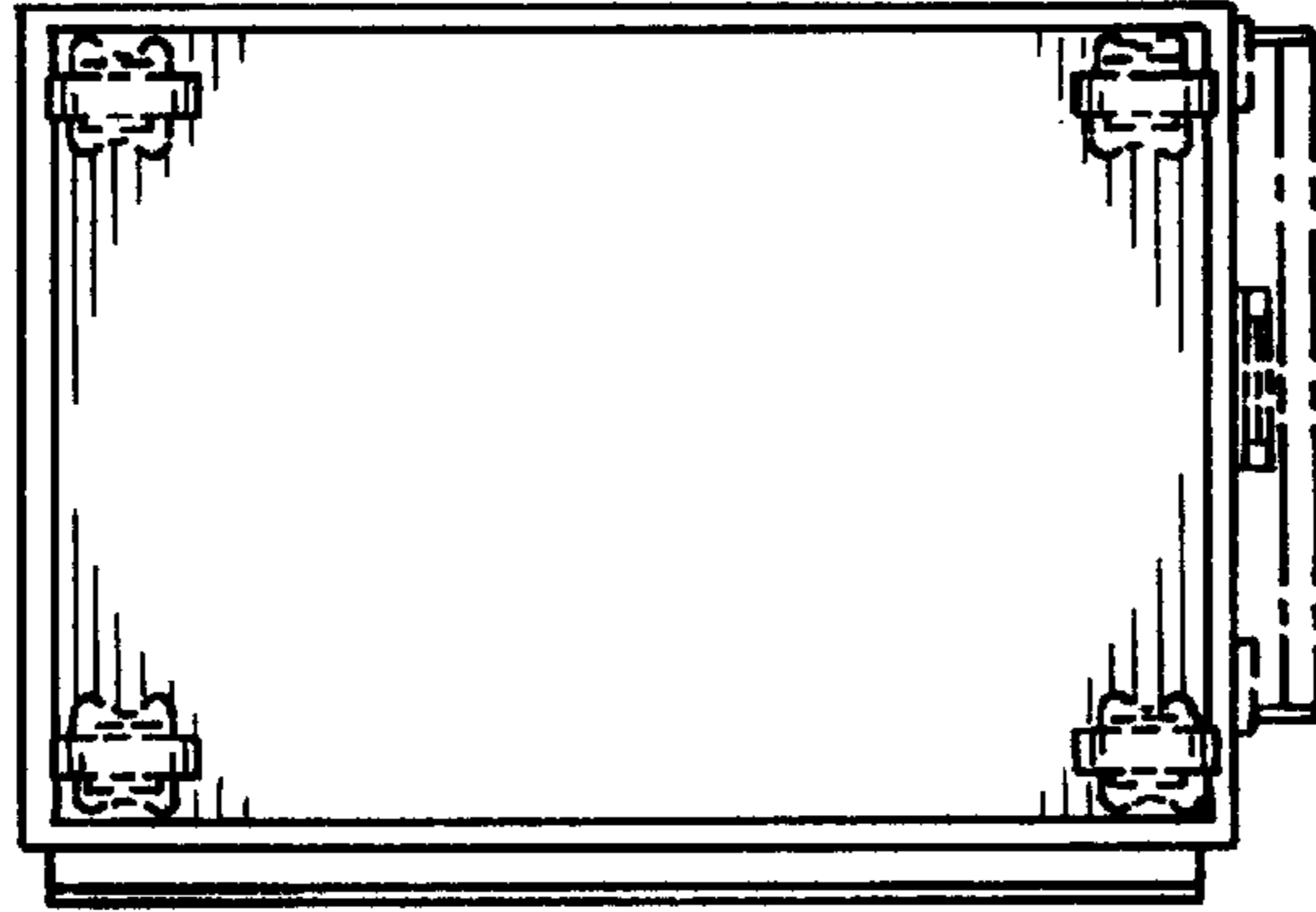

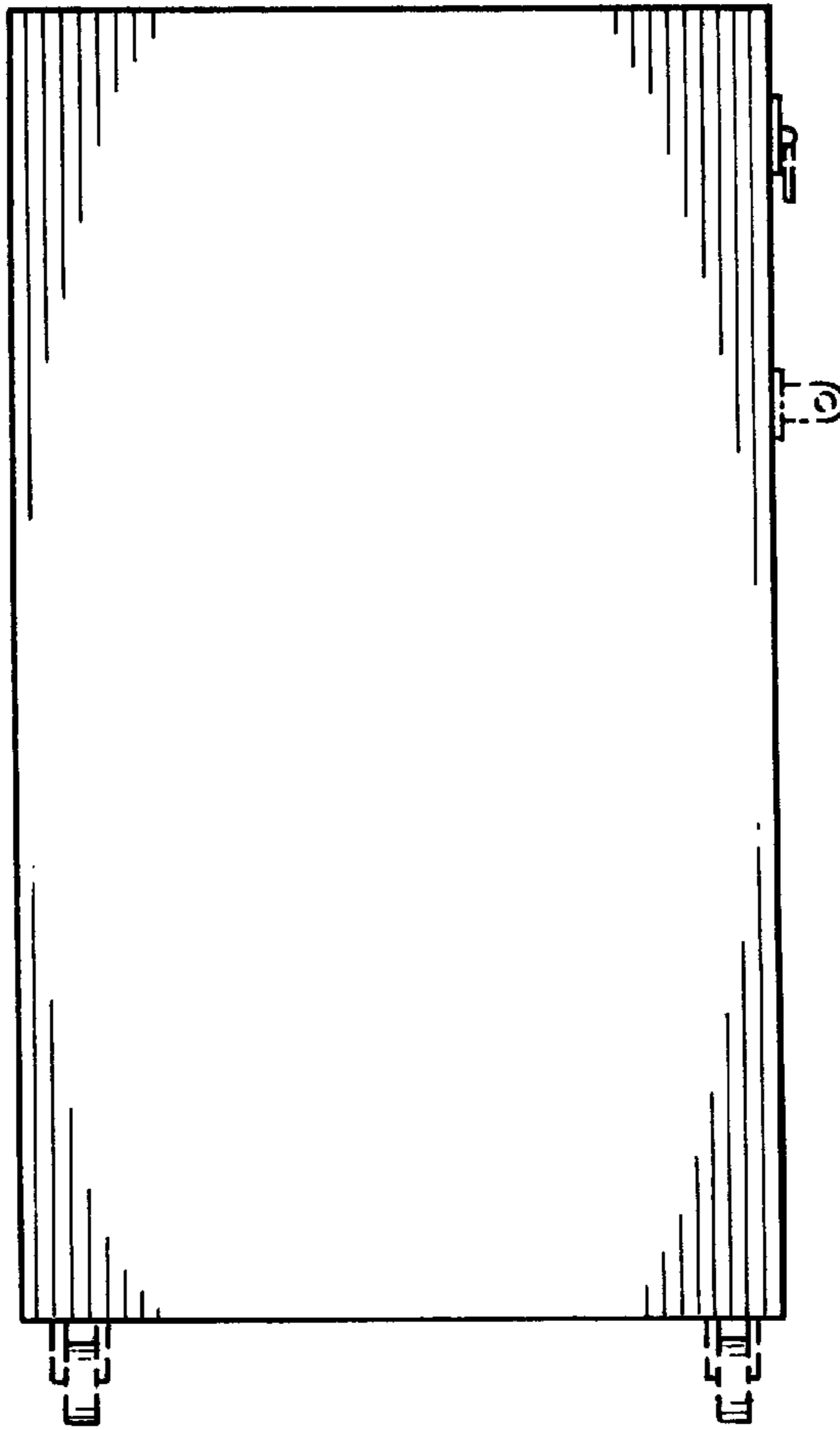
