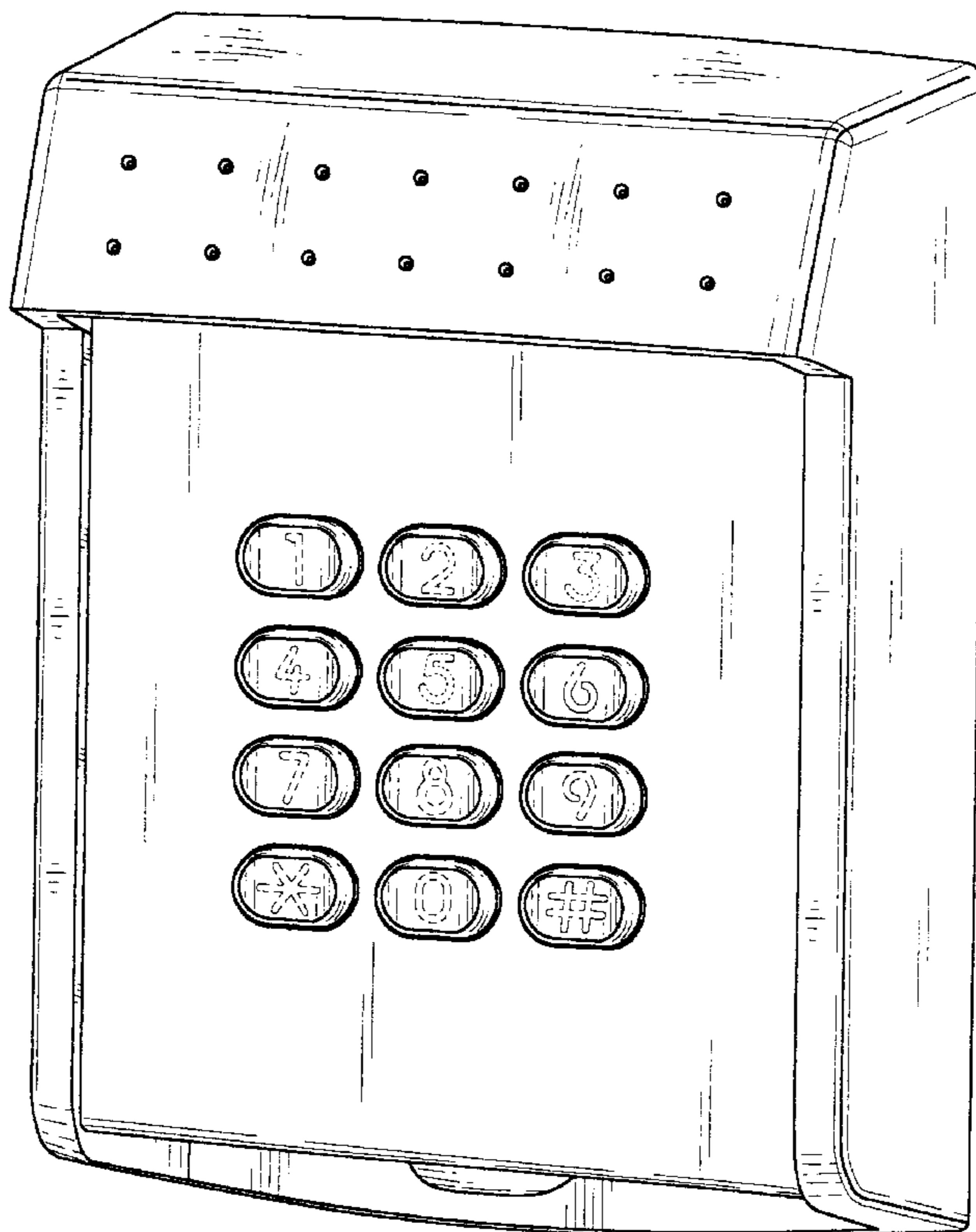
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective of a utility control box, showing my present design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevation thereof;
FIG. 4 is a right side elevation view thereof, the left side elevation being a mirror image; and,
FIG. 5 is a bottom plan view thereof.

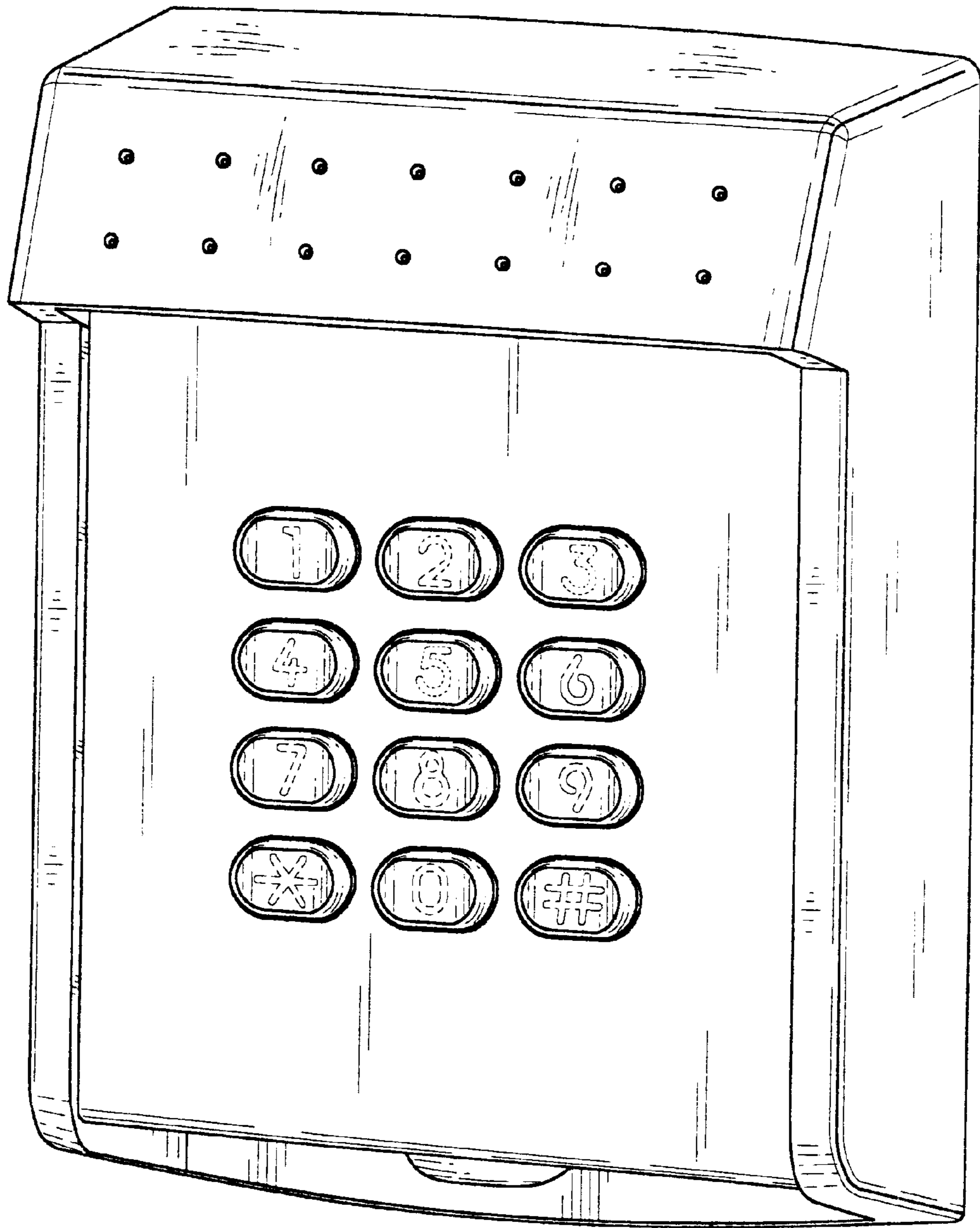

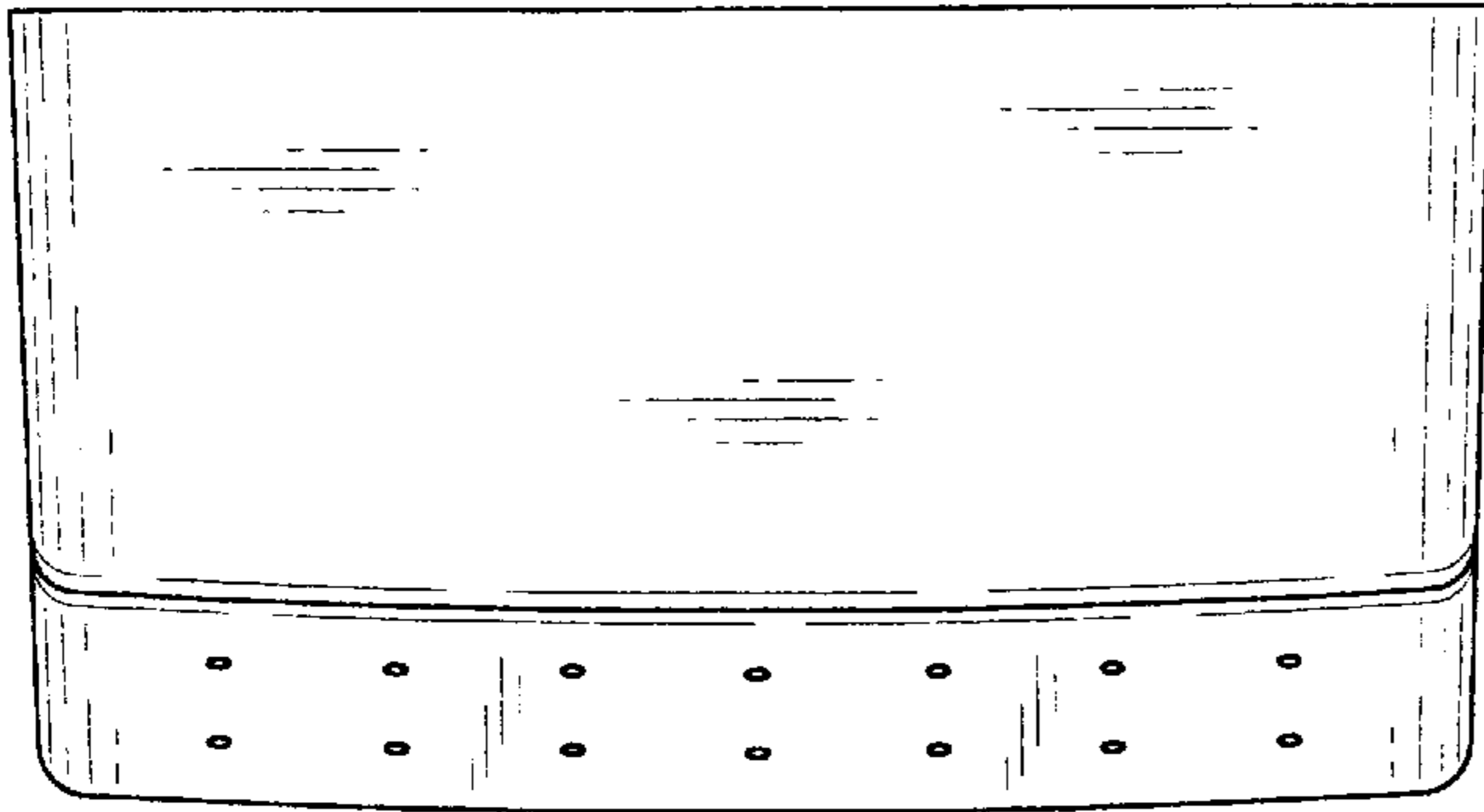

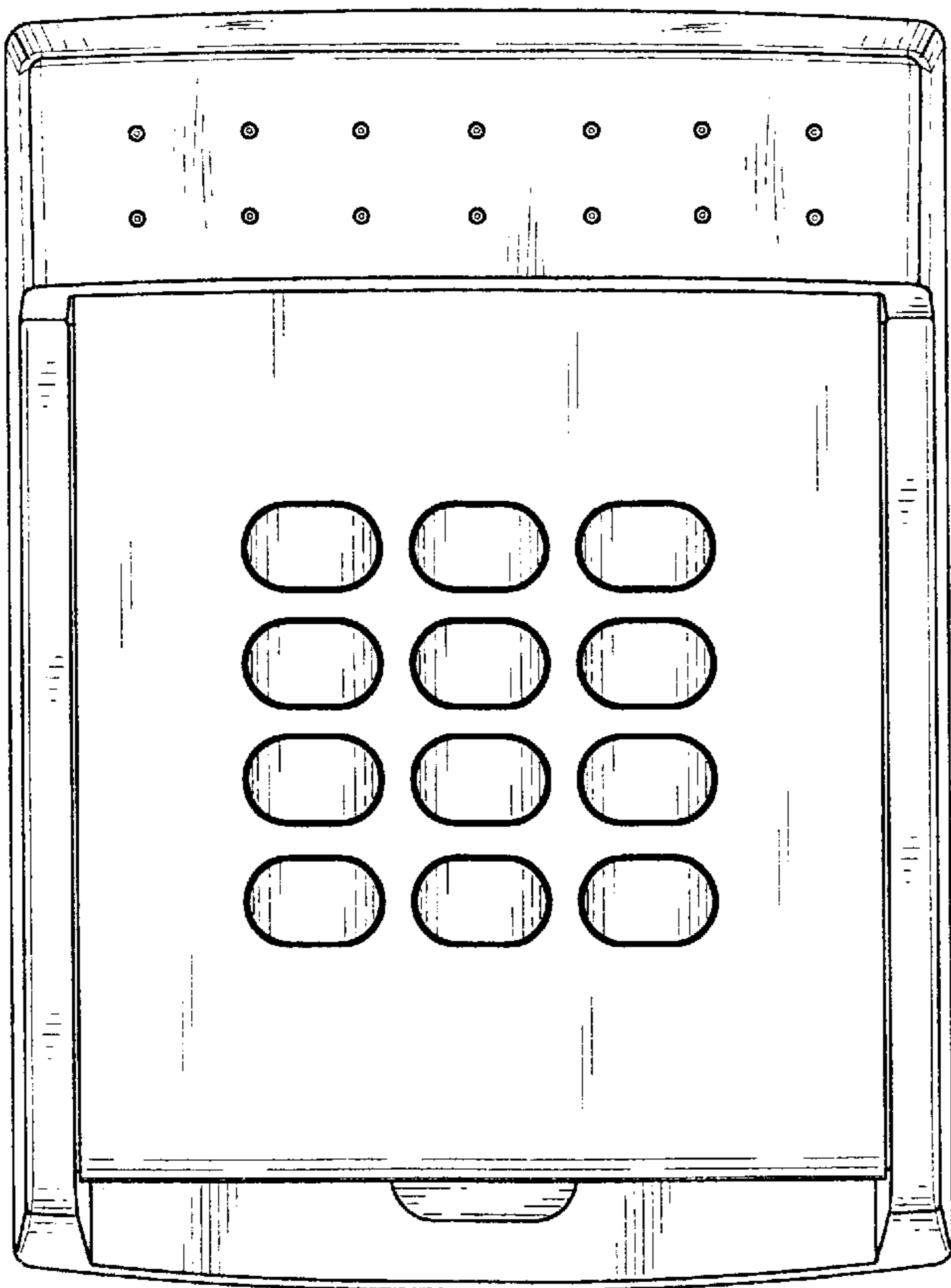

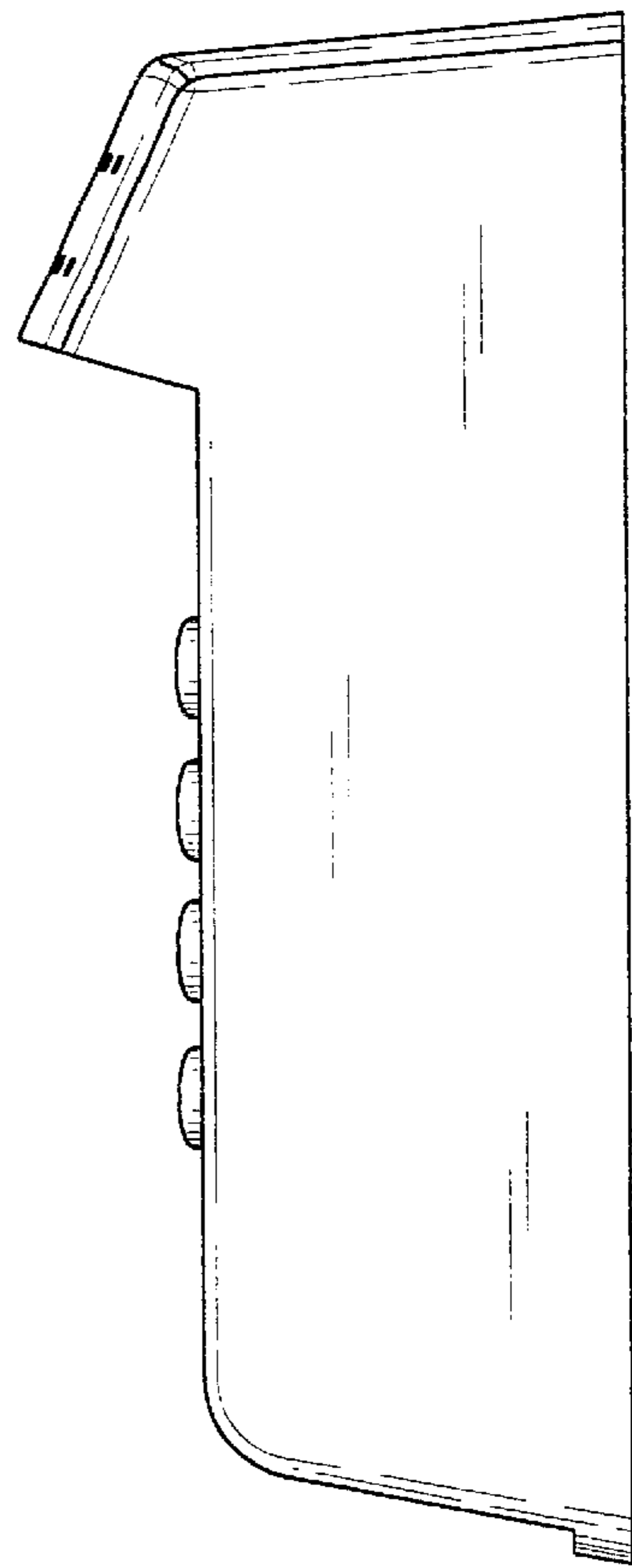

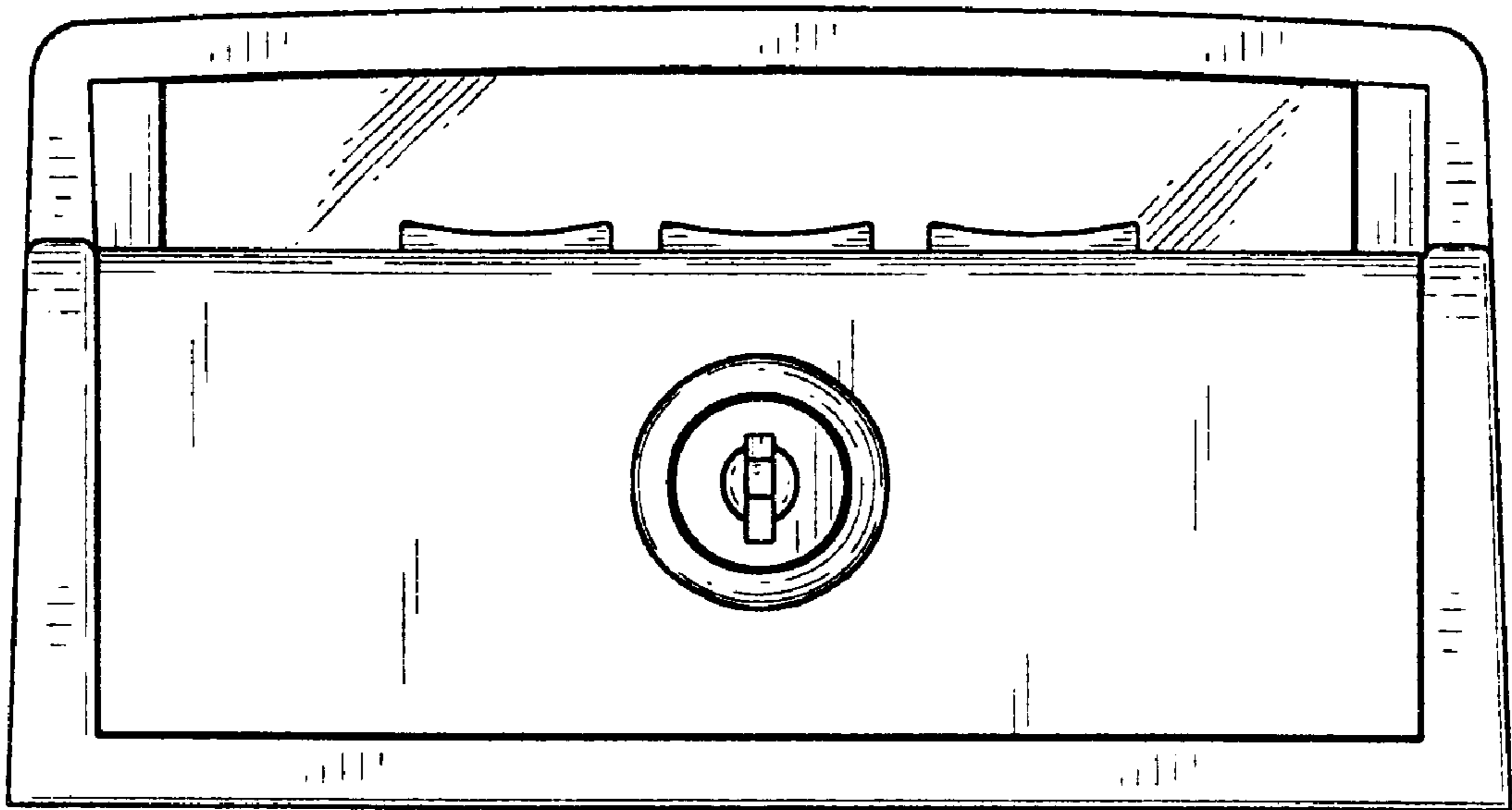
