**DESCRIPTION**

FIG. 1 is a top plan view of a fabric construction embodying our design;

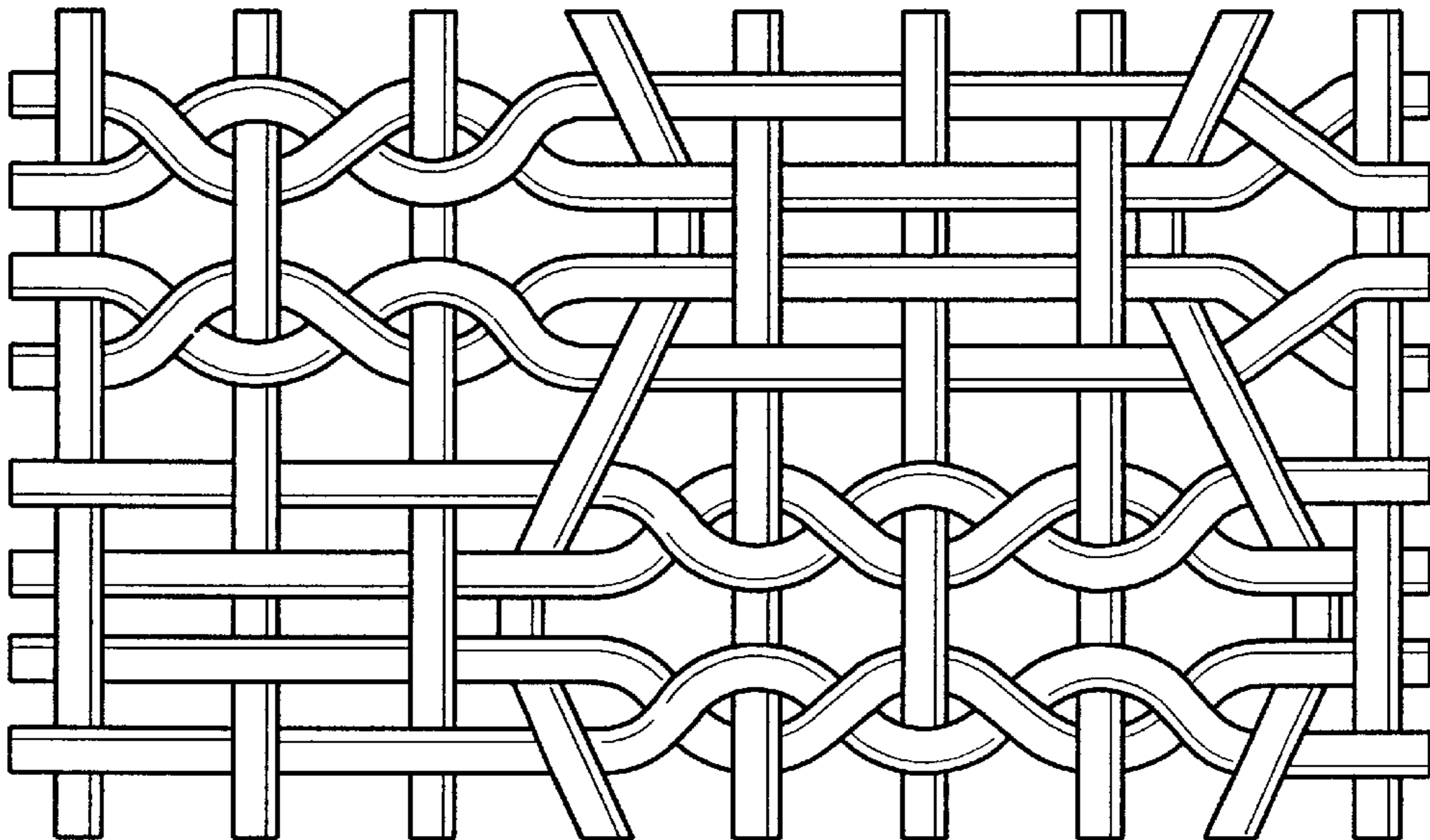

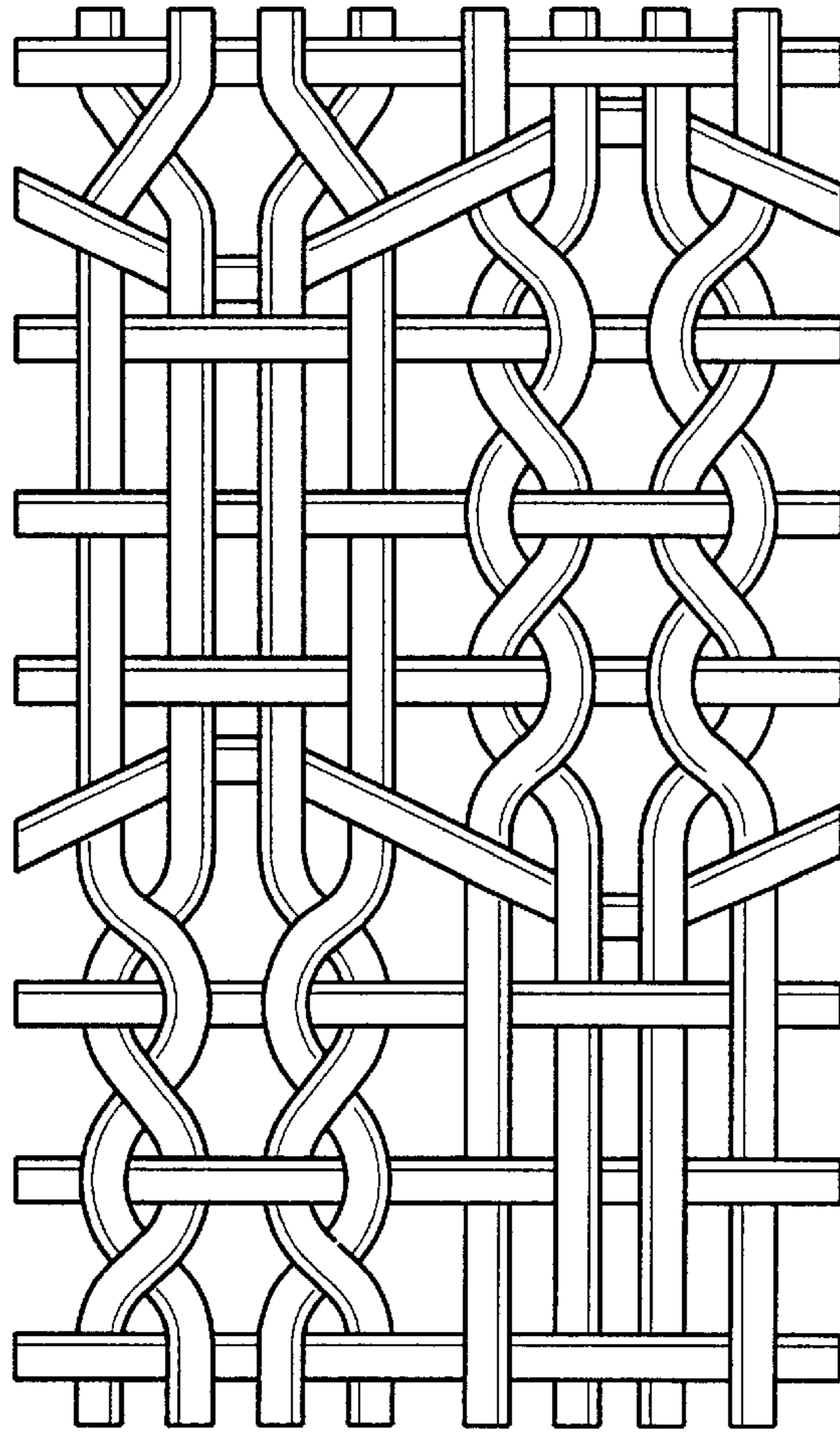

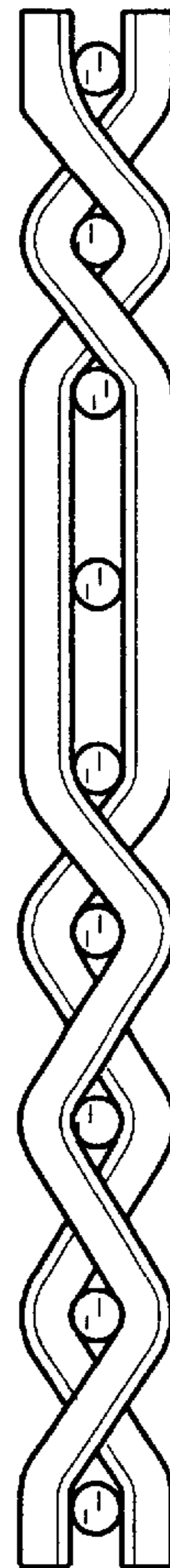

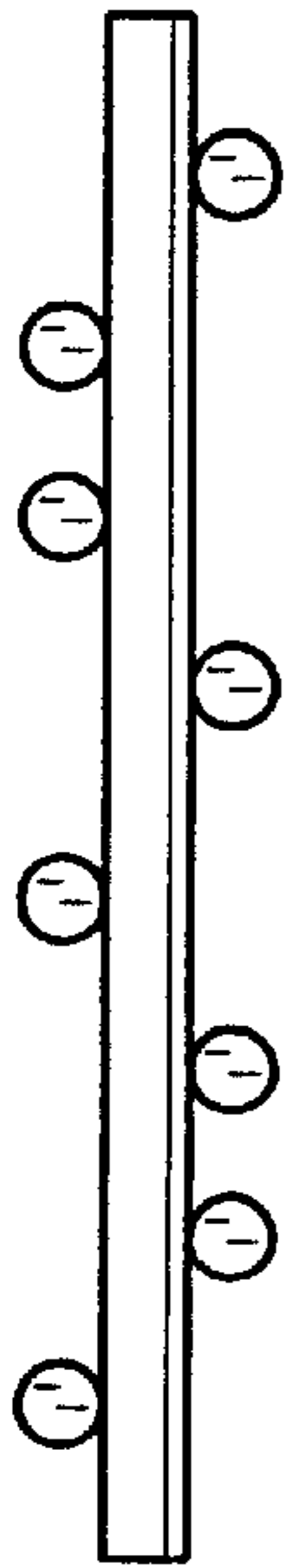

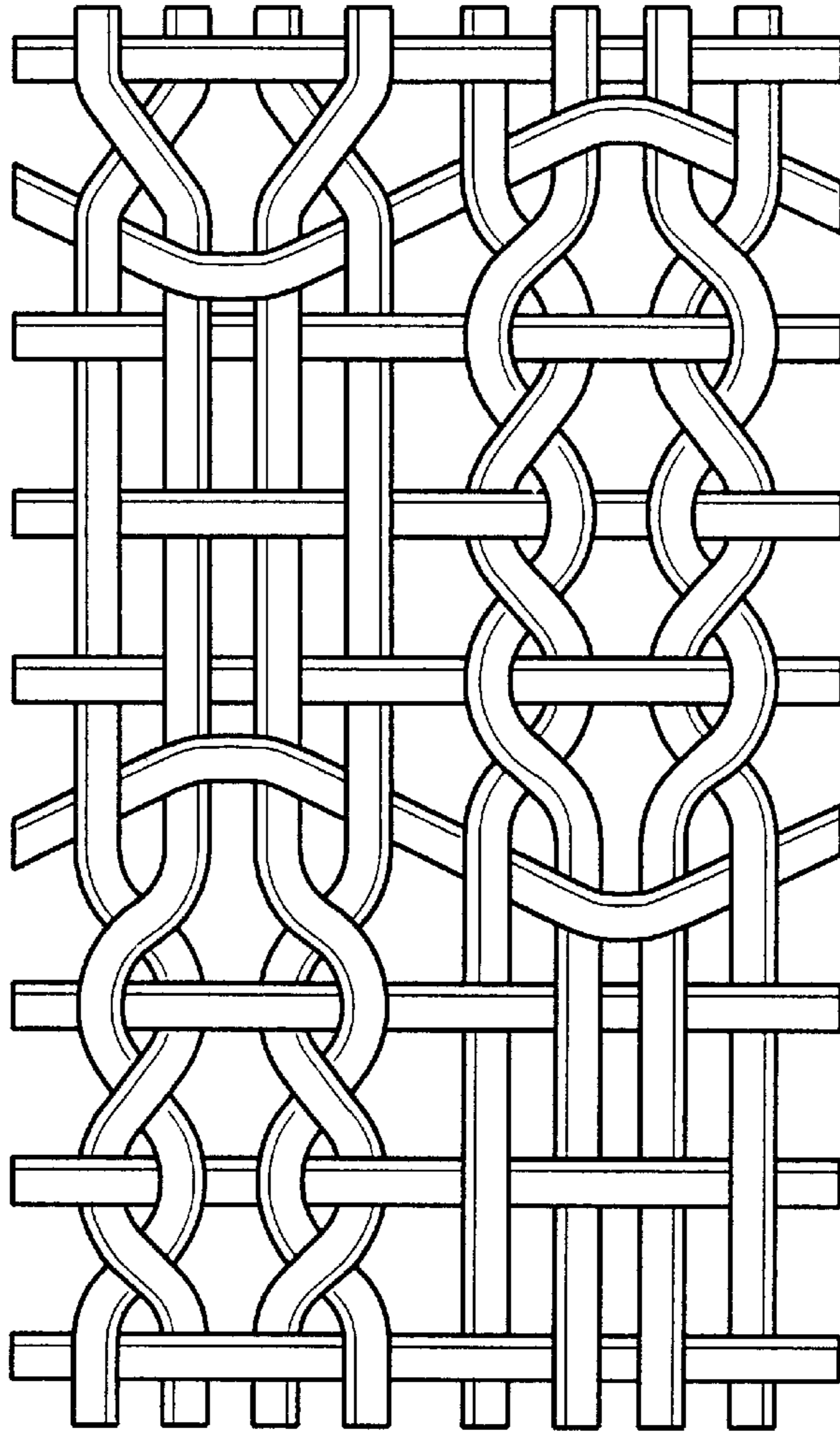

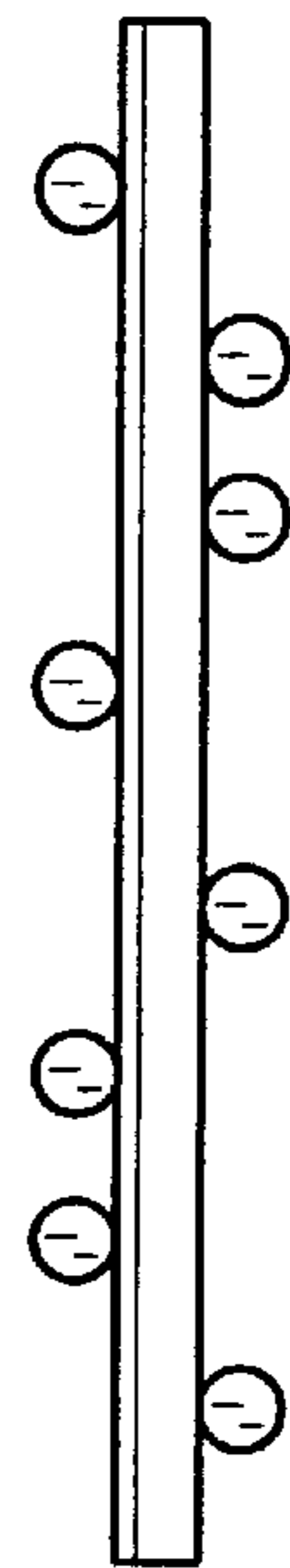
