with a slidable drawer in the installed position of our new
design;

FIG. 5 is a side elevational view of the left side thereof;

FIG. 6 is an enlarged top plan view thereof;

FIG. 7 is a bottom plan view of the top shelf assembly with
the slidable drawer in the installed position;

FIG. 8 is a bottom plan view of the bottom shelf assembly;

FIG. 9 is a perspective view of the locker shelf assembly in
the unassembled packaged position with the drawer in the
packaged nested position;

FIG. 10 is a front elevational view of FIG. 9;

FIG. 11 is a top plan view of FIG. 9;

FIG. 12 is a bottom plan view of FIG. 9 with the drawer in
the packaged nested position;

FIG. 13 is a rear elevational view of FIG. 9 with the drawer
in the packaged nested position; and,

FIG. 14 is a side elevational view of FIG. 9, the opposite side
being a mirror image thereof.

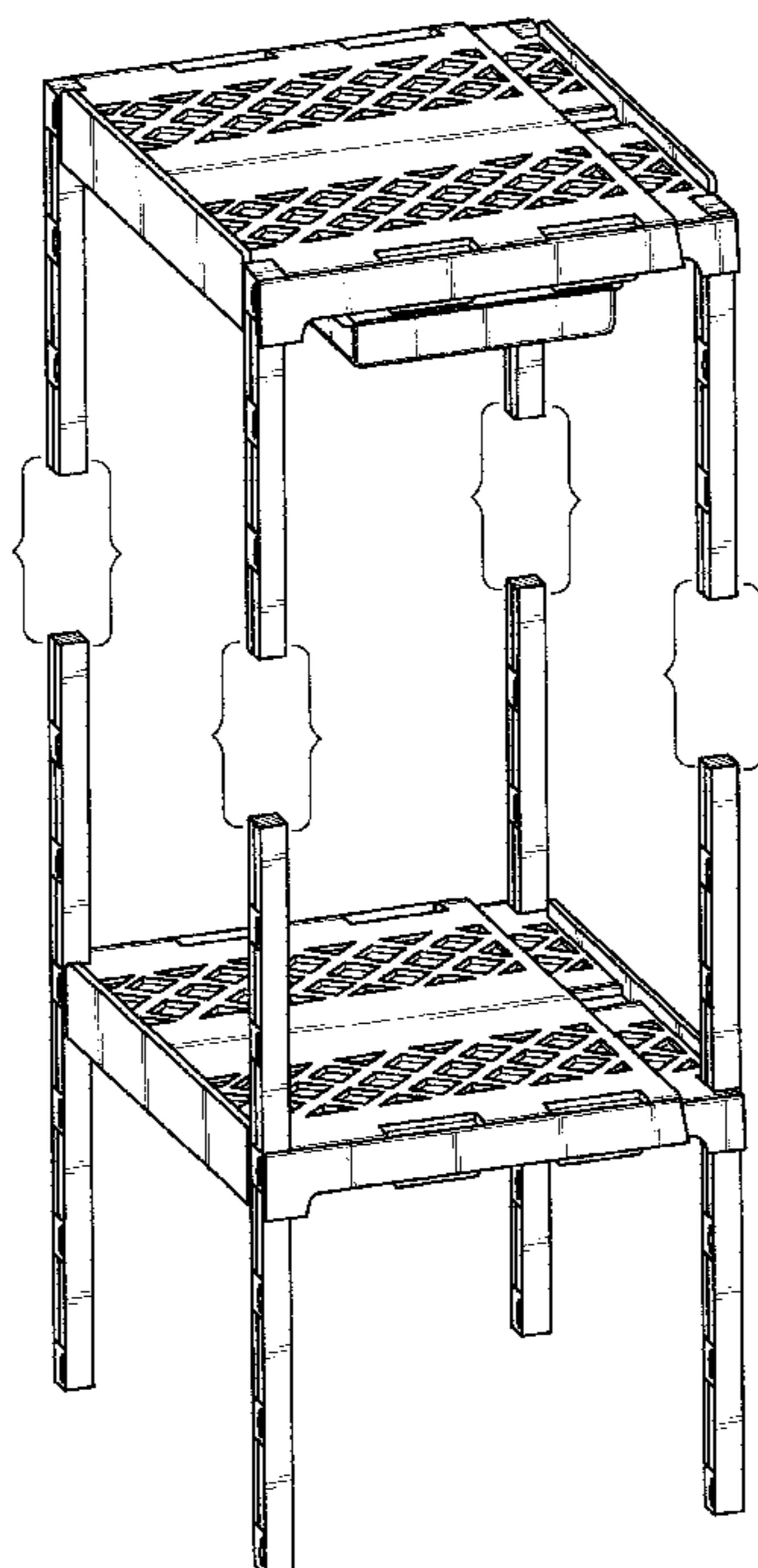
The legs are shown broken apart to indicate indeterminate

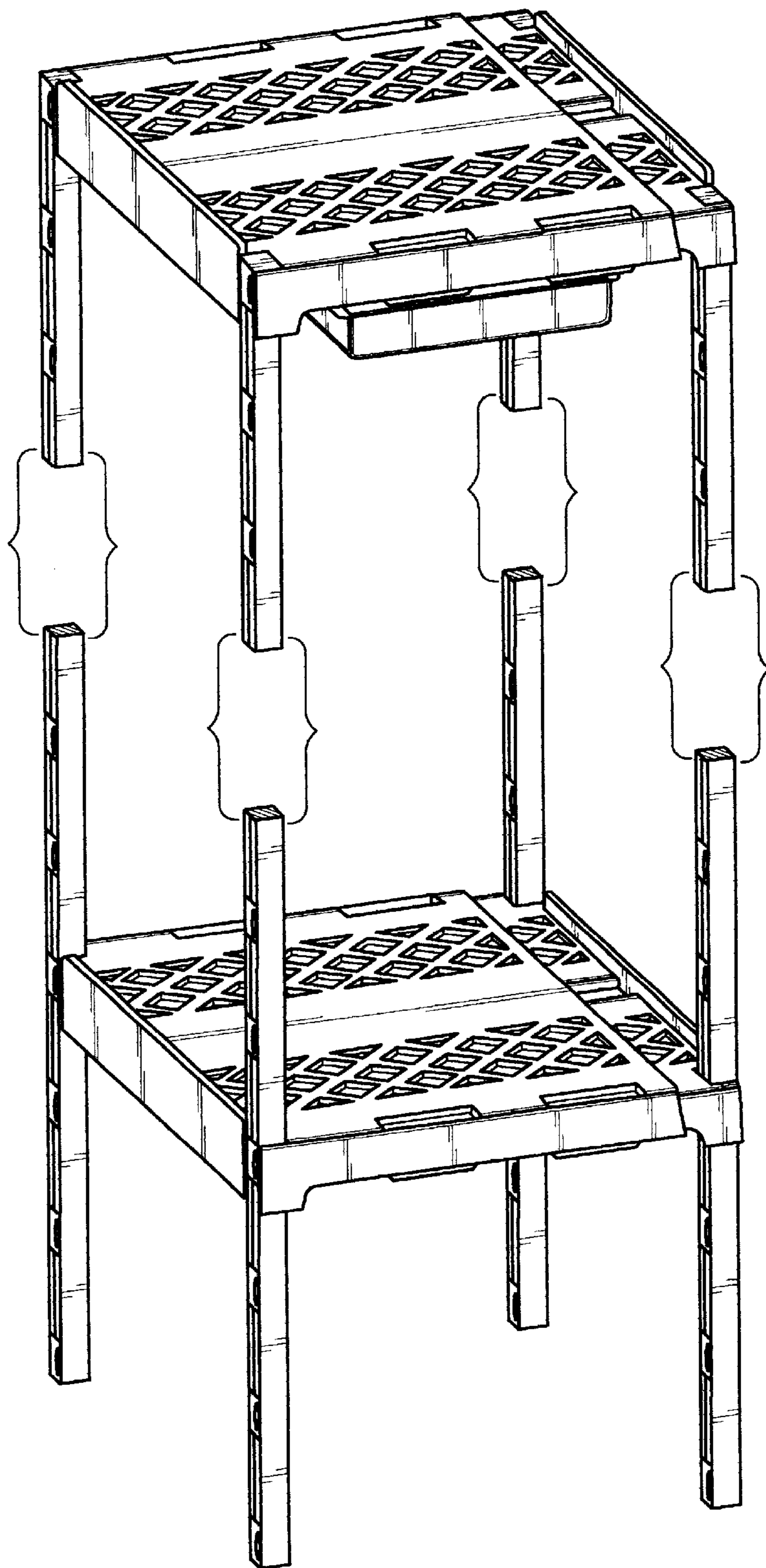

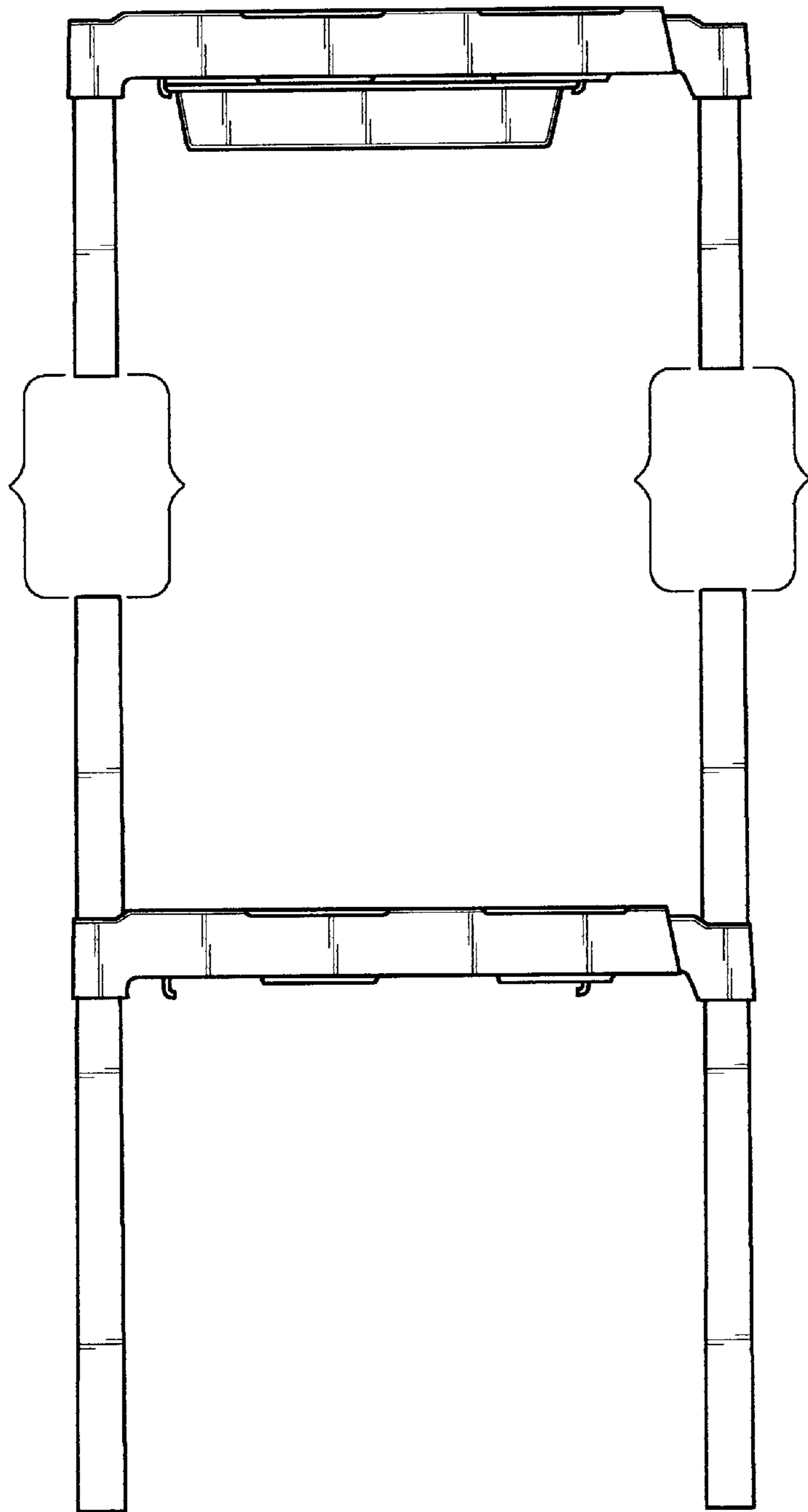

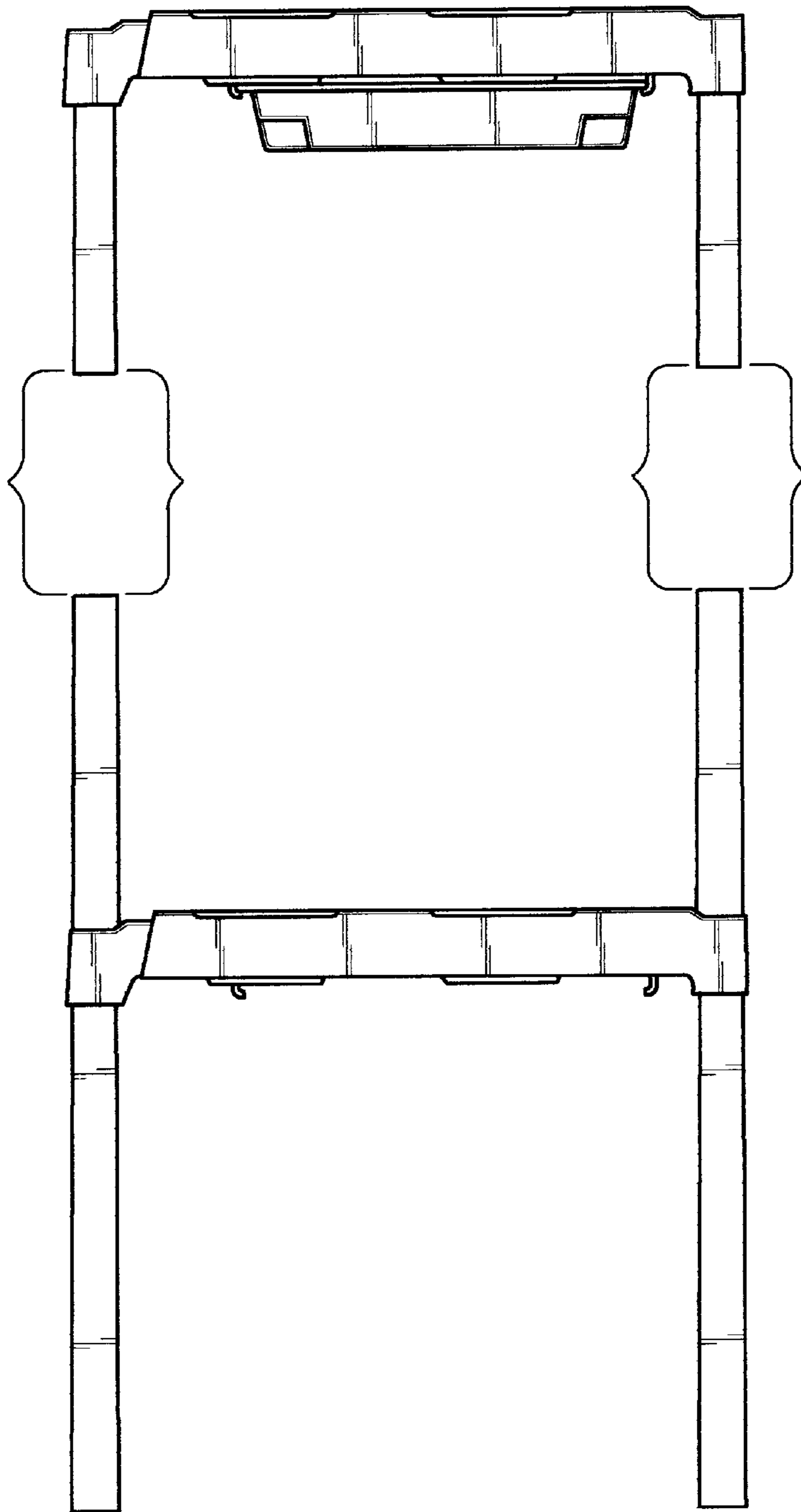

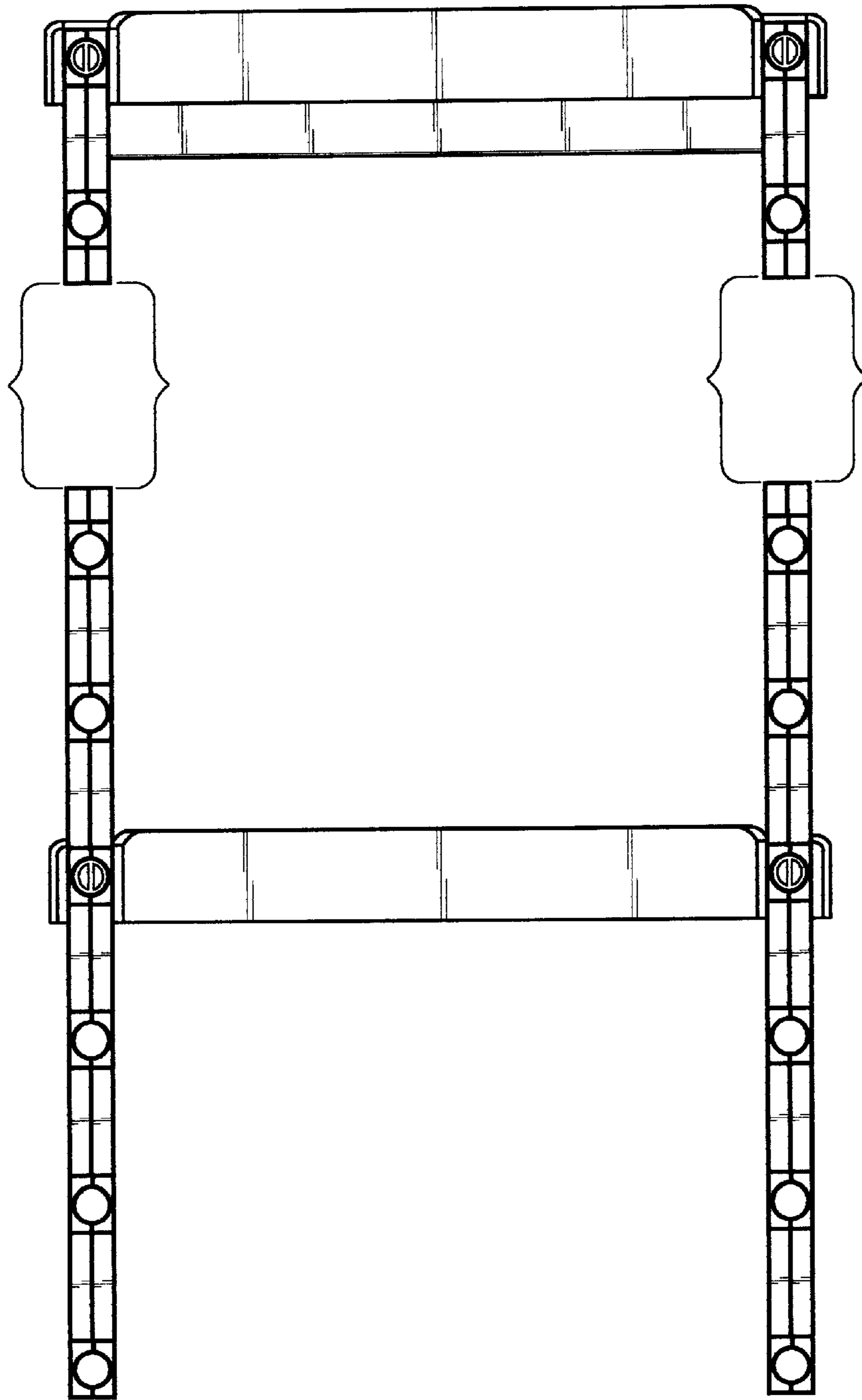

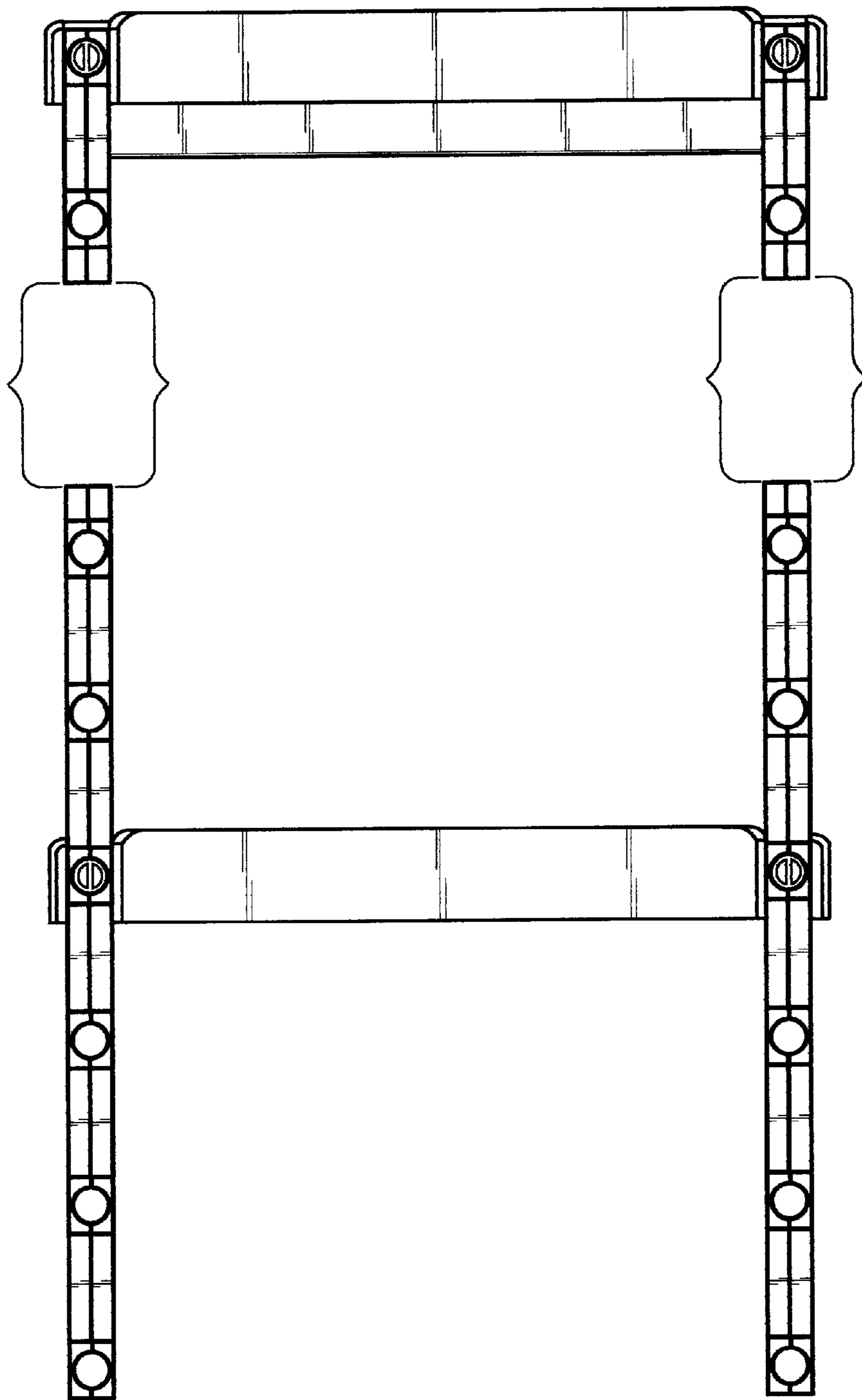

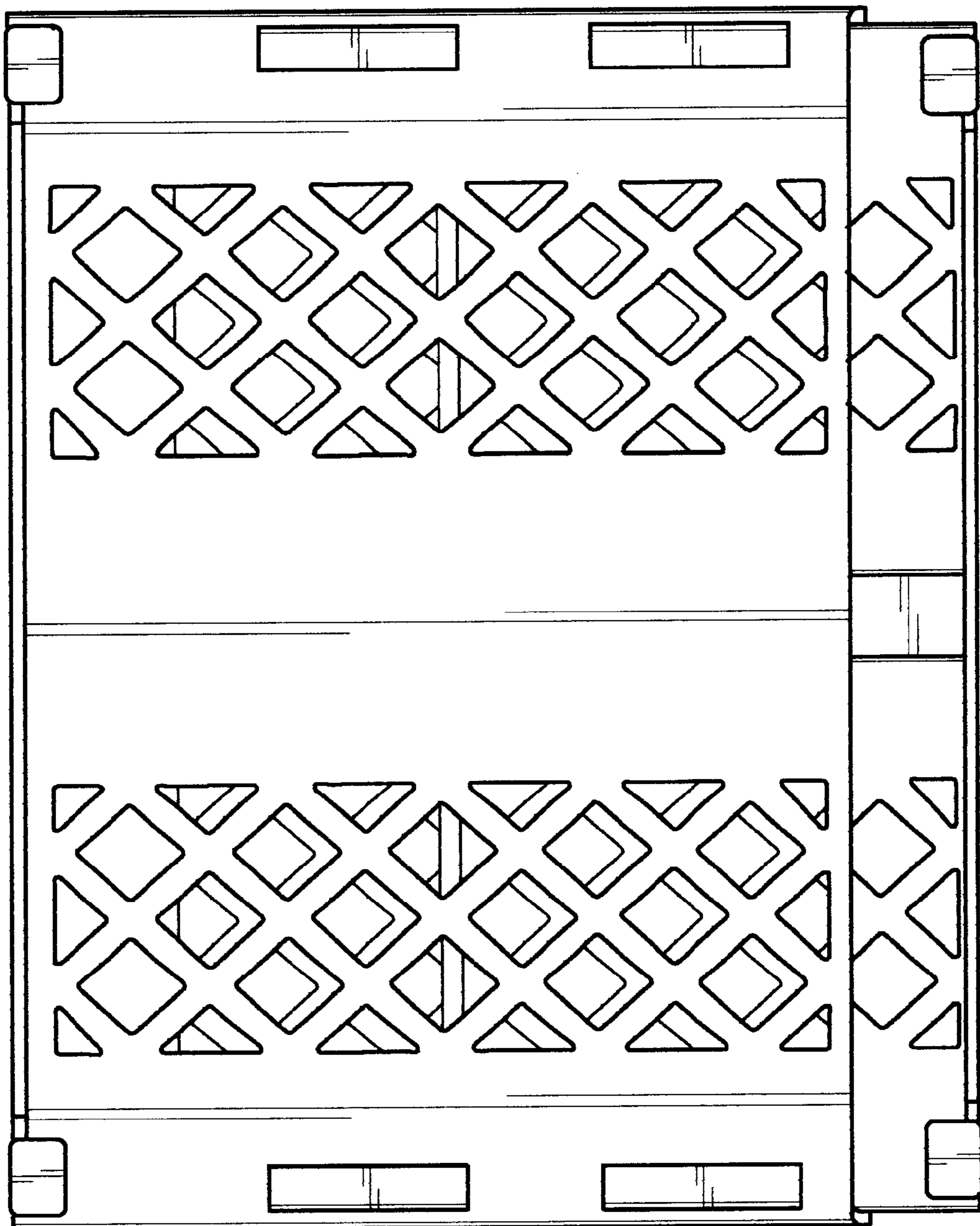

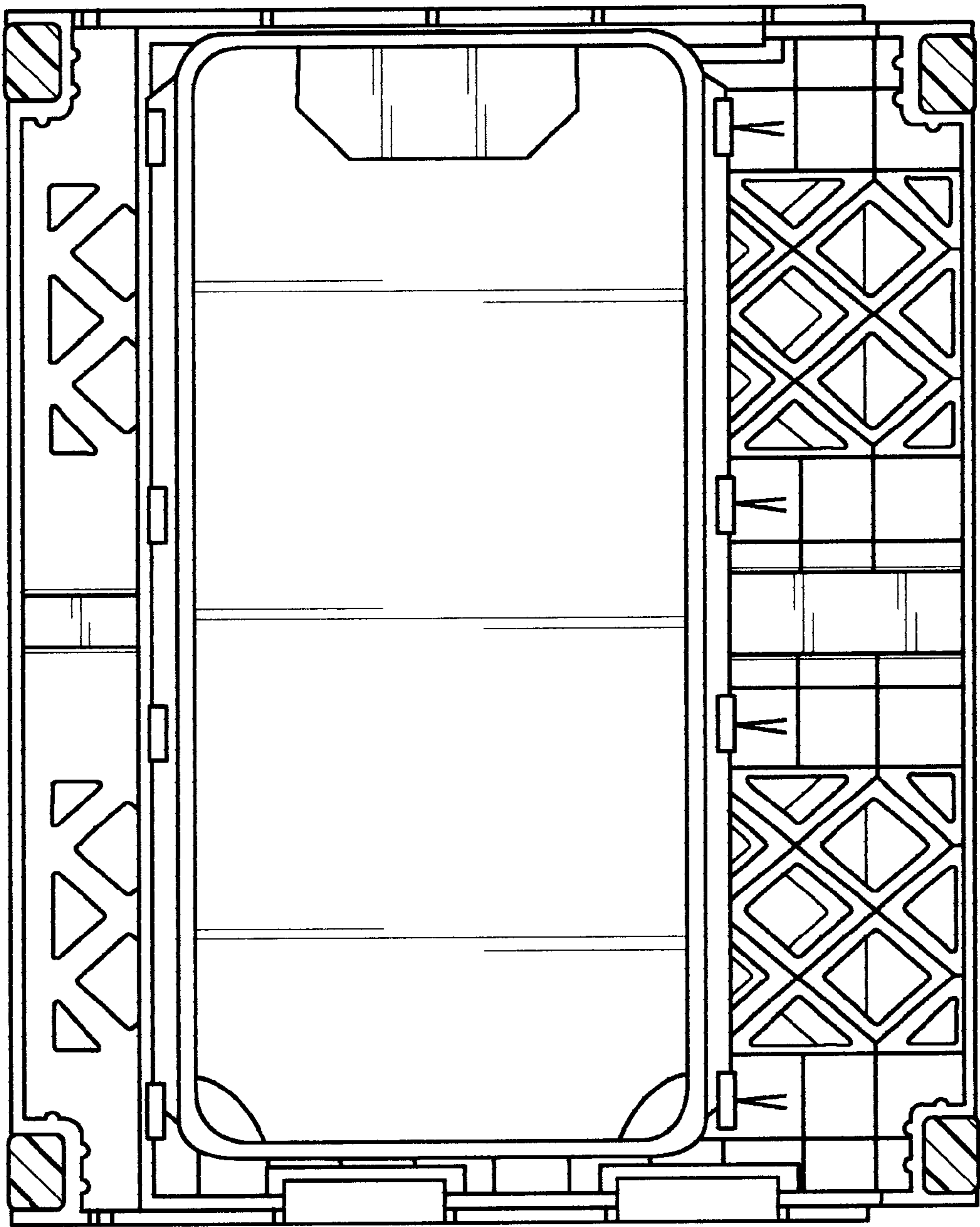

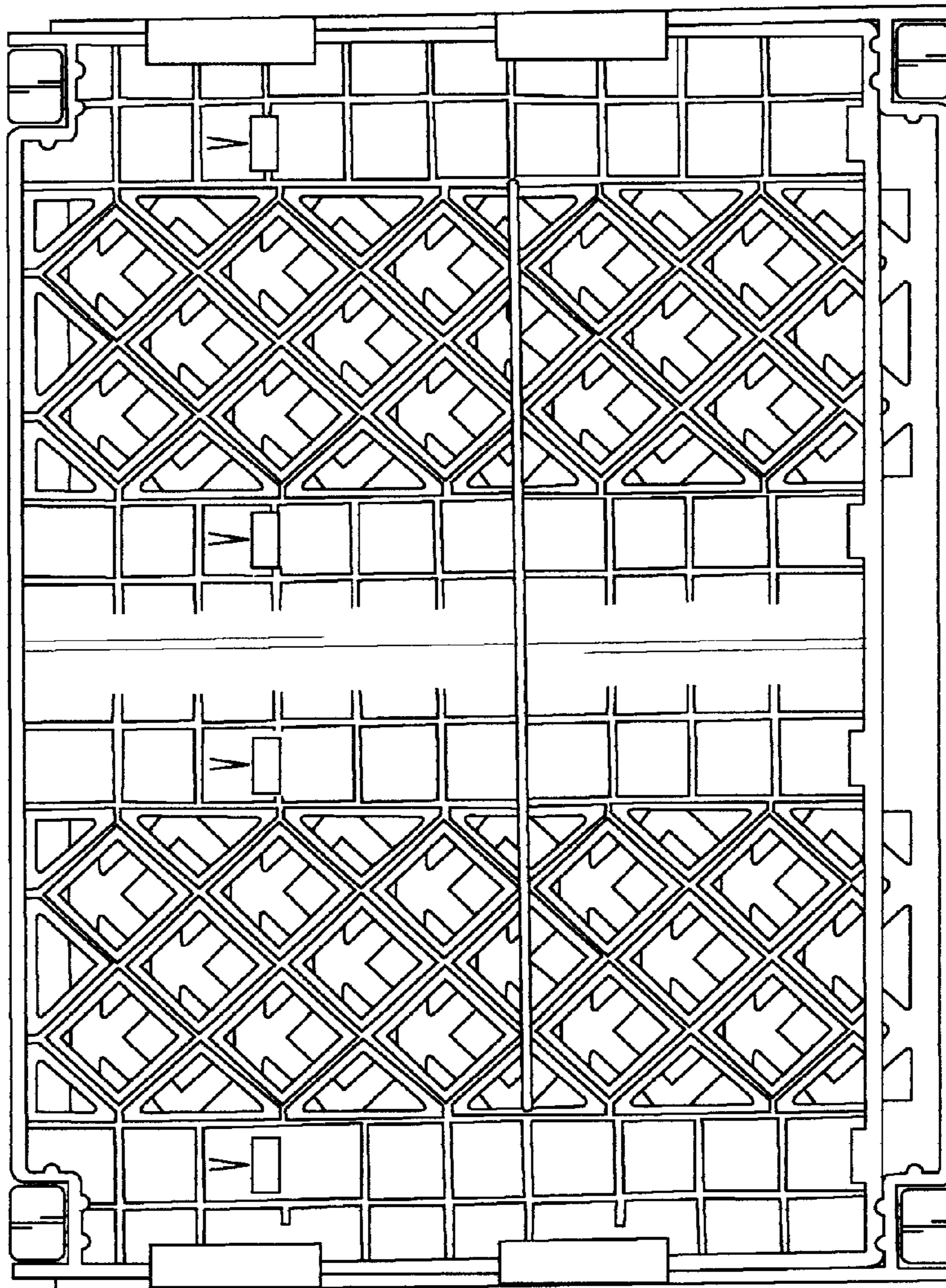

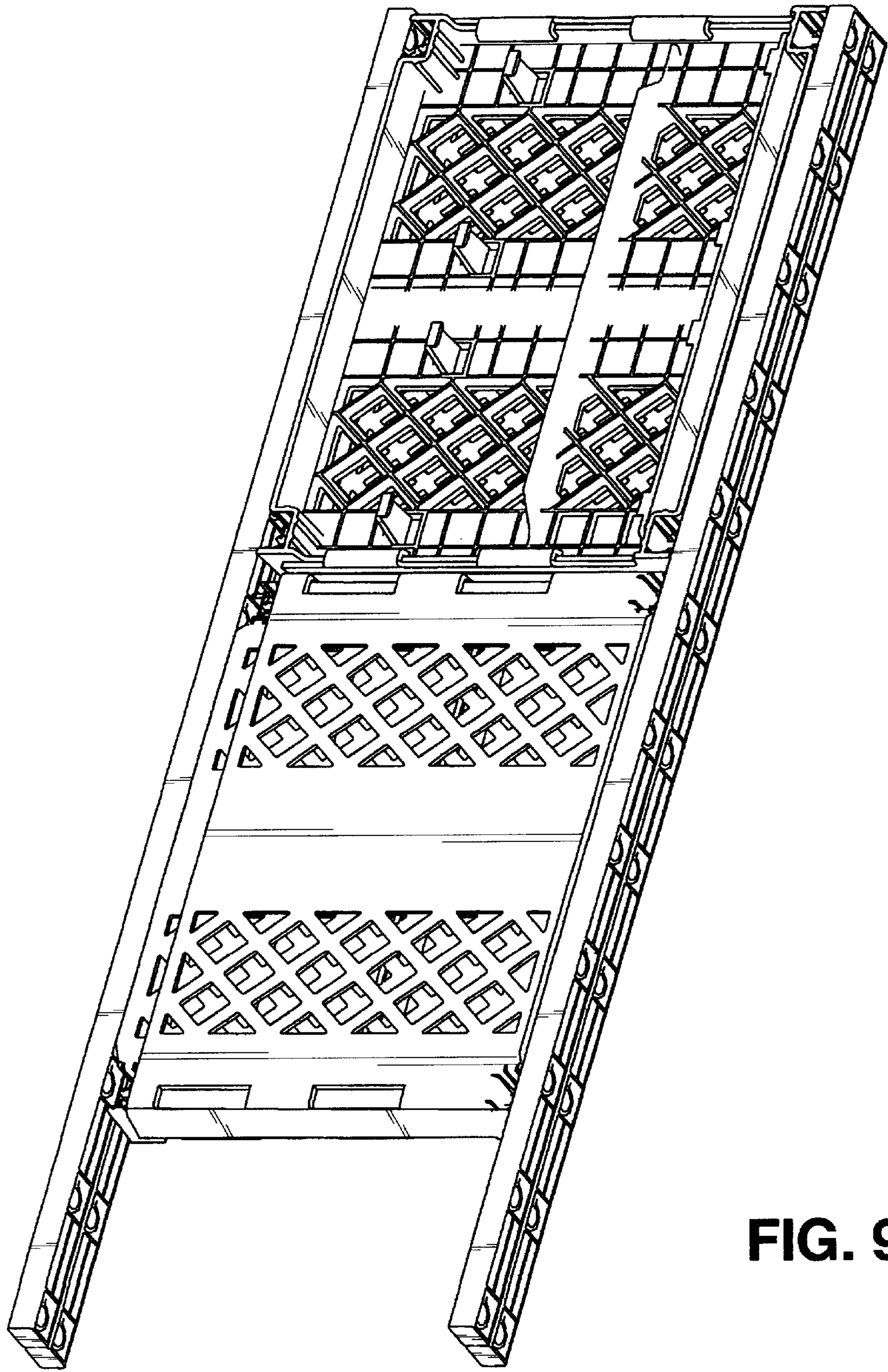

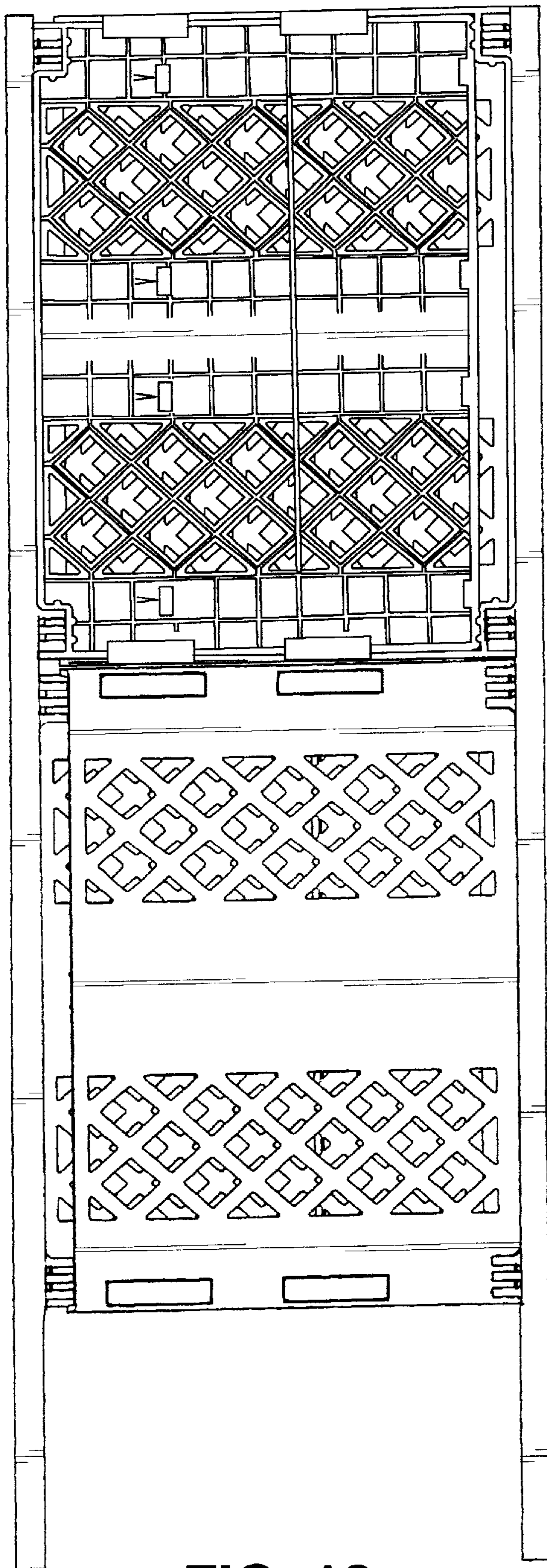

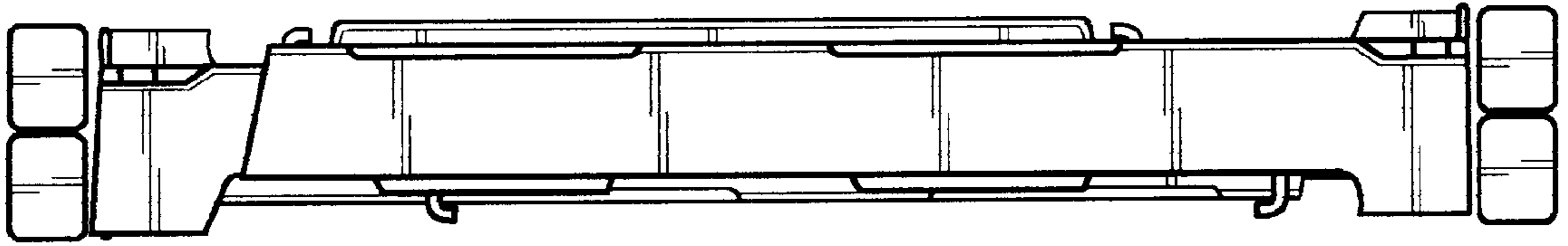

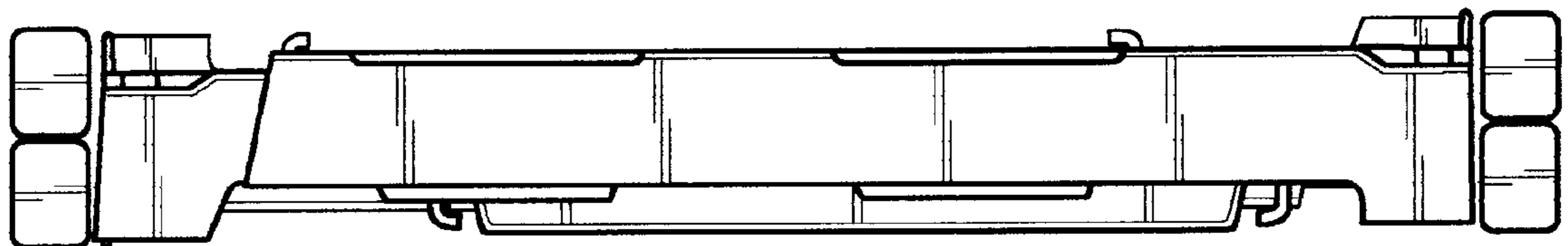

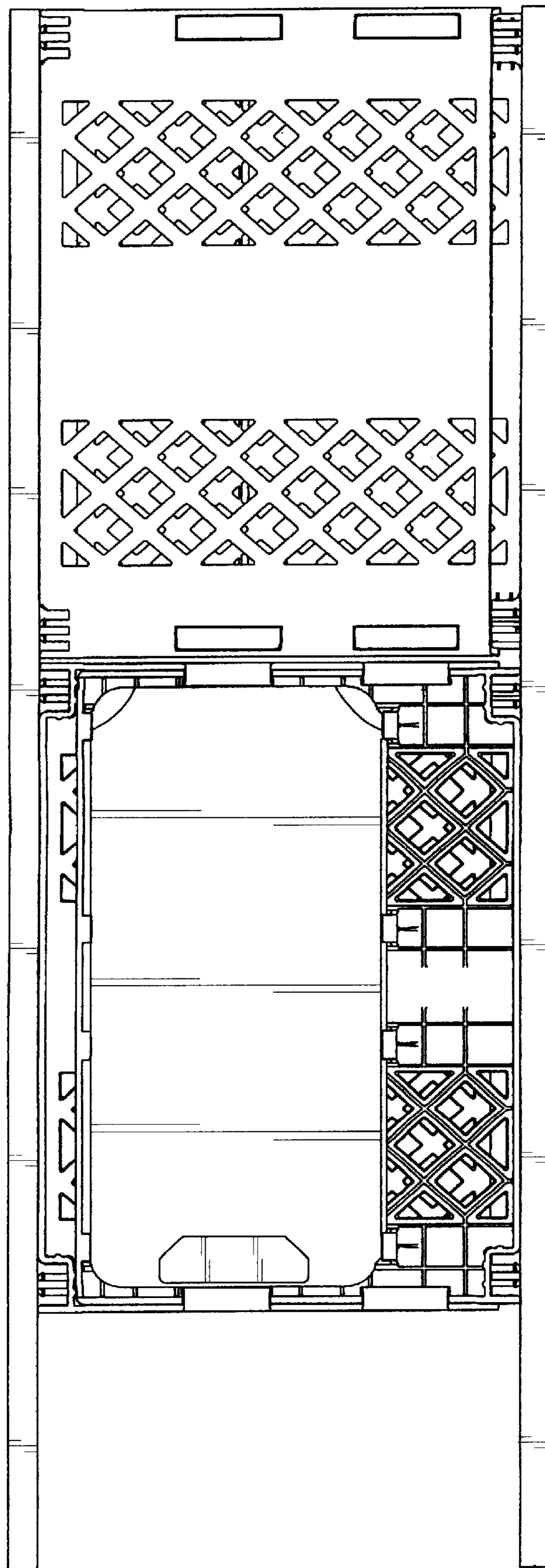

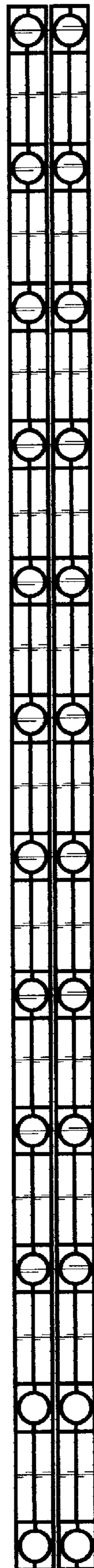
