The ornamental design box for holding compact disk, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a box or container capable of holding compact disks showing my new design;
 FIG. 2 is a rear elevation view thereof;
 FIG. 3 is a left side elevation view thereof;
 FIG. 4 is a right side elevation view thereof;
 FIG. 5 is a top plan view of thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a right side elevation view showing said box in closing condition;
 FIG. 8 is a top plan view of said box of FIG. 7; and,
 FIG. 9 is a left side view showing a pallet for compact disks with broken lines, which are for illustrative purpose only and form no part of the claimed design.

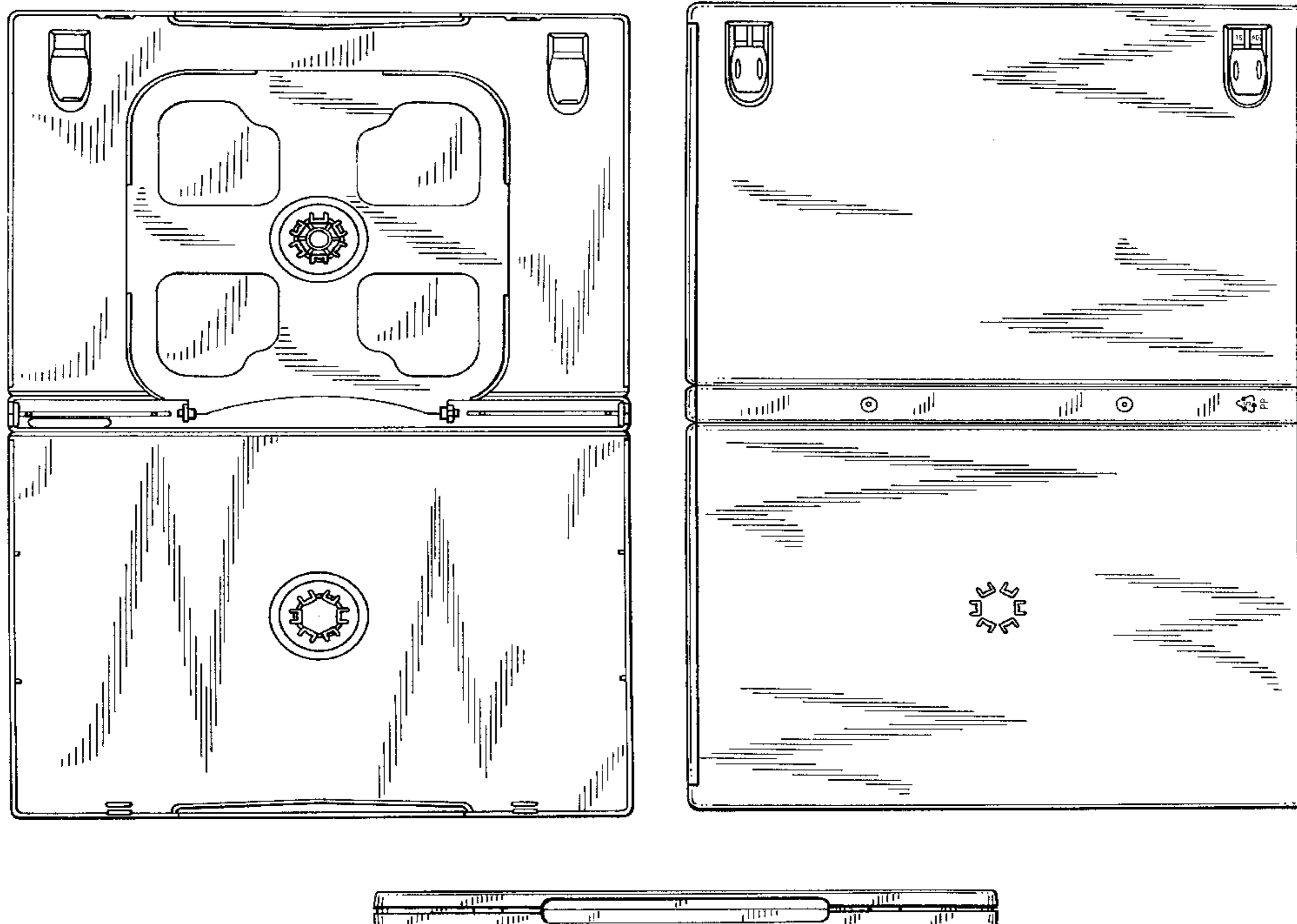

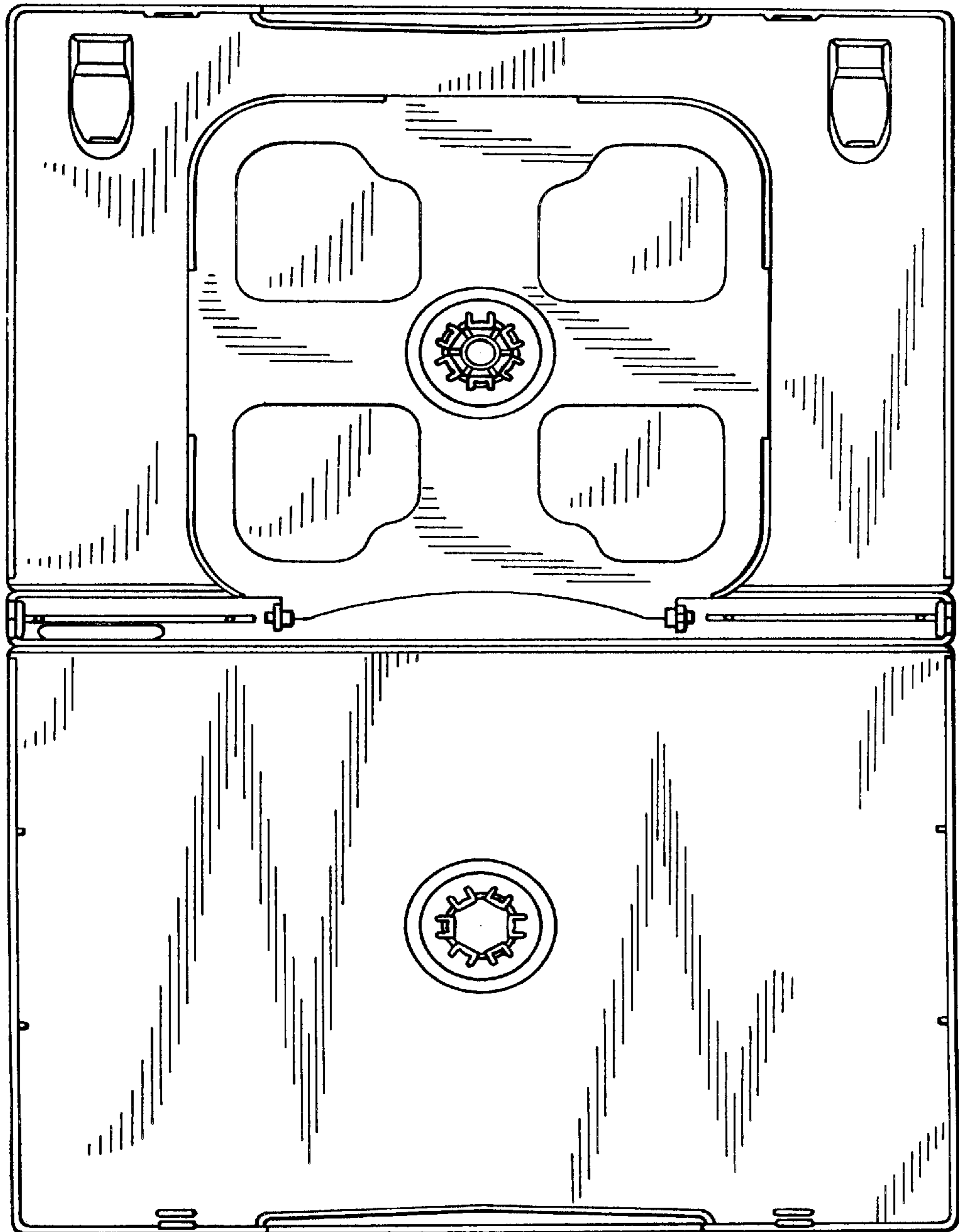

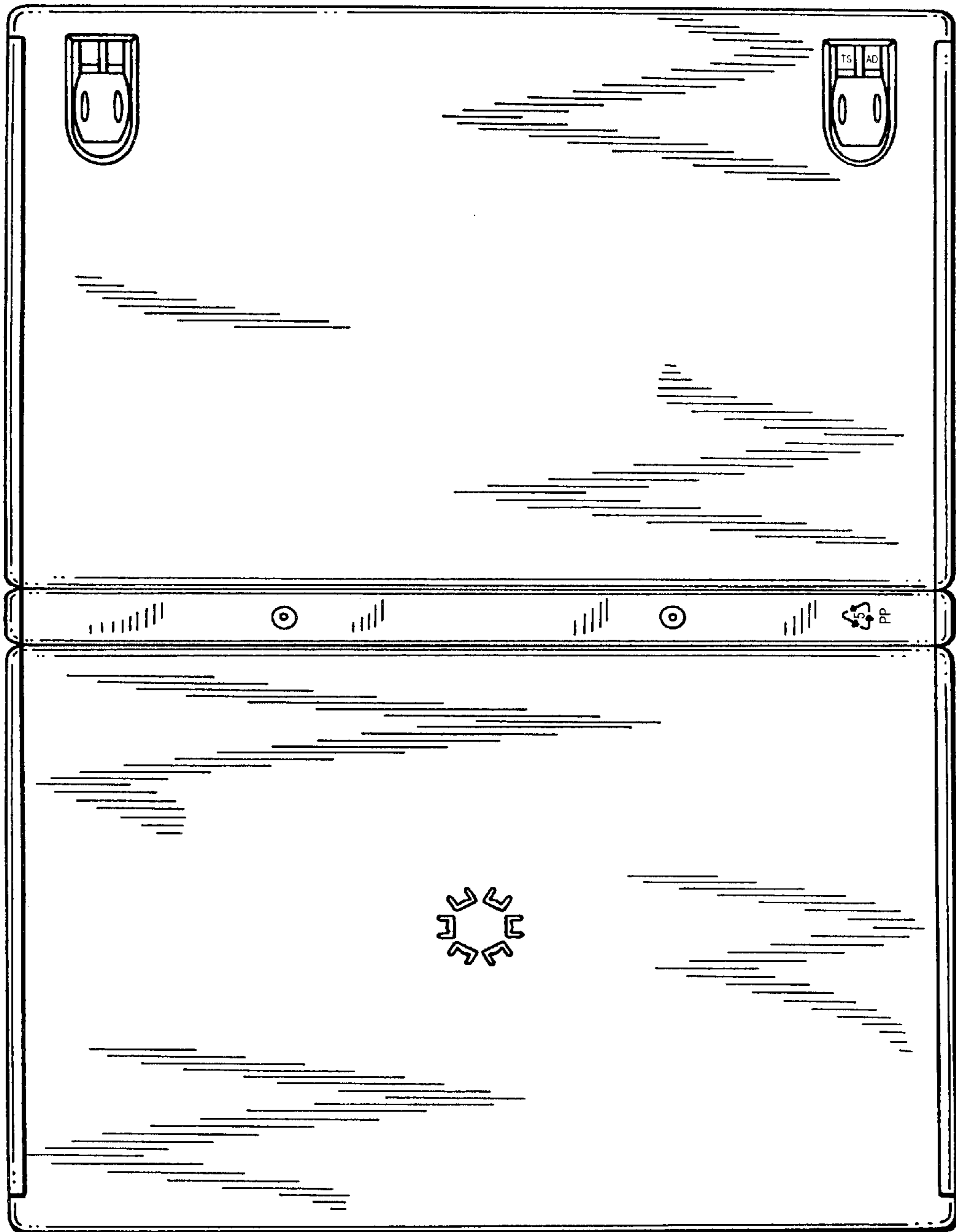

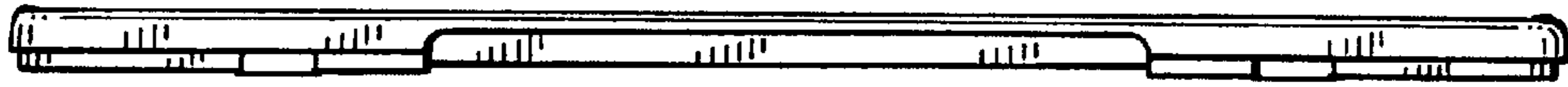

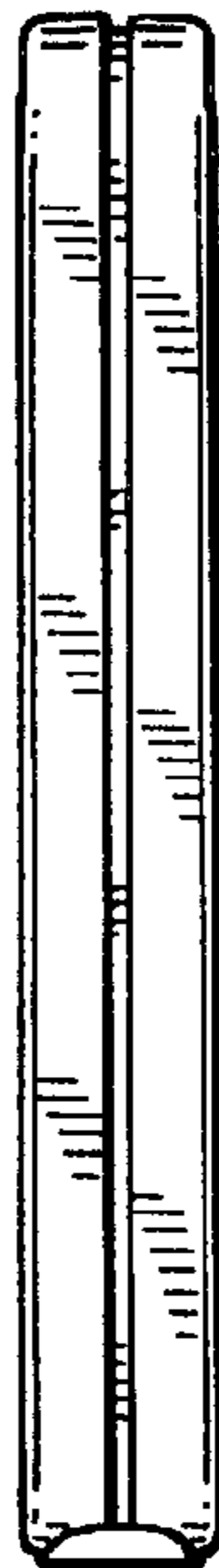

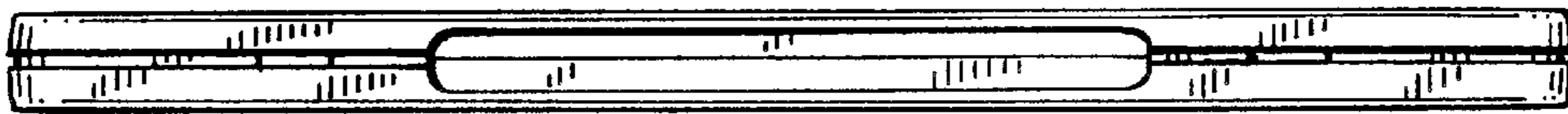

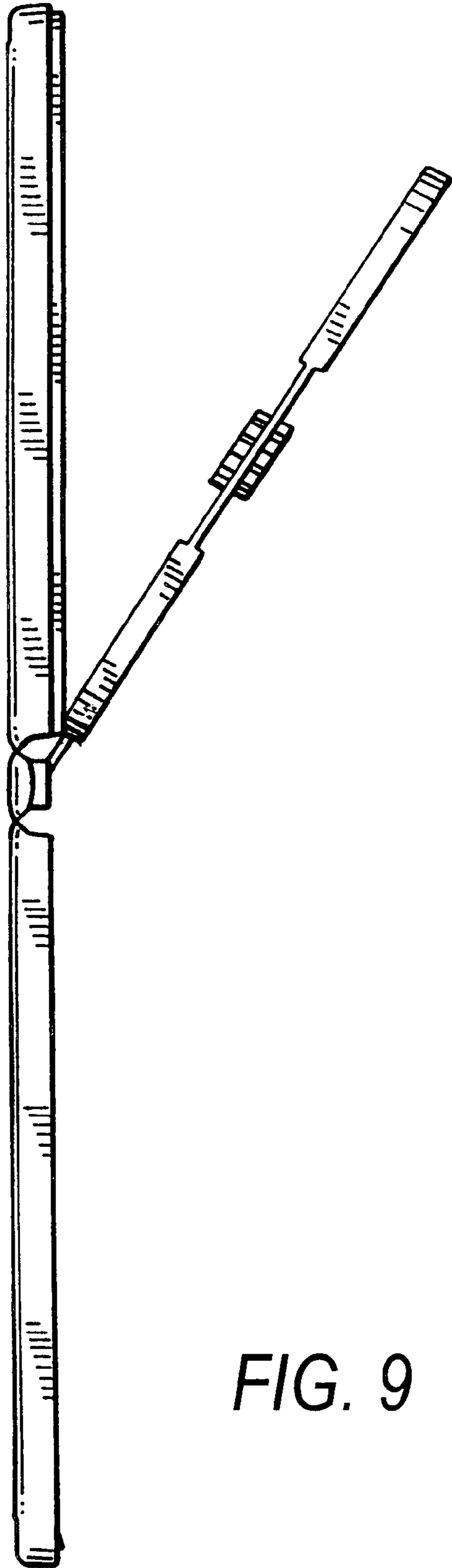
