(57) **CLAIM**

The ornamental design for a hacksaw, as shown and described.

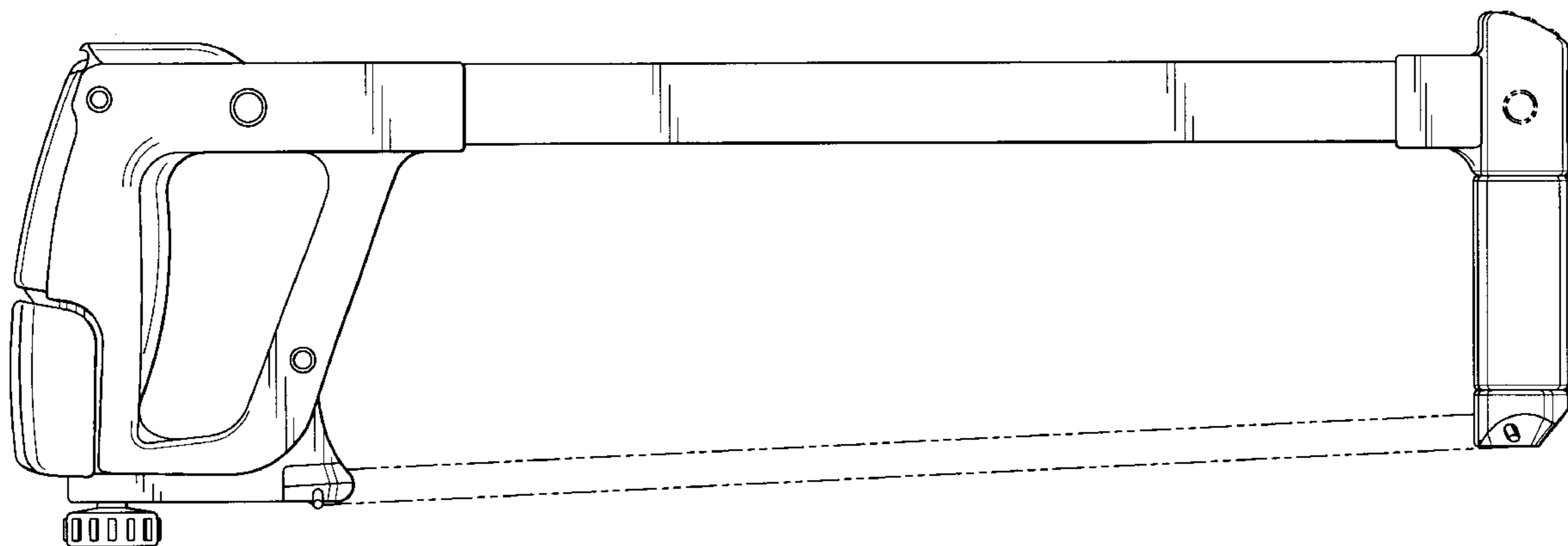
DESCRIPTION

FIG. 1 is a left side elevational view showing my new design;
 FIG. 2 is a rear elevational view of the hacksaw of FIG. 1;
 FIG. 3 is a right side elevational view of the hacksaw of FIG. 1;
 FIG. 4 is a front elevational view of the hacksaw of FIG. 1;
 FIG. 5 is a top plan view of the hacksaw of FIG. 1;
 FIG. 6 is a bottom plan view of the hacksaw of FIG. 1;
 FIG. 7 is a left side elevational view of a portion of the hacksaw of FIG. 1 illustrating the front pillar in greater detail; and,
 FIG. 8 is another left side elevational view of the hacksaw of FIG. 1.

The broken lines showing a hacksaw blade in FIGS. 1, 3, 7 and 8, the hole for receiving a screw to retain the front pillar of the hacksaw to the hacksaw frame in FIGS. 1, 4, 7 and 8 and the end cap plugs in FIG. 8 are environmental only and form no part of the claimed design.

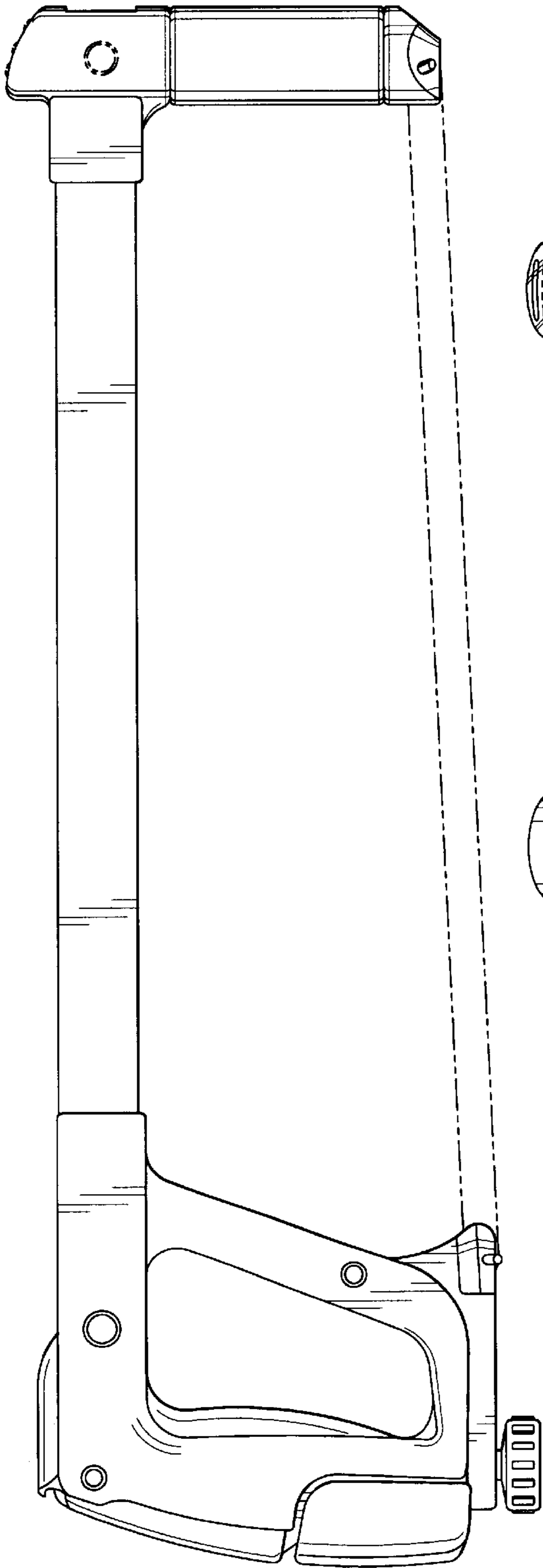

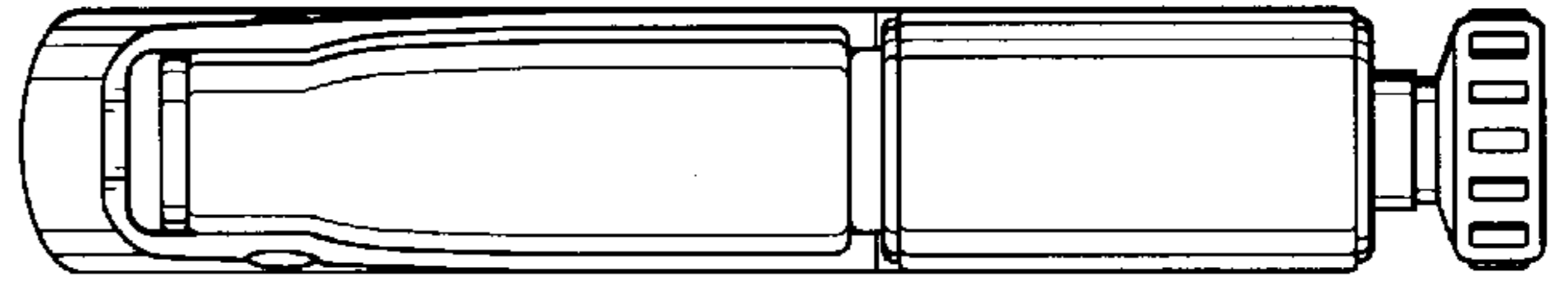

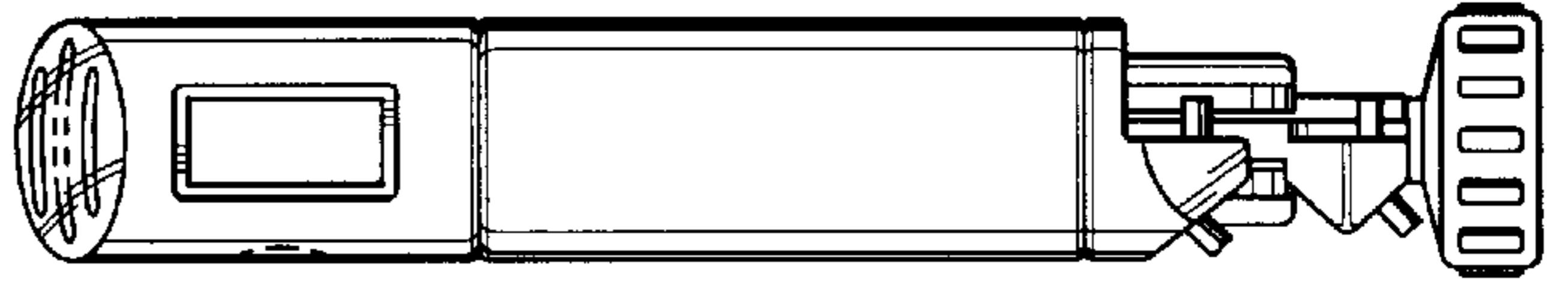

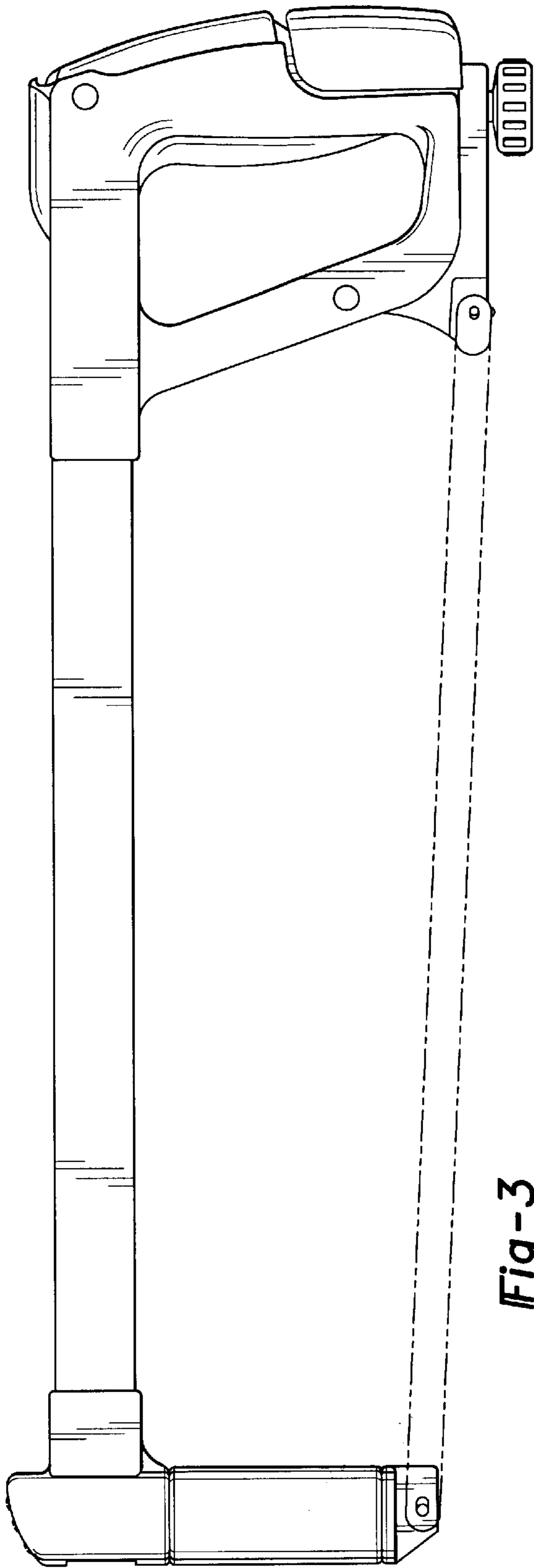

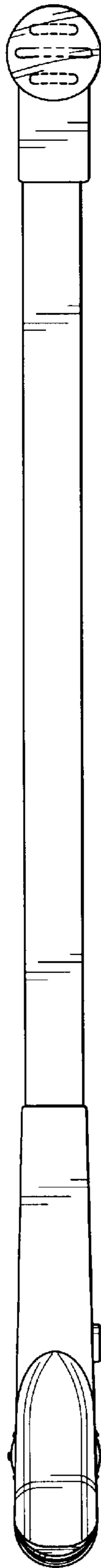

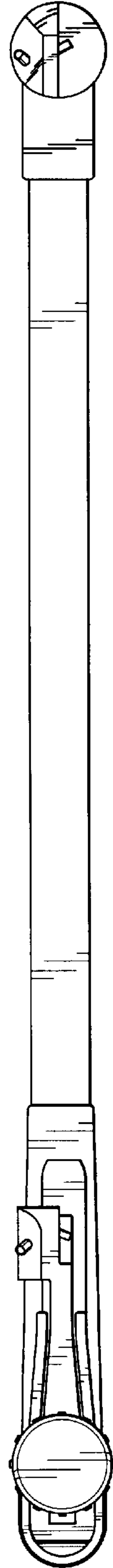

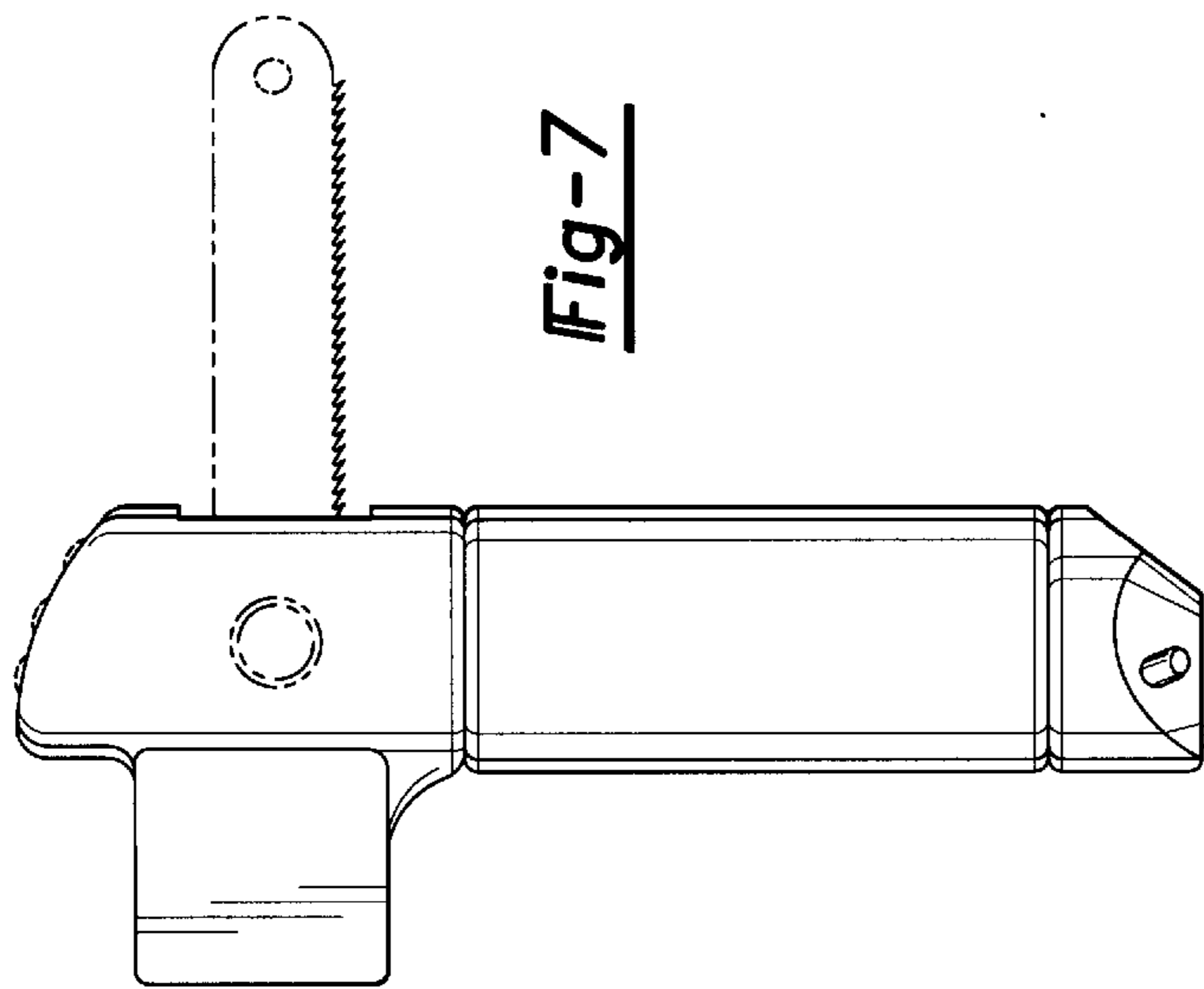

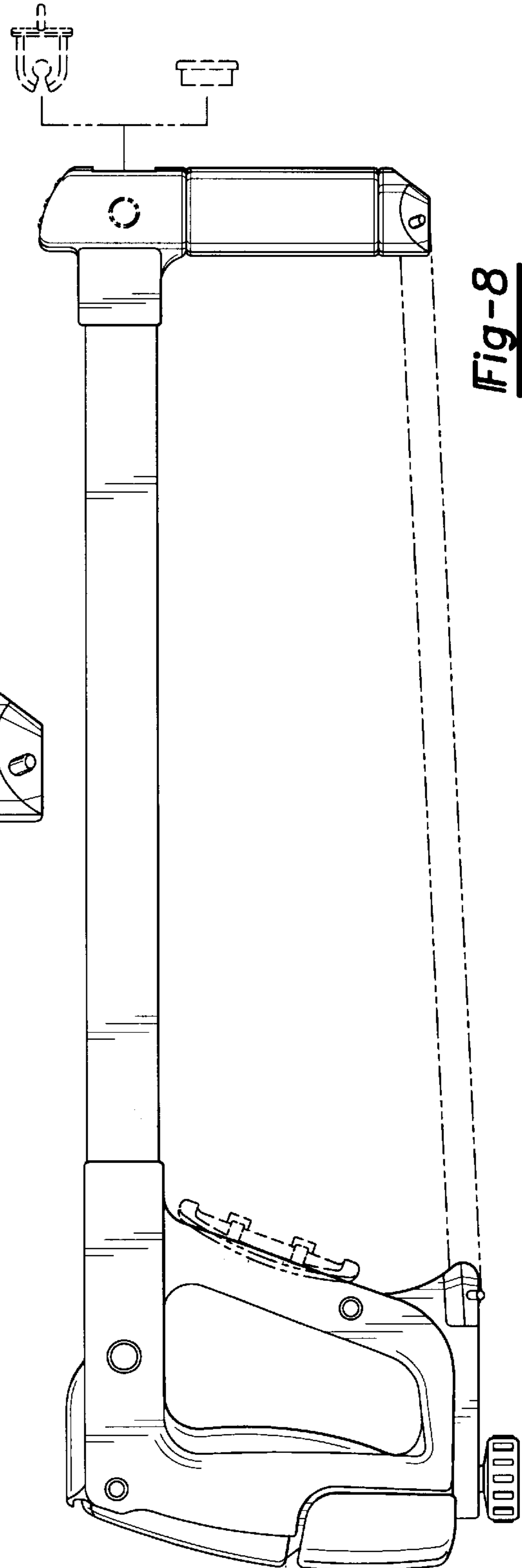
