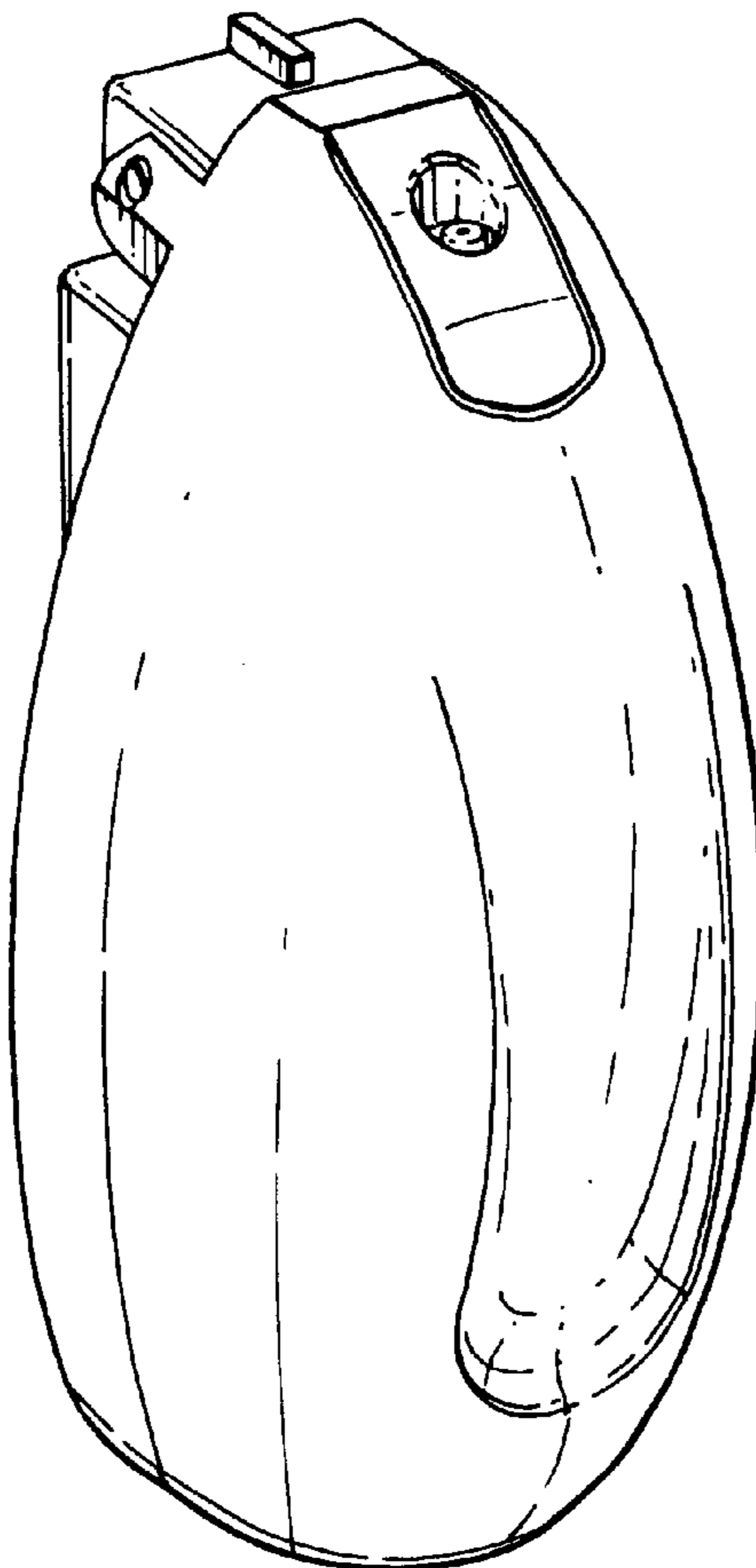
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an upper left side perspective view of a dispenser in accordance with our new design;  
FIG. 2 is a left side elevation view thereof;

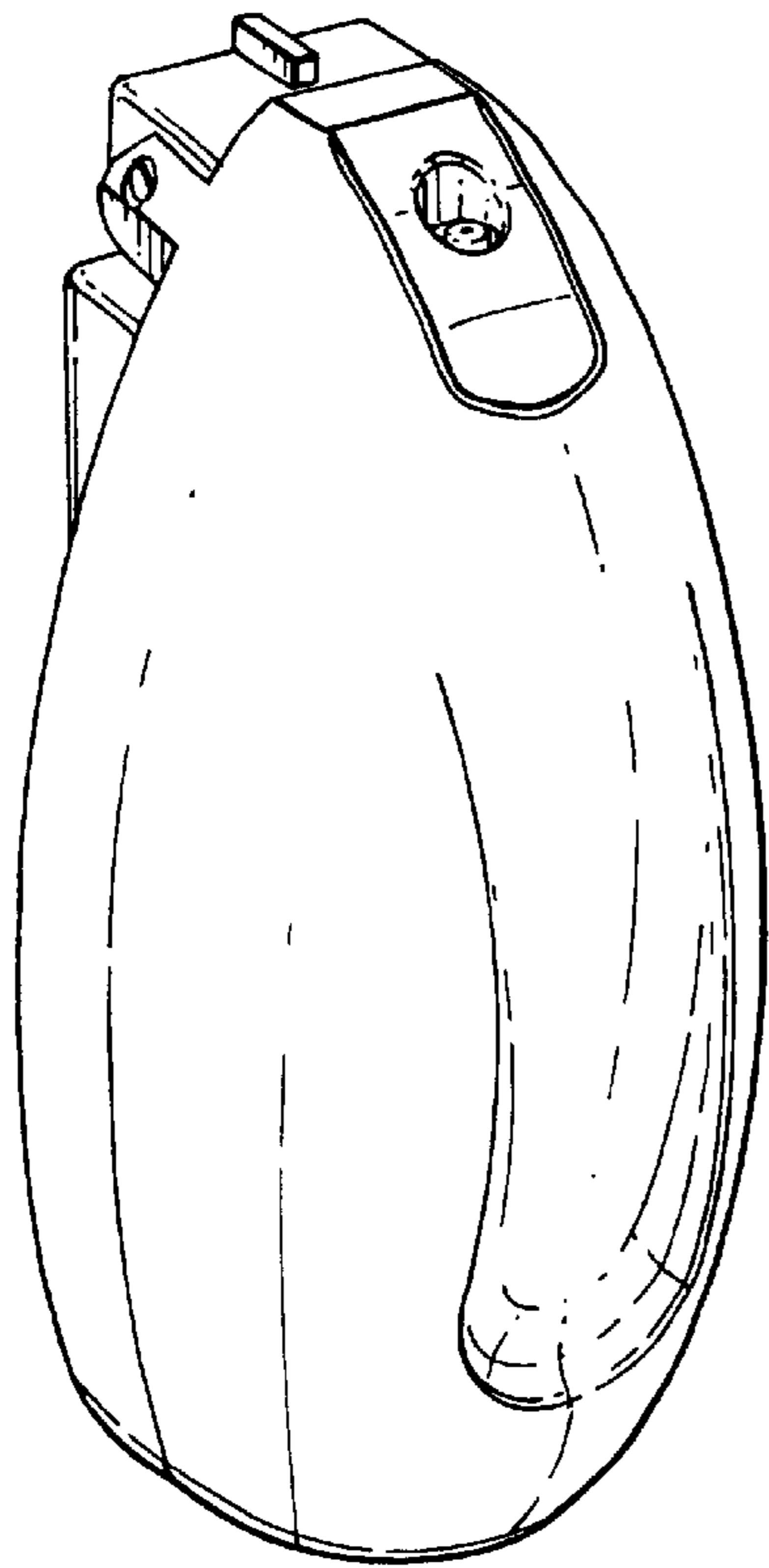

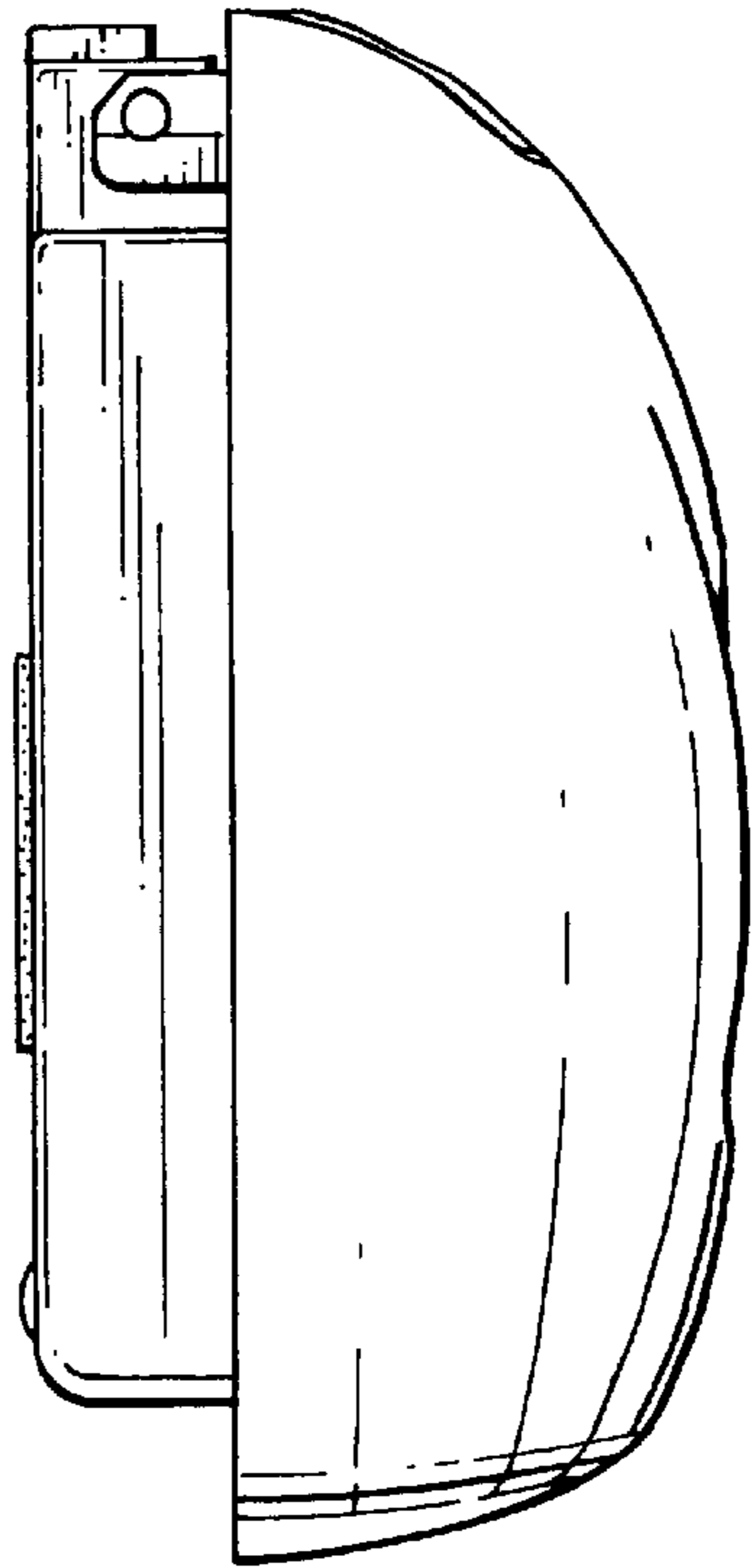

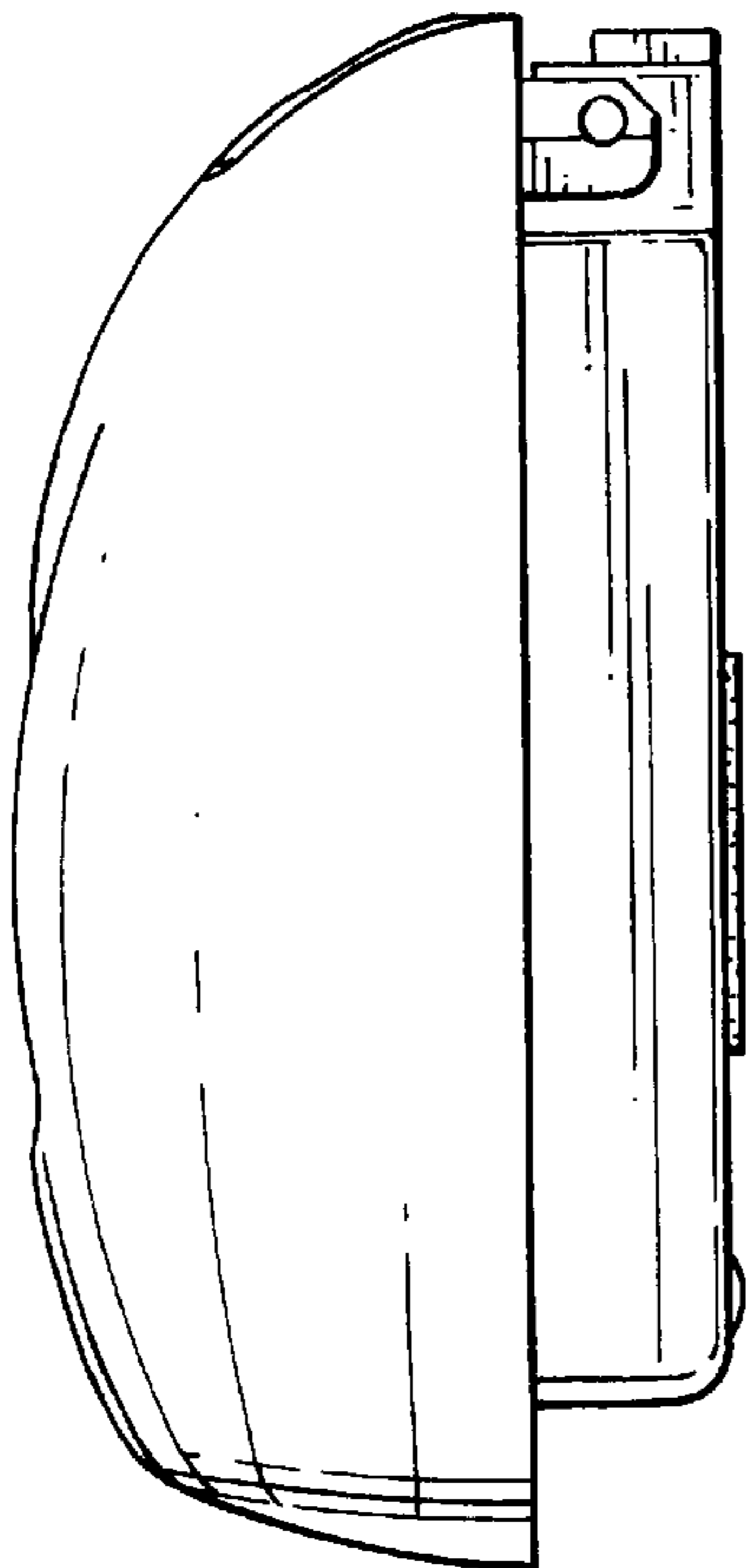

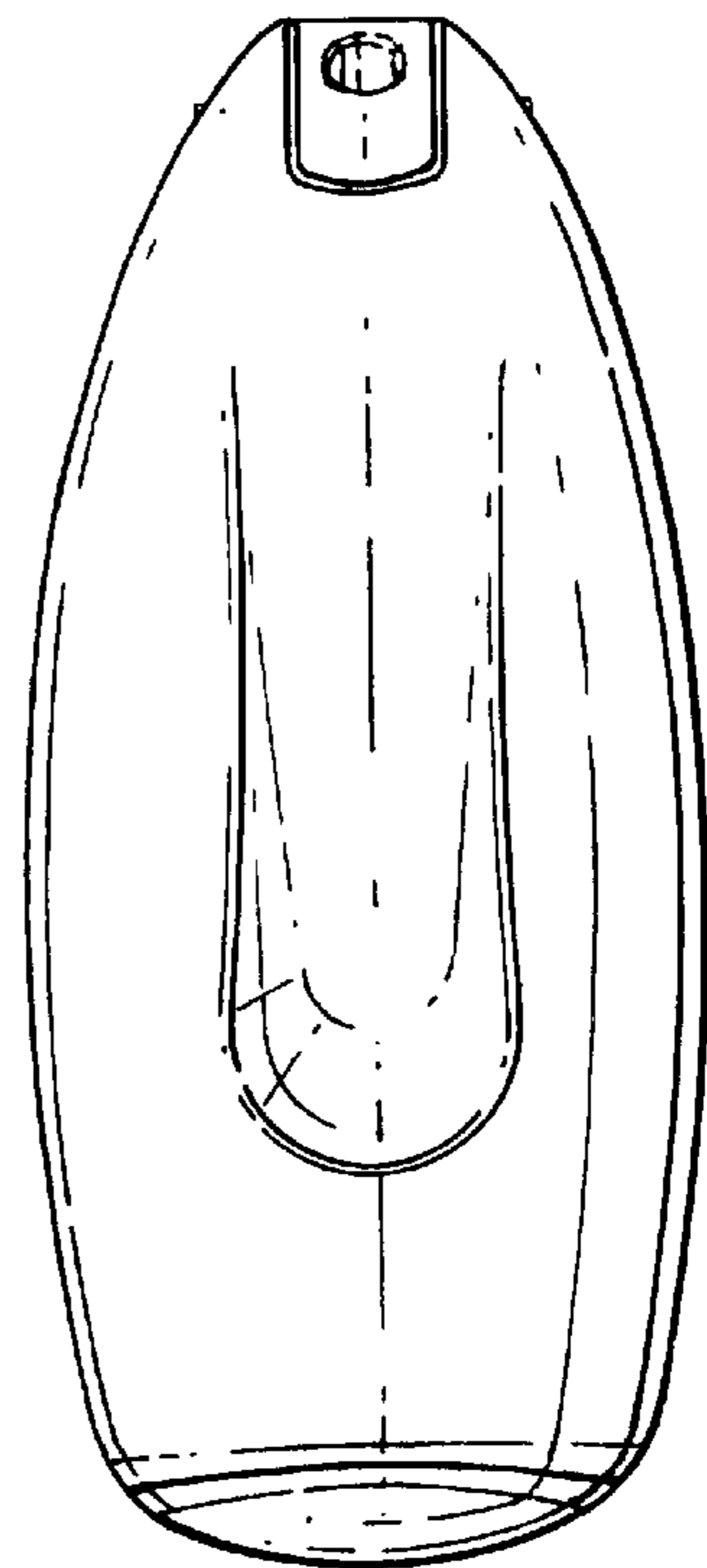

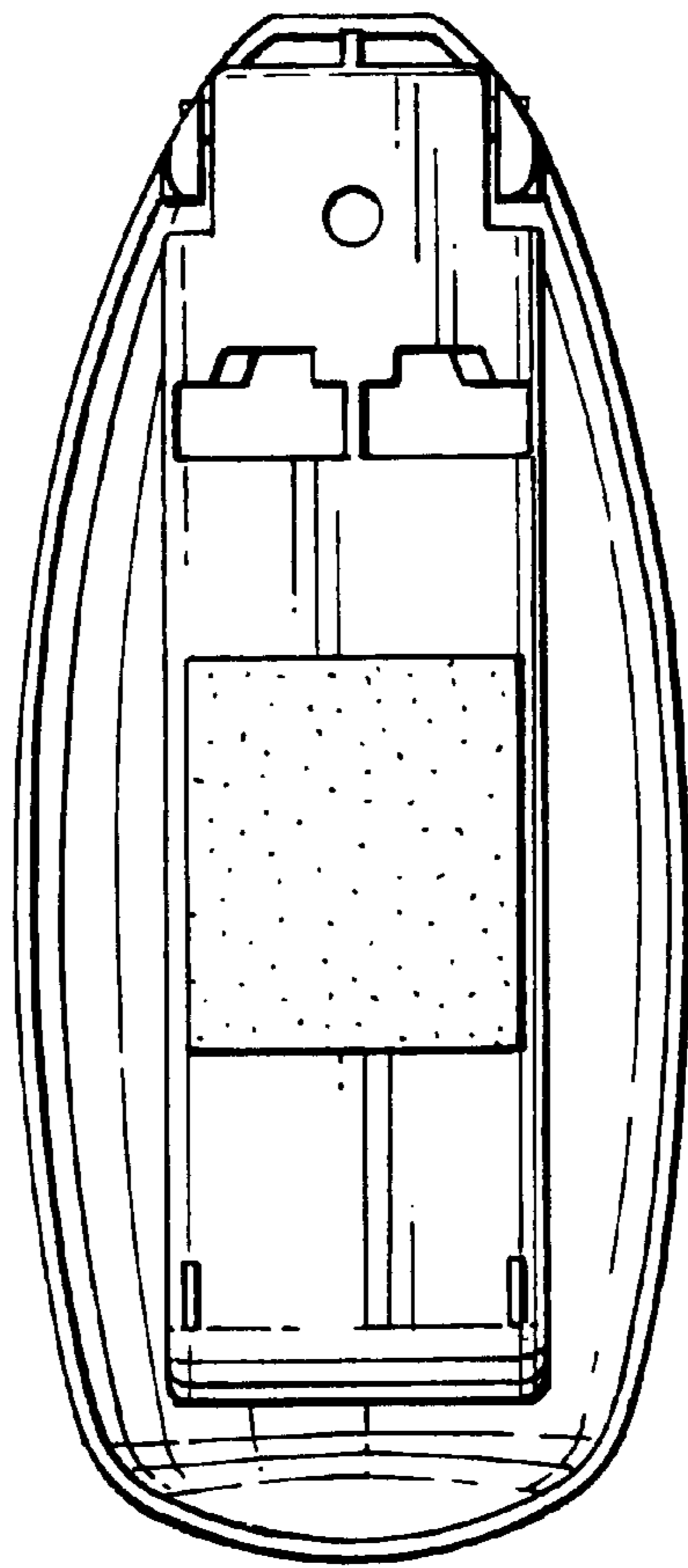

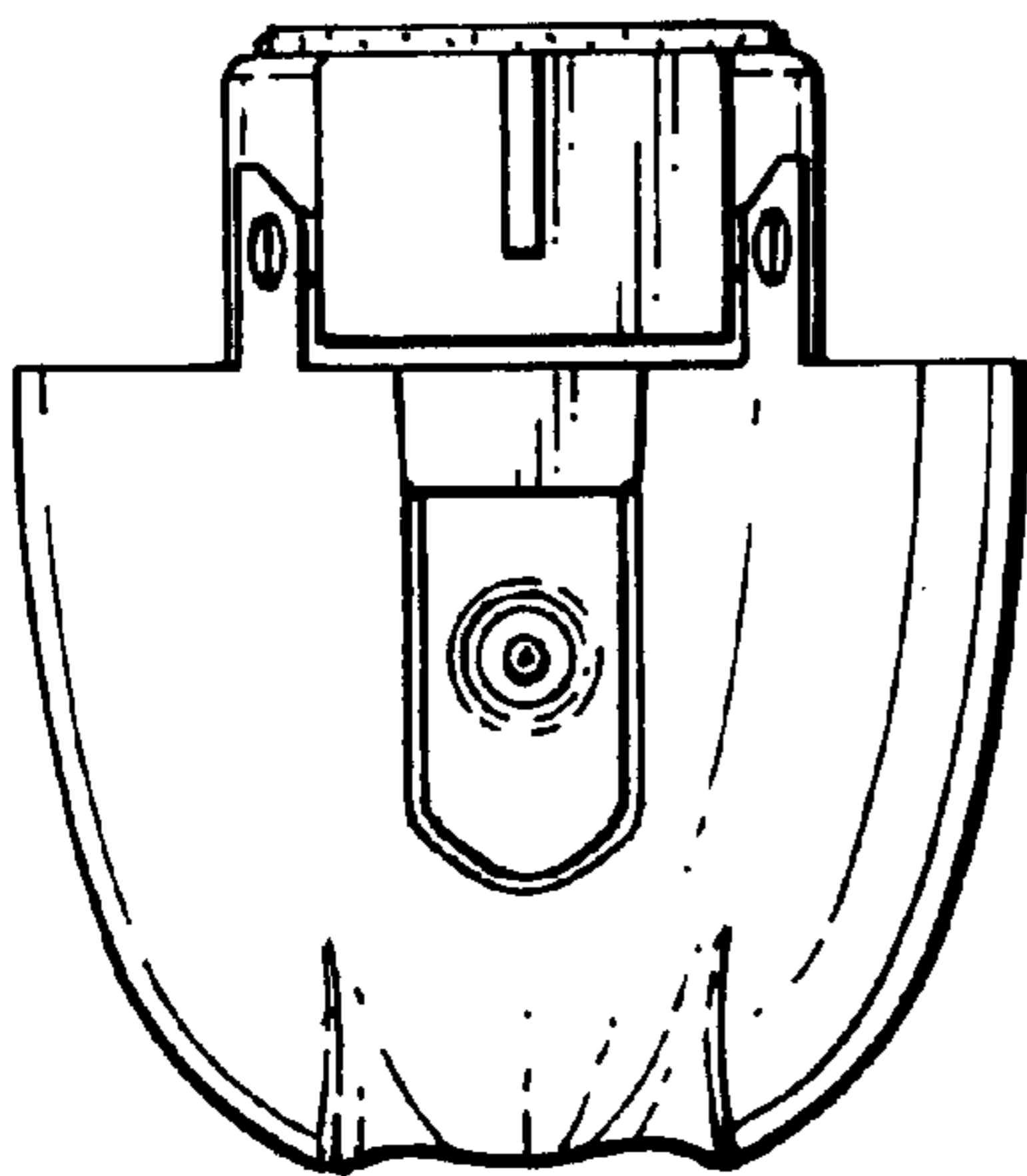

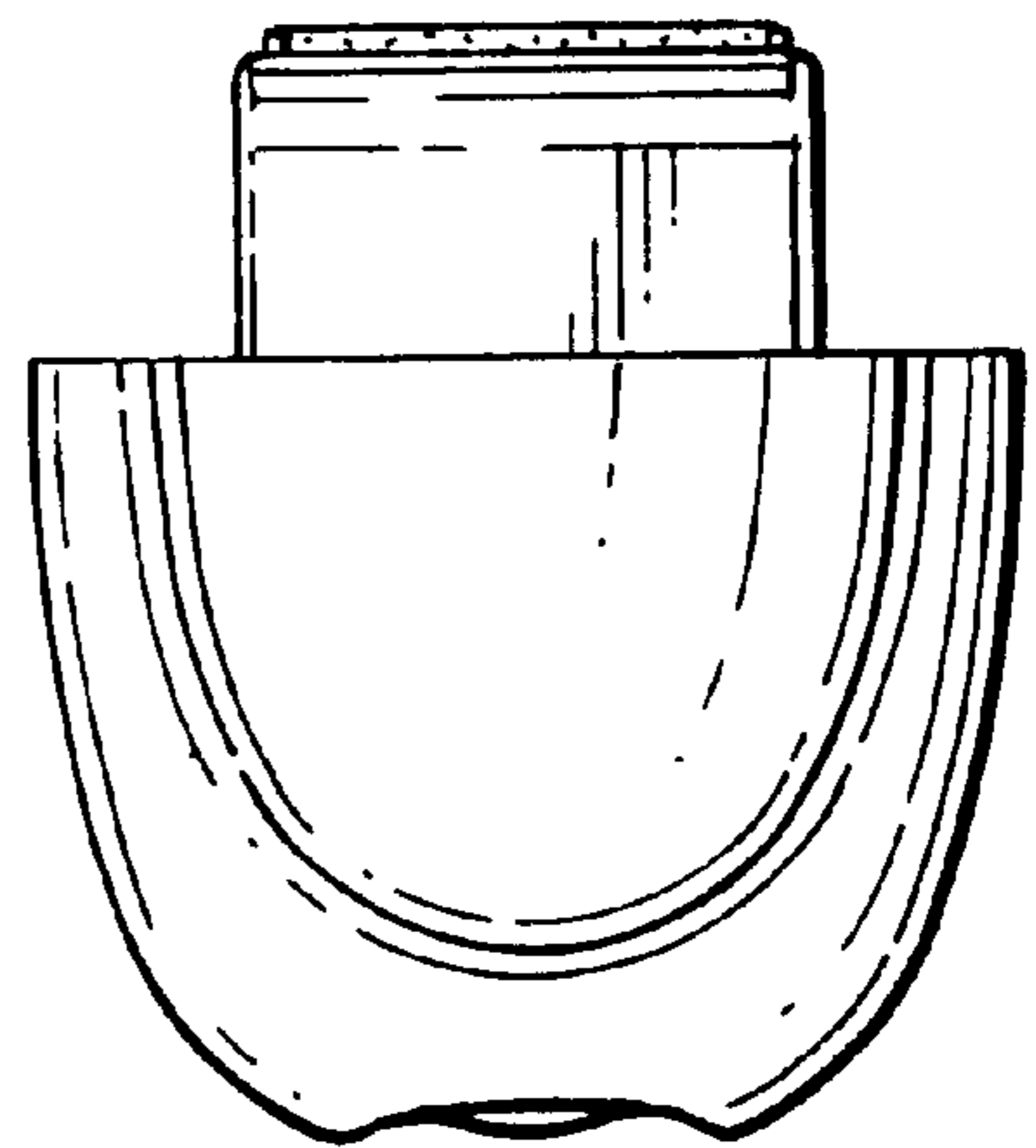
