**DESCRIPTION**

FIG. 1 is a perspective view of the cap of my design.

FIG. 6 is an alternate embodiment of the cap of my design.

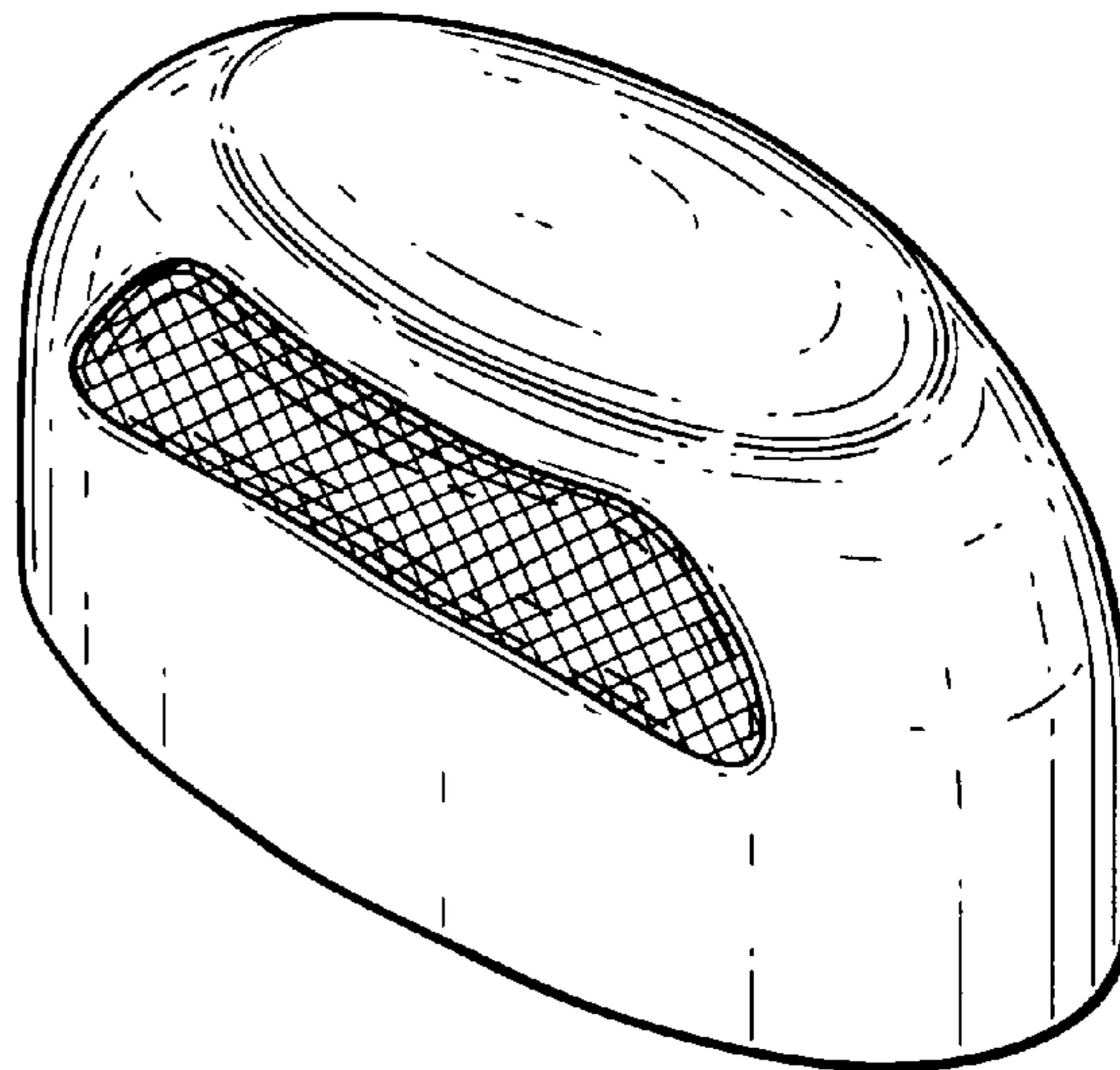
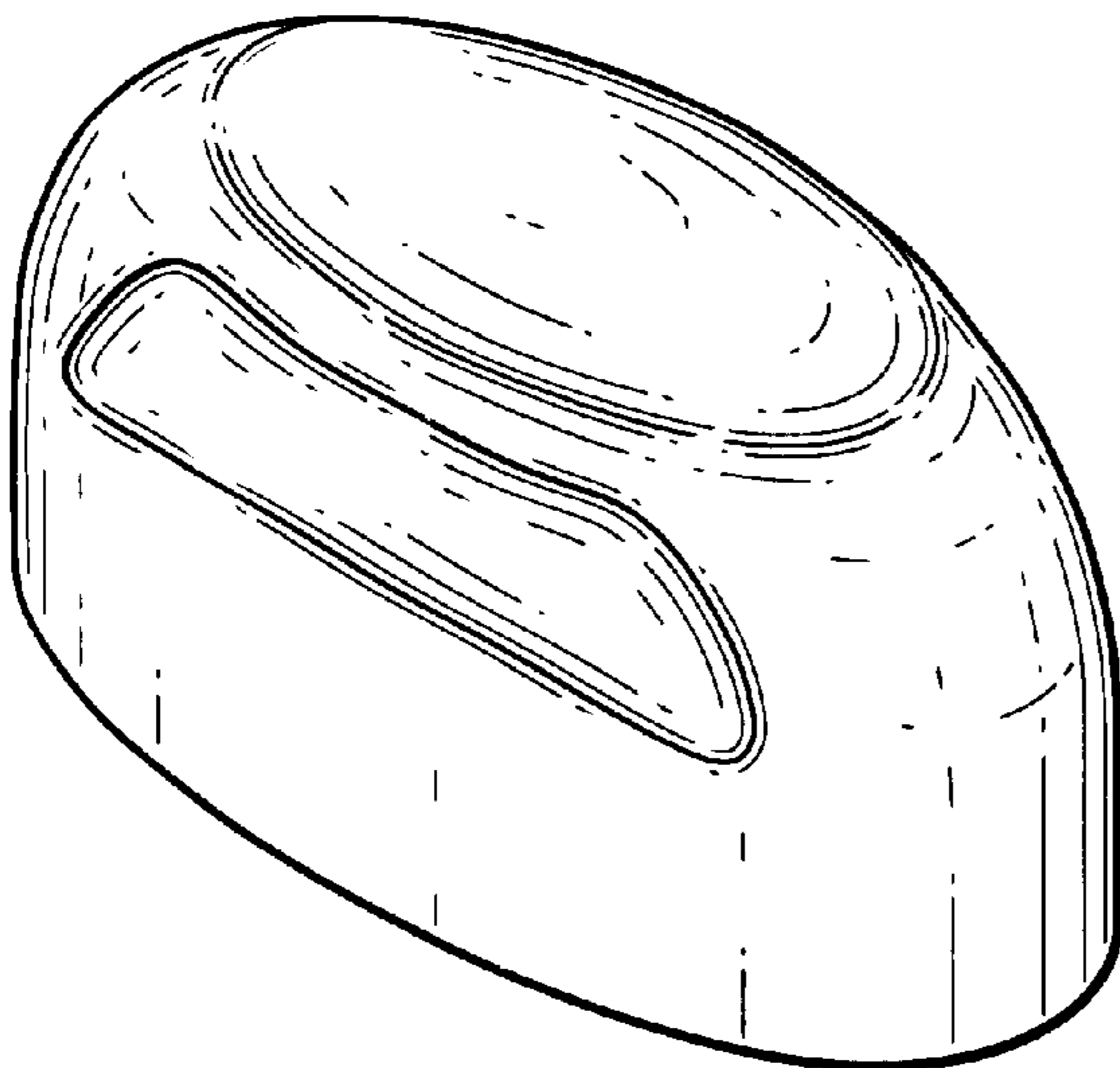
FIG. 7 is a front elevation view, the rear elevation view being a mirror image thereof.

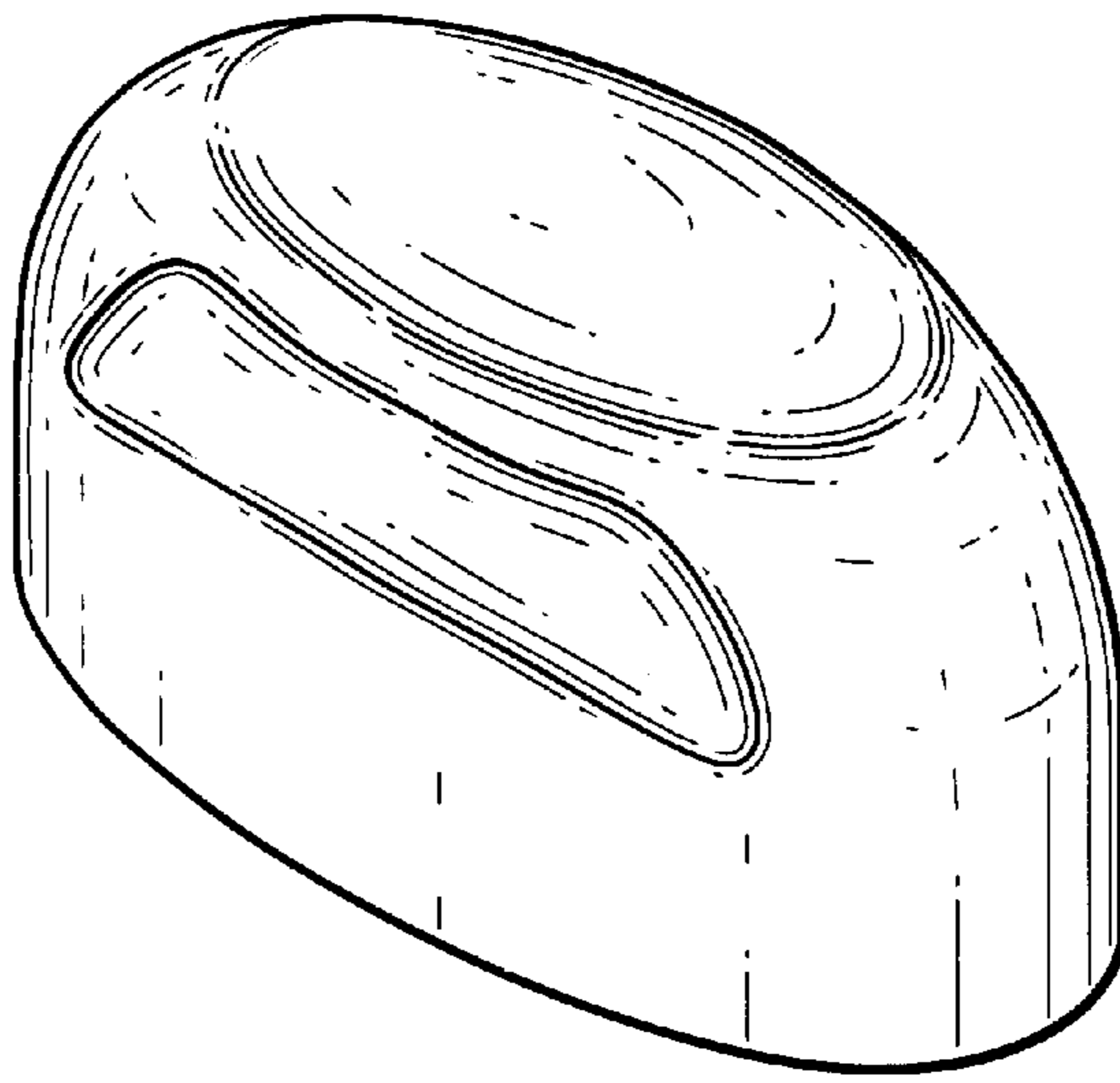

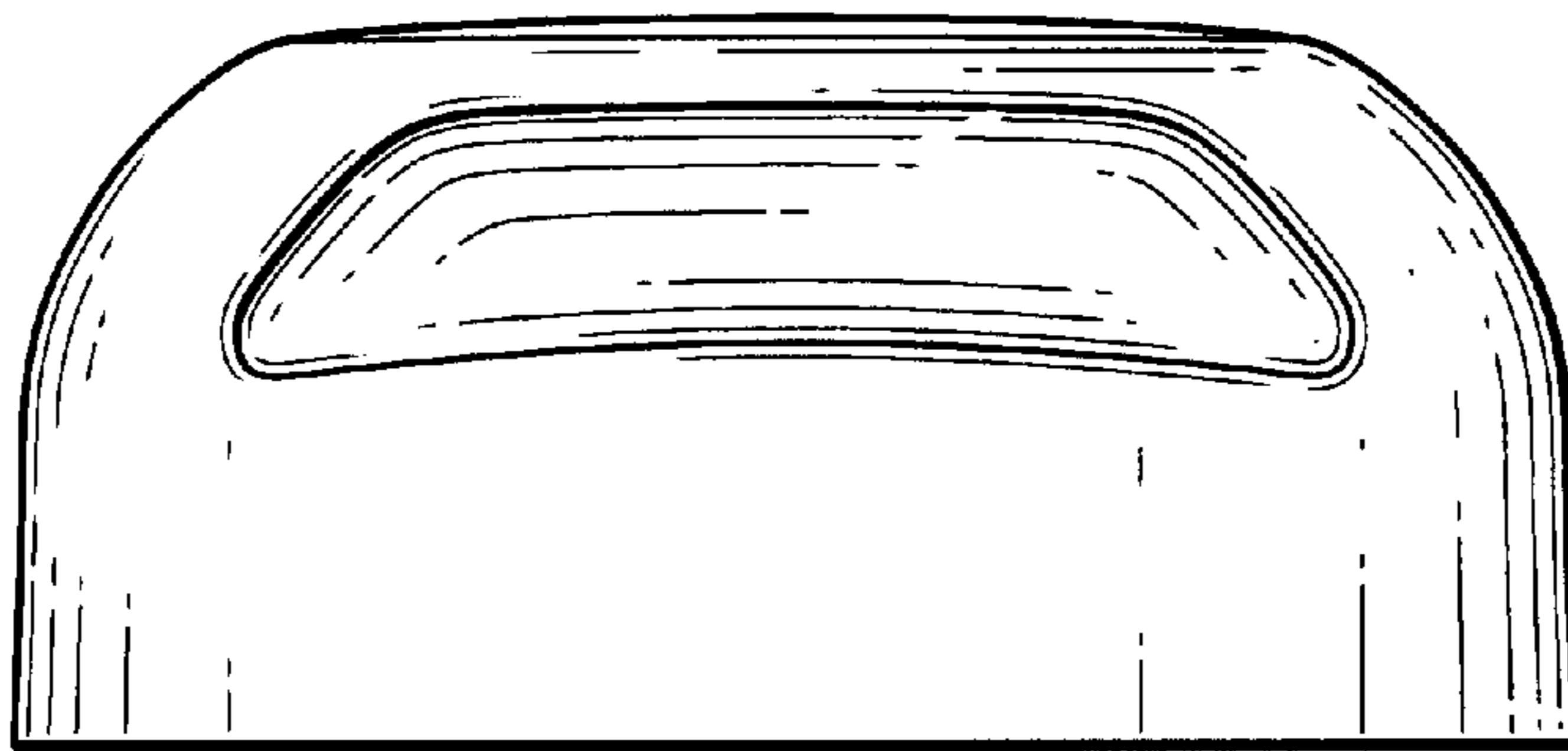

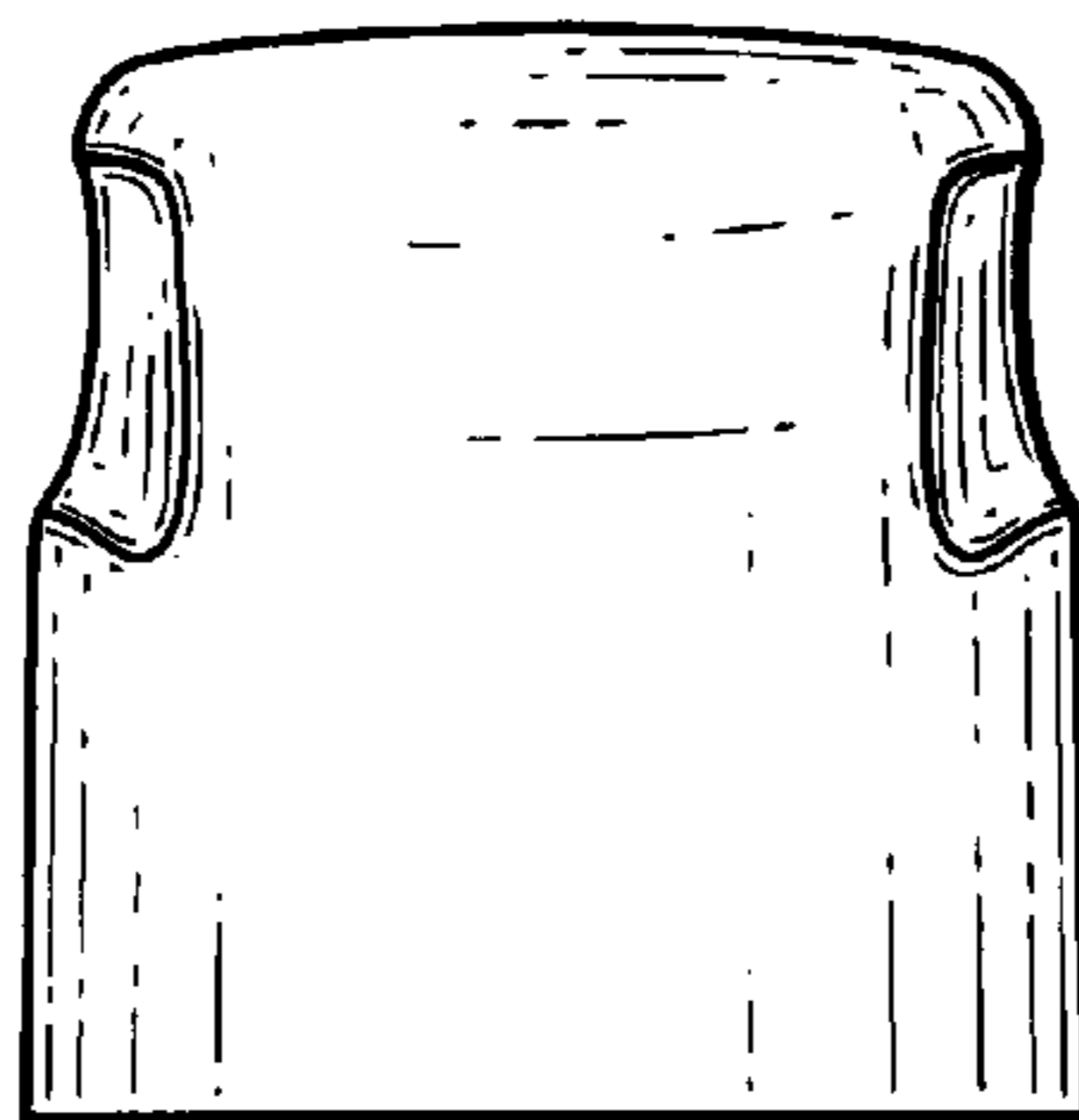

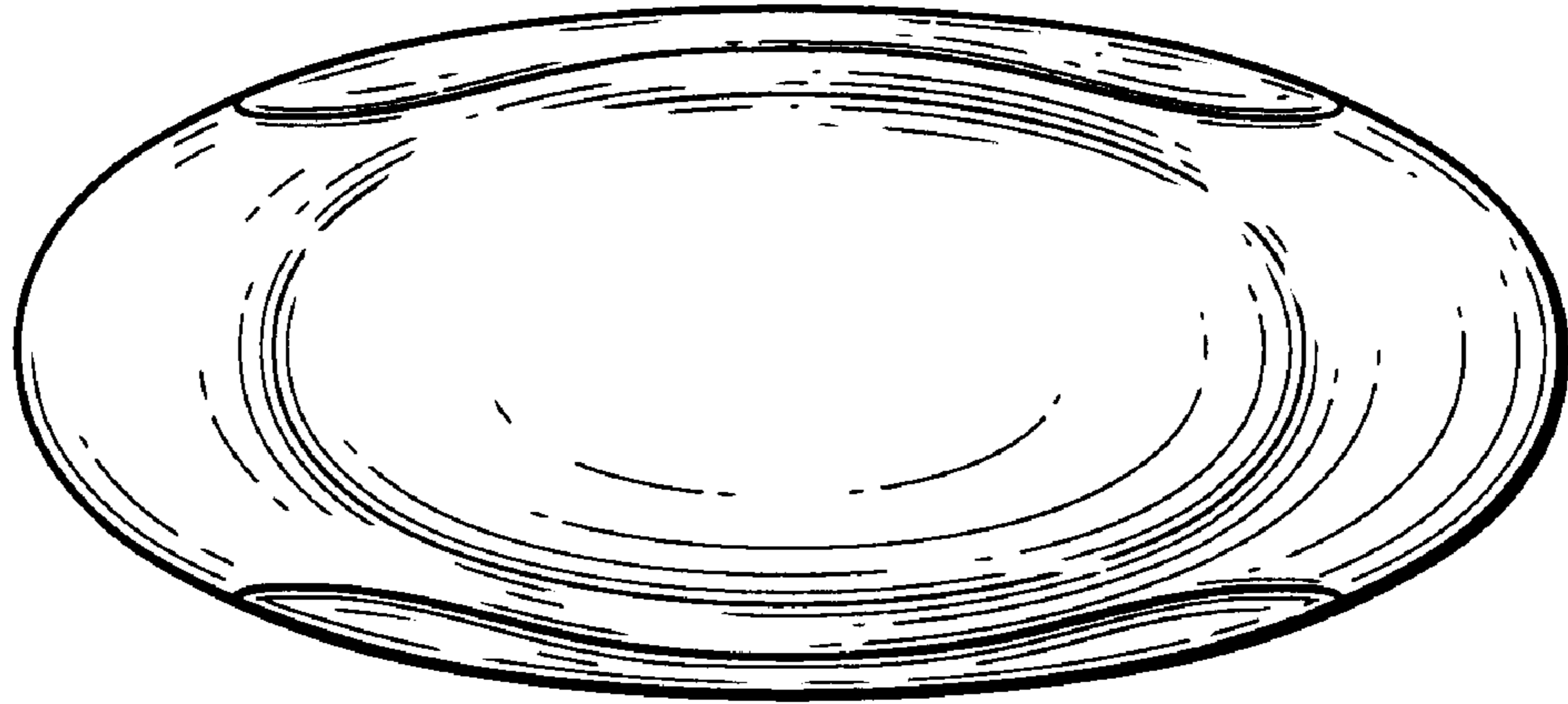

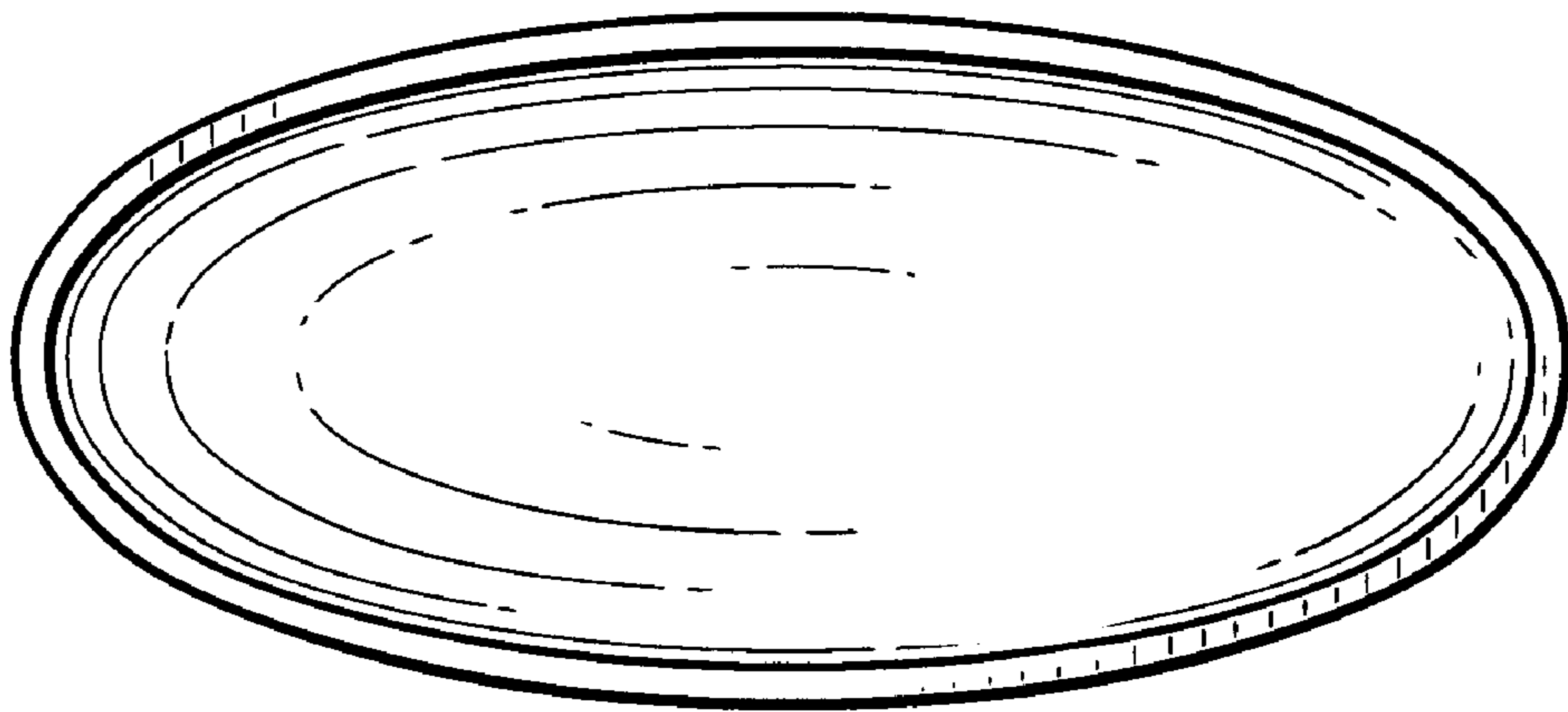

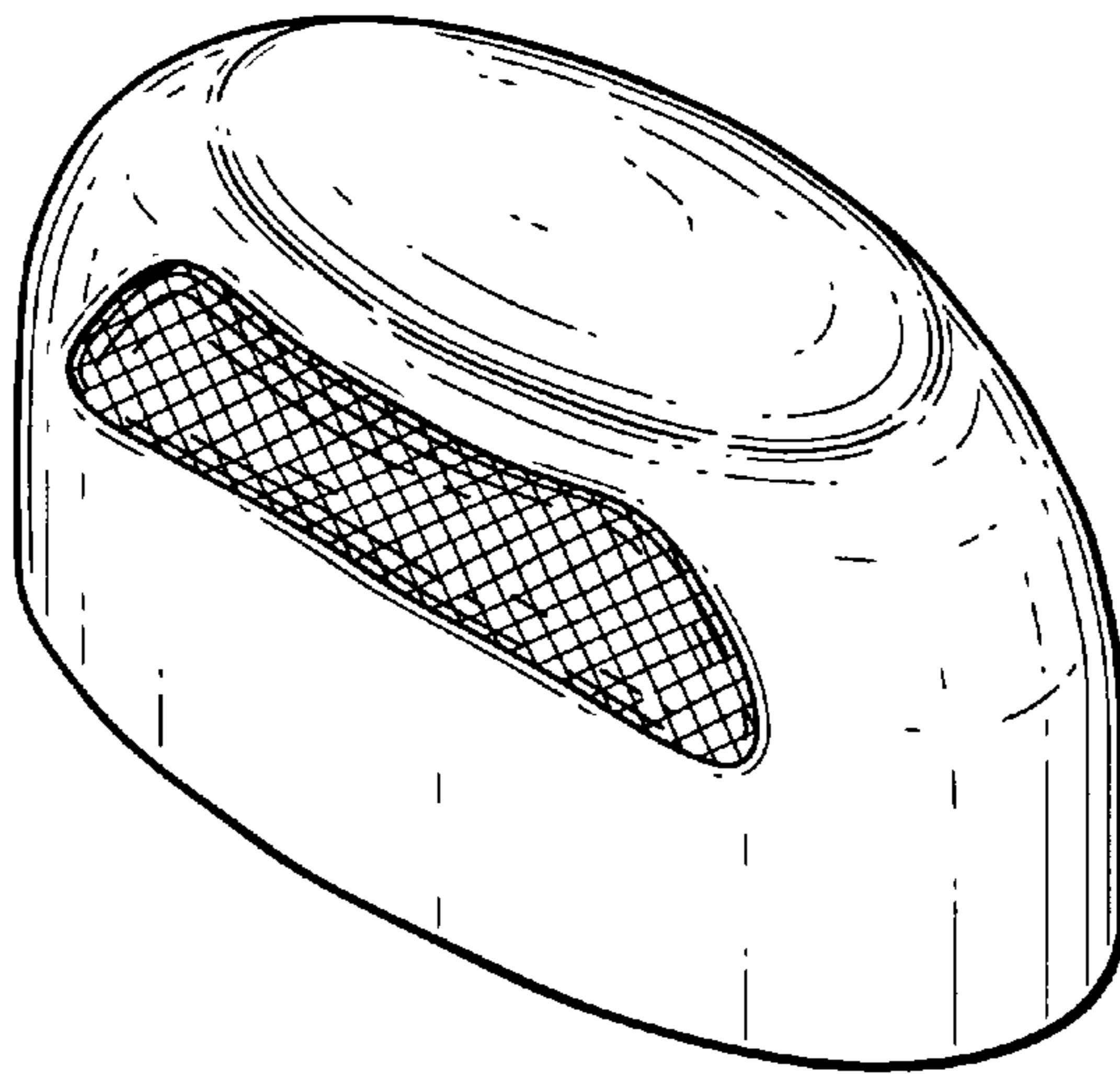

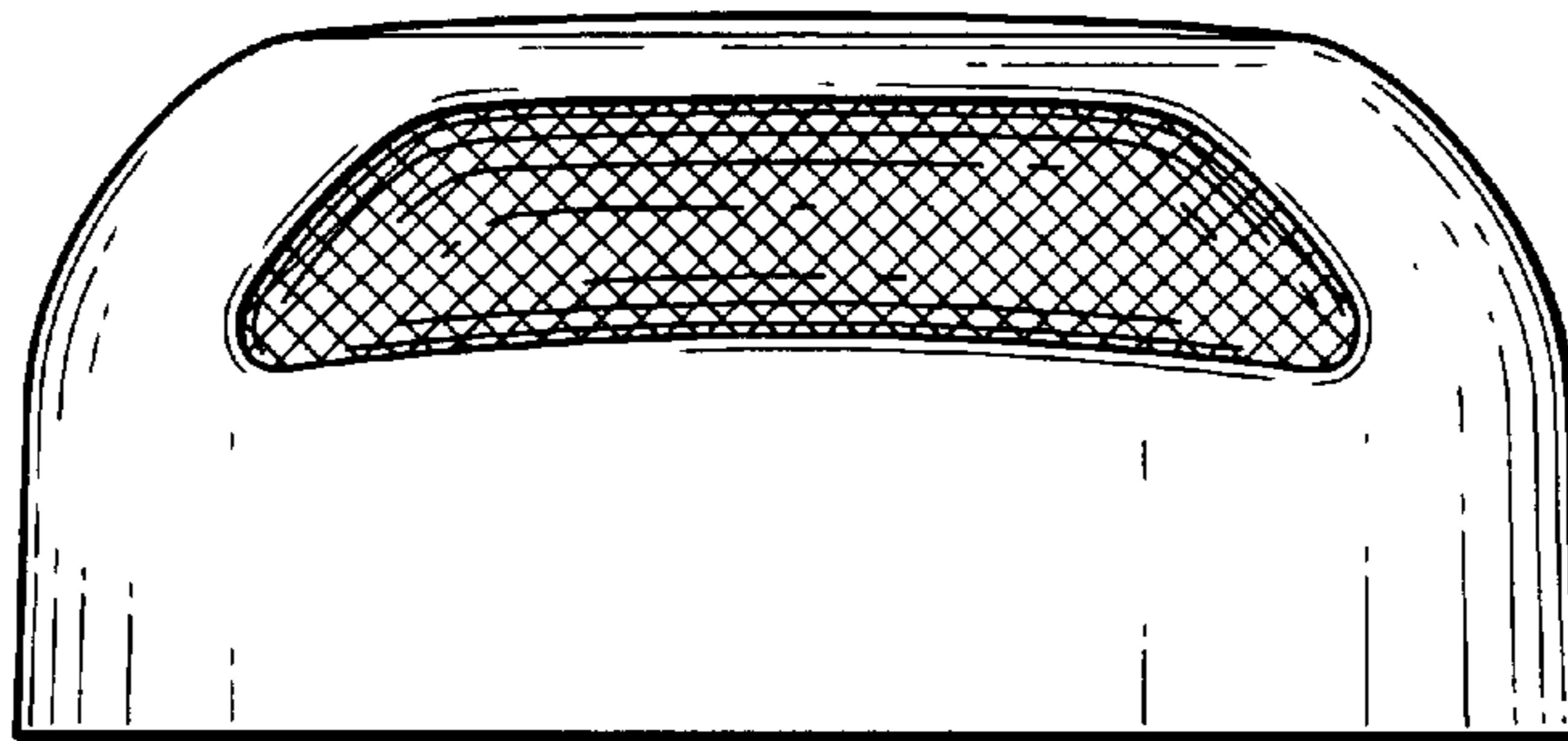

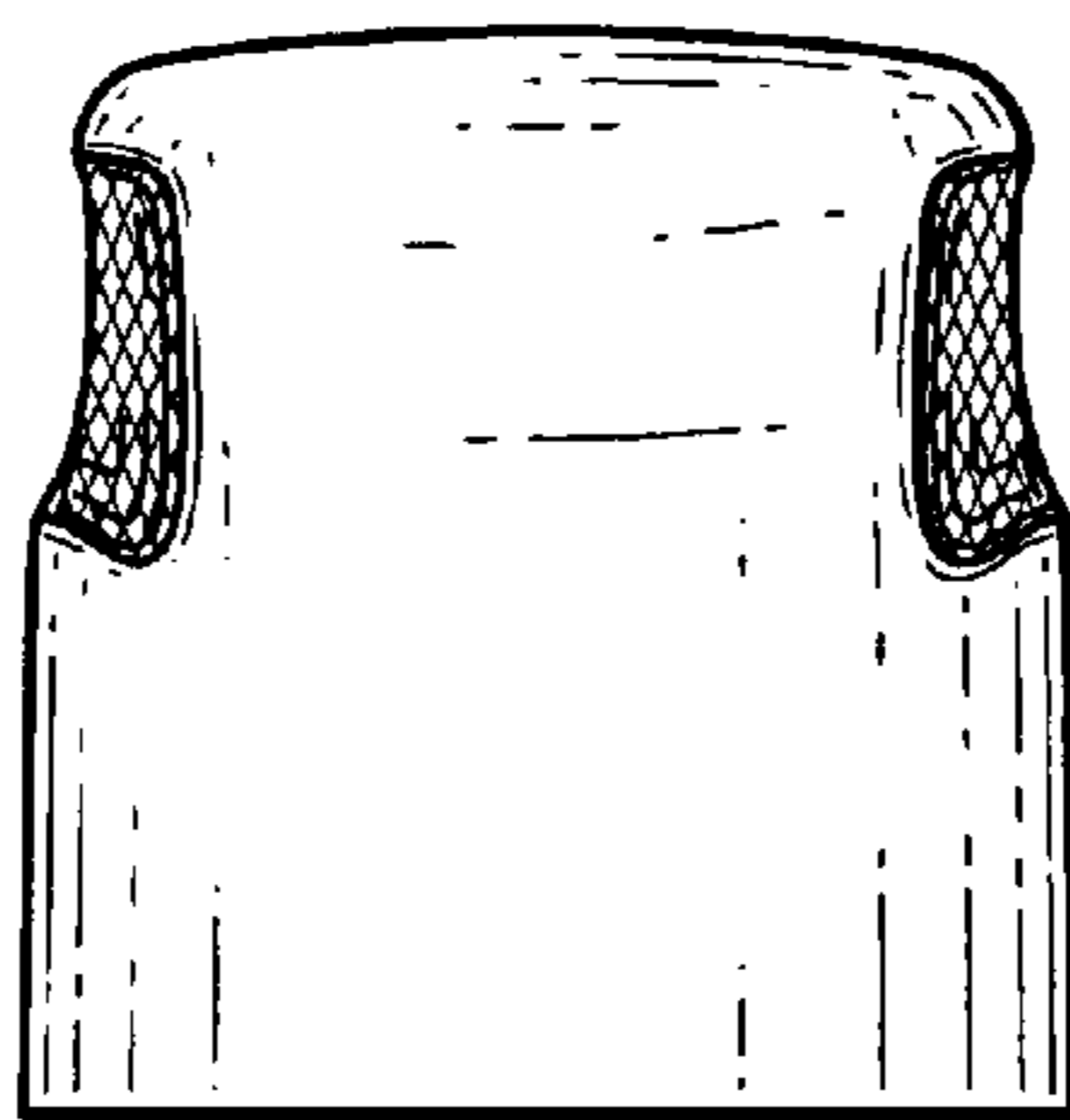

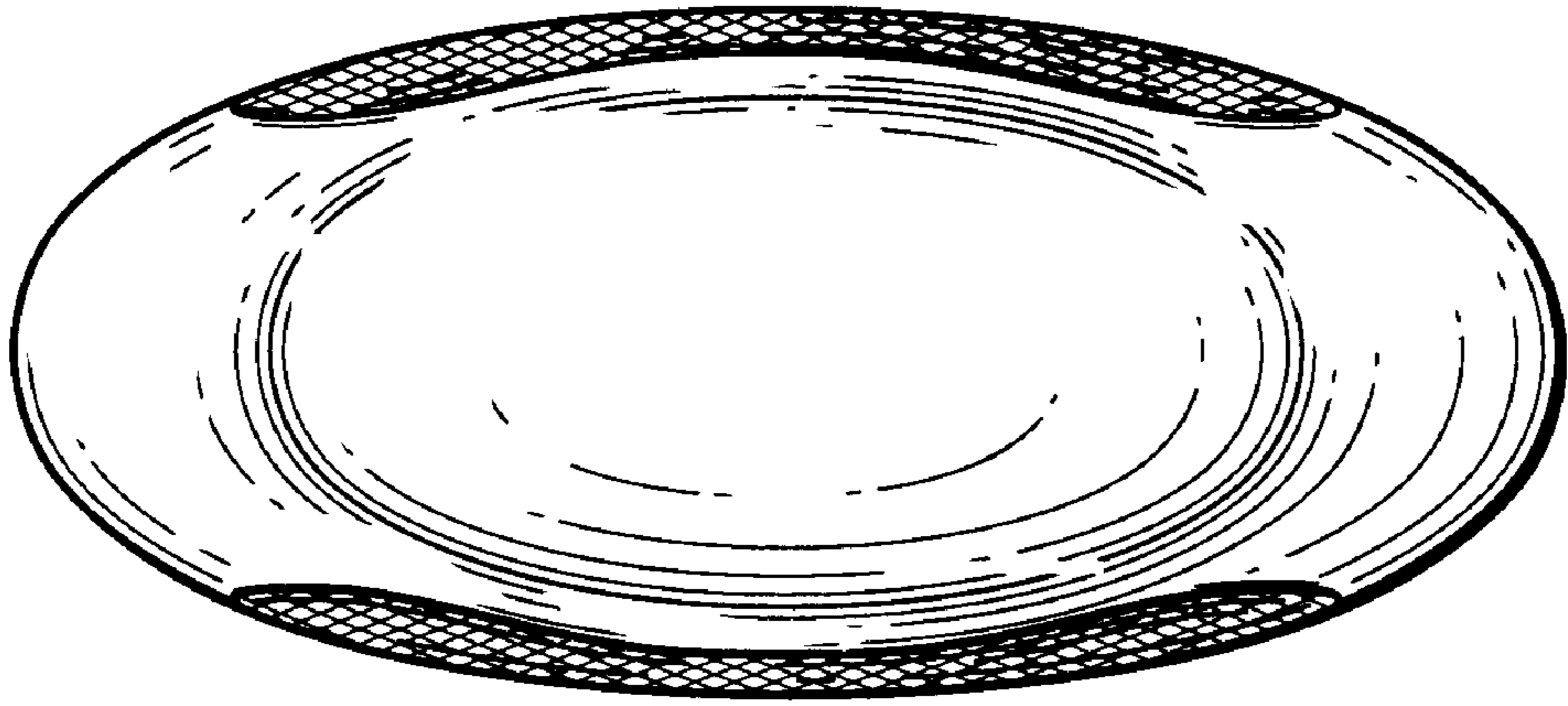

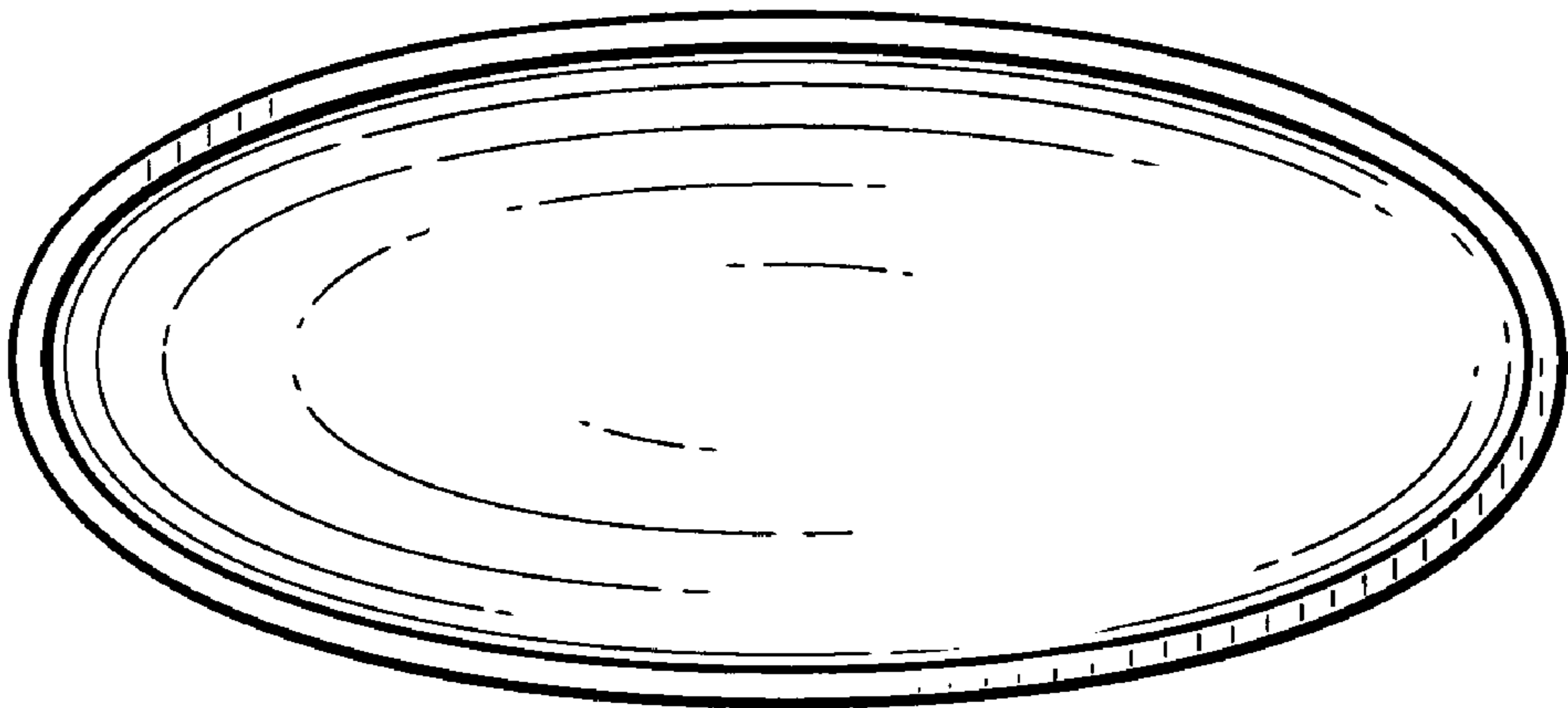
