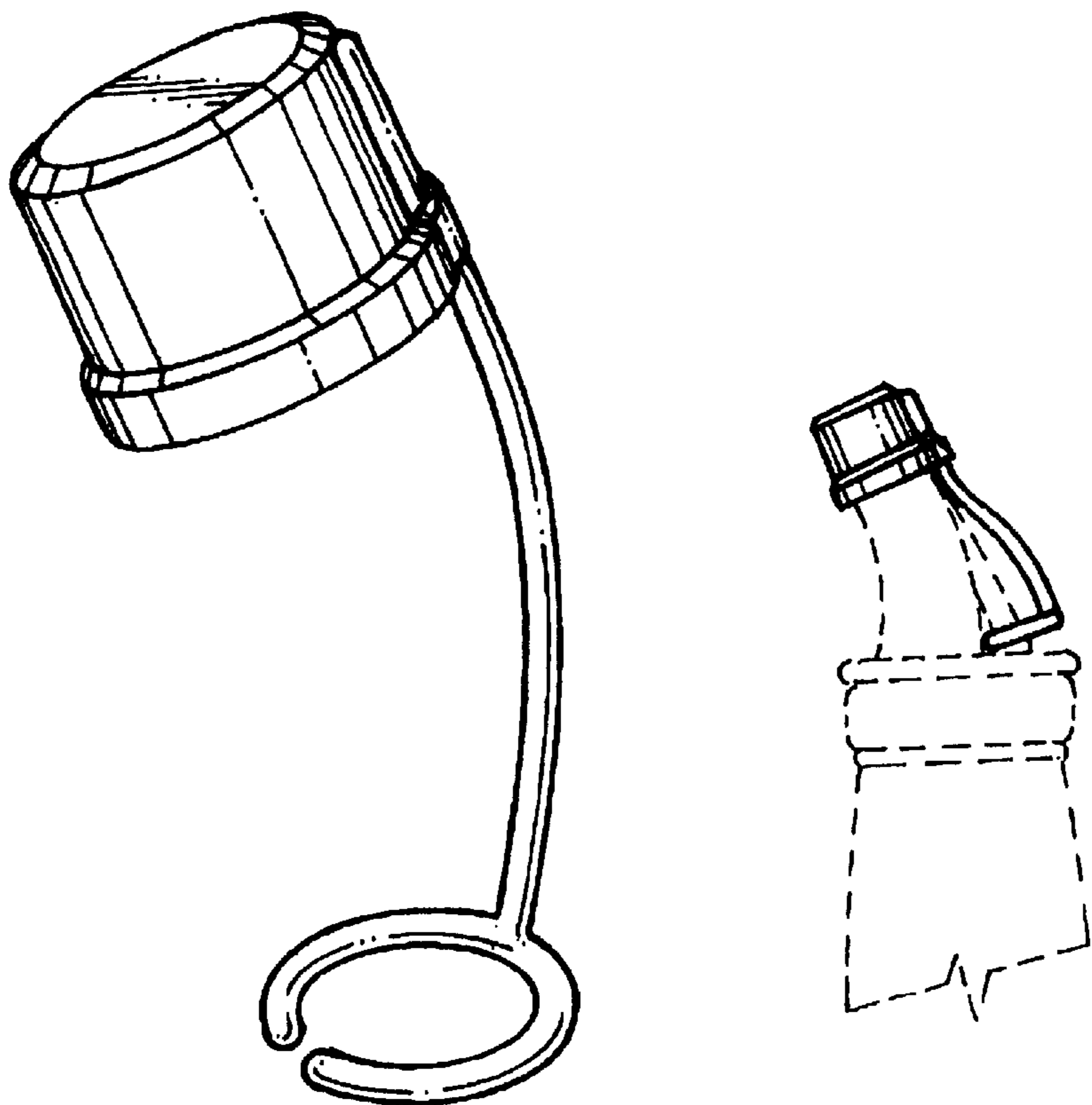
(57) **CLAIM**

I claim the ornamental design for a cap with mounting clip for beverage bottle measuring spout, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cap with mounting clip for beverage bottle measuring spout showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a reduced perspective view showing the cap with mounting clip for beverage bottle measuring spout in use; the broken lines show environmental structure for illustrative purposes only and form no part of the claimed design.

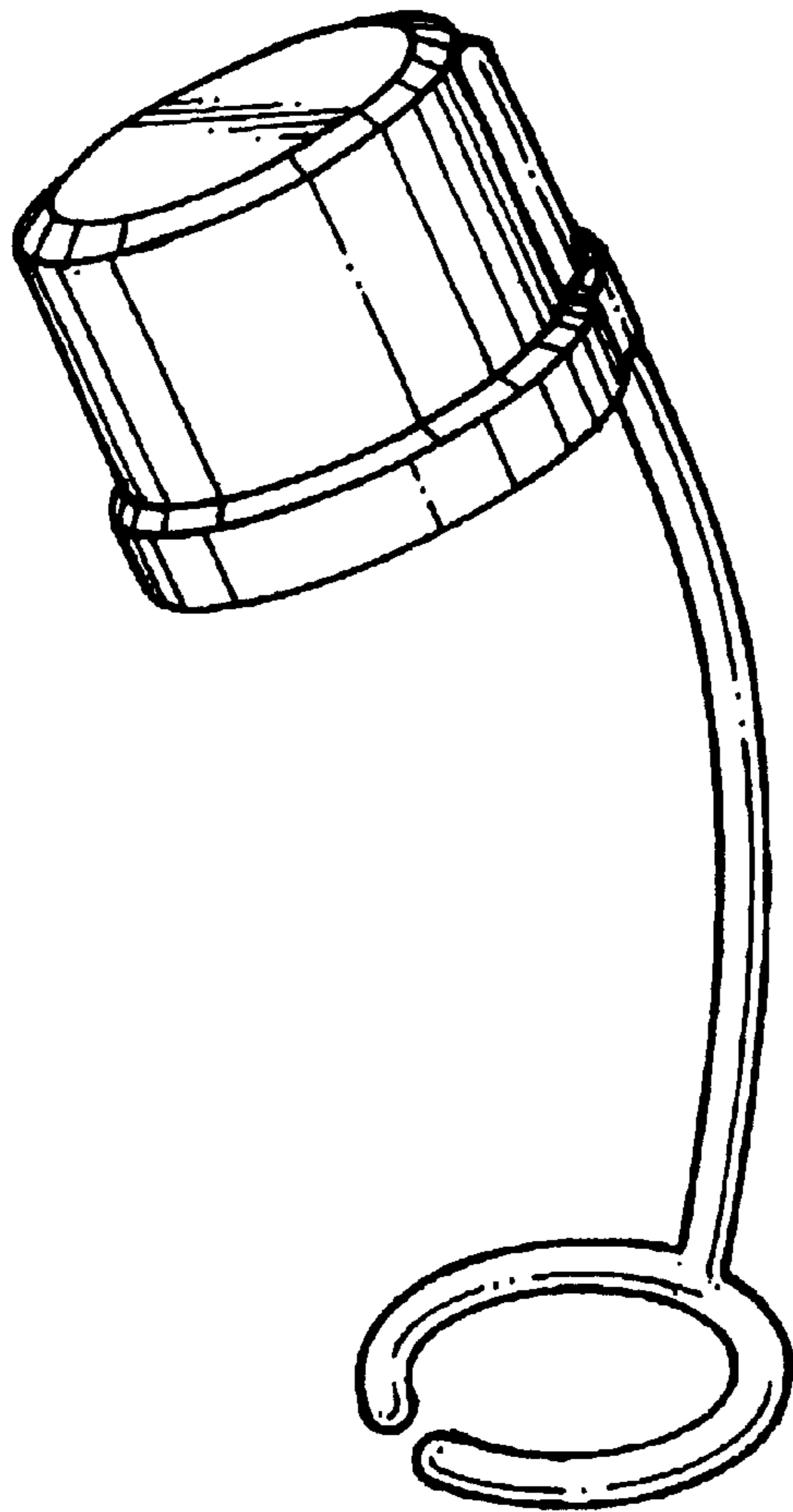

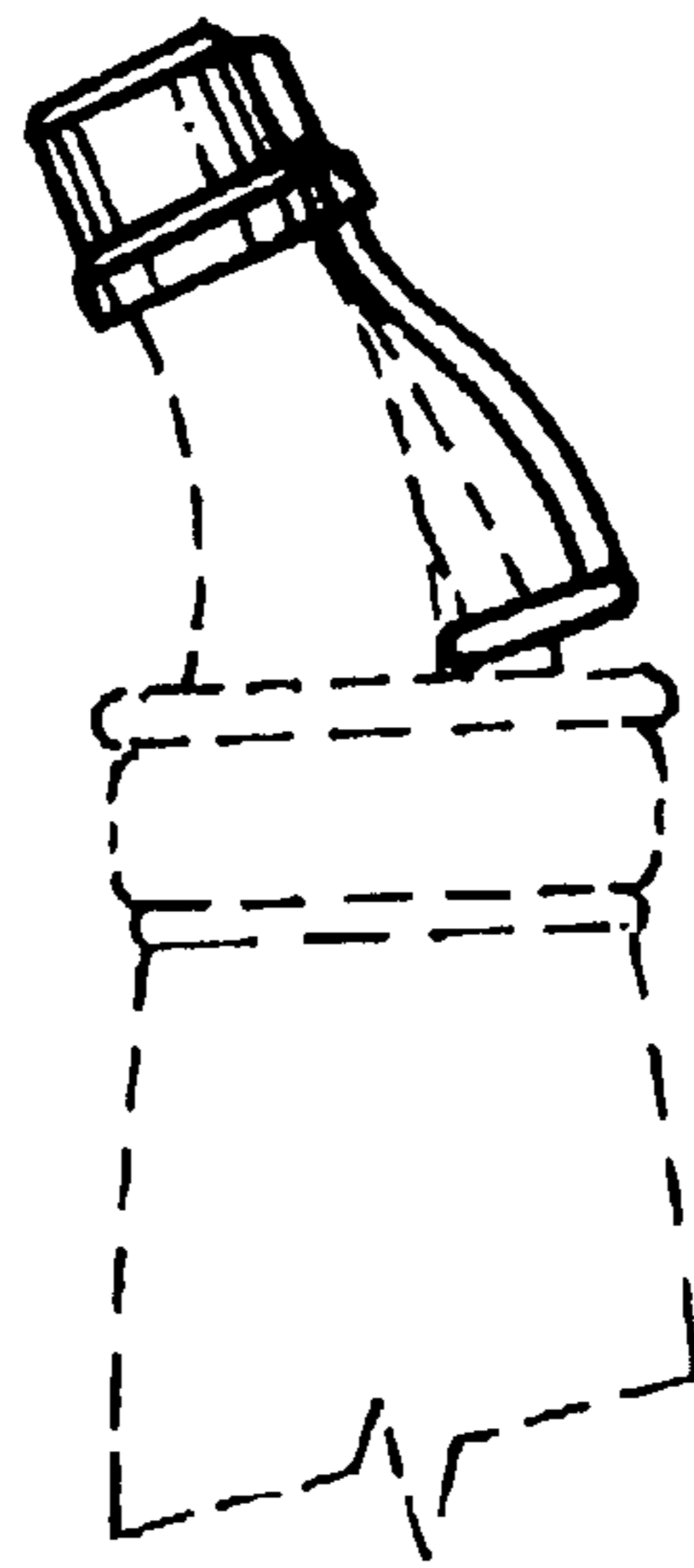

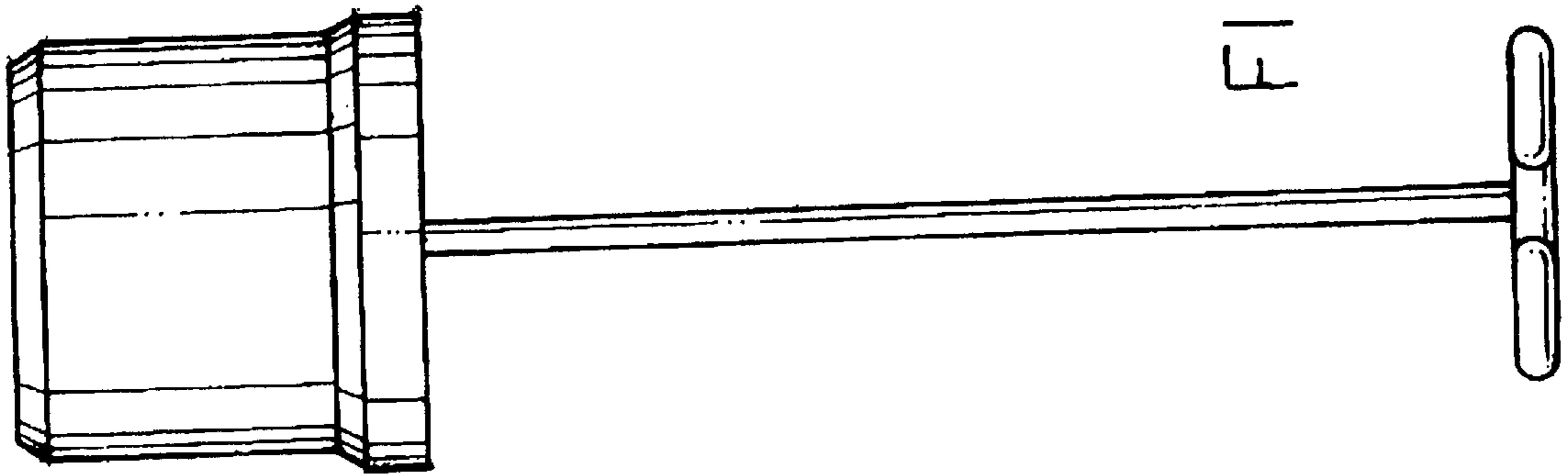

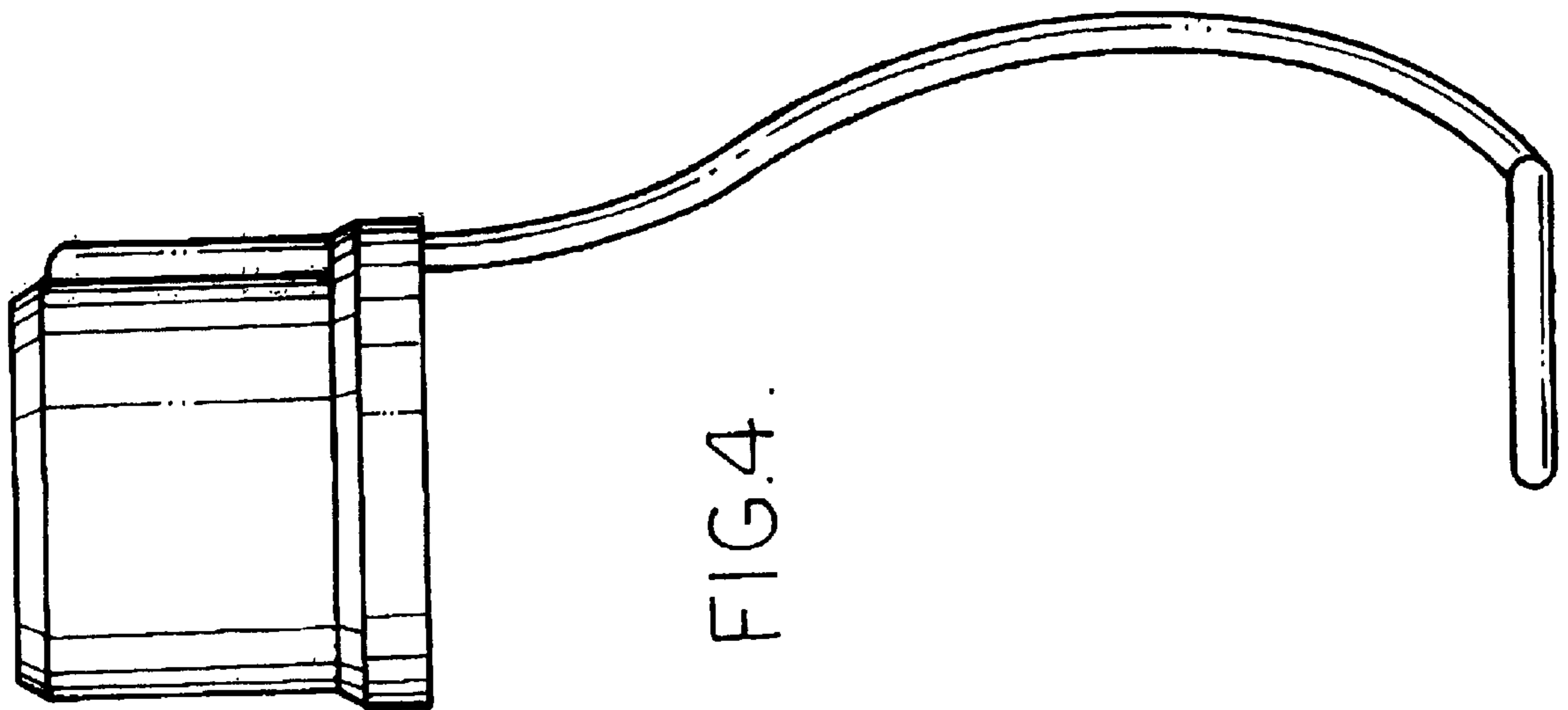

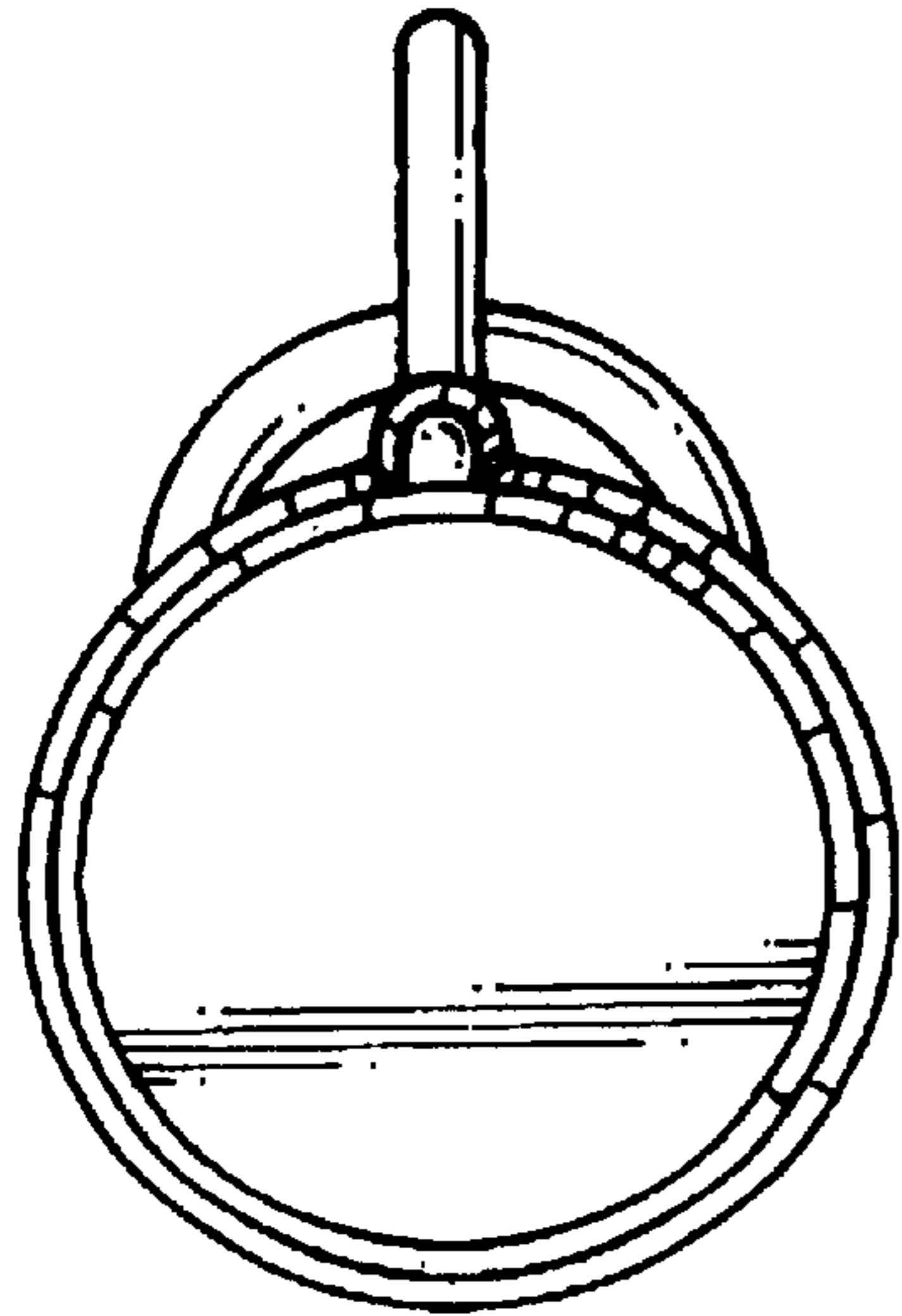

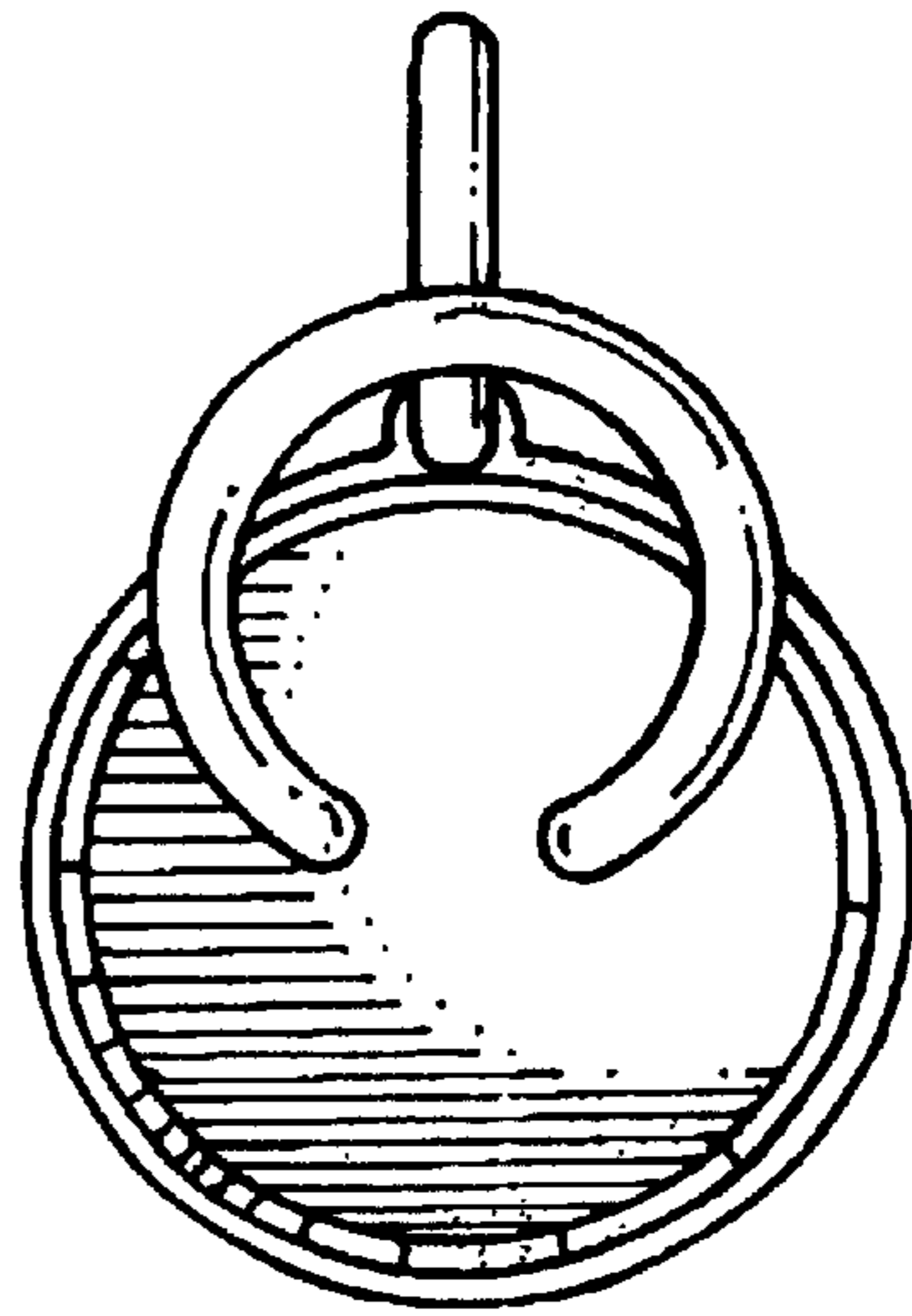
