The ornamental design for a cellular telephone holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cellular telephone holder in full lines.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

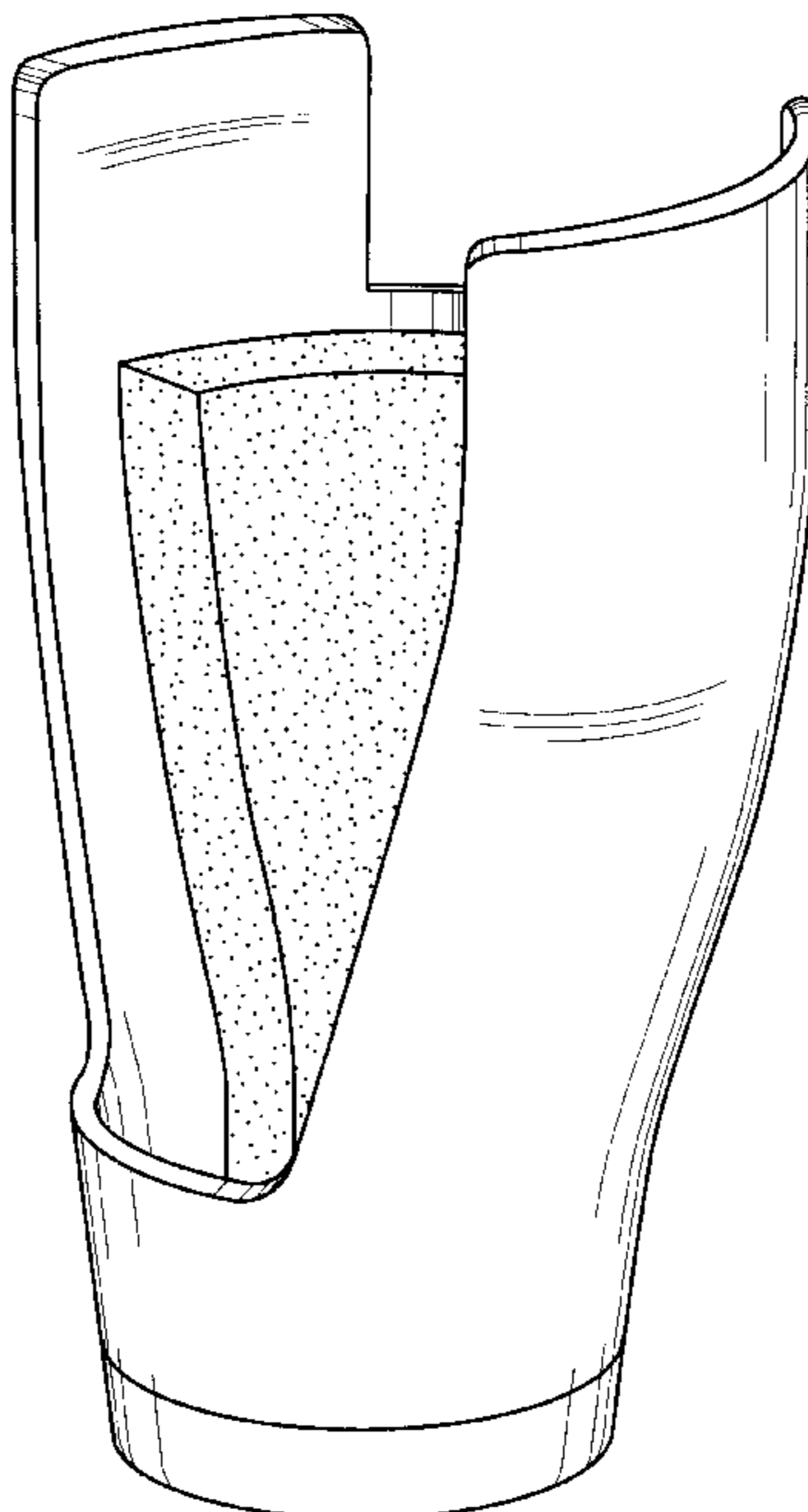
FIG. 4 is a right side elevational view thereof.

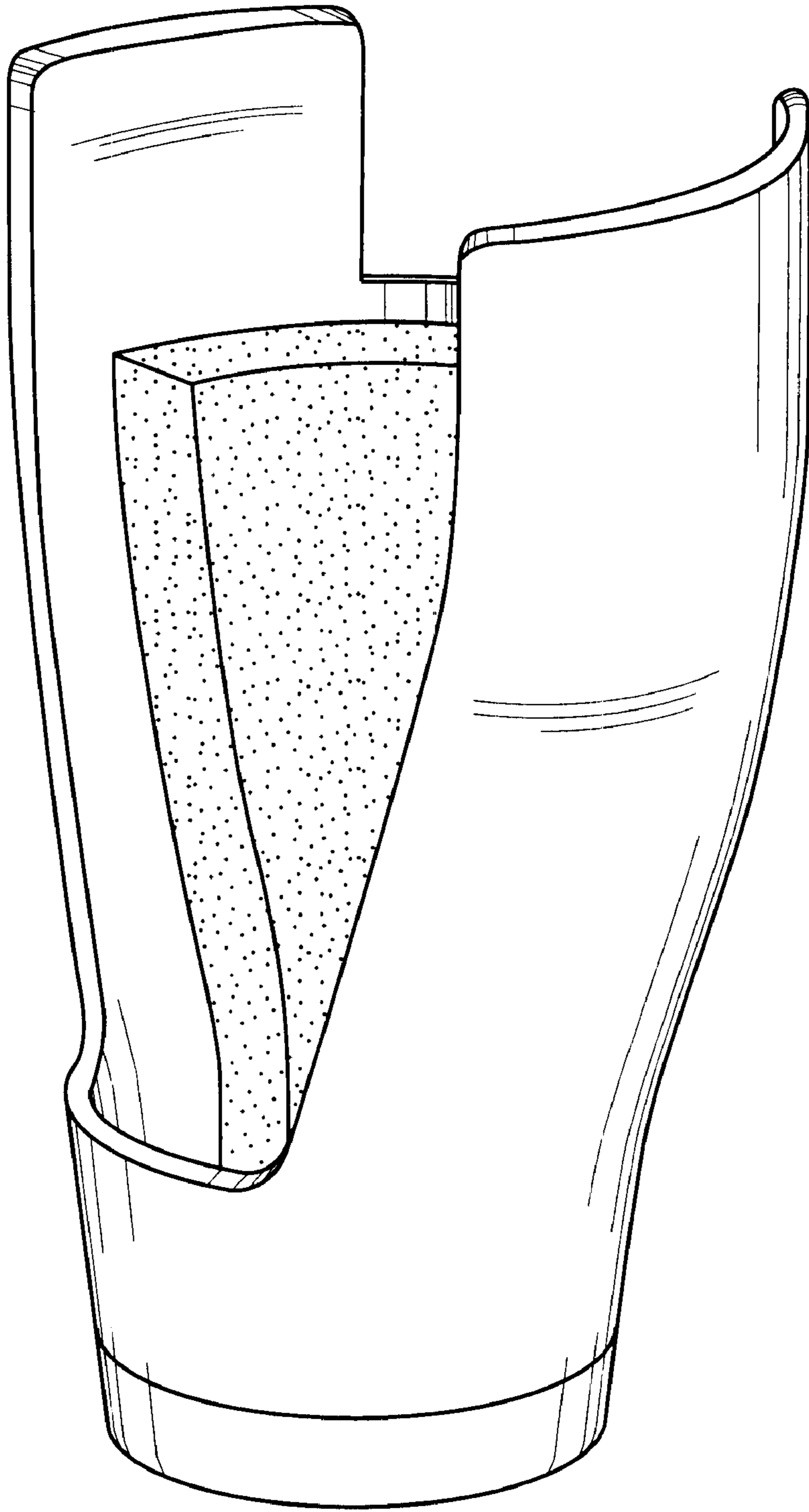

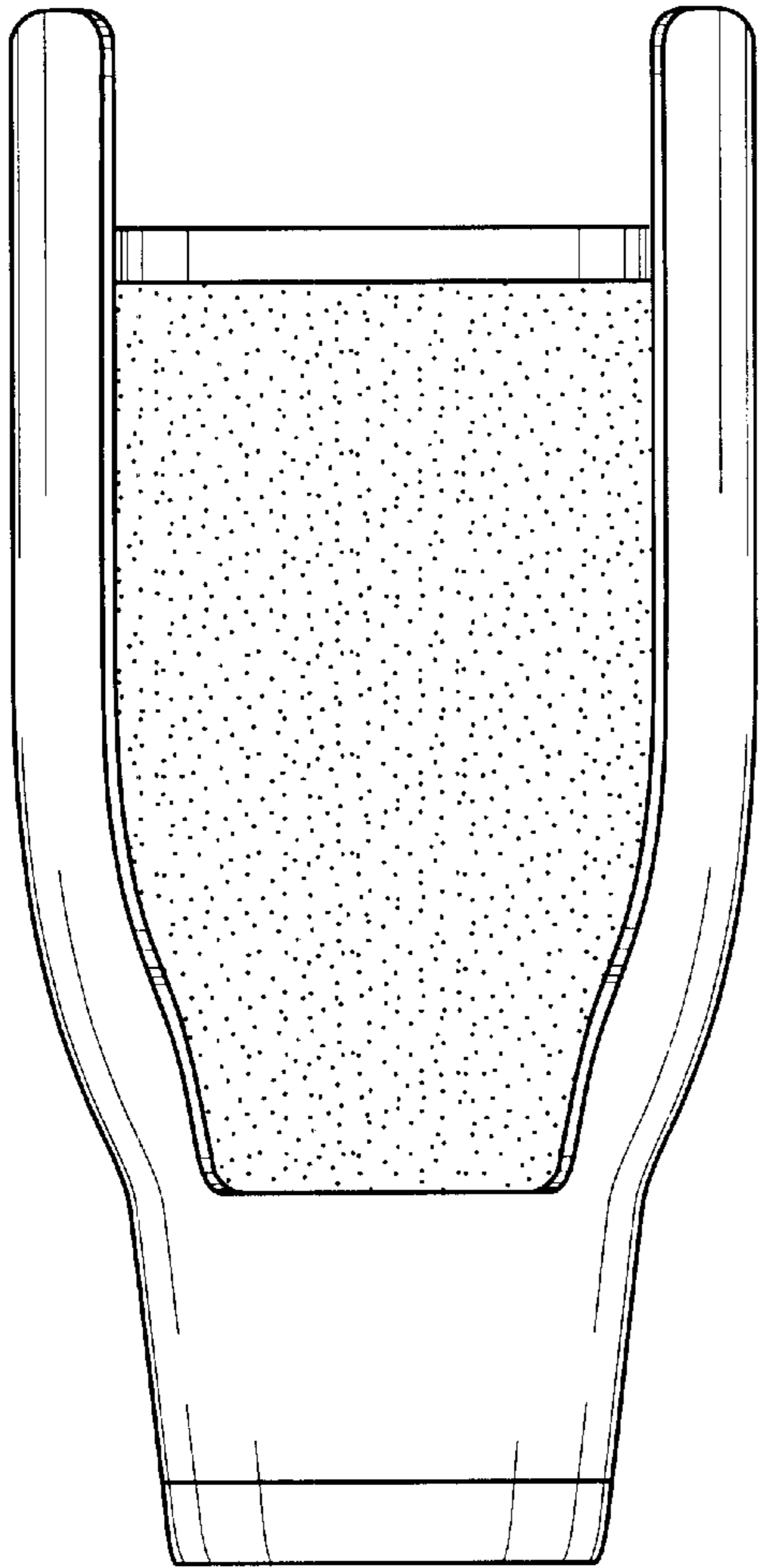

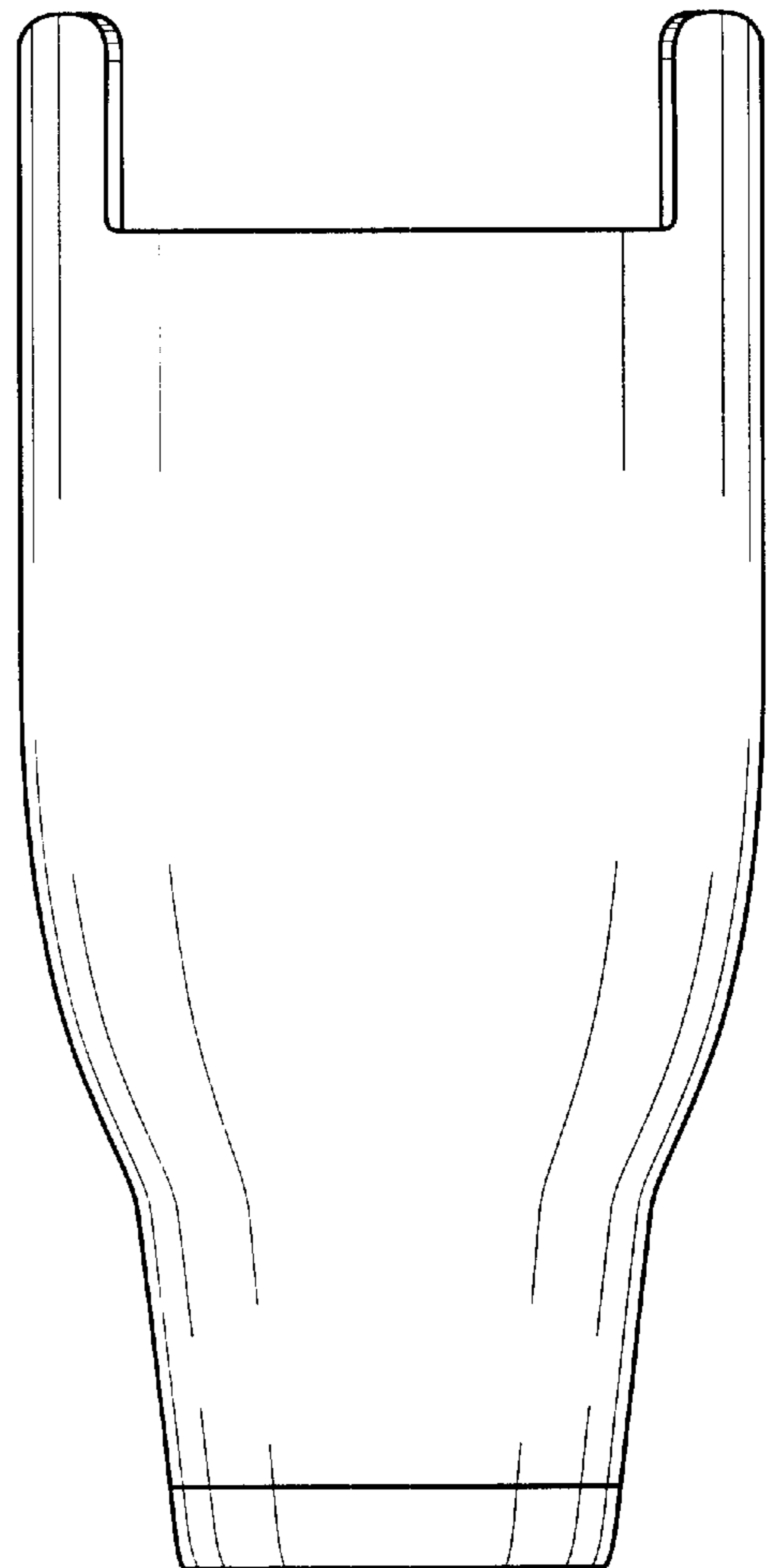

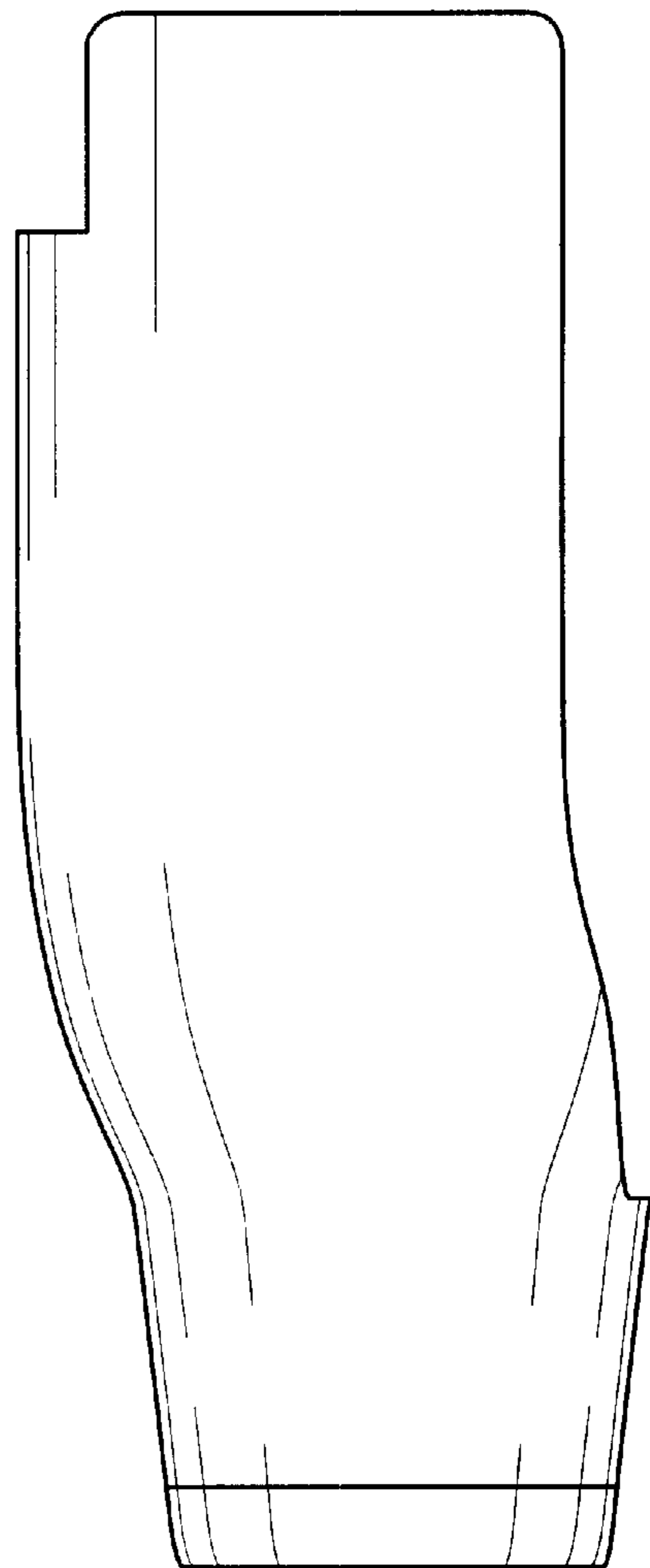

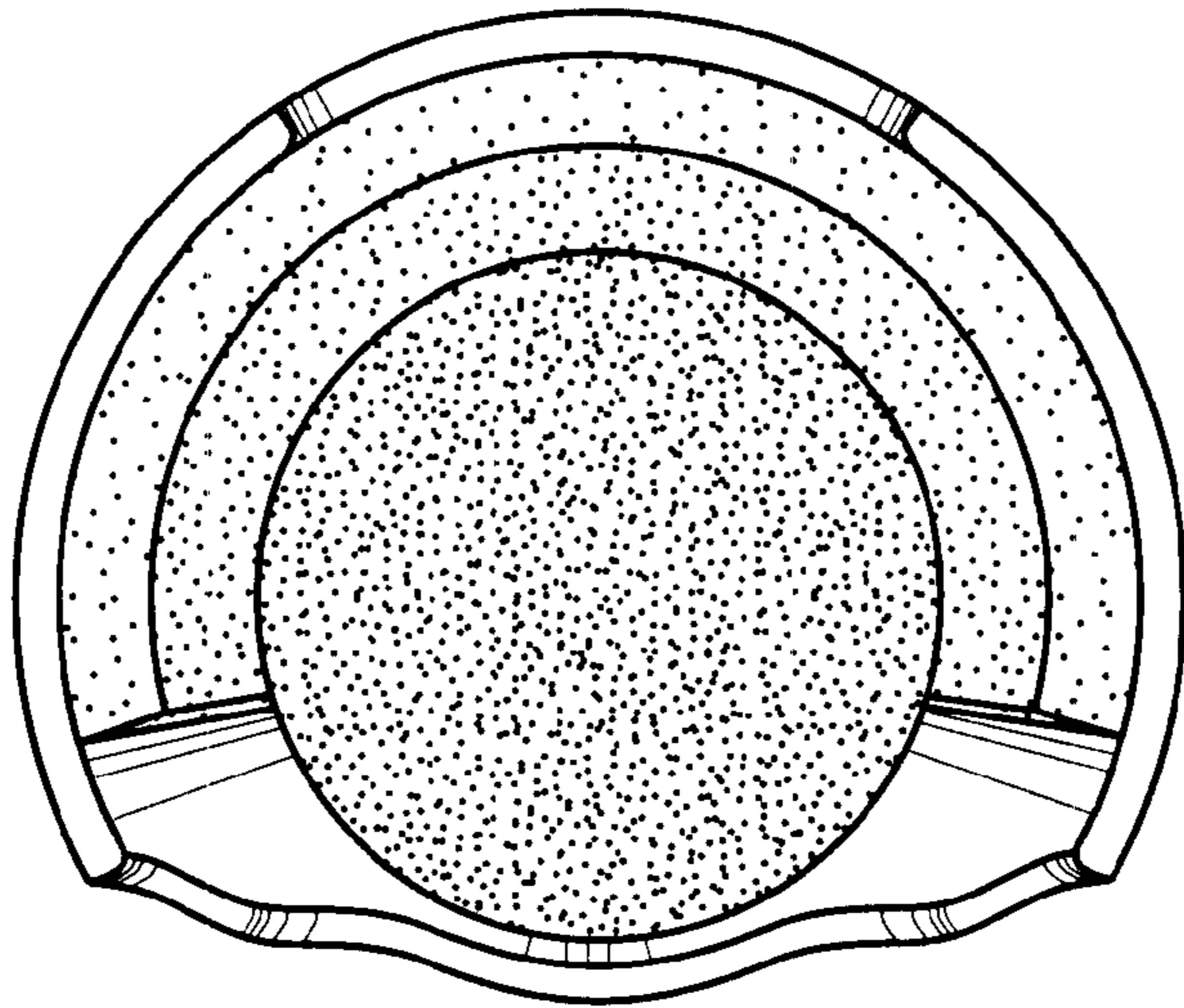

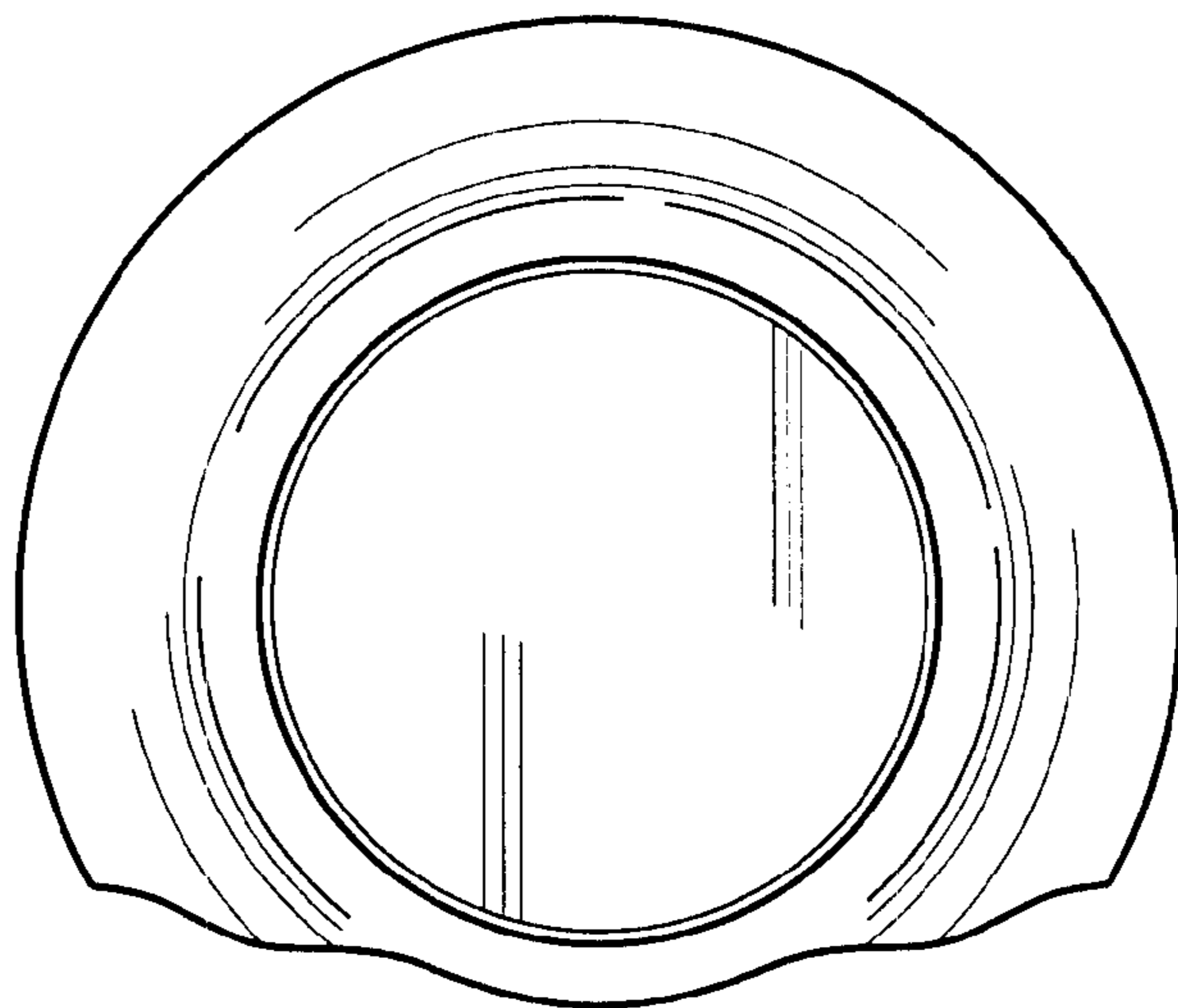
