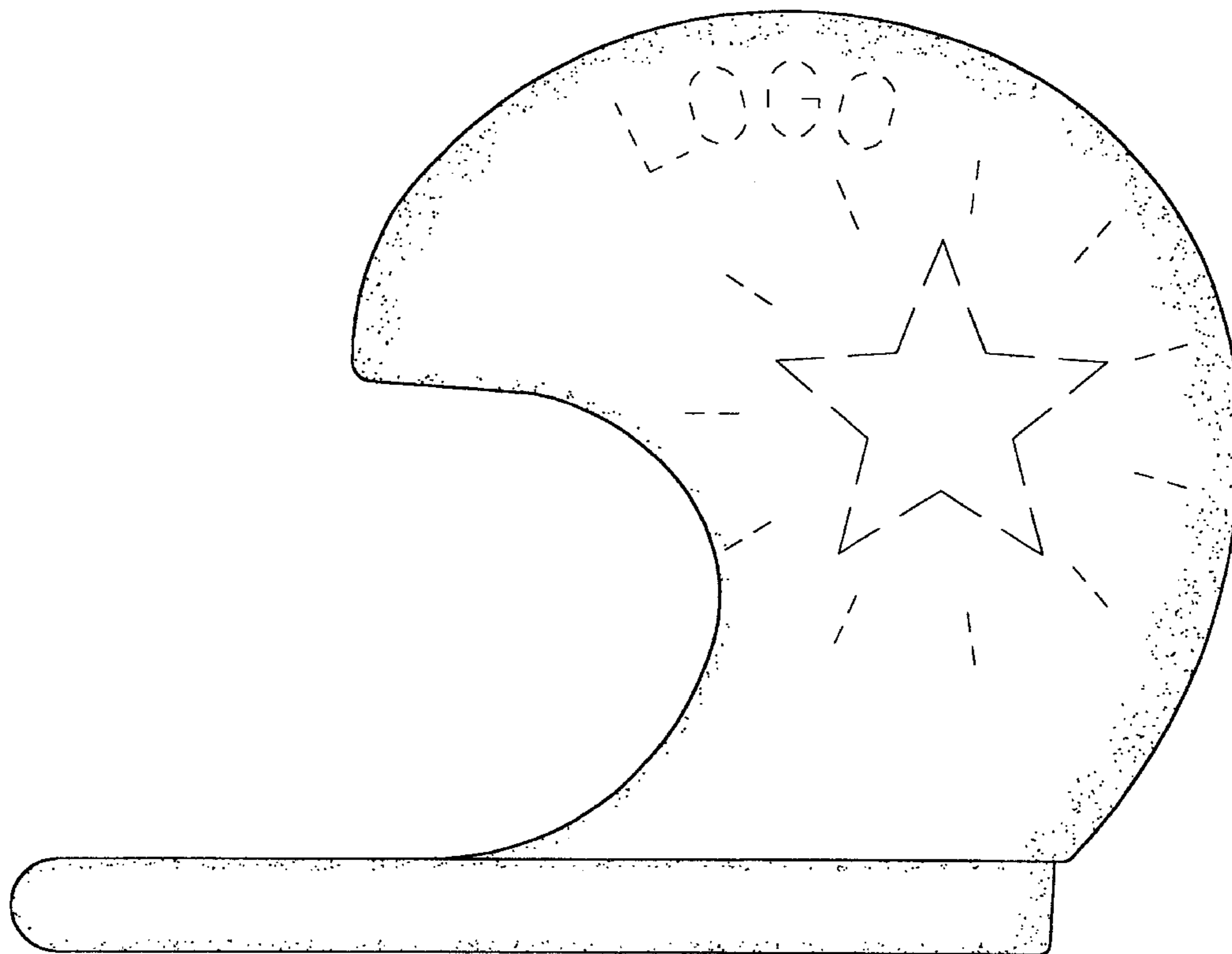
(57) **CLAIM**

The ornamental design for a head cover, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevated view of a head cover showing my new design;
 FIG. 2 is a right side elevated view of the head cover;
 FIG. 3 is a rear elevated view of the head cover;
 FIG. 4 is a front view of the head cover;
 FIG. 5 is a top plan view of the head cover; and,
 FIG. 6 is a bottom plan view of the head cover.

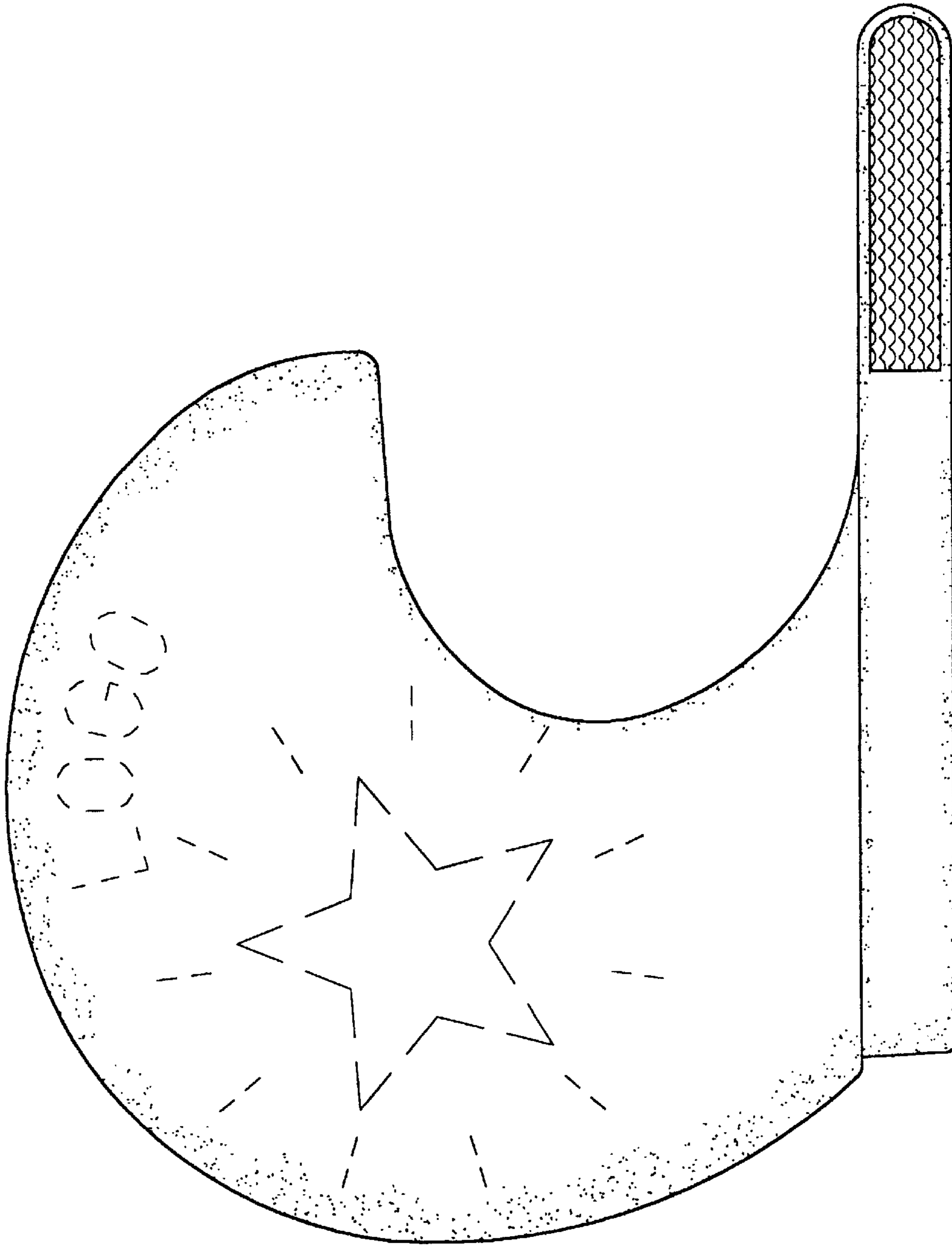

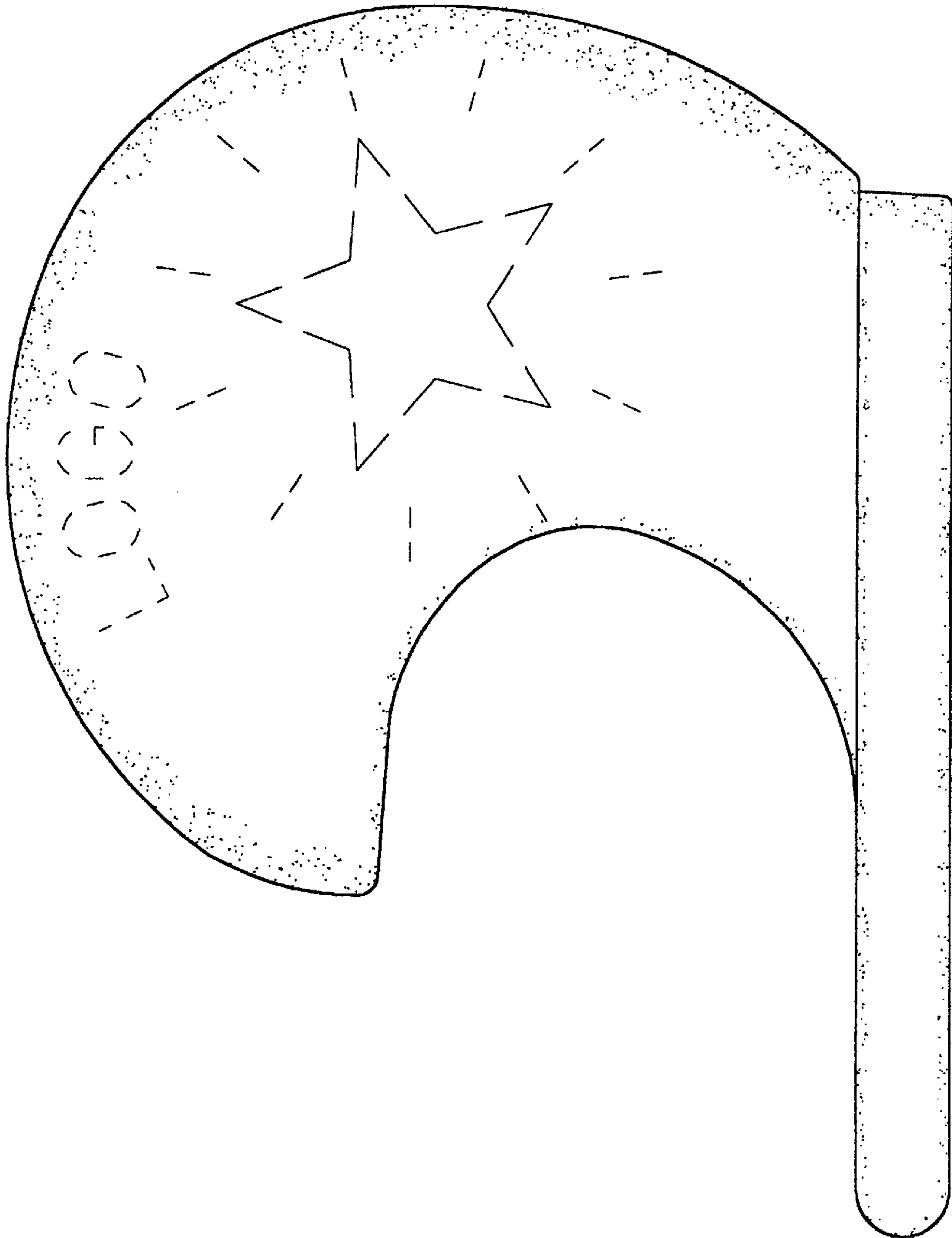

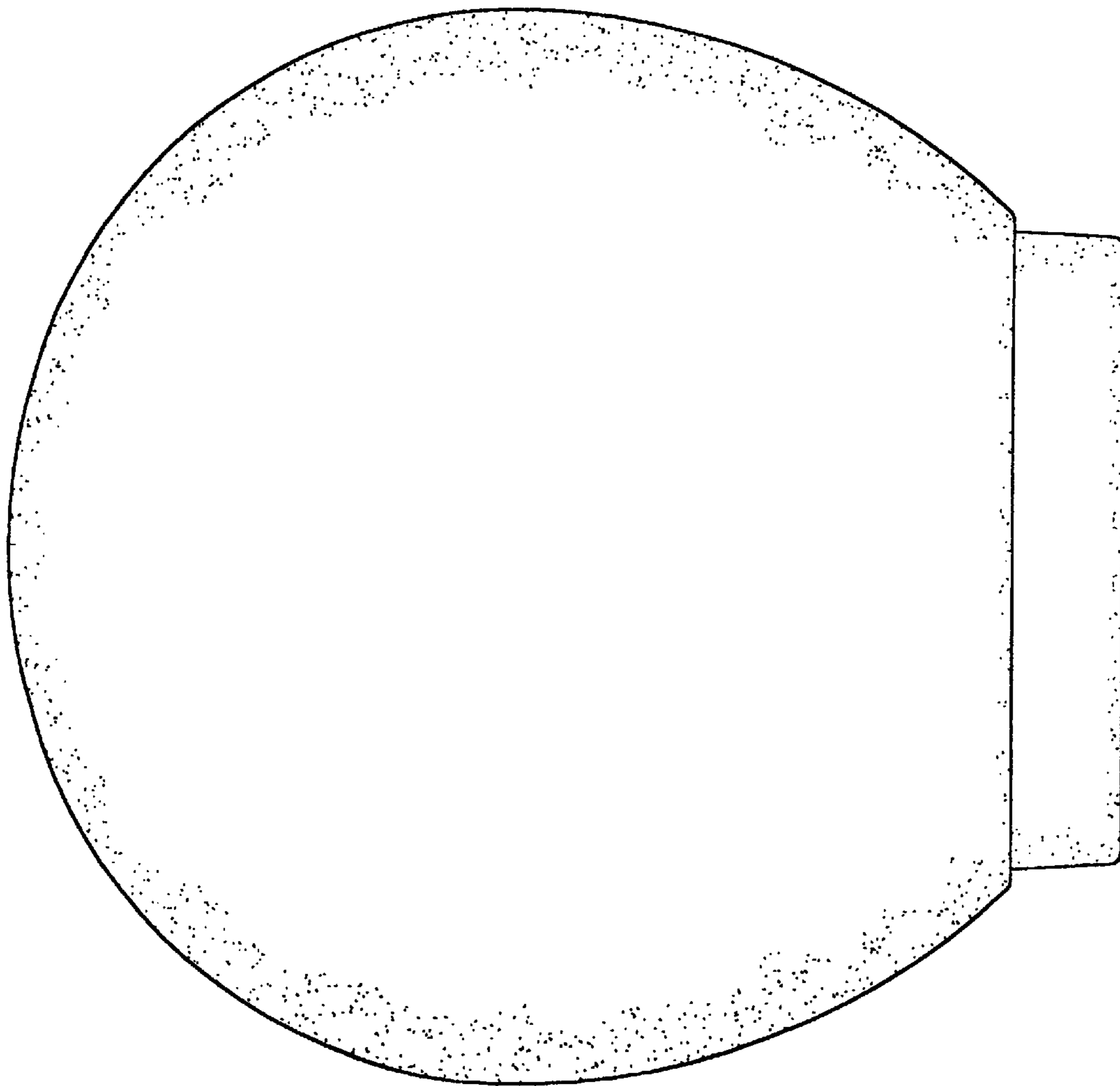

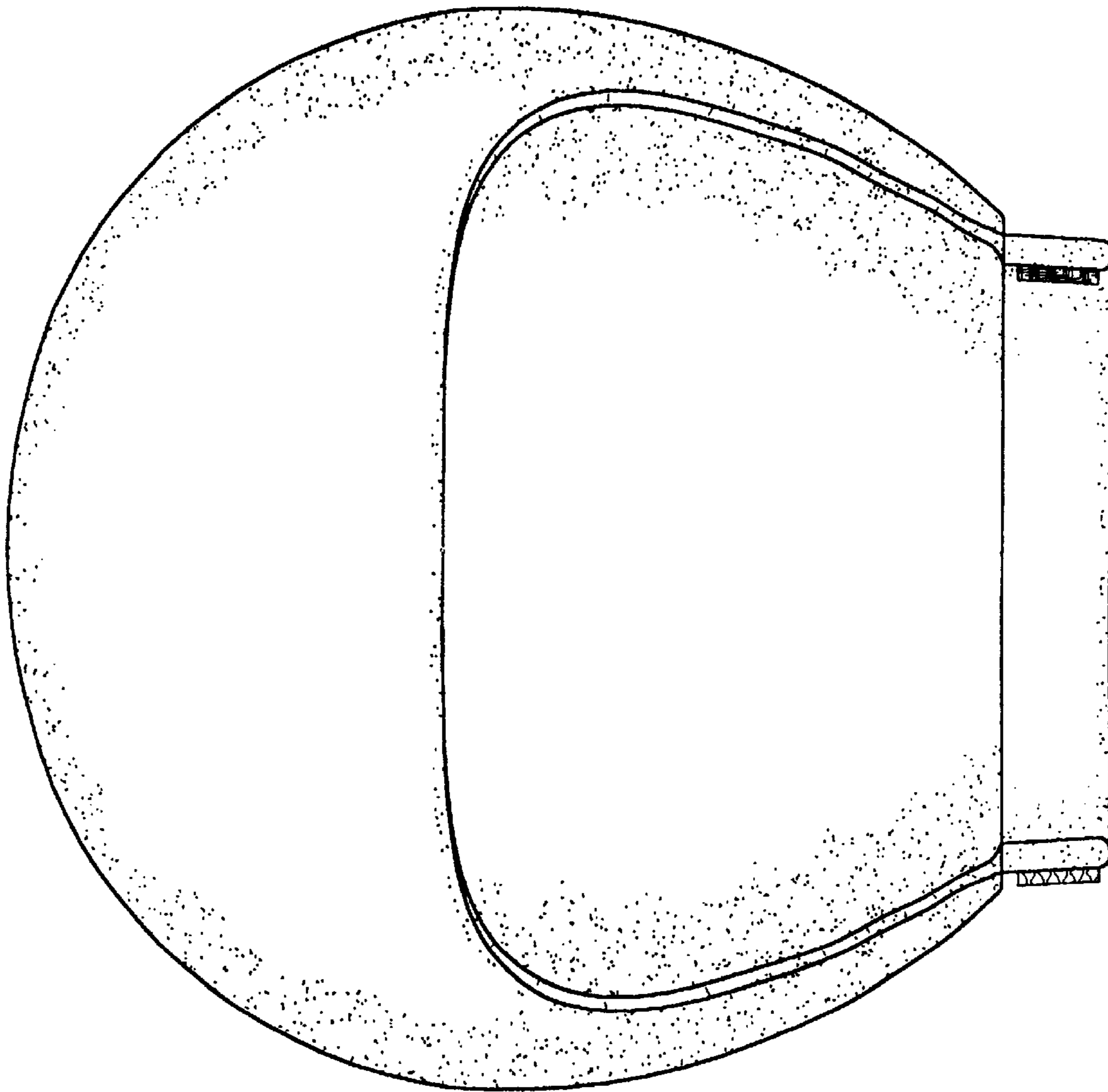

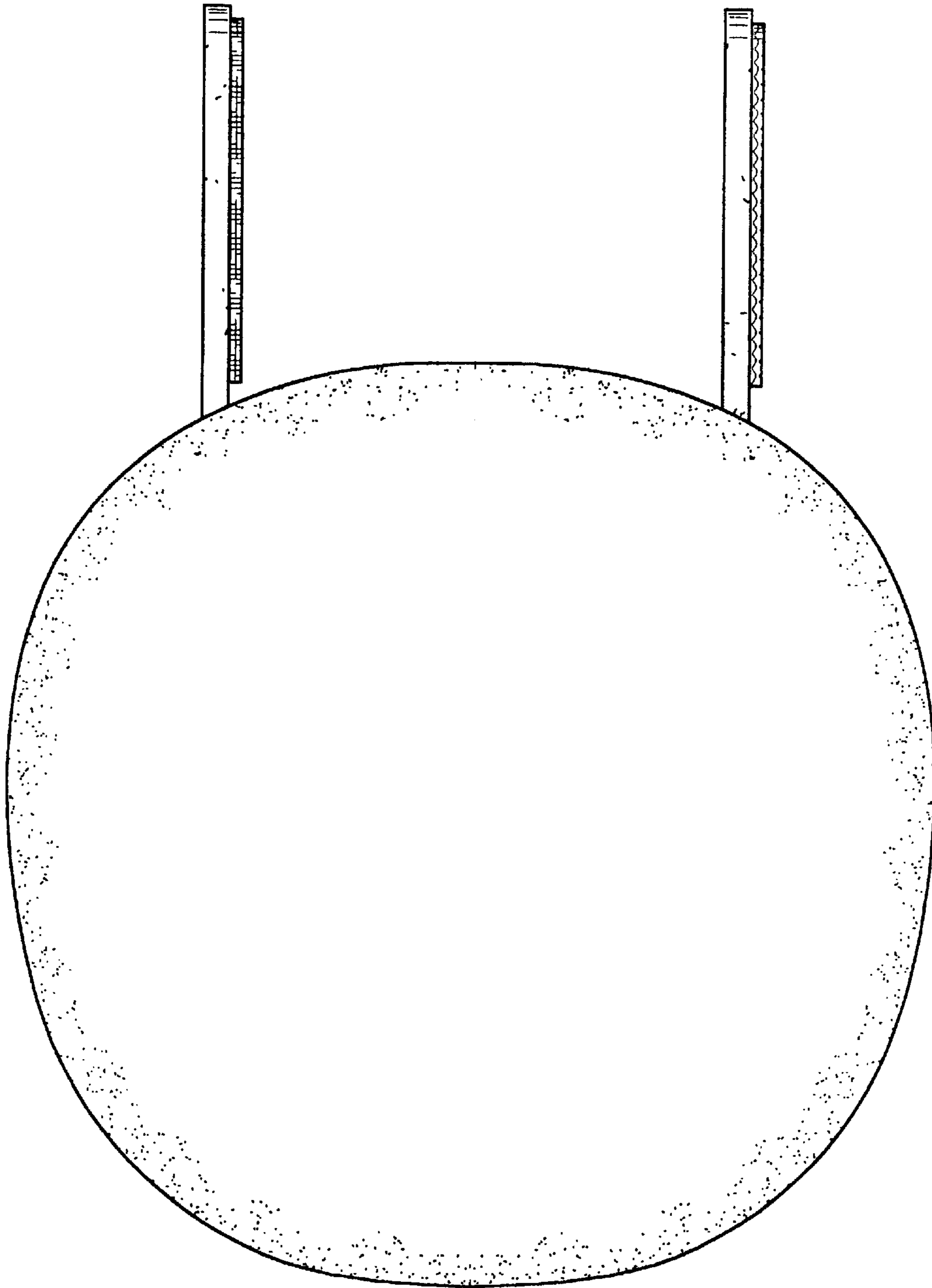

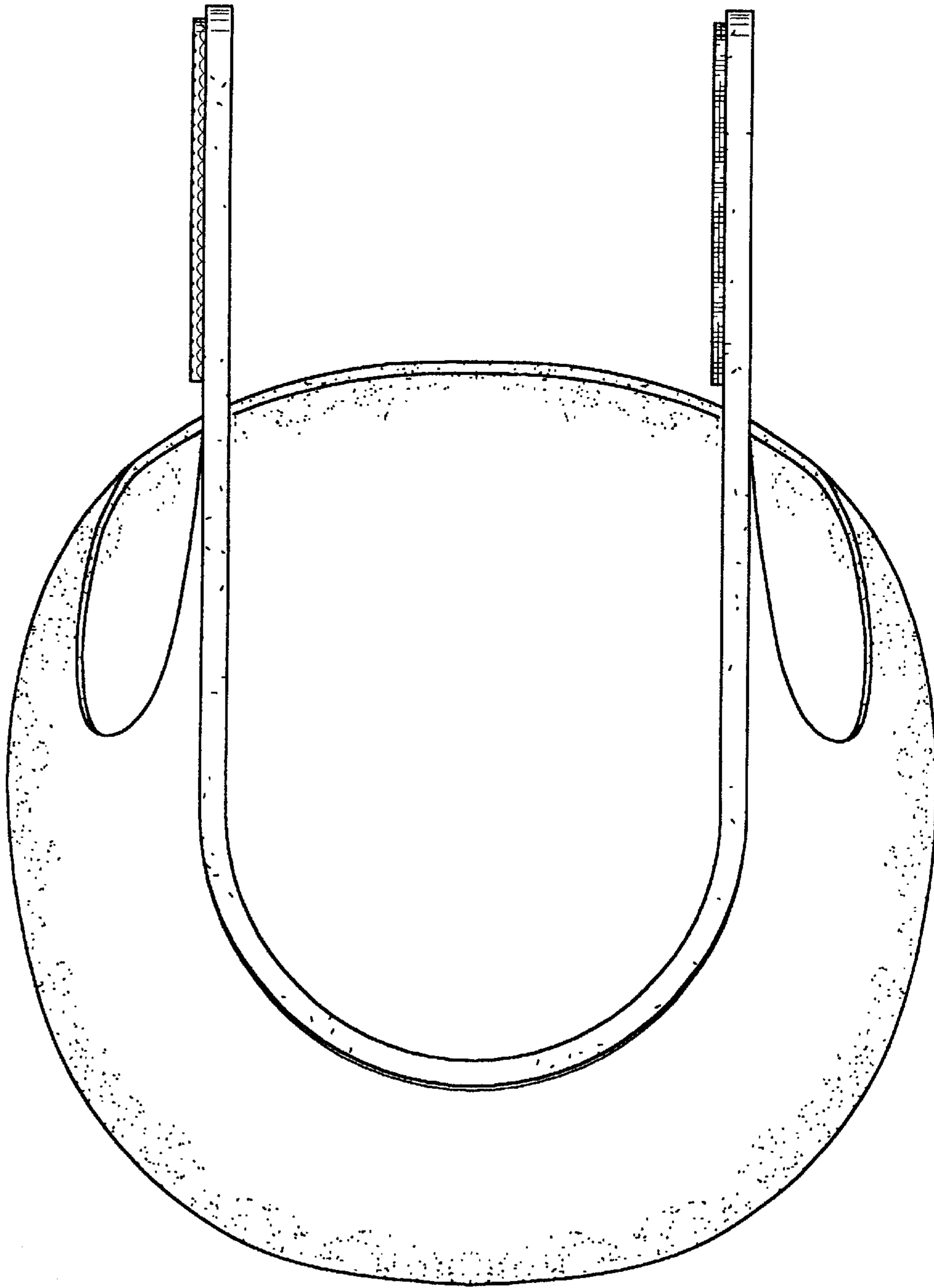
