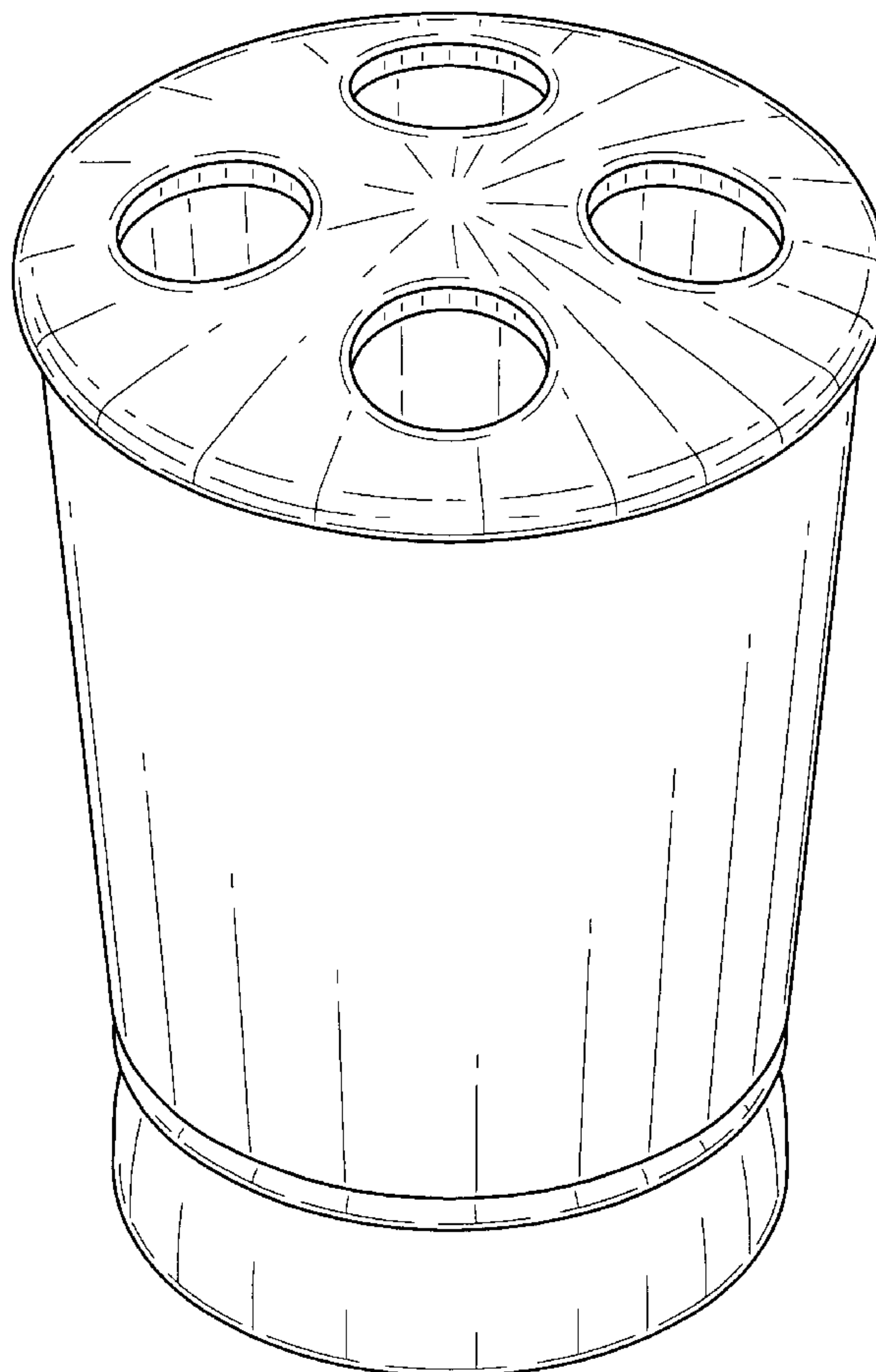
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a toothbrush holder embodying this invention;  
FIG. 2 is a top view of the toothbrush holder shown in FIG. 1;

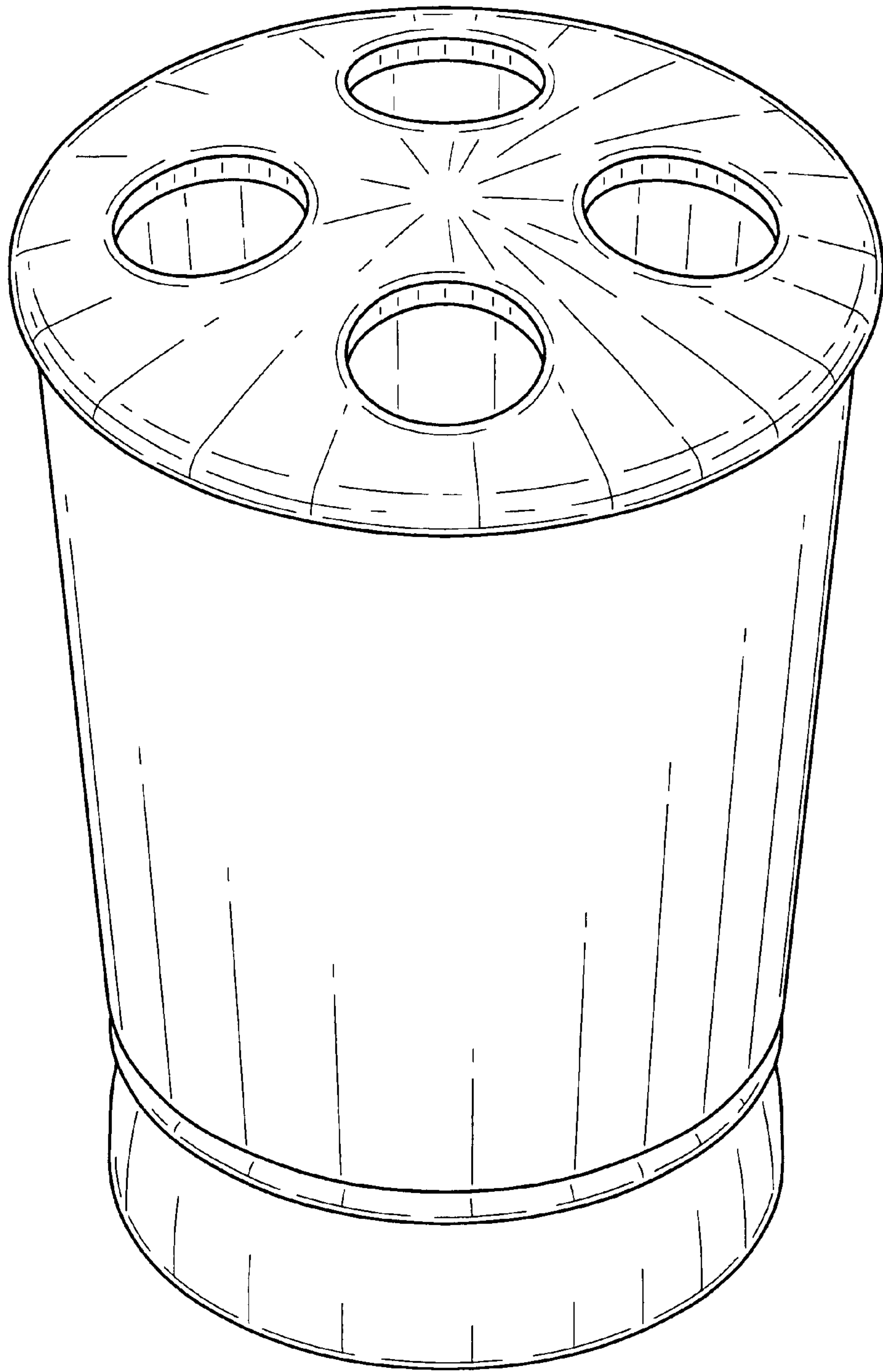

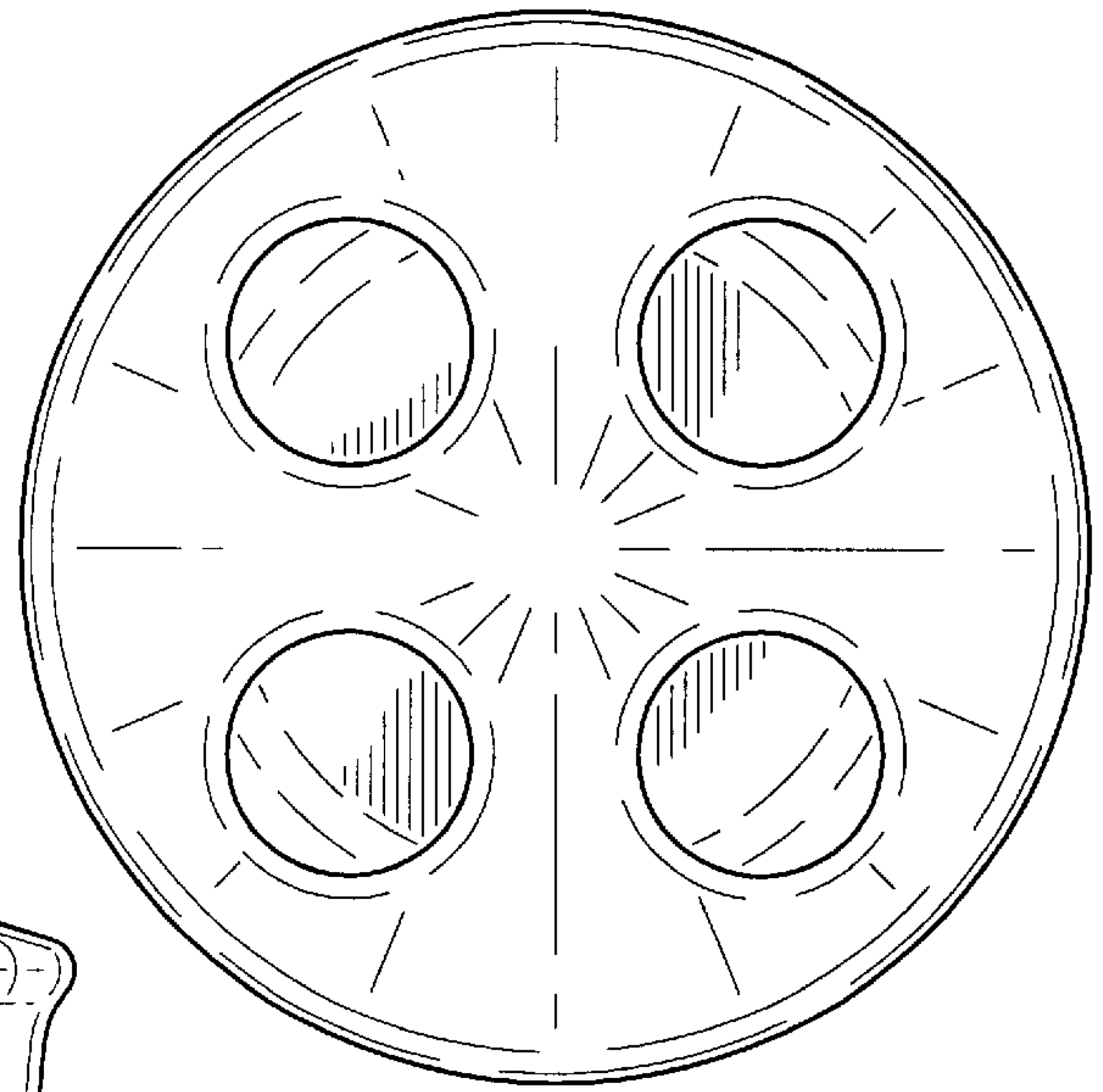

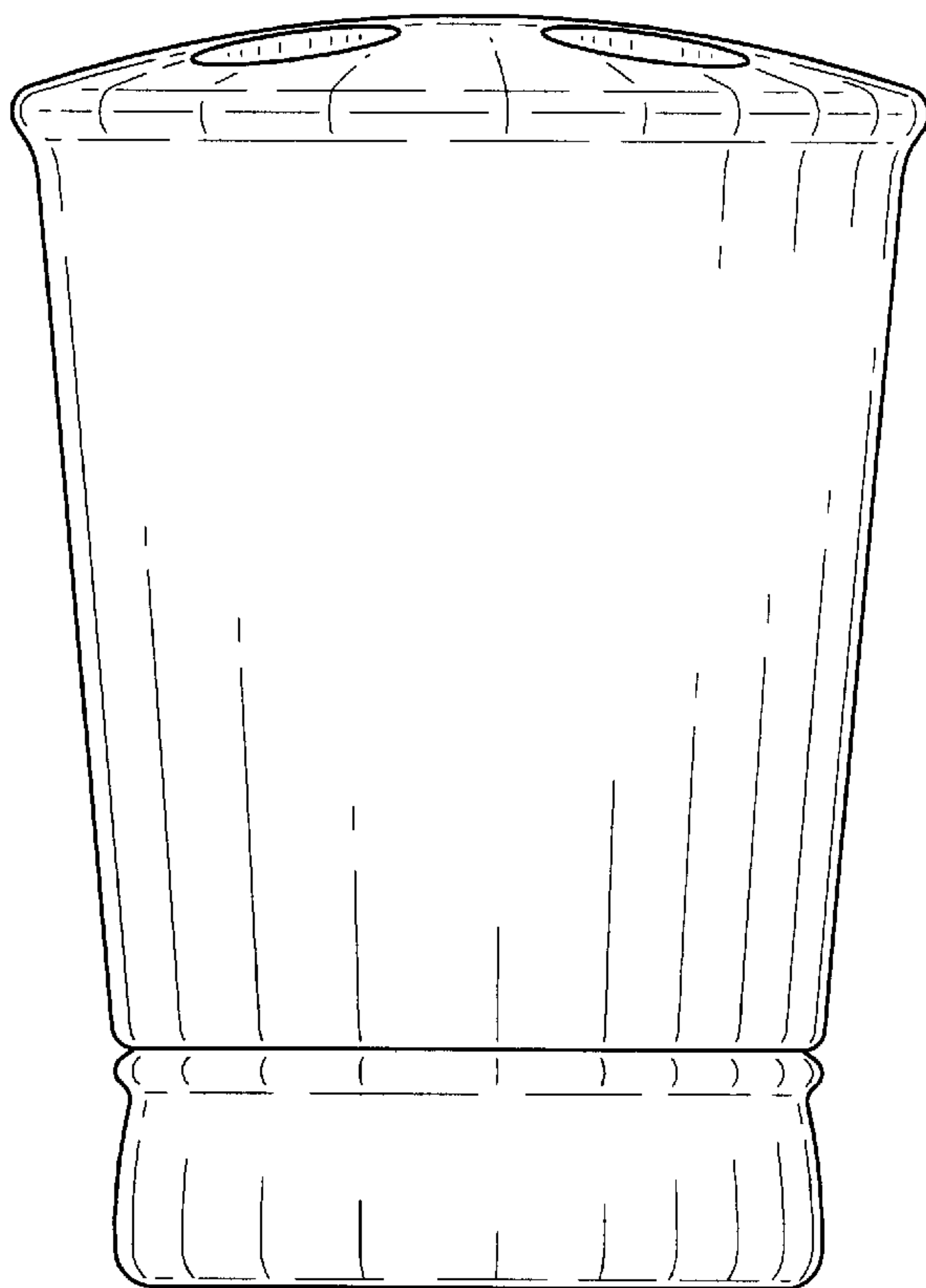

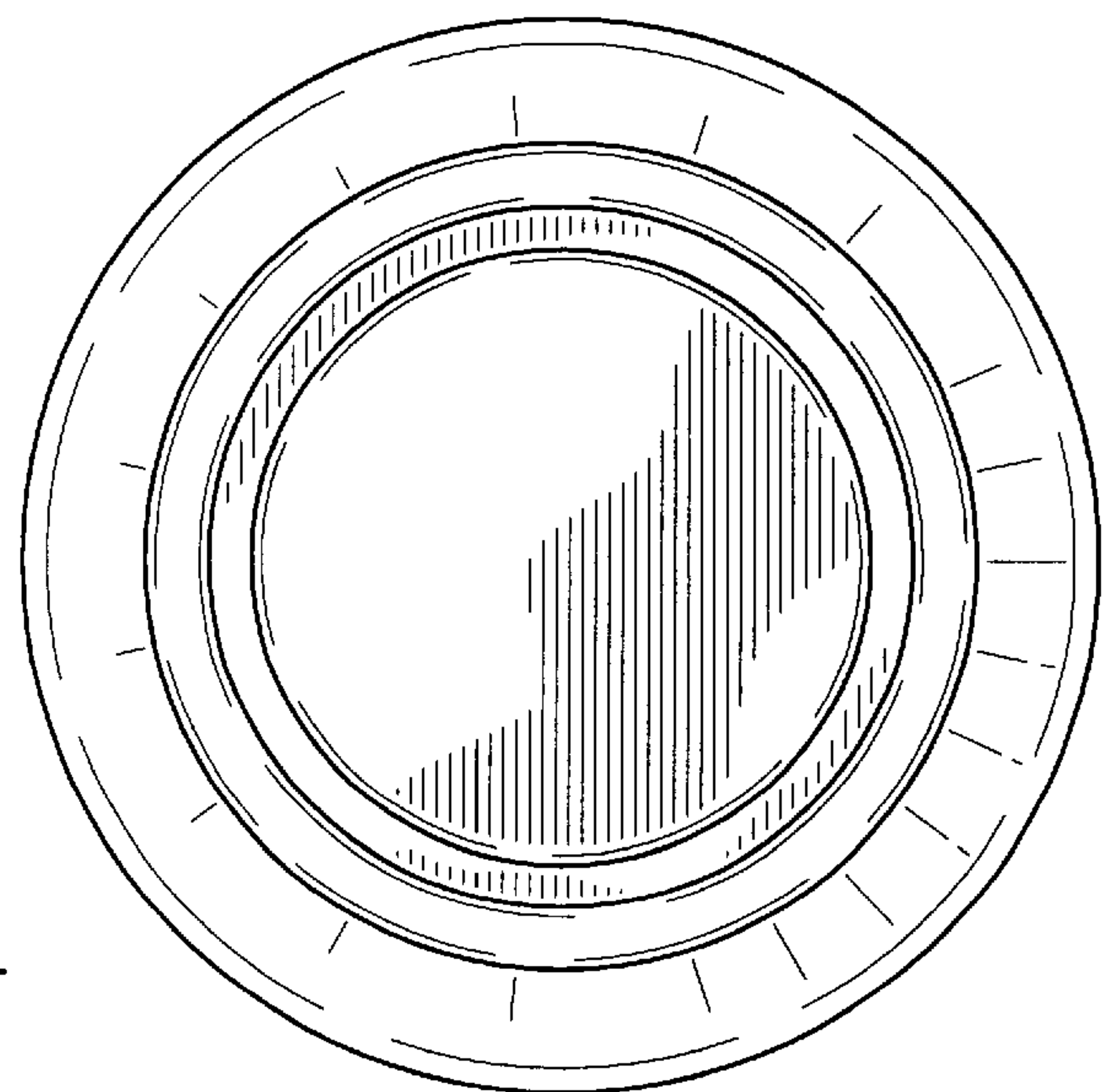
