DESCRIPTION

FIG. 1 is a top, perspective view of a first embodiment of a bowl of my design;

FIG. 5 is a top, perspective view of a second embodiment thereof;

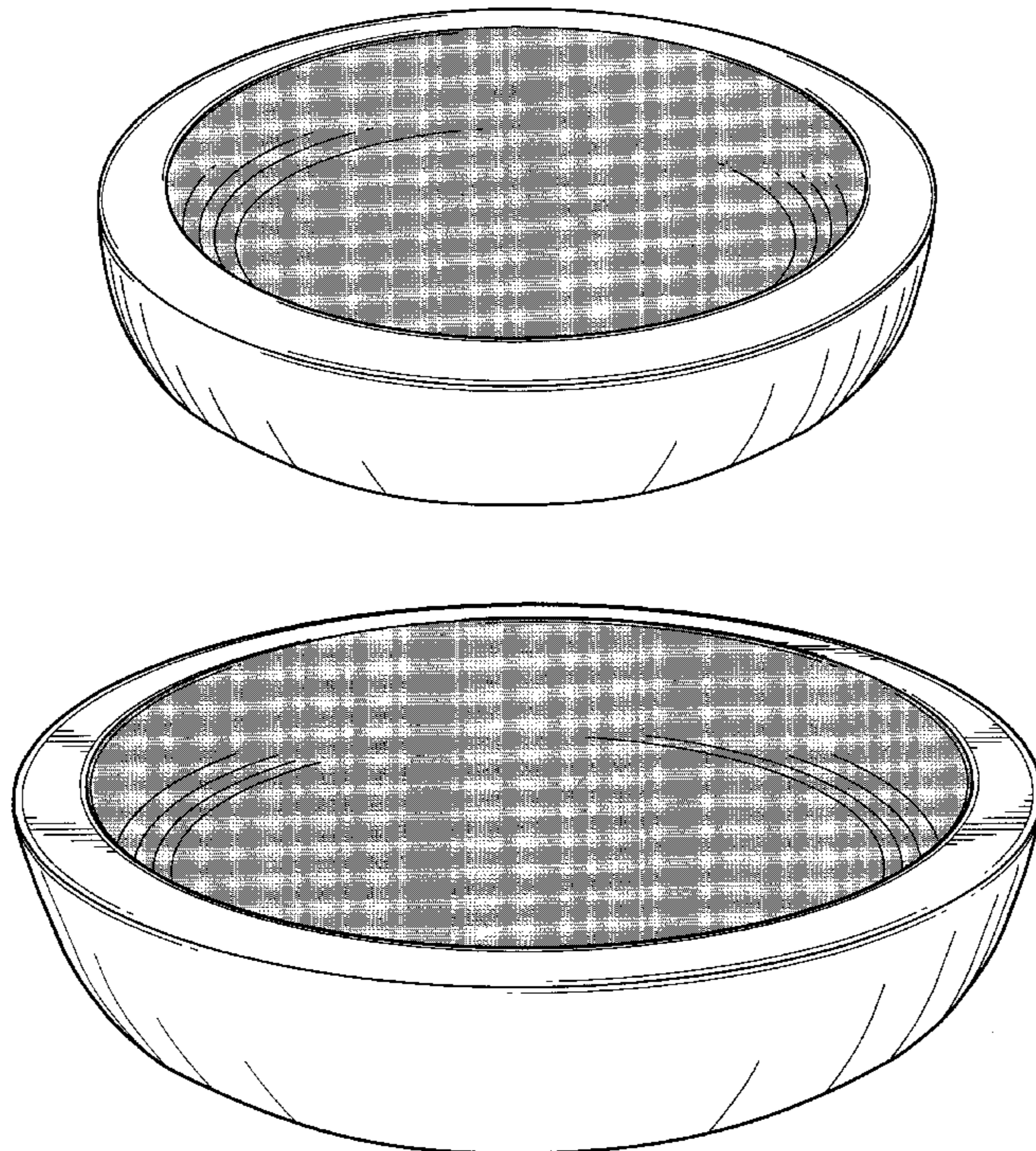
FIG. 6 is a top view thereof;

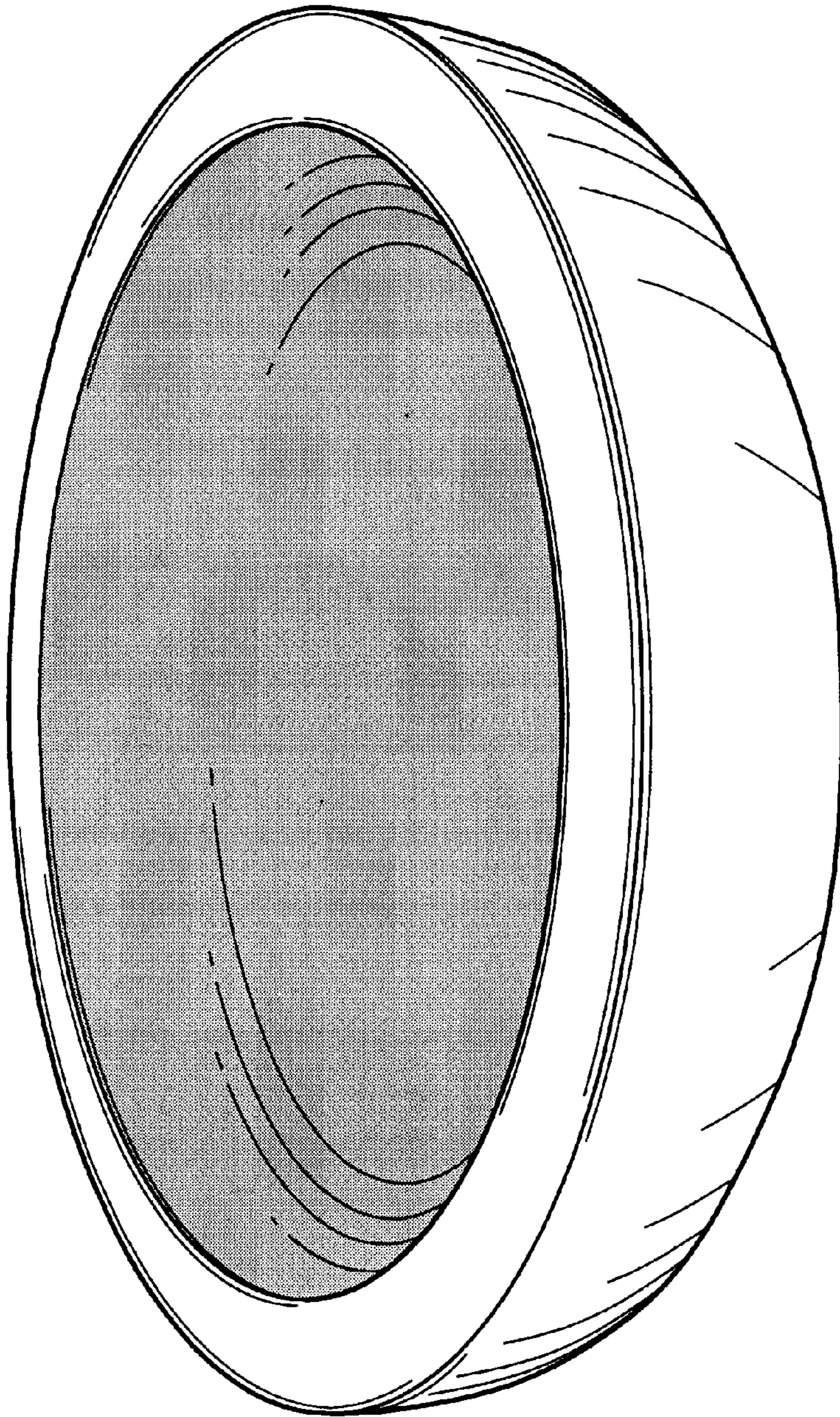

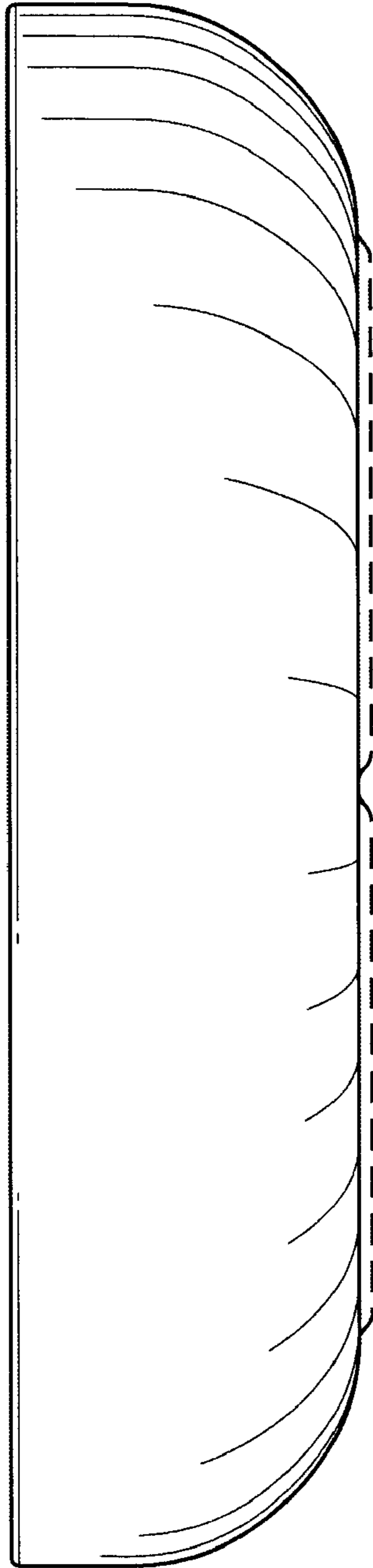

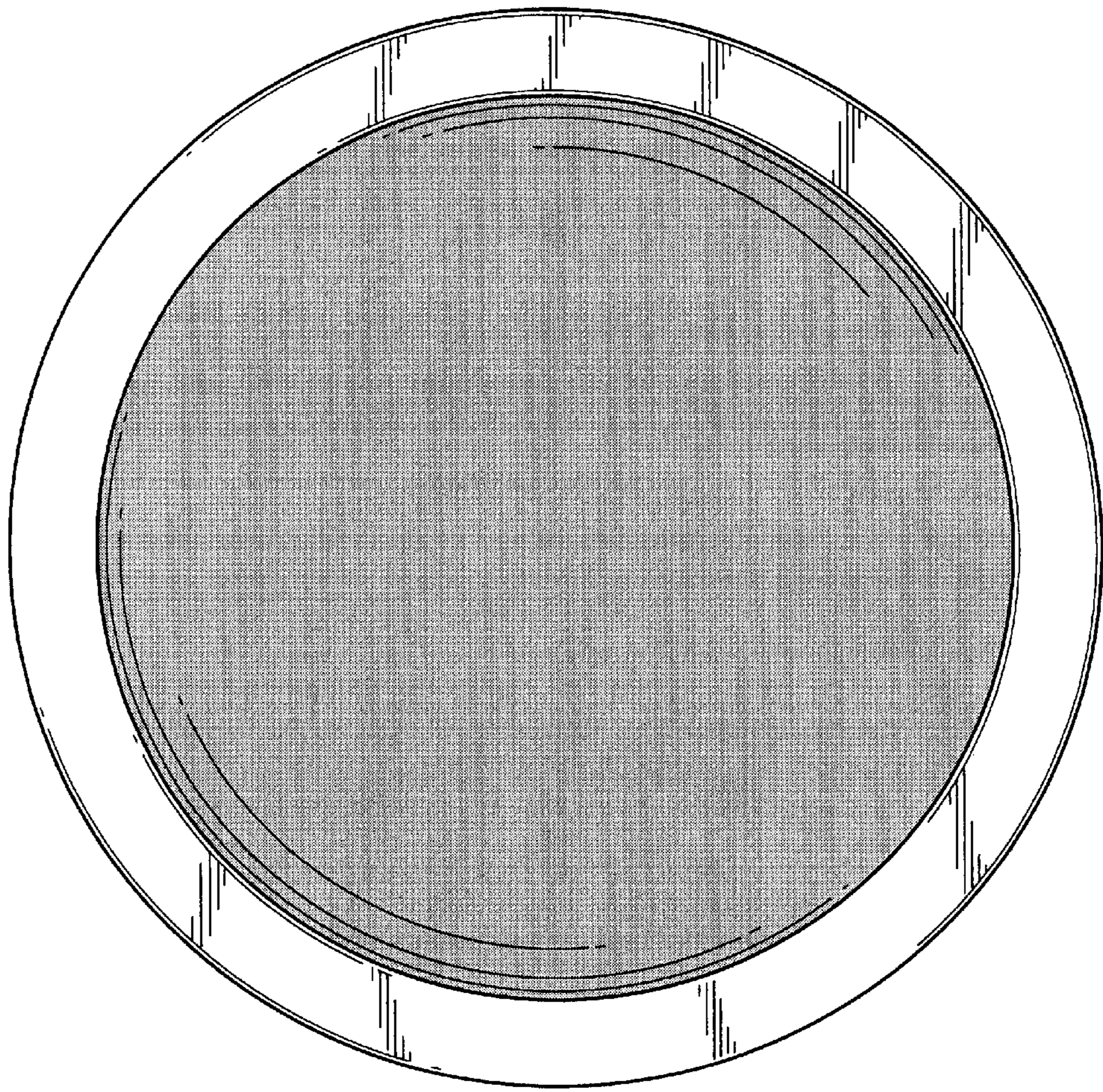

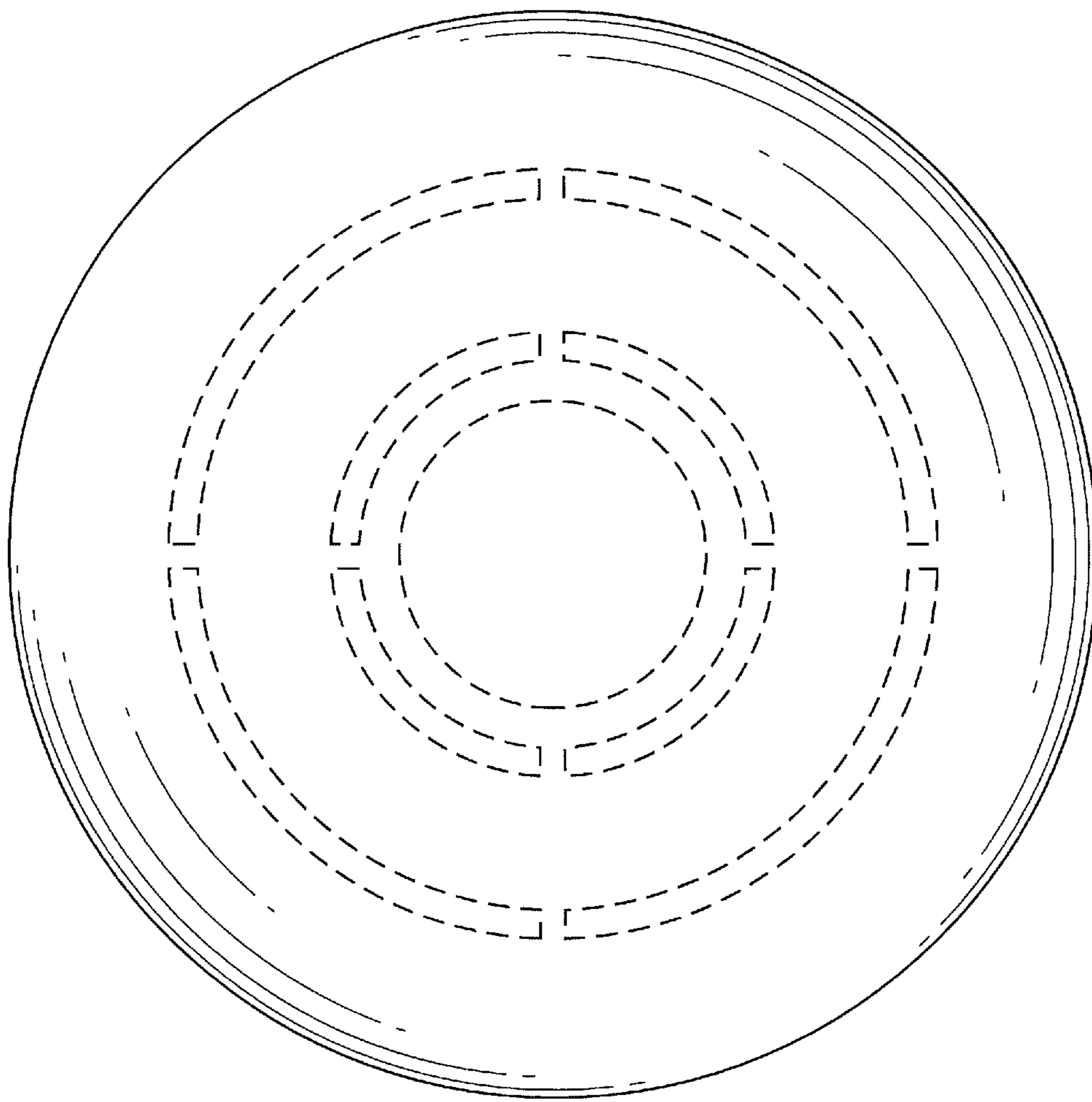

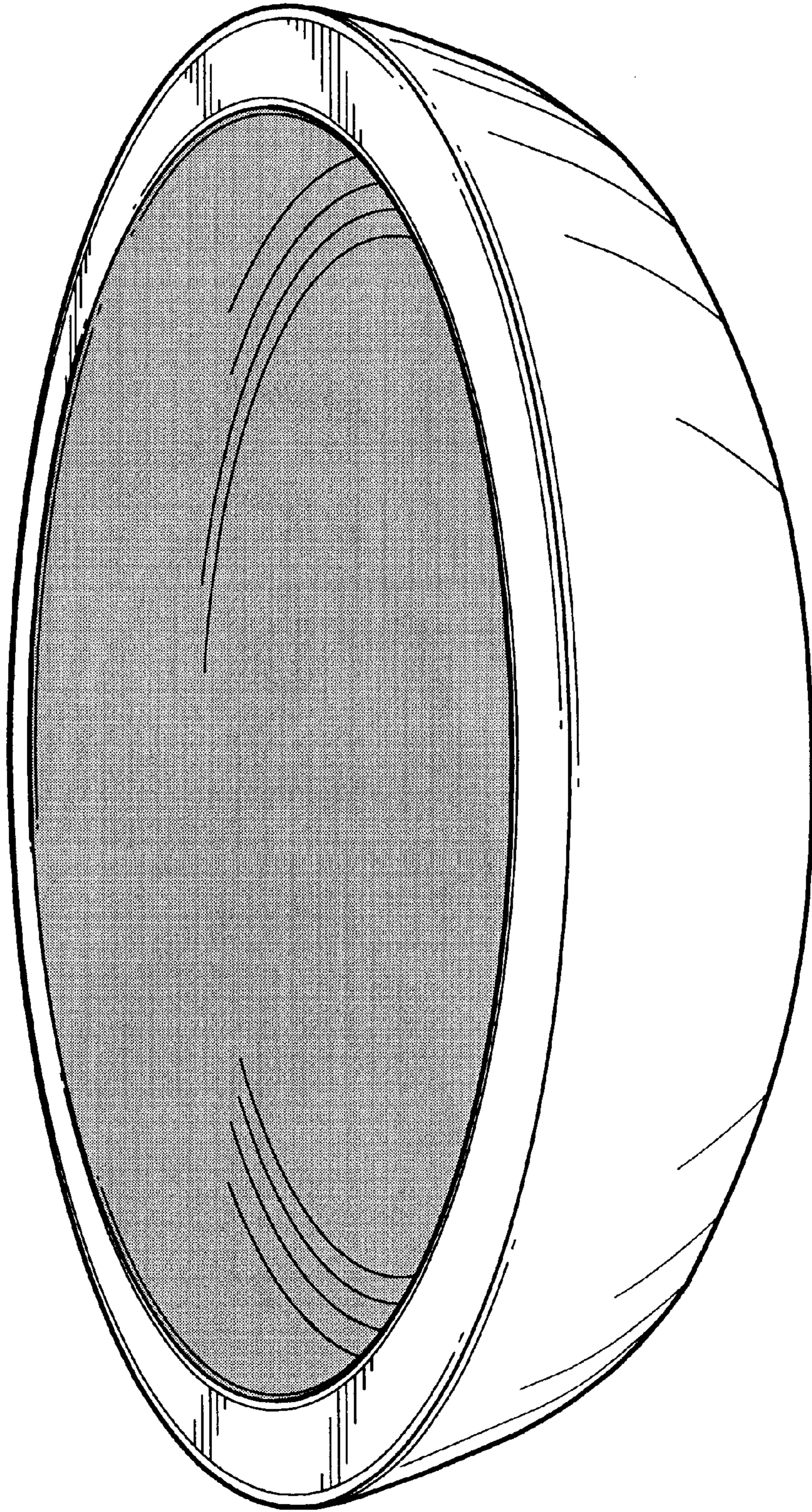

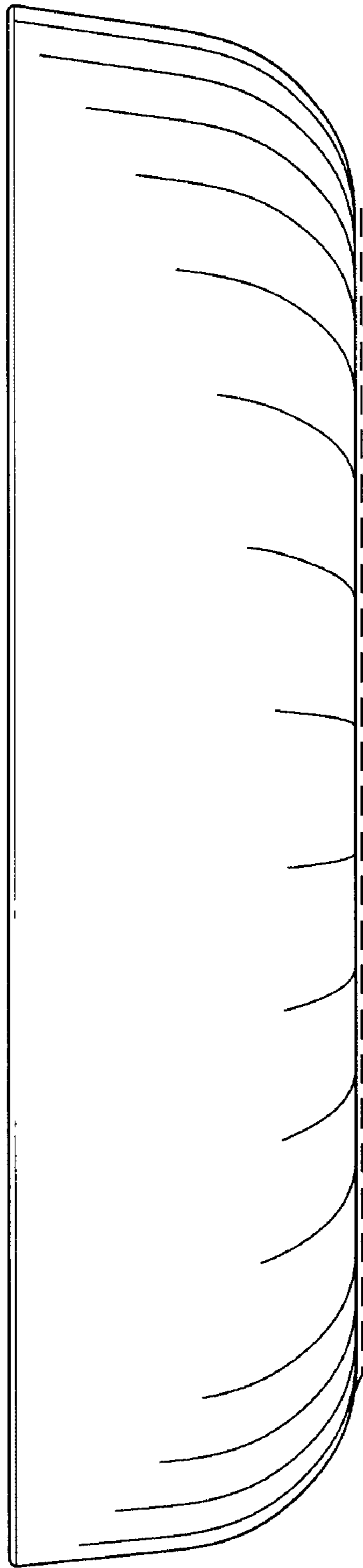

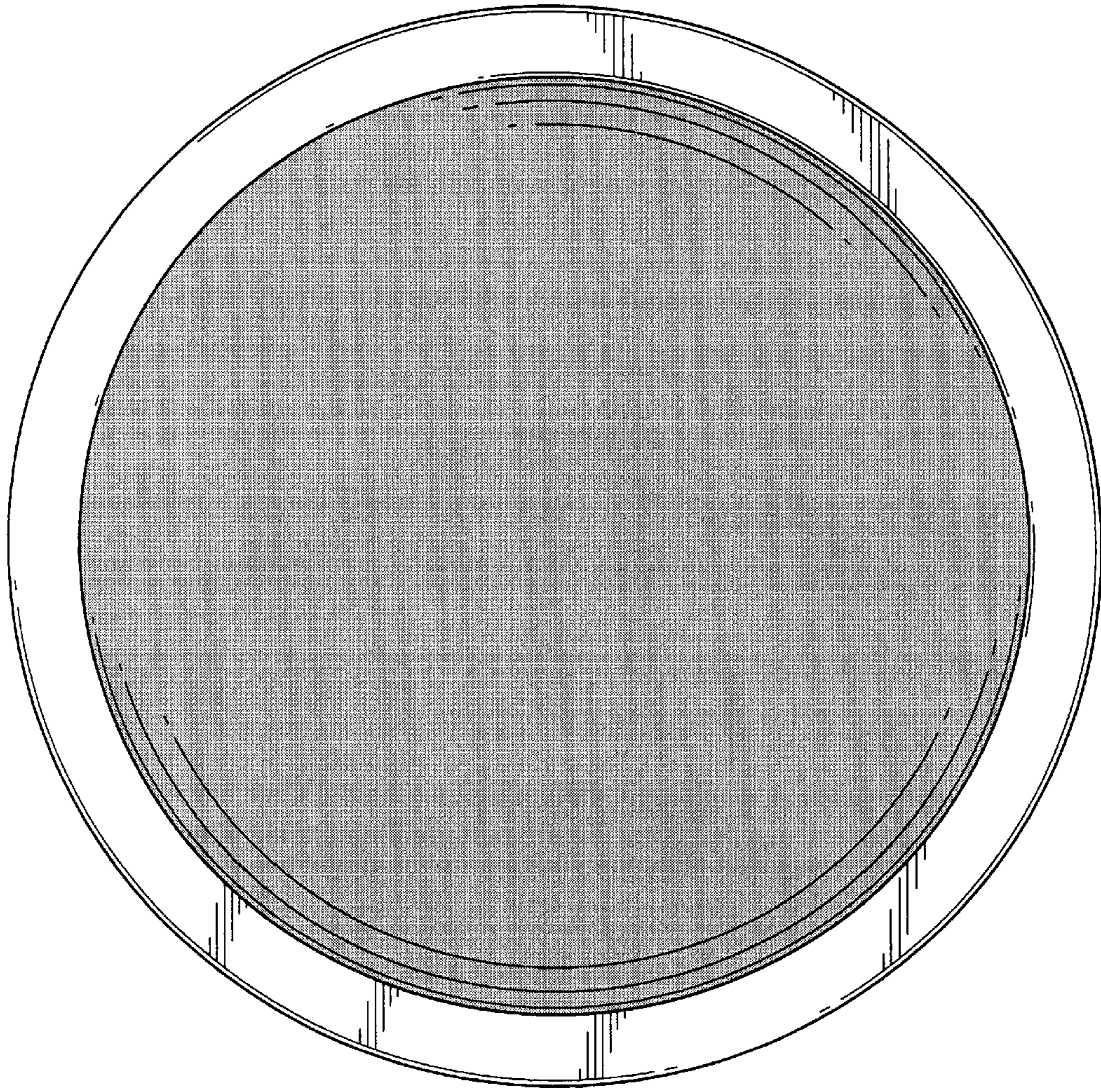

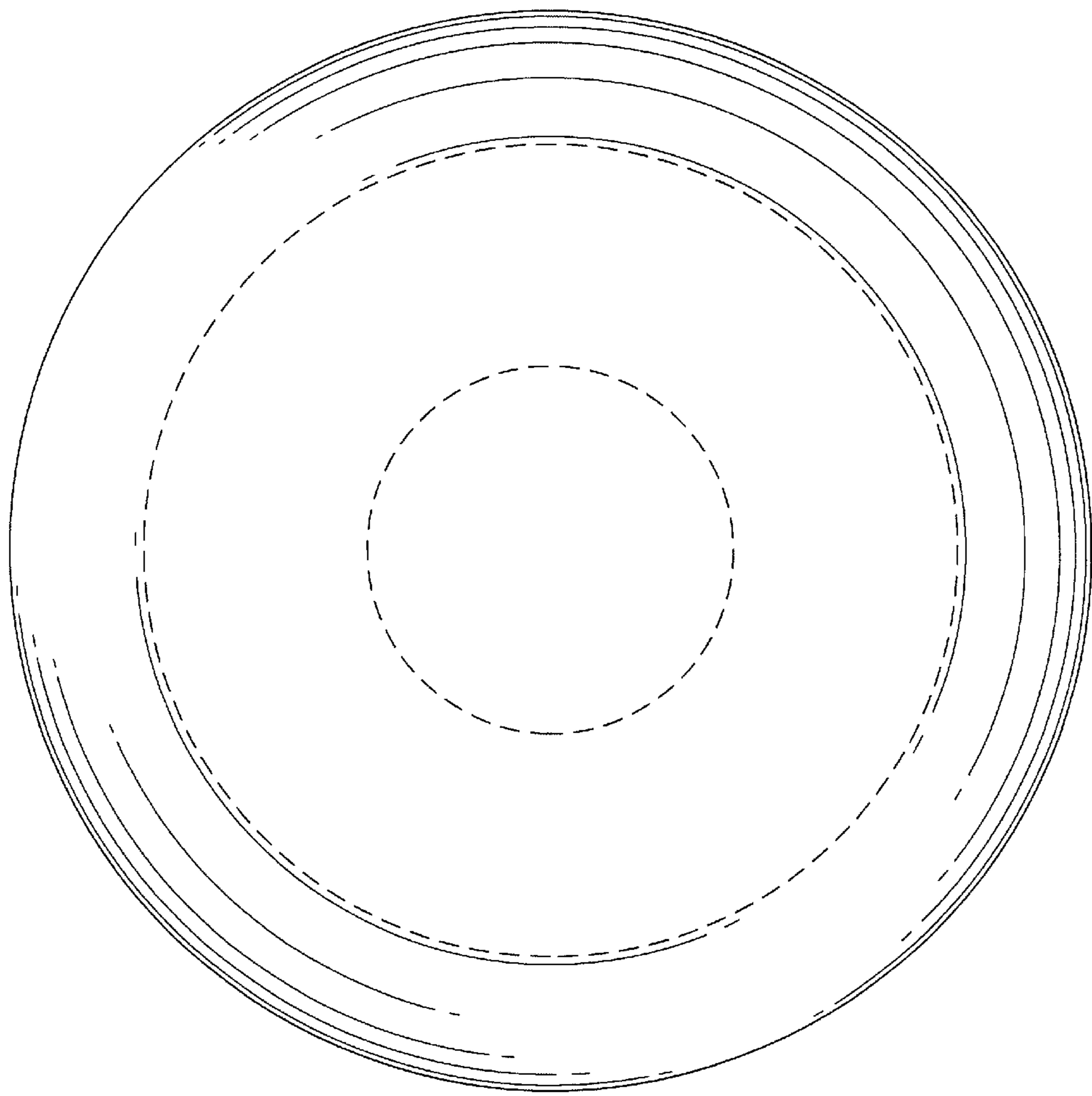
