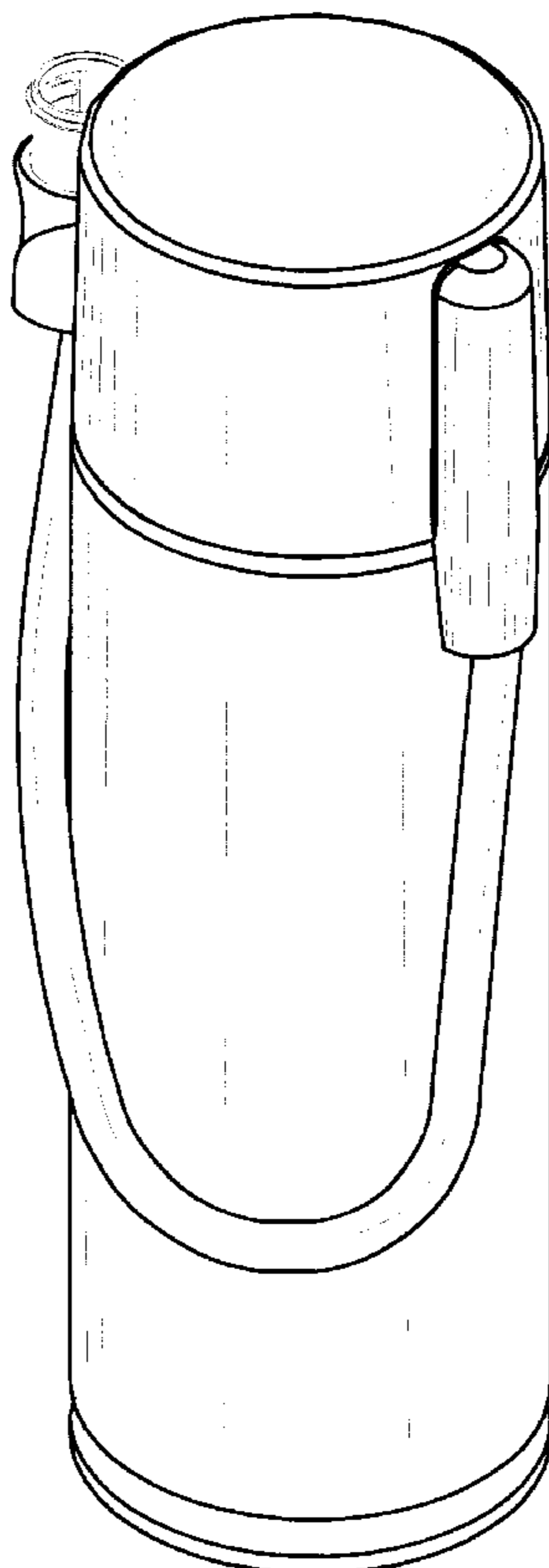
(57) **CLAIM**

The ornamental design for an aerosol dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the aerosol dispenser of the claimed design;
FIG. 2 is a front elevational view of the article shown in FIG. 1,
FIG. 3 is a rear elevational view of the article shown in FIG. 1;
FIG. 4 is a side elevational view of the article shown in FIG. 1, the opposite side view being a mirror image thereof;
FIG. 5 is a top plan view of the article shown in FIG. 4; and,
FIG. 6 is a bottom plan view of the article shown in FIG. 4.

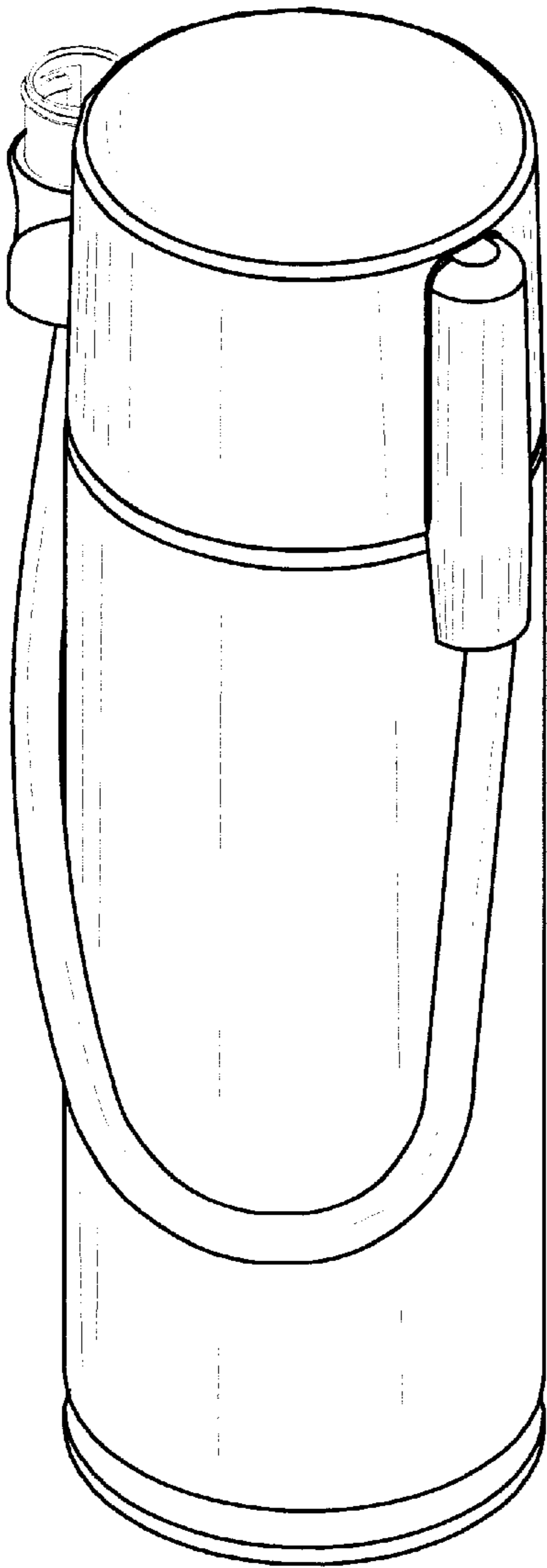

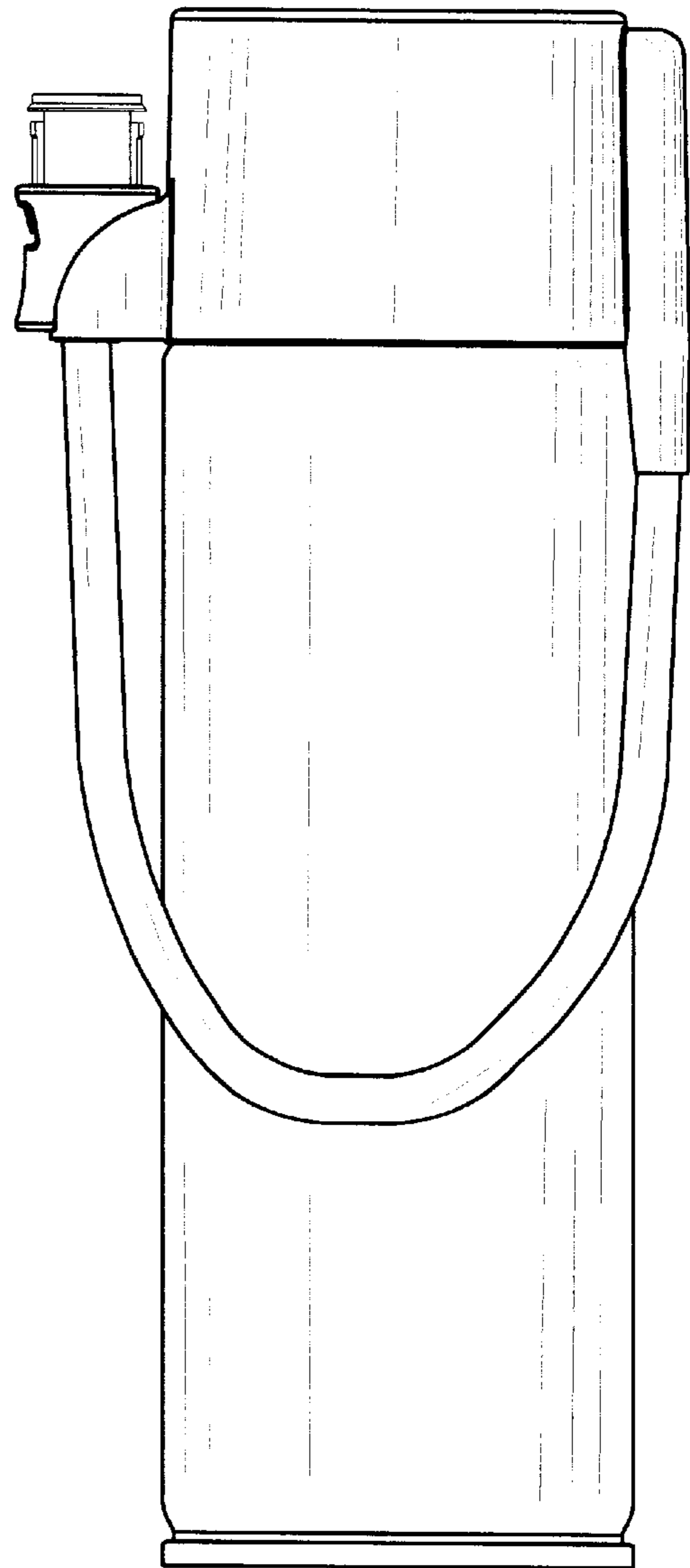

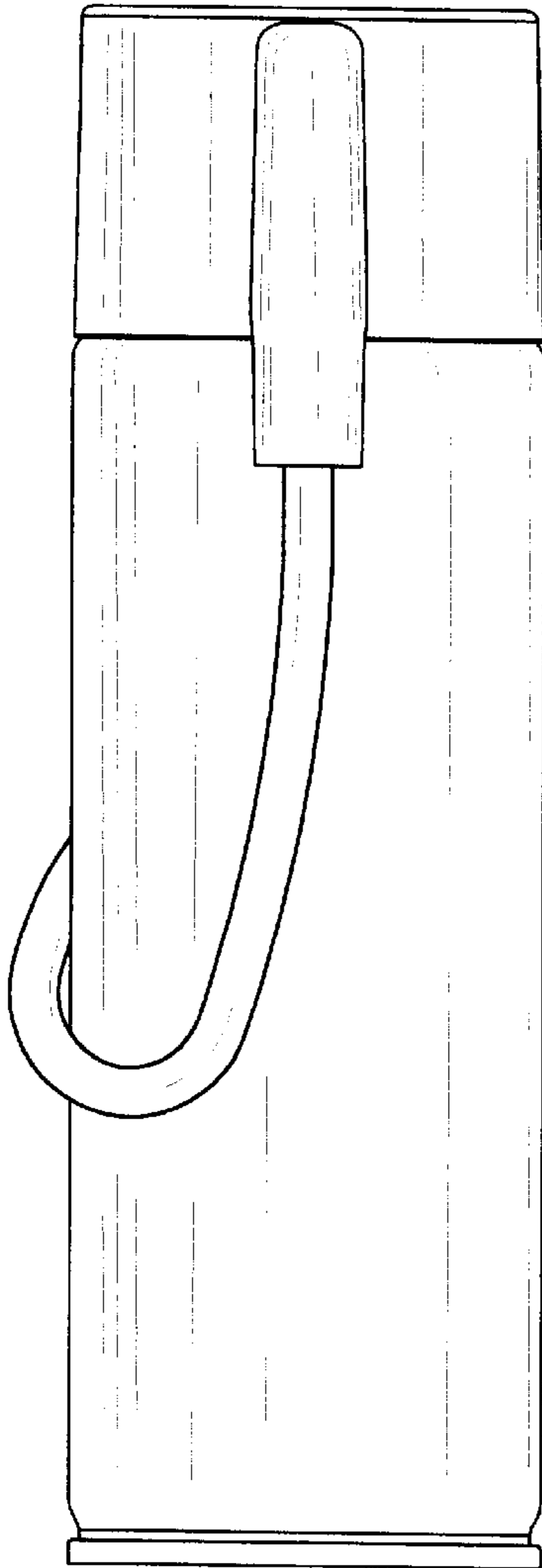

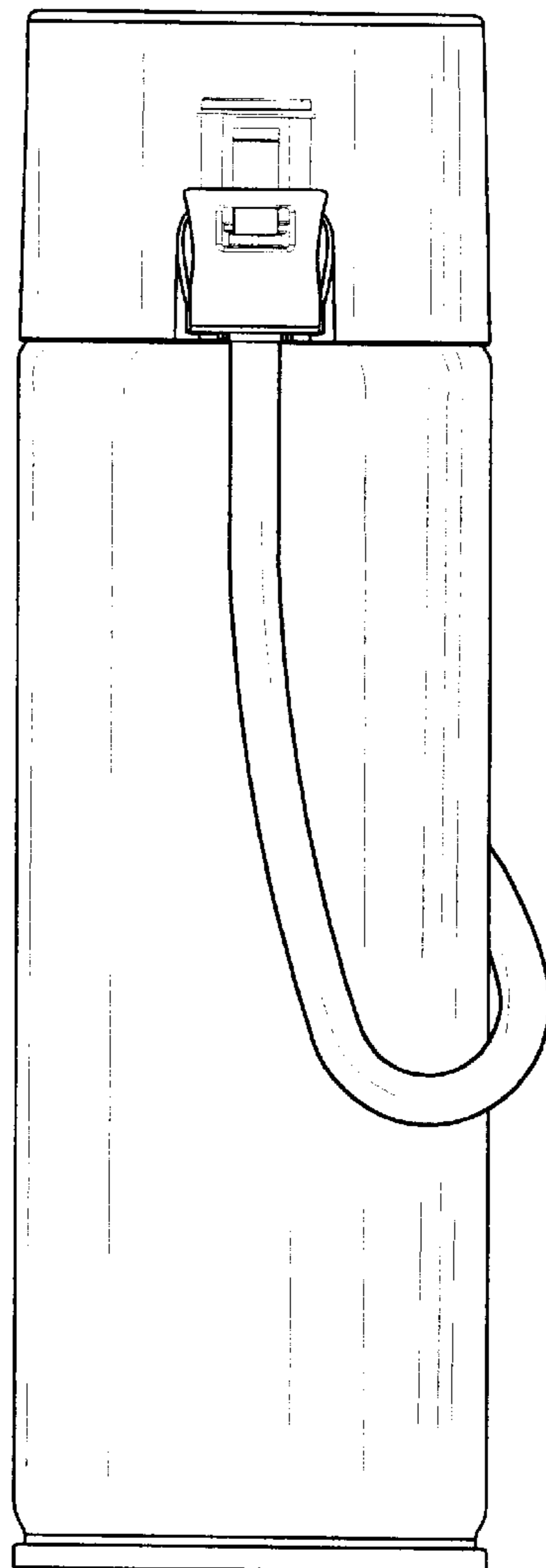

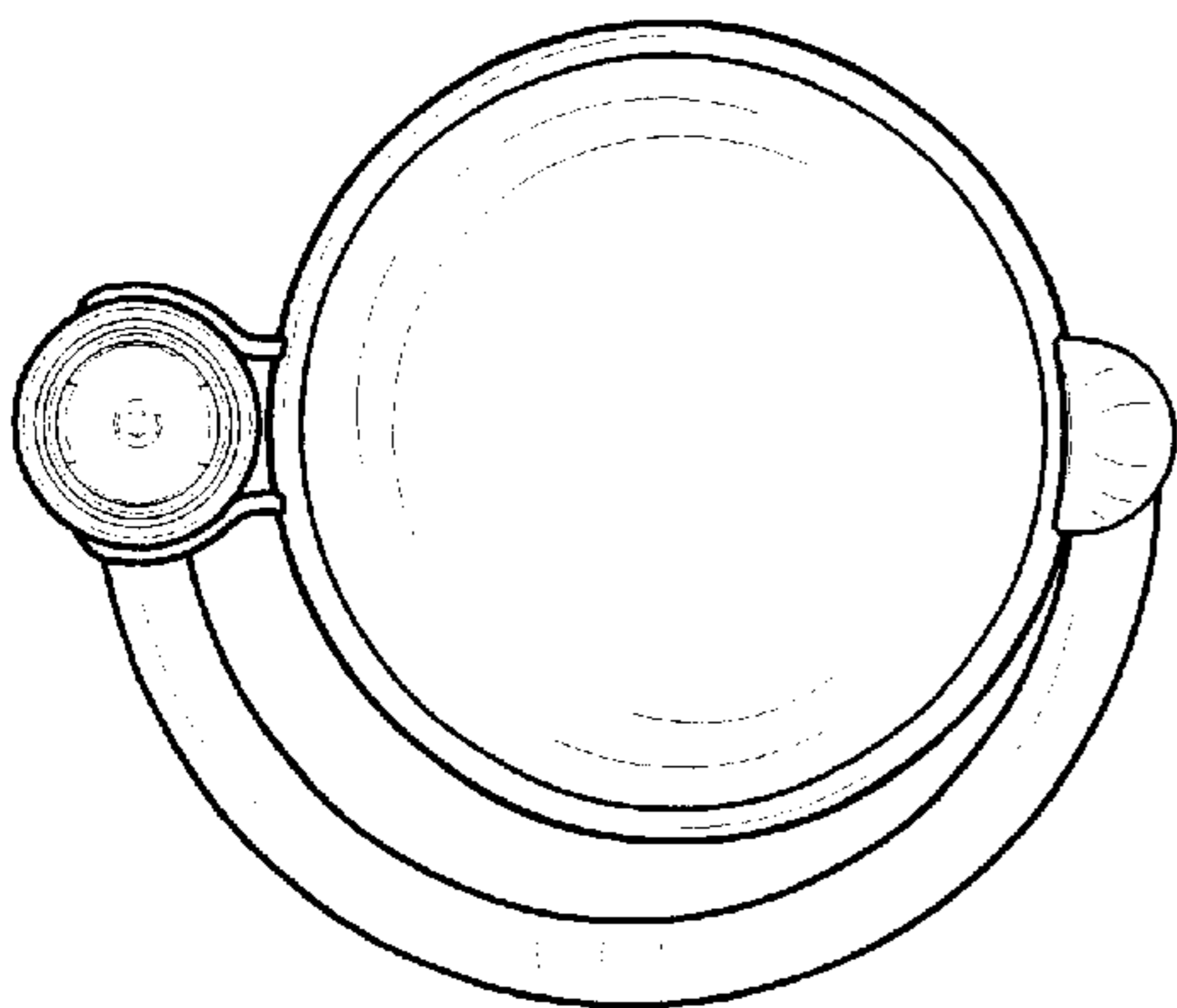

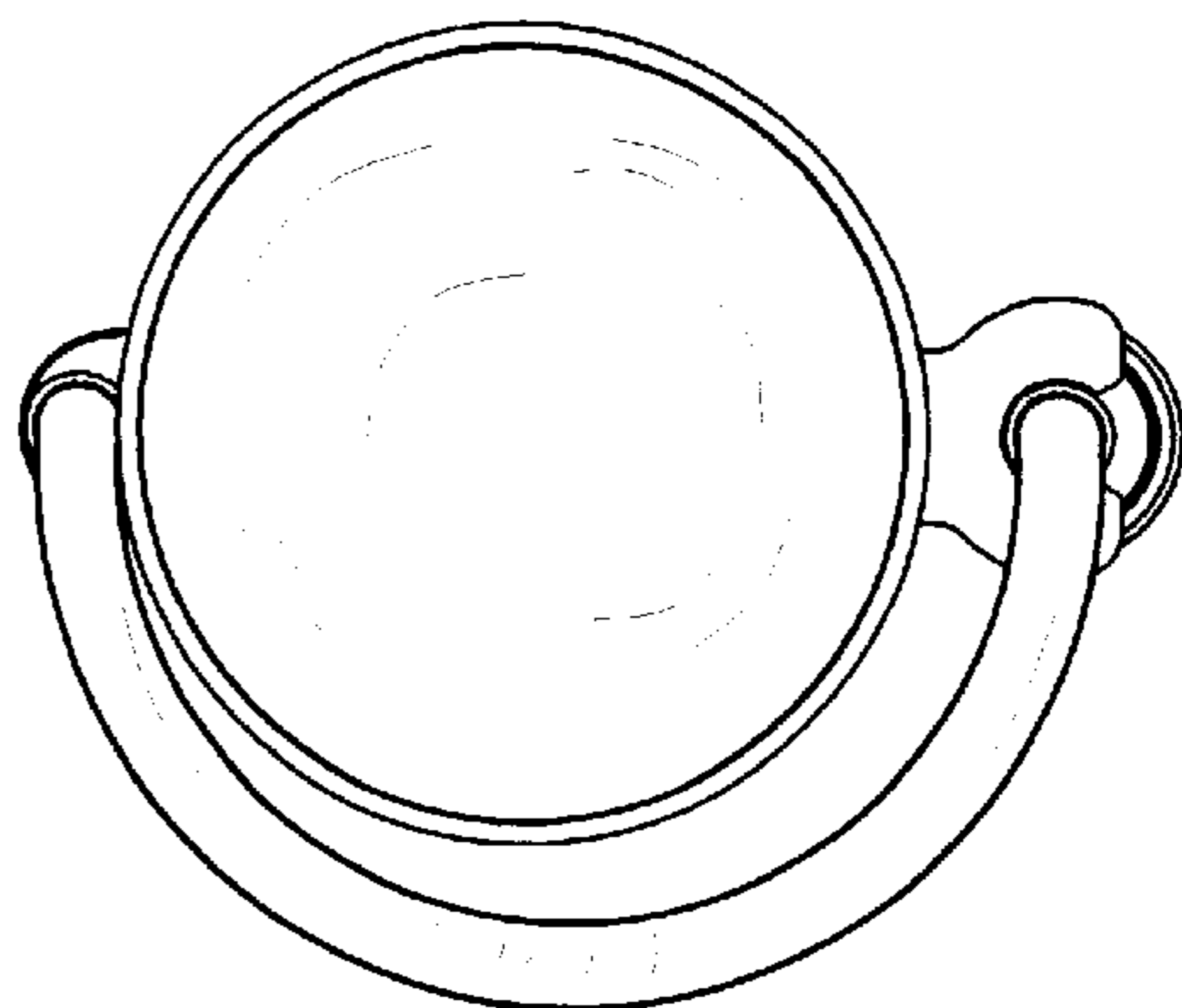
