(57) **CLAIM**

We claim the ornamental design for a plastic bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a plastic bottle showing the present invention.

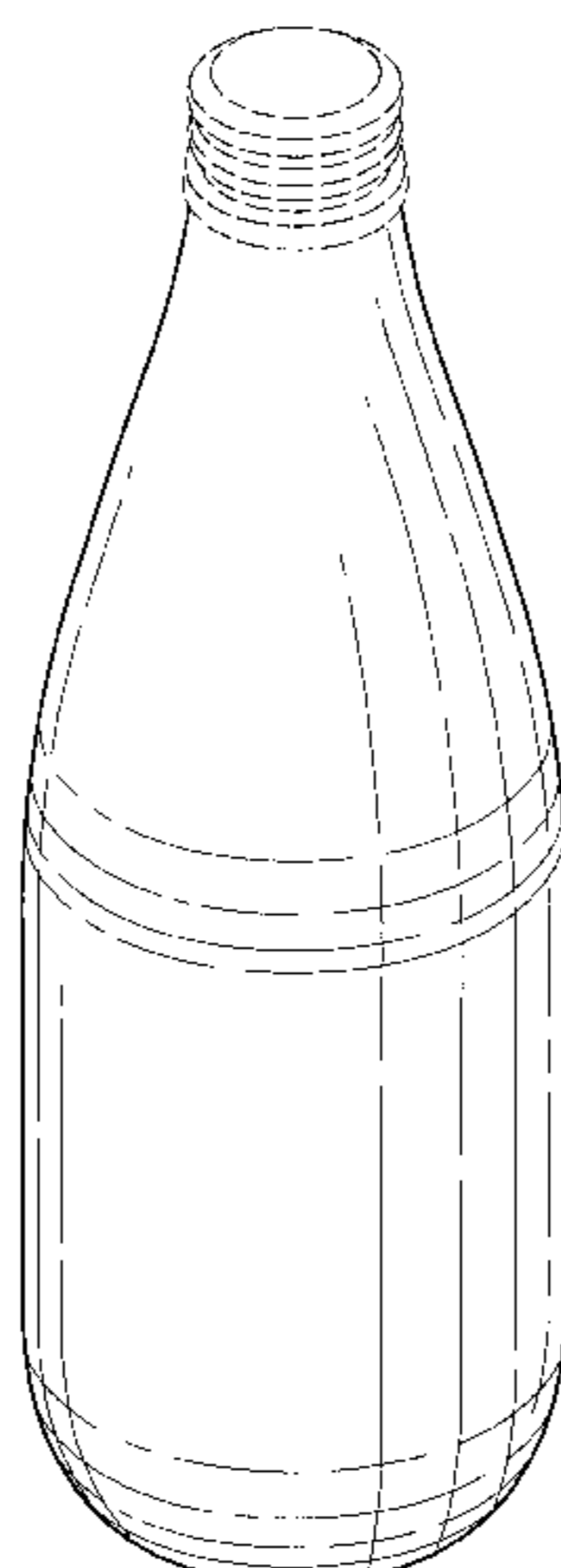
FIG. 2 is a side elevation view of the bottle shown in FIG. 1, all sides being identical.

FIG. 3 is a plan view from the top of FIG. 2; and,

FIG. 4 is a plan view from the bottom of FIG. 2.

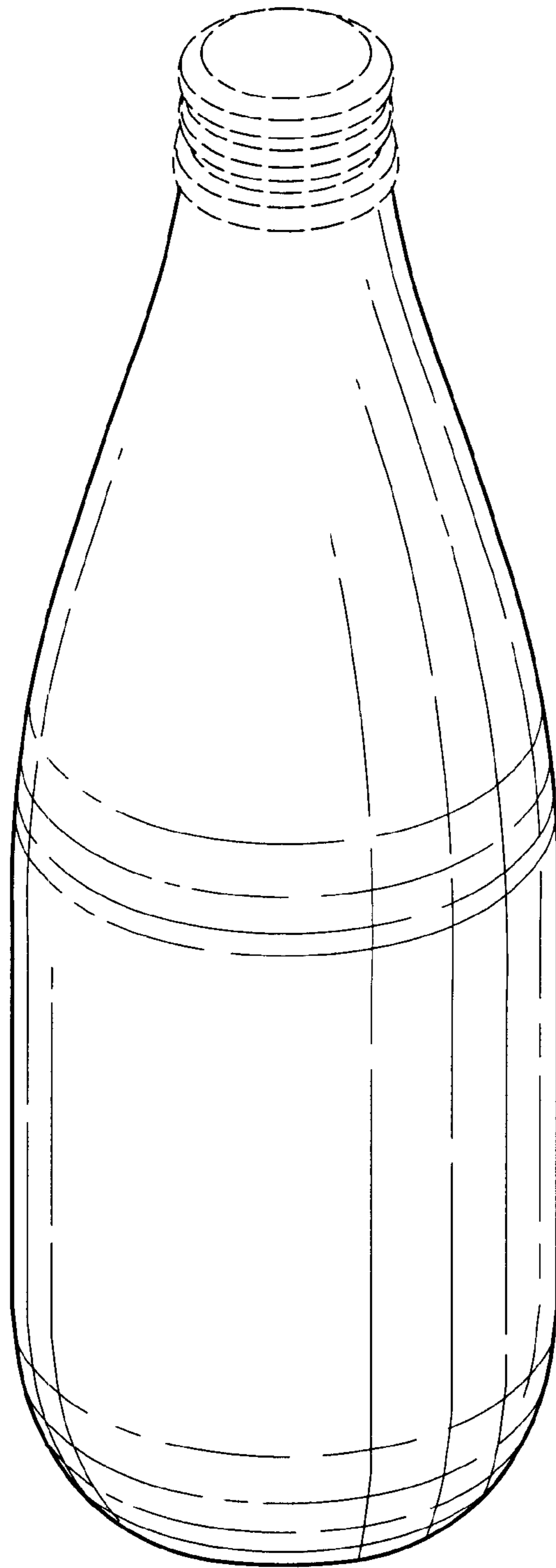

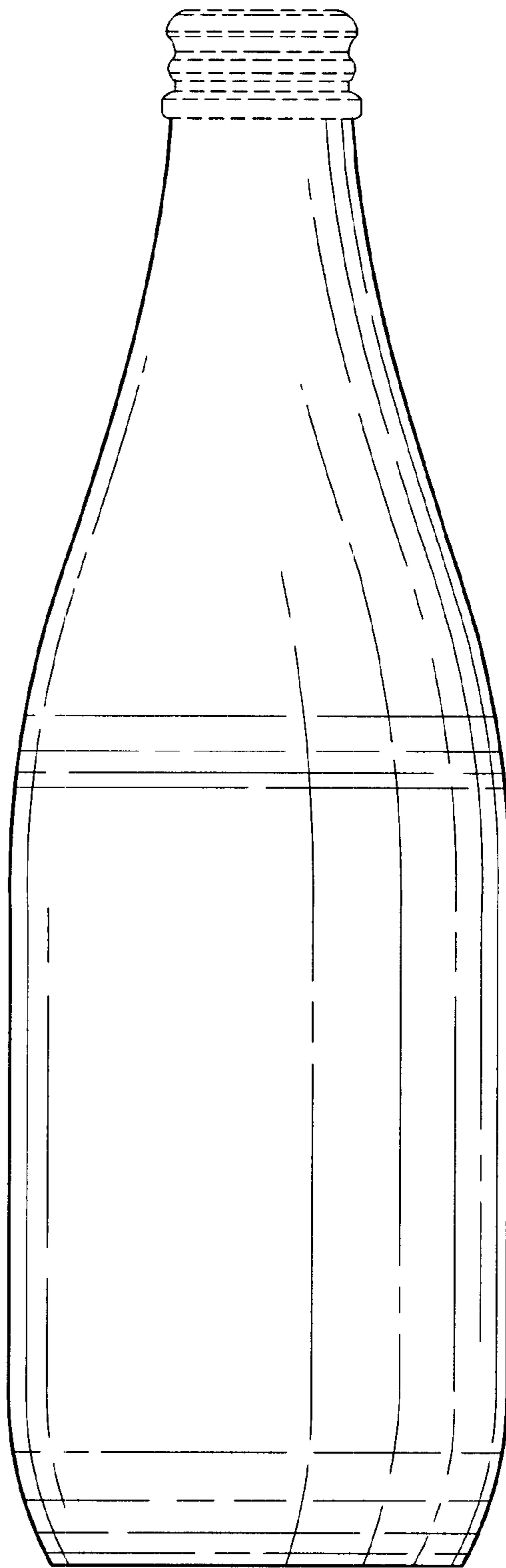

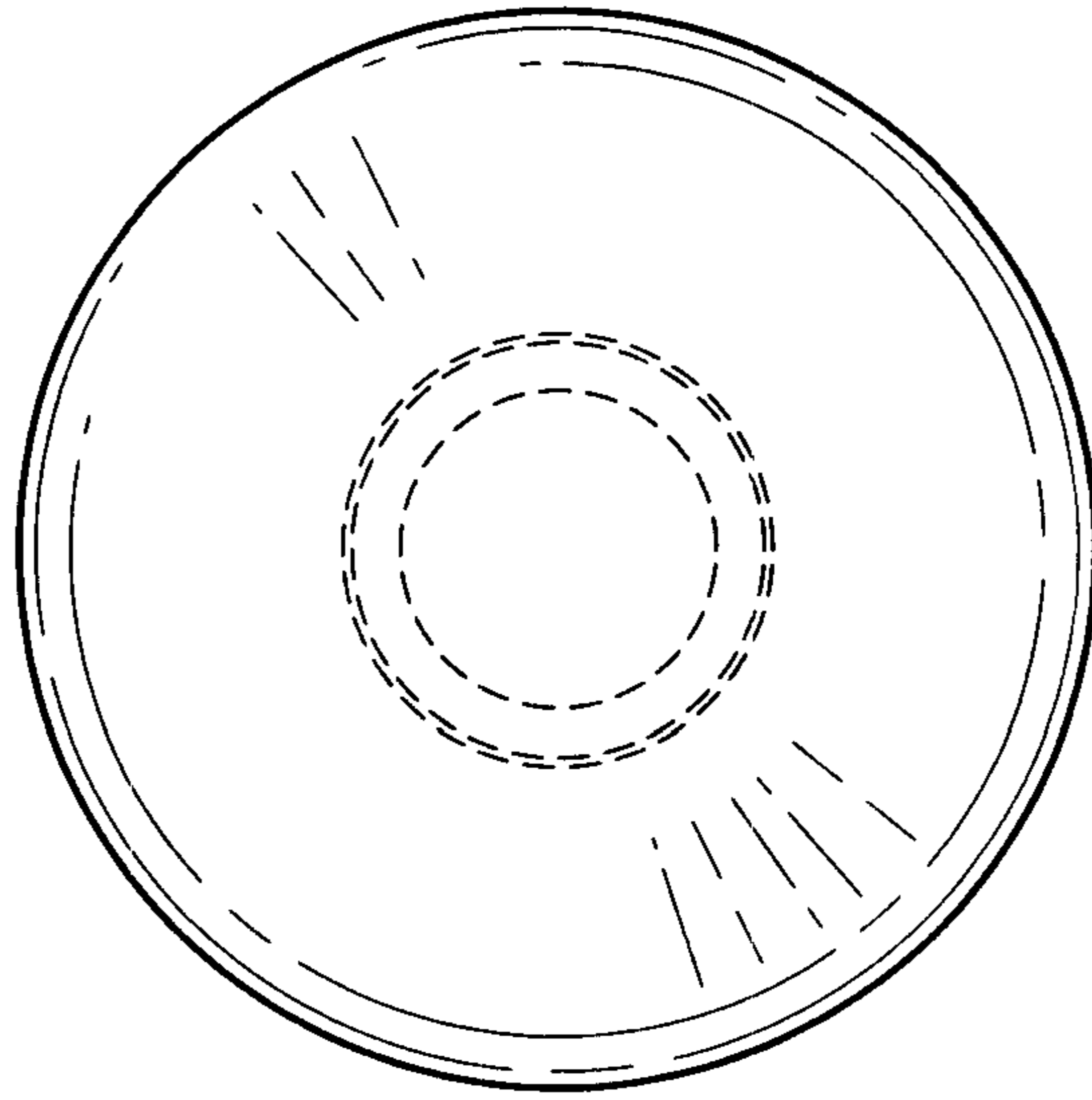

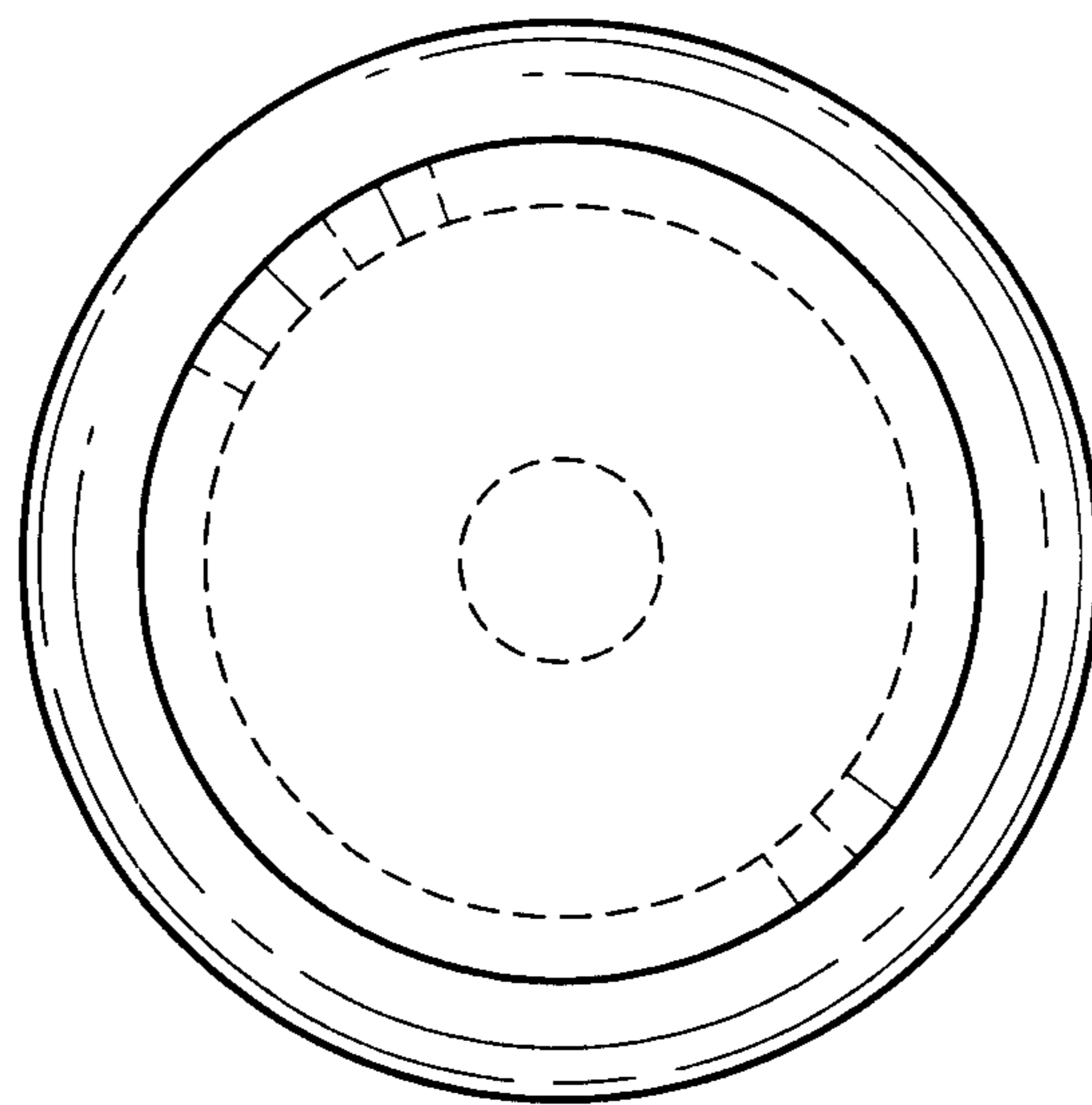
