**DESCRIPTION**

FIG. 1 is a front elevational view of a wax machine, showing my new design;

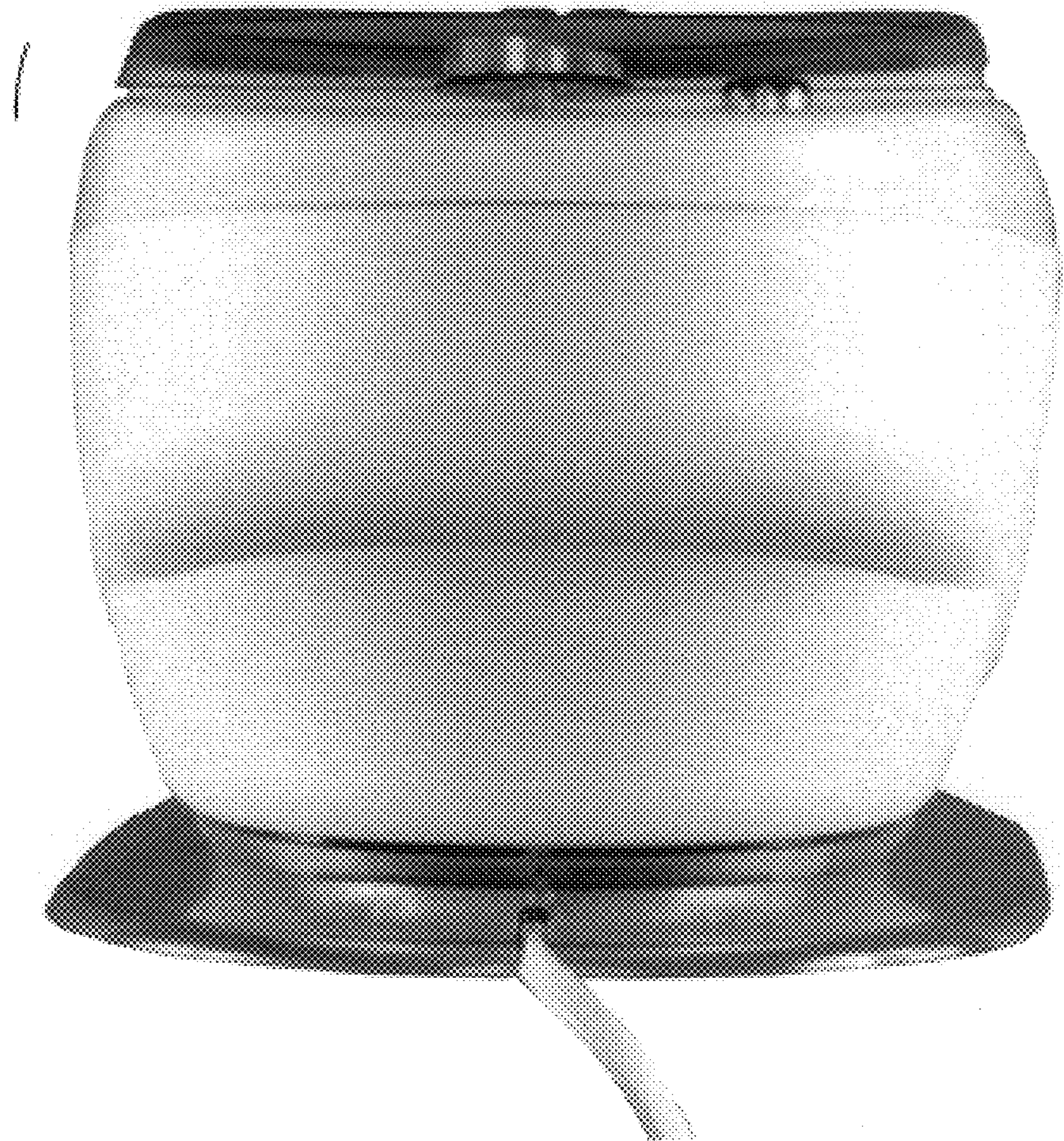

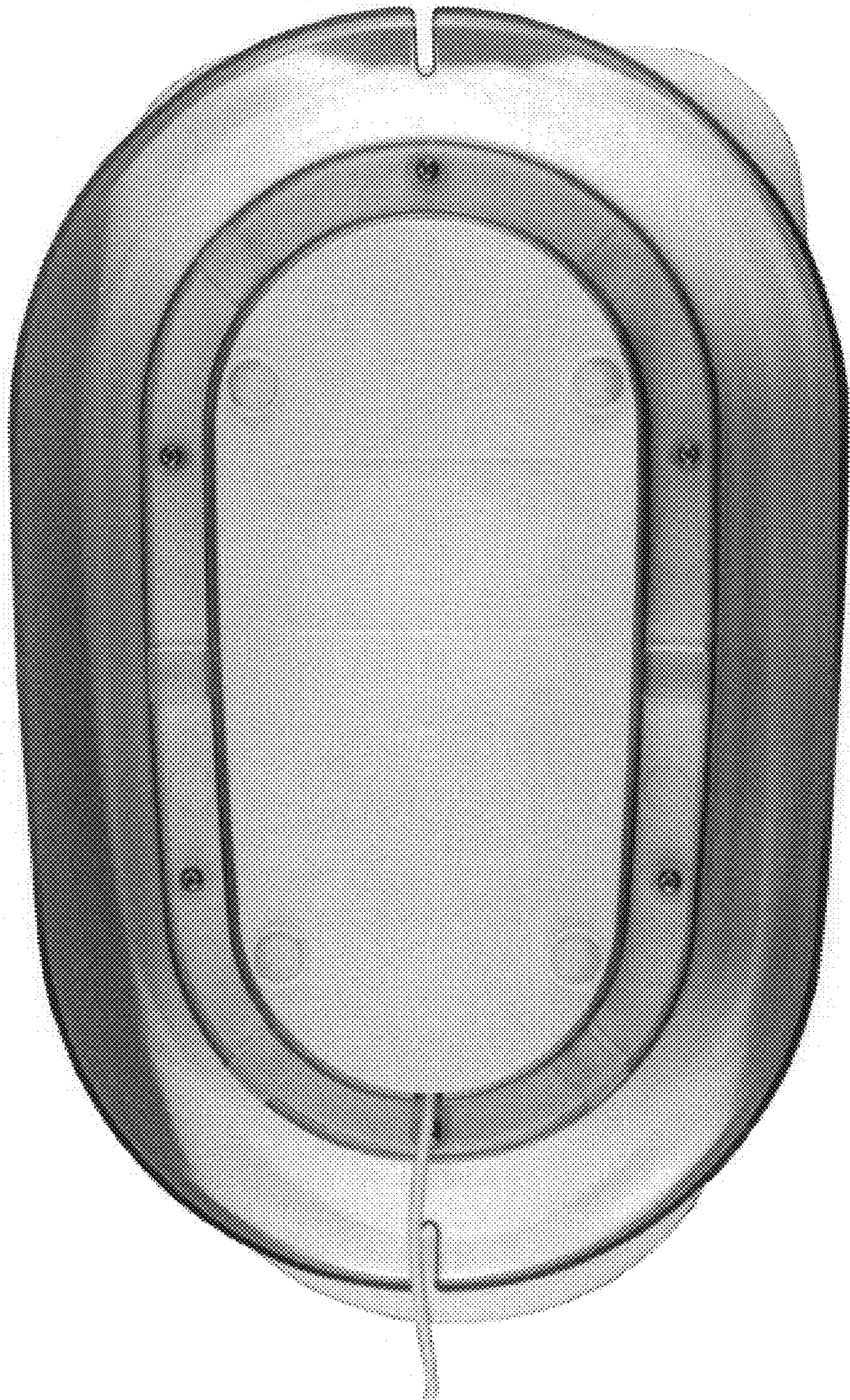
