**DESCRIPTION**

FIG. 1 is a top perspective view of a refreezable lid showing our new design;

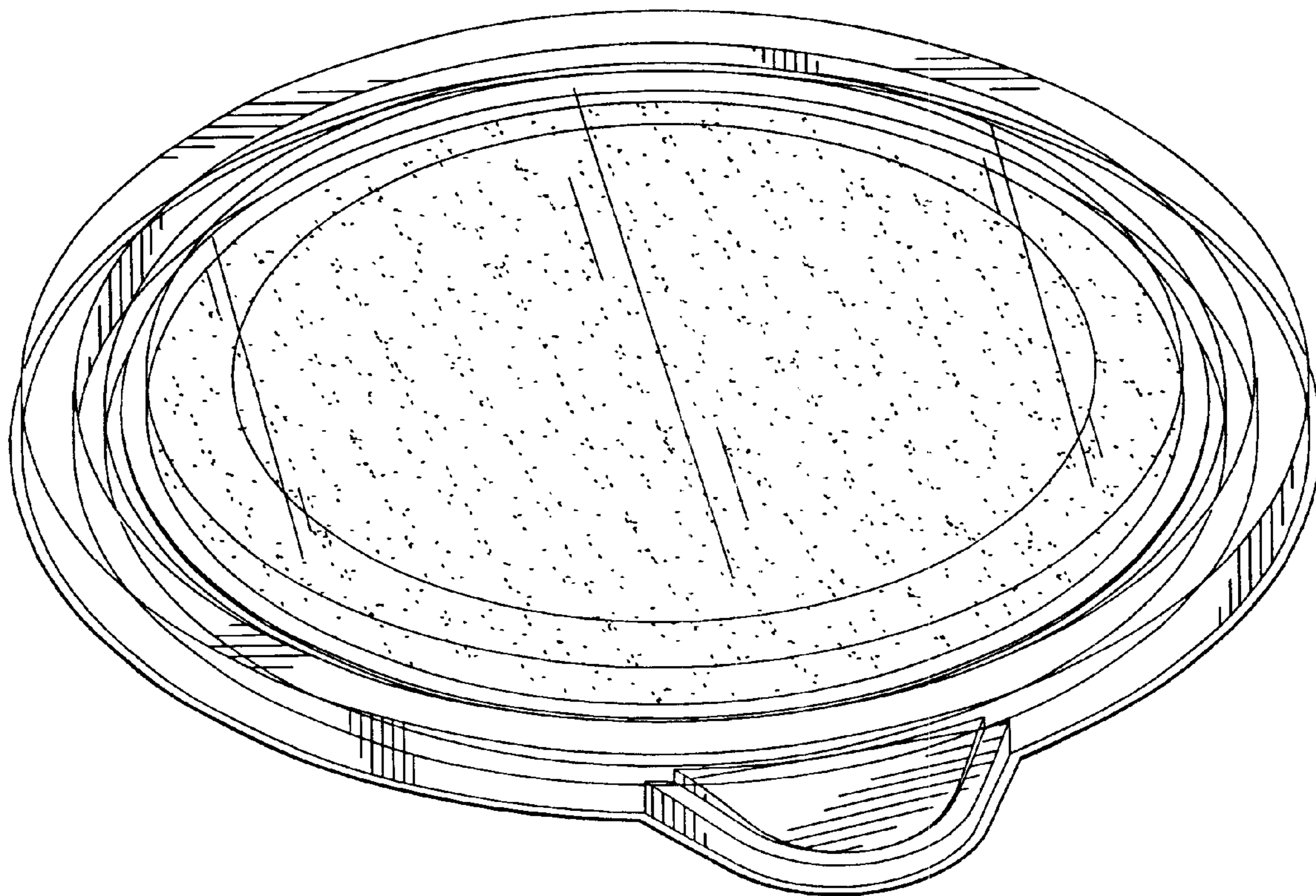

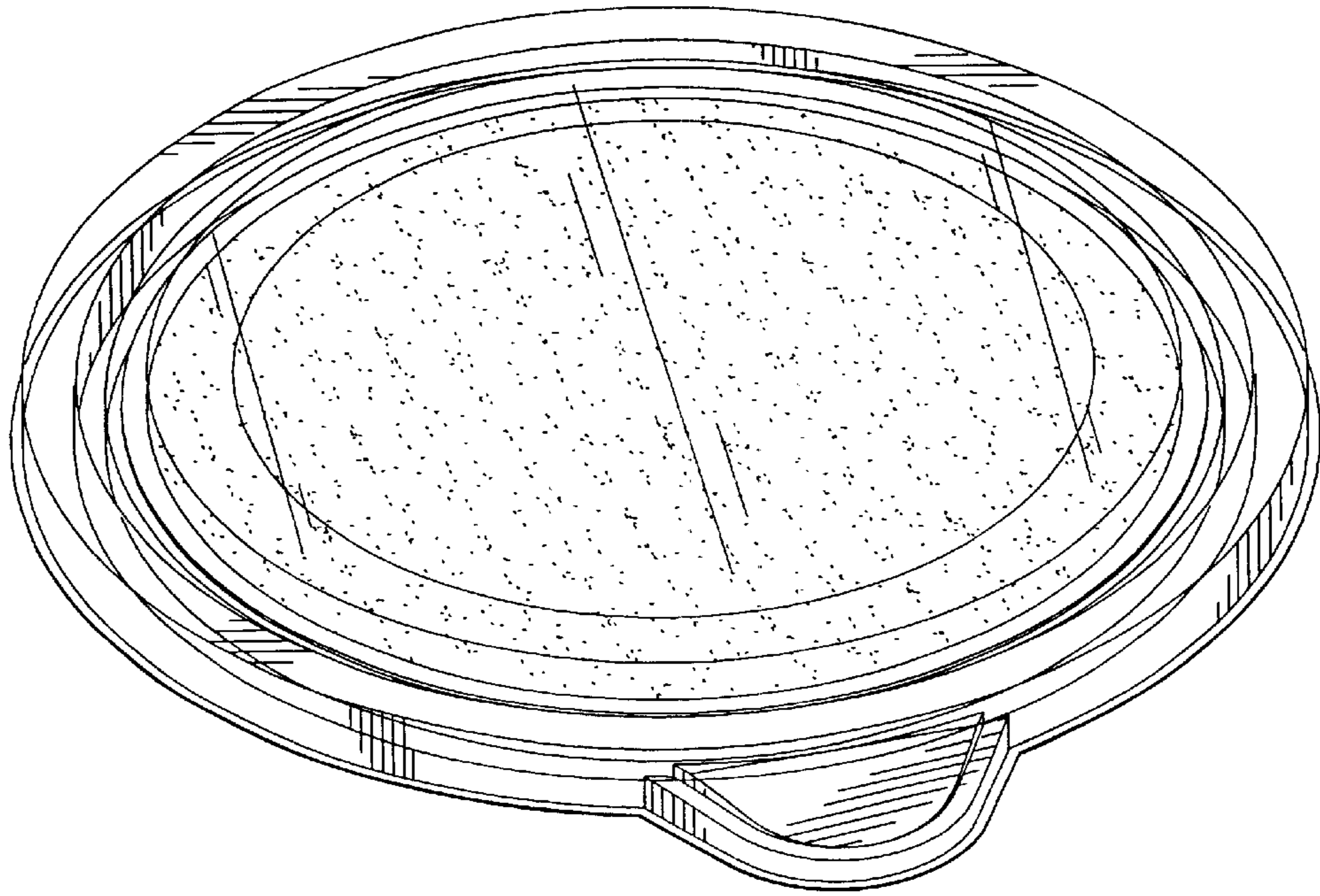

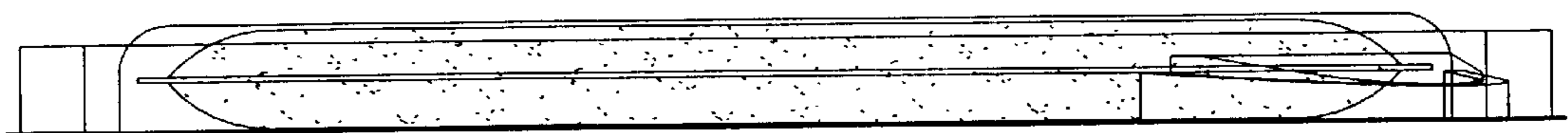

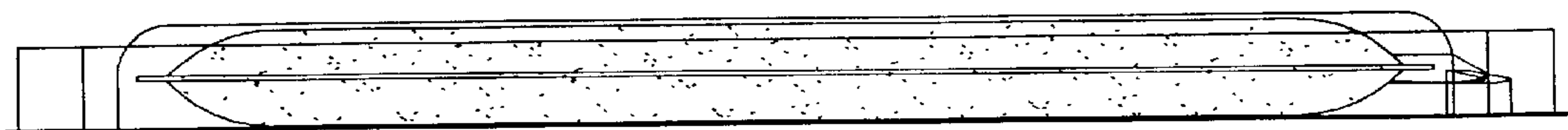

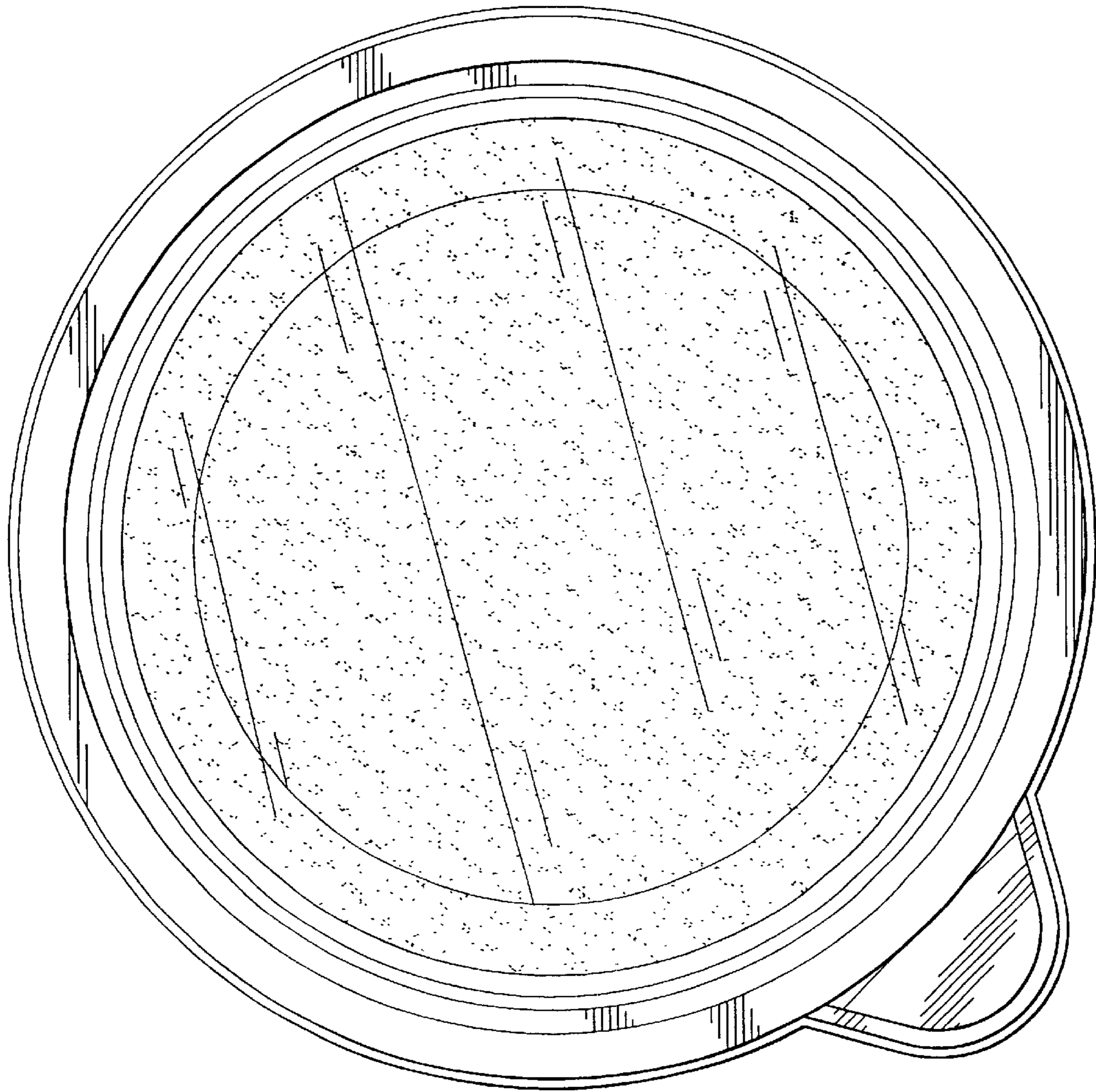

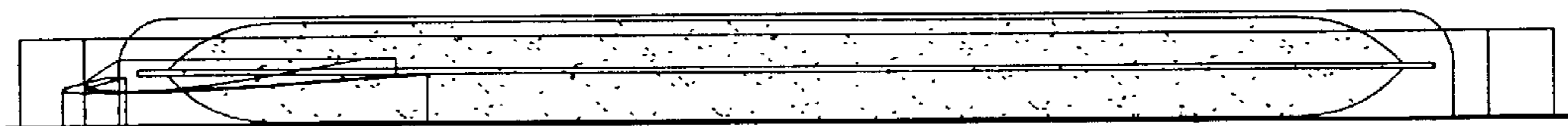

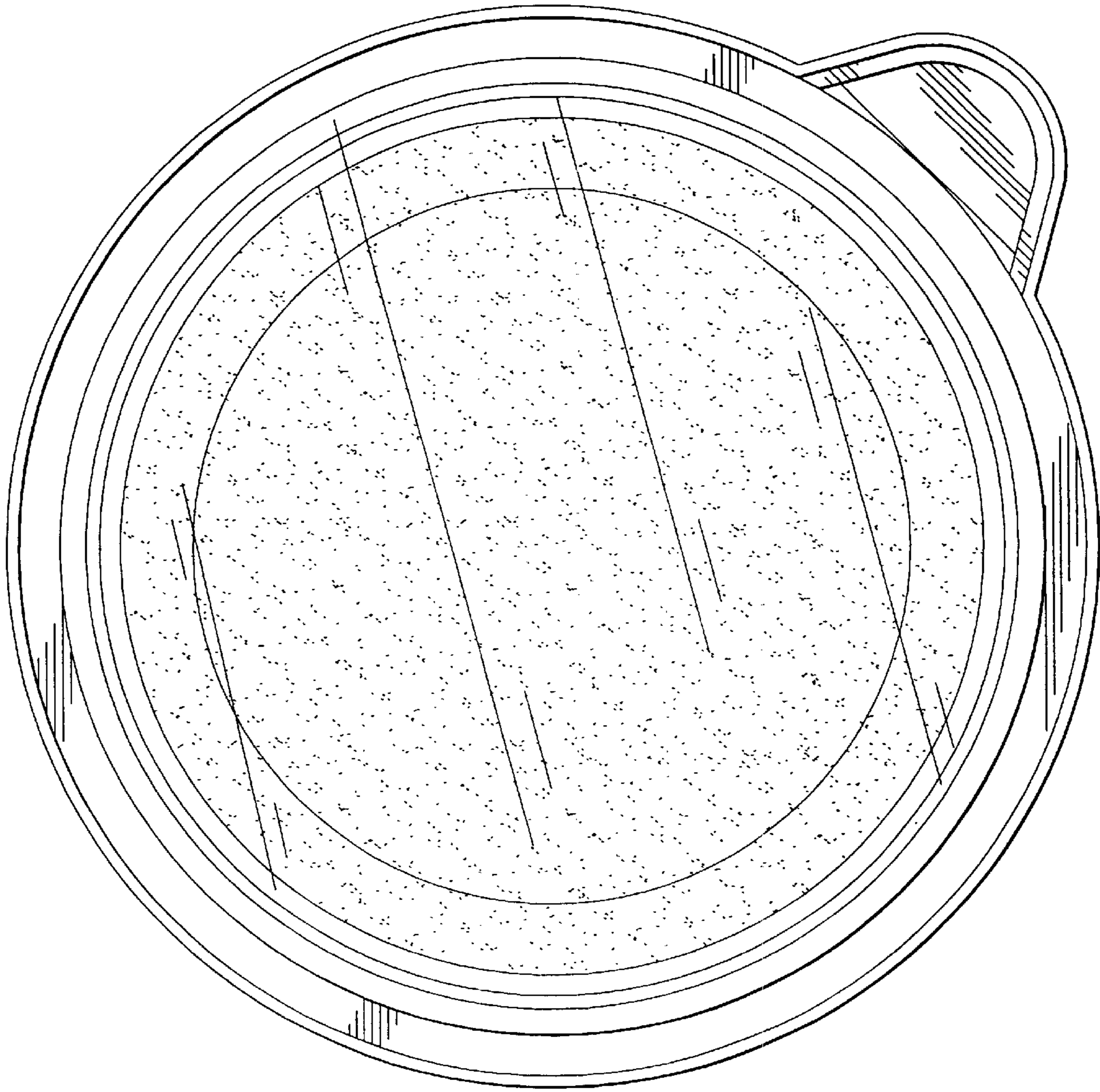
