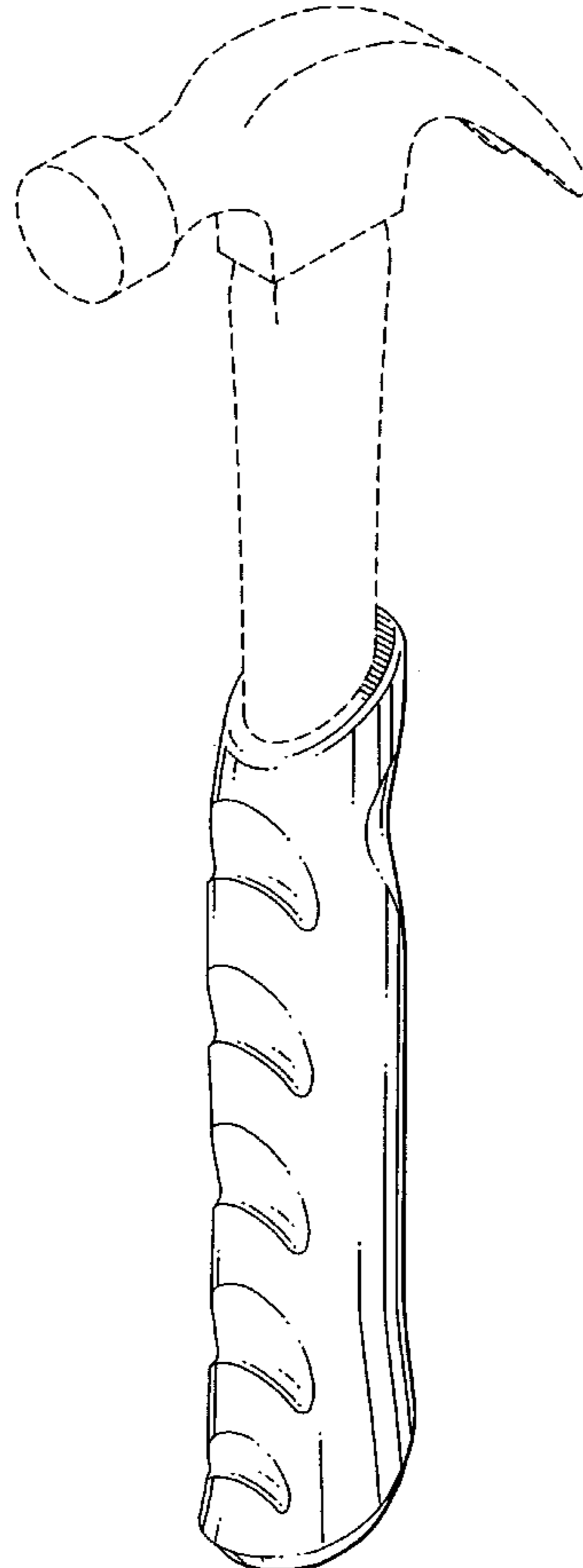
(57) **CLAIM**

The ornamental design for a hammer handle, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the
hammer handle;
FIG. 2 is a side view of the embodiment of FIG. 1, the
opposite side being a mirror image;
FIG. 3 is a front view of the embodiment of FIG. 1;
FIG. 4 is a rear view of the embodiment of FIG. 1;
FIG. 5 is a top plan view taken from the direction of arrows
5—5 of FIG. 2; and,
FIG. 6 is a bottom view of the embodiment of FIG. 1.

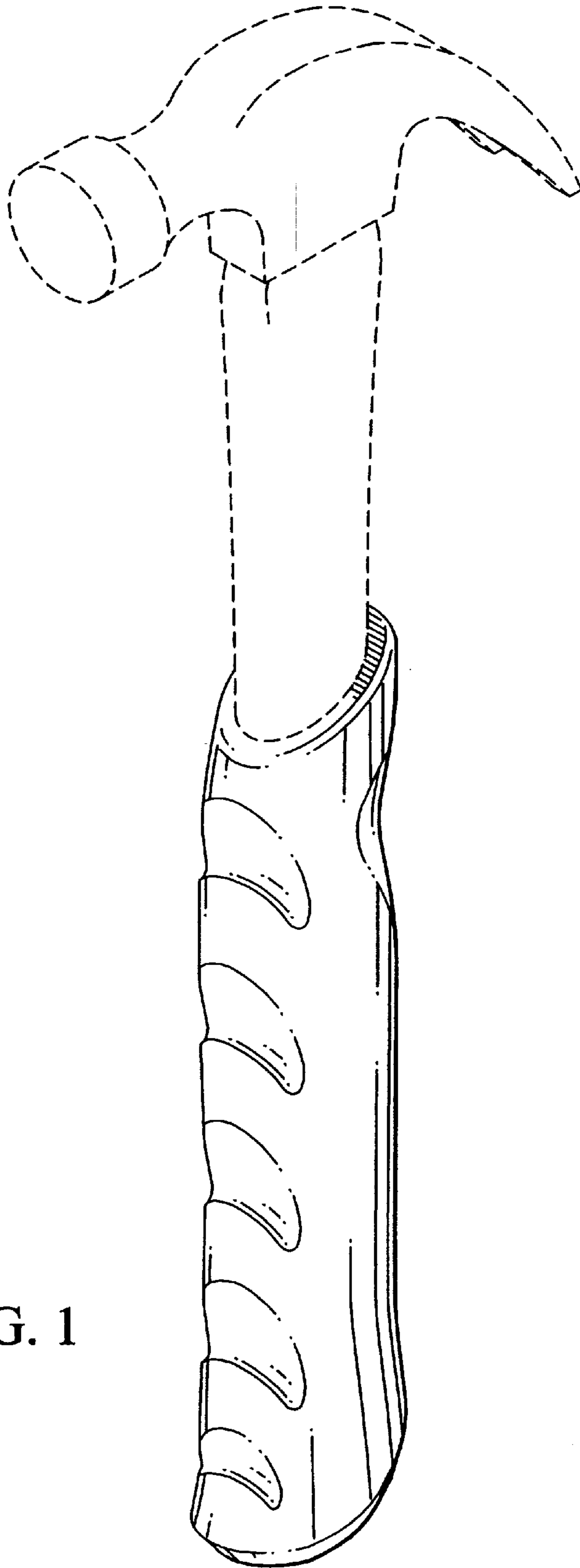

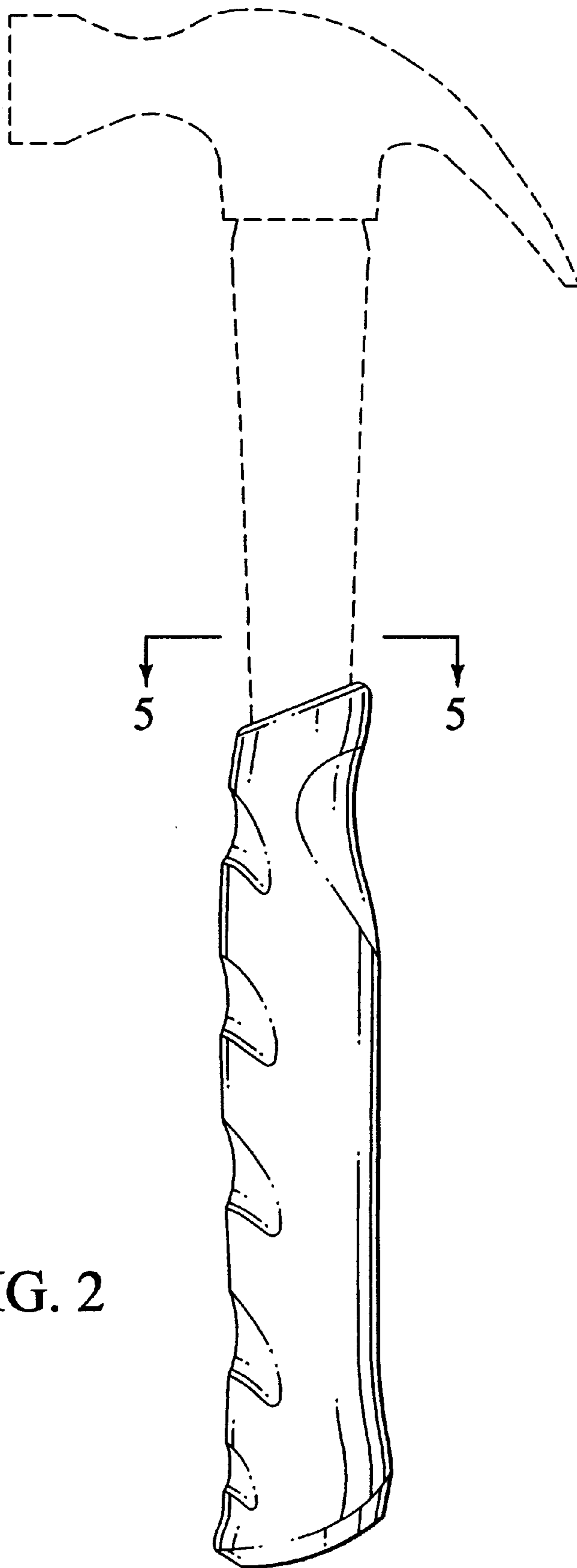

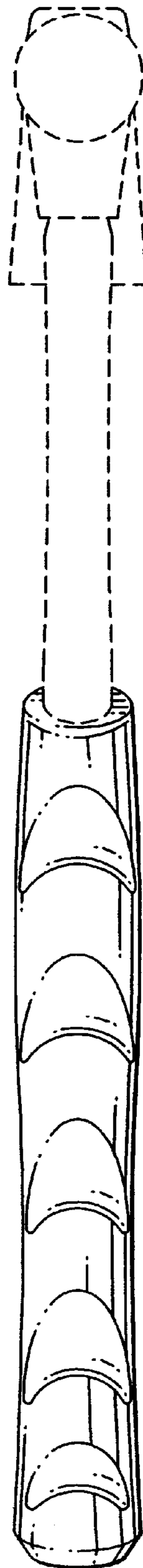

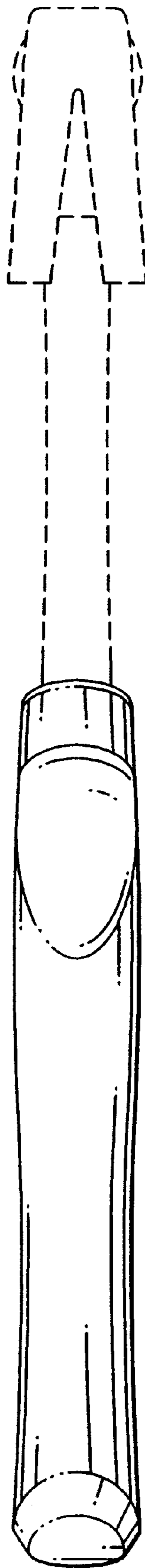

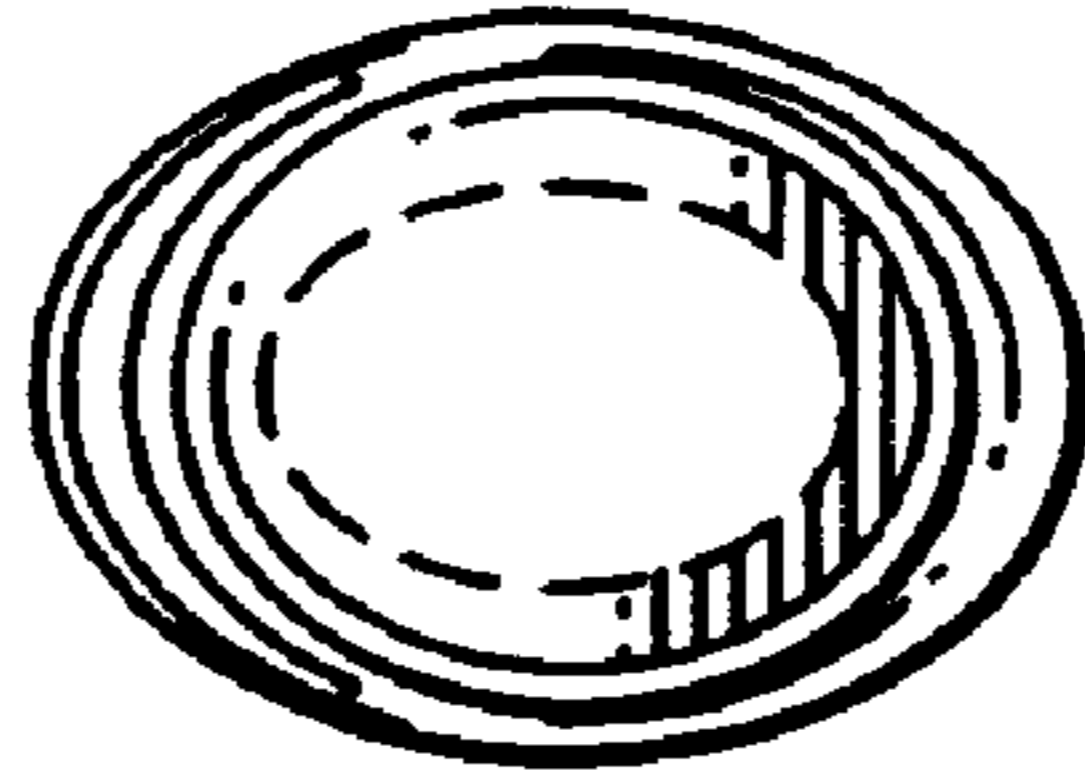

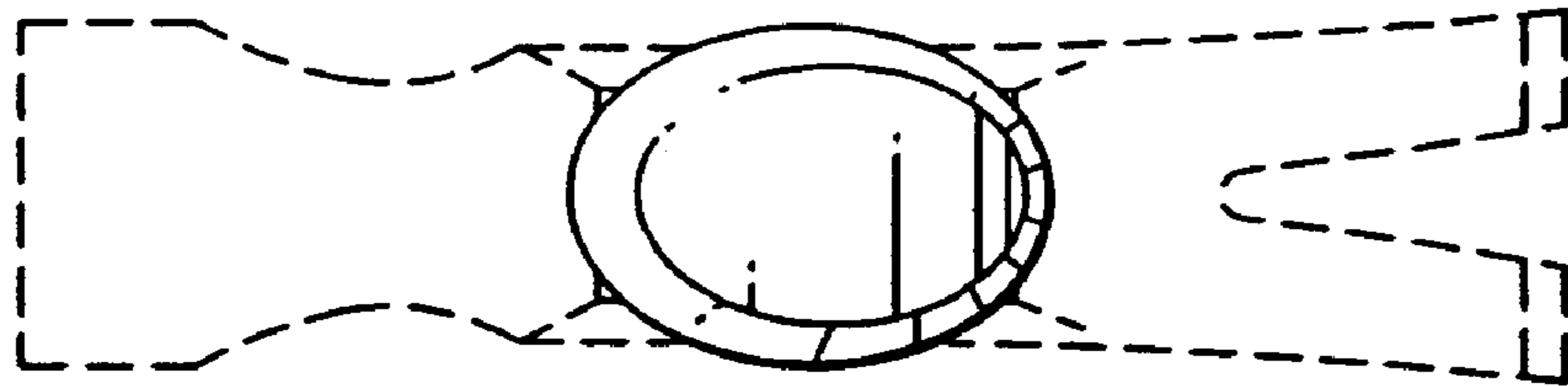
