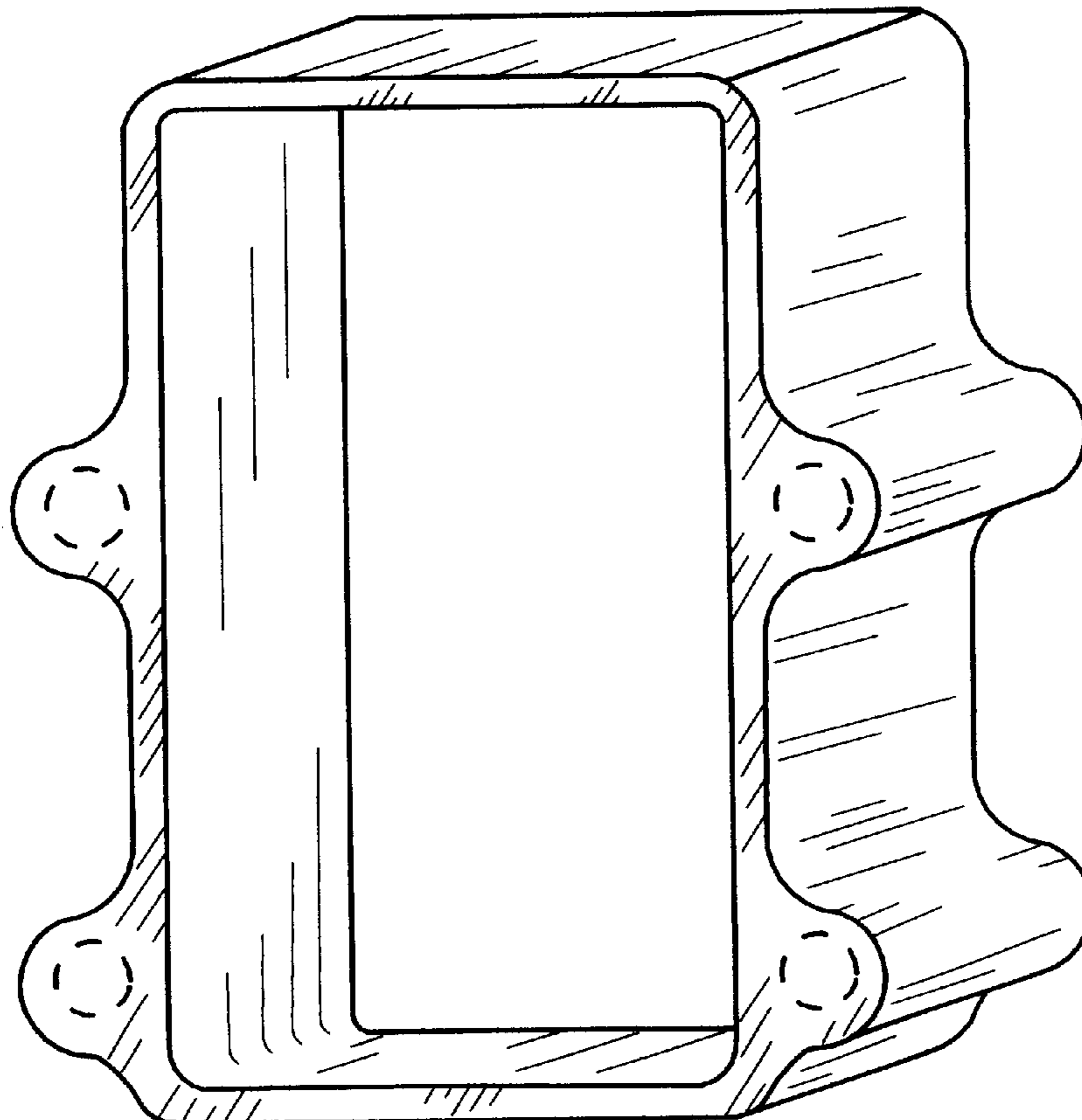
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the bracket of the present invention;  
FIG. 2 is a front view thereof, the rear view being identical to the front view;  
FIG. 3 is a right side view thereof, the left side view being identical to the right side view; and,  
FIG. 4 is a top view thereof, the bottom view being identical to the top view.

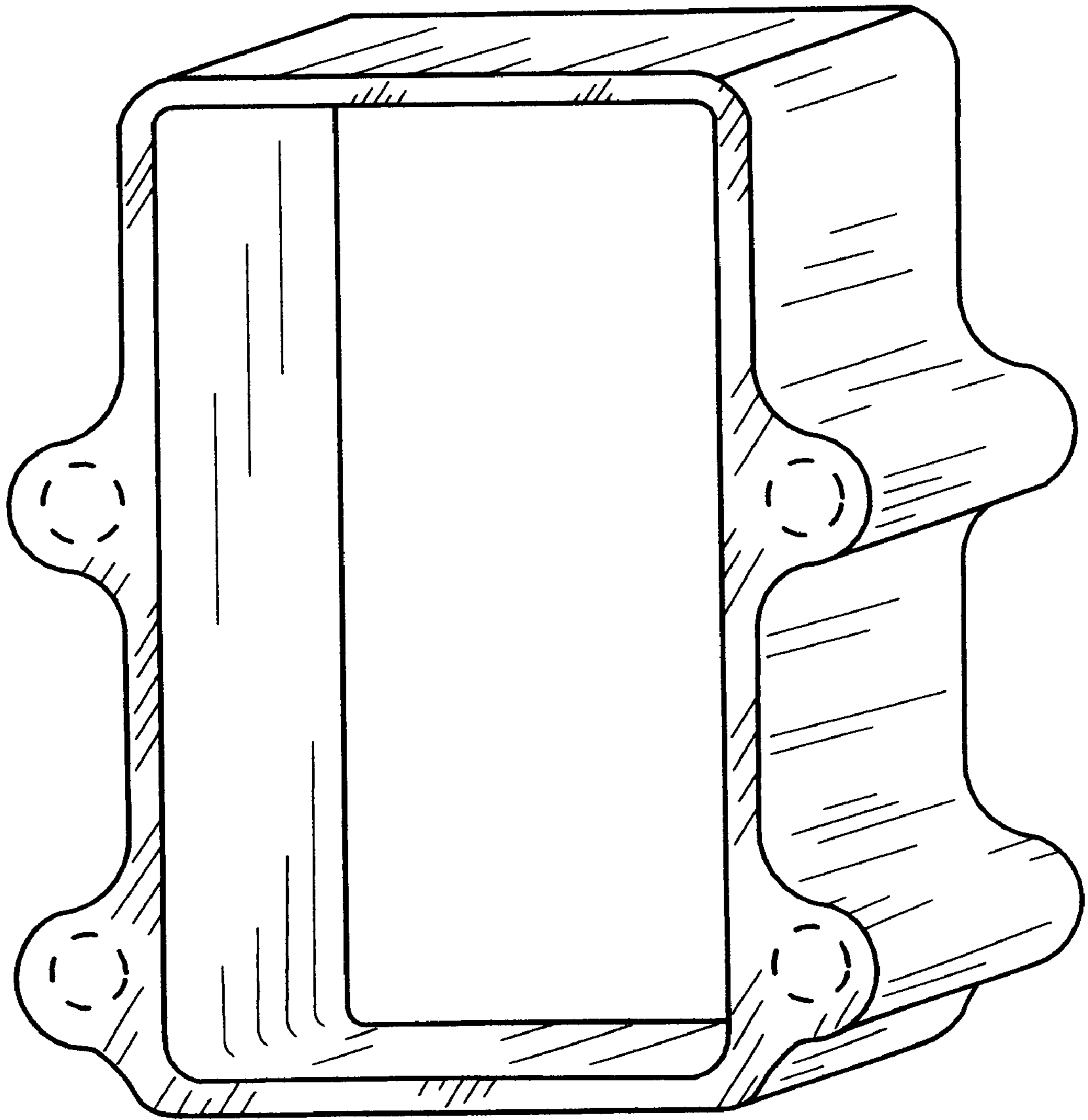

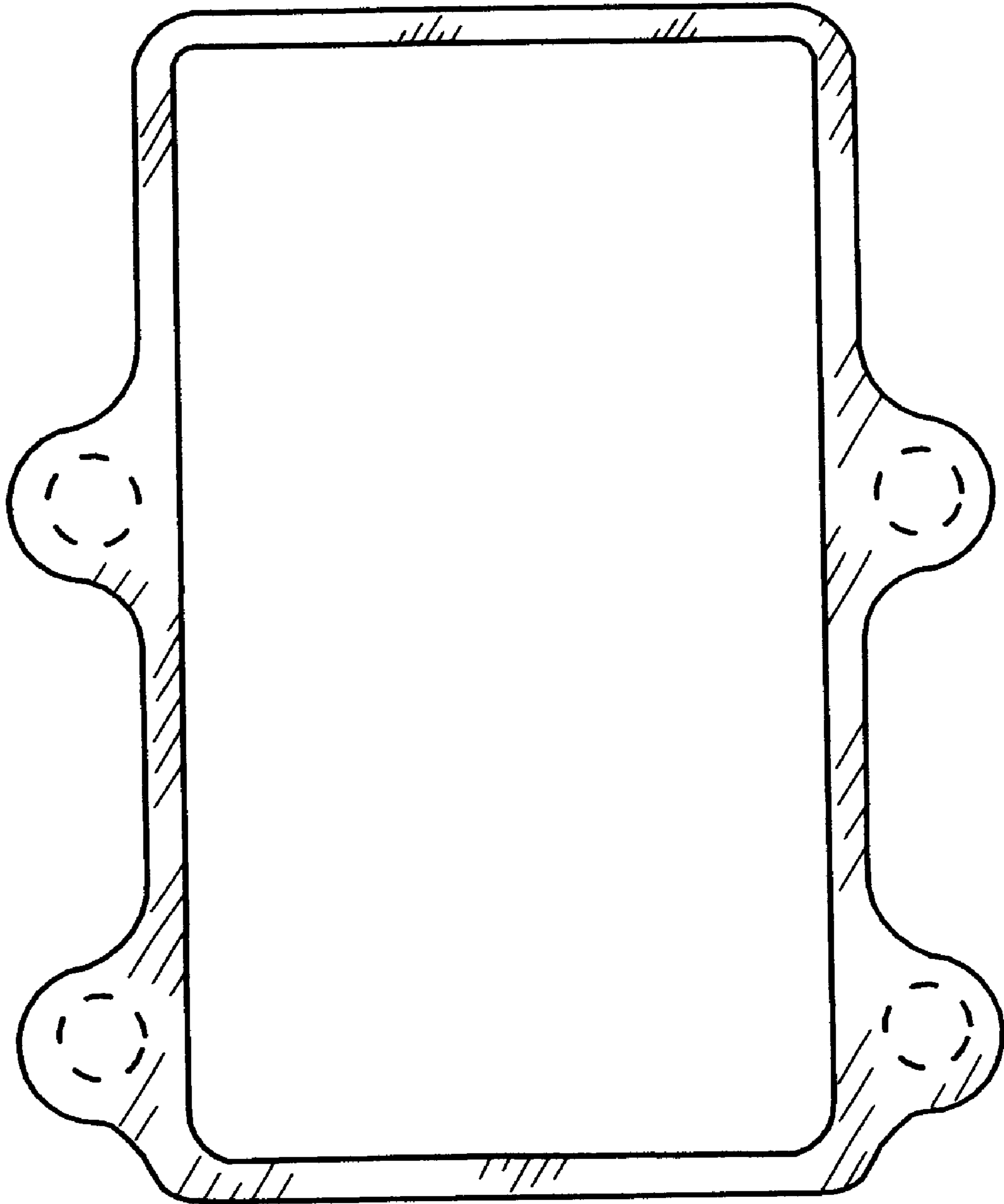

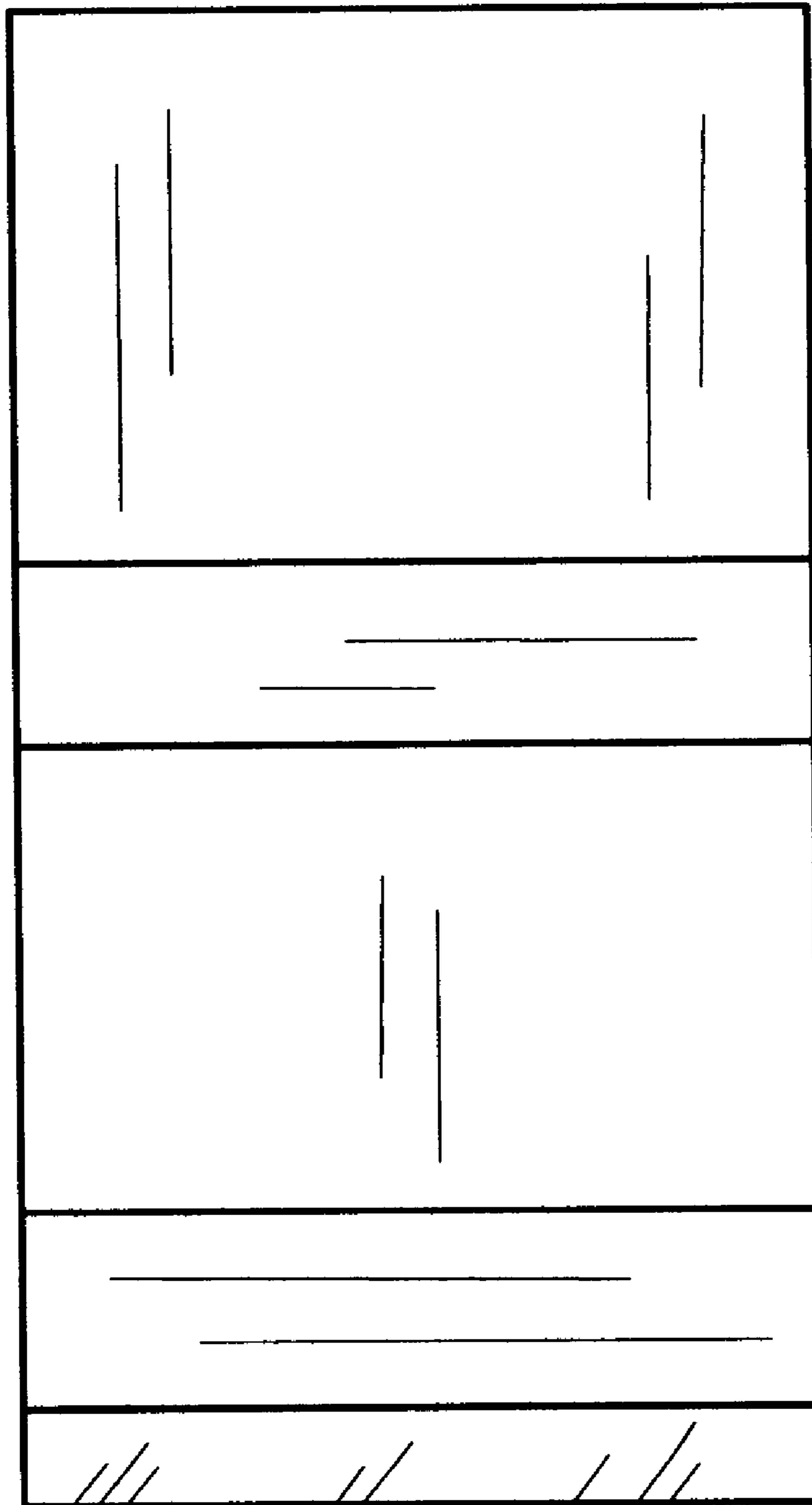

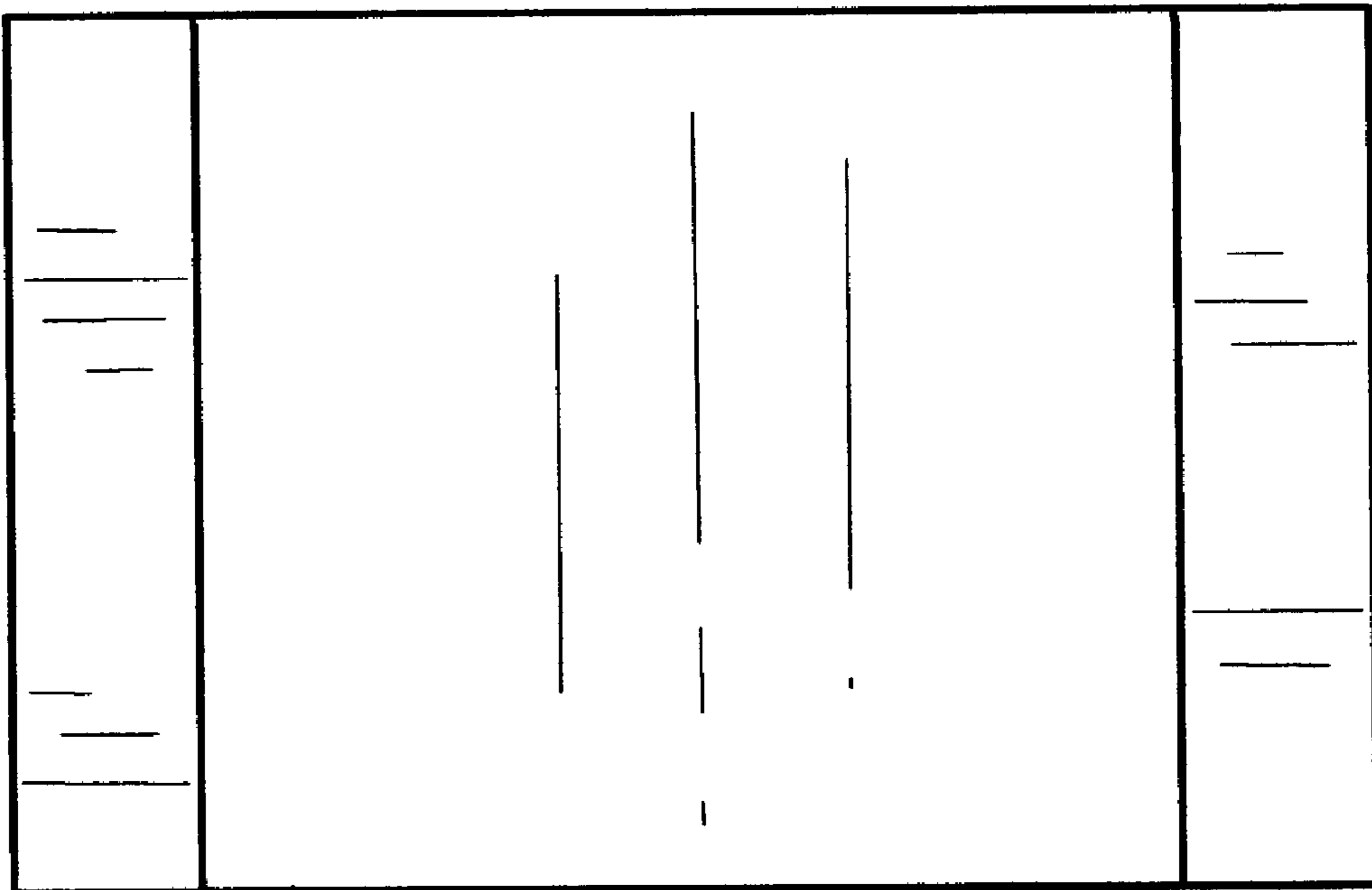
