FIG. 14 is a perspective view from below of alternative.

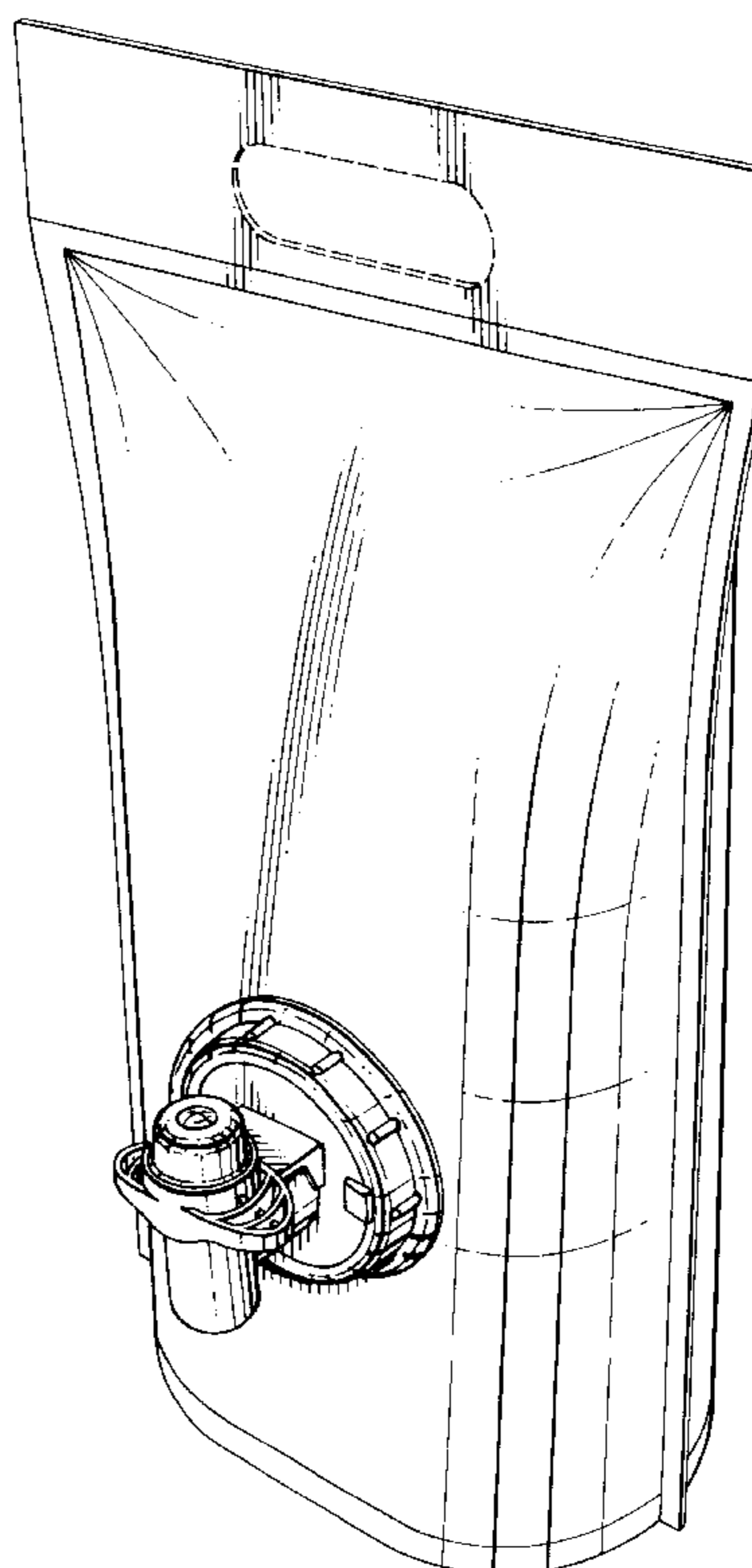
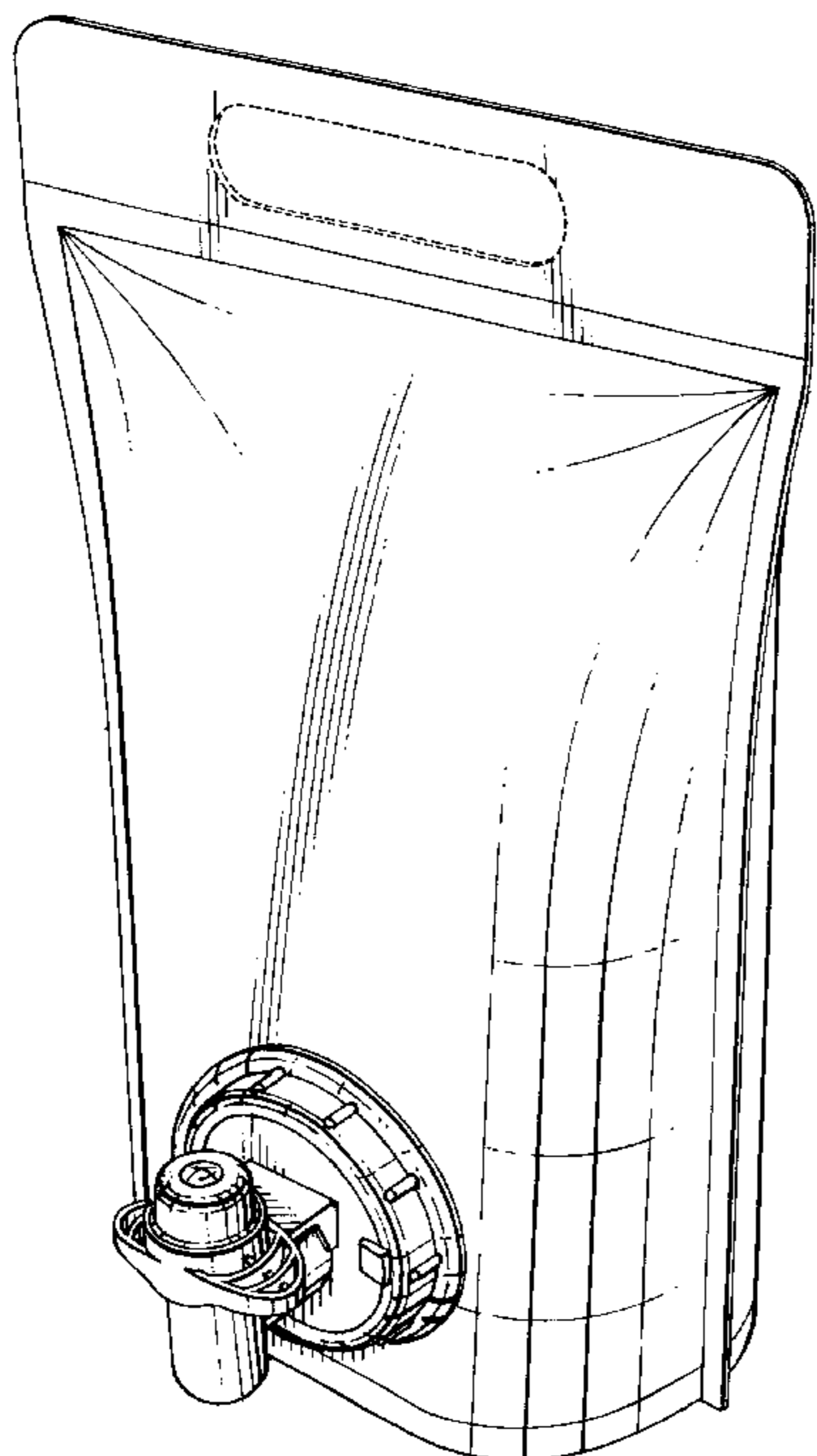

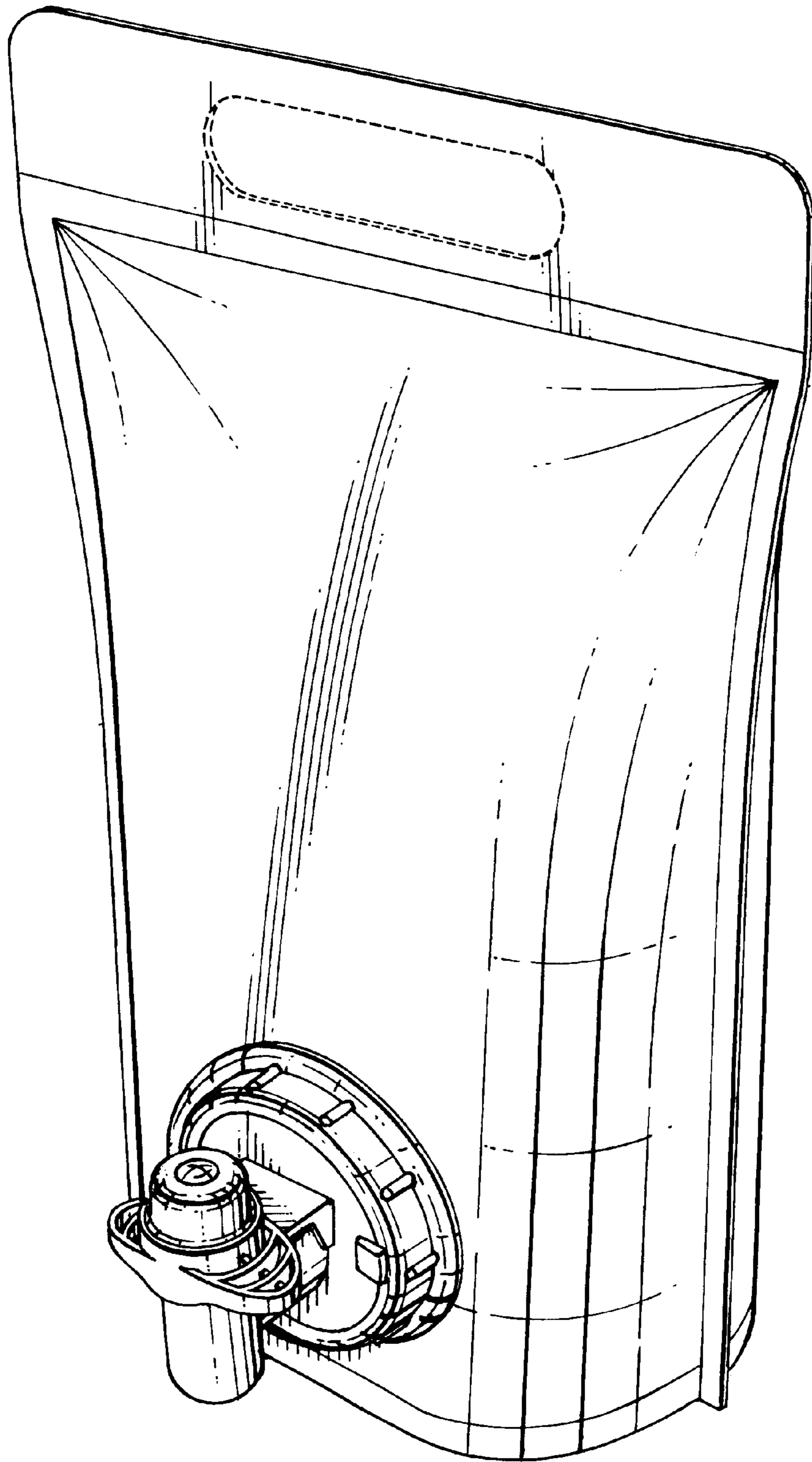

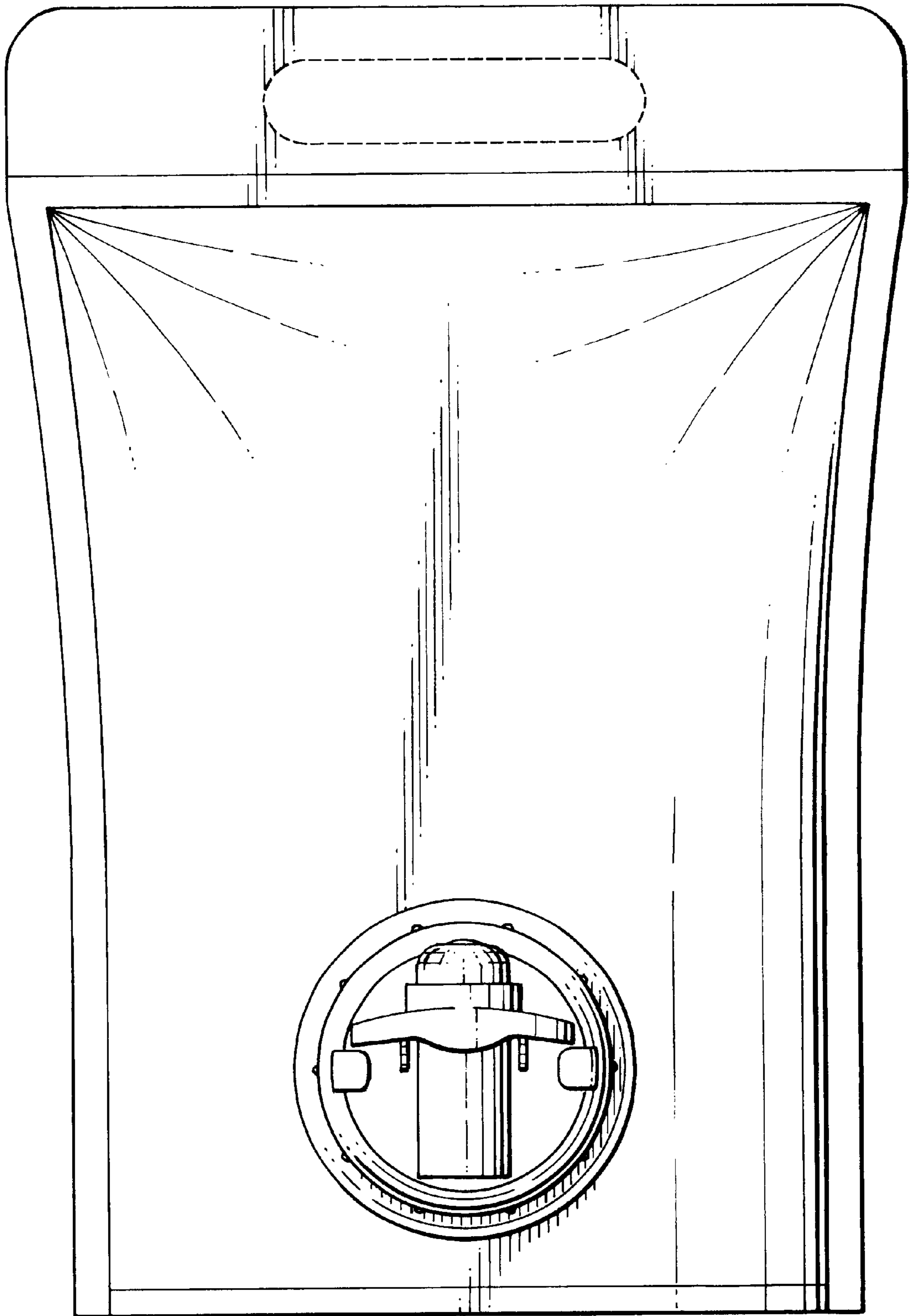

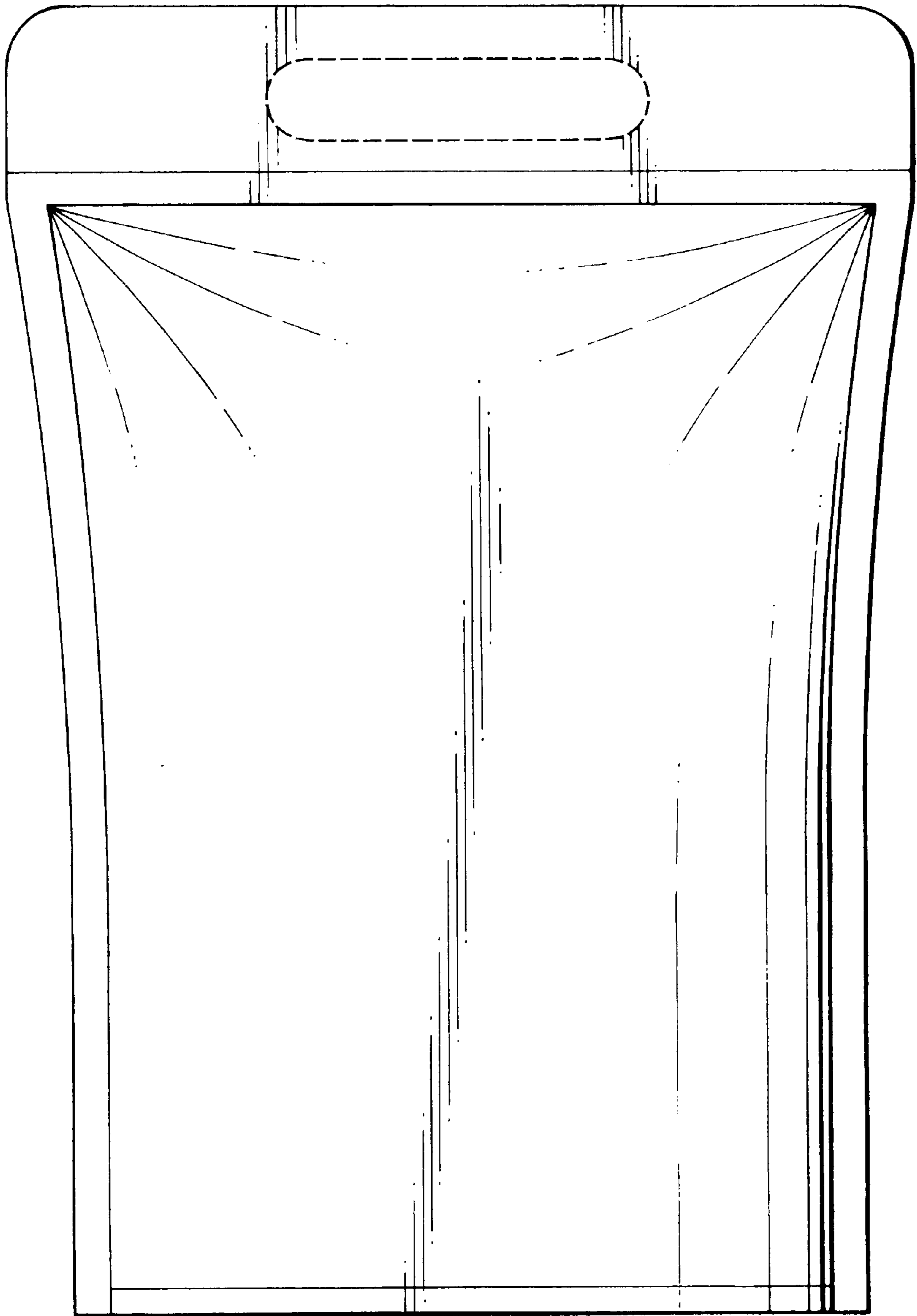

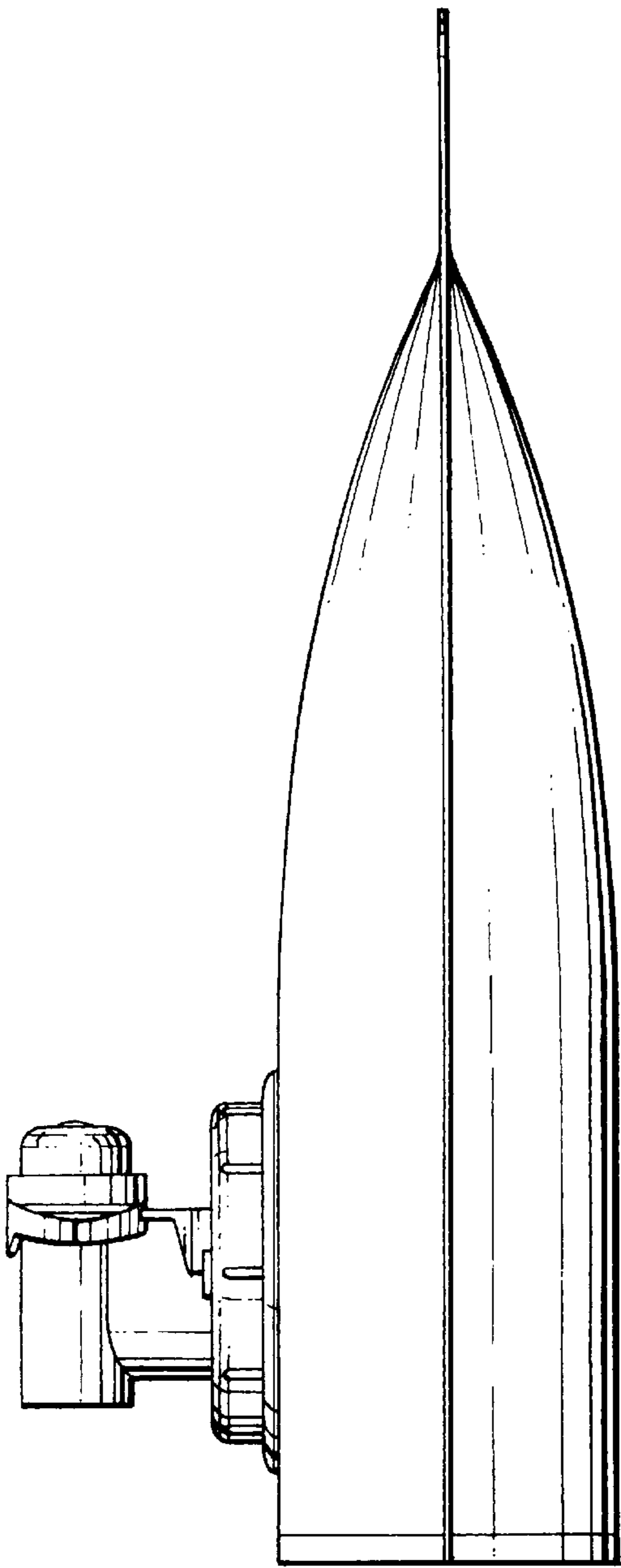

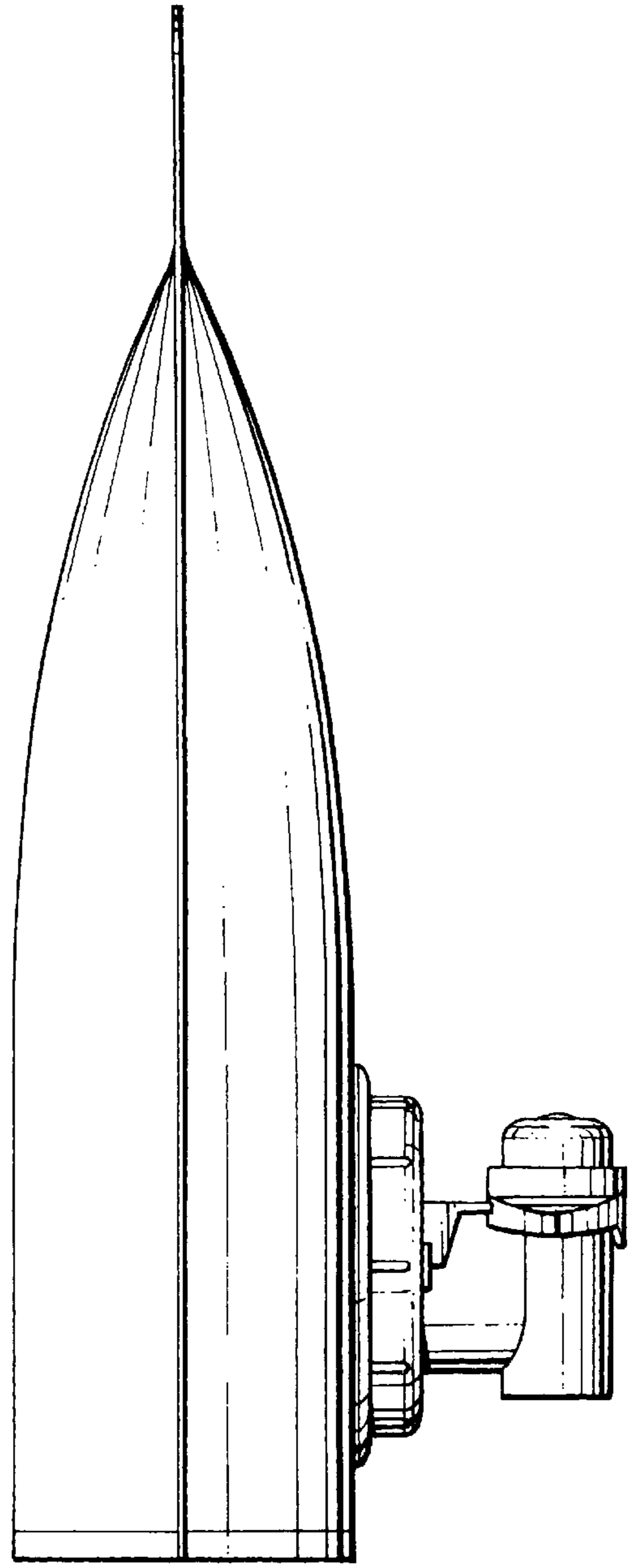

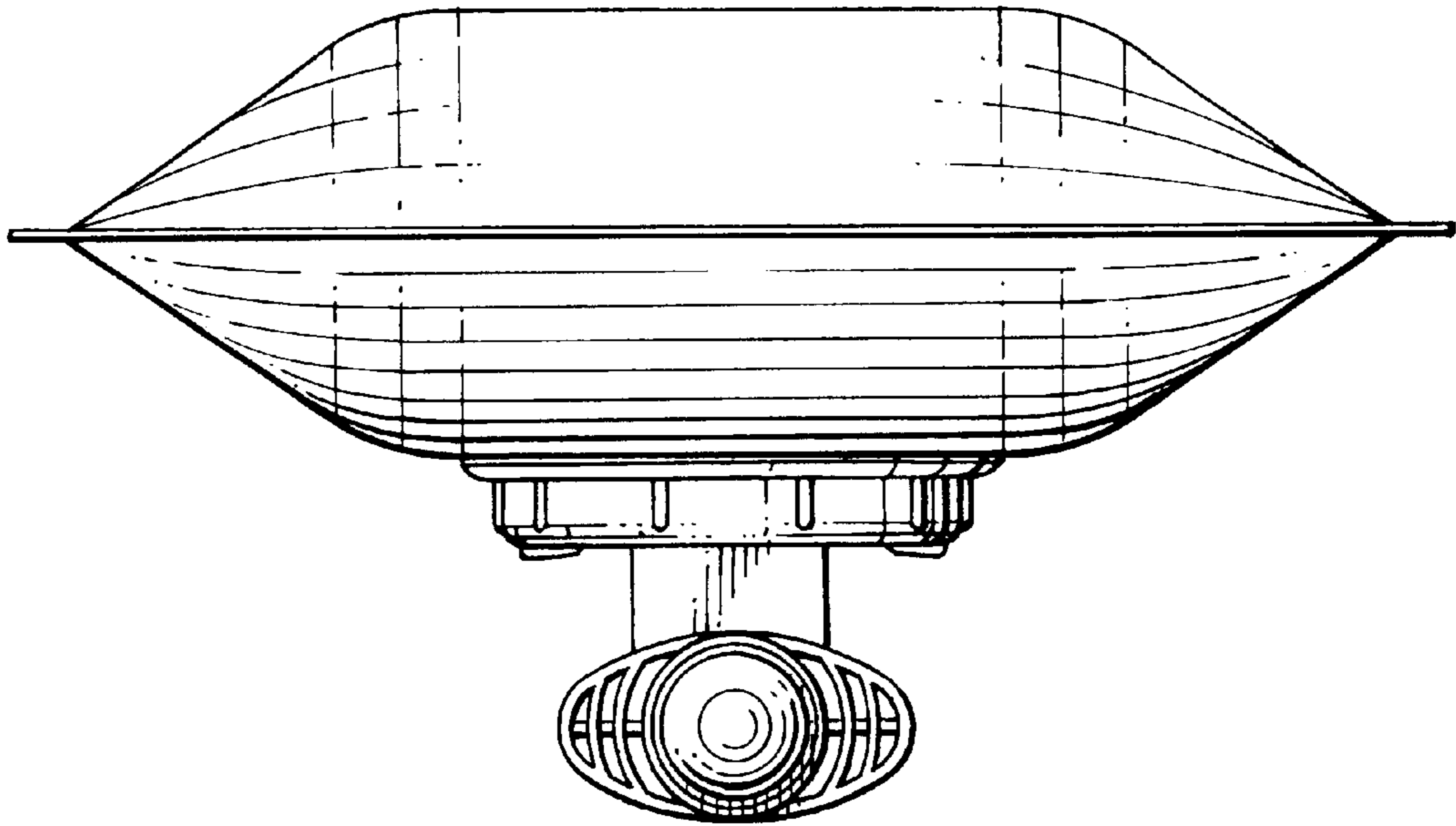

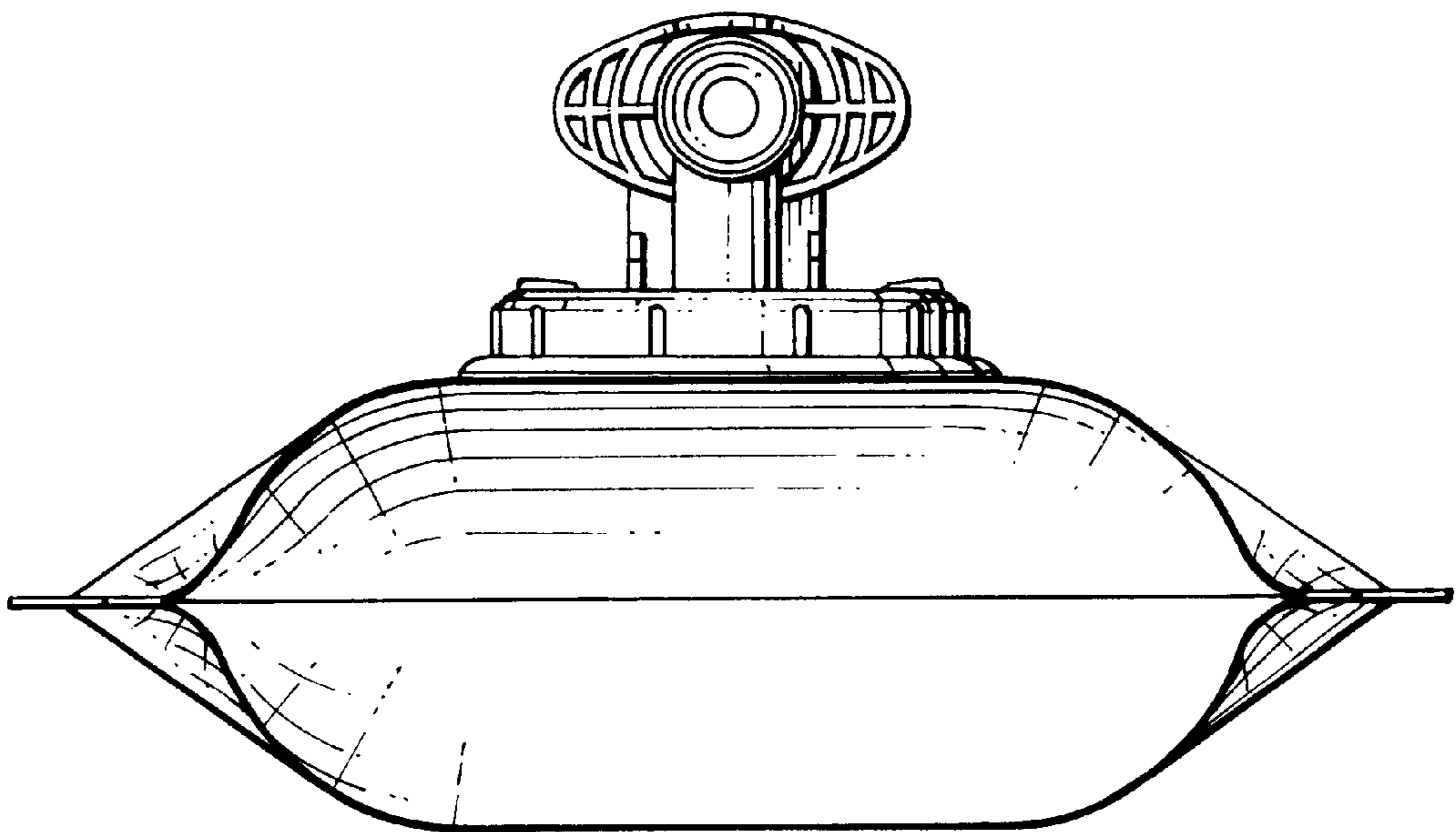

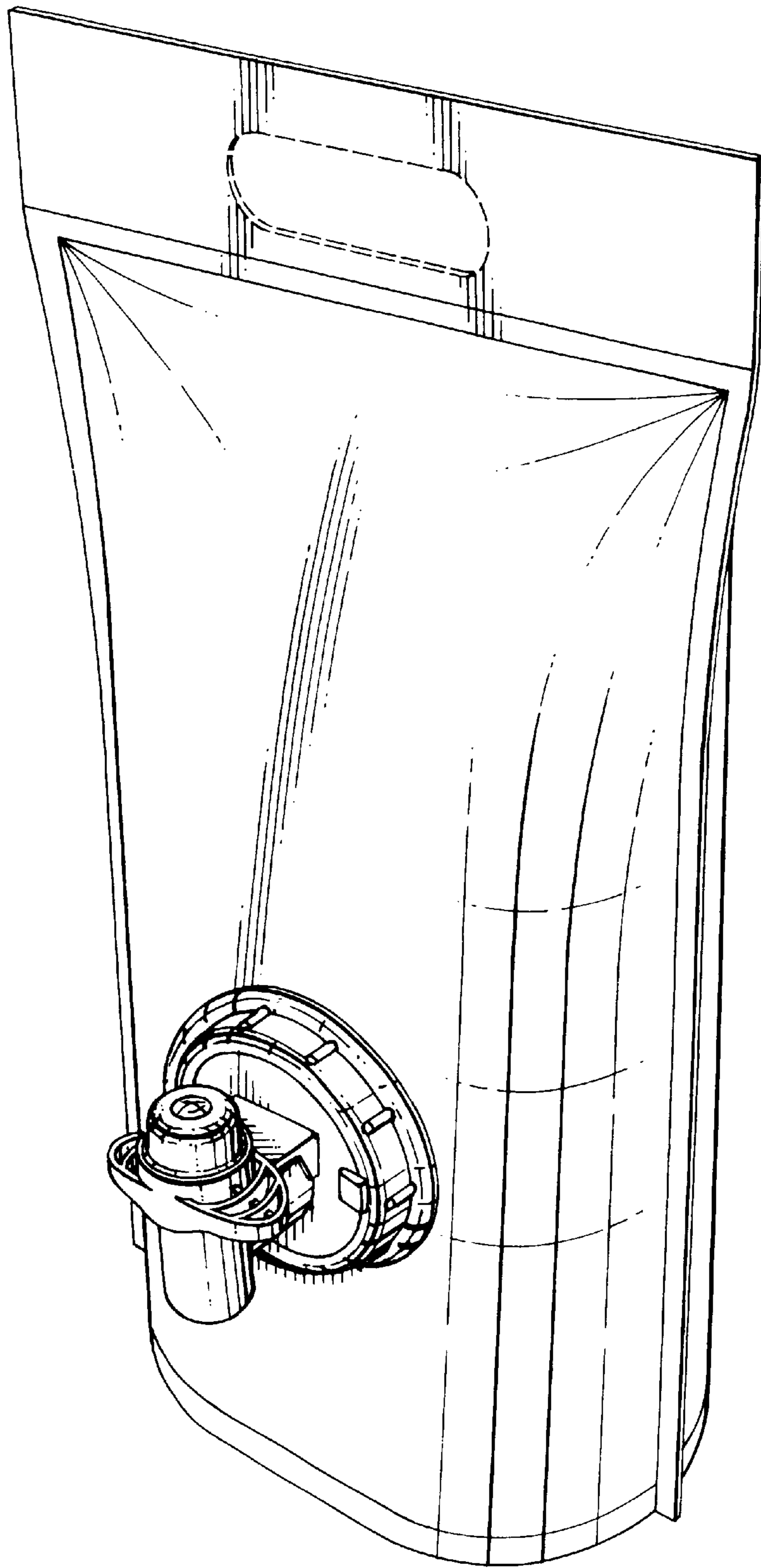

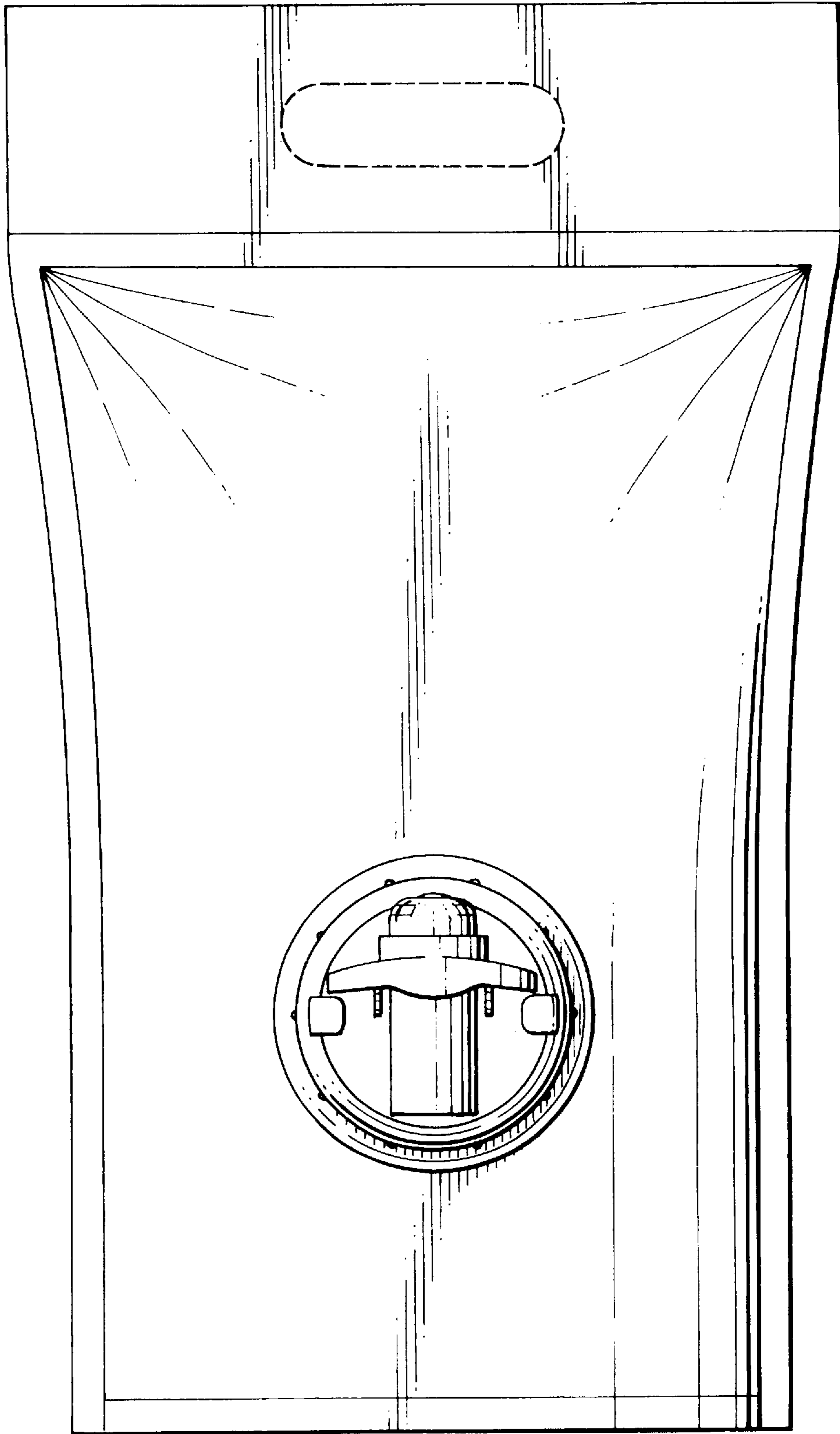

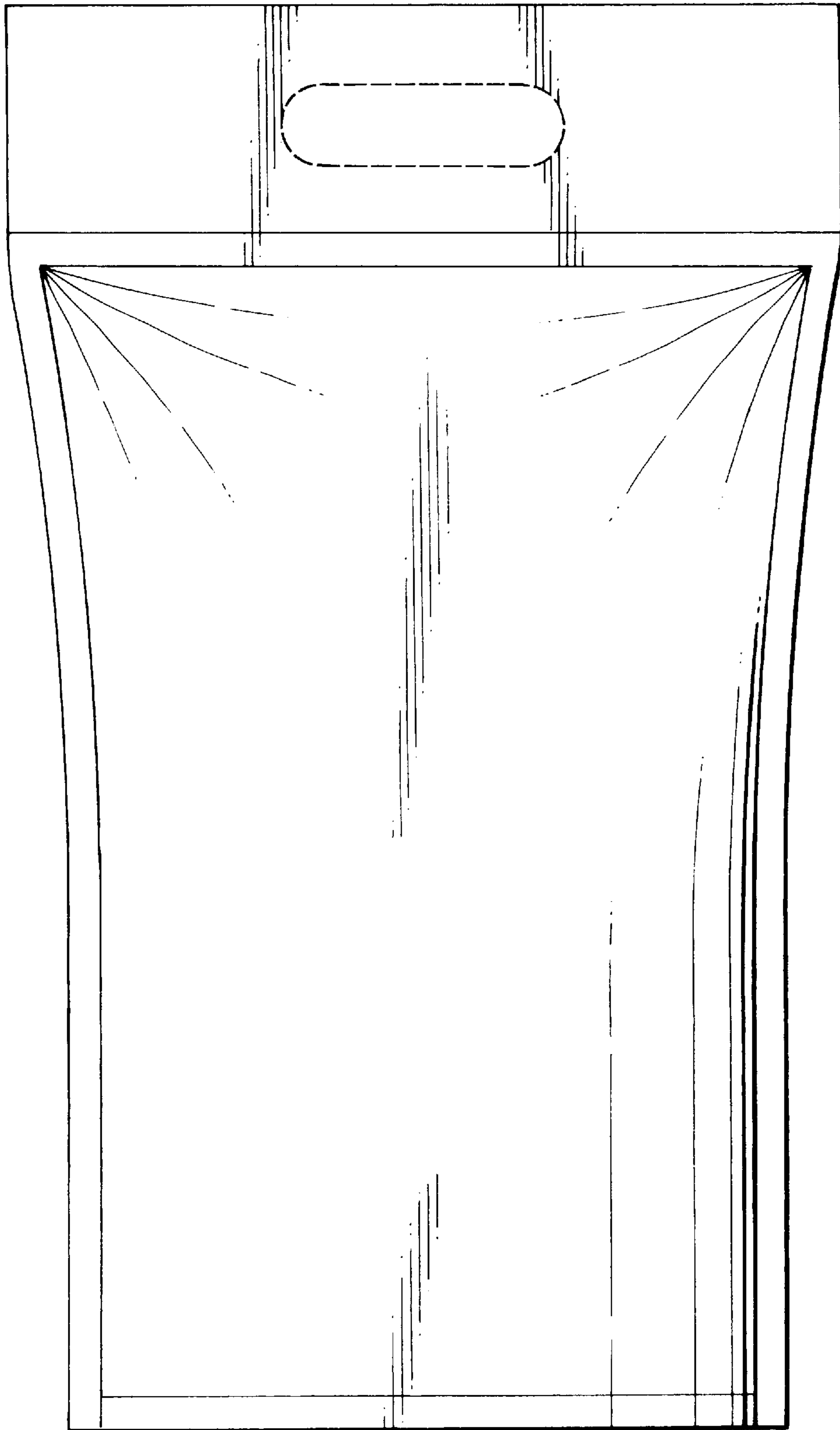

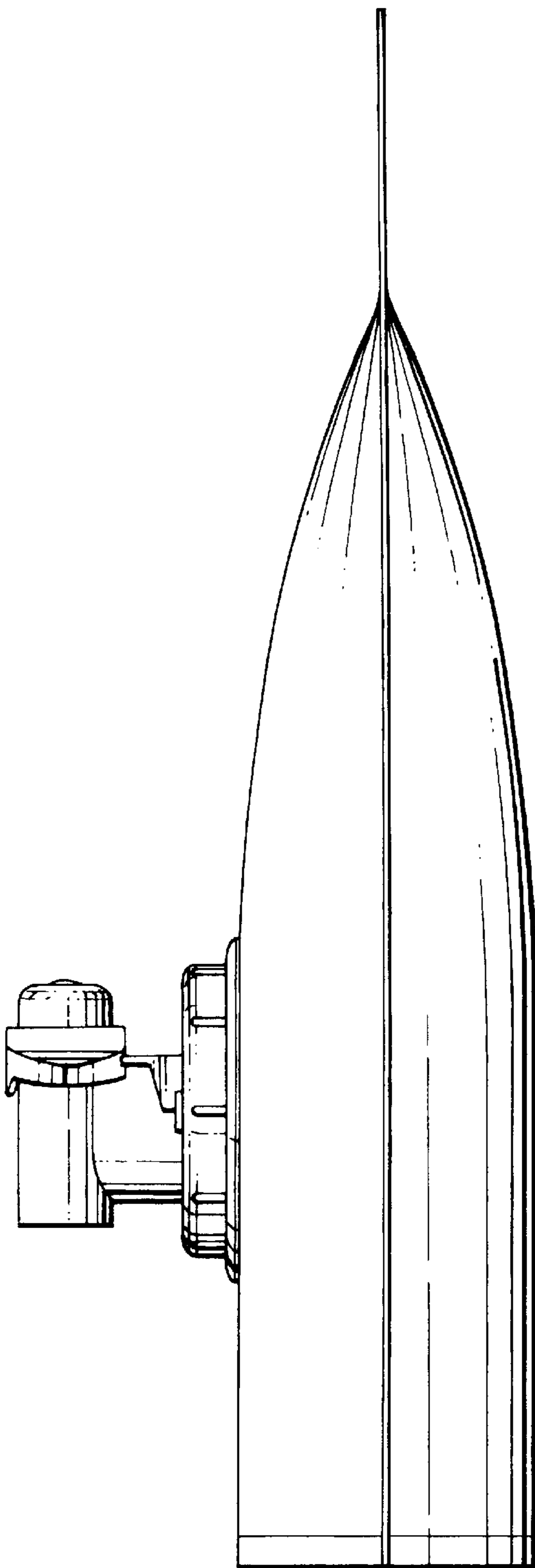

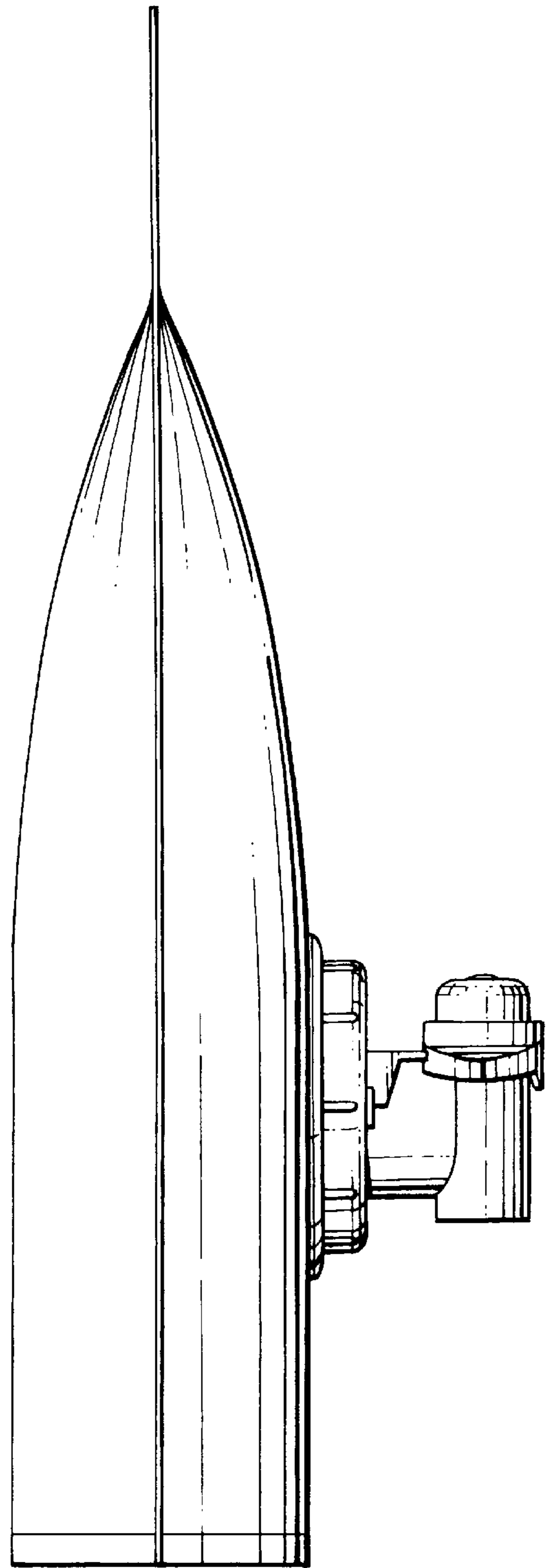

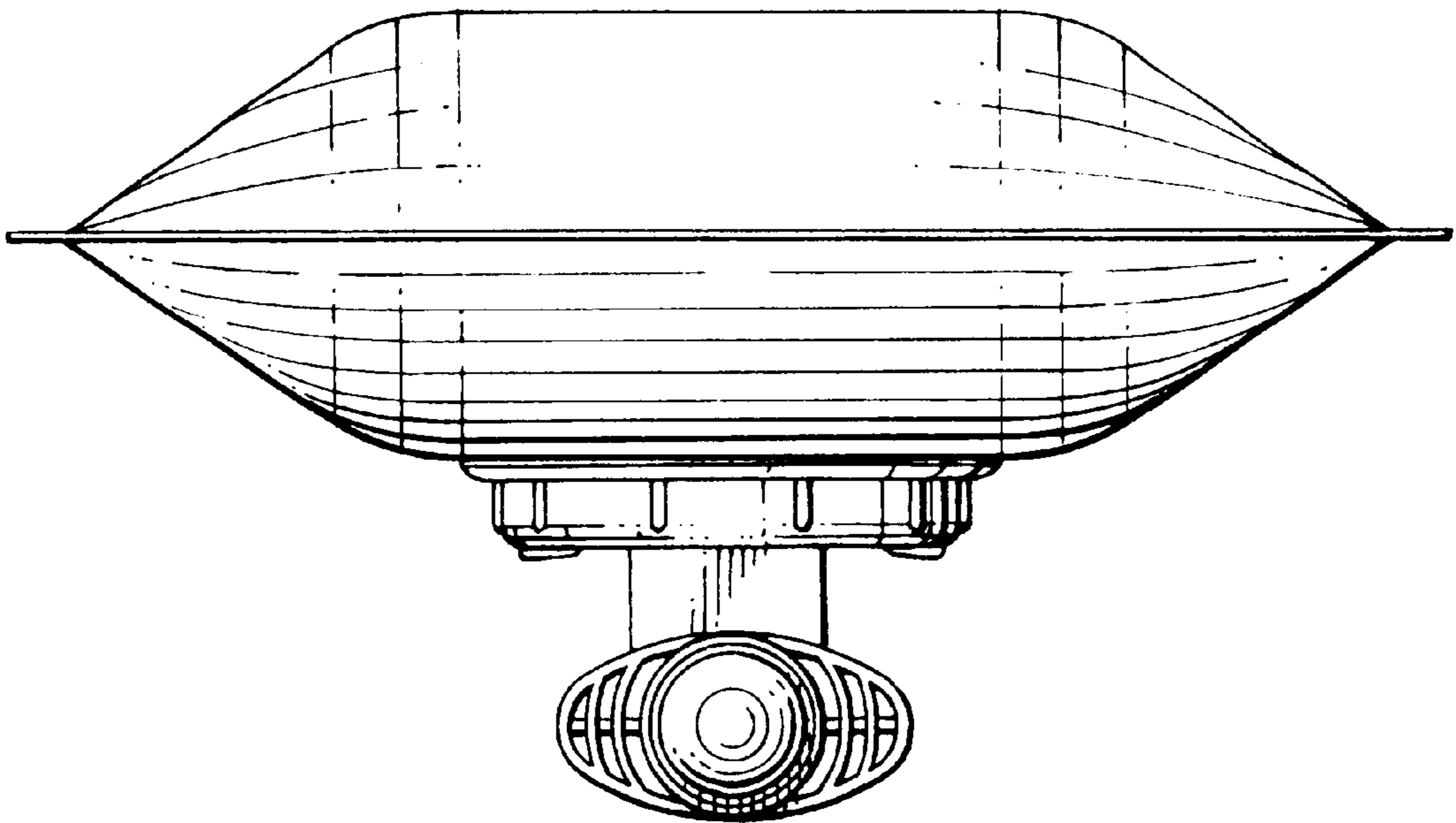

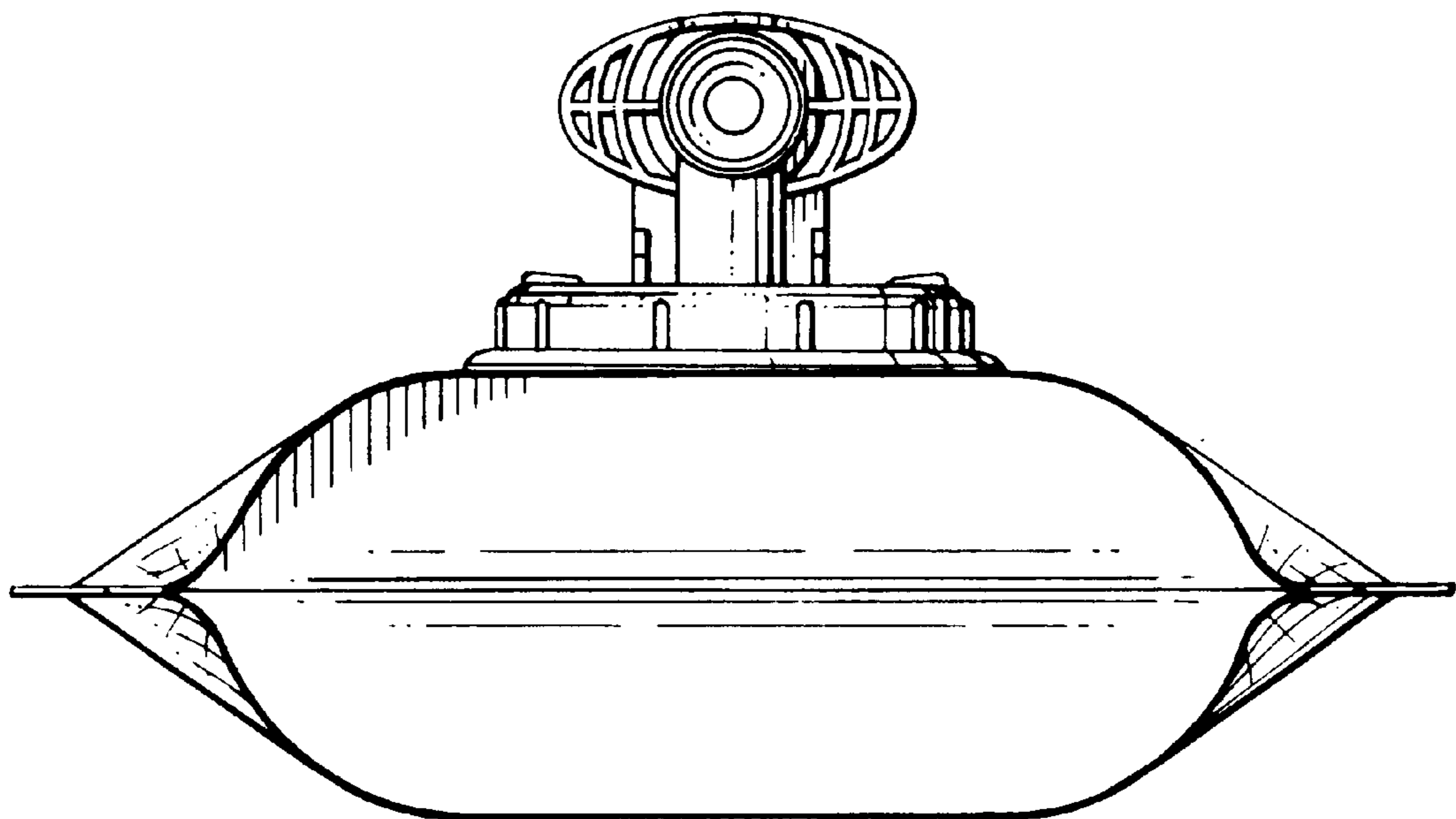
