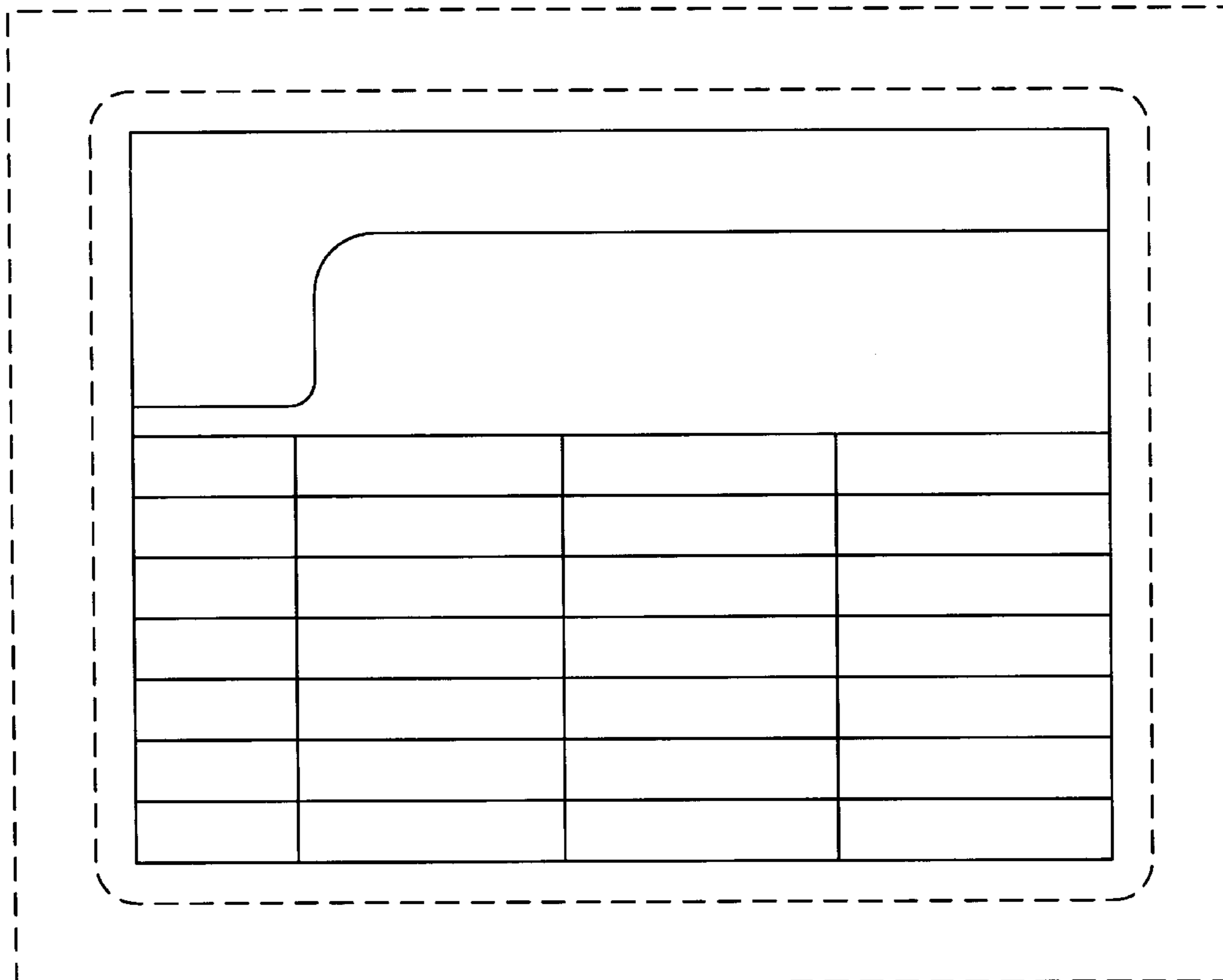
(57) **CLAIM**

The ornamental design for a user interface for a television display screen, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a user interface on a television display screen showing our new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; FIG. 4 is a front view of a fourth embodiment thereof; and, FIG. 5 is a front view of a fifth embodiment thereof. The broken line drawing of a television display screen in all views is for illustrative purposes only and forms no part of the claimed design.

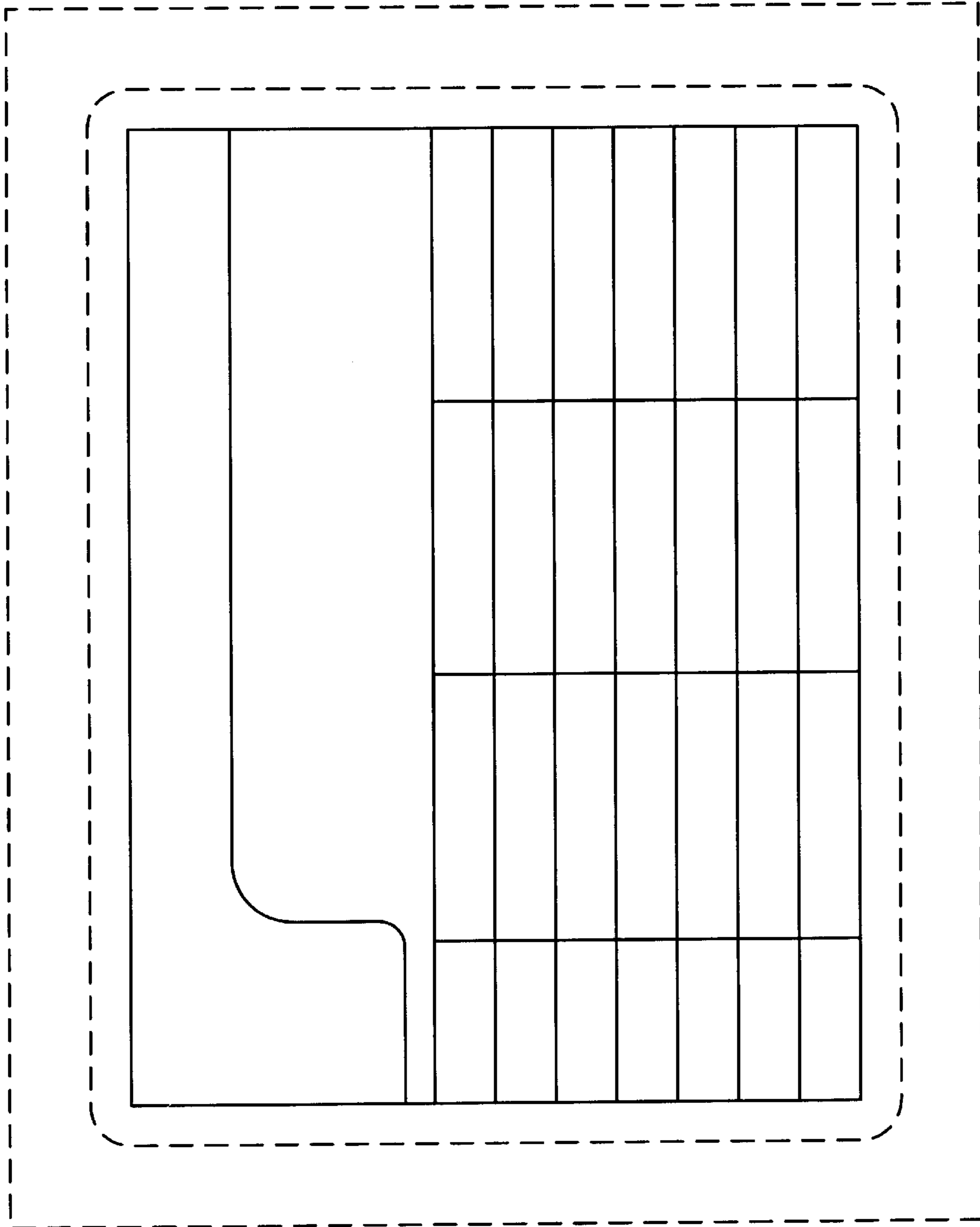

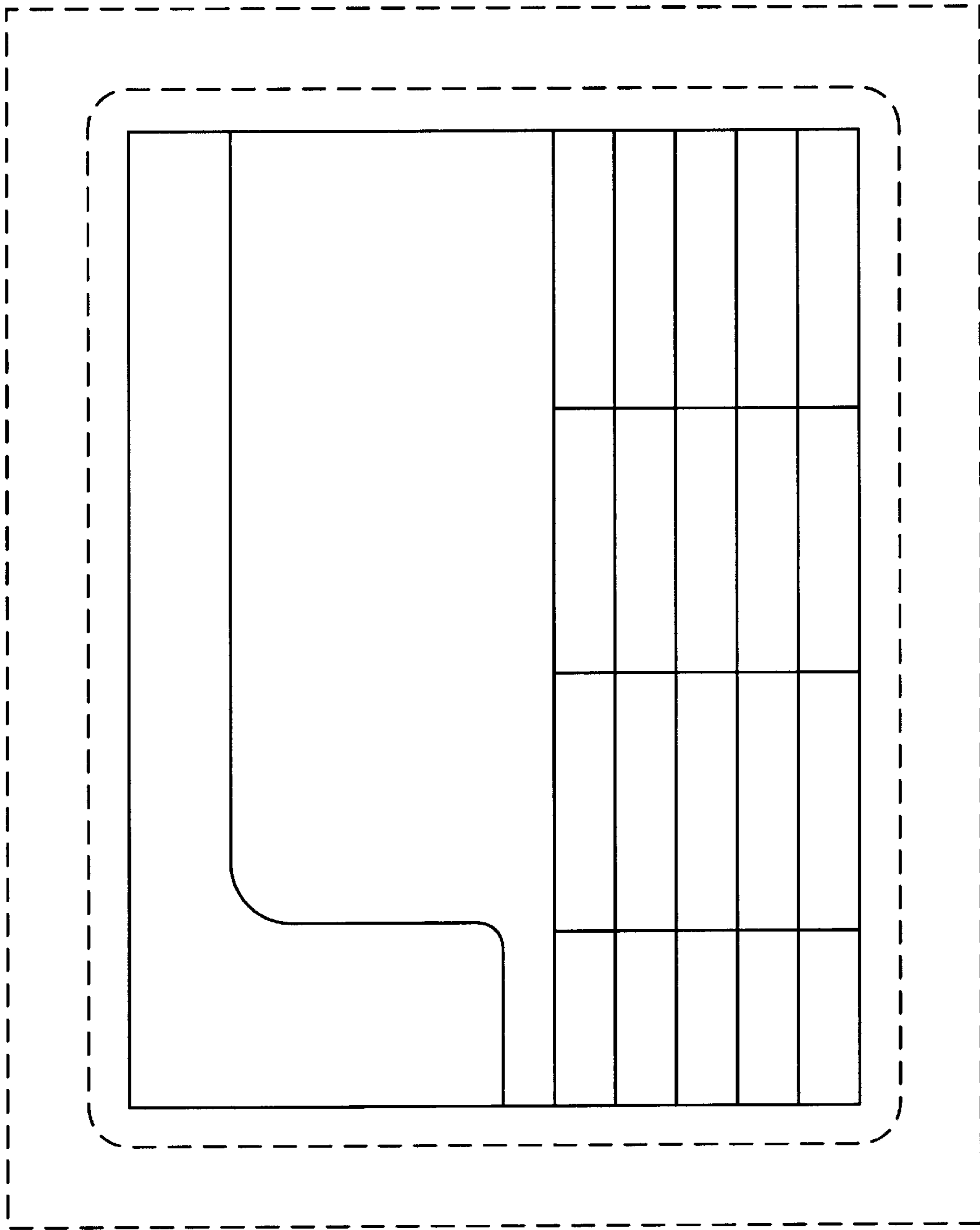

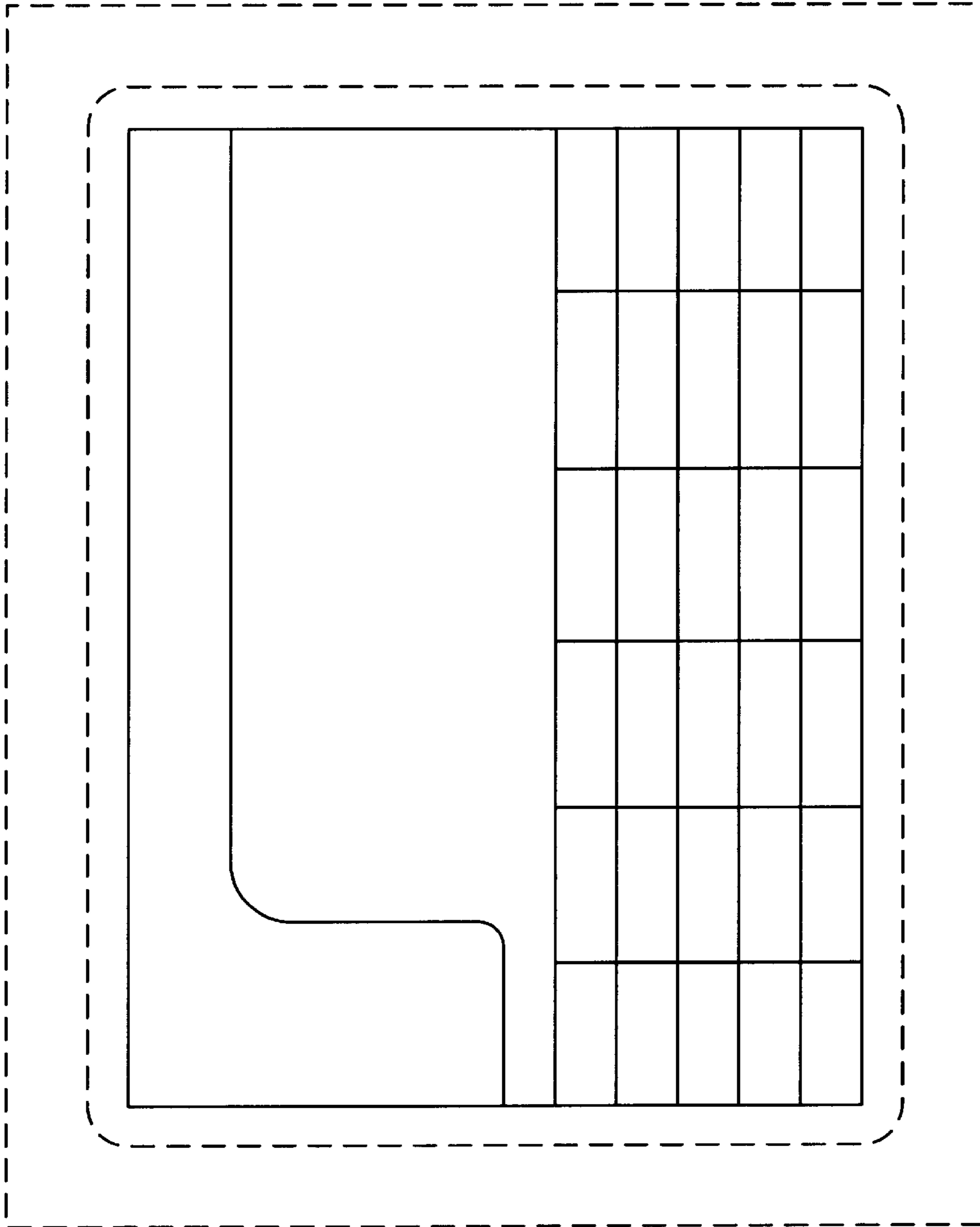

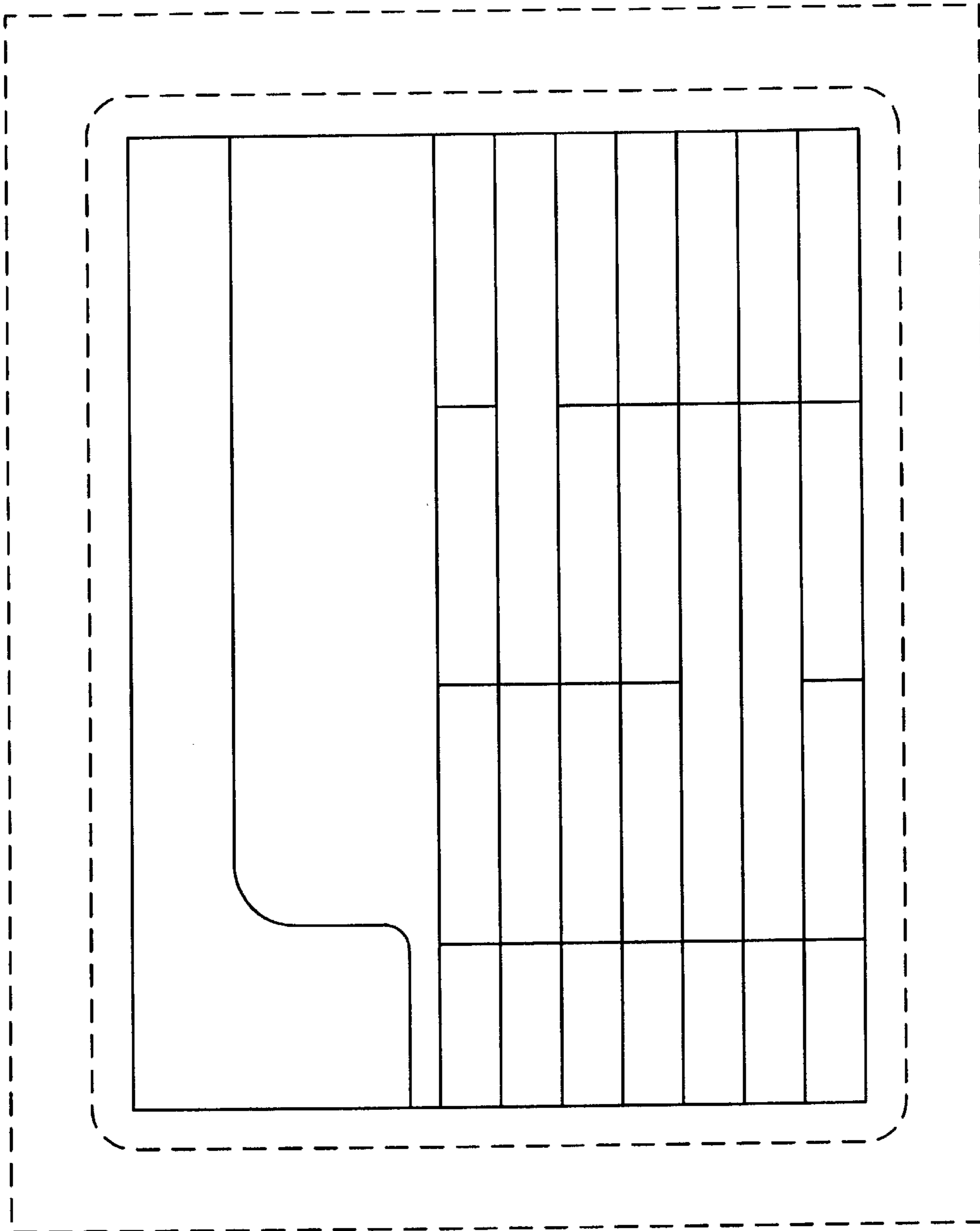

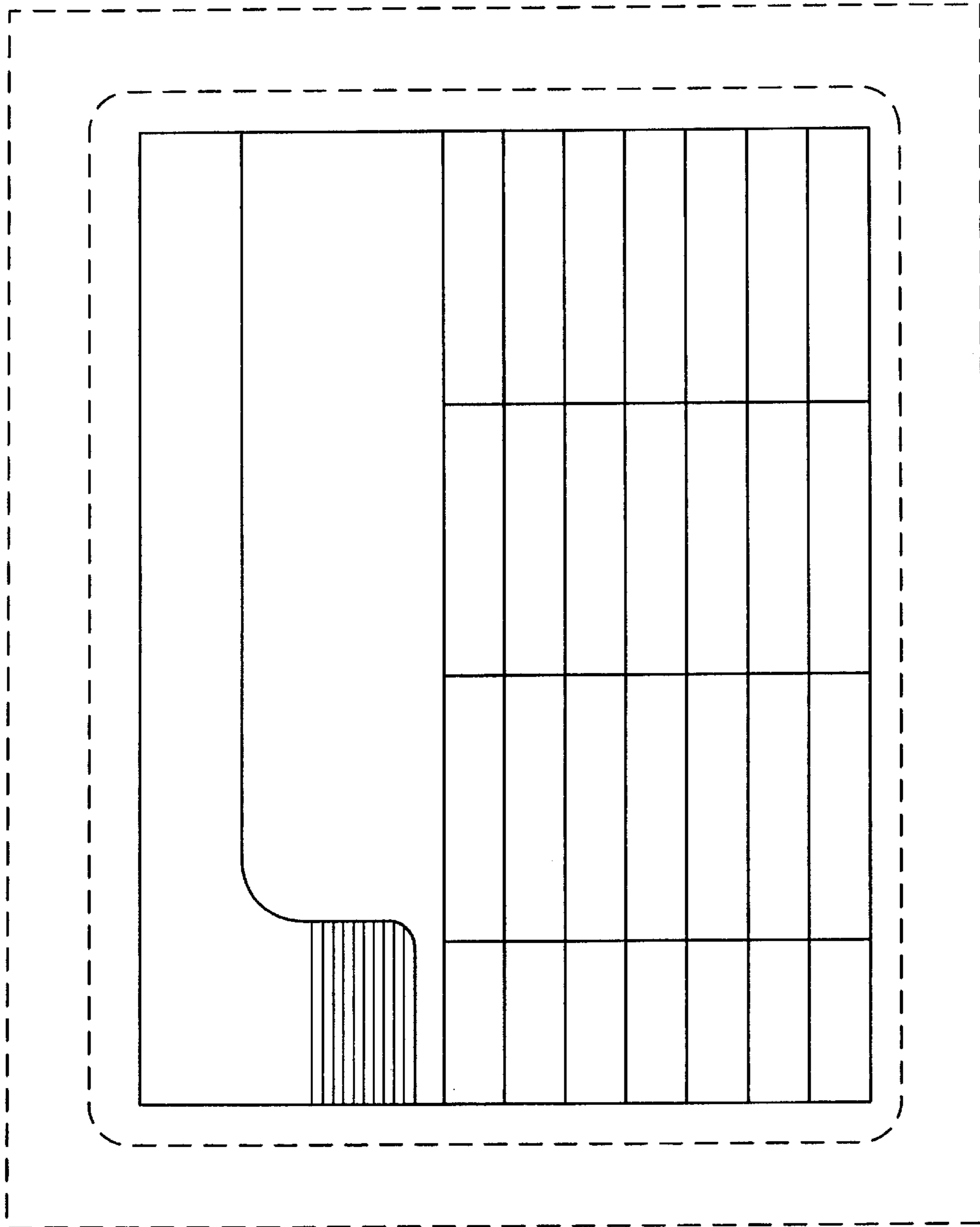
