(57) **CLAIM**

The ornamental design for a propeller for electric powered outboard motor, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, front perspective view of a propeller for an electric powered outboard motor, shown with a hub in broken lines to secure the propeller onto a shaft (not shown). FIG. 2 is a top, left, front perspective view of a propeller for electric powered outboard motor;

FIG. 3 is a top plan view of a propeller for electric powered outboard motor, shown with structural members in broken lines to secure the propeller onto a shaft (not shown);

FIG. 4 is a bottom plan view of a propeller for electric powered outboard motor, shown with structural members in broken lines to secure the propeller onto a shaft (not shown);

FIG. 5 is a front elevational view of a propeller for electric powered outboard motor;

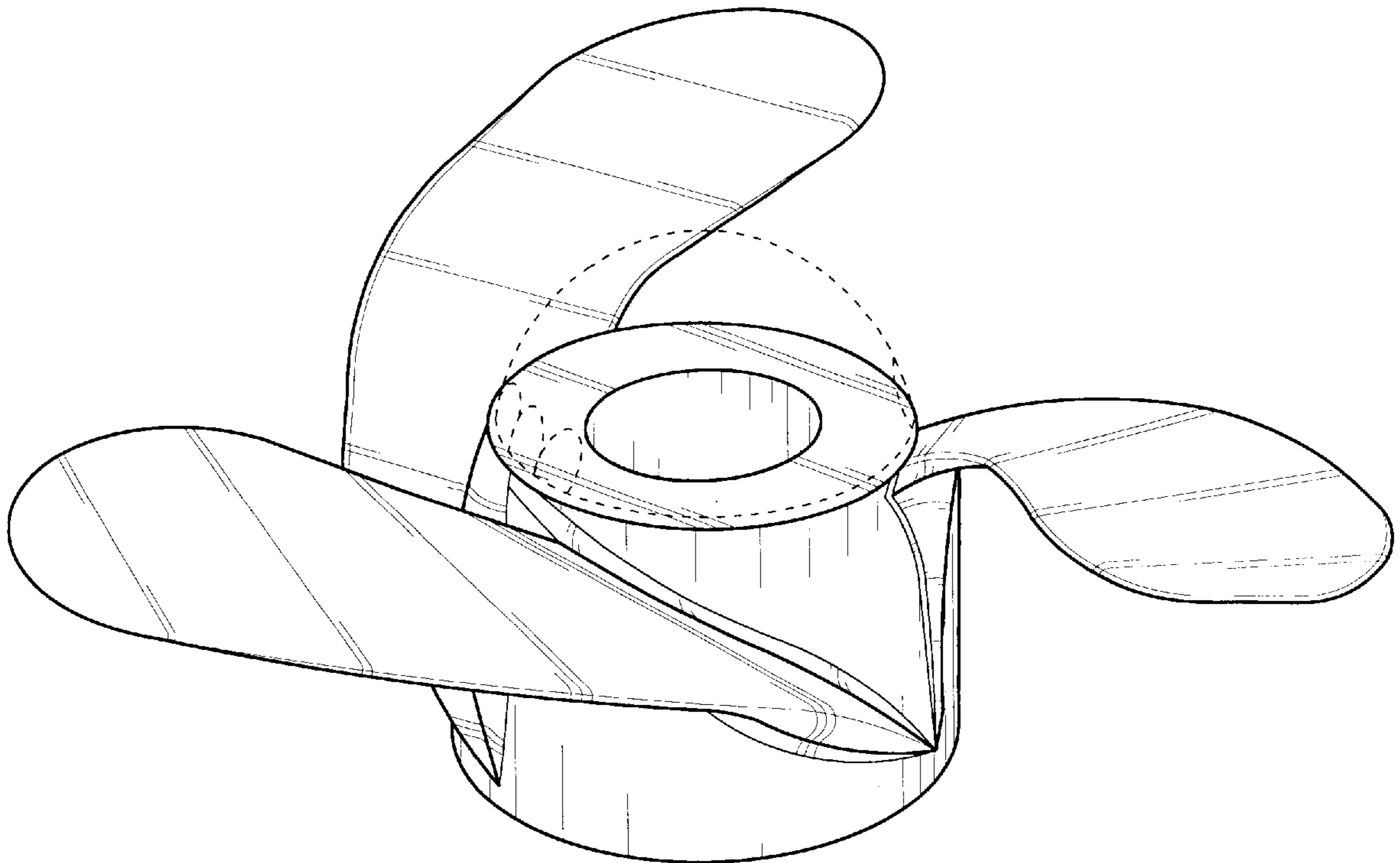
FIG. 6 is a left side elevational view of a propeller for electric powered outboard motor;

FIG. 7 is a right side elevational view of a propeller for electric powered outboard motor; and,

FIG. 8 is a rear elevational view of a propeller for electric powered outboard motor.

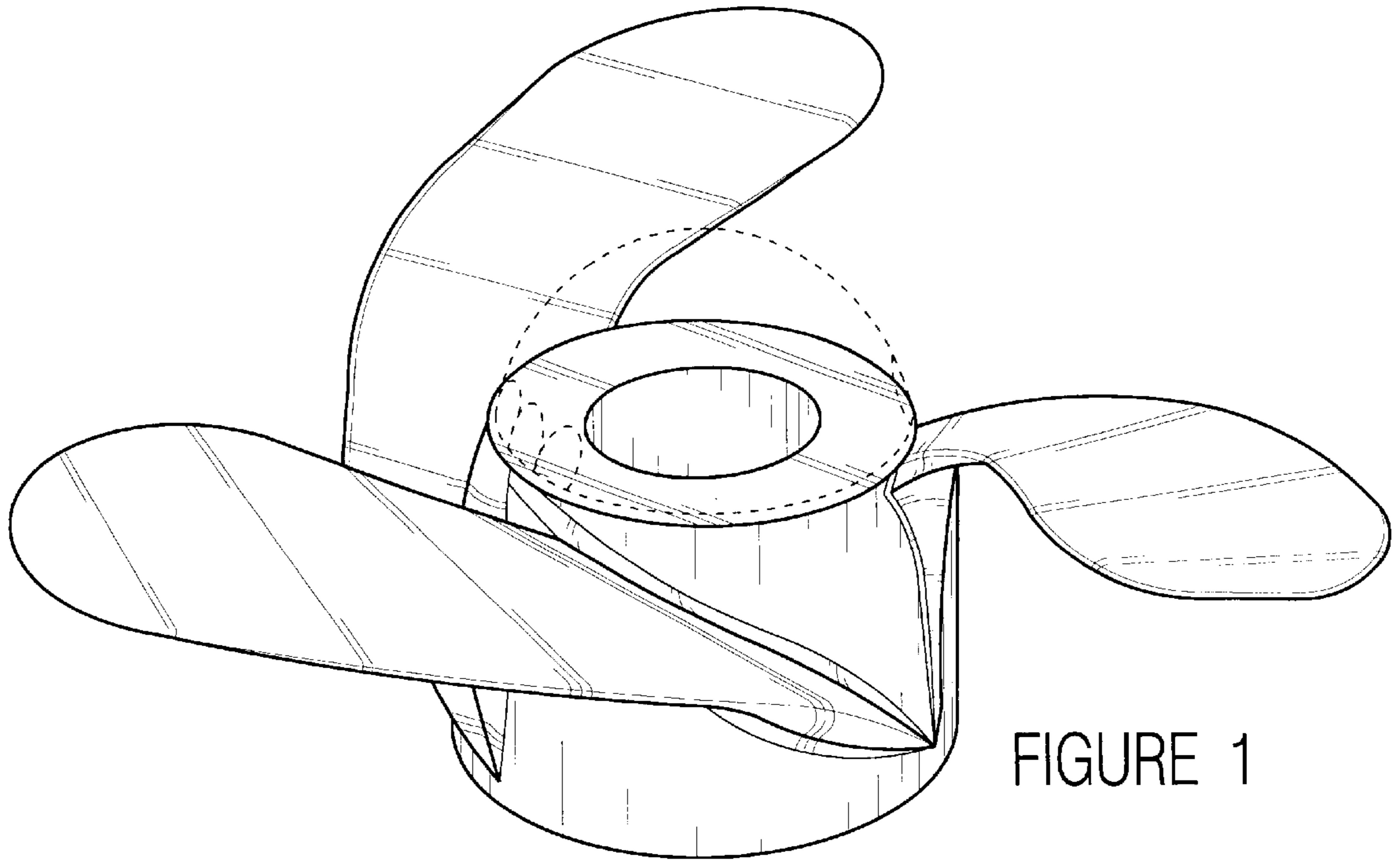

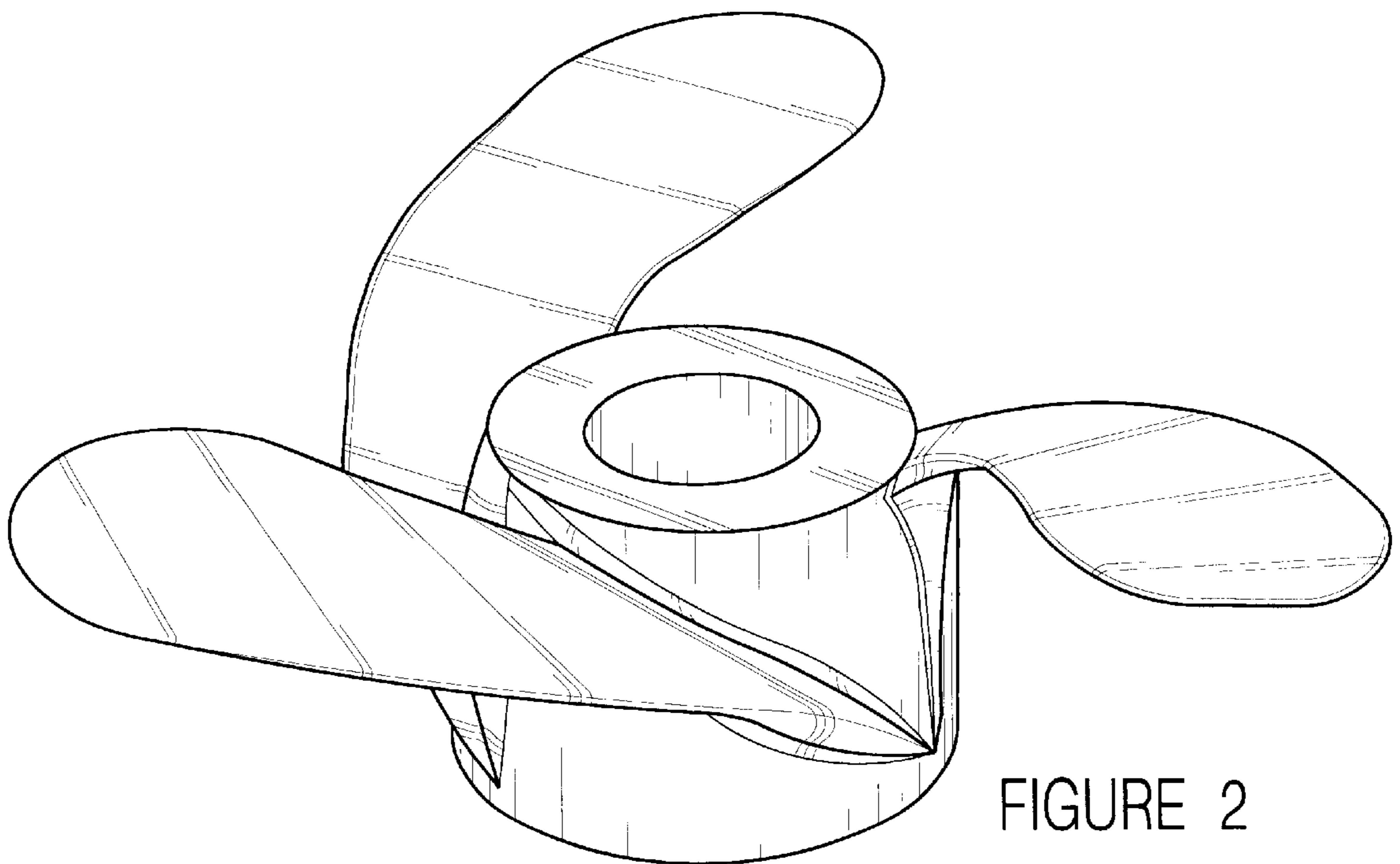

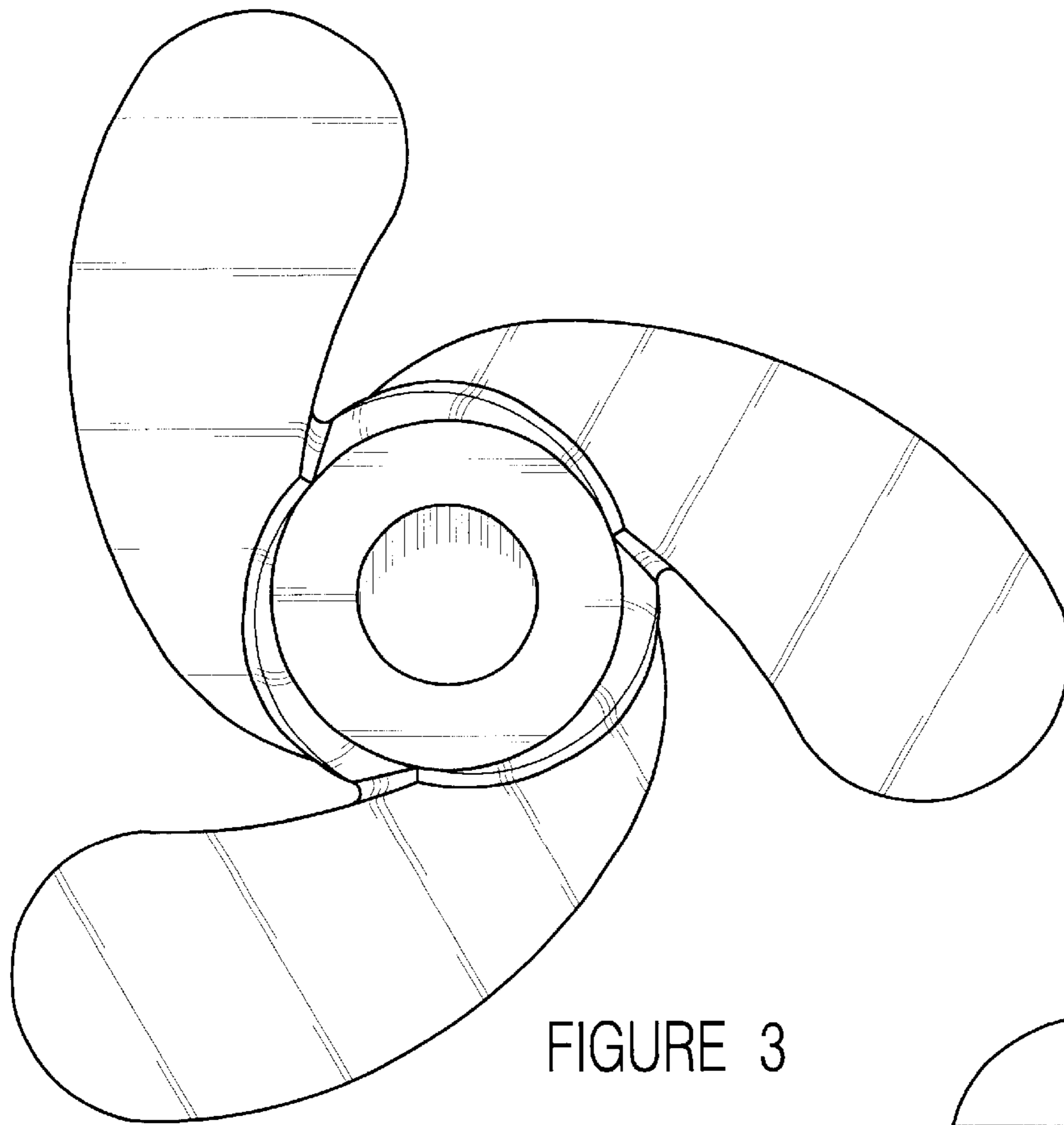

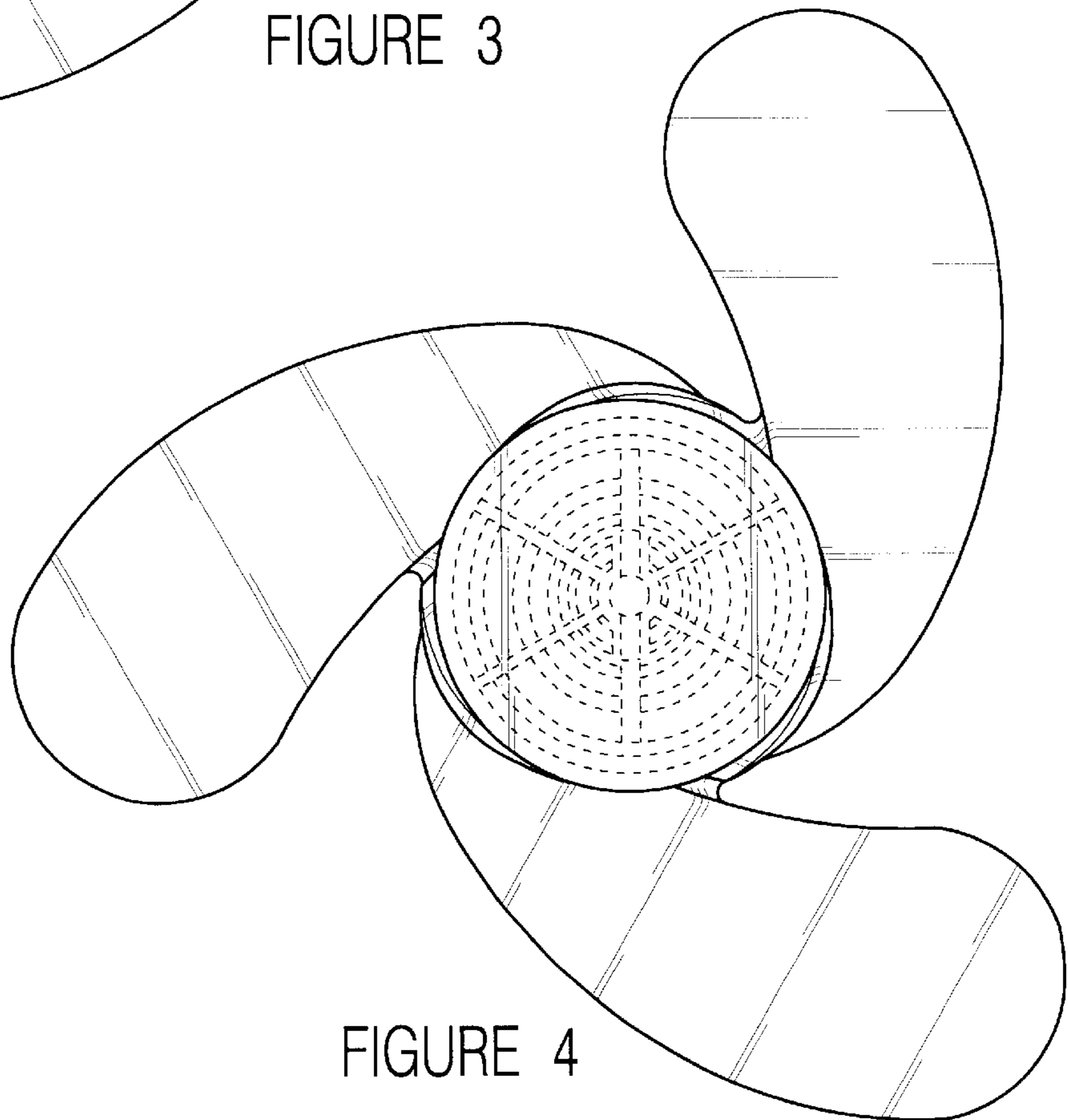

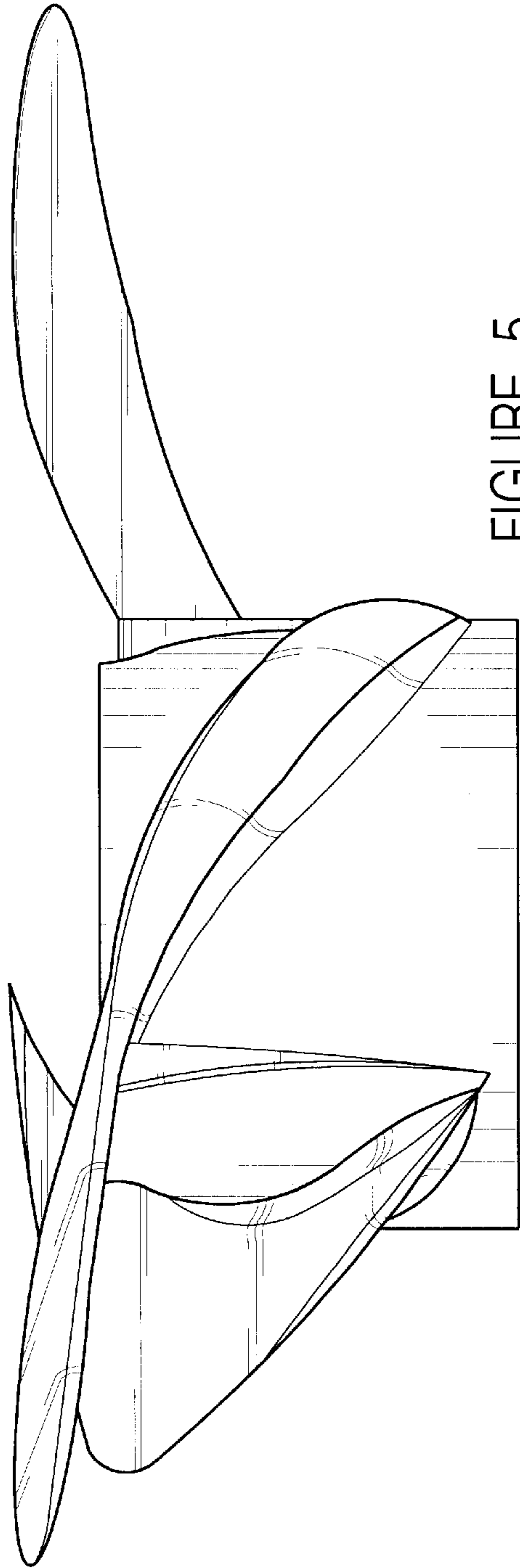

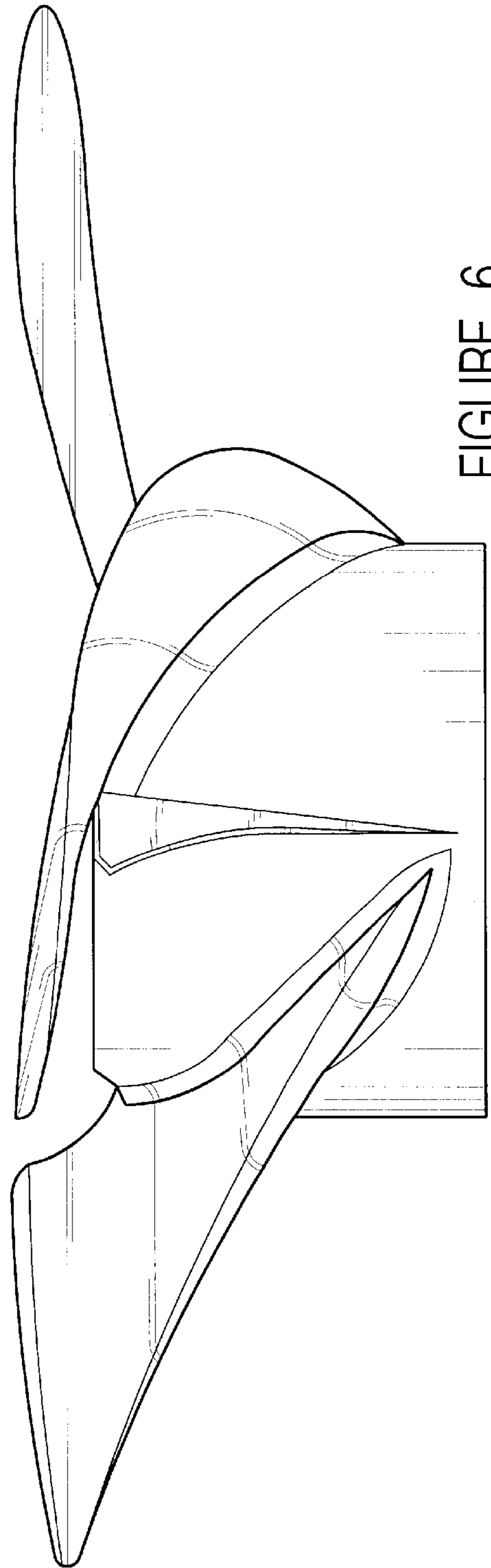

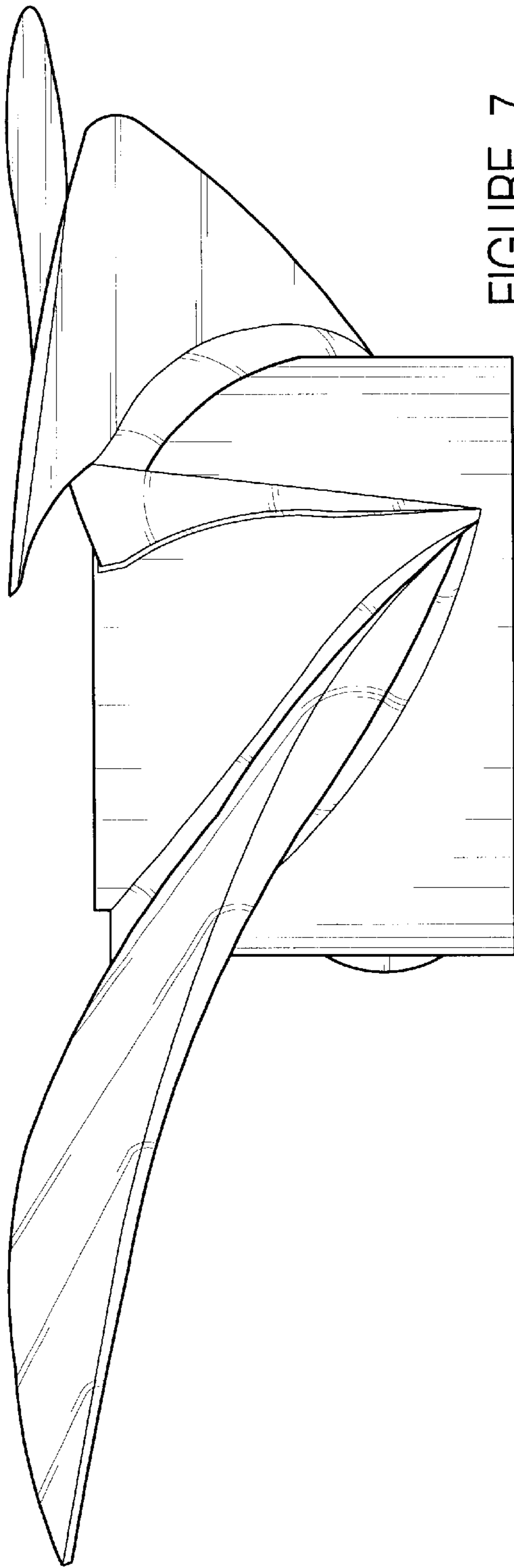

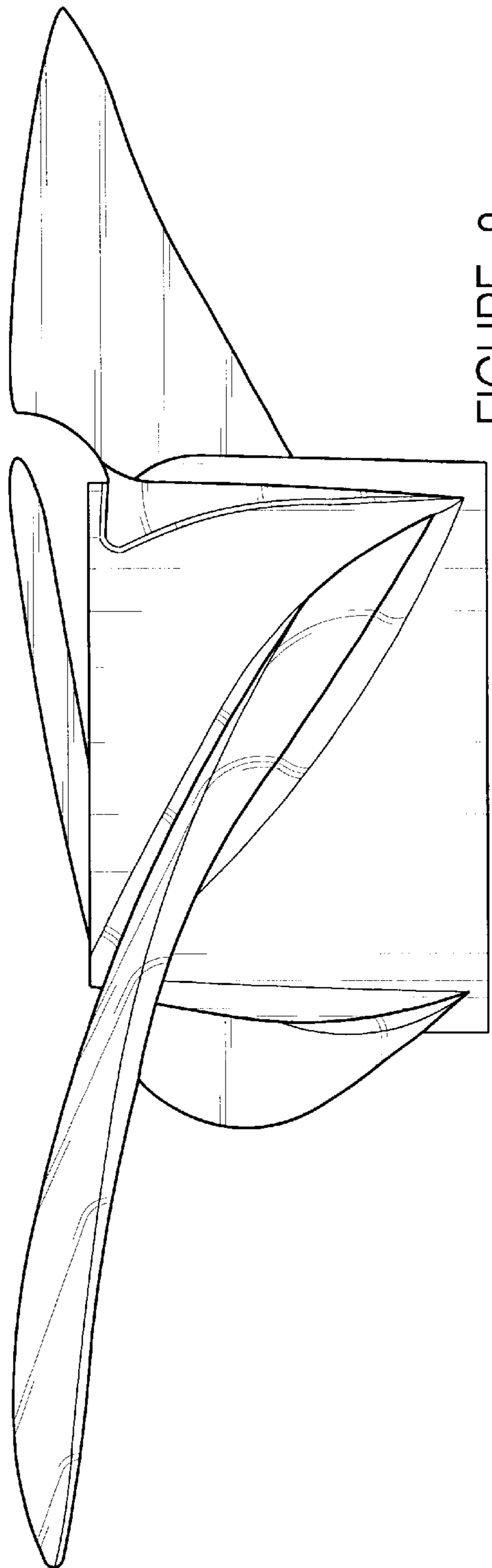
