DESCRIPTION

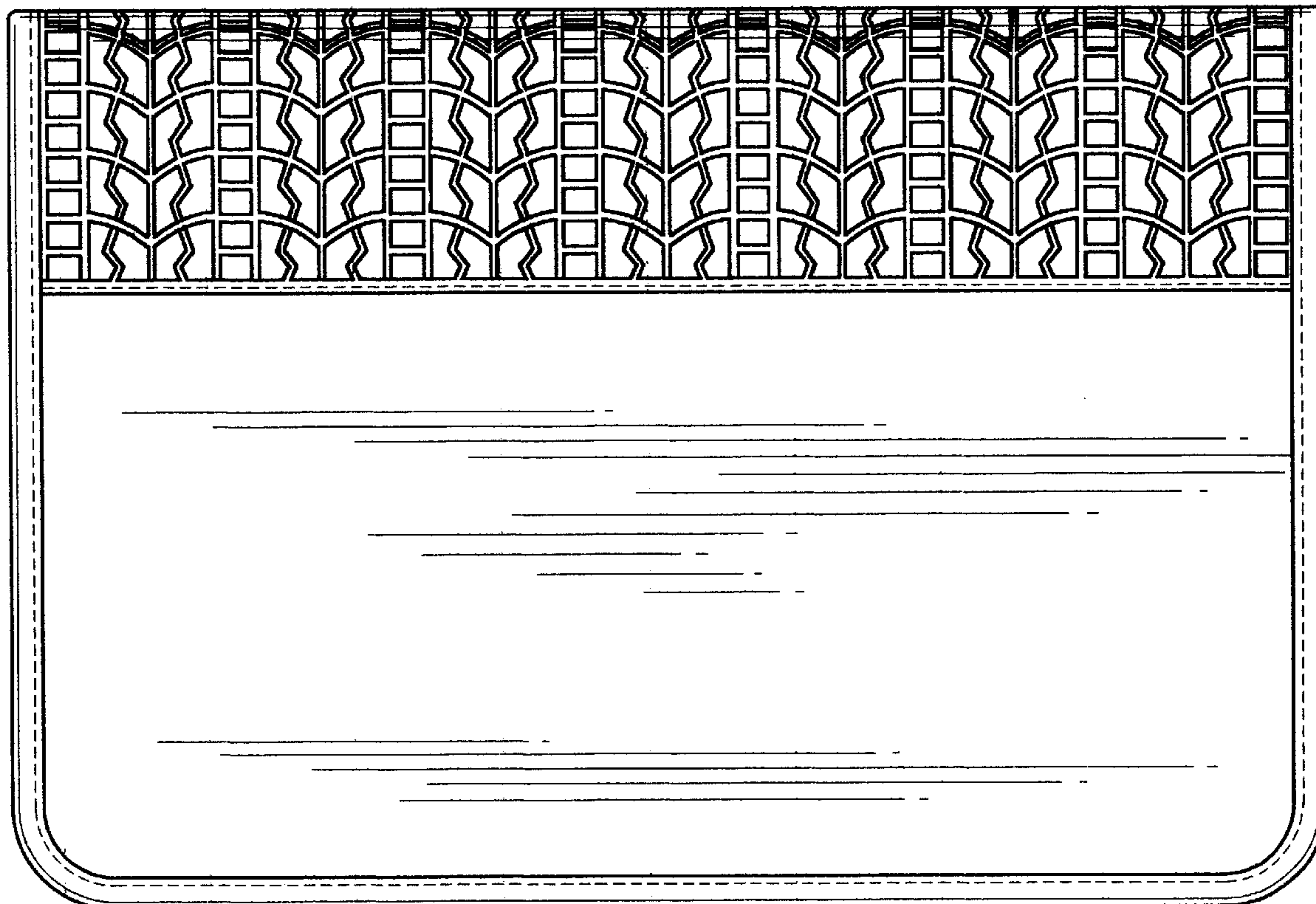
FIG. 1 is a front elevational view of a notepad folder of the present invention;

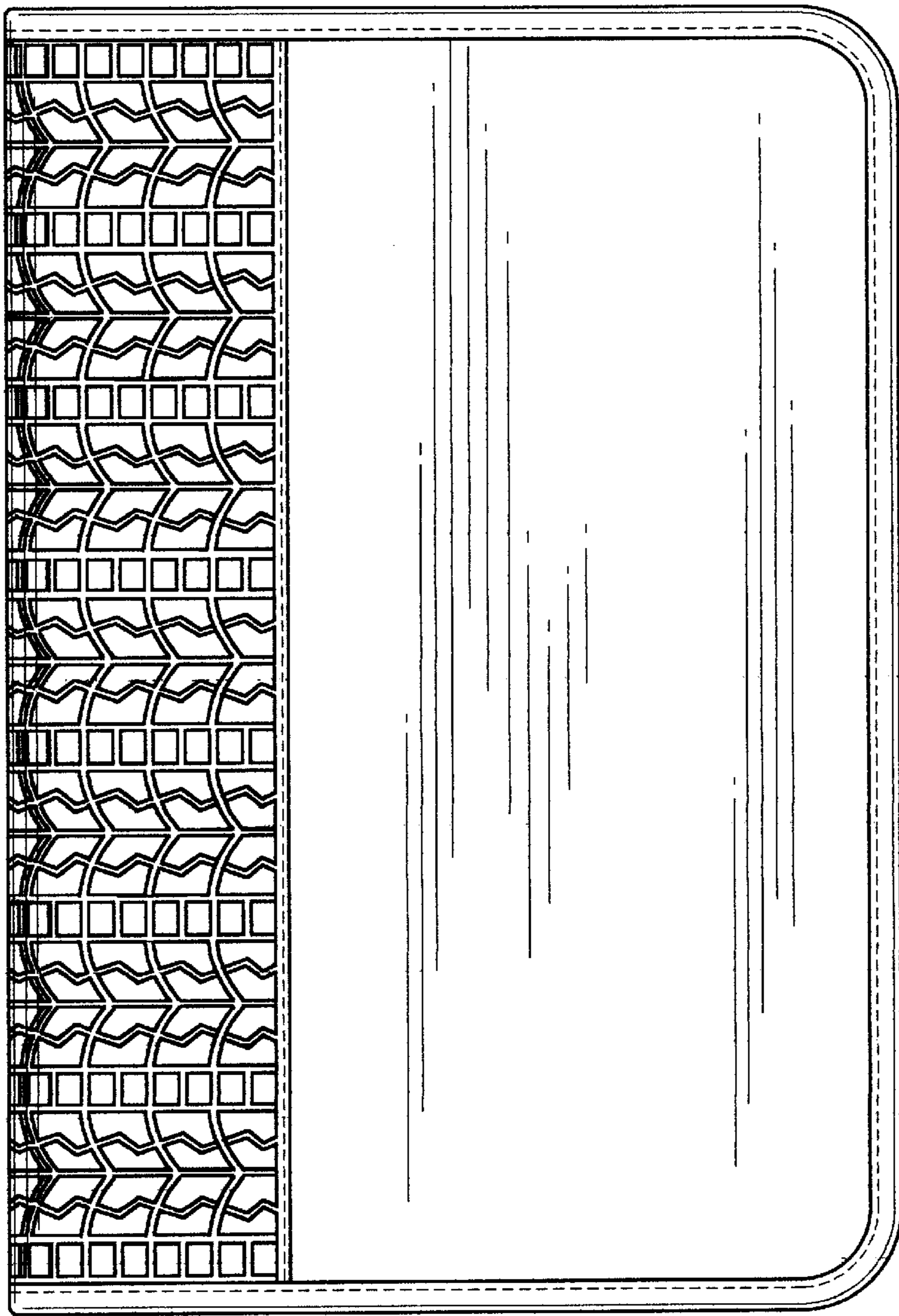

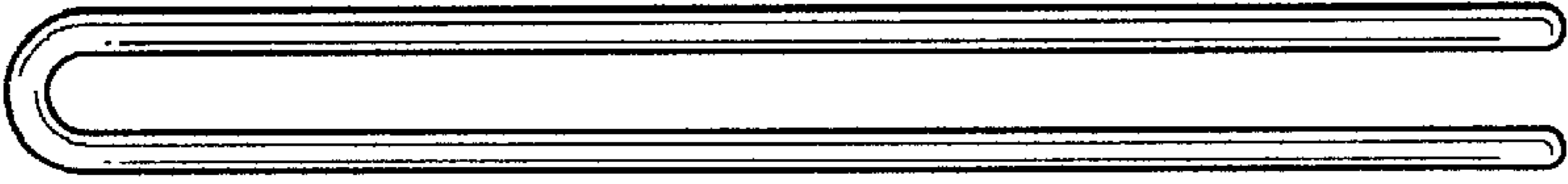

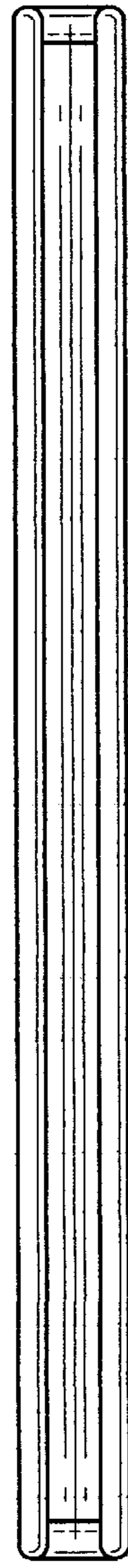

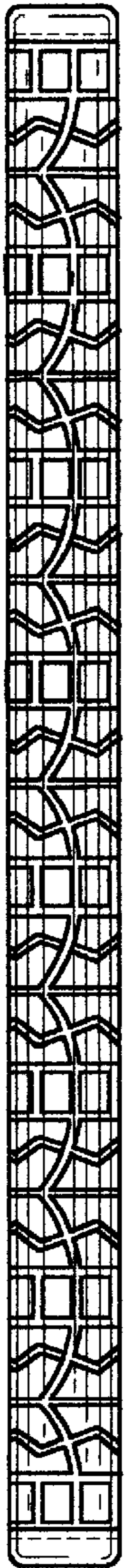

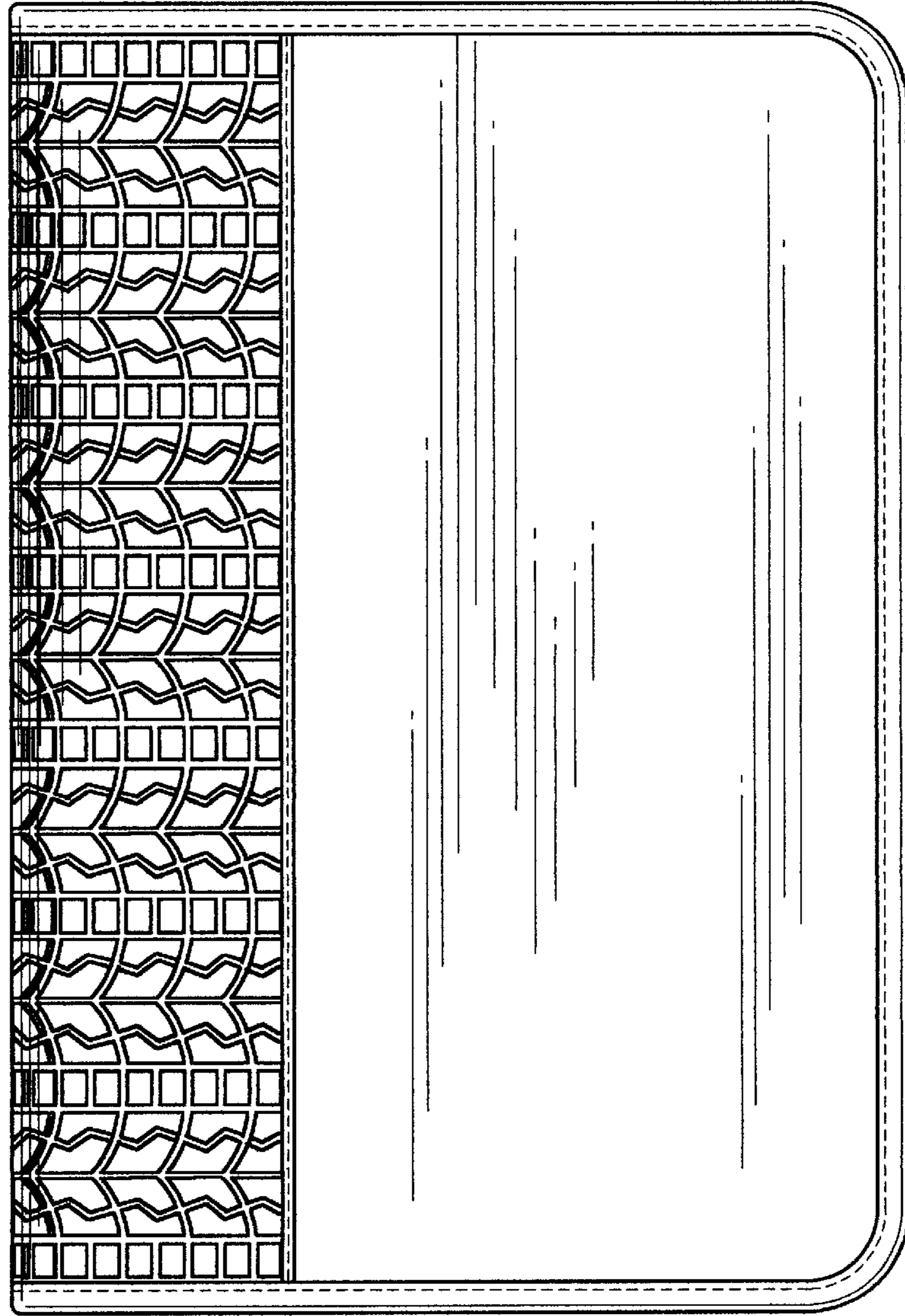

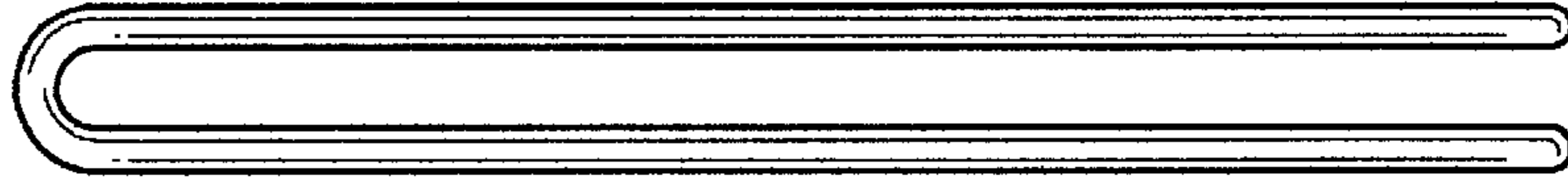
