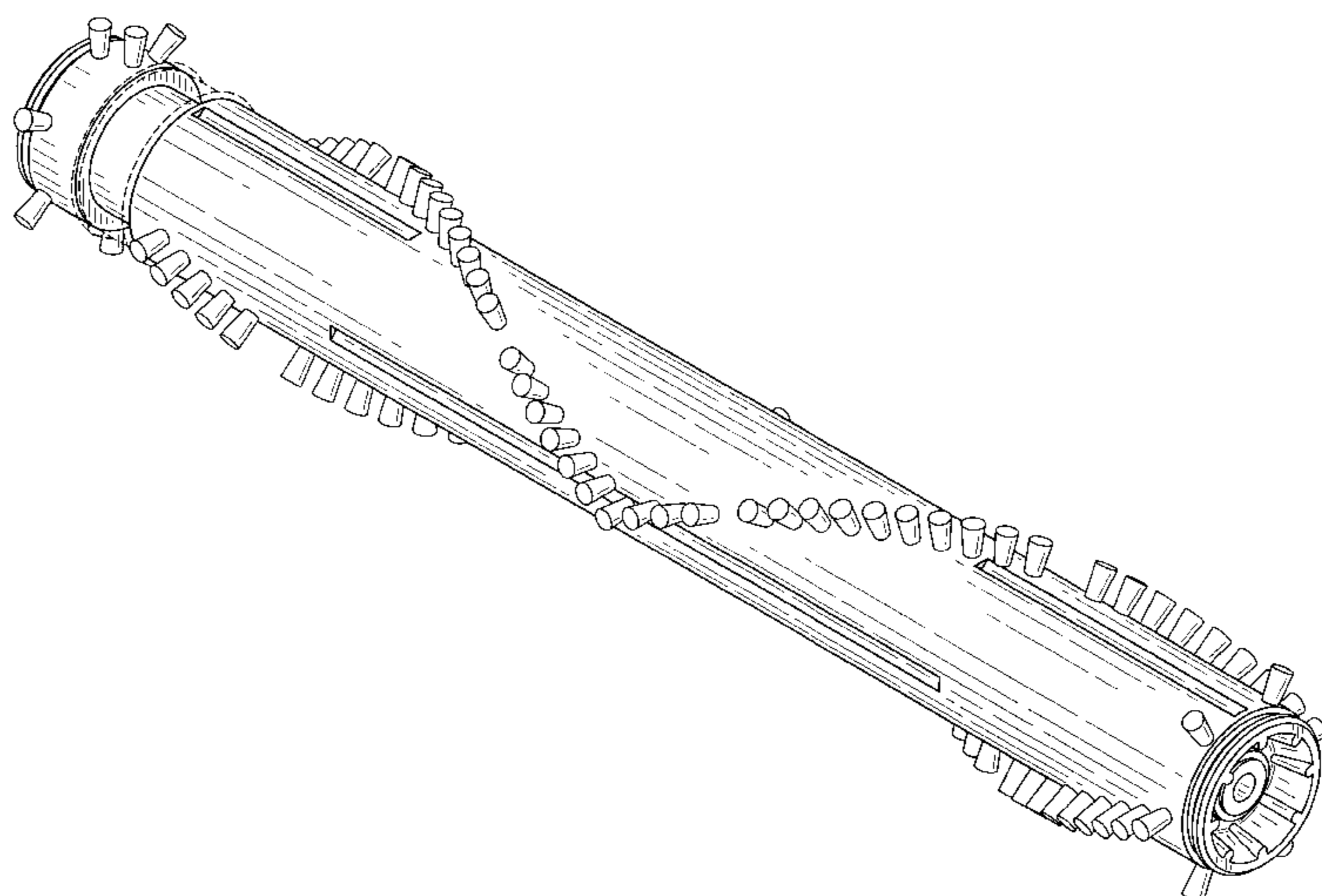
(57) **CLAIM**

The ornamental design for an agitator for a vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an agitator for a vacuum cleaner showing our new design; FIG. 2 is an end view thereof; FIG. 3 is a side view thereof; FIG. 4 is a side view thereof having been rotated ¼ of a revolution from FIG. 3; FIG. 5 is a side view thereof having been rotated ¼ of a revolution from FIG. 4; FIG. 6 is a side view thereof having been rotated ¼ of a revolution from FIG. 5; and, FIG. 7 is an end view thereof of the opposite end of FIG. 2. The details shown in broken lines in FIGS. 1 and 3-7 are for illustrative purposes only and form no part of the claimed design.

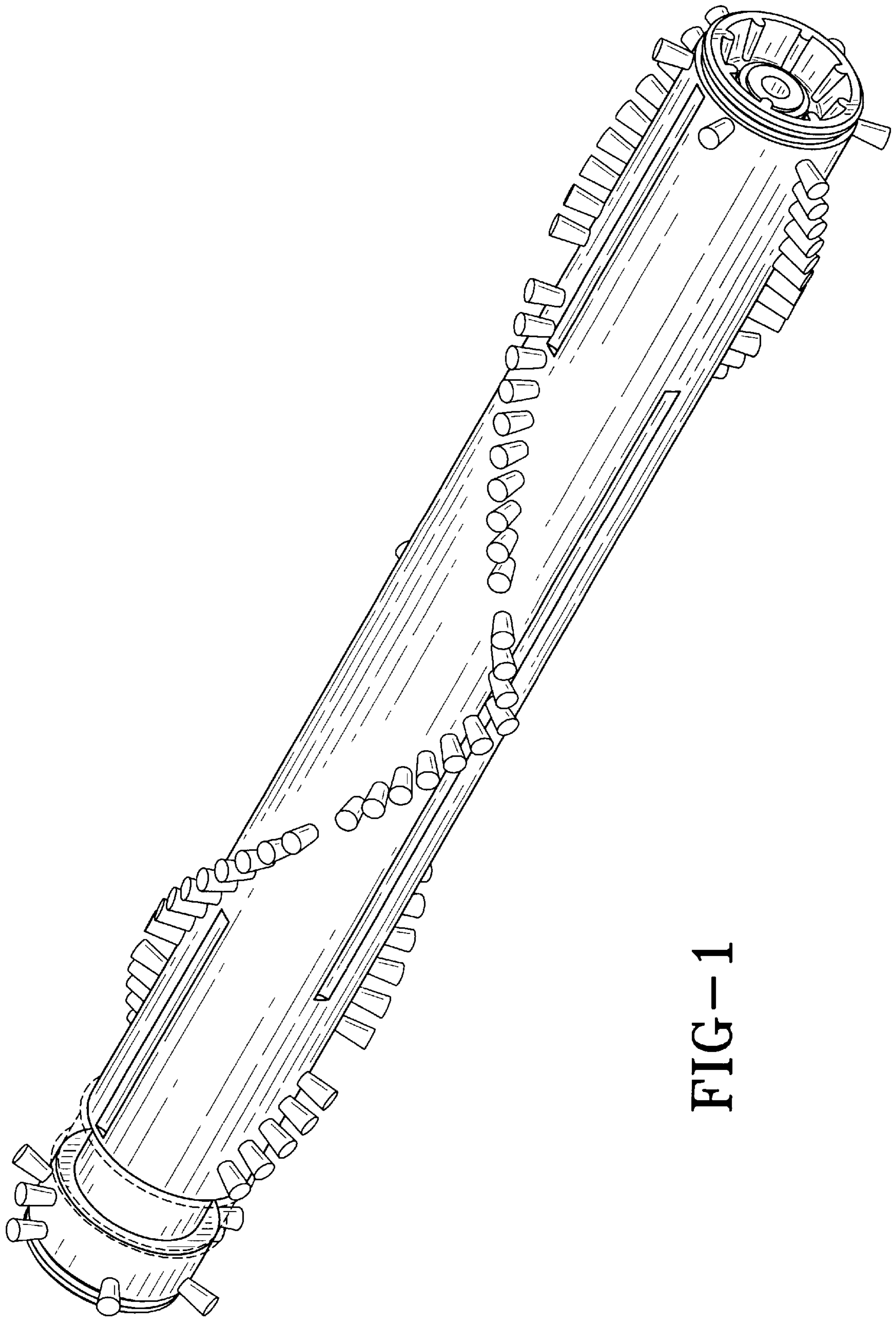

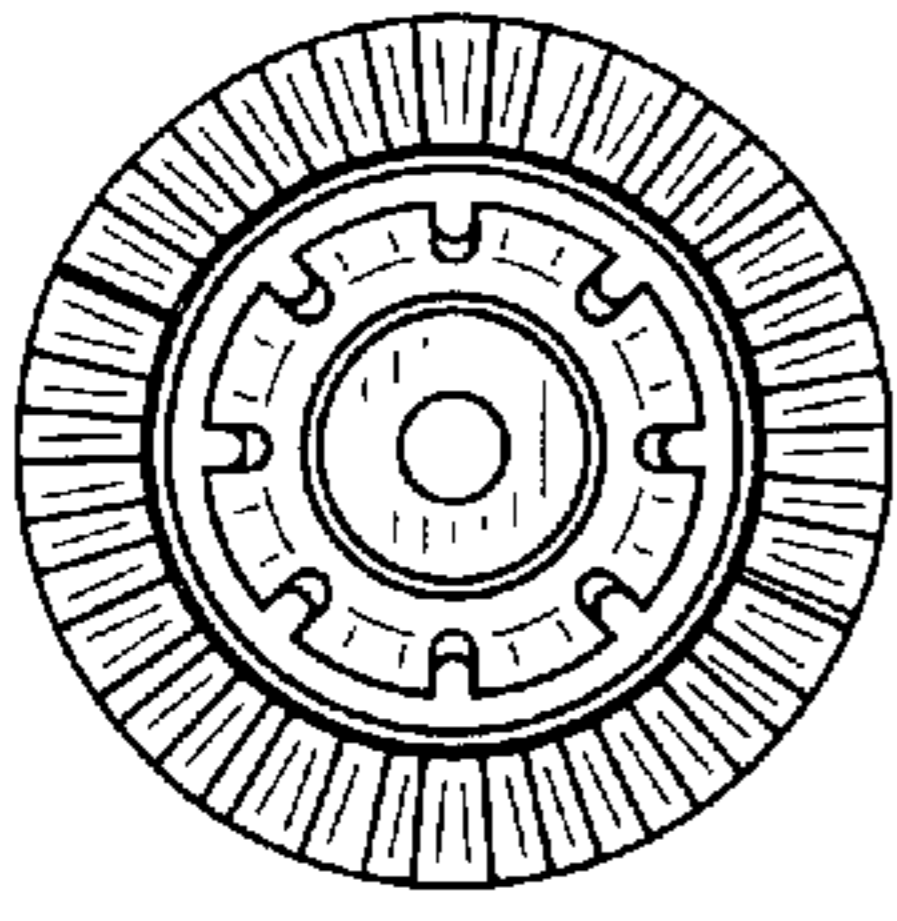

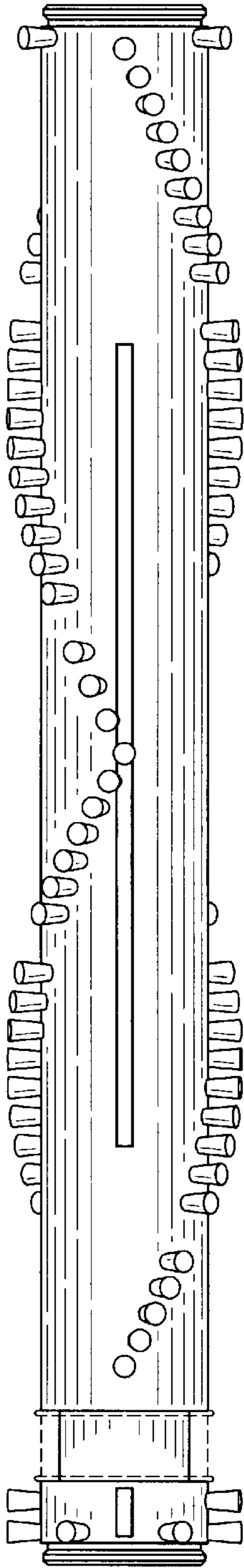

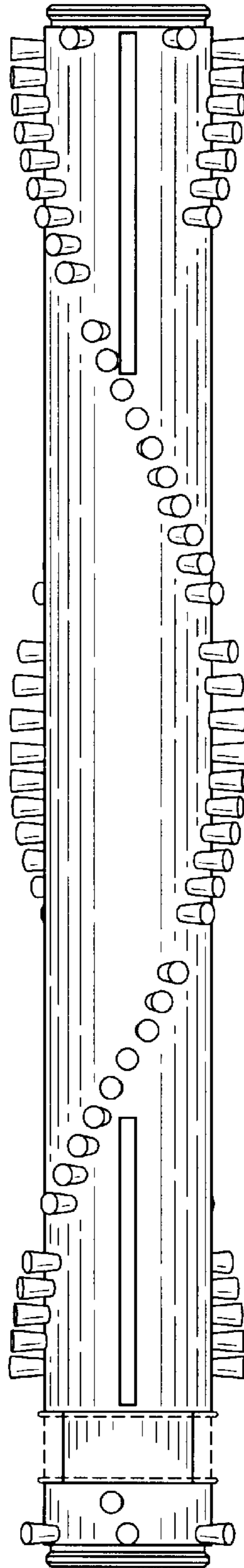

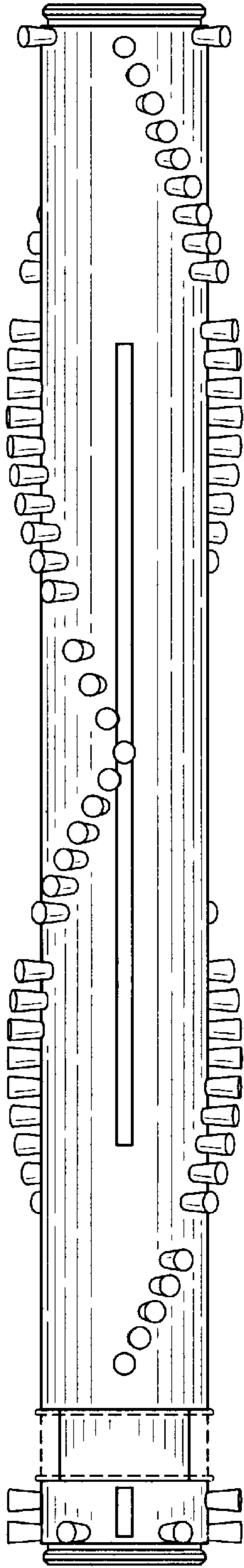

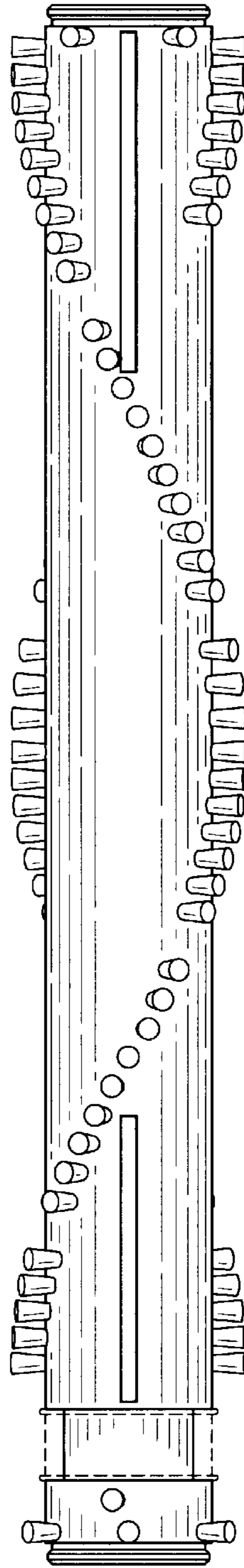

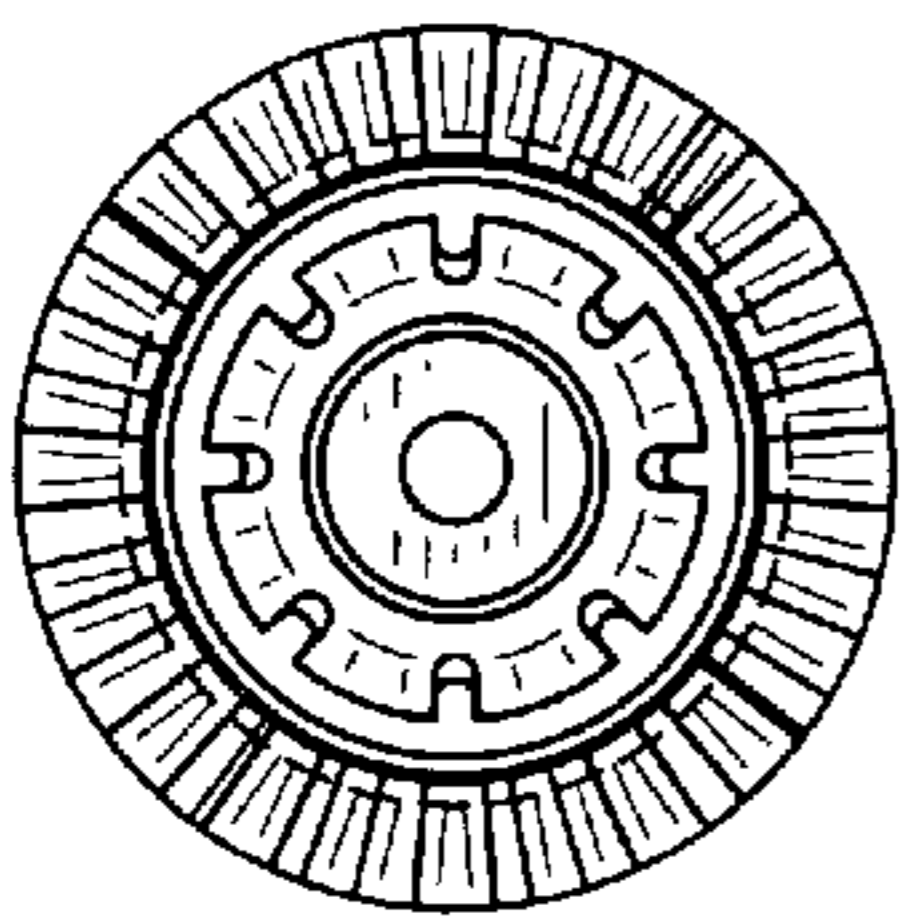
