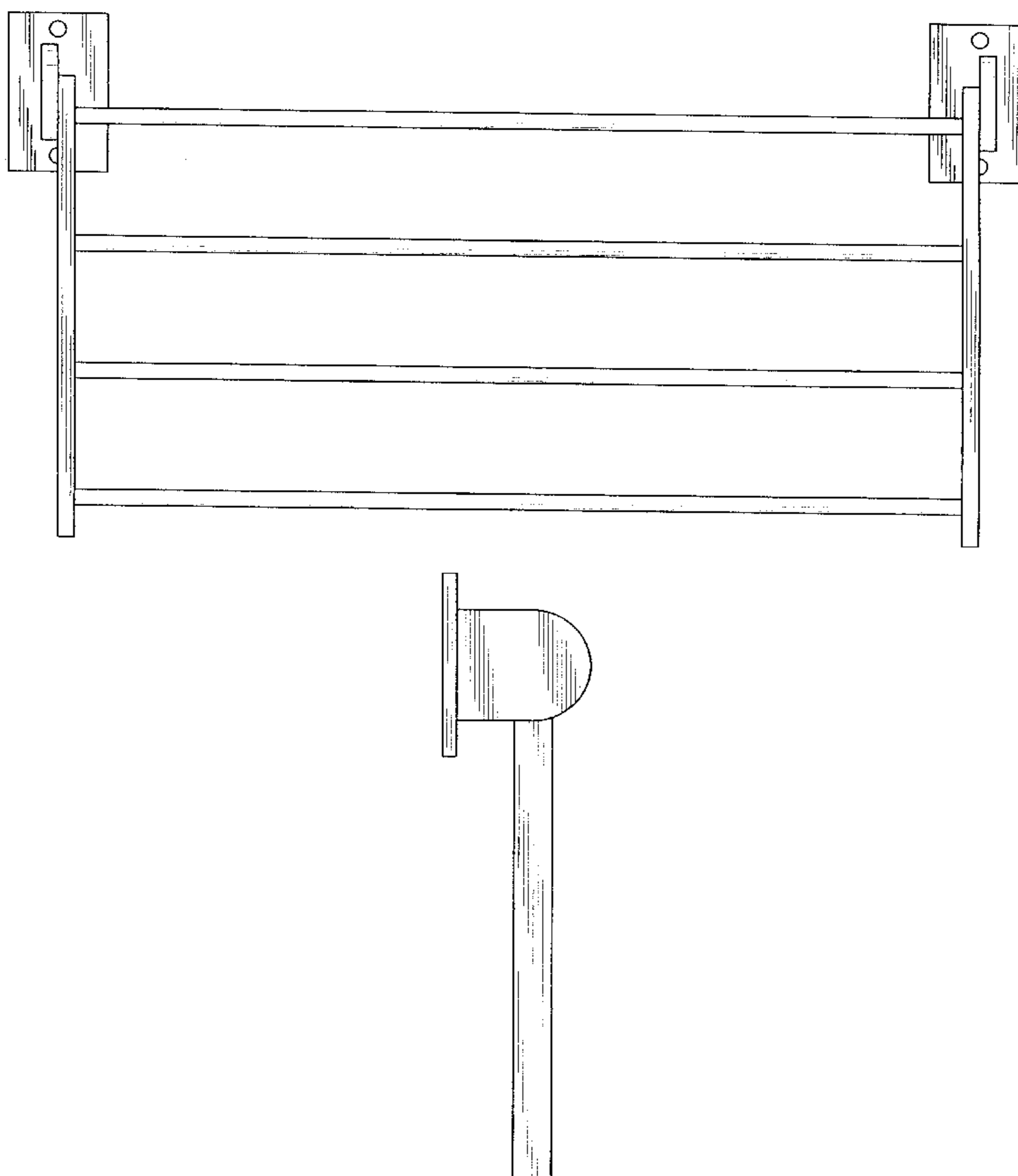

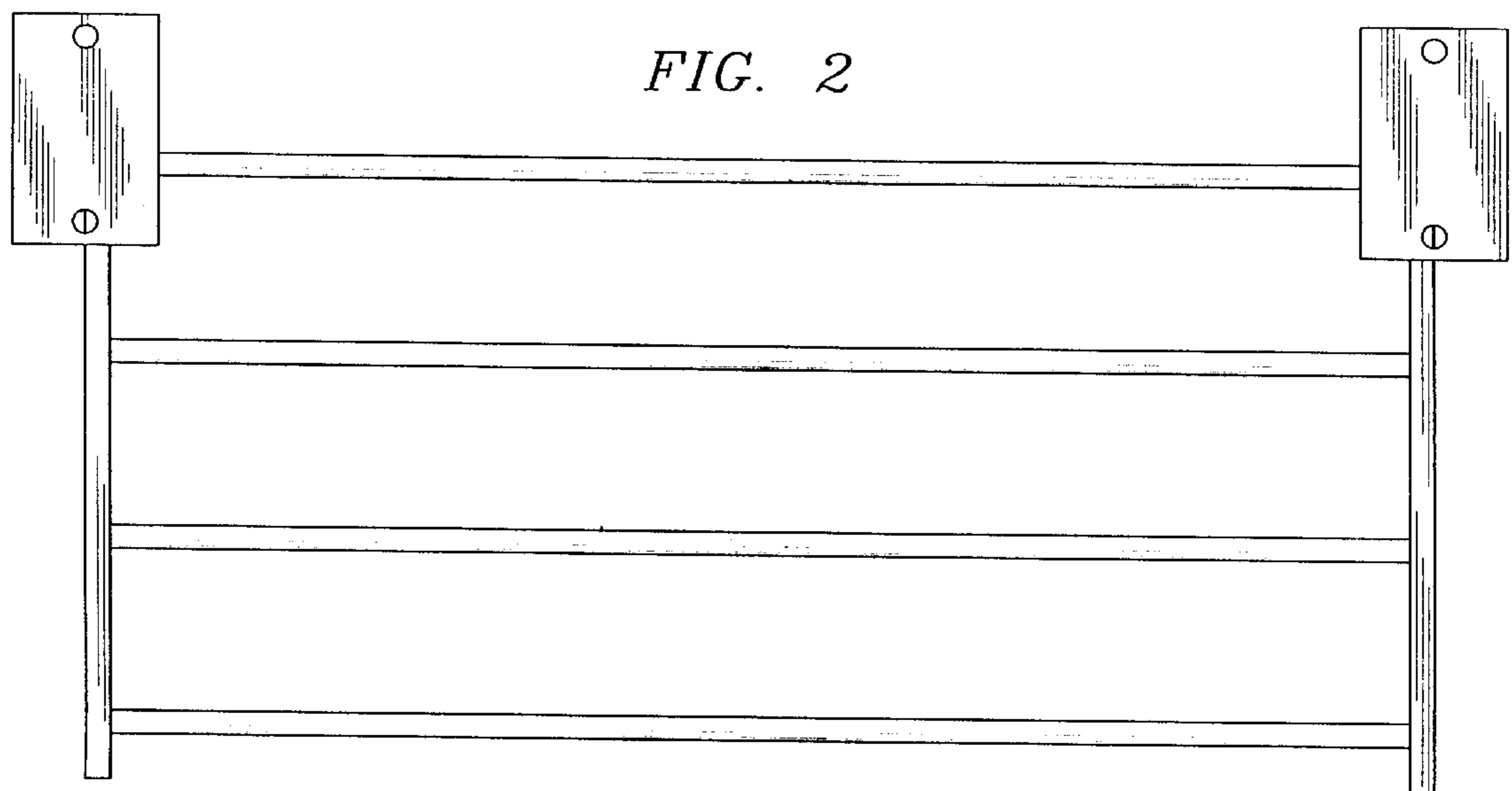
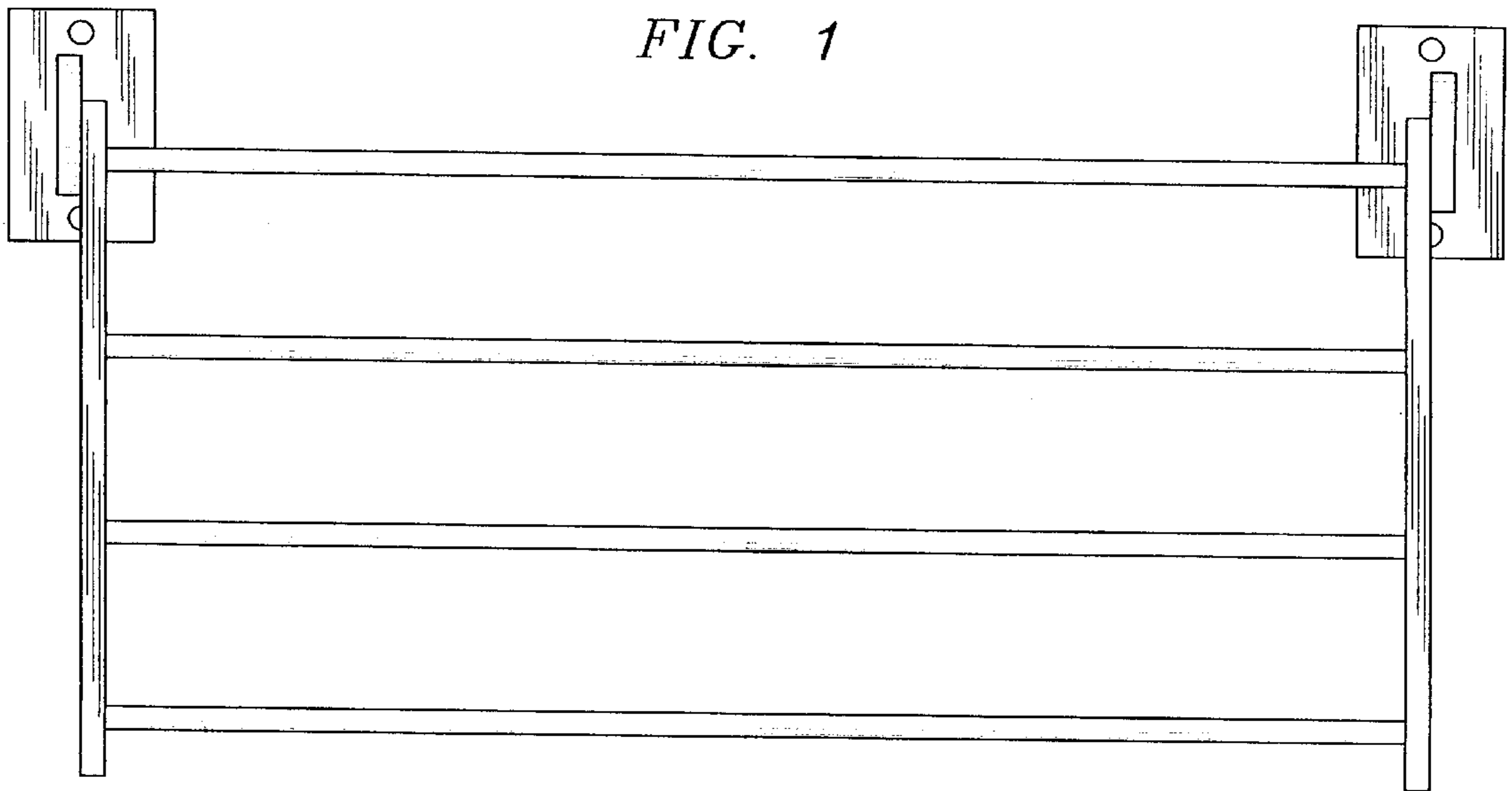
The ornamental design for a towel hanging apparatus, as shown.

**DESCRIPTION**

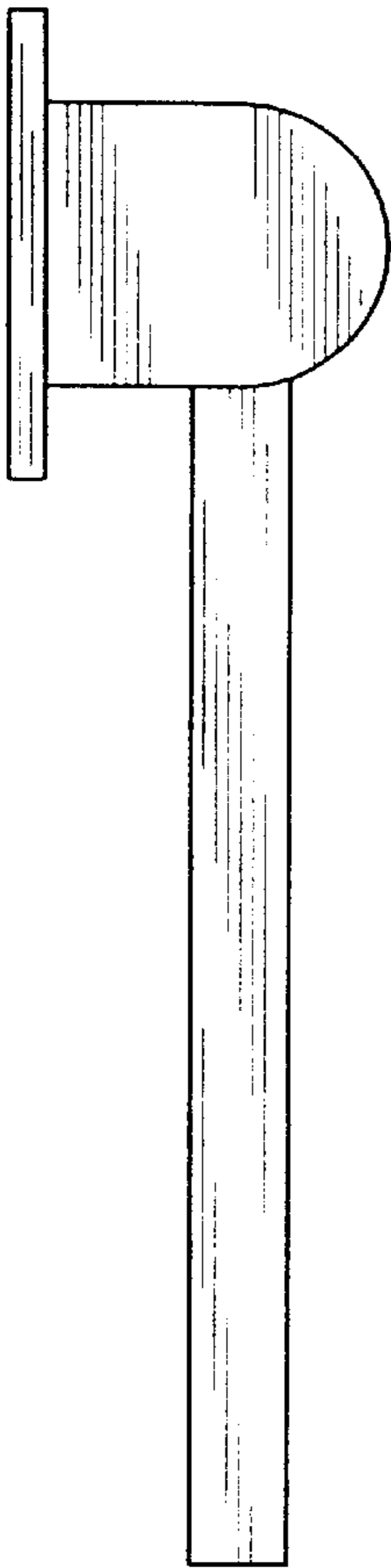
FIG. 1 is a front plan view of the towel hanging apparatus of the present invention;

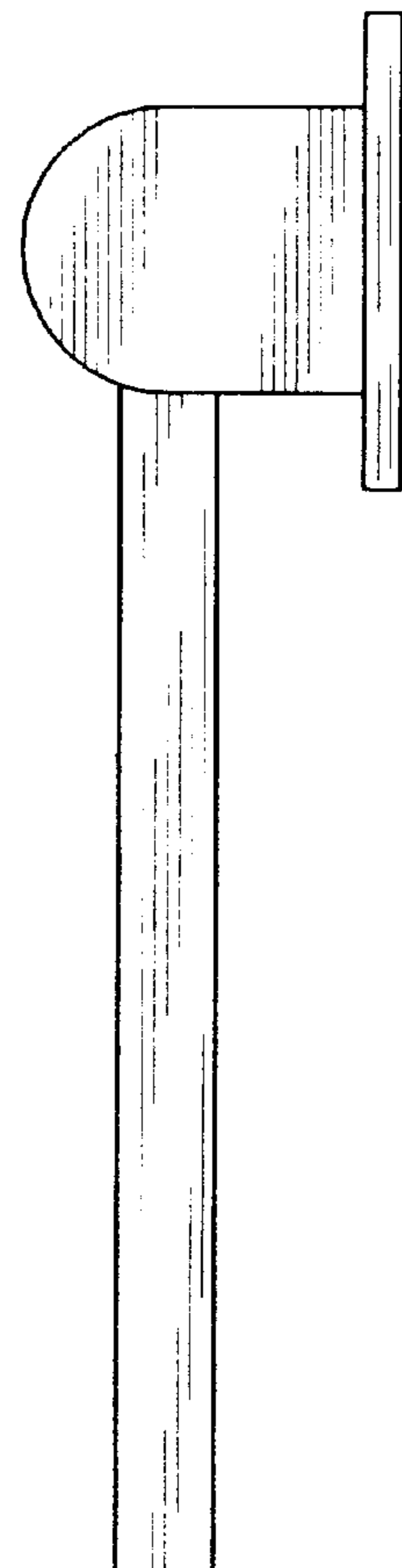

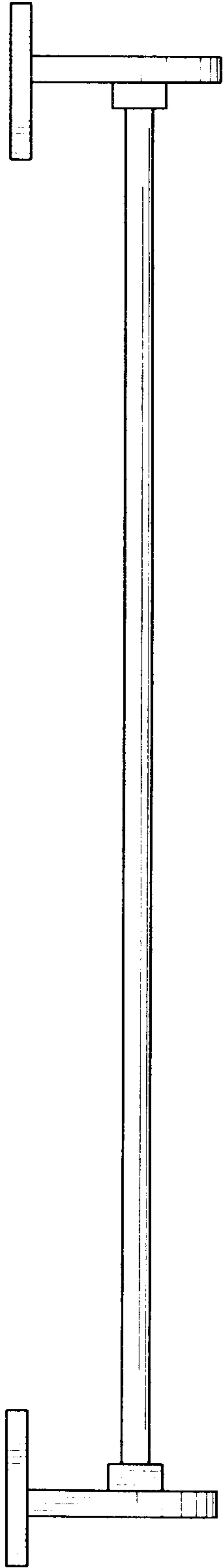
