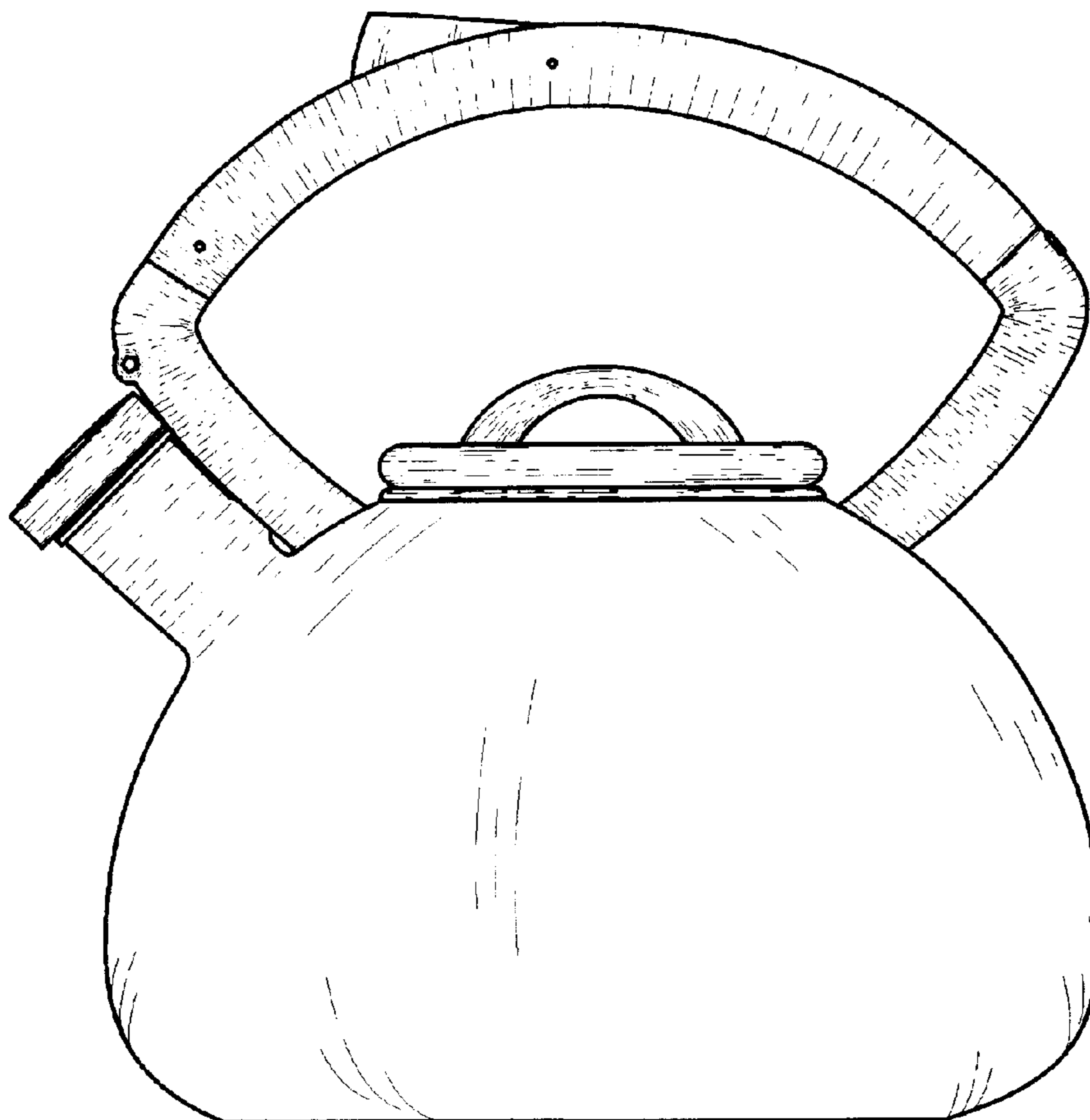

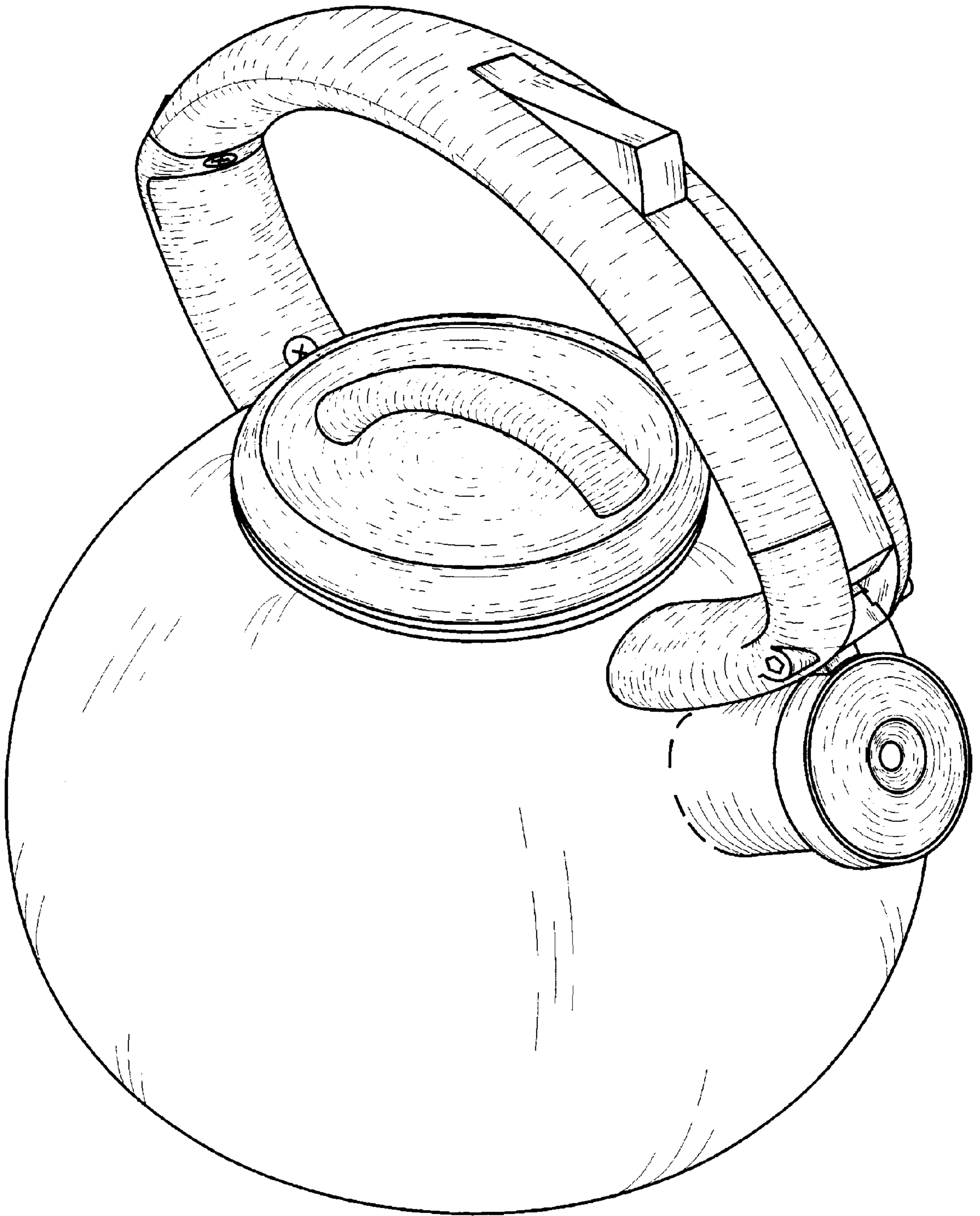
The ornamental design for the tea kettle, as shown.

**DESCRIPTION**

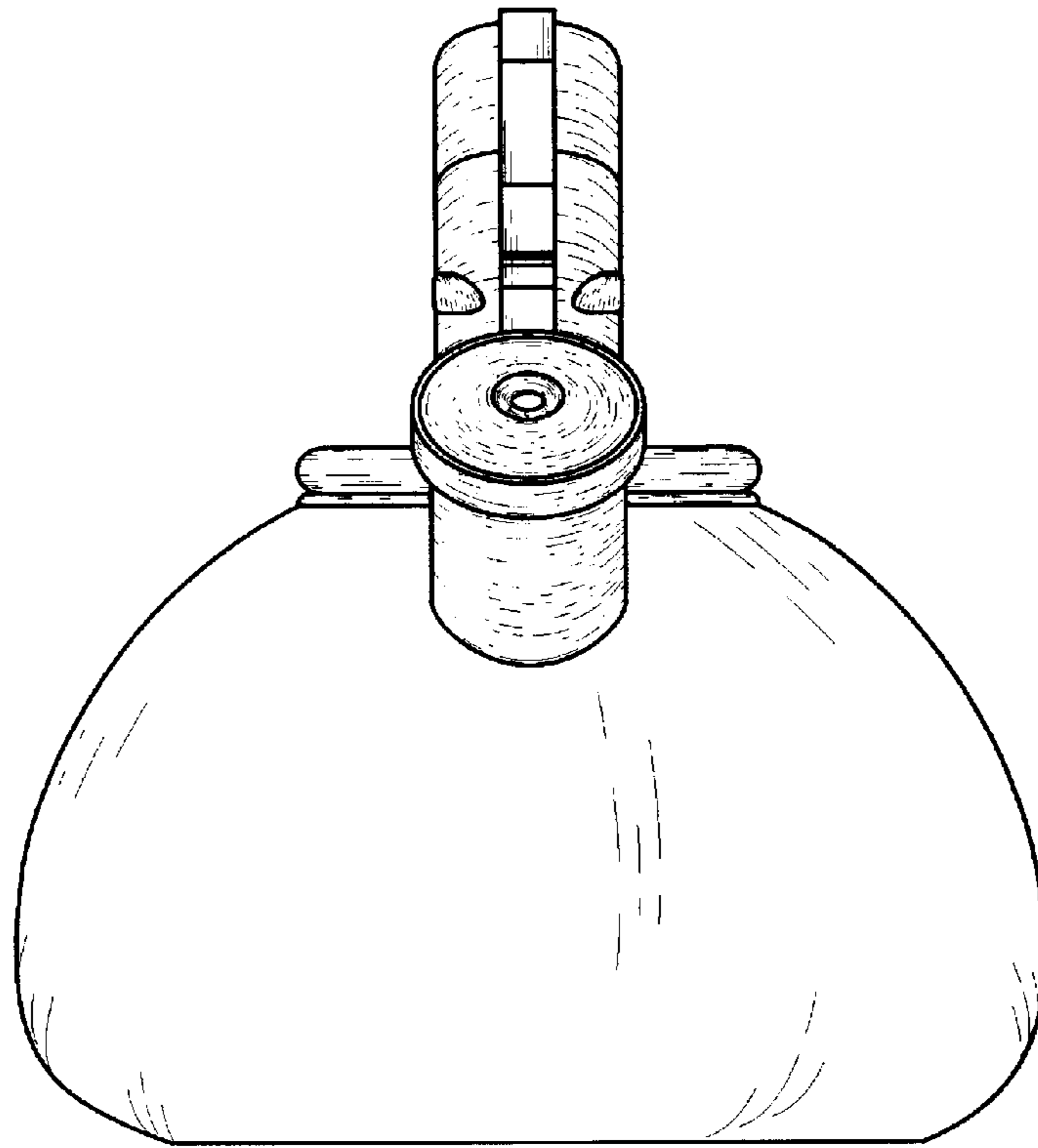
FIG. 1 is a perspective view of the tea kettle;

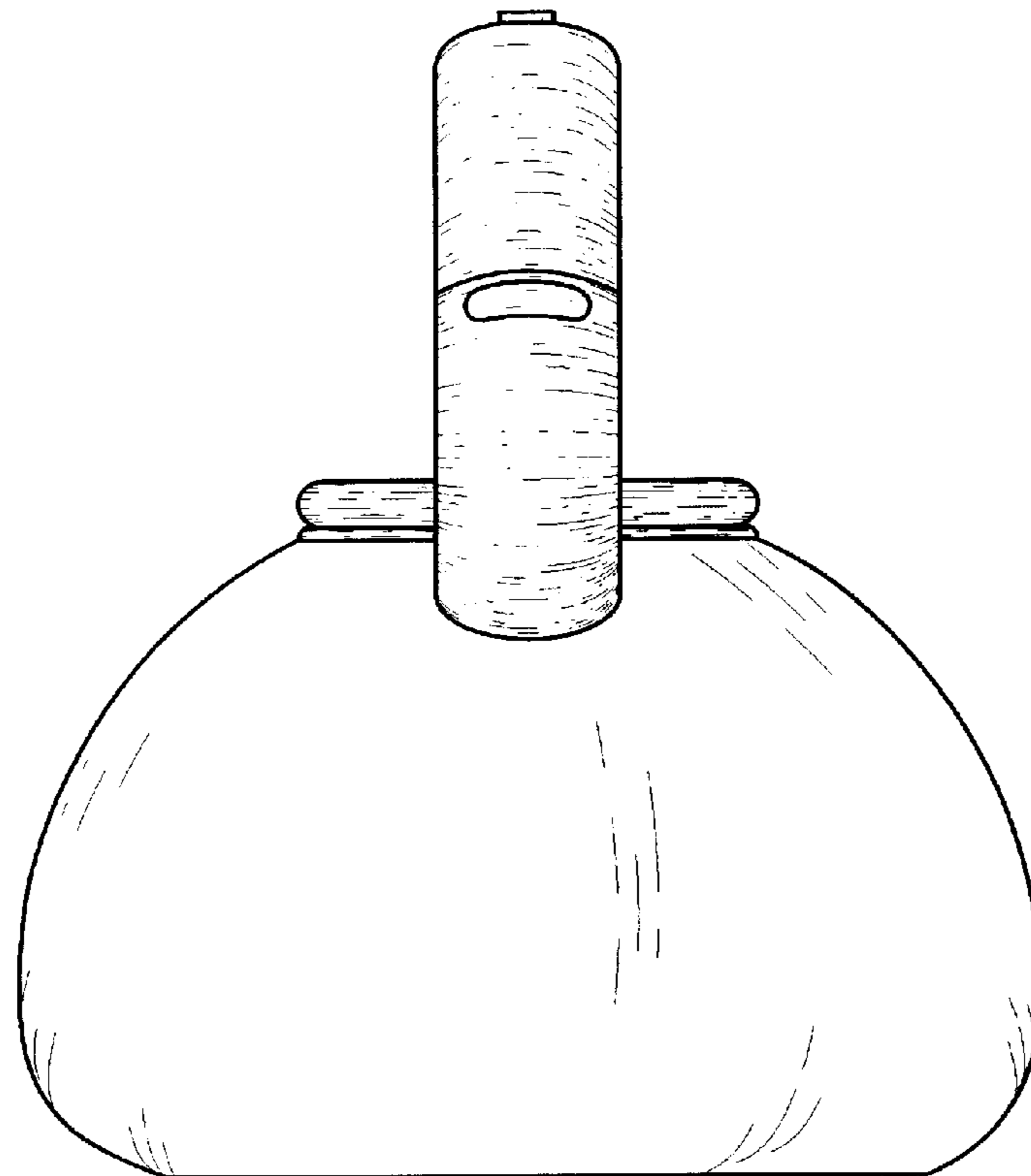




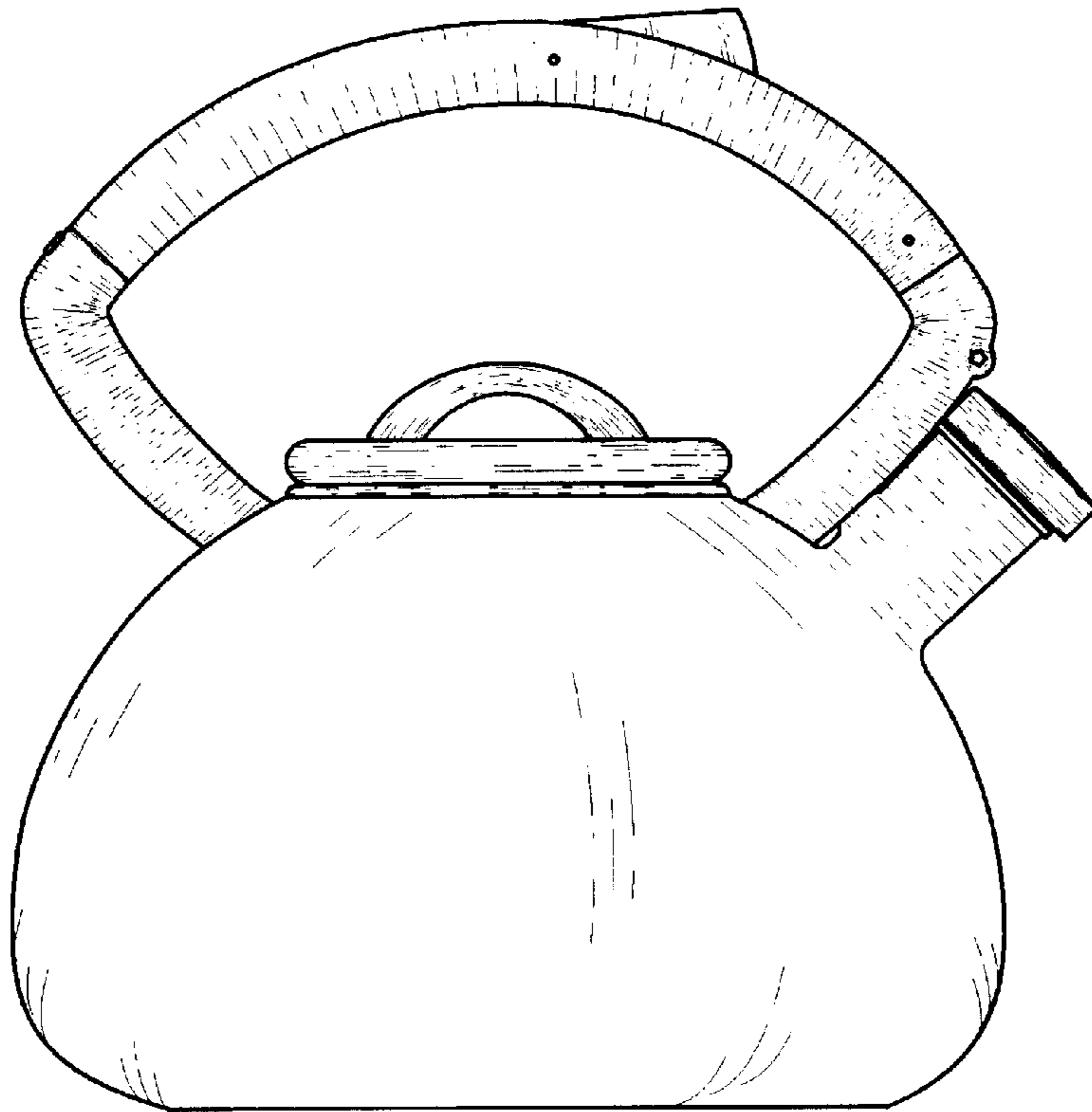

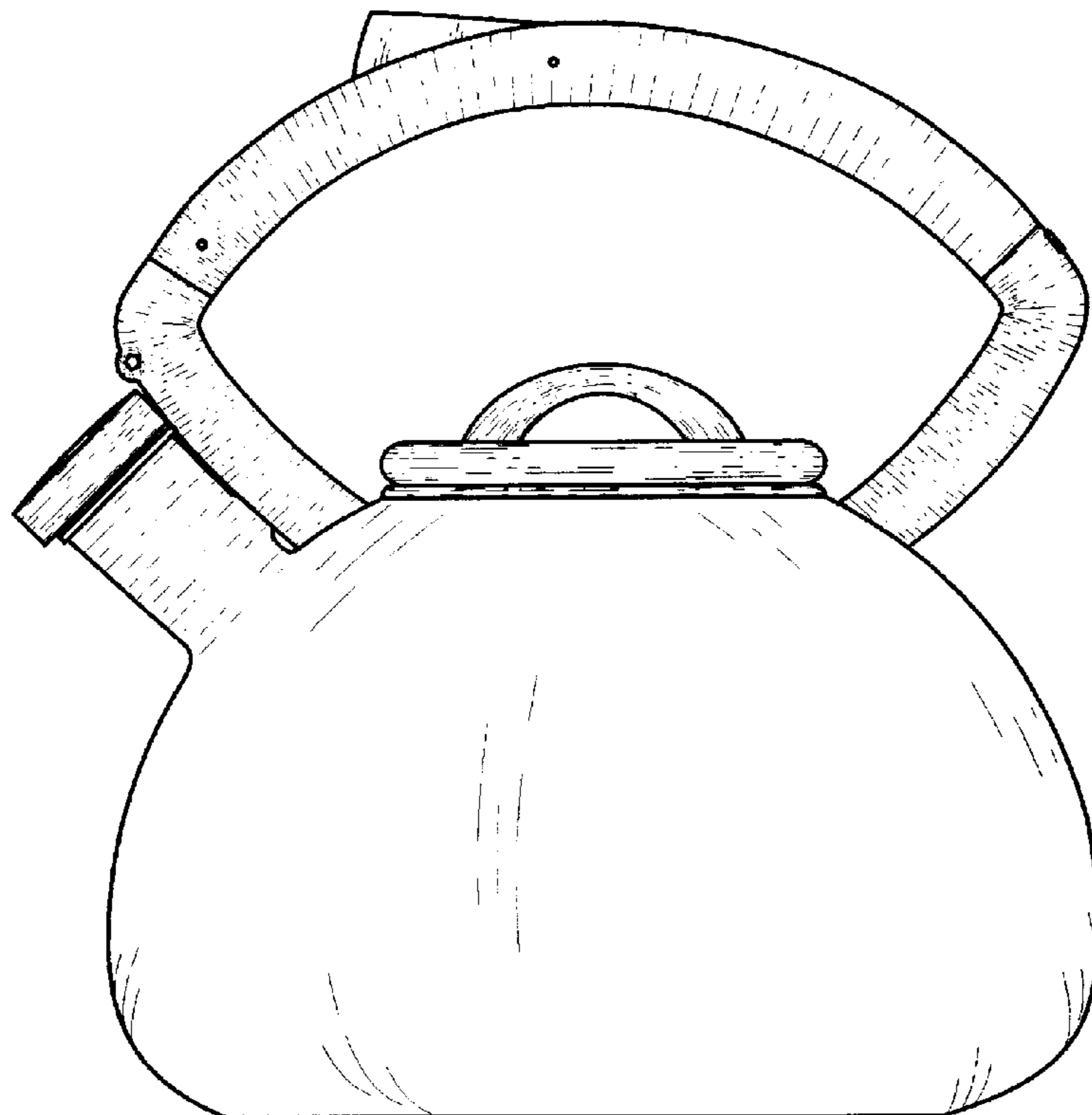

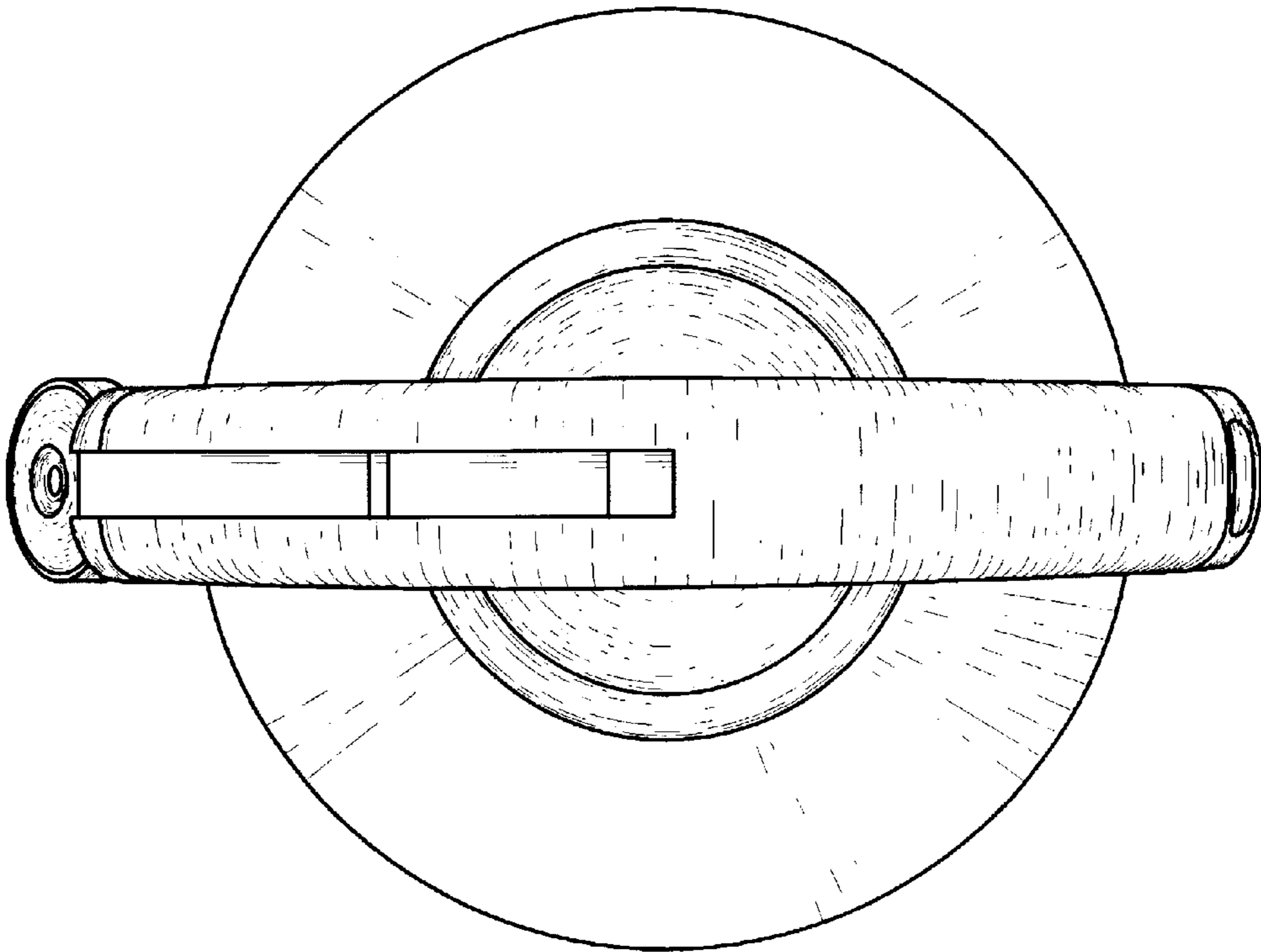

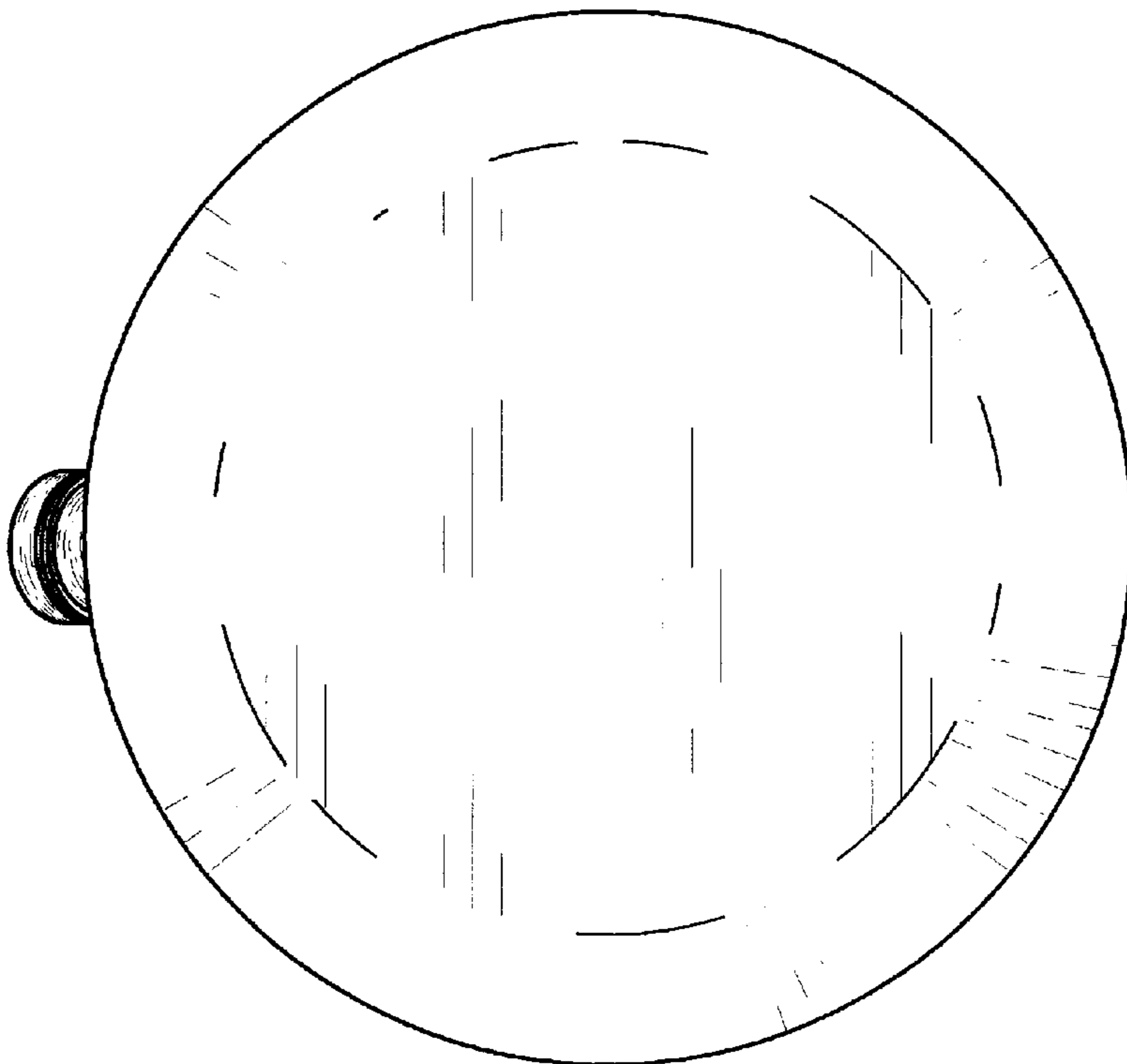
