We claim the ornamental design for a drinking tumbler, as shown and described.

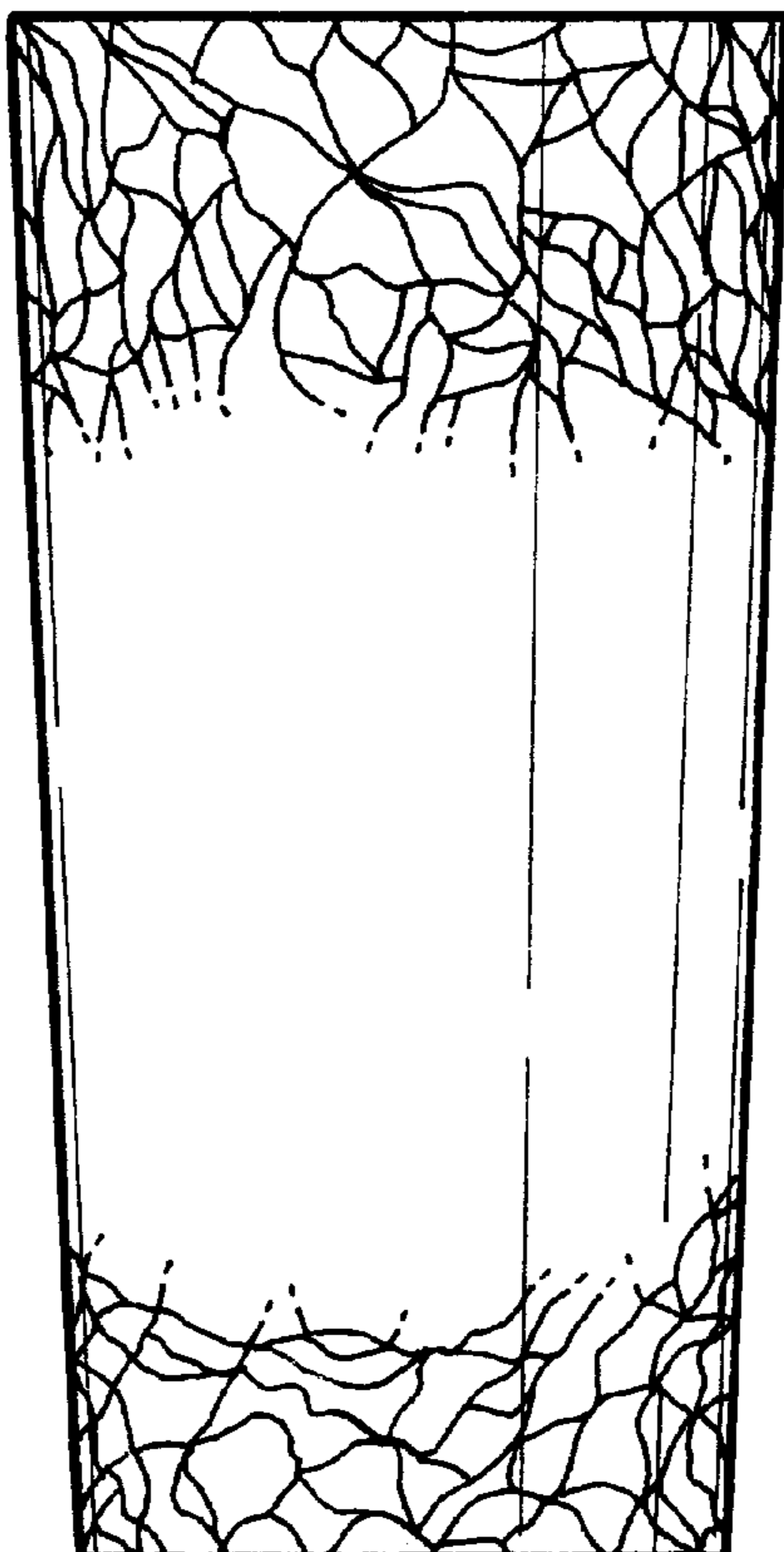
**DESCRIPTION**

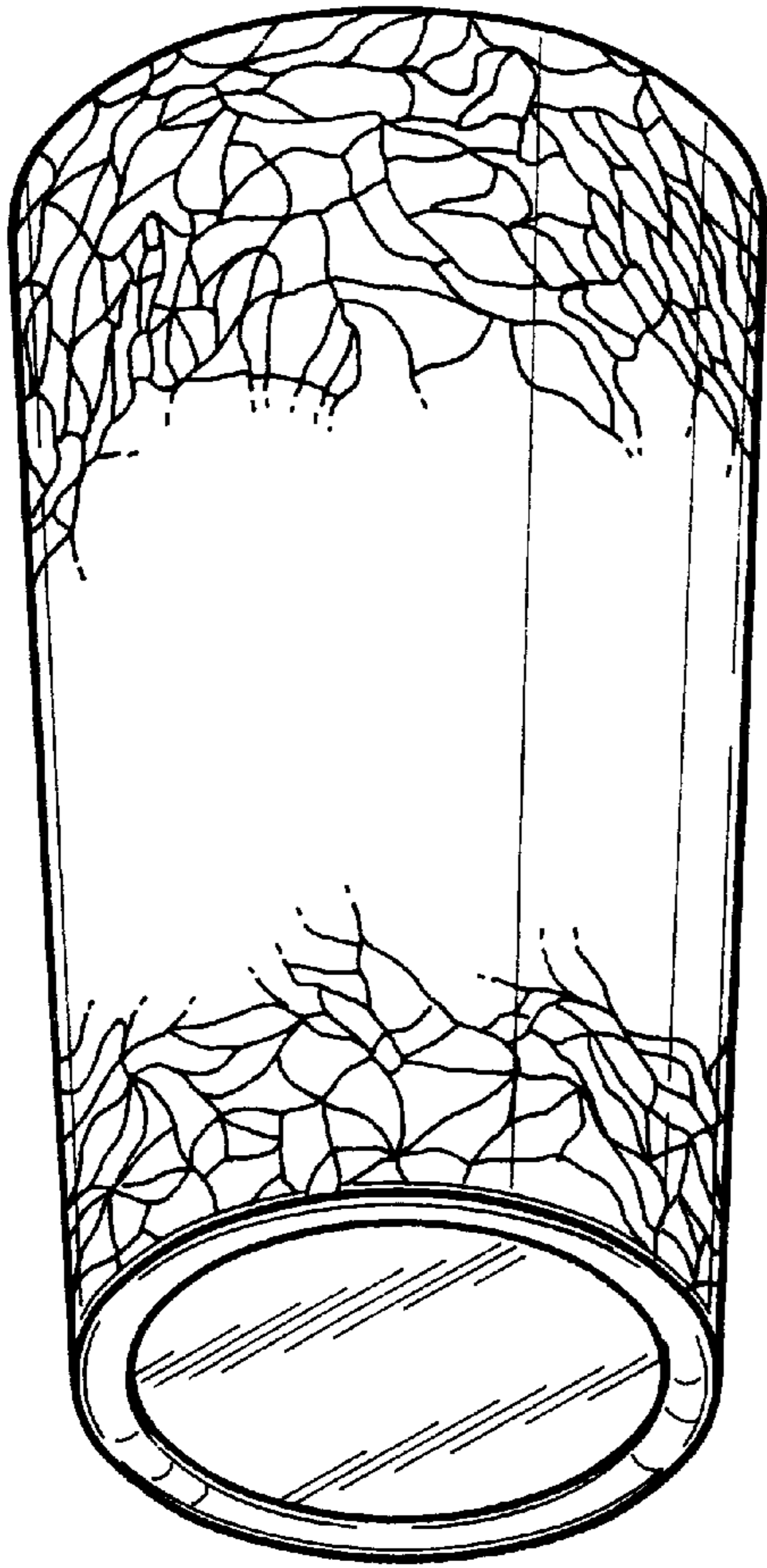

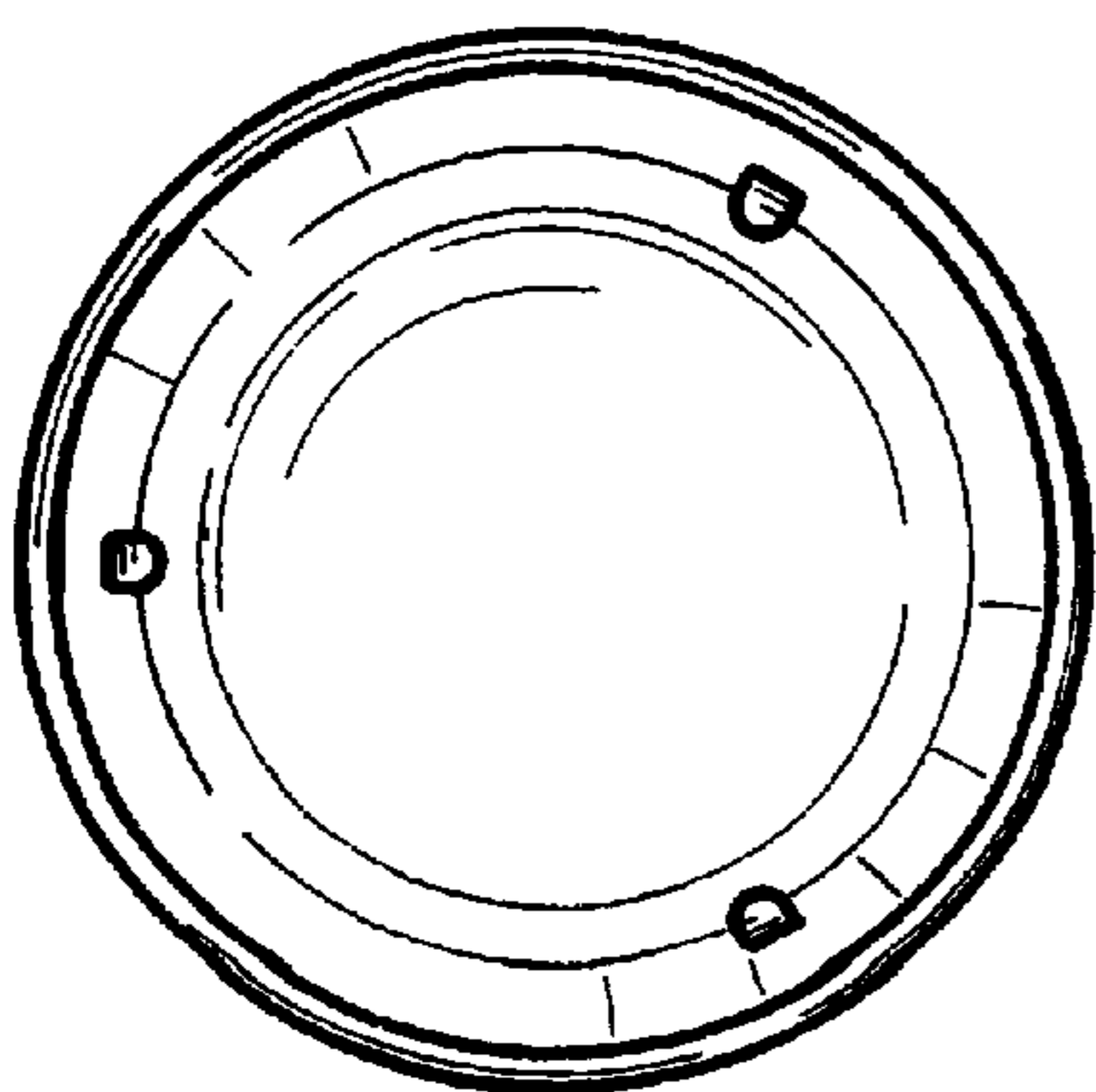

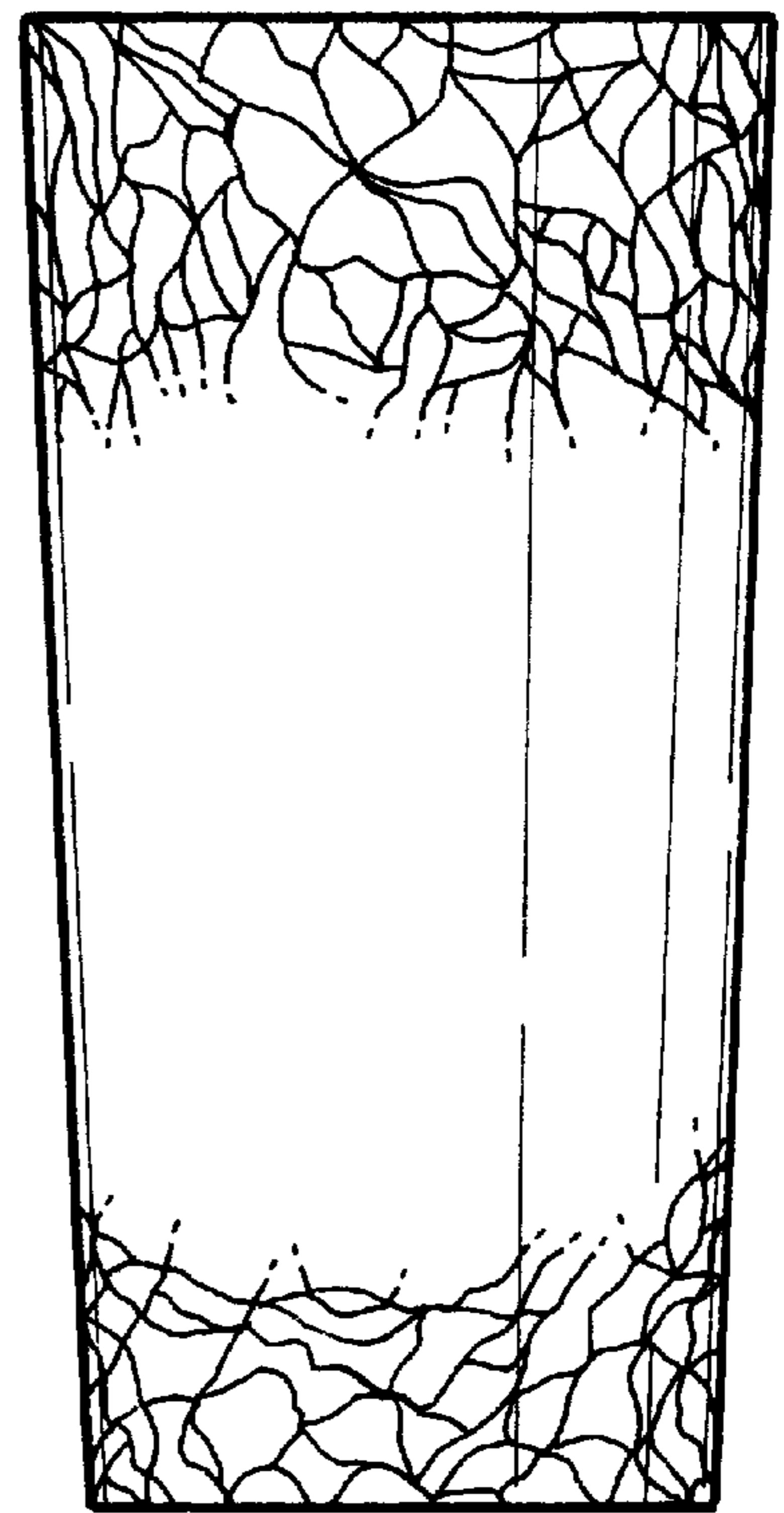
