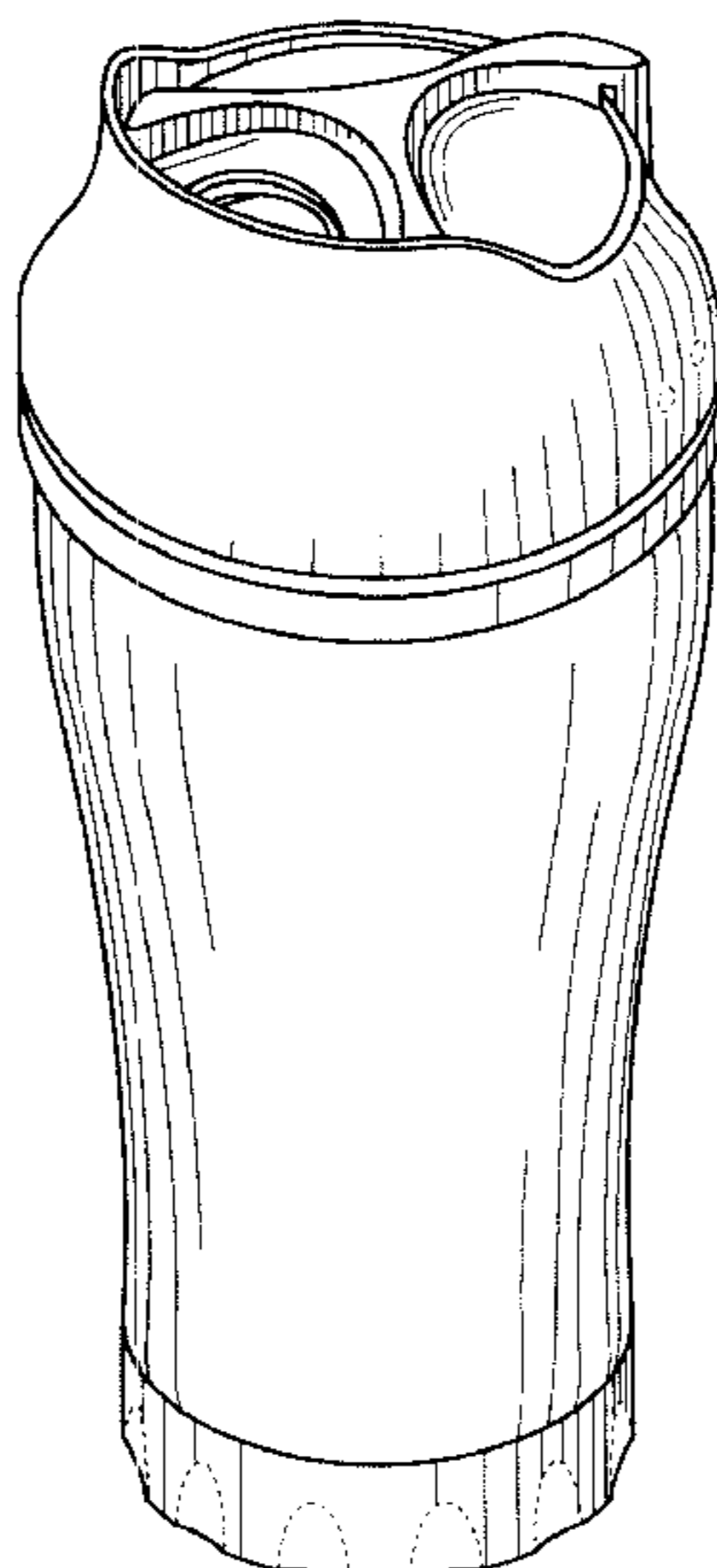

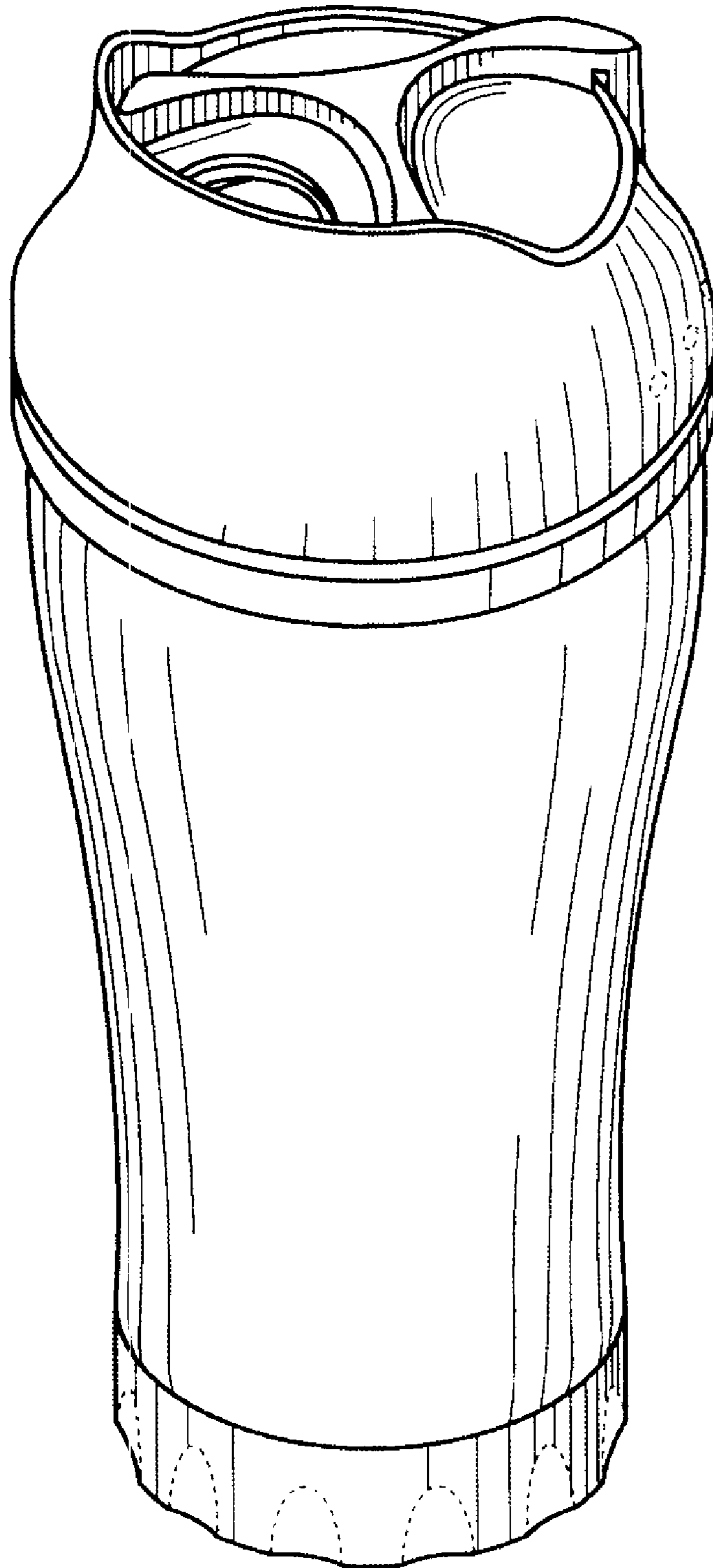
The original design for a cup with lid, as shown and described.

**DESCRIPTION**

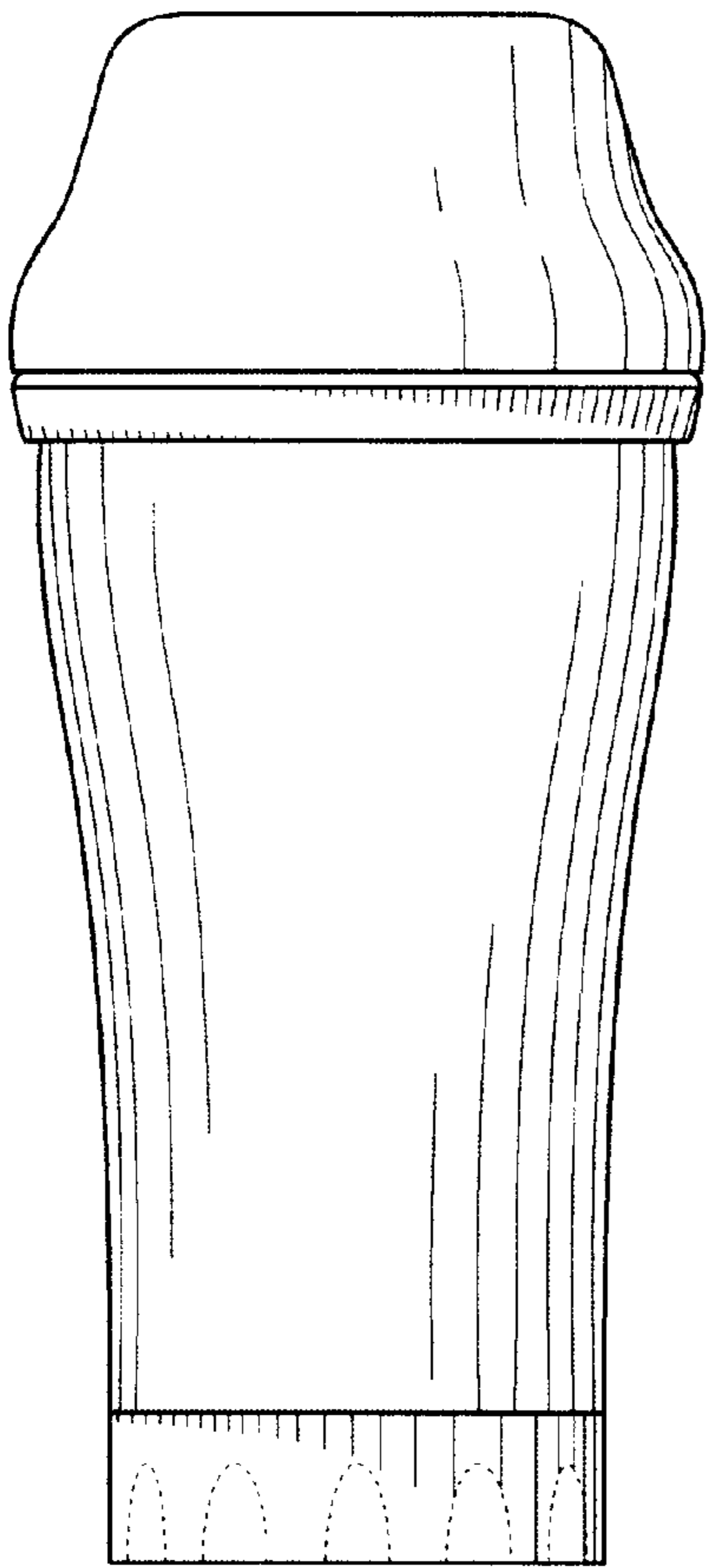
FIG. 1 is a top perspective view of a cup with lid in accordance with the new design;

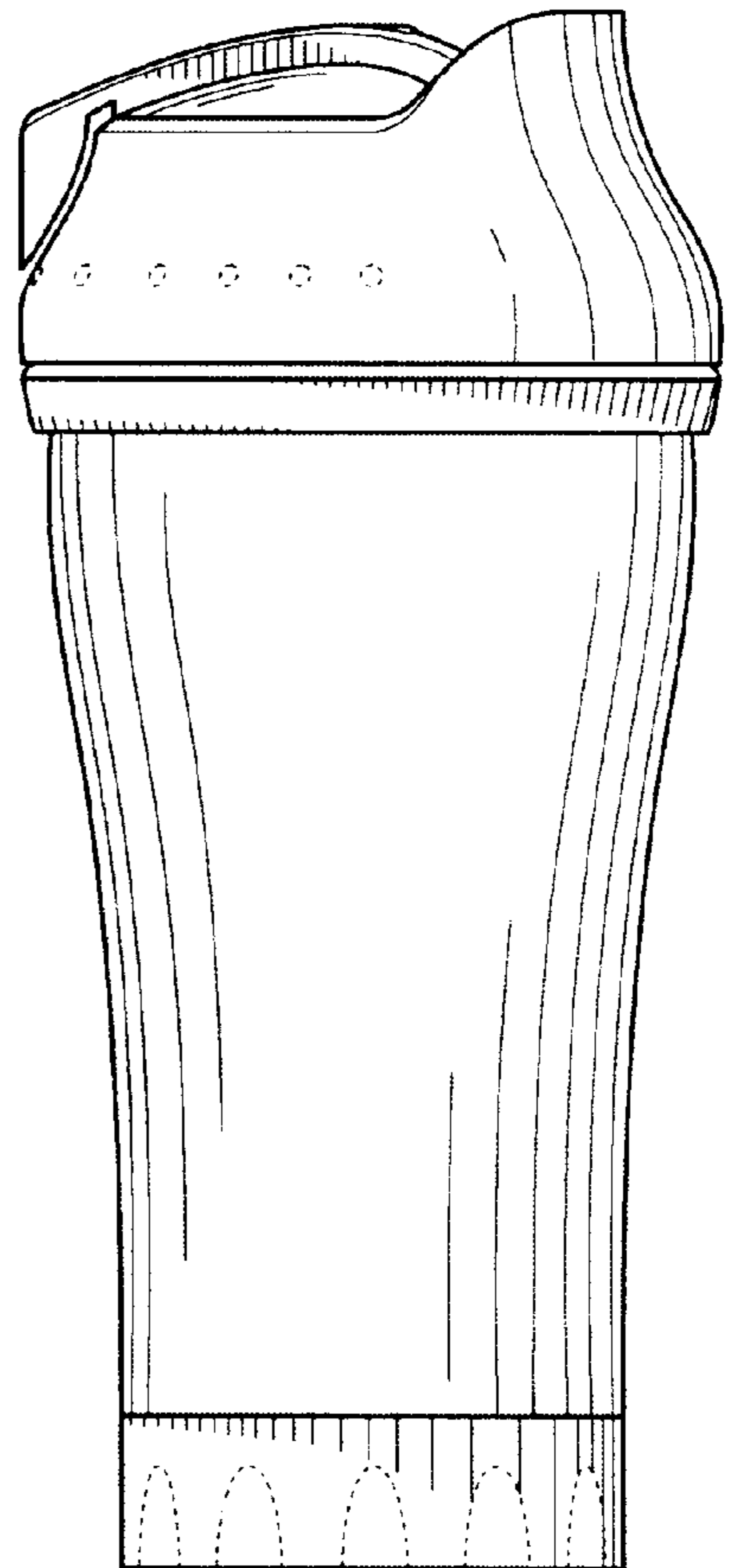




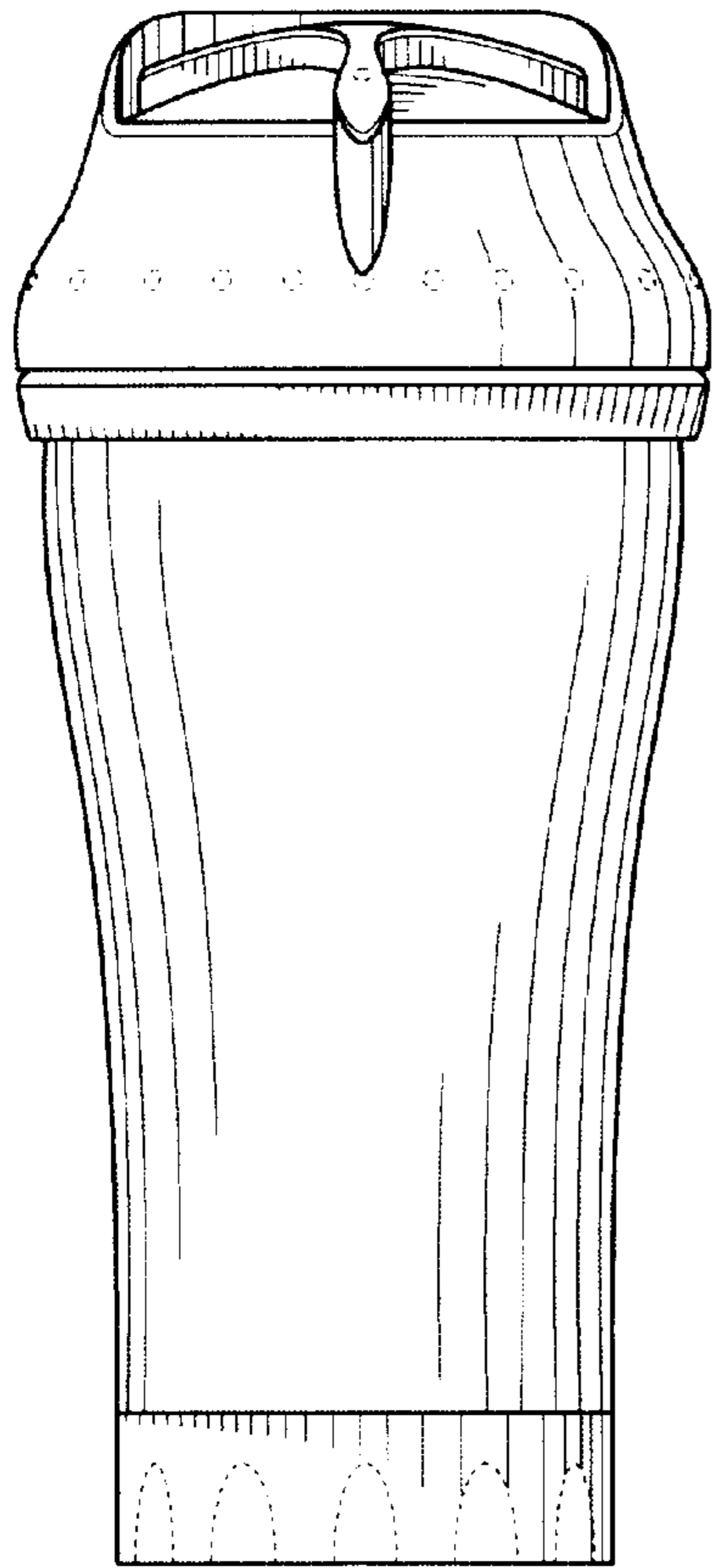

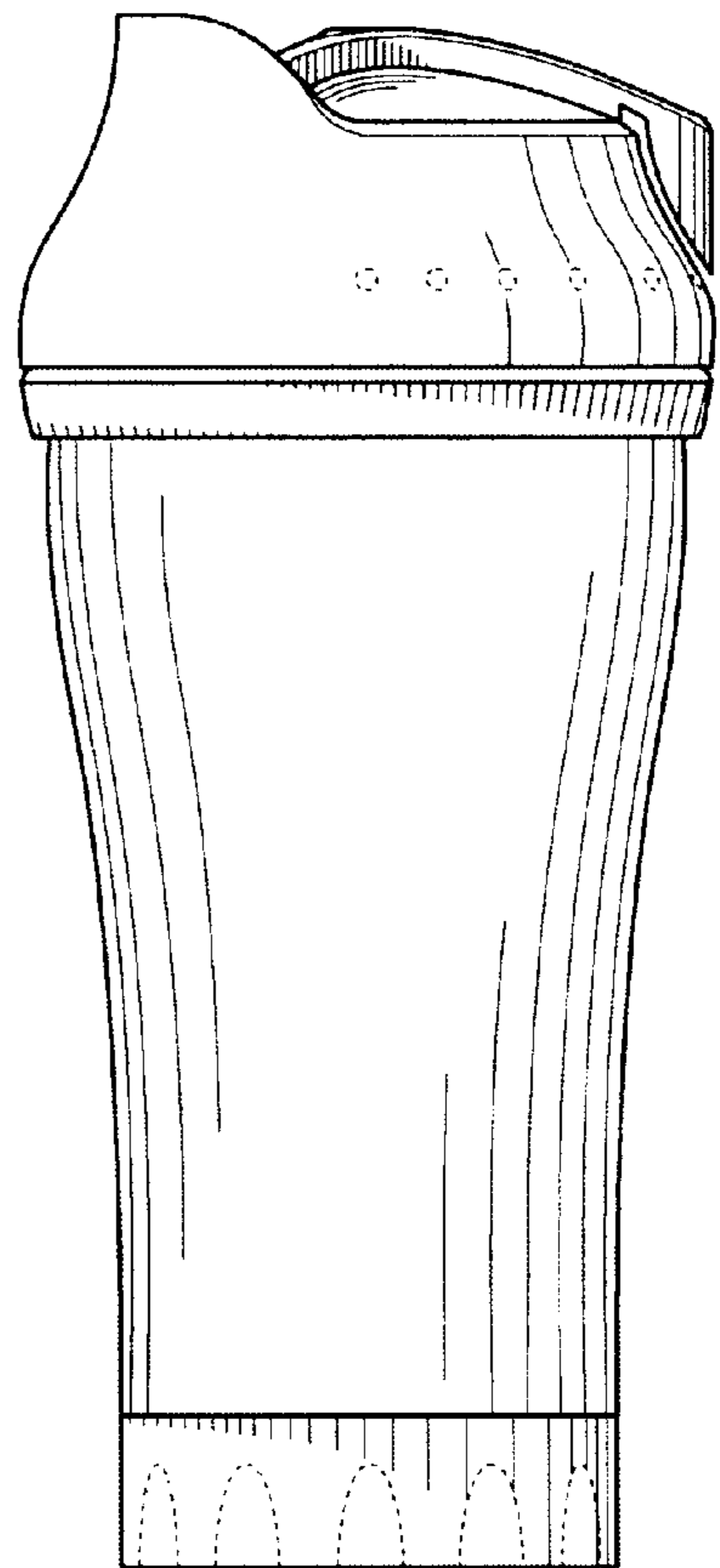

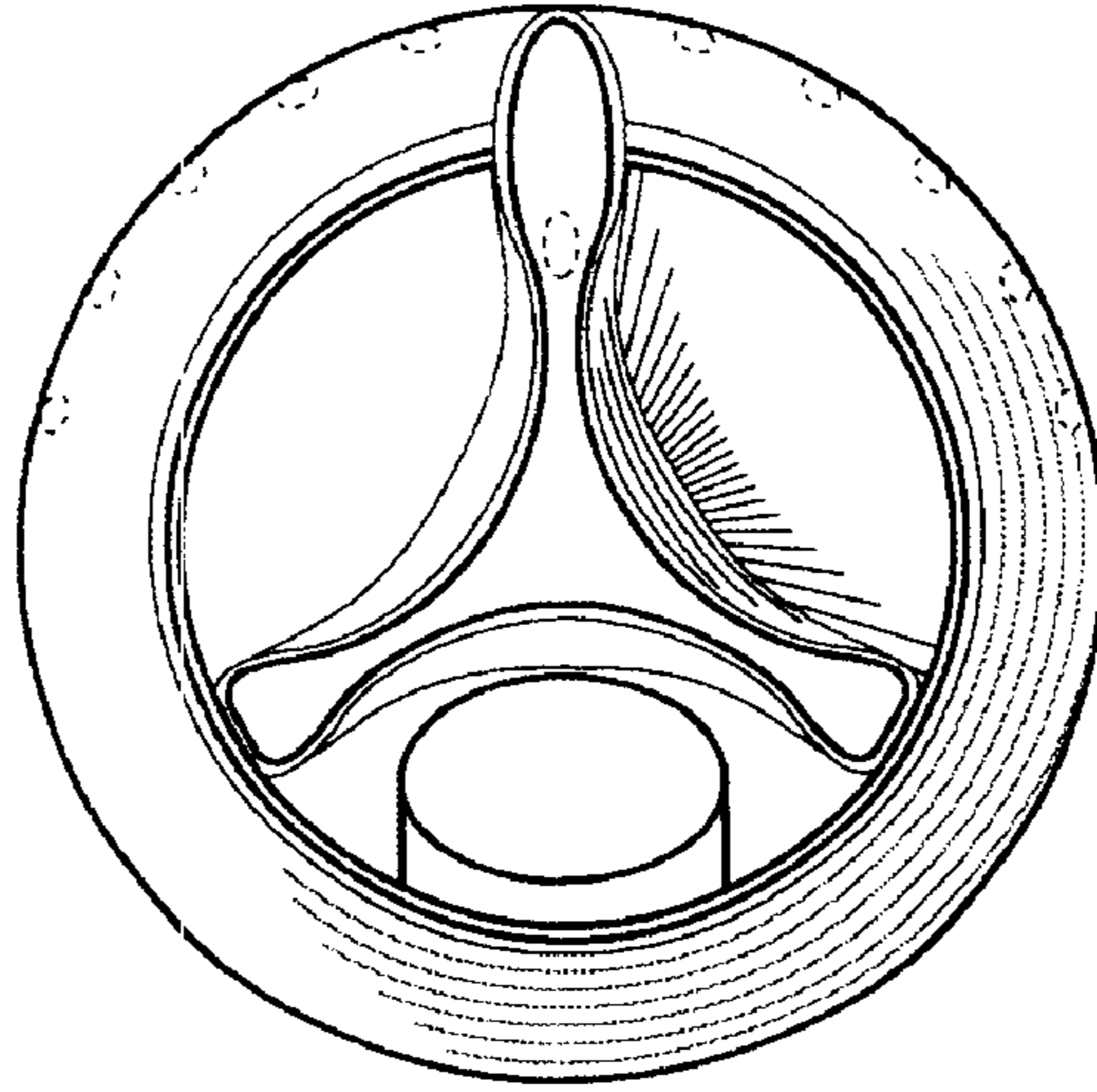

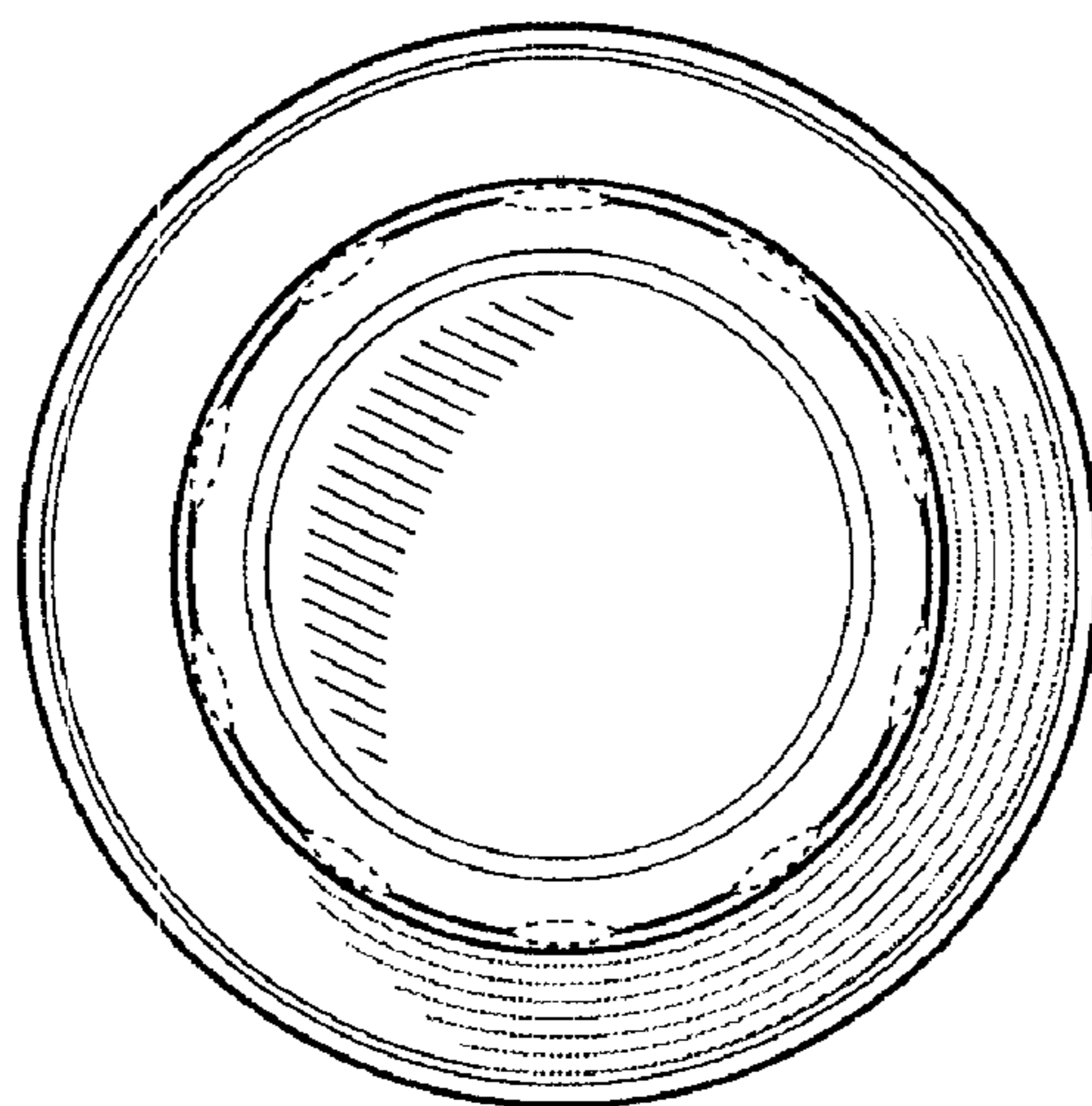
