(57) **CLAIM**

The ornamental design for a heart shaped eyeglass holding rings, as shown and described.

**DESCRIPTION**

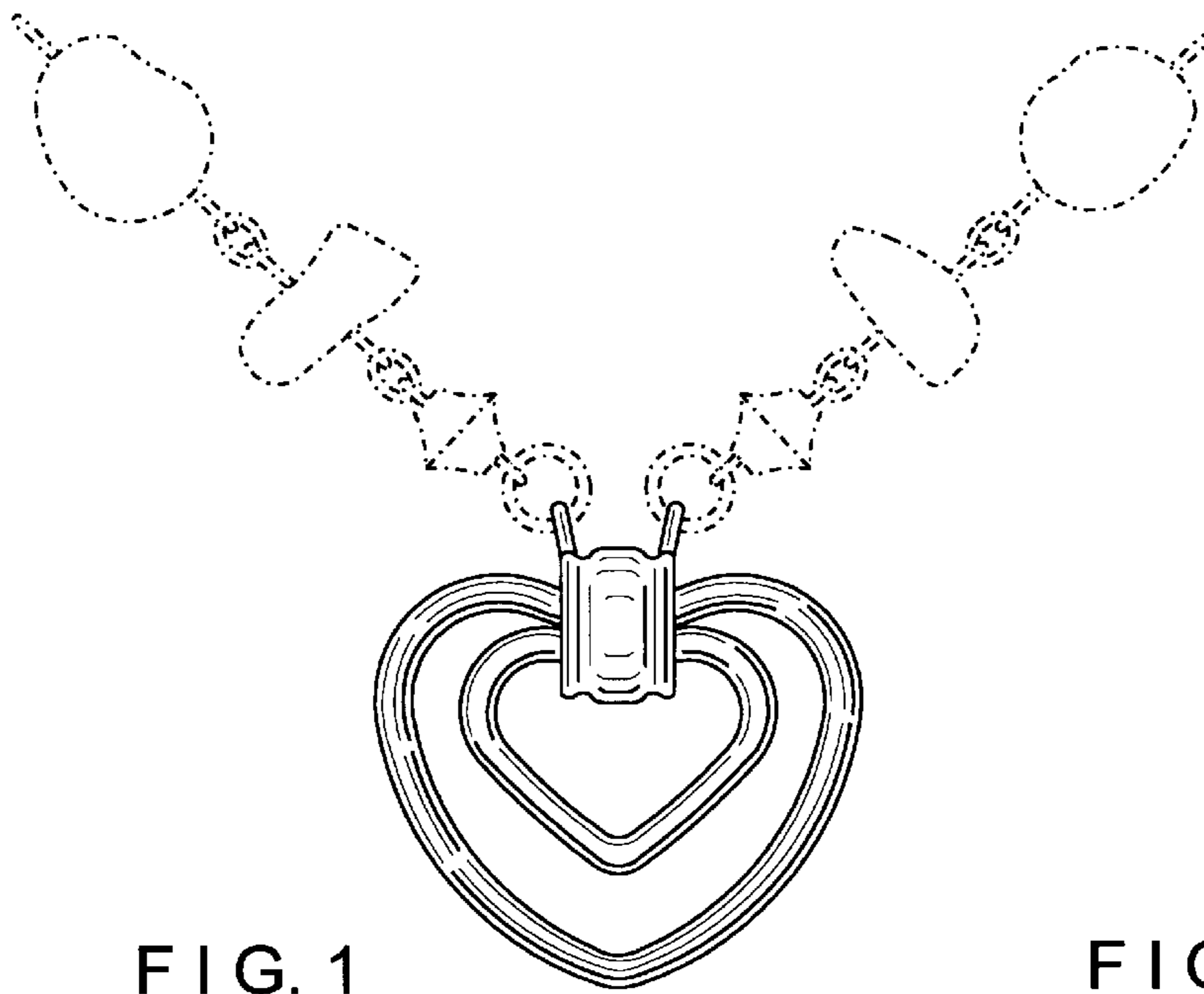

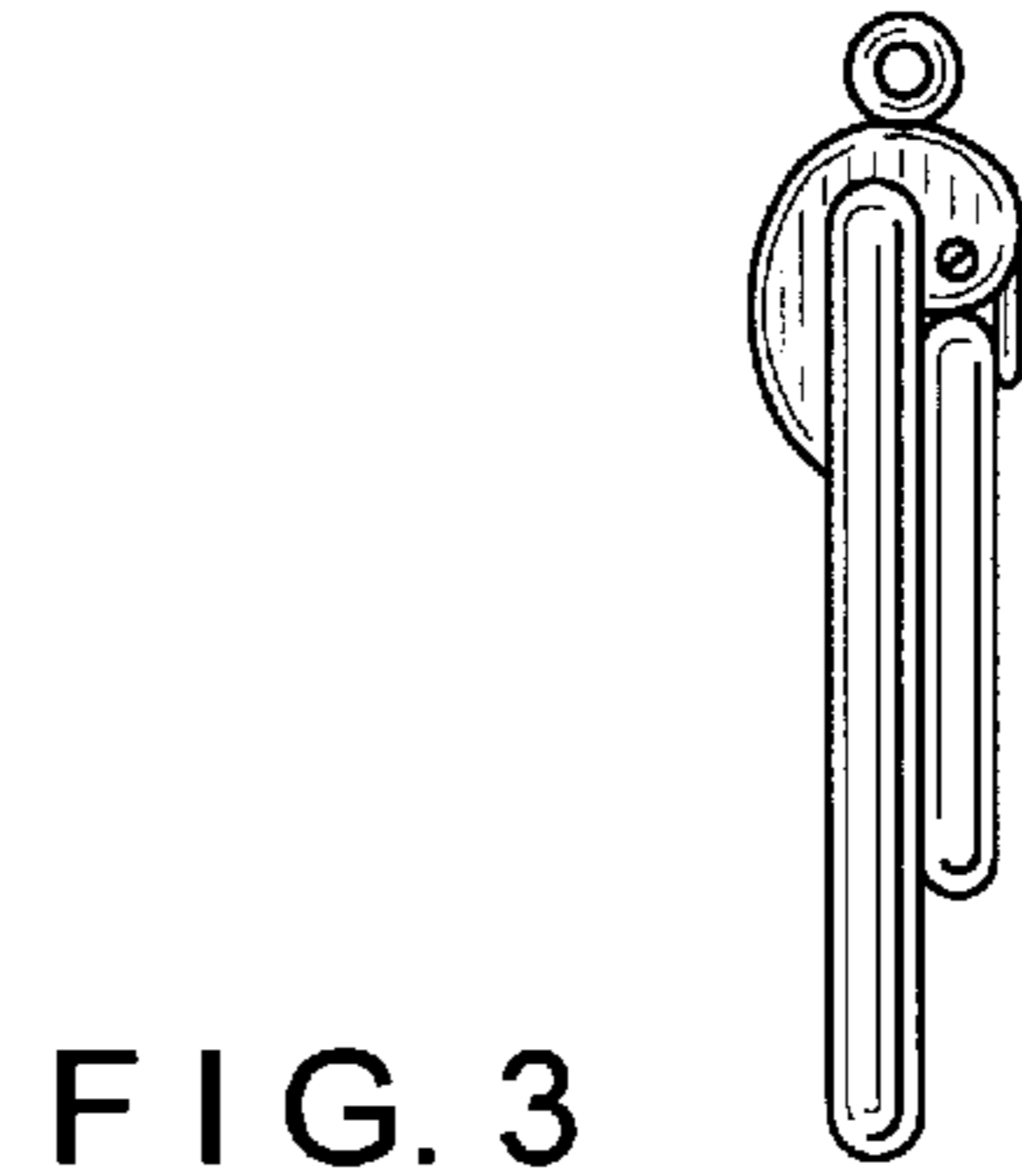

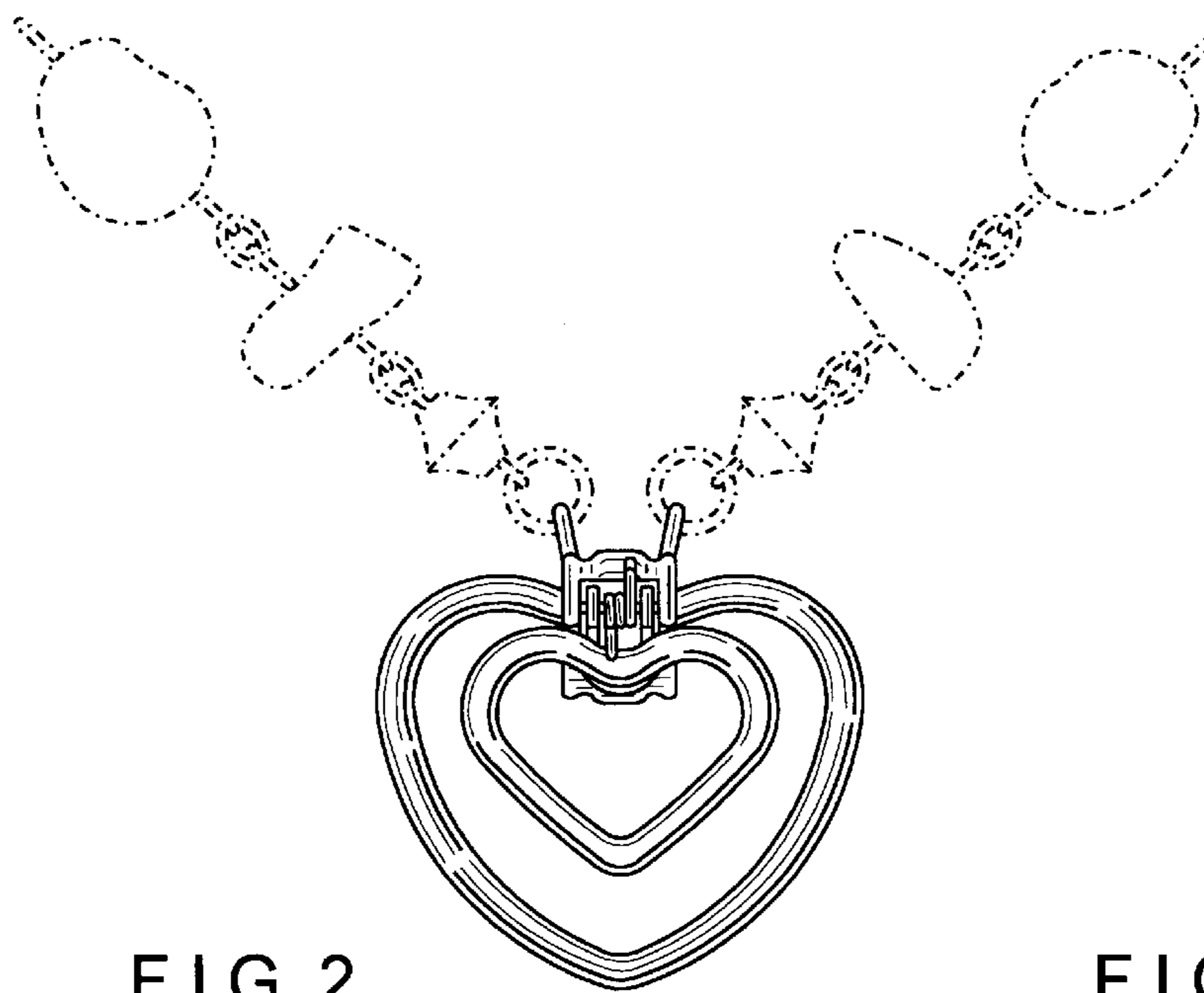

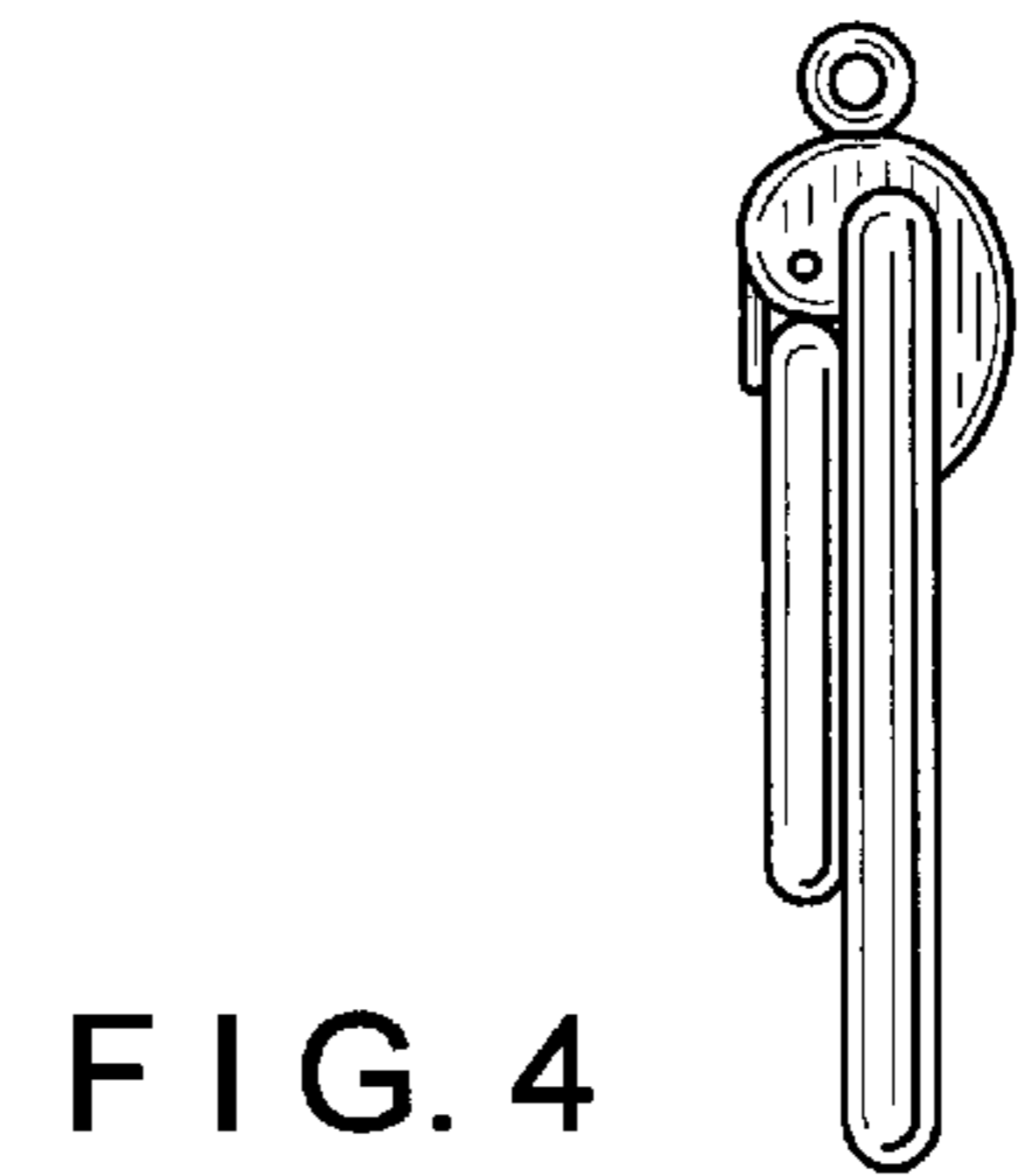

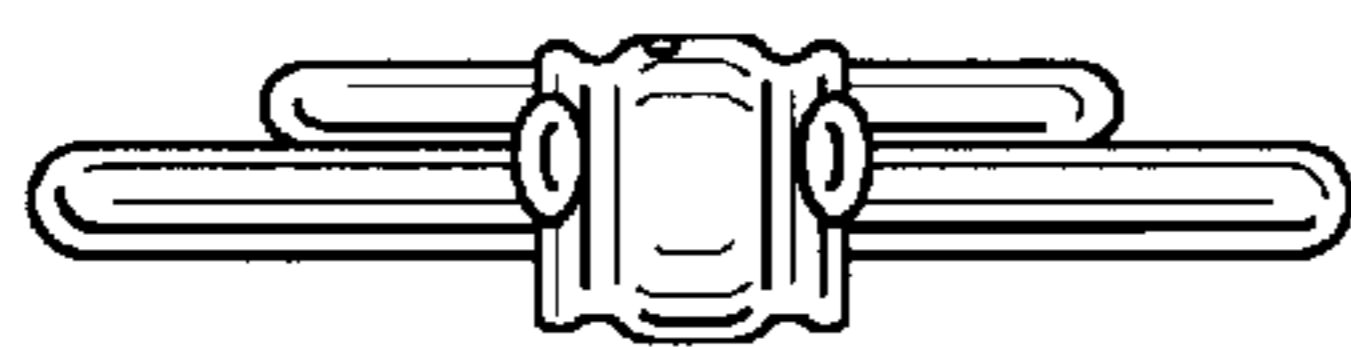

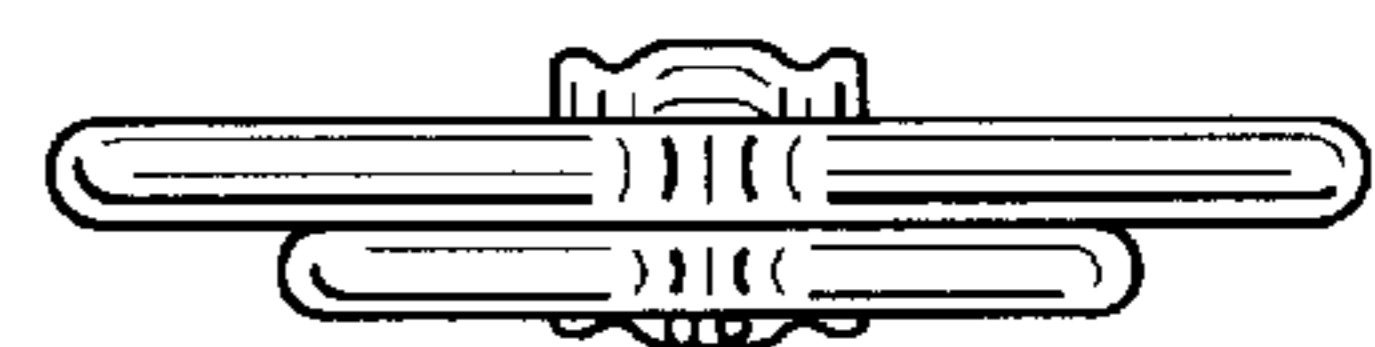
