FIG. 1 is a perspective view of a first embodiment of a tab for a slider of a slide fastener of the claimed design; FIG. 2 is a front elevational view of the tab for a slider of a slide fastener of FIG. 1 and the rear elevational view is the same as the front elevational view; FIG. 3 is a right-side elevational view of the tab for a slider of a slide fastener of FIG. 1. and the left-side elevational view is symmetrical to the right-side elevational view; FIG. 4 is a top plan view of the tab for a slider of a slide fastener of FIG. 1; FIG. 5 is a bottom plan view of the tab for a slider of a slide fastener of FIG. 1; FIG. 6 is a perspective view of a second embodiment of a tab for a slider of a slide fastener of the claimed design; FIG. 7 is a front elevational view of the tab for a slider of a slide fastener of FIG. 6 and the rear elevational view is the same as the front elevational view; FIG. 8 is a right-side elevational view of the tab for a slider of a slide fastener of FIG. 6 and the left-side elevational view is symmetrical to the right-side elevational view; FIG. 9 is a top plan view of the tab for a slider of a slide fastener of FIG. 6; and, FIG. 10 is a bottom plan view of the tab for a slider of a slide fastener of FIG. 6.

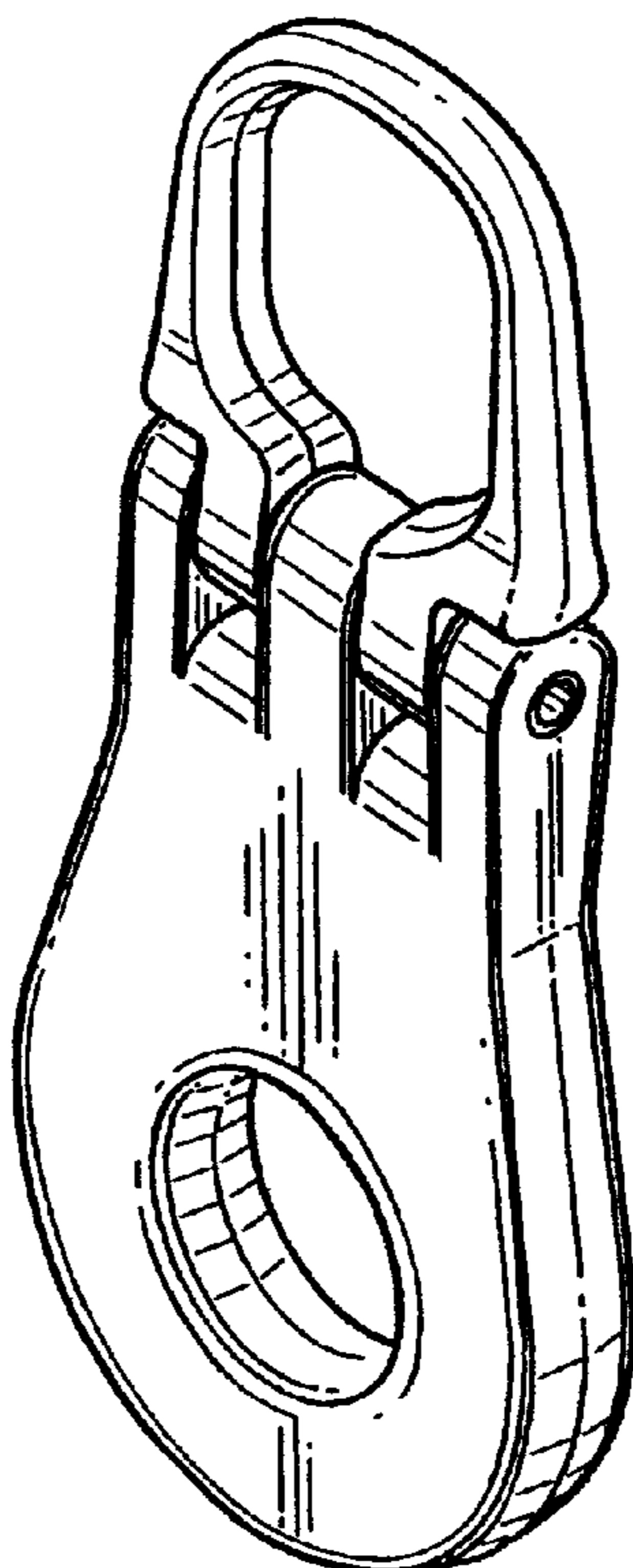

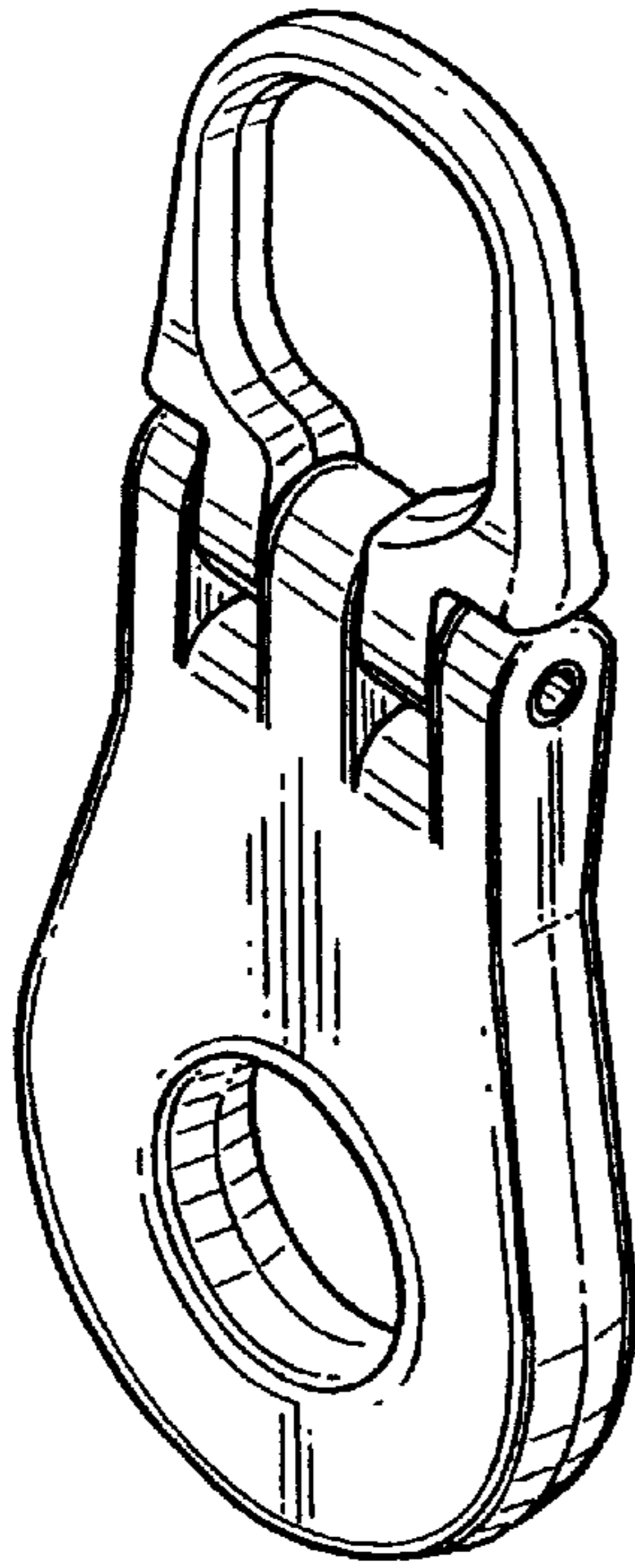

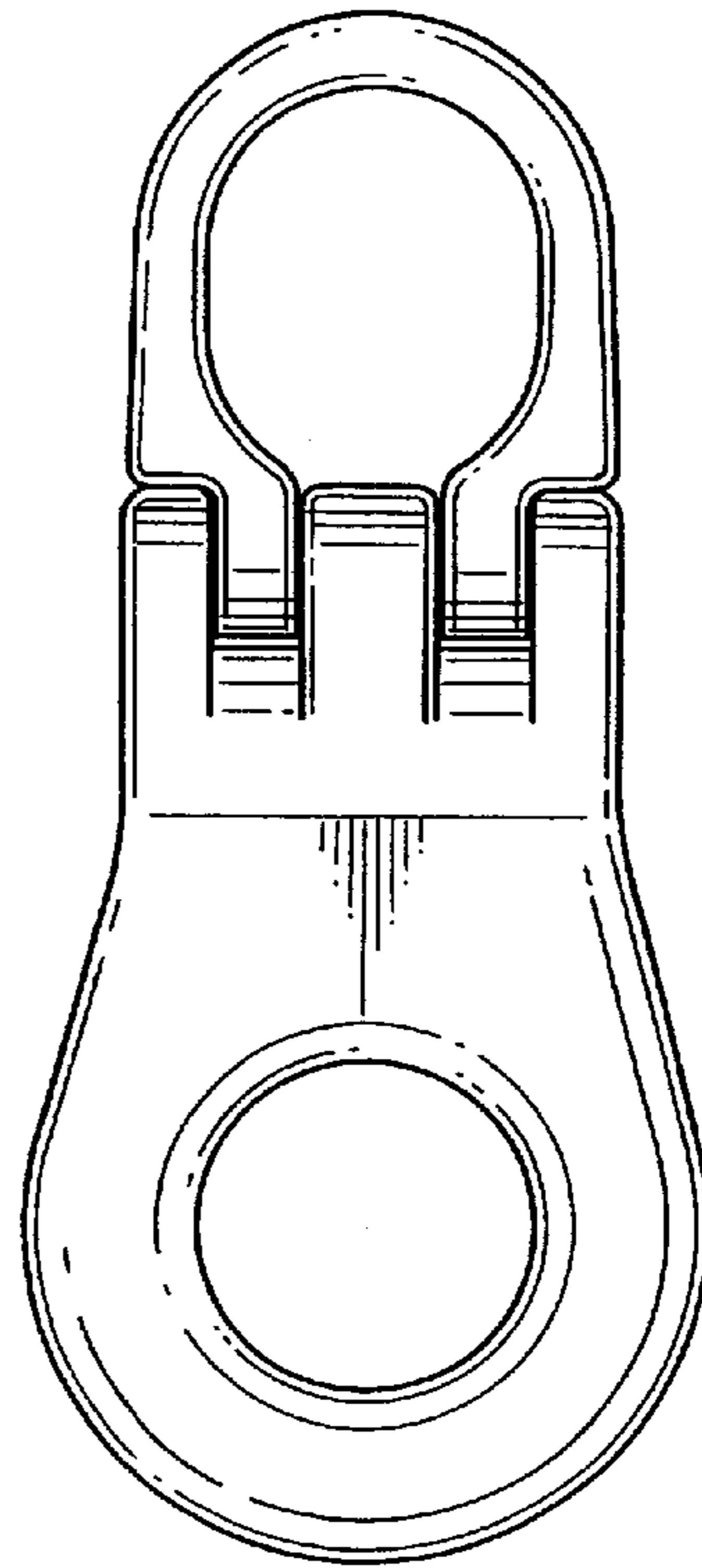

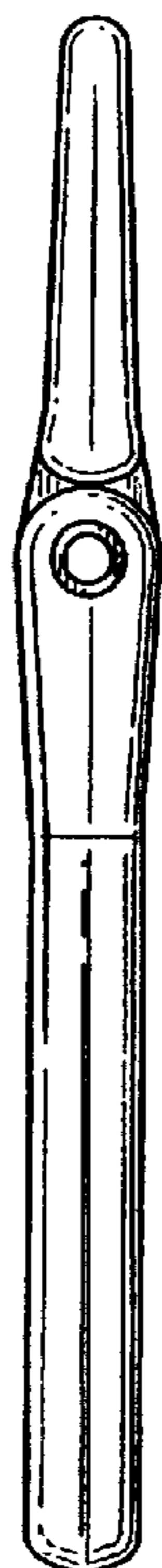

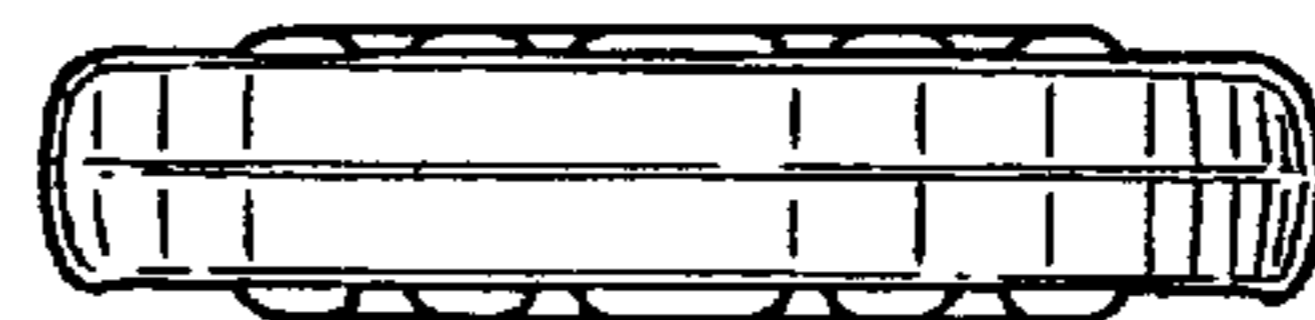

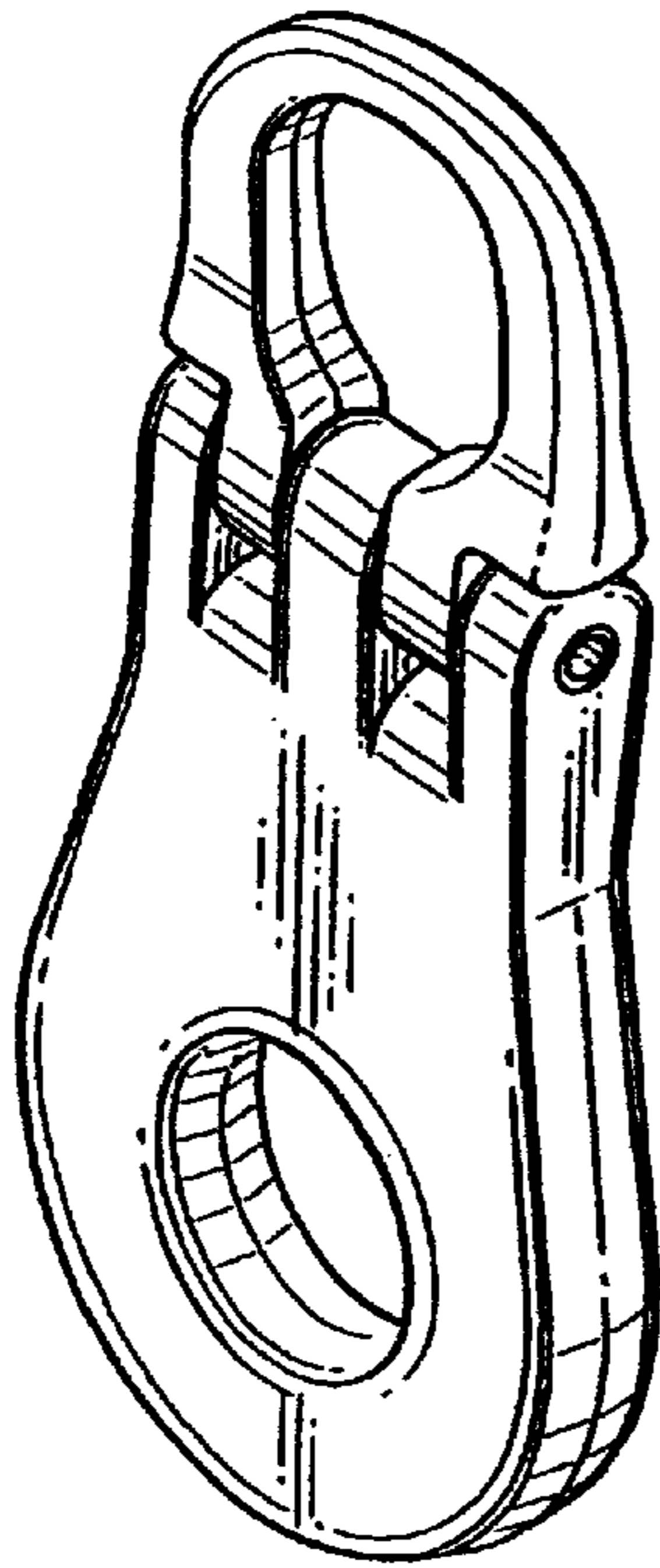

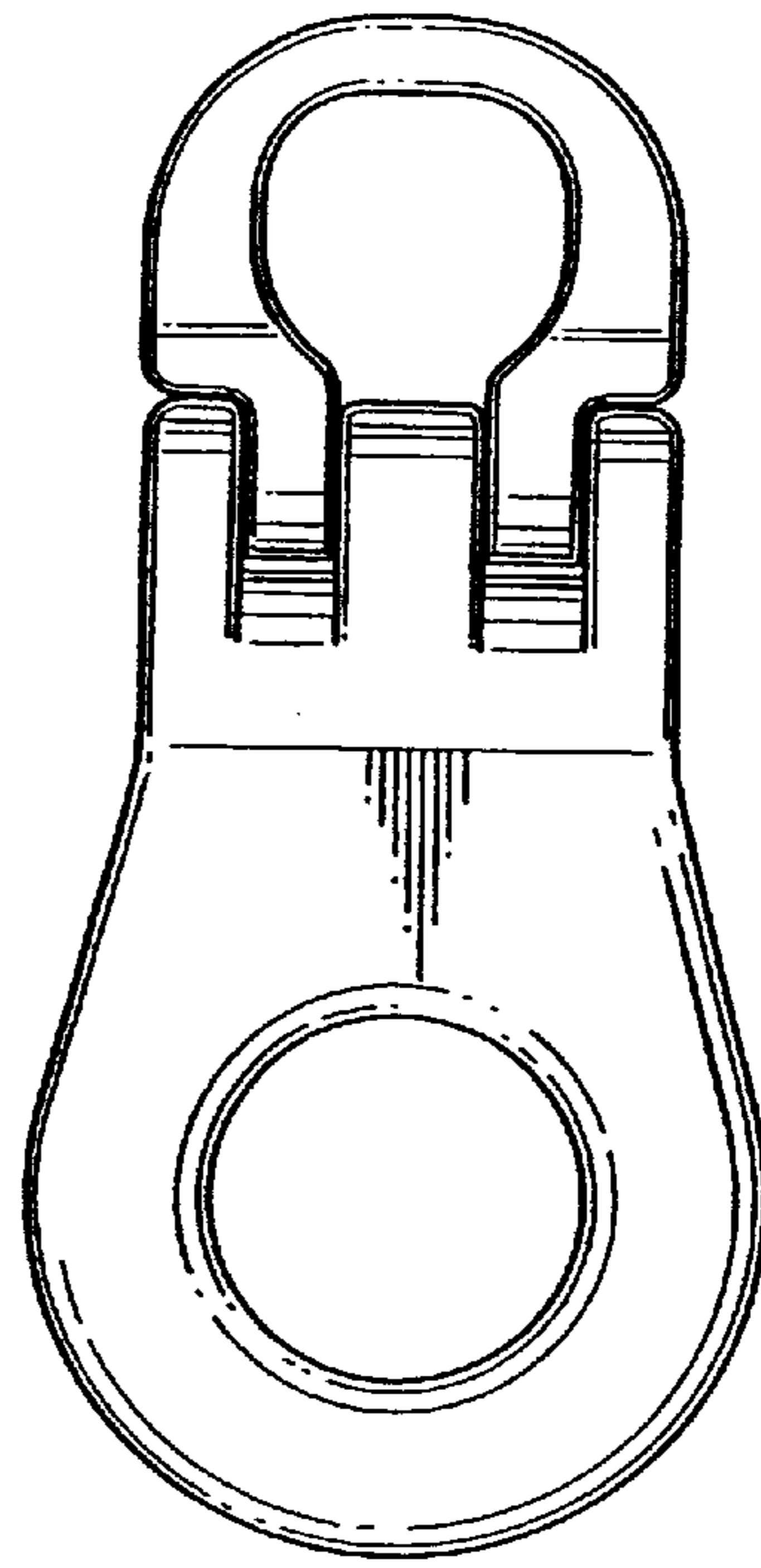
