(57) **CLAIM**

The ornamental design for a “storage battery,” as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a storage battery;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a right side view thereof, the left side being identical thereto;  
 FIG. 6 is a section 6—6 view of FIG. 1 with an illustration of an internal structure omitted; and,  
 FIG. 7 is a section 7—7 view of FIG. 1 with an illustration of an internal structure omitted.

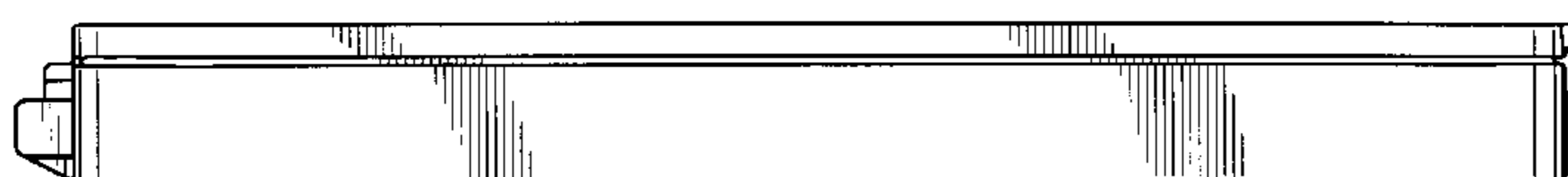
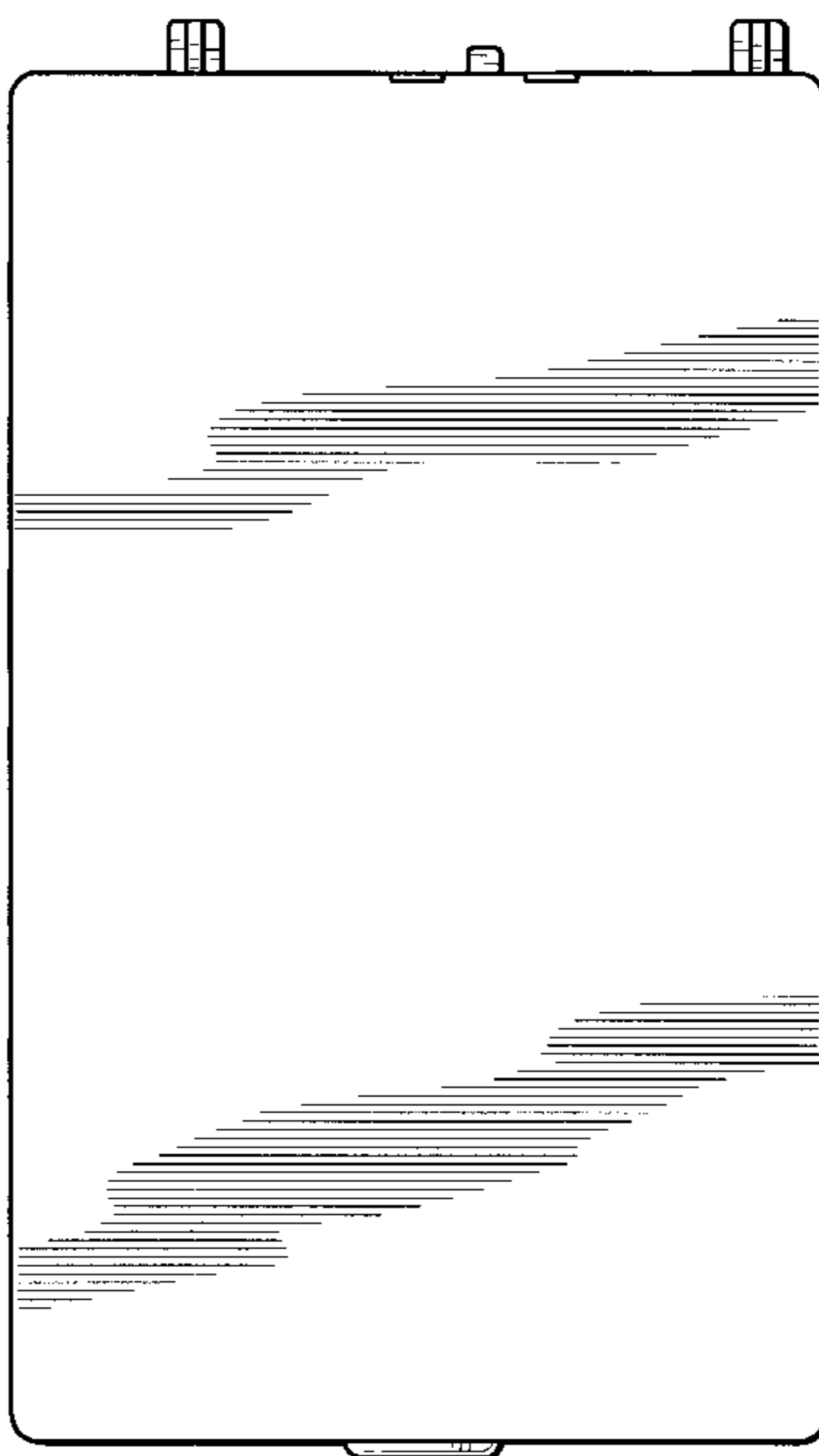

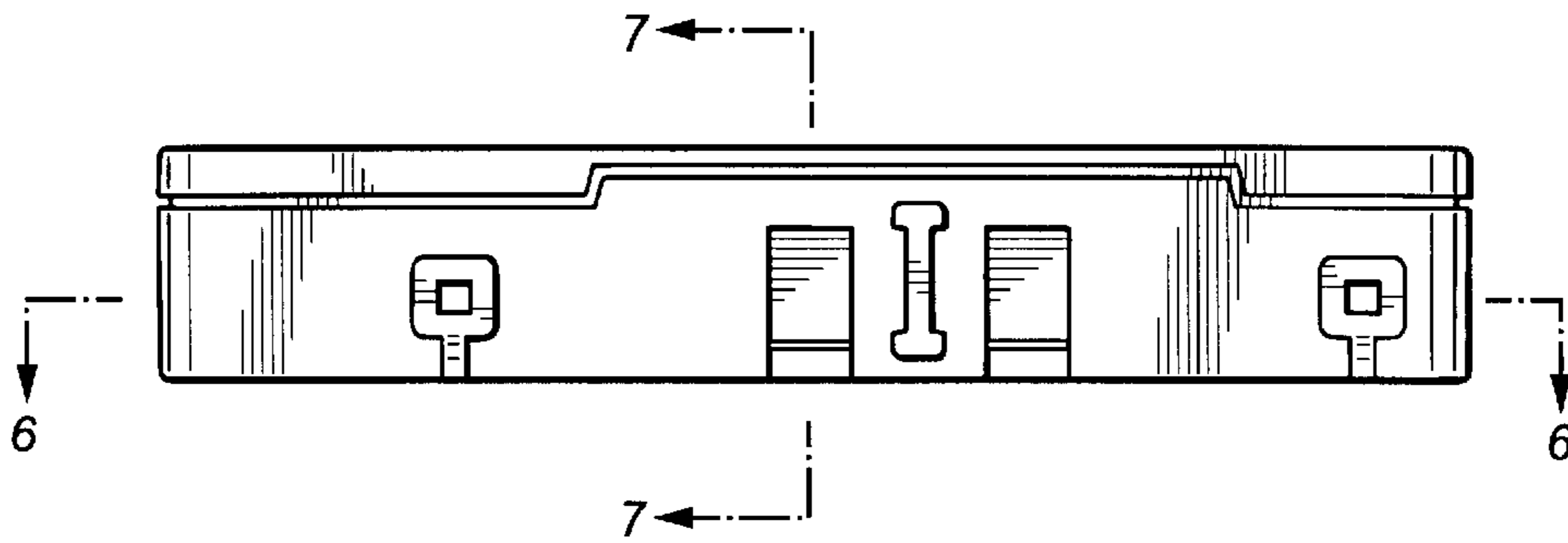
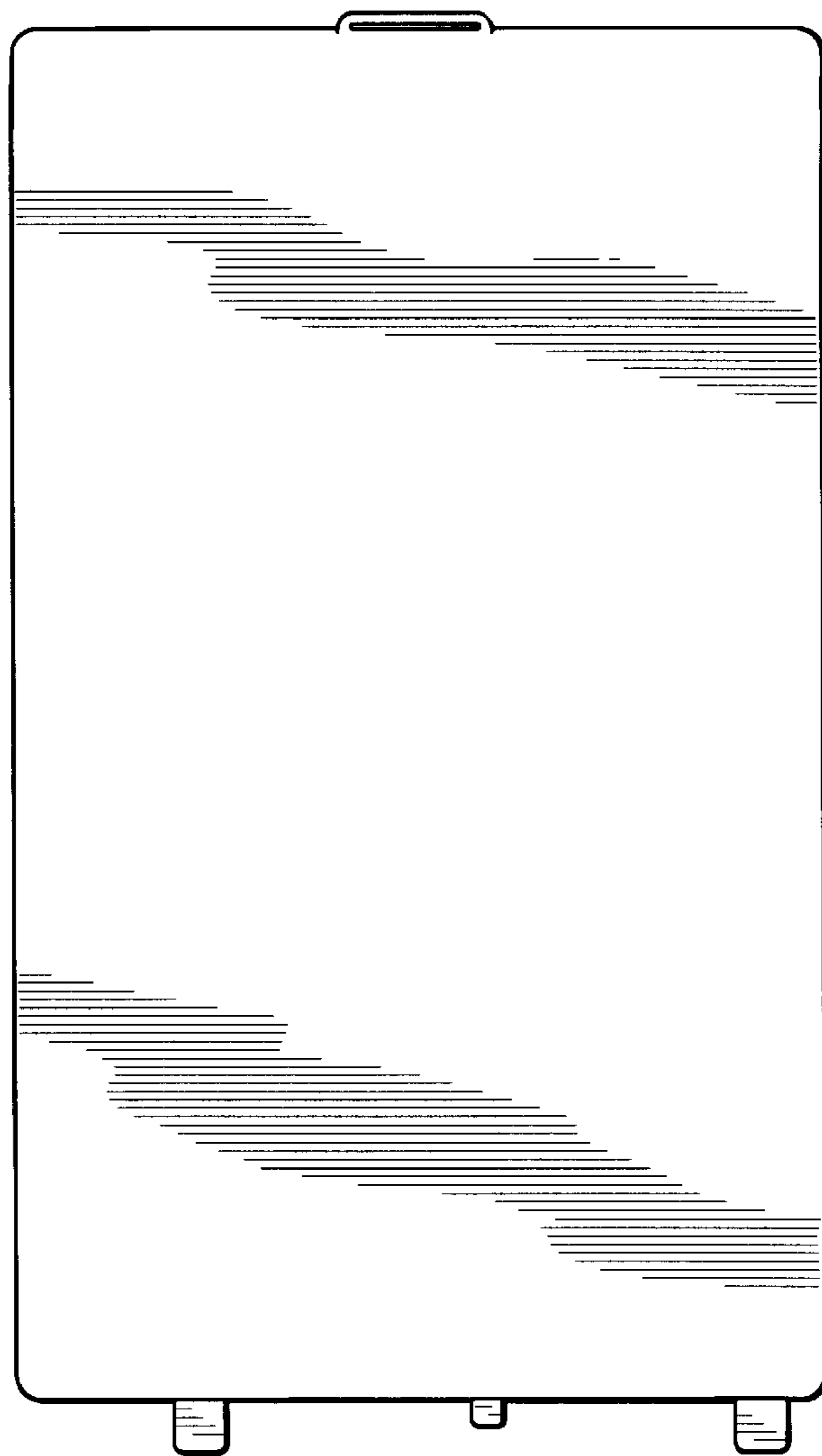
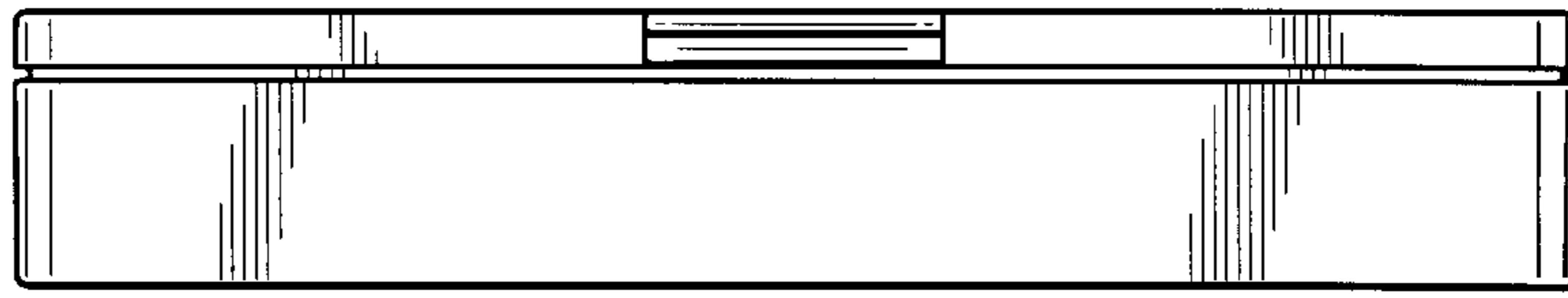


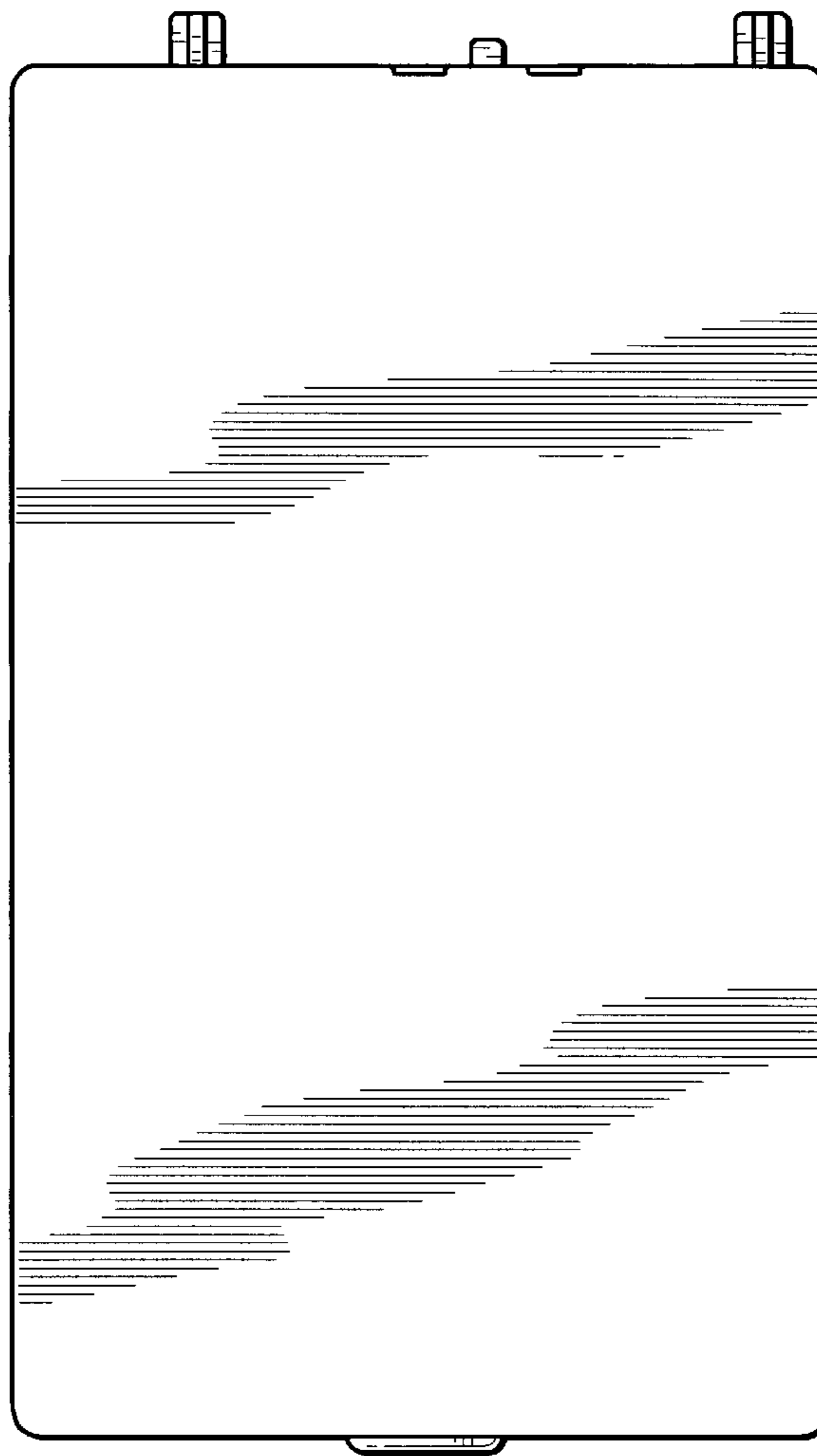

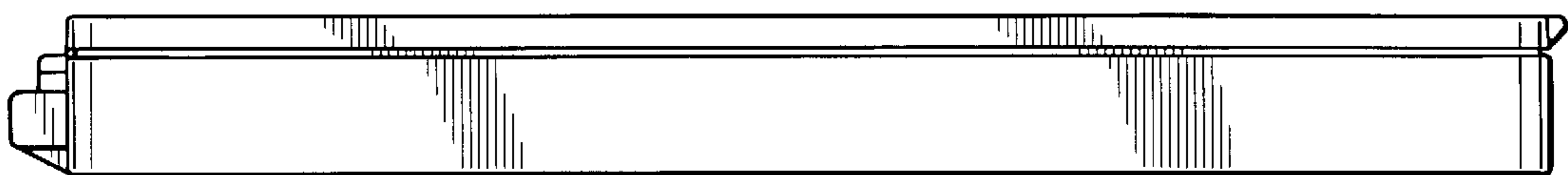

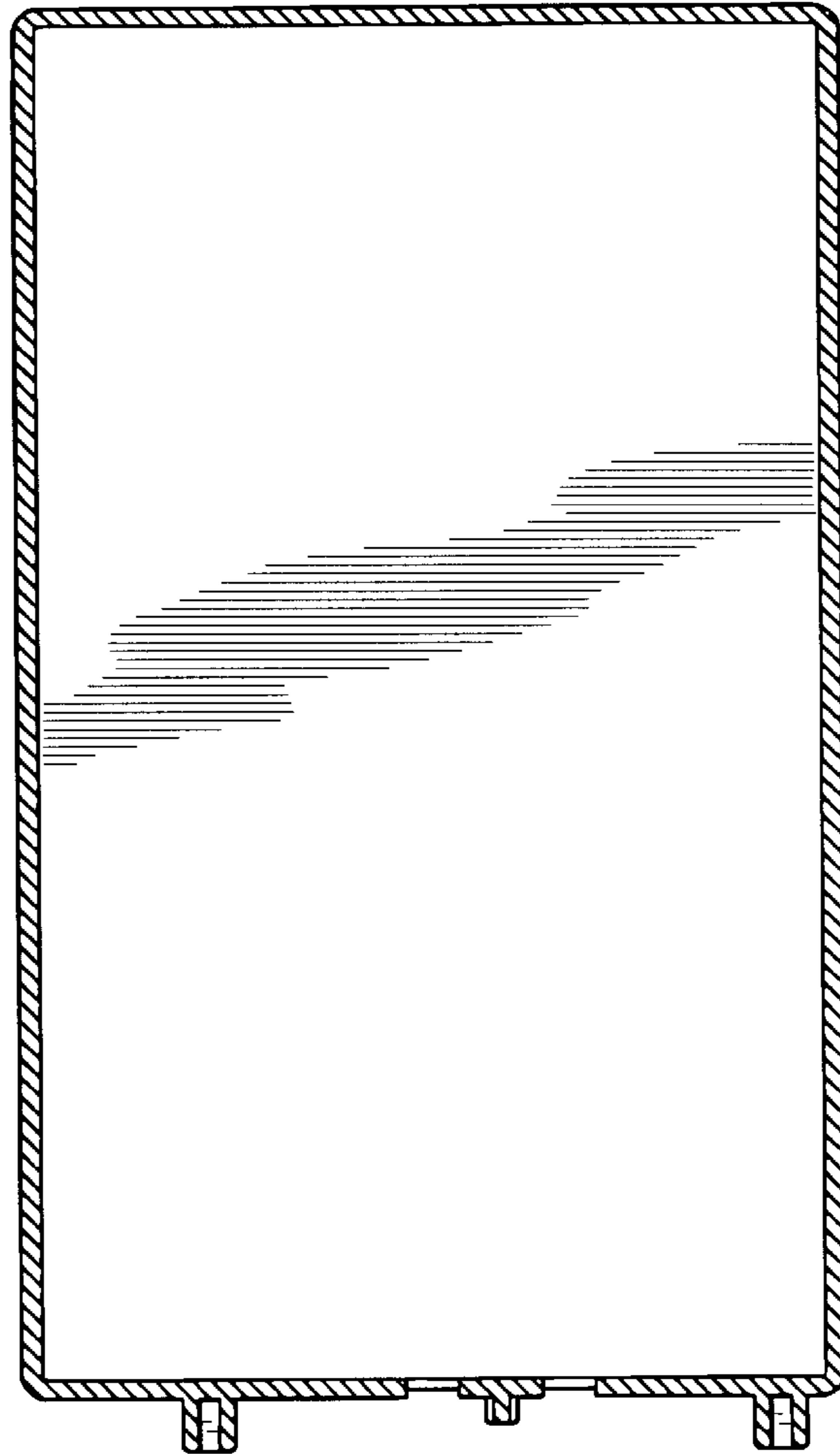
