(57) **CLAIM**

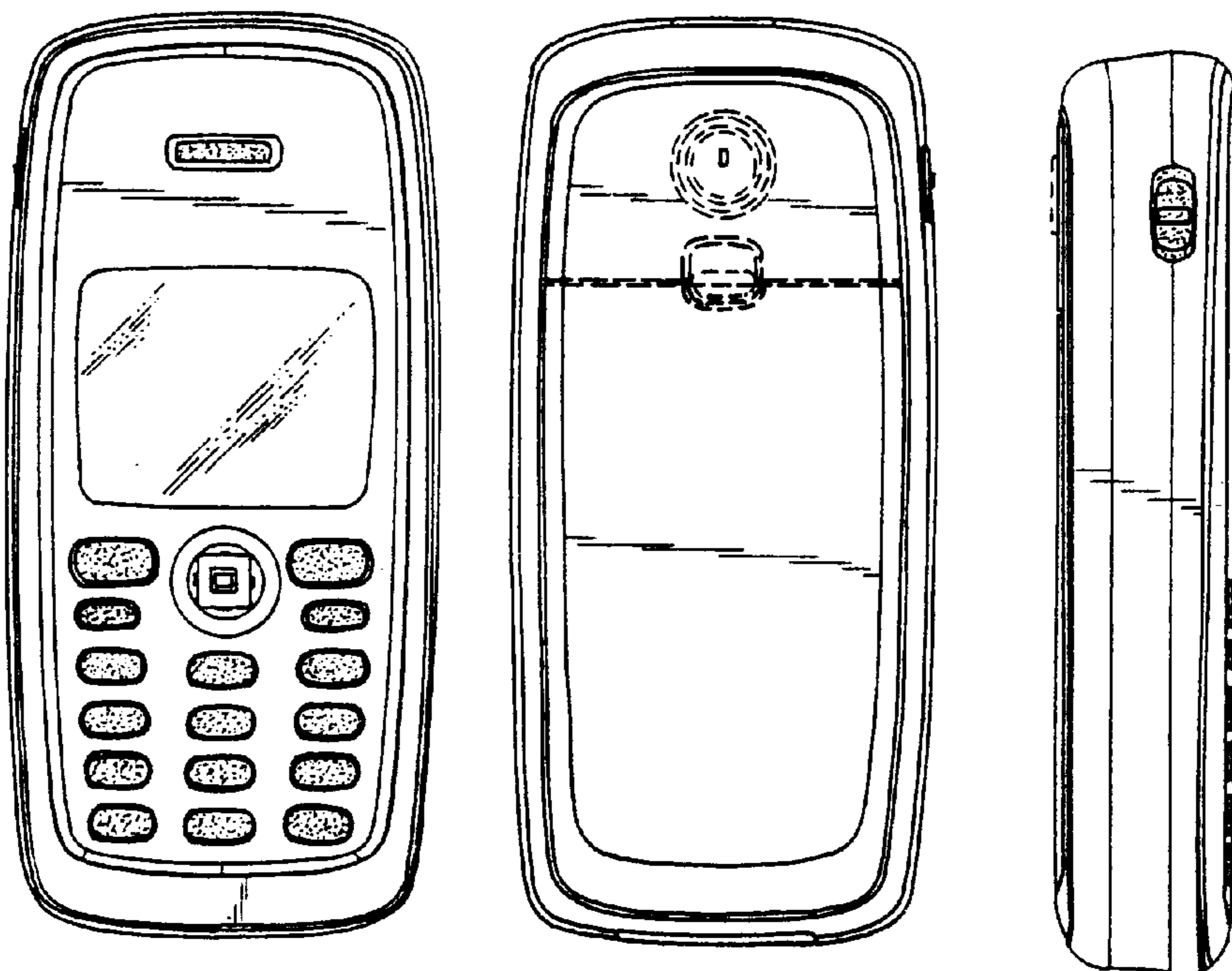
The ornamental design for a mobile communication device, as shown and described.

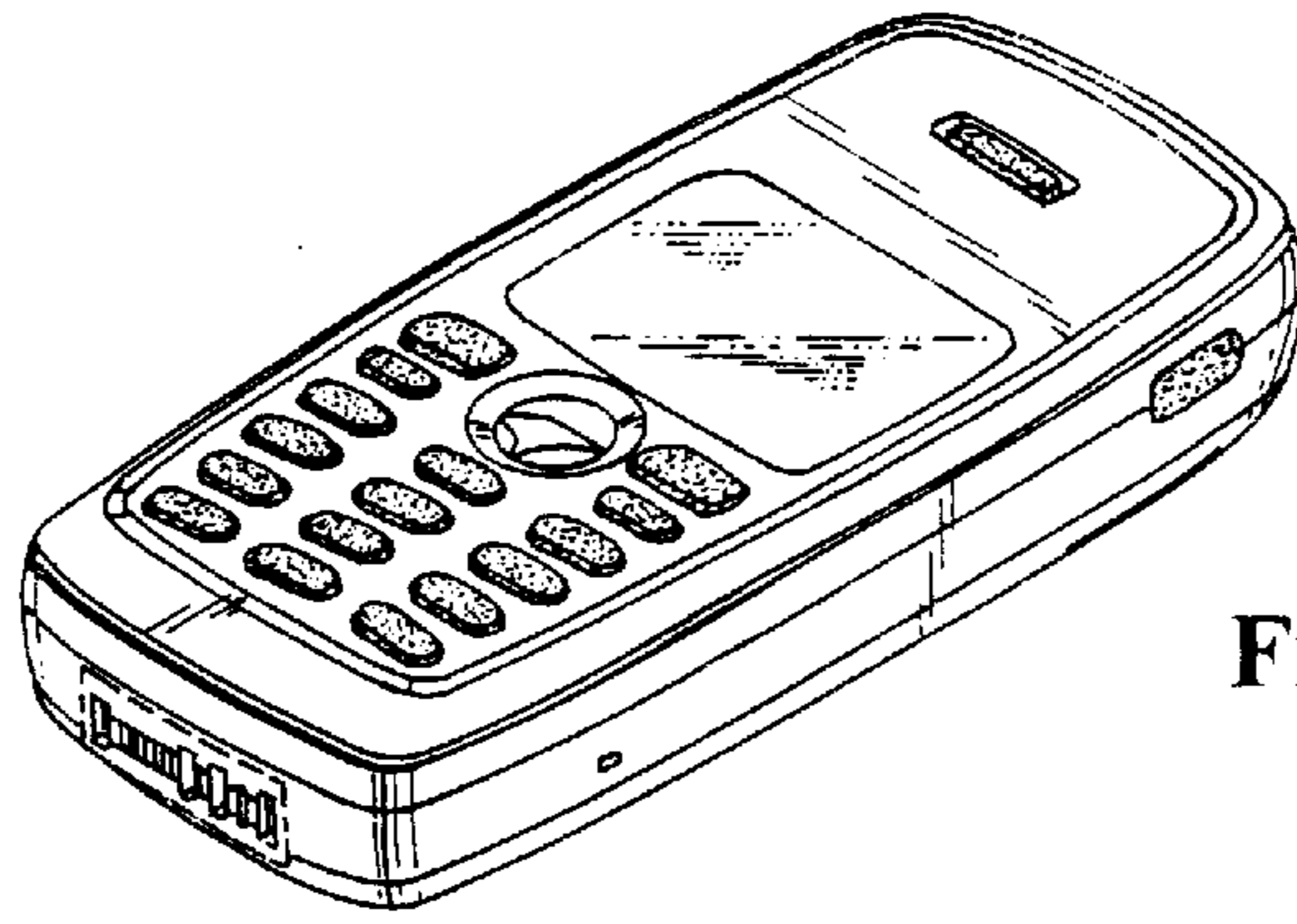

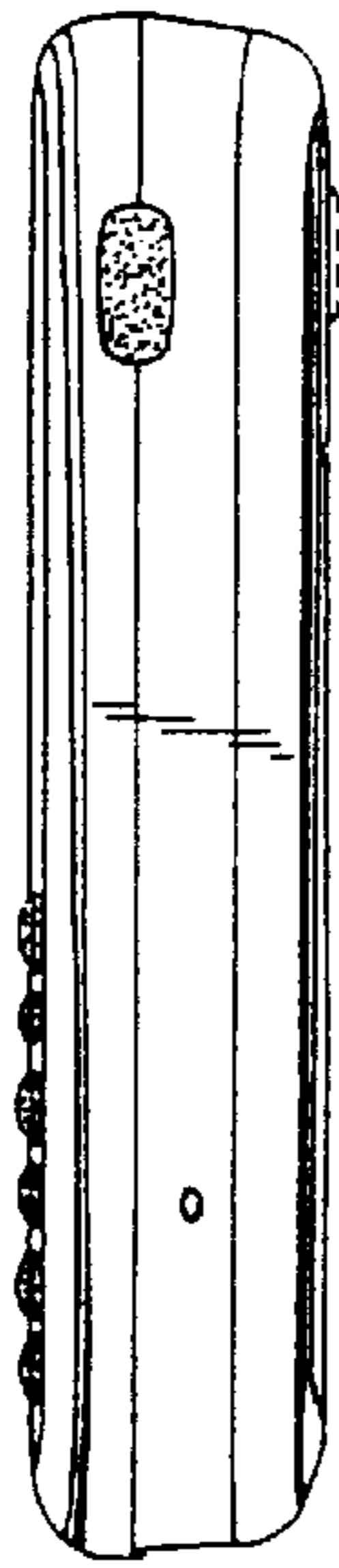

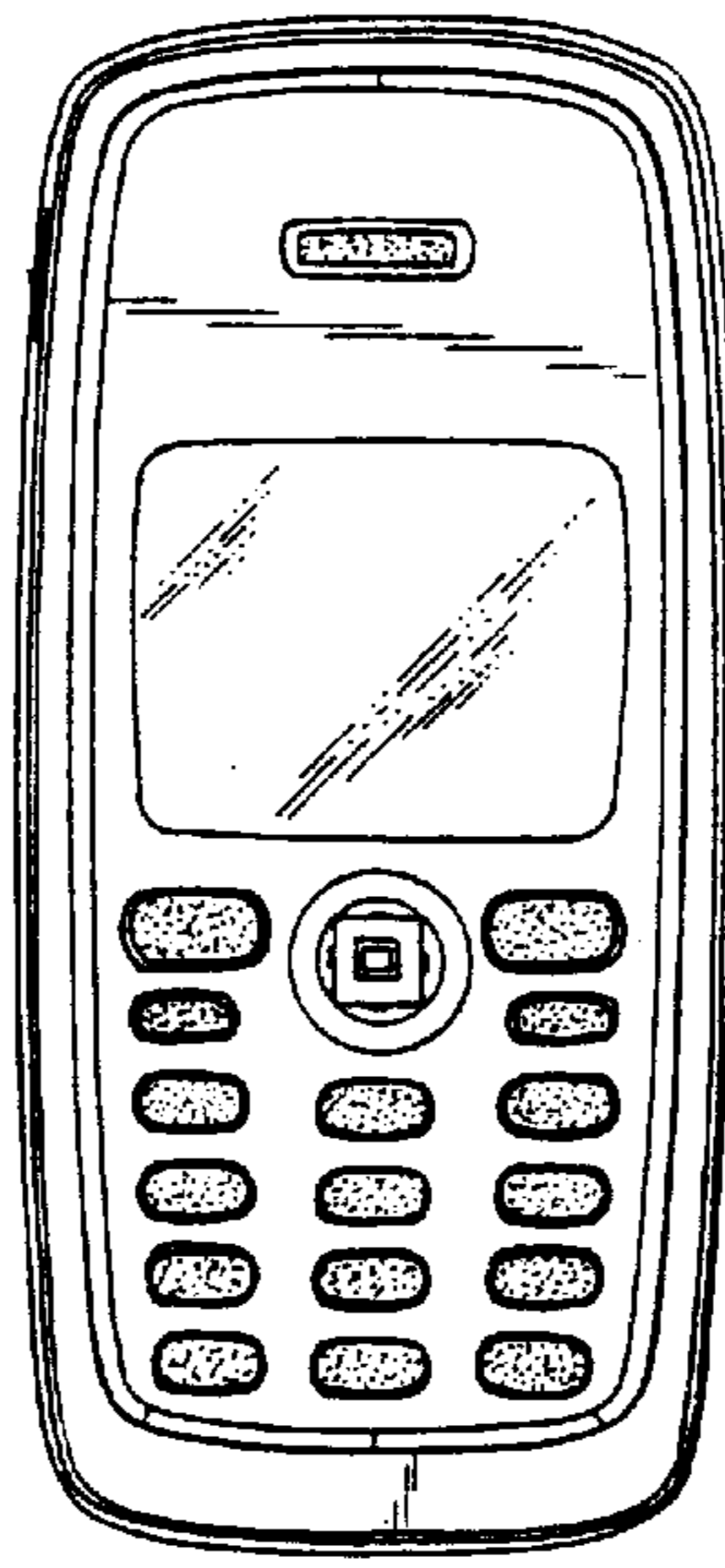

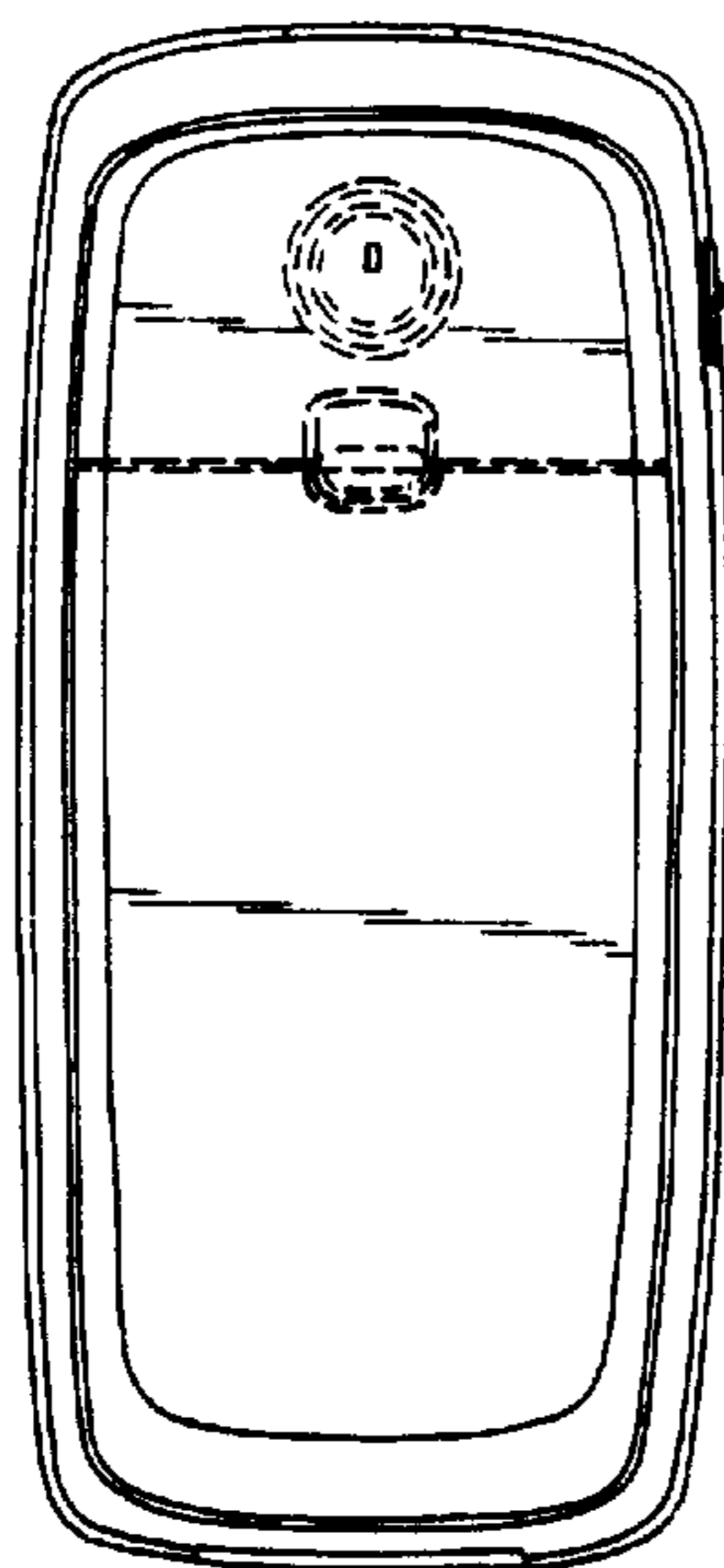

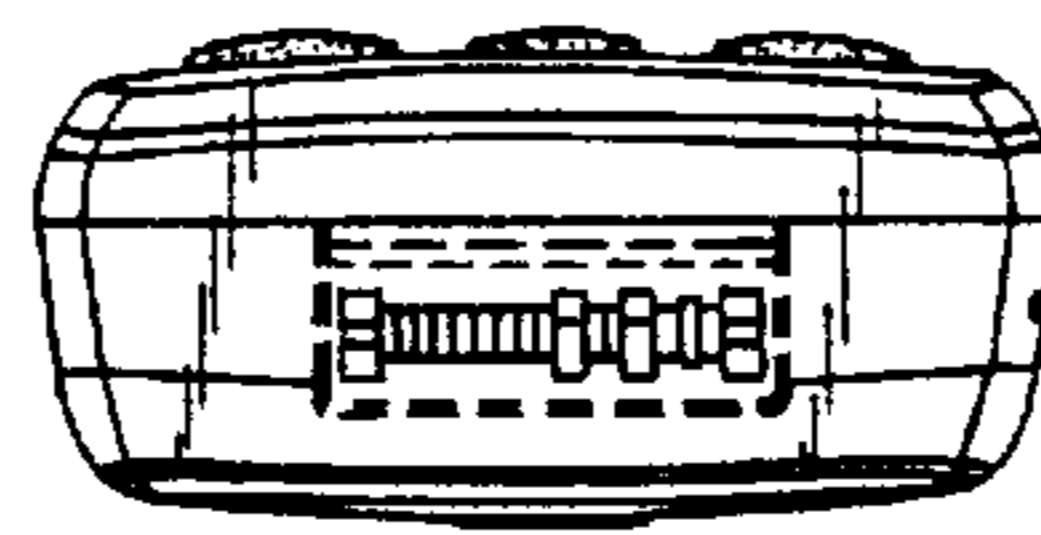

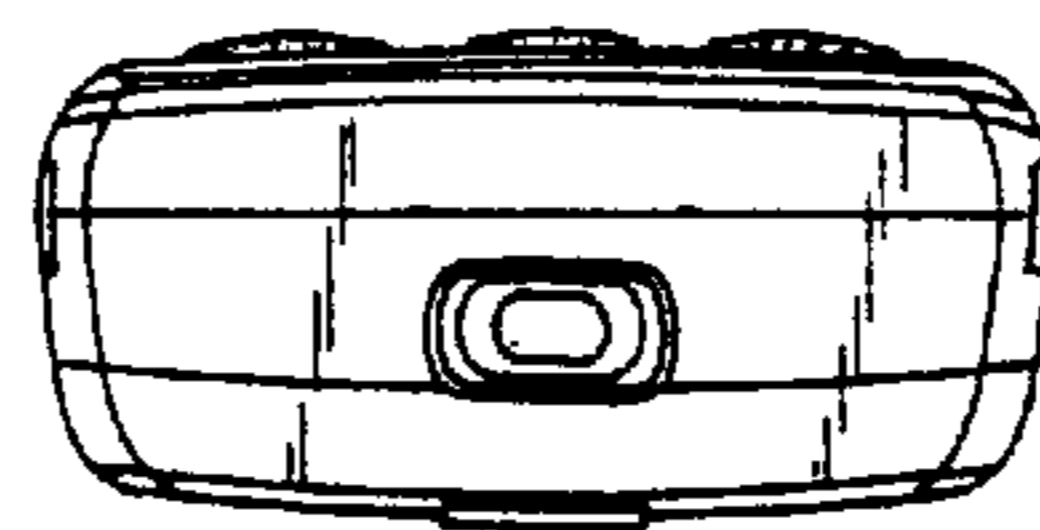
