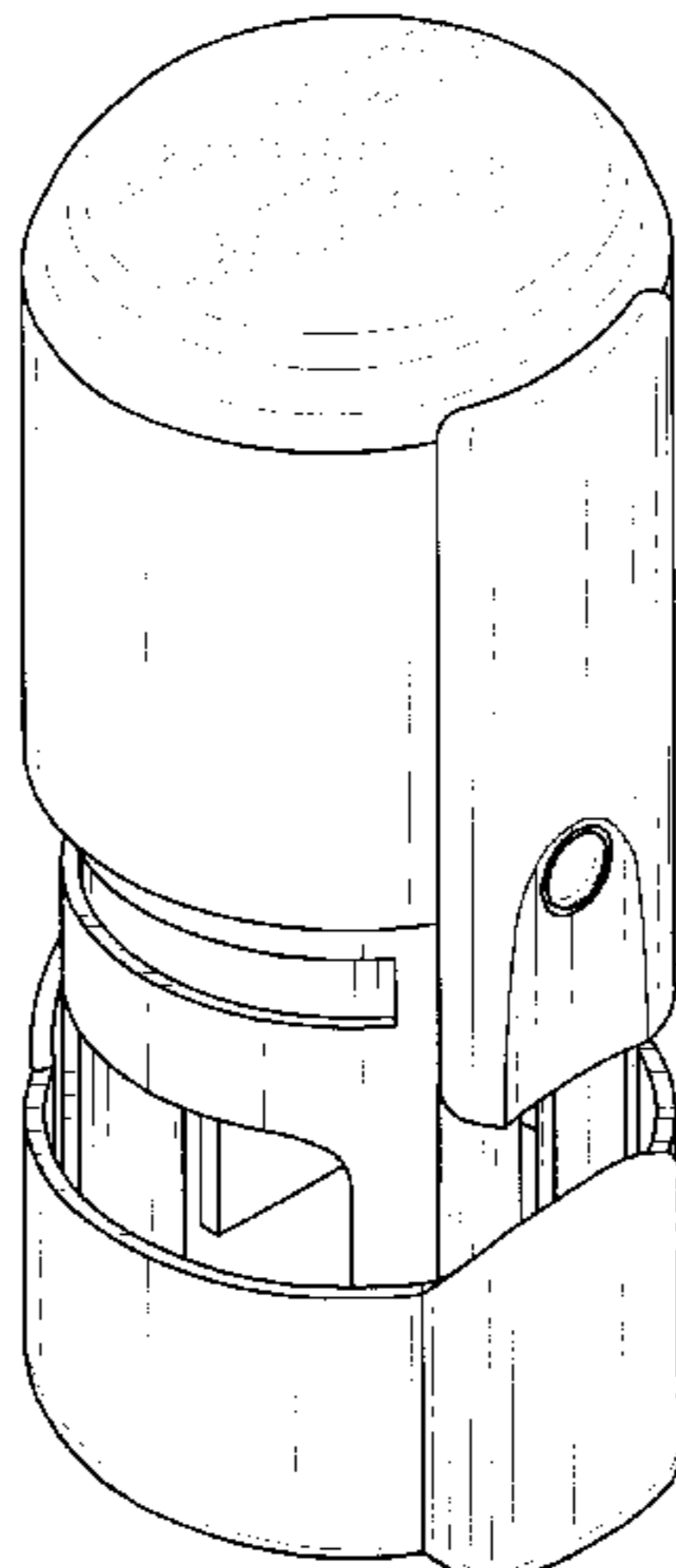
(57) **CLAIM**

The ornamental design for hand stamp and storage cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the subject hand stamp and storage cap in a locked position; FIG. 2 is a front plan view thereof; FIG. 3 is a right side view thereof (the left side view being a mirror image of the right side view) thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is bottom plan view thereof; FIG. 7 is a perspective view of the subject hand stamp and storage cap in an unlocked position; FIG. 8 is a front plan view of the unlocked hand stamp and storage cap shown in FIG. 7; FIG. 9 is a right side view (the left side being a mirror image of the right side view) of the unlocked hand stamp and storage cap shown in FIG. 7; and, FIG. 10 is a rear view of the unlocked hand stamp and storage cap shown in FIG. 7.

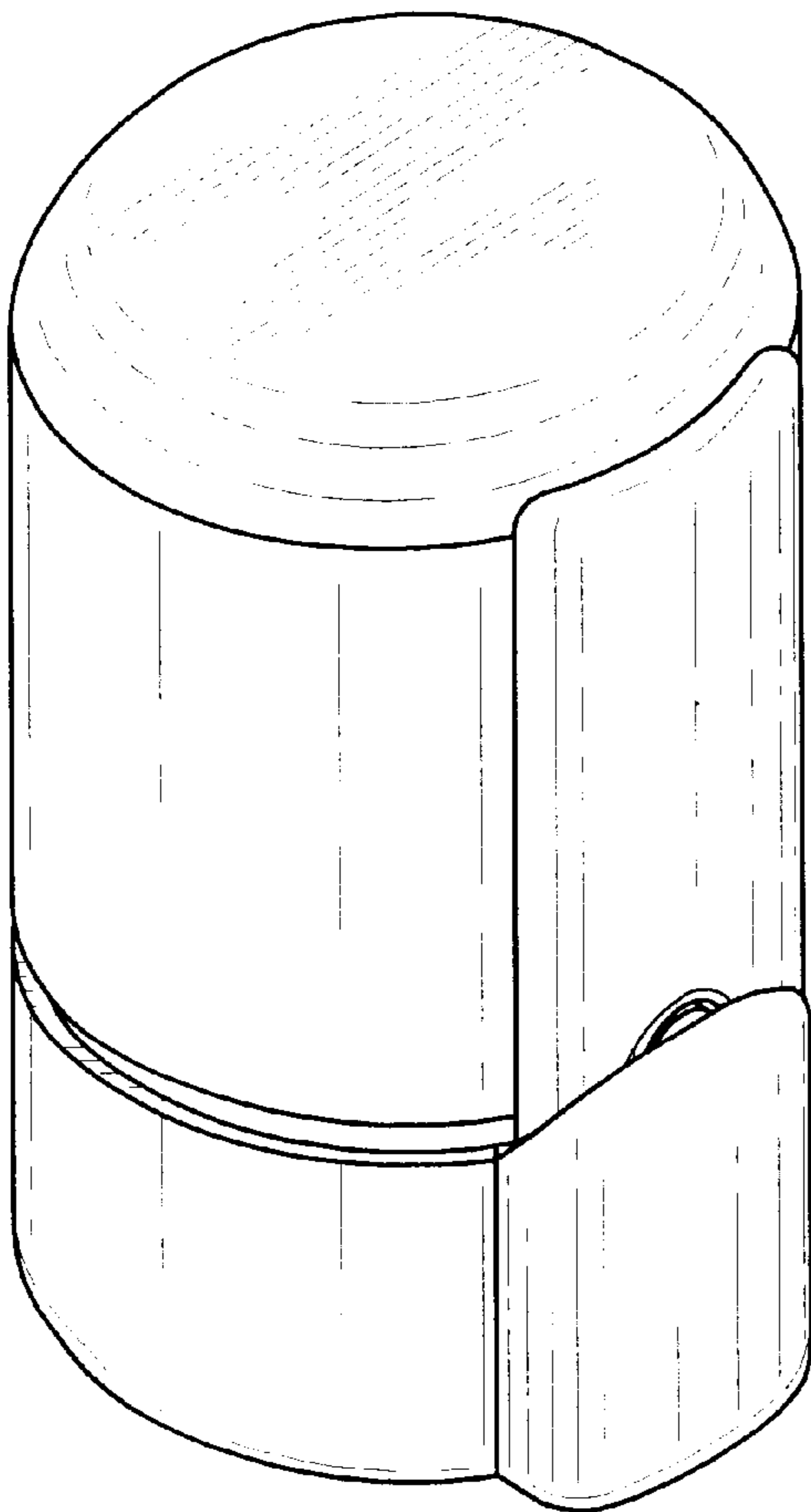

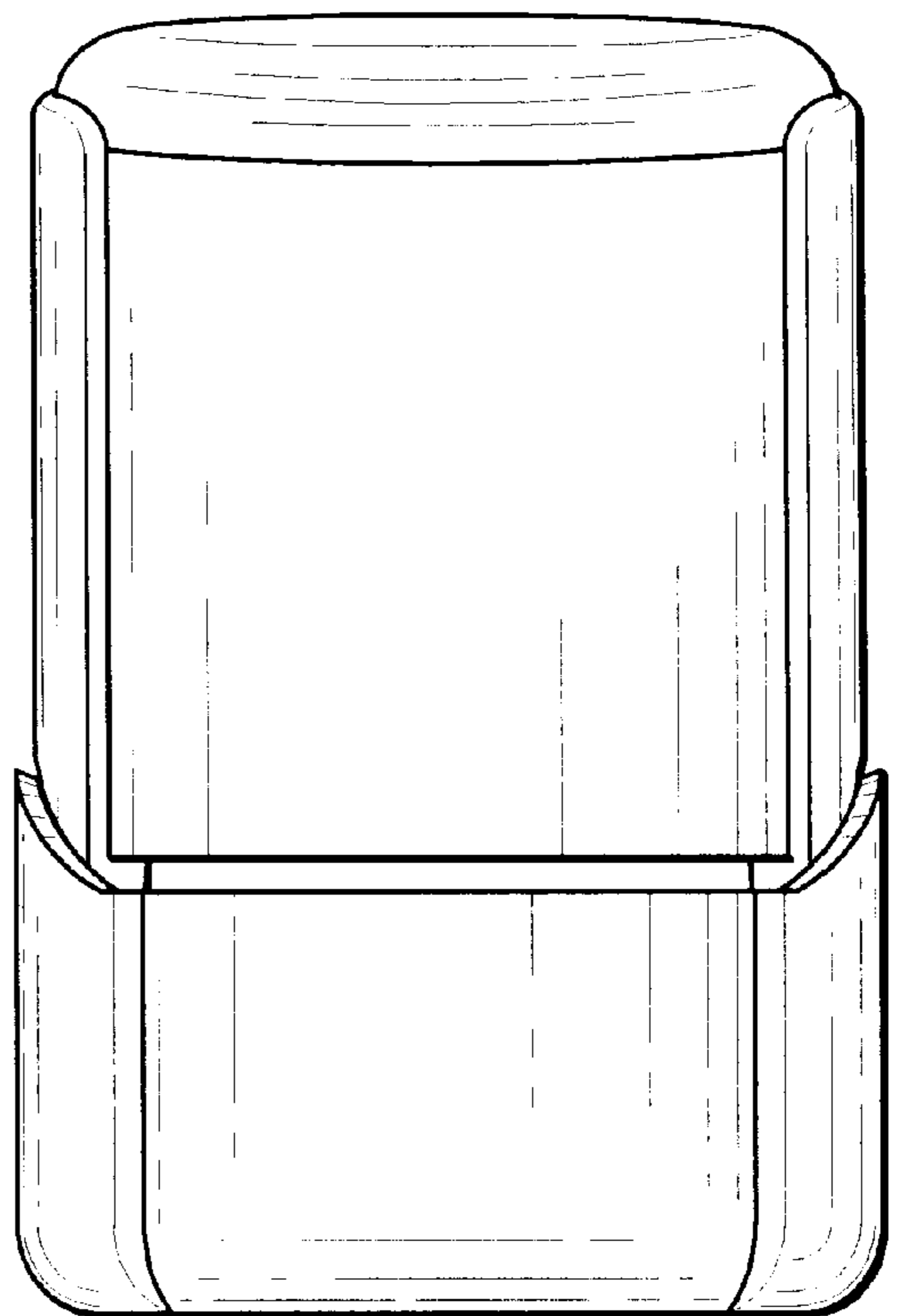

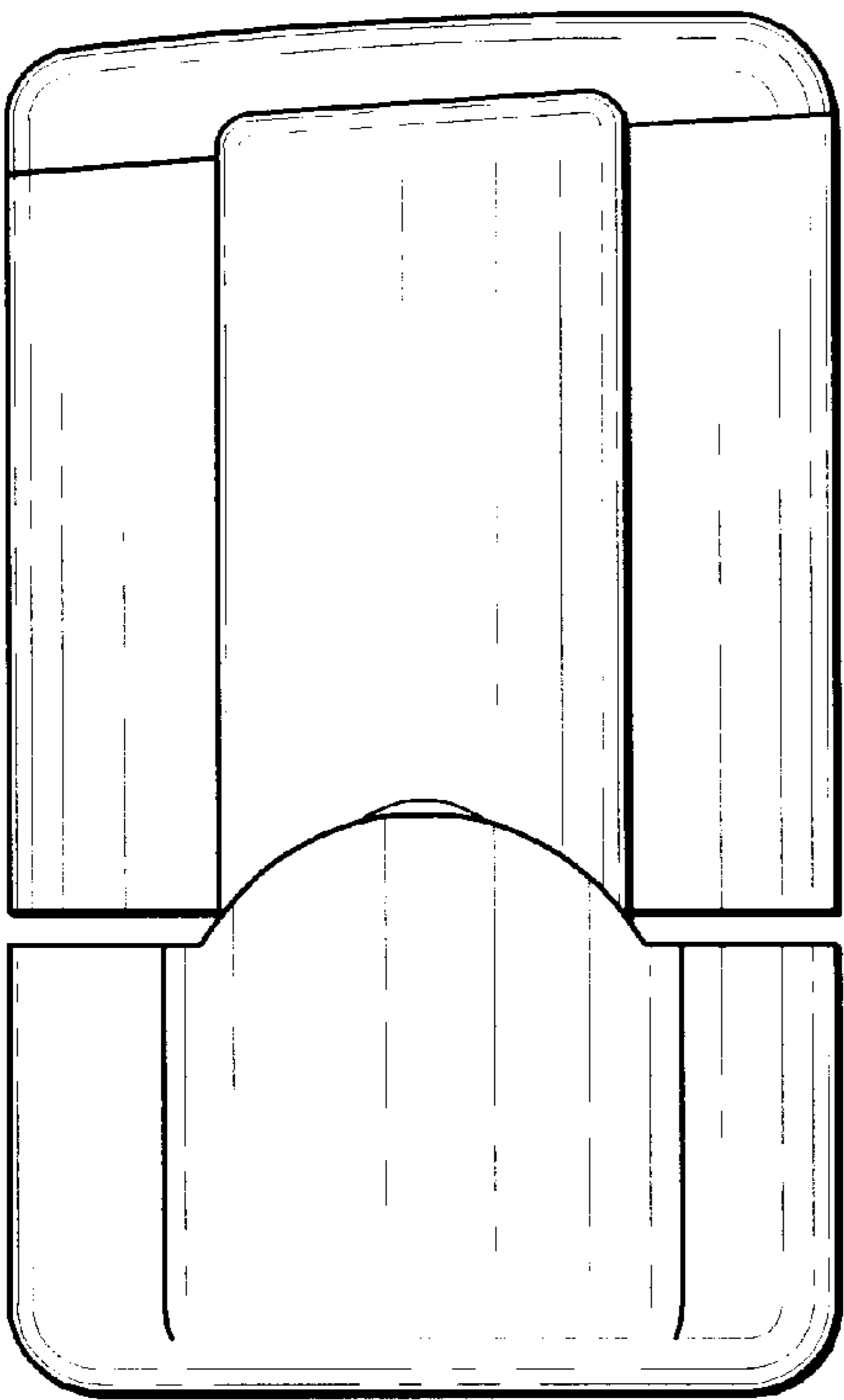

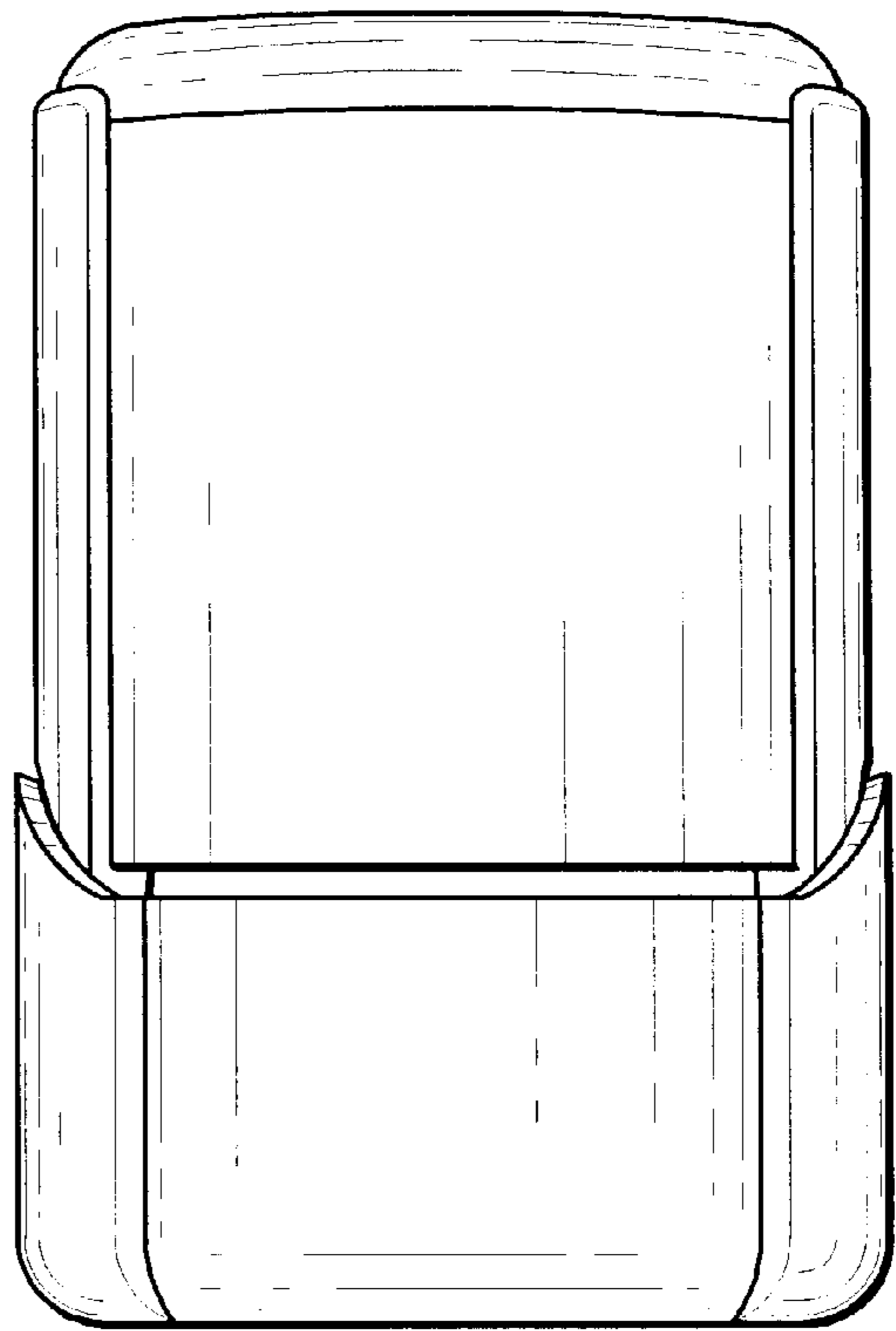

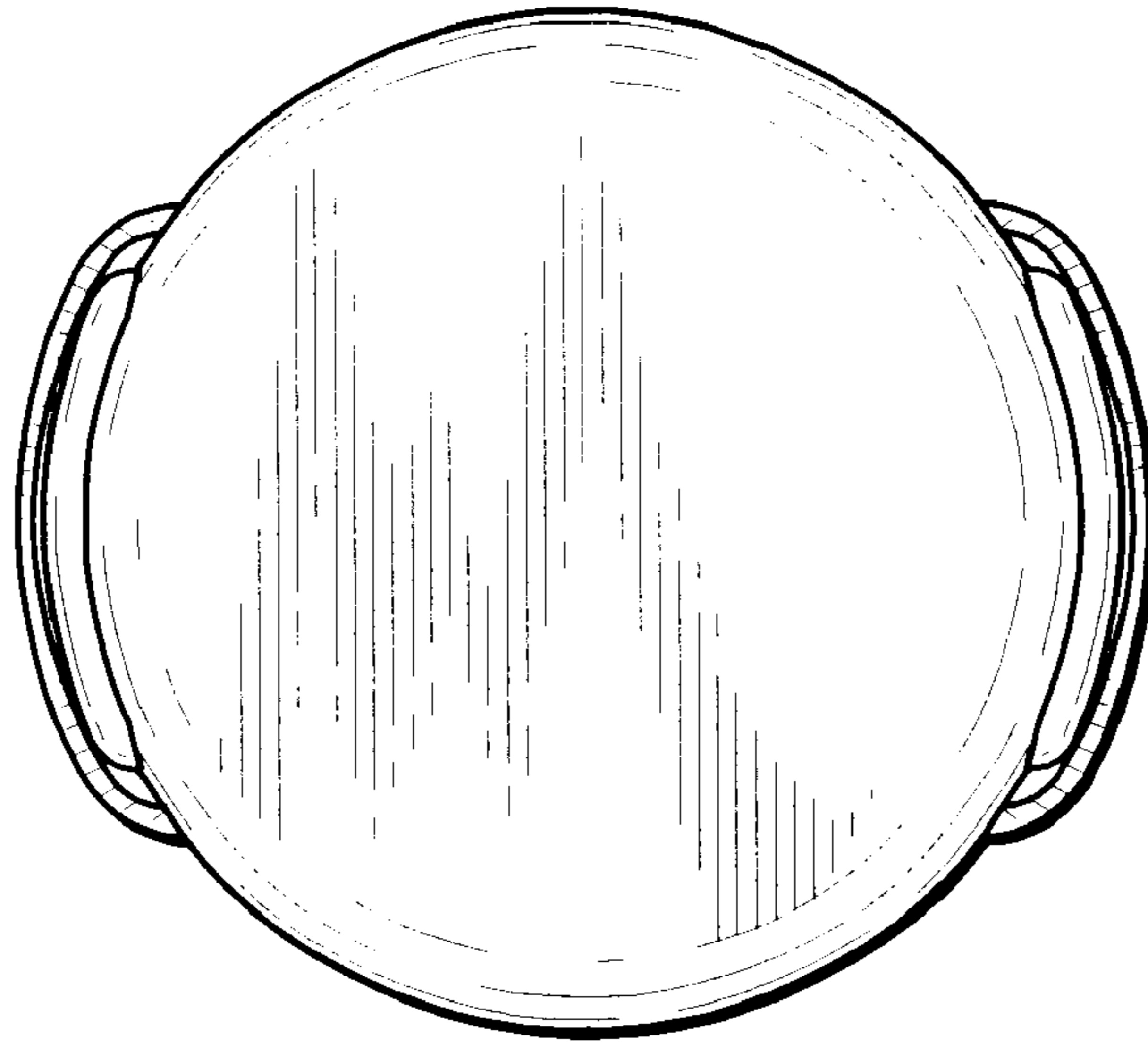

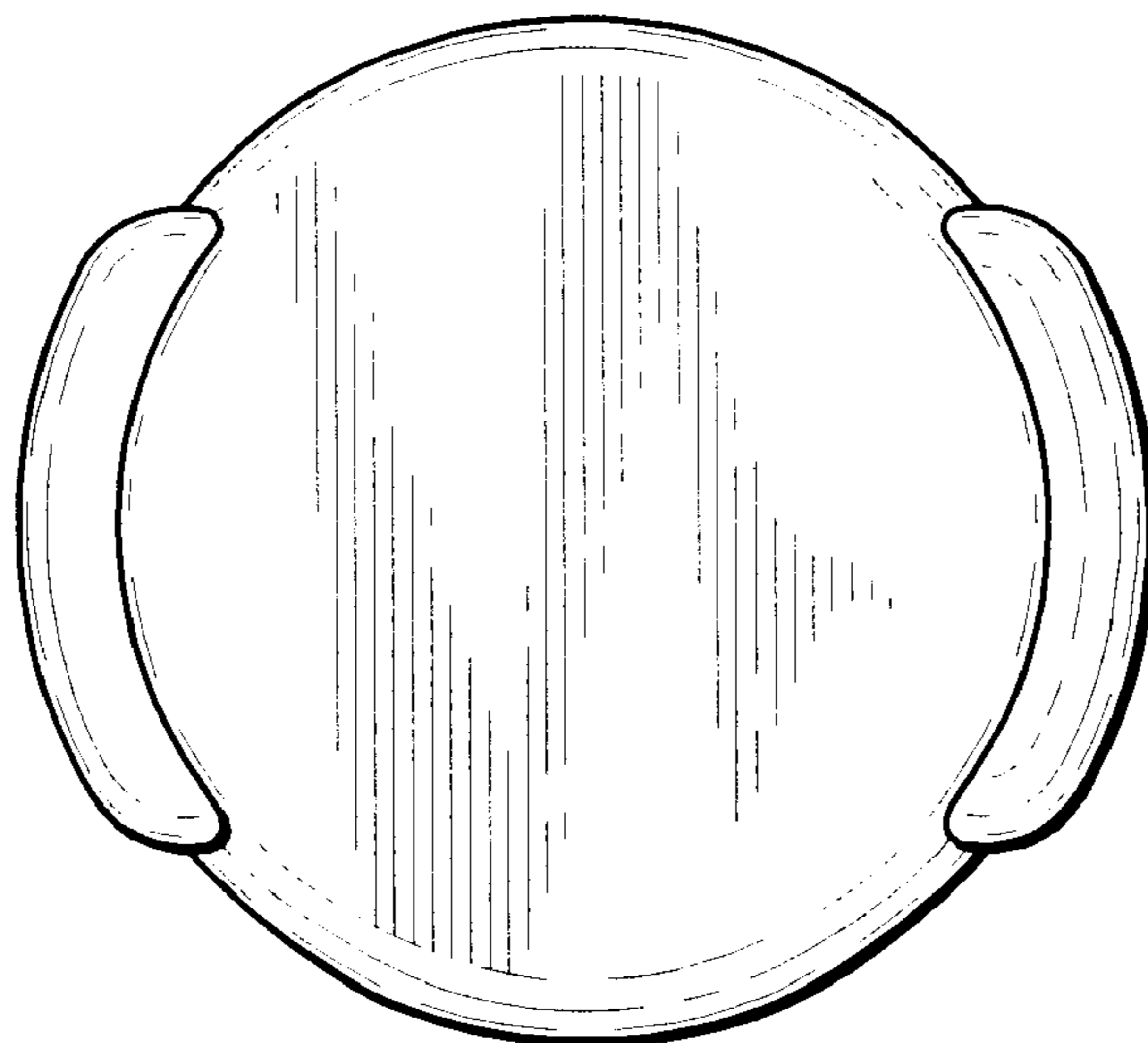

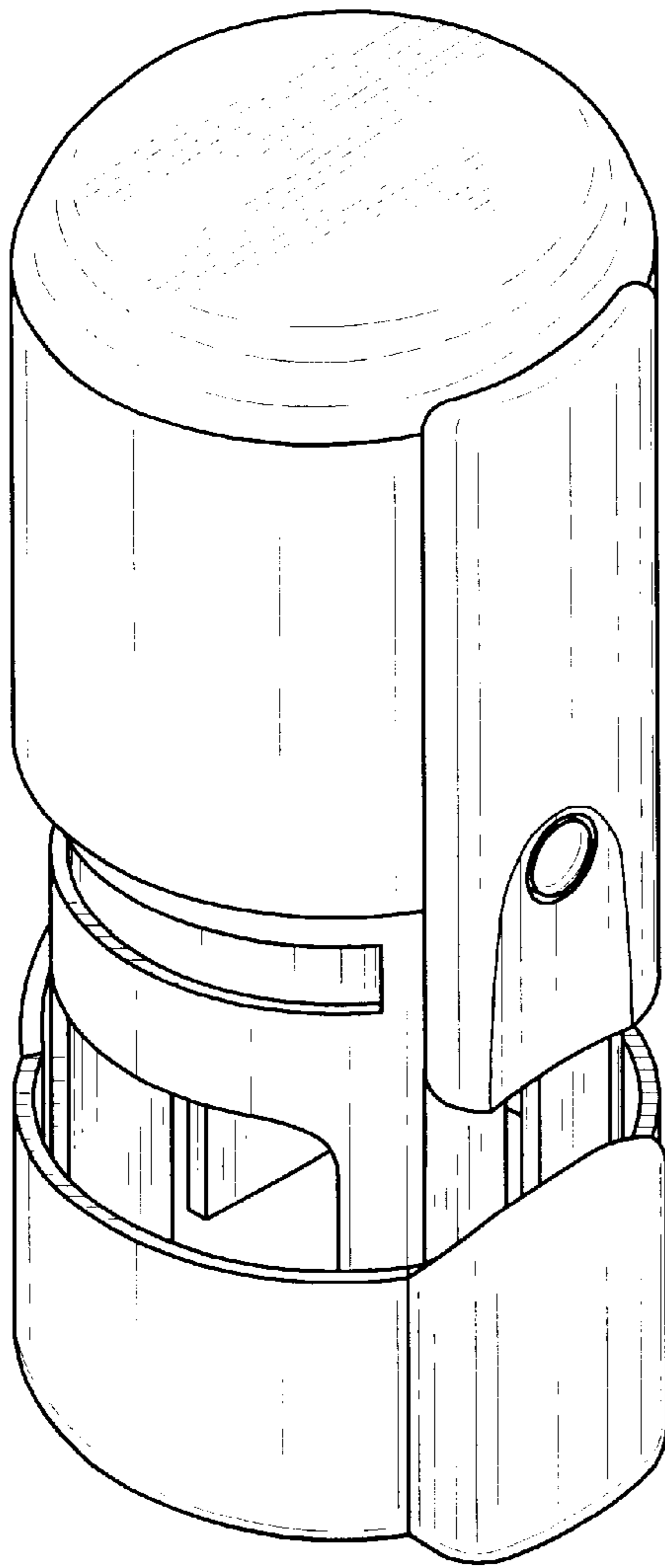

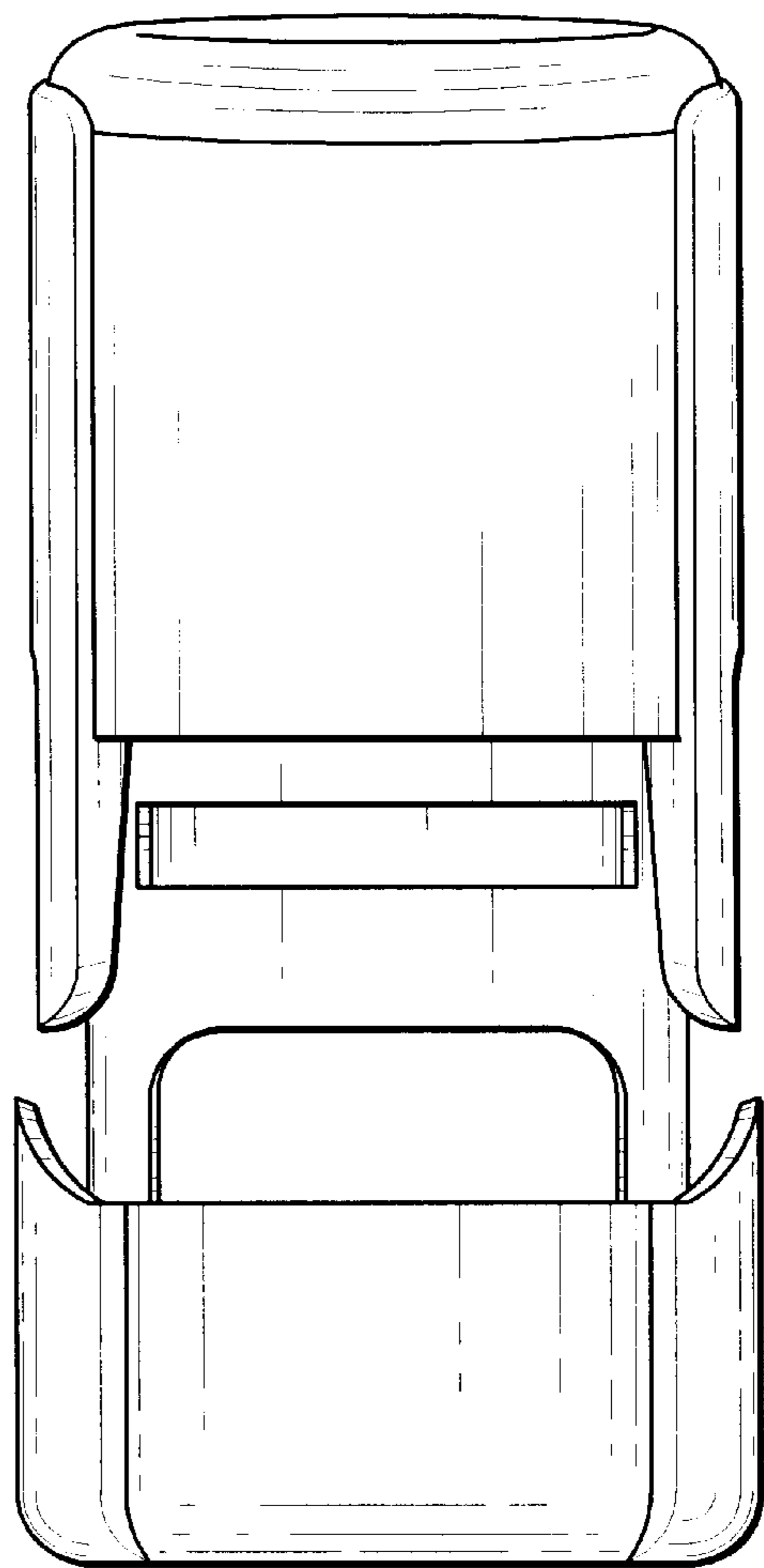

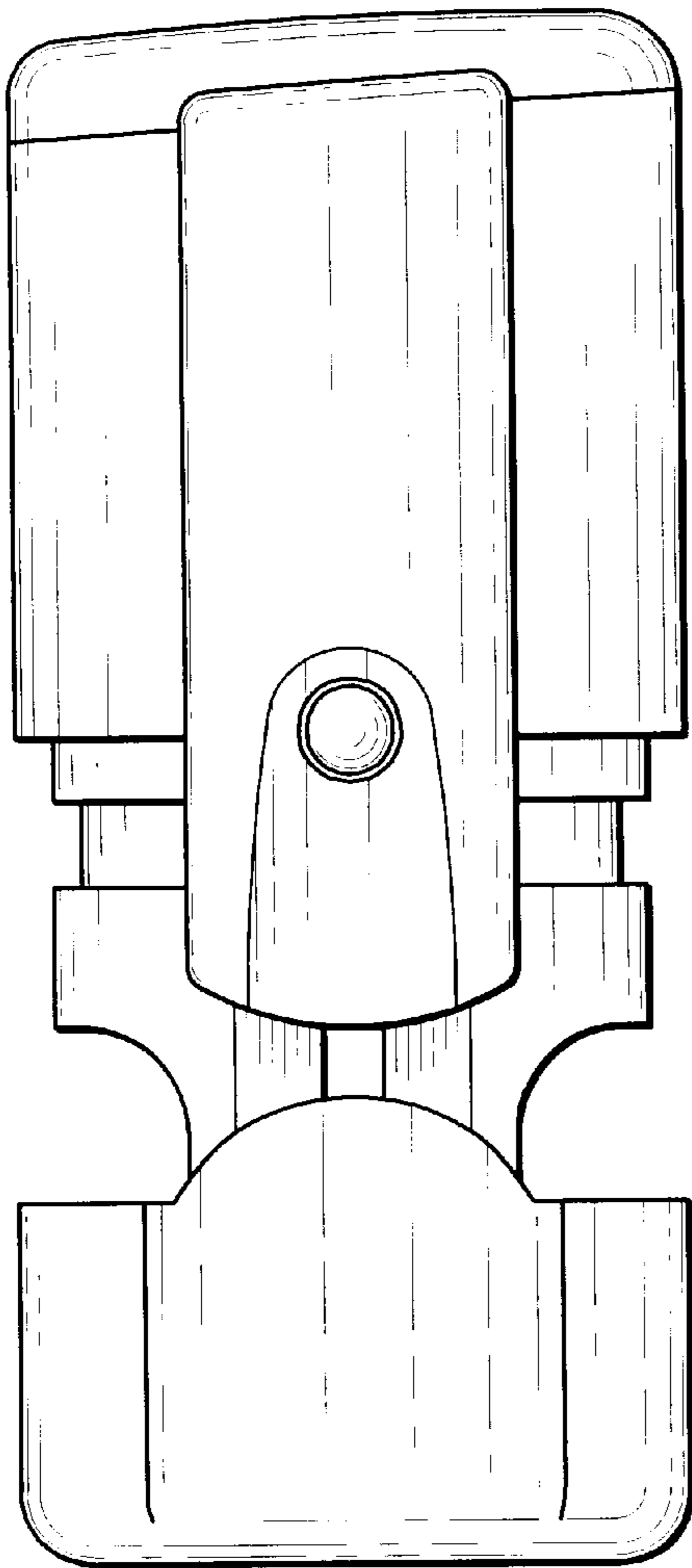
