(57) **CLAIM**

The ornamental design for a slotted hosel for a golf club head, as shown.

DESCRIPTION

FIG. 1 is a perspective view showing the front, top and toe end sides of a slotted hosel embodying the new design, the dotted line depiction of an iron-type golf club head being for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a toe end elevational view thereof;

FIG. 5 is a heel end elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is top plan view thereof;

FIG. 8 is a perspective view showing the top, front and toe end sides of the slotted hosel for a golf club head in accordance with an alternative embodiment thereof, the dotted line depiction of an iron-type golf club head being for illustrative purposes only and forms no part of the claimed design;

FIG. 9 is a front elevational view of the embodiment of FIG. 8;

FIG. 10 is a rear elevational view of the embodiment of FIG. 8;

FIG. 11 is a toe end elevational view of the embodiment of FIG. 8;

FIG. 12 is a heel end elevational view of the embodiment of FIG. 8;

FIG. 13 is a bottom plan view of the embodiment of FIG. 8; and,

FIG. 14 is a top plan view of the embodiment of FIG. 8.

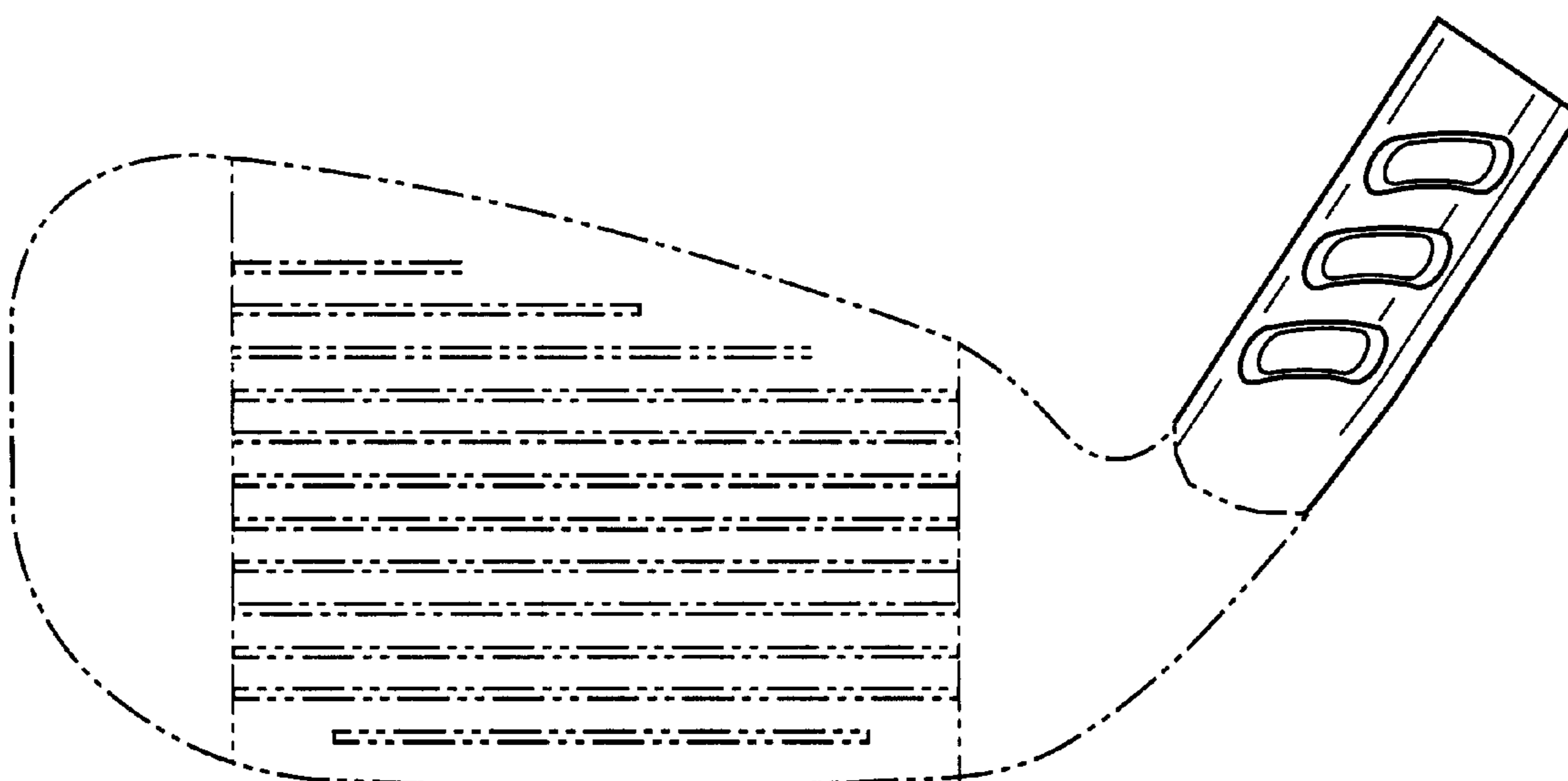

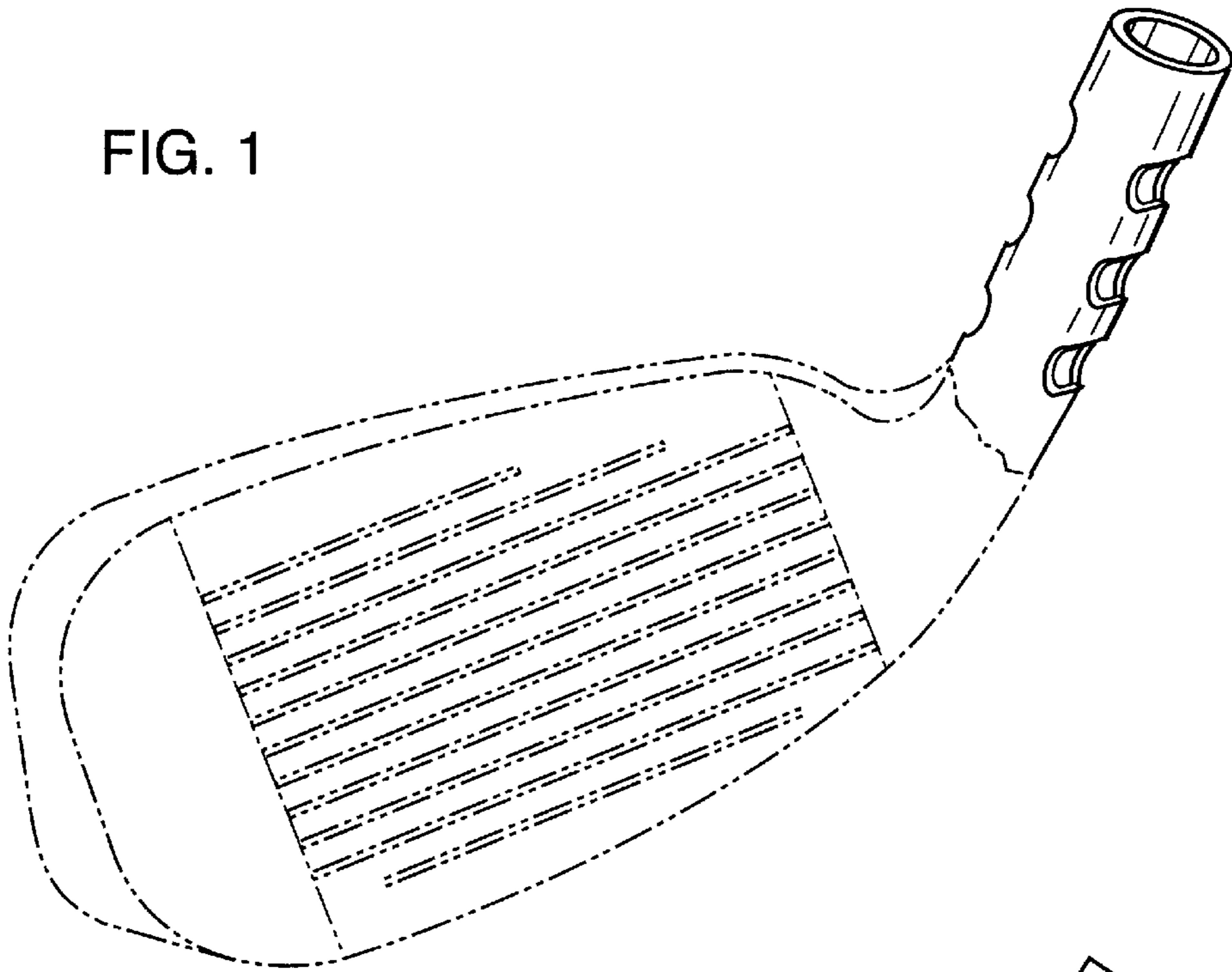

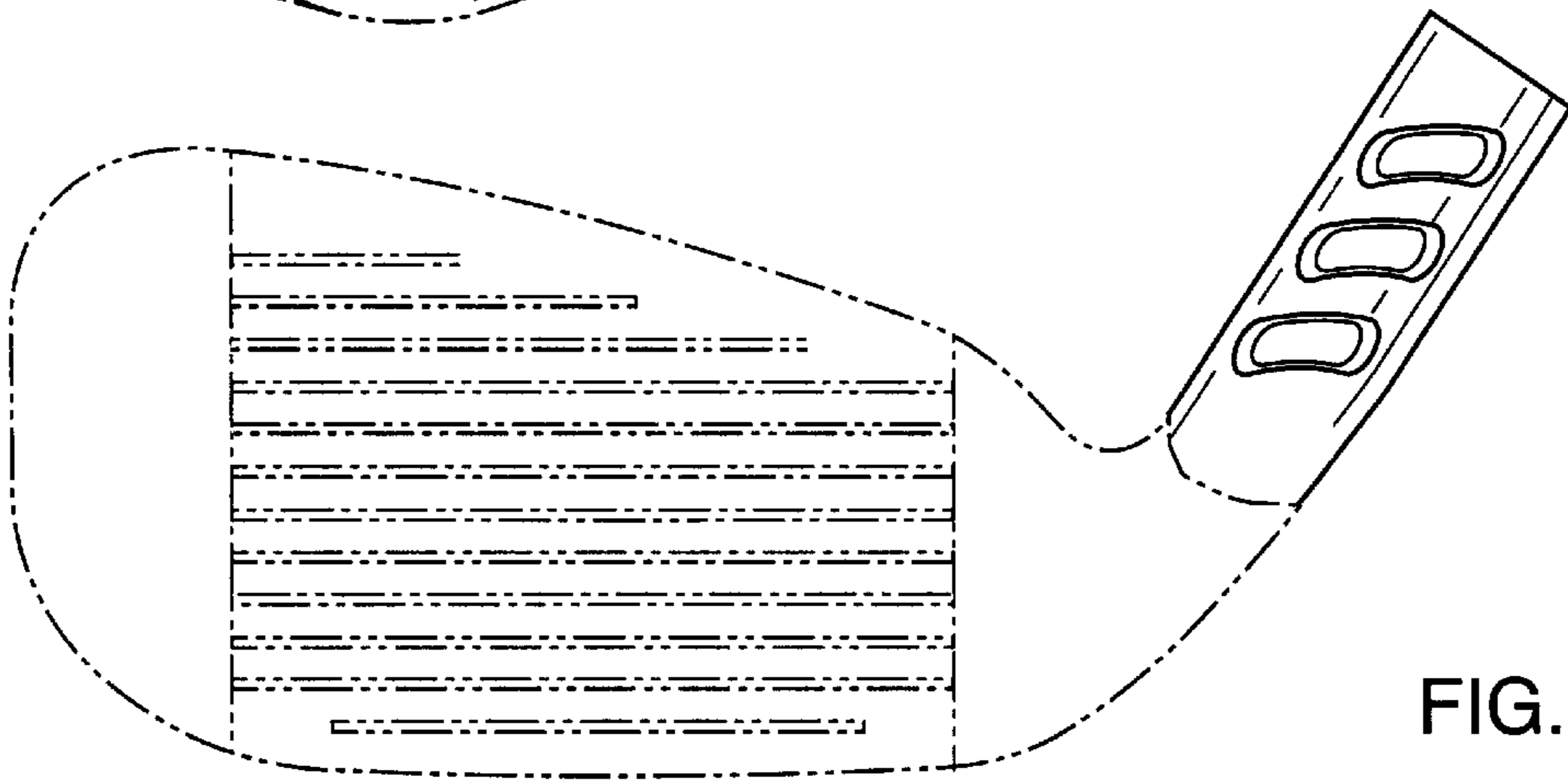

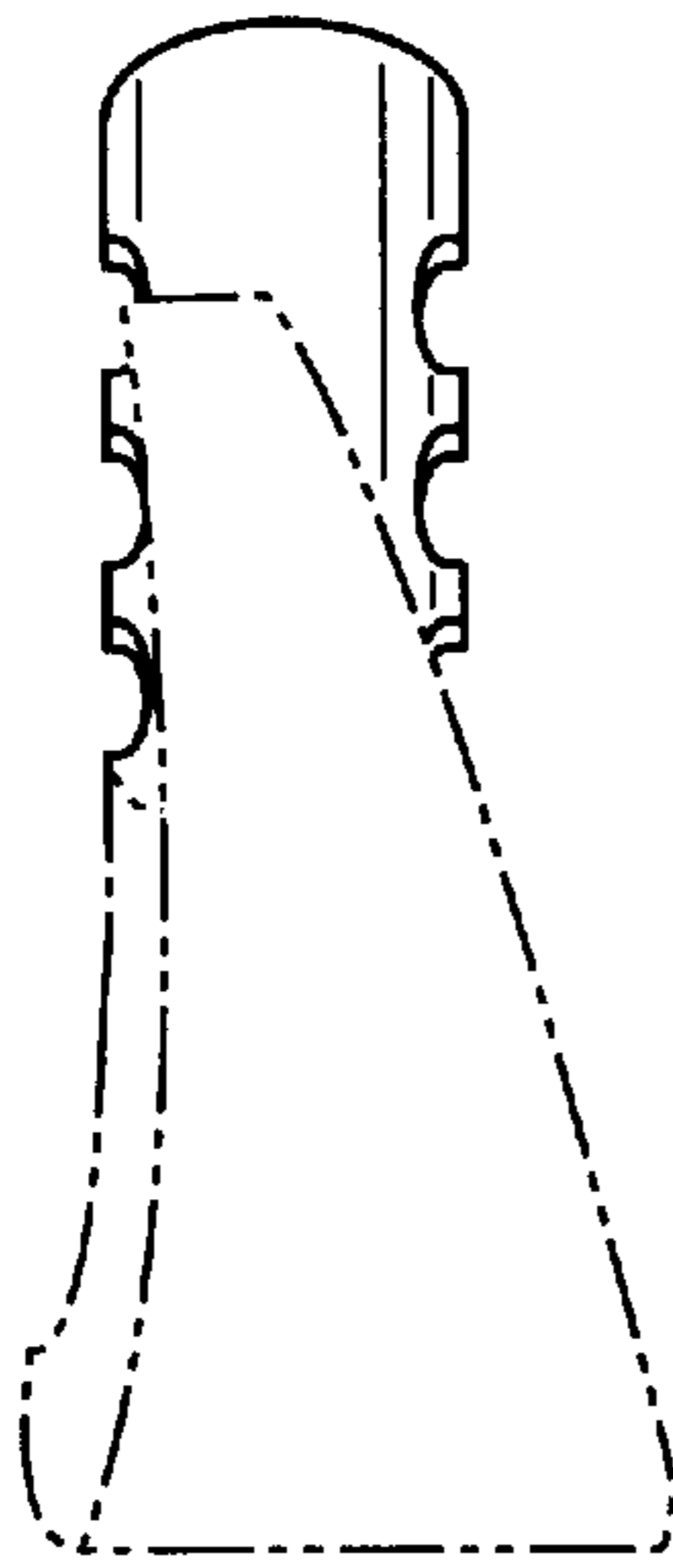

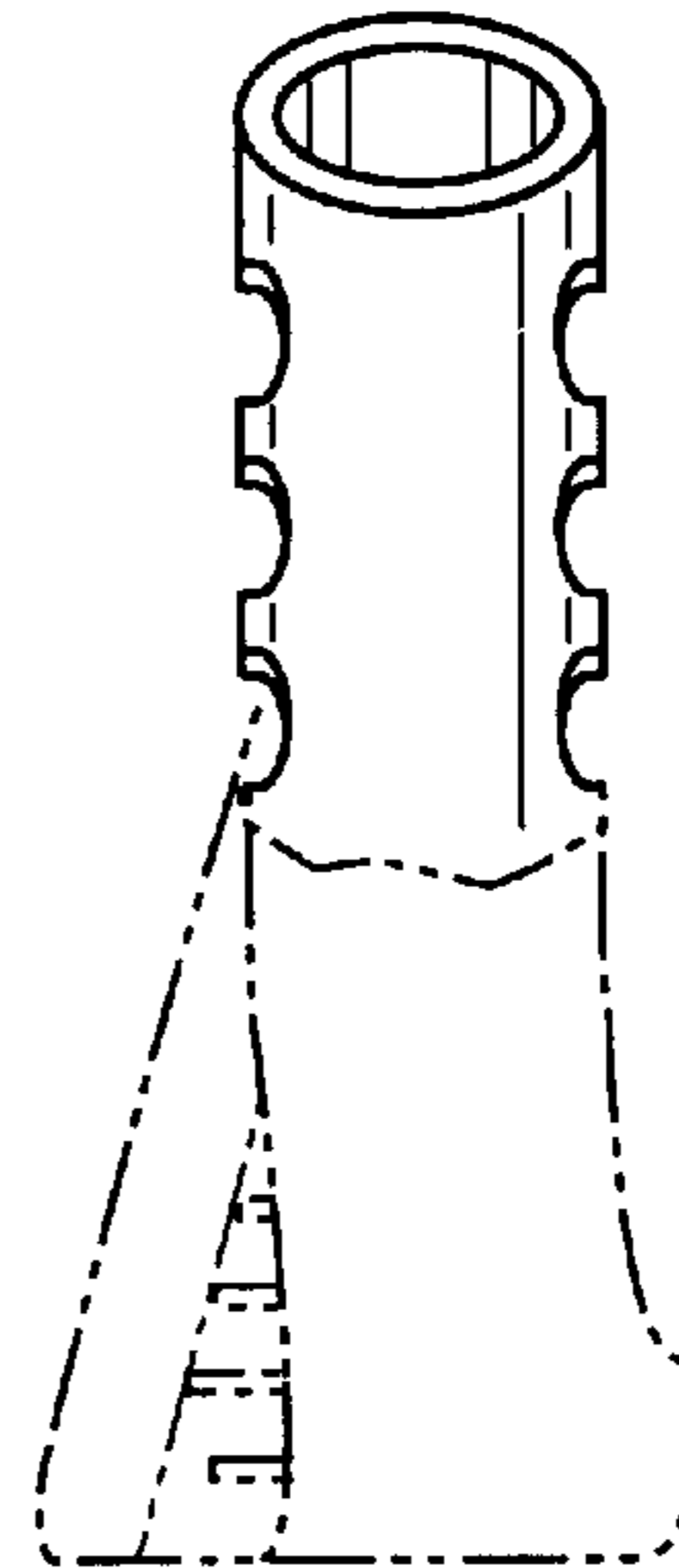

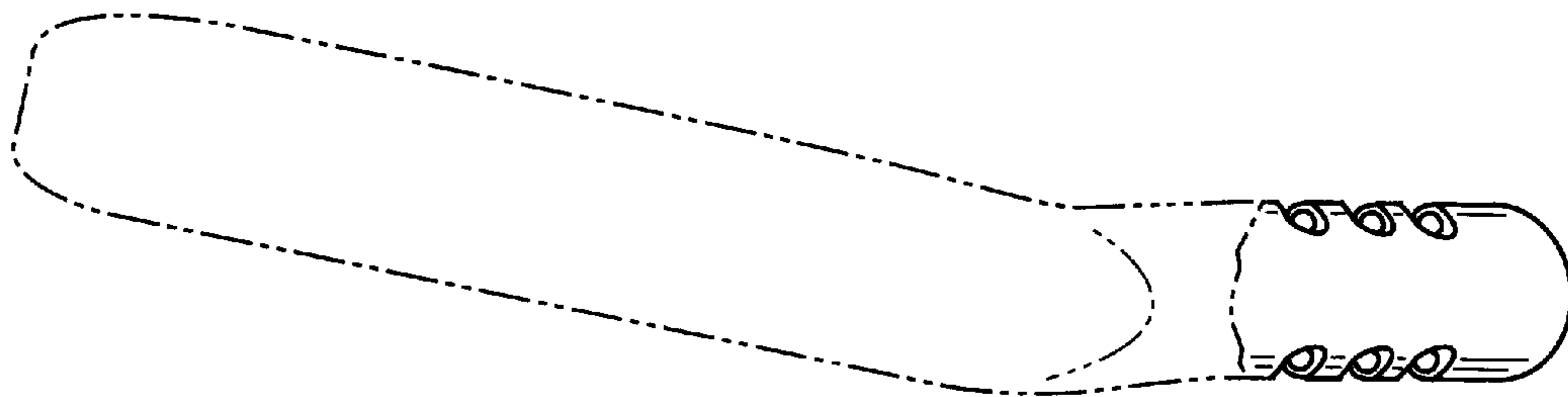

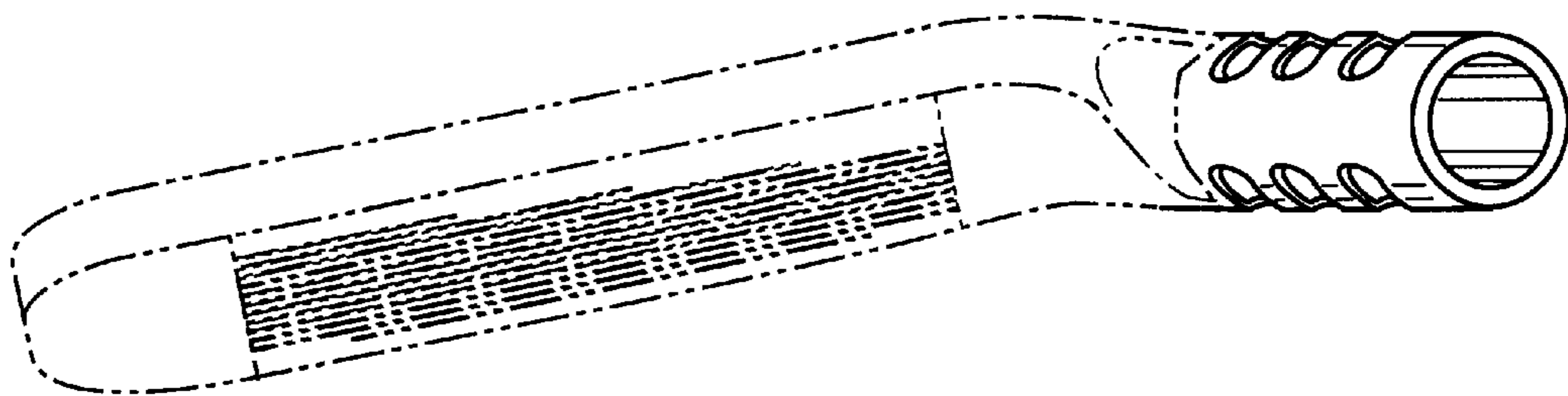

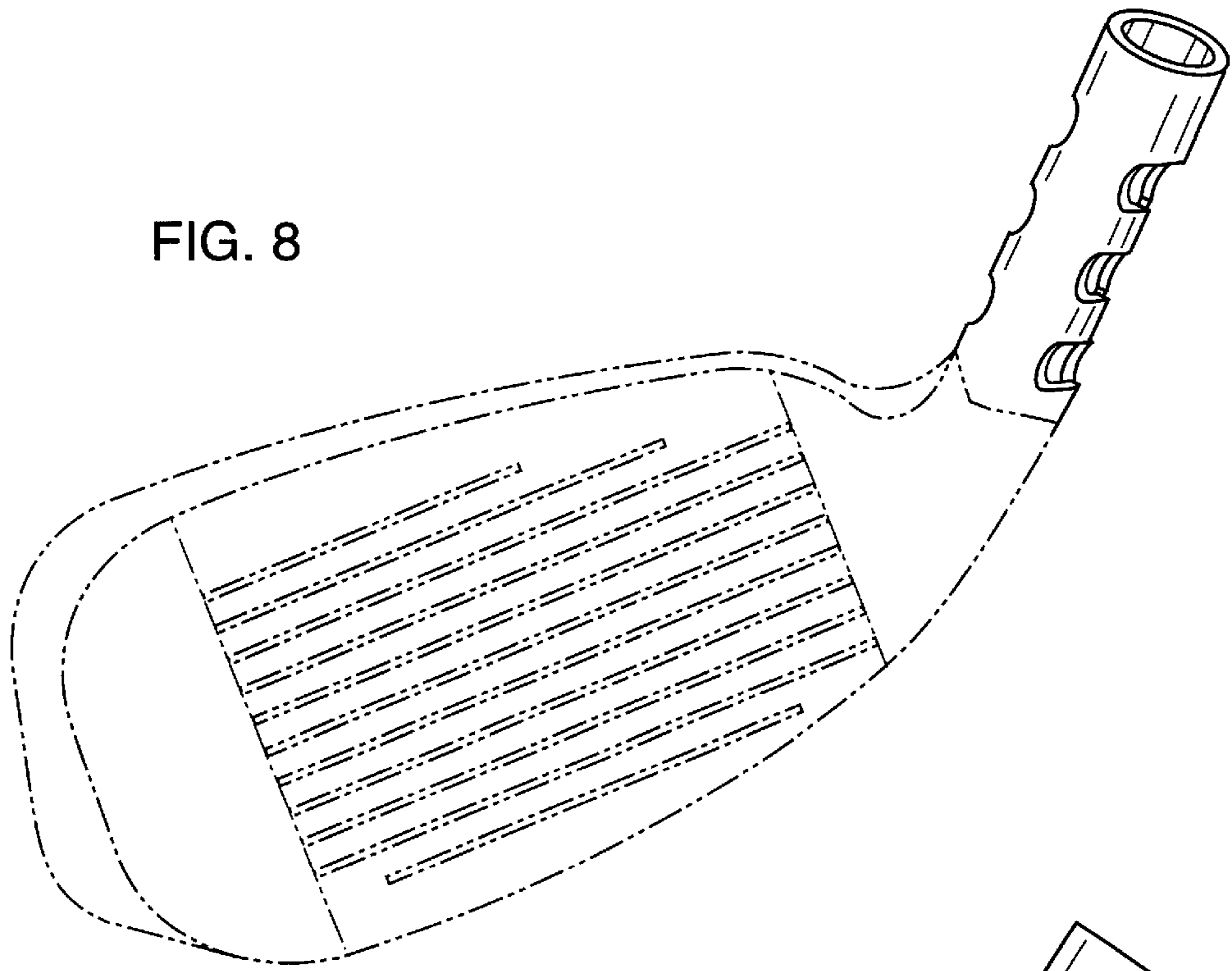

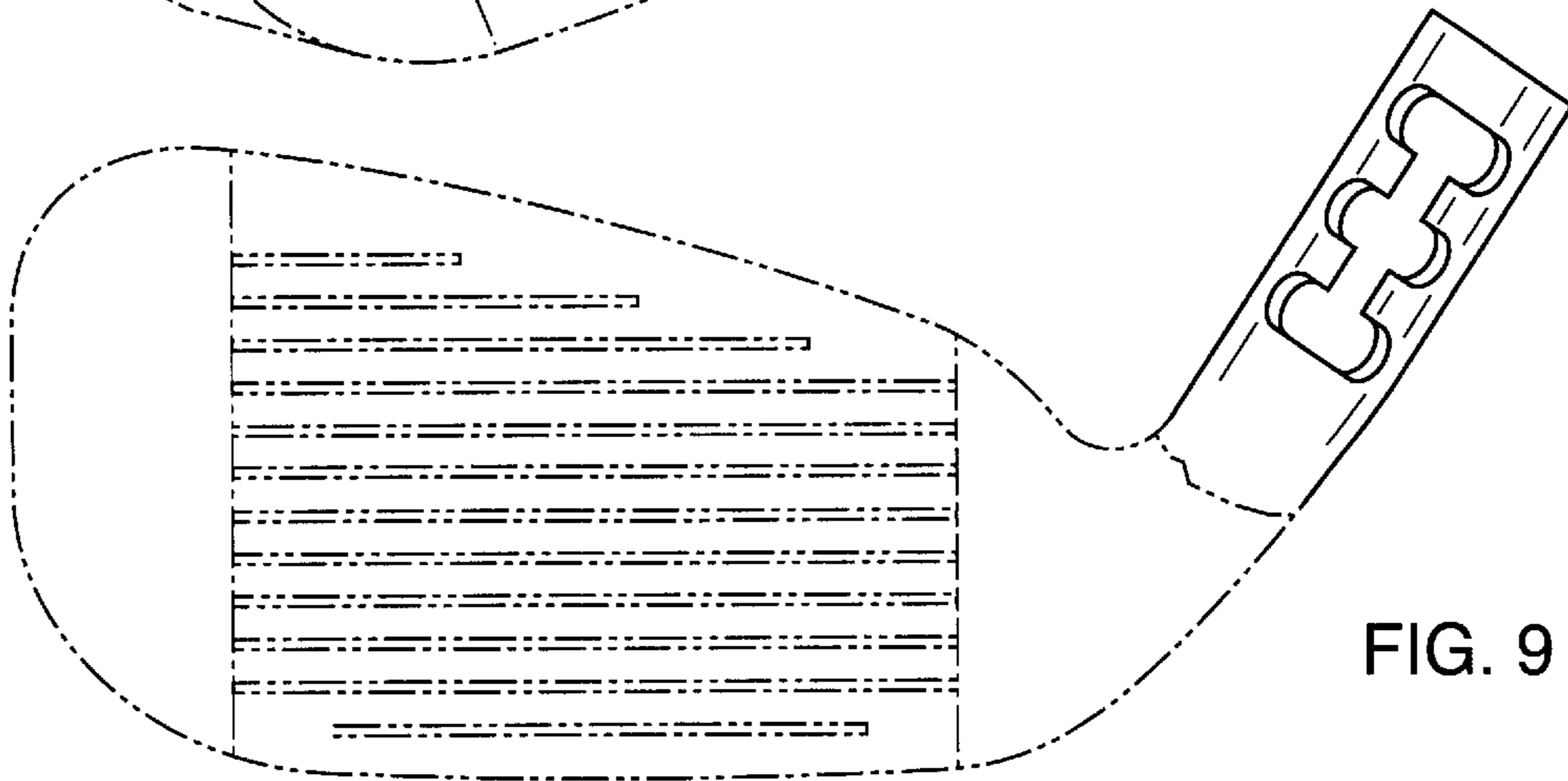

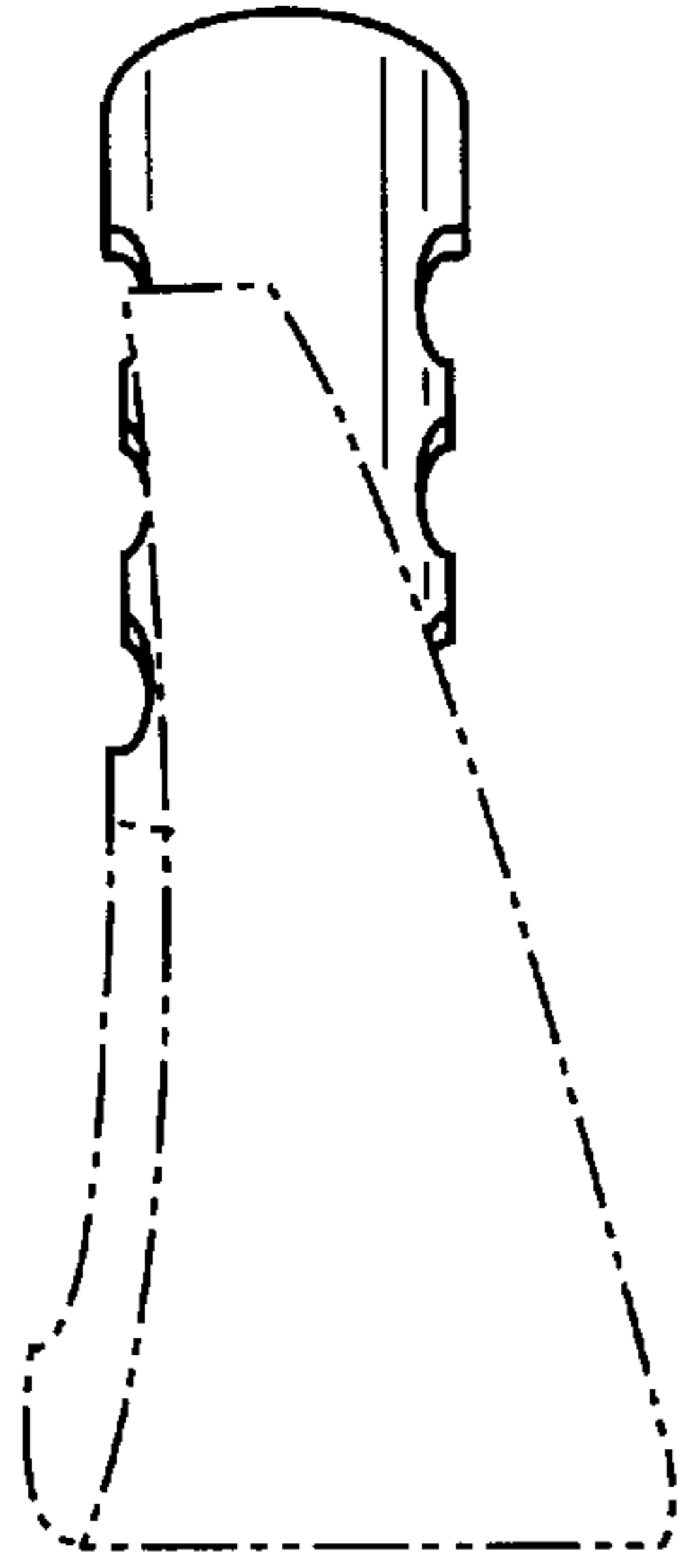

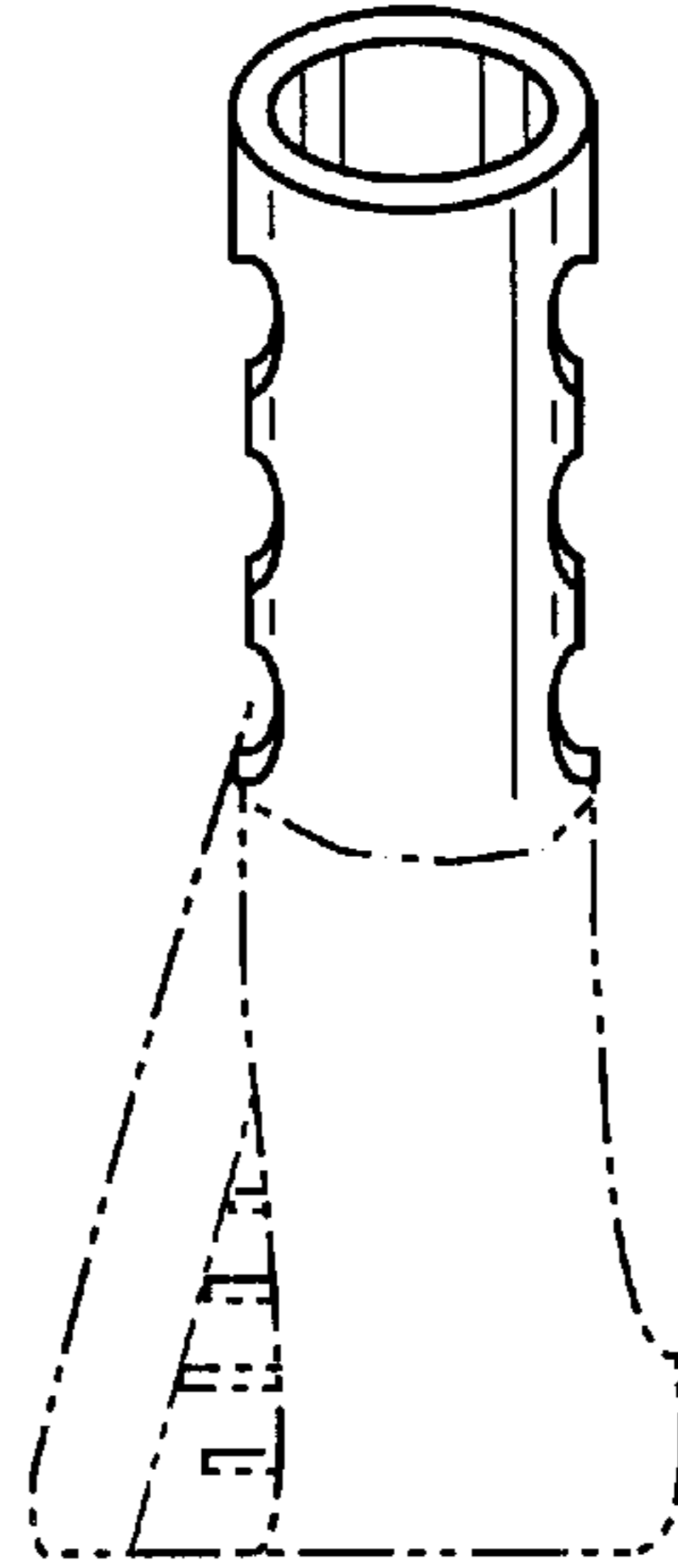

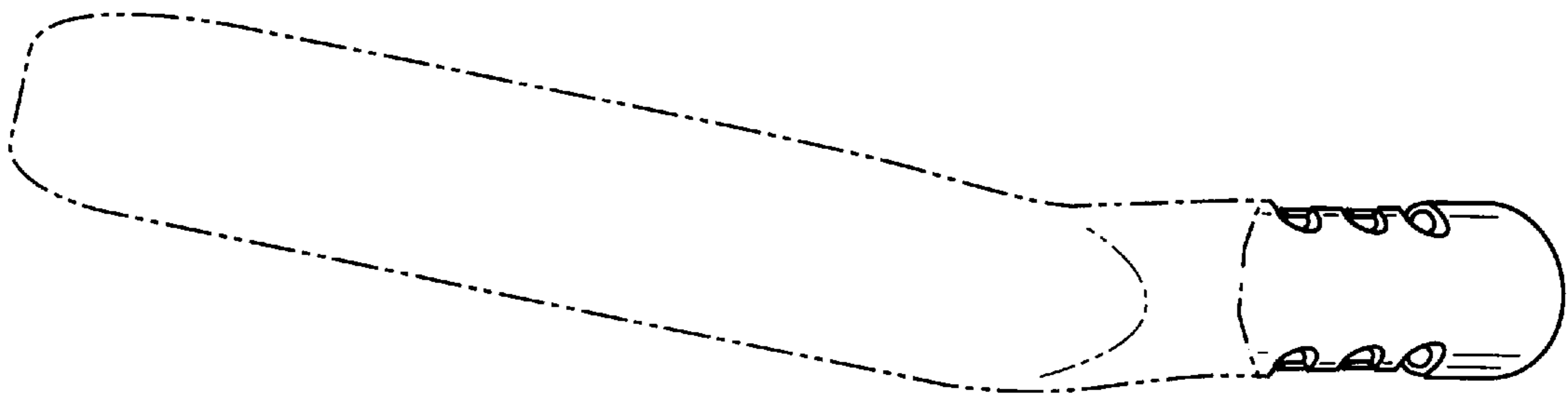

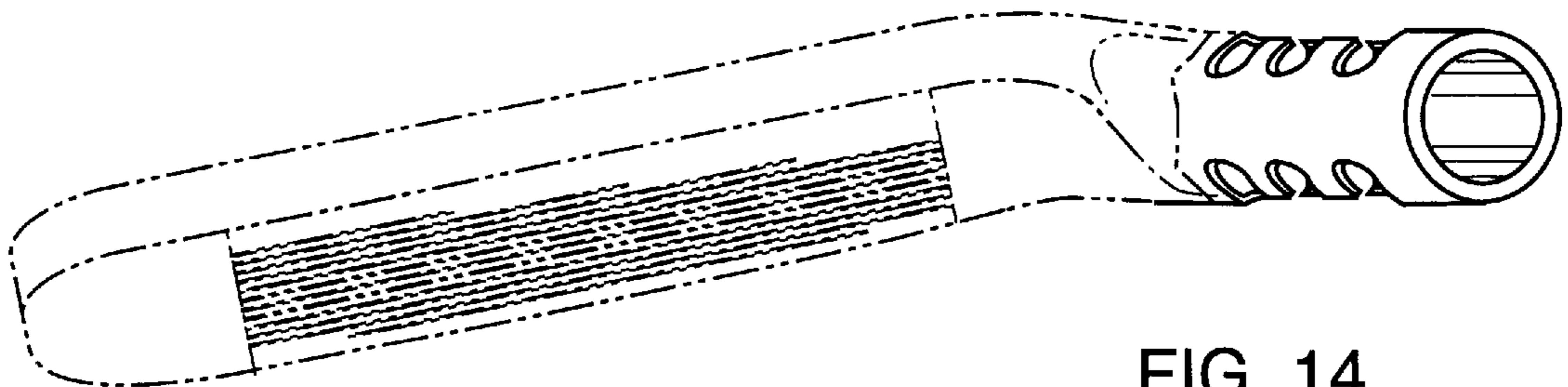

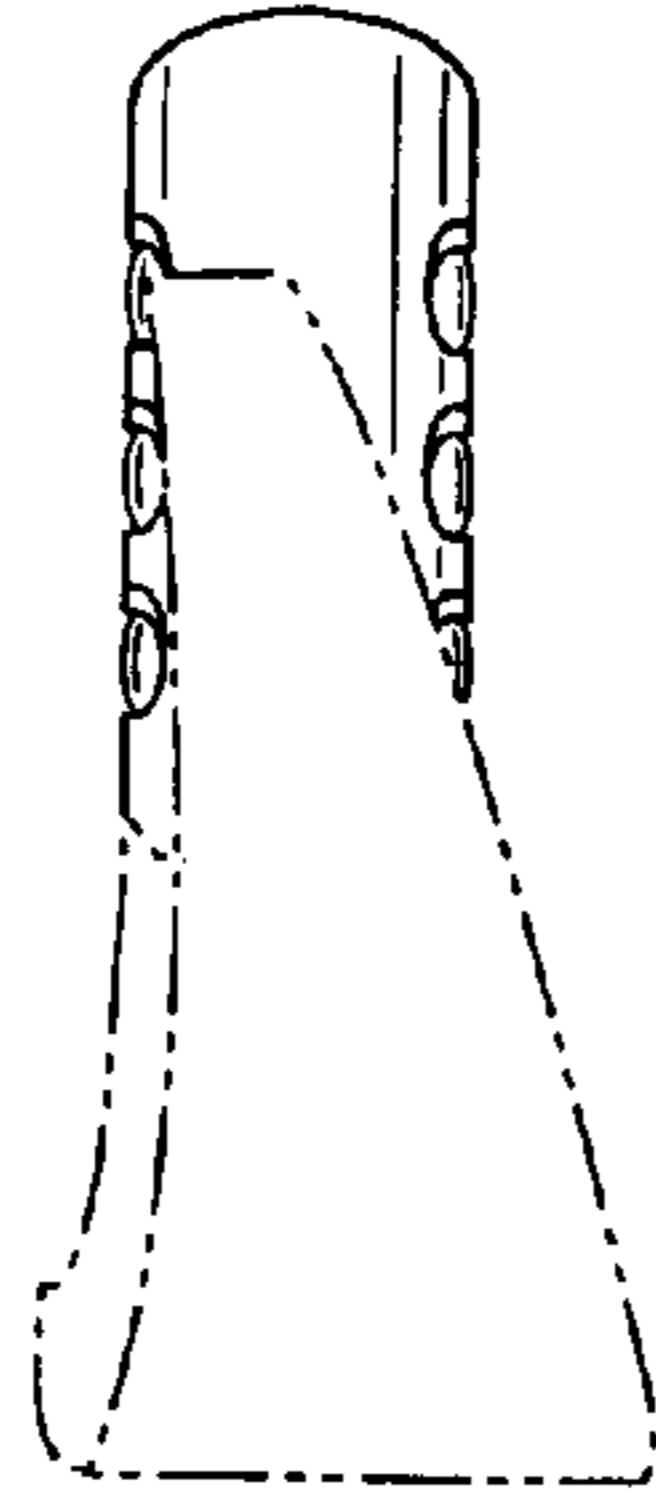

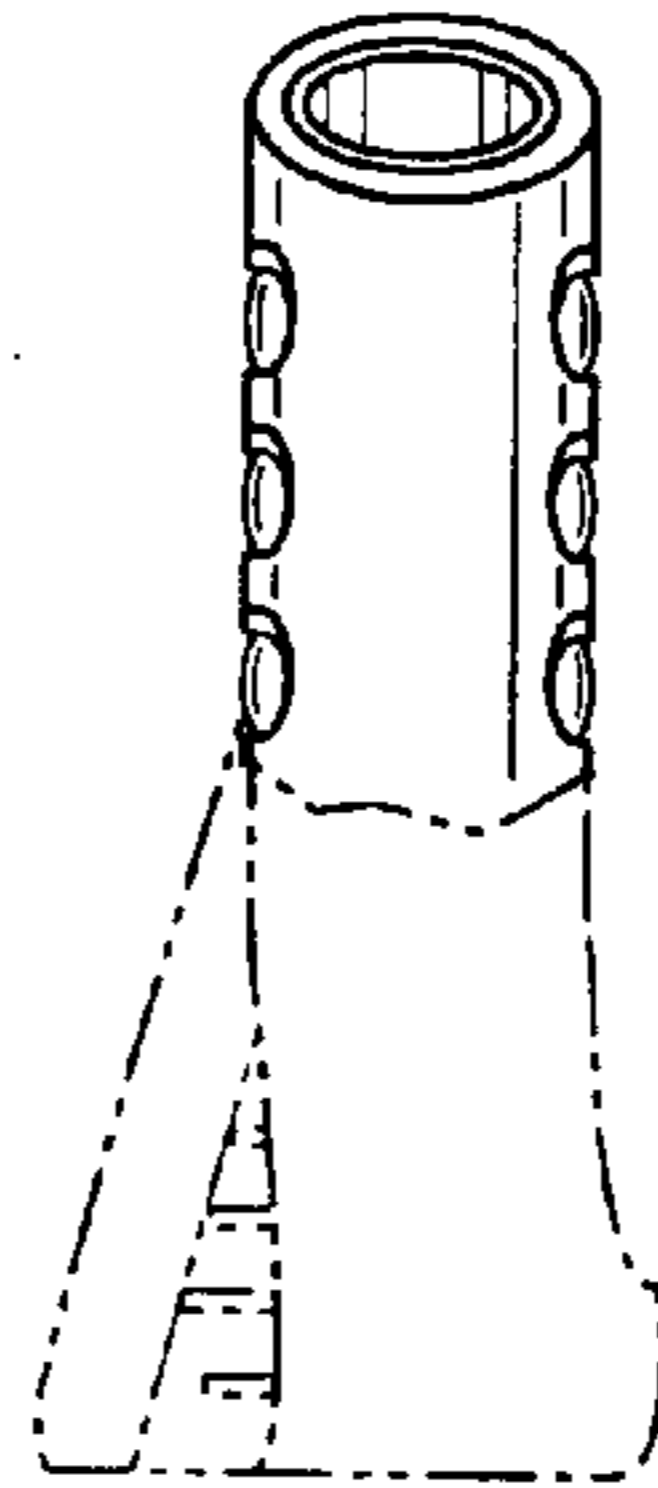

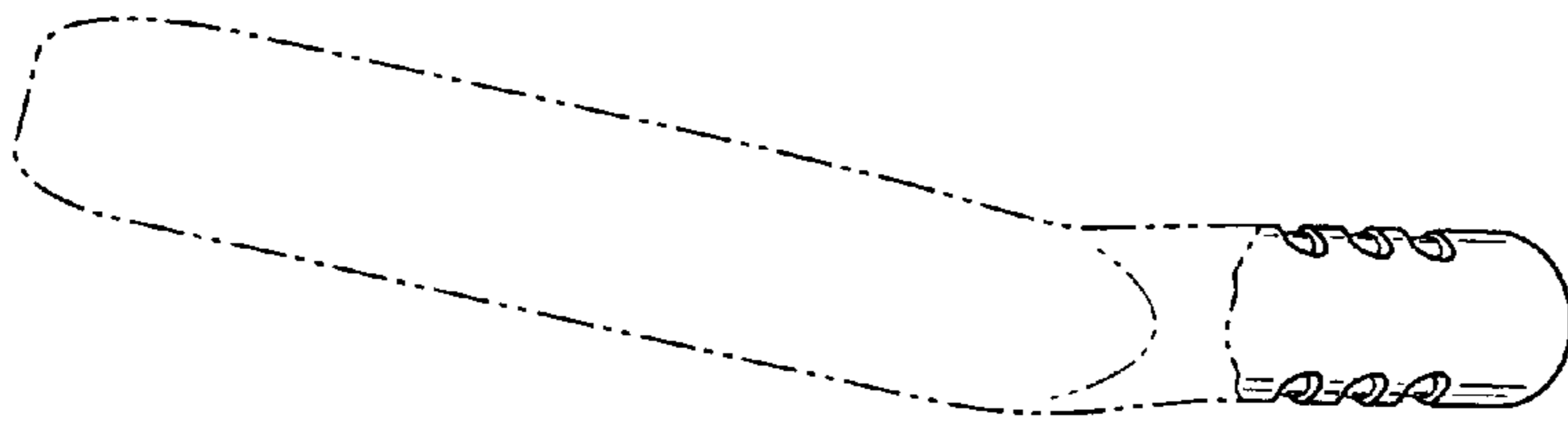

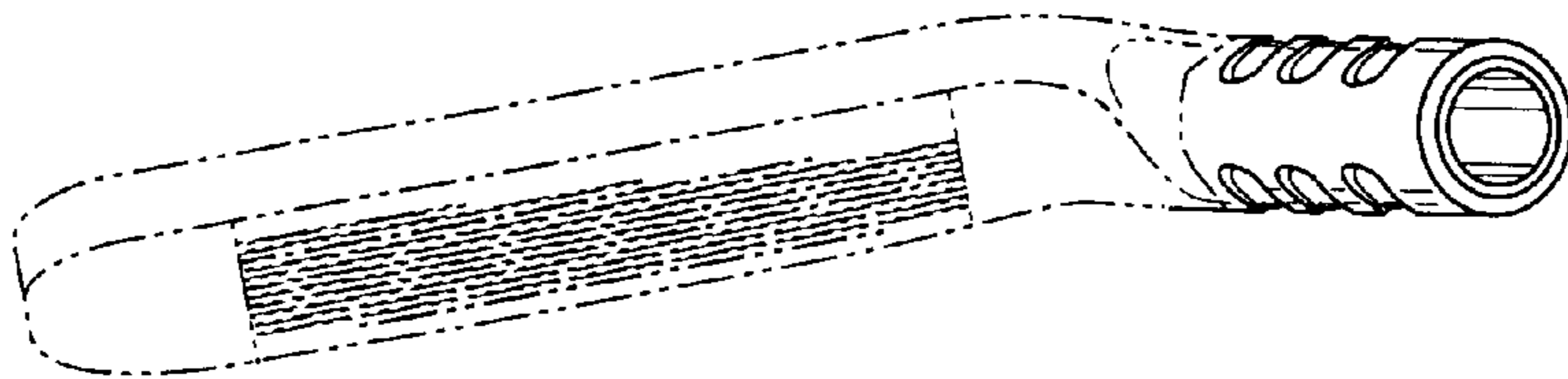
