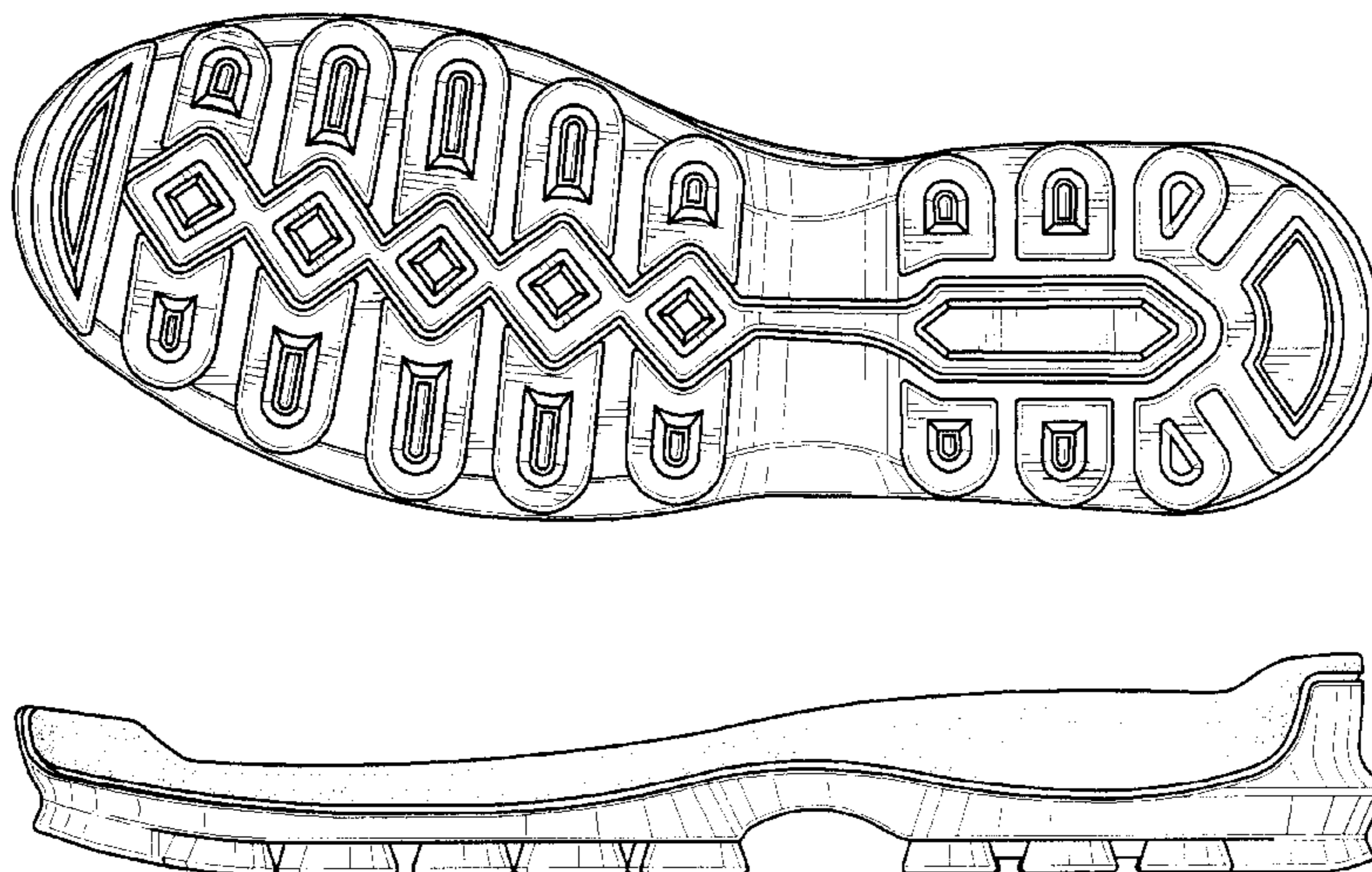
(57) **CLAIM**

The ornamental design for a footwear bottom, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a footwear bottom showing our new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a rear view thereof; and,  
FIG. 7 is a front view thereof.  
The broken lines shown in FIG. 2 illustrate the unclaimed portion of the top surface.

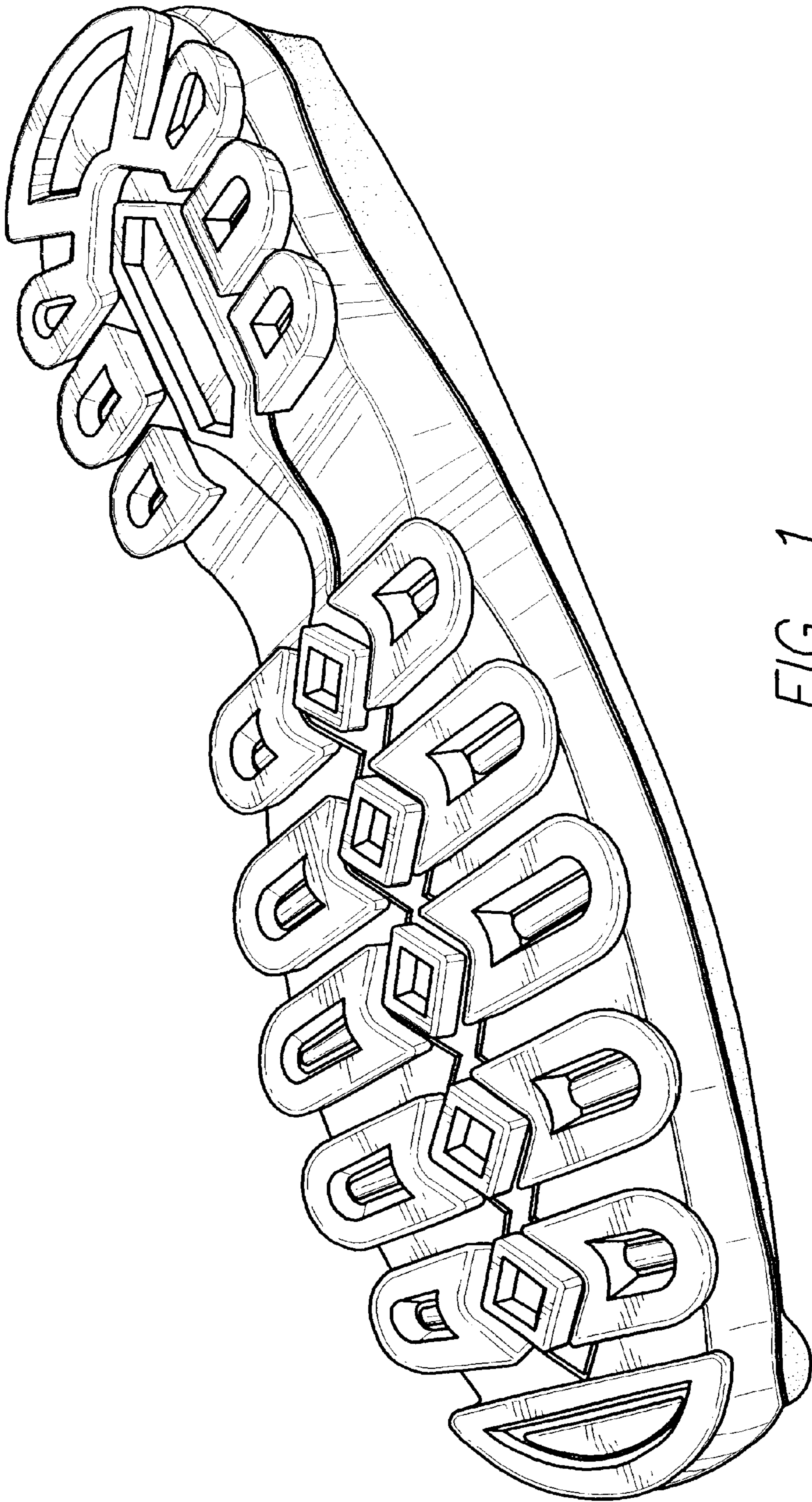

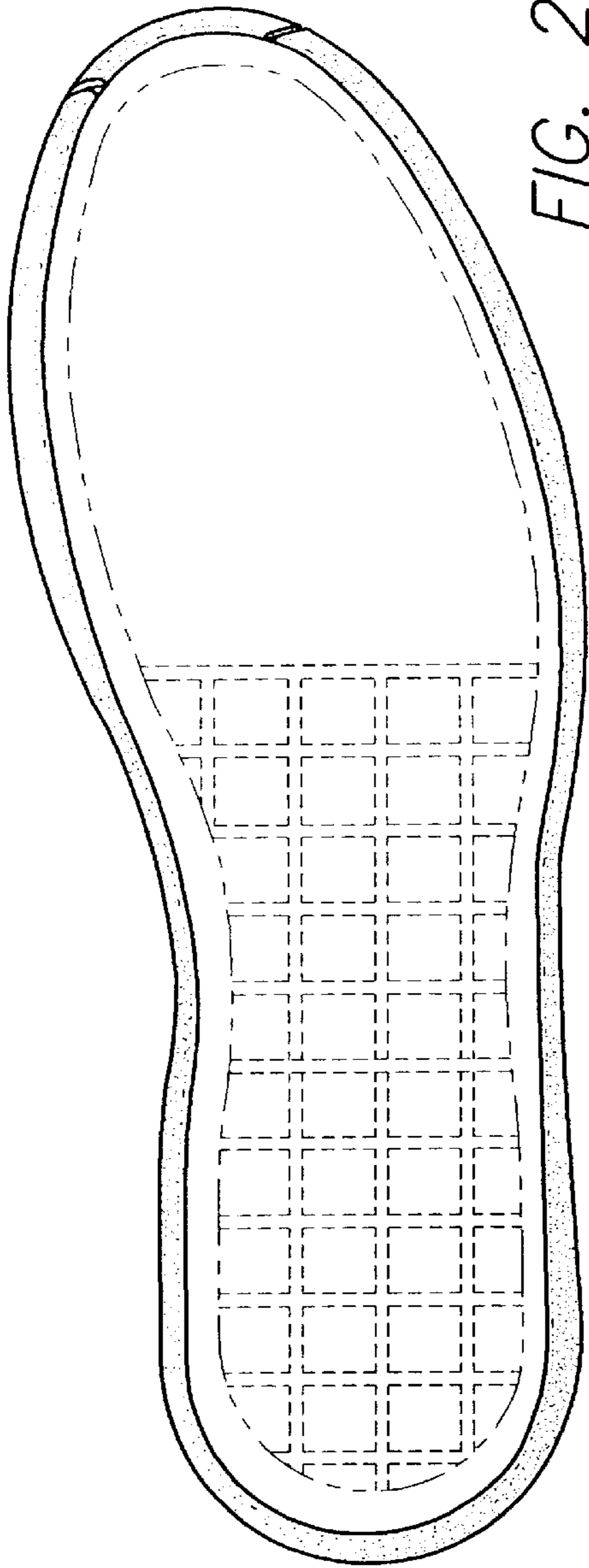

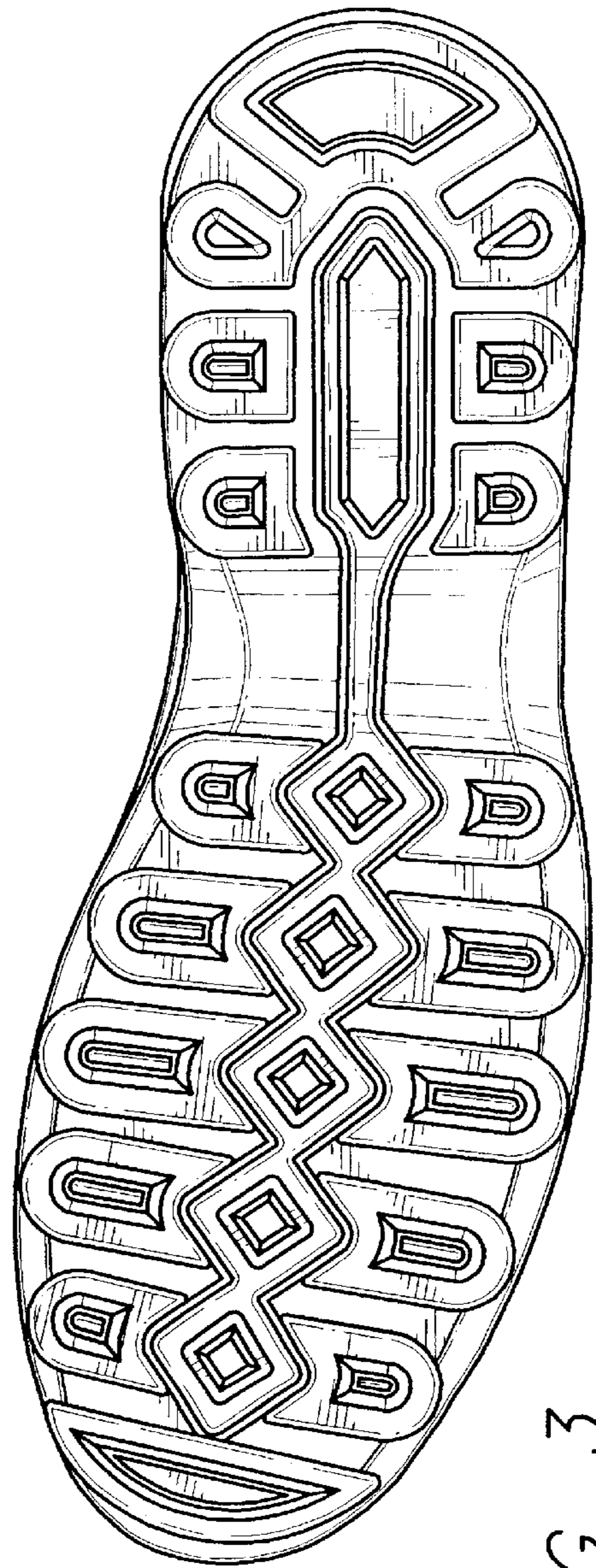

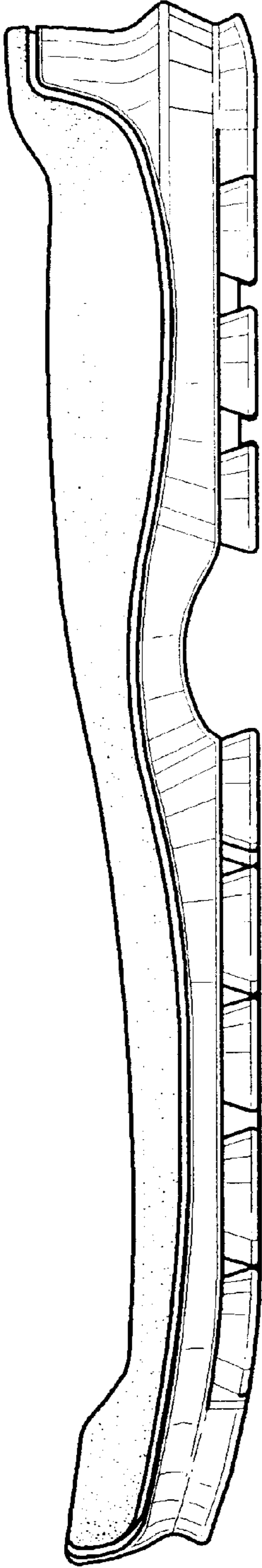

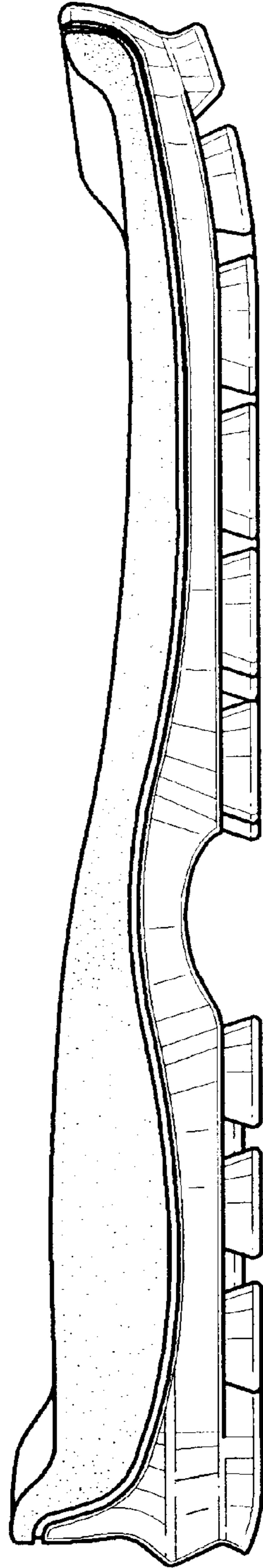

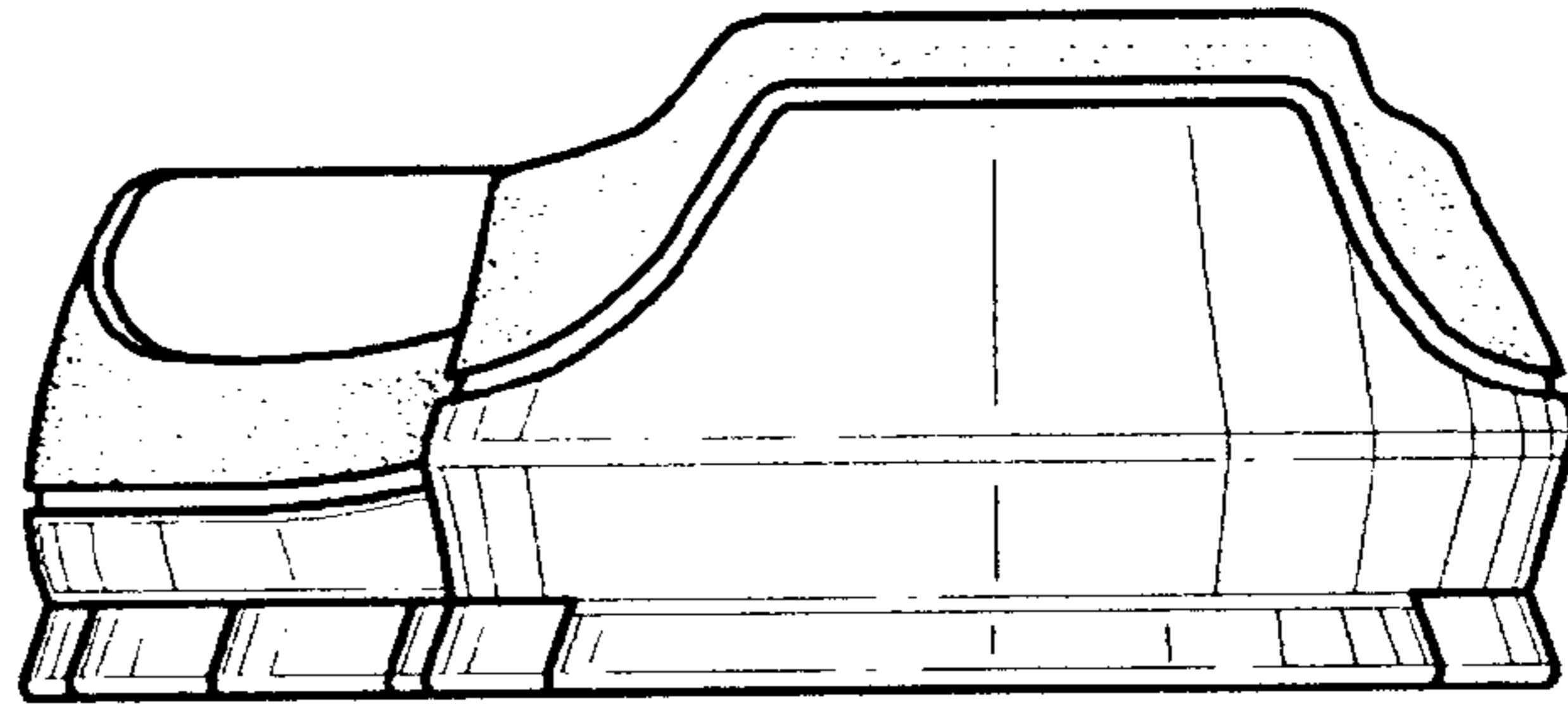

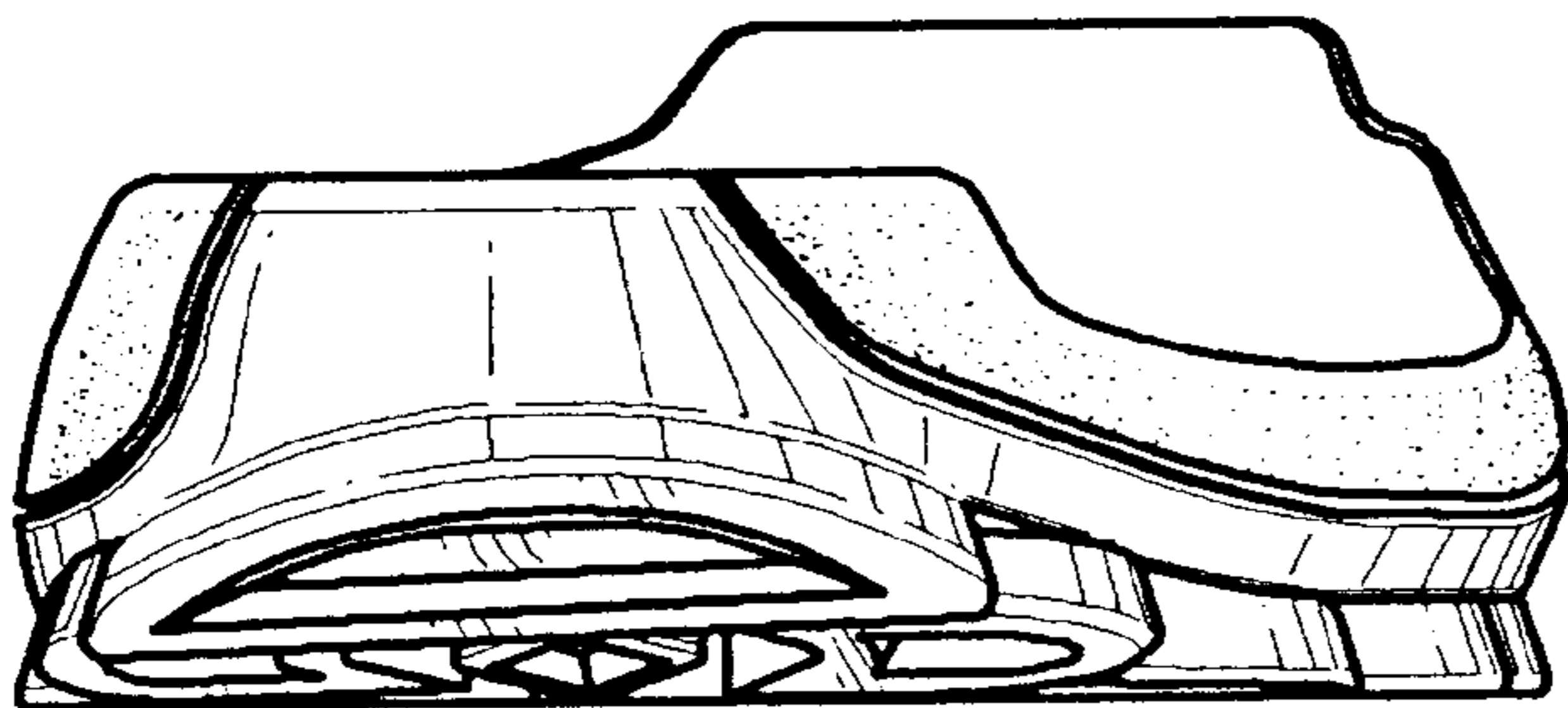
