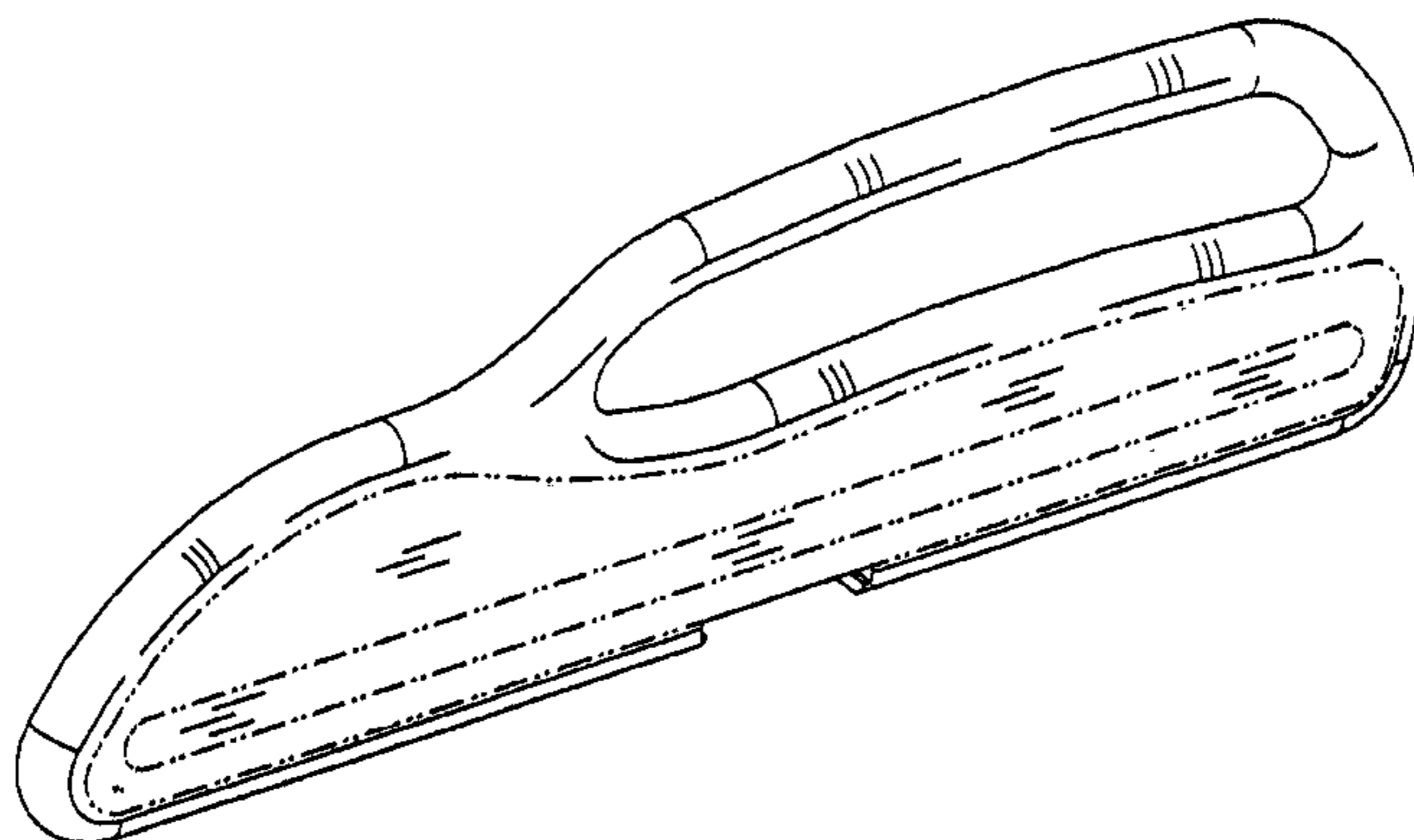
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a bed siderail;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is an end view of thereof;

FIG. 5 is another end view thereof;

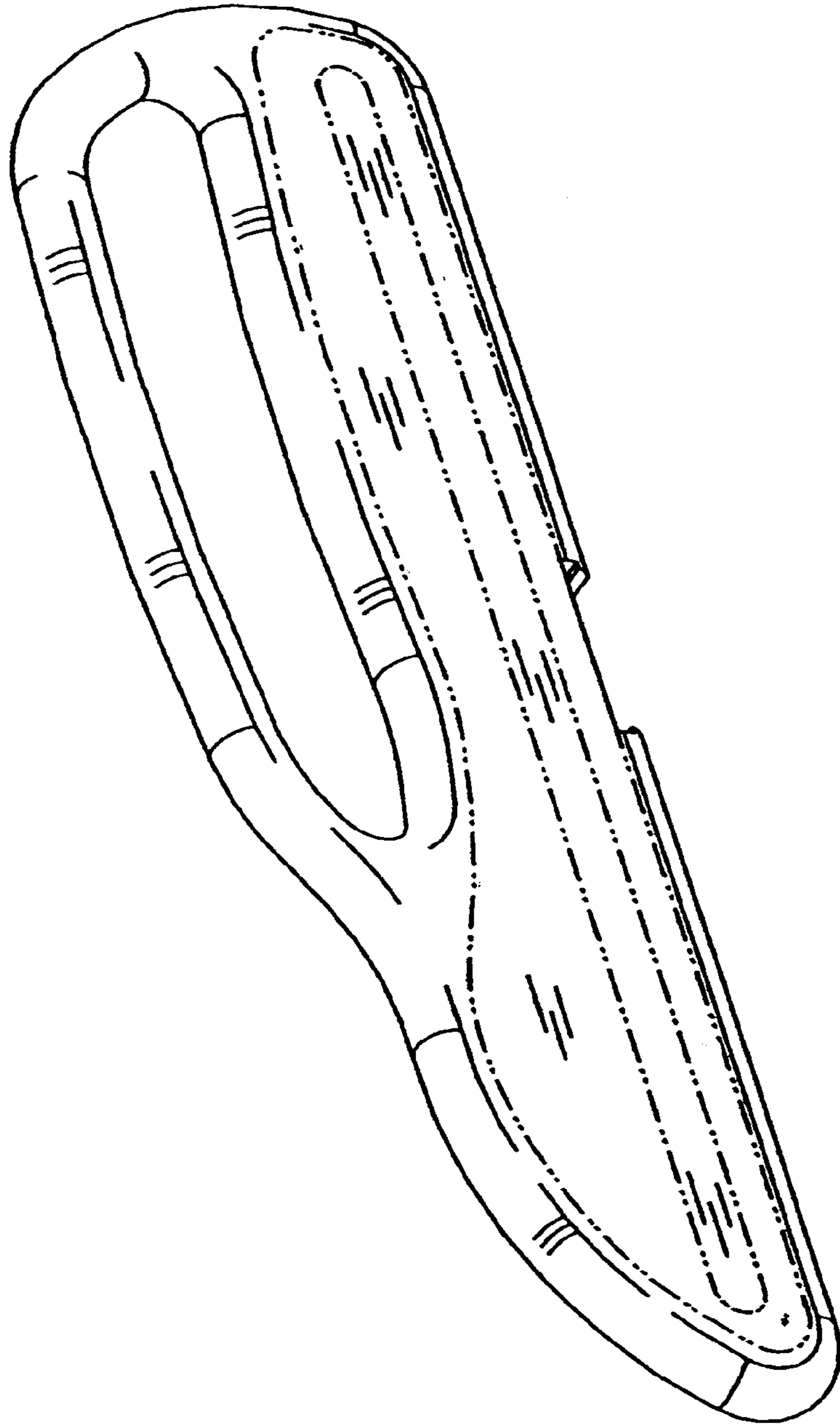

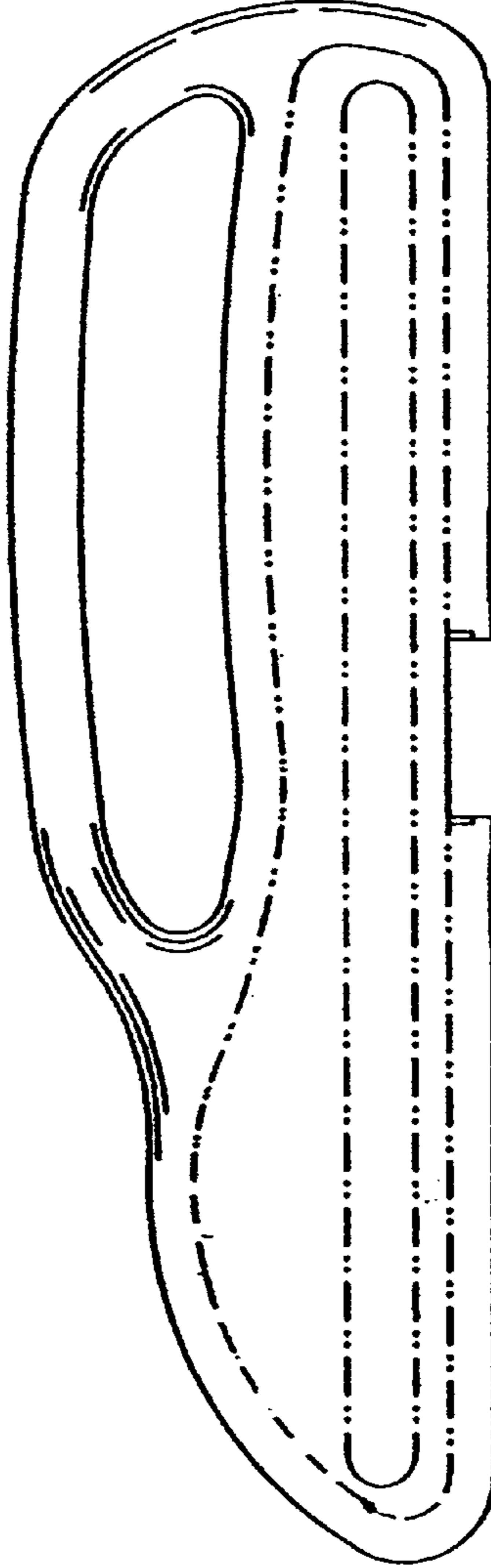
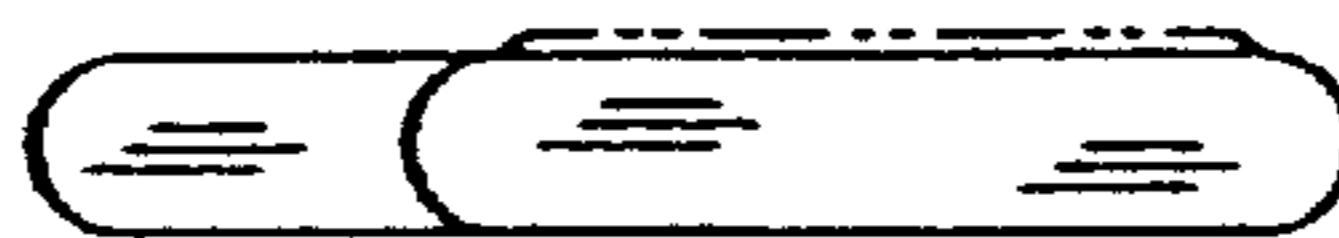

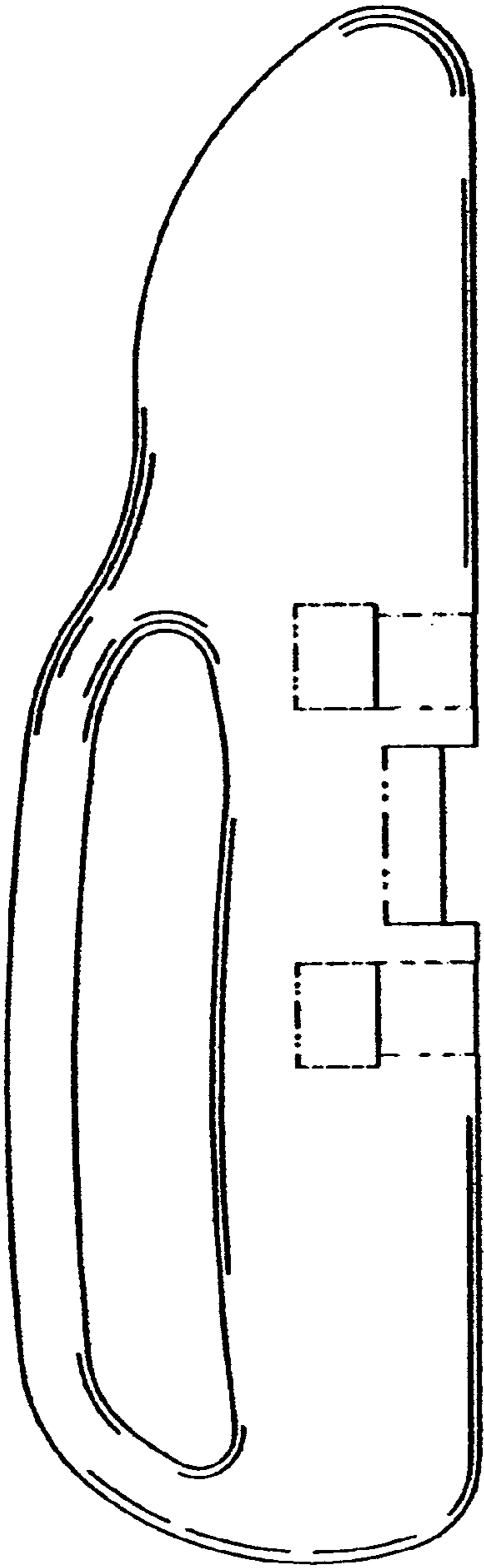
