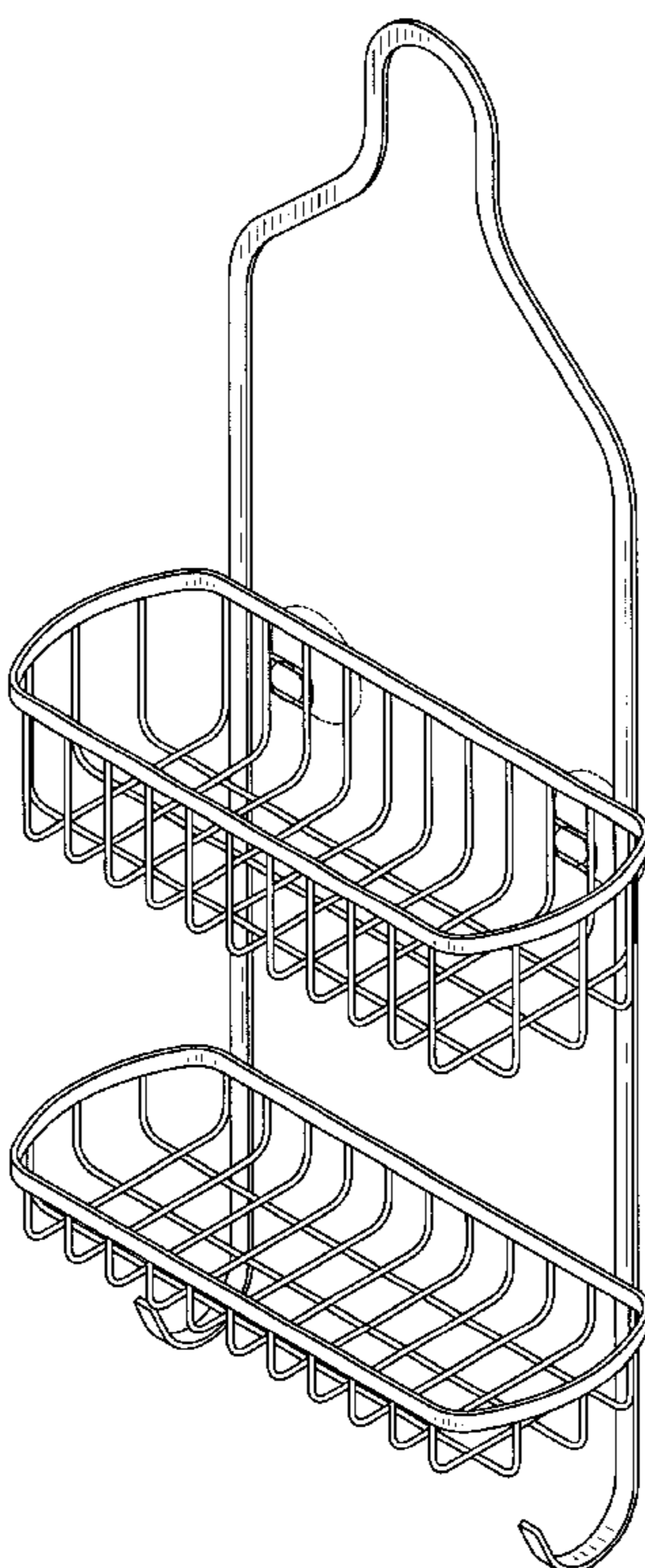
(57) **CLAIM**

The ornamental design for a shower caddy, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the shower caddy according to the invention;  
FIG. 2 is a top view of the shower caddy as shown in FIG. 1;  
FIG. 3 is a front view of the shower caddy as shown in FIG. 1;  
FIG. 4 is a side view of the shower caddy as shown in FIG. 1;  
FIG. 5 is a rear view of the shower caddy as shown in FIG. 1;  
FIG. 6 is a side view of the shower caddy taken from the opposite side as shown in FIG. 4; and,  
FIG. 7 is a bottom view of the shower caddy as shown in FIG. 1.

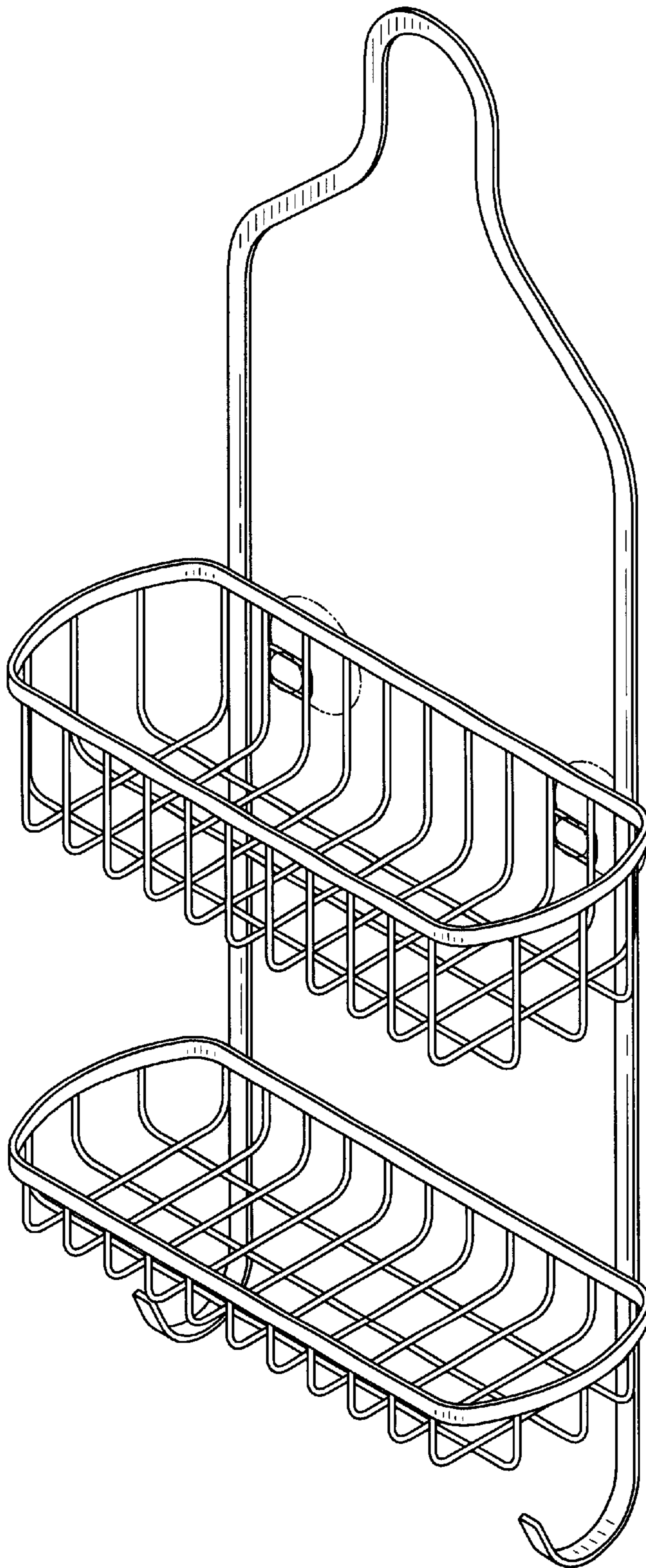

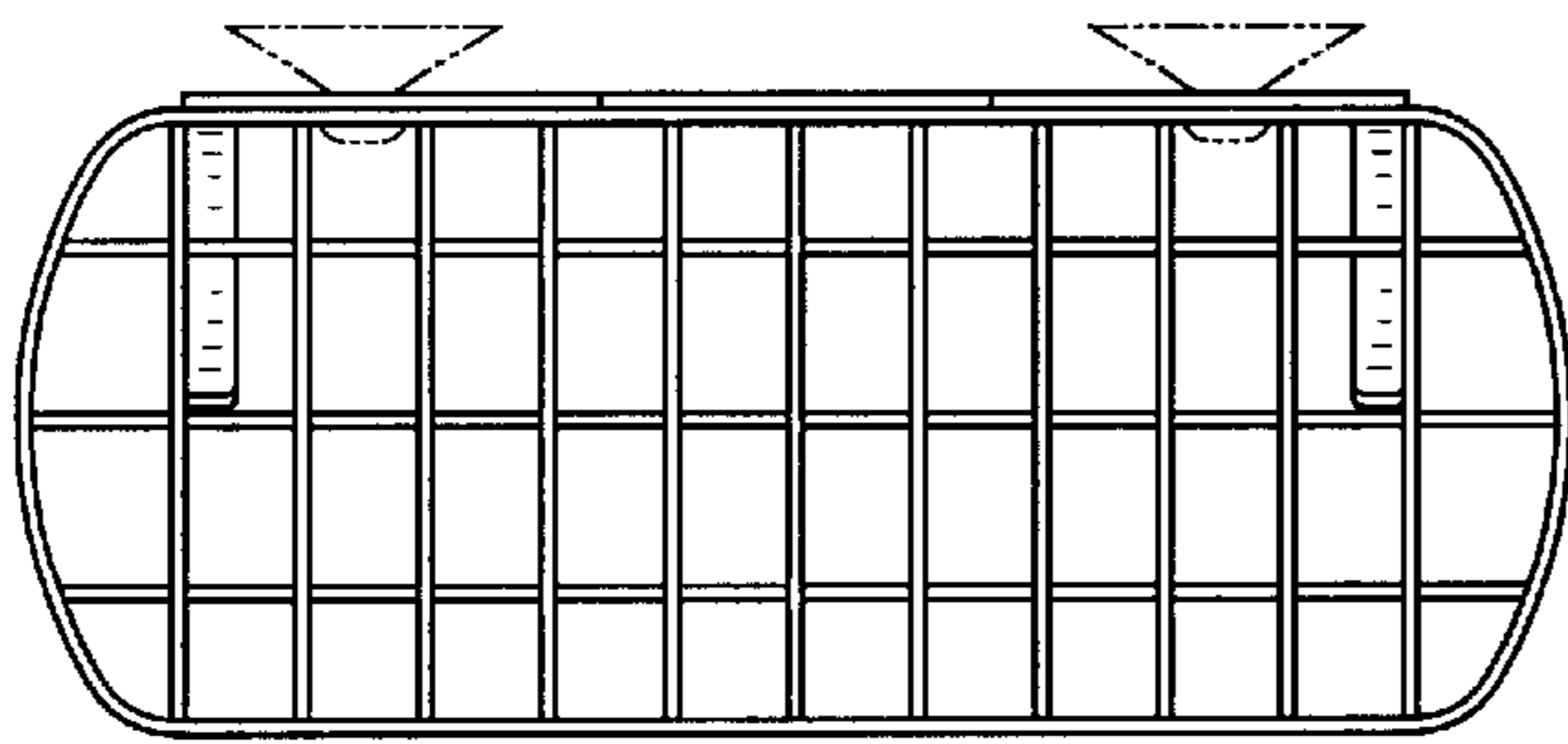

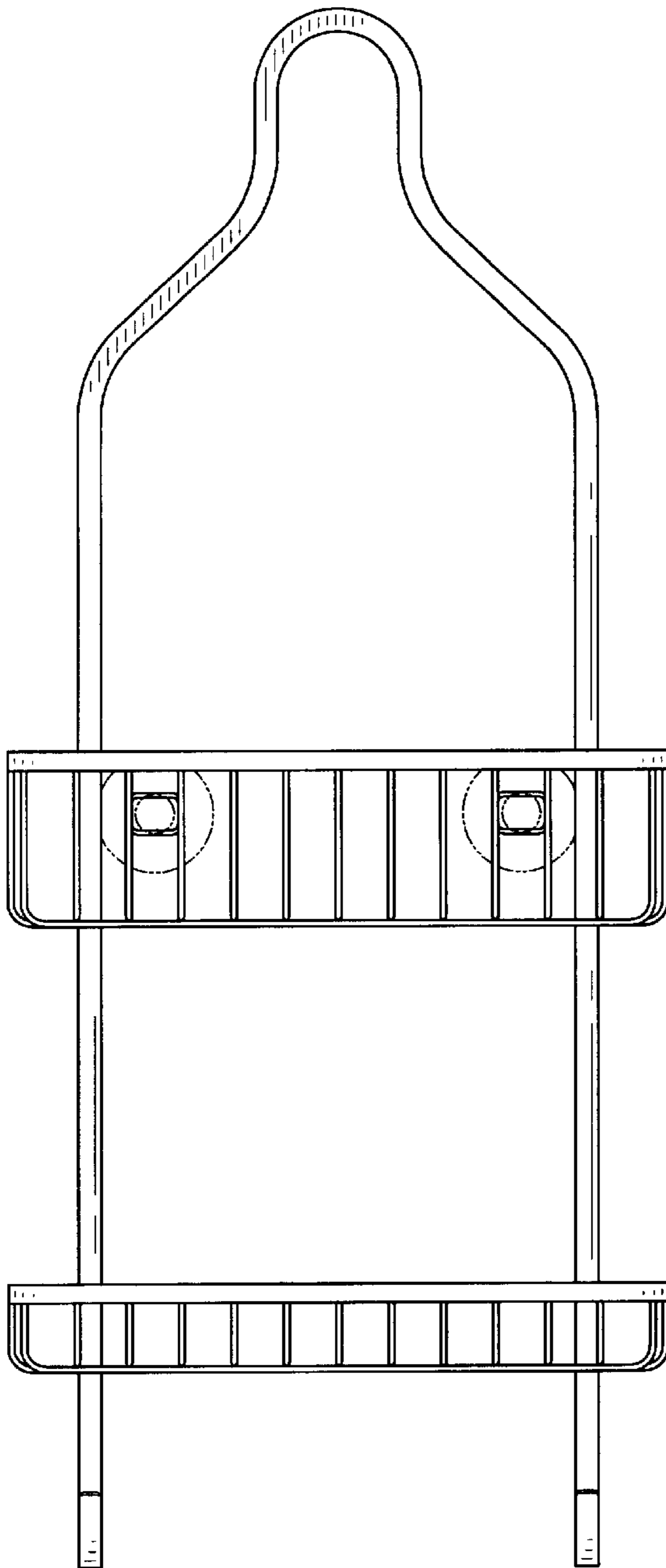

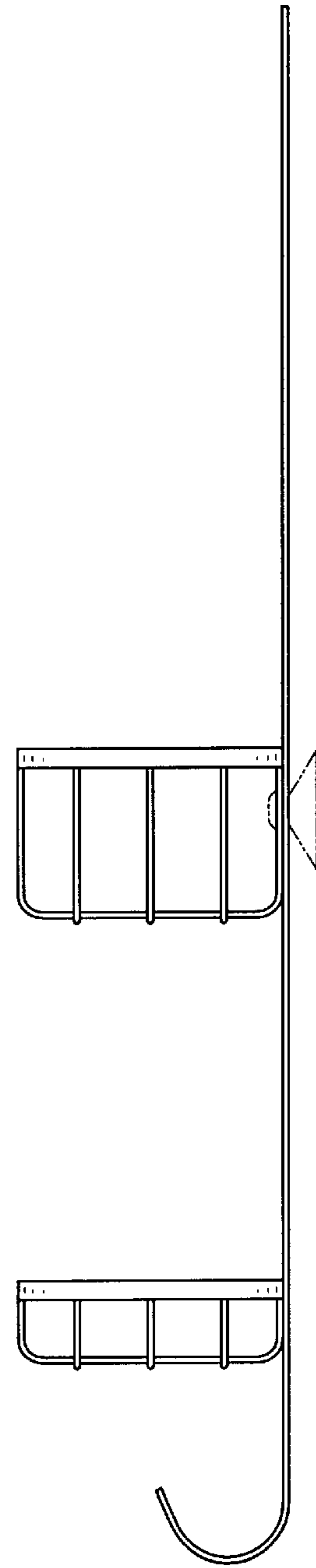

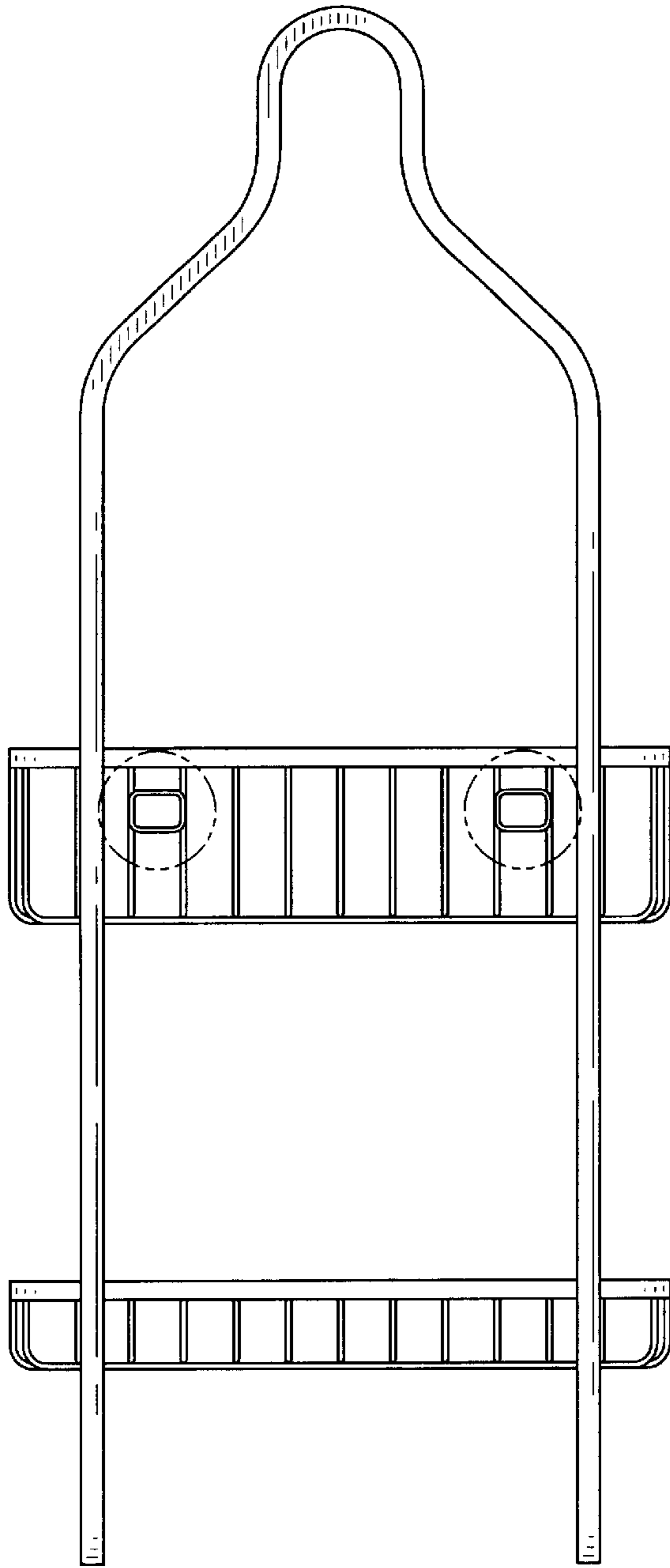

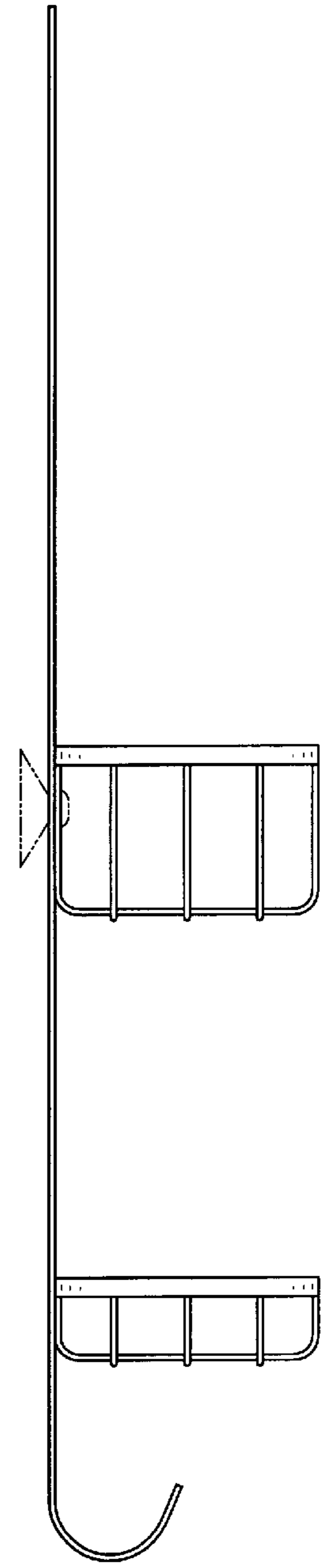

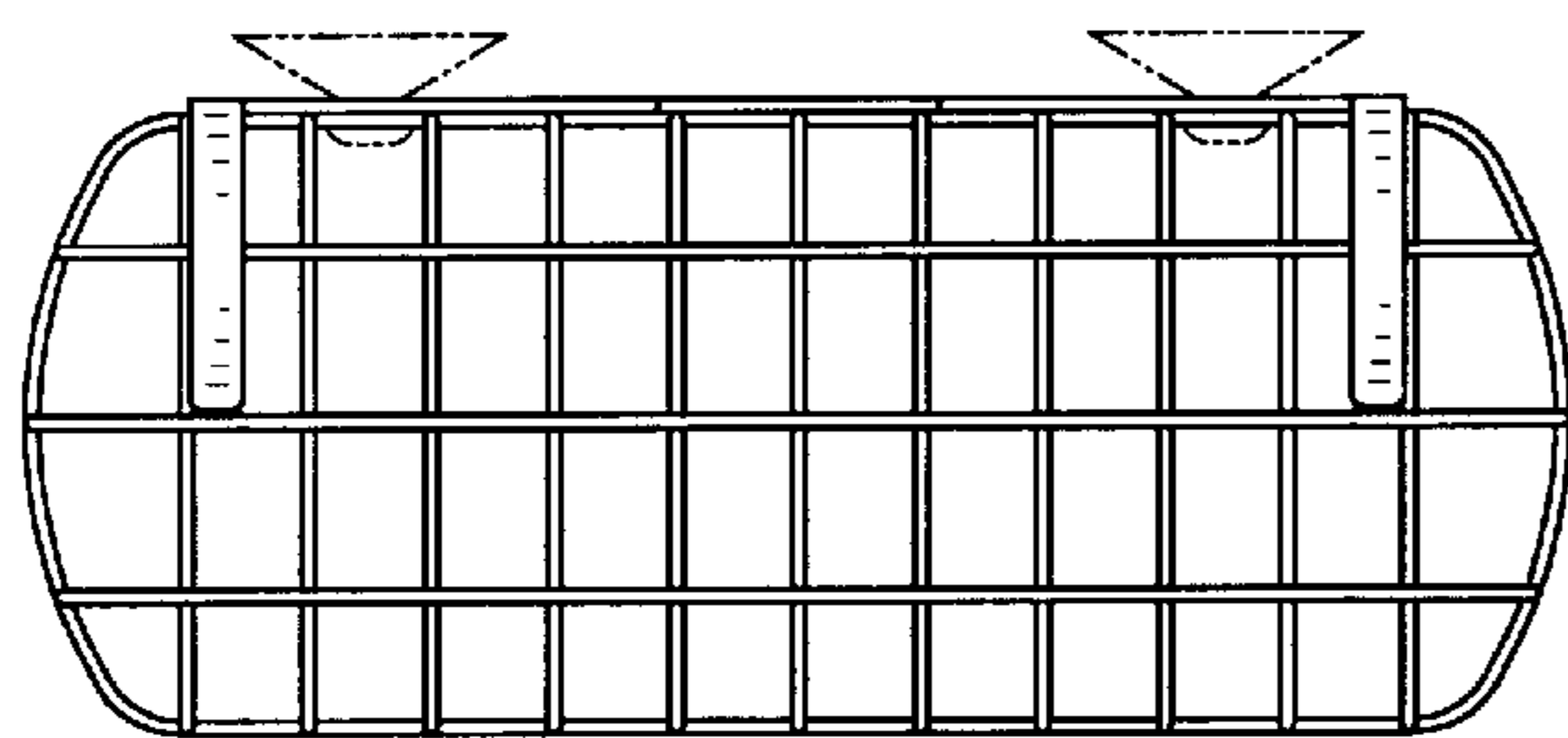
