(57) **CLAIM**

The ornamental design for a table cover runner, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a table cover runner showing my new design, the bottom view being identical thereto;
 FIG. 2 is a front elevation view of the table cover runner shown in FIG. 1, the back elevation view being identical thereto;
 FIG. 3 is a left elevation view of the table cover runner shown in FIG. 1, the right elevation view being identical thereto;
 FIG. 4 is a top plan view of a second embodiment of a table cover runner showing my new design;
 FIG. 5 is a front elevation view of the table cover runner shown in FIG. 4, the back elevation view being identical thereto;
 FIG. 6 is a left elevation view of the table cover runner shown in FIG. 4, the right elevation view being identical thereto;
 FIG. 7 is a bottom view of the table cover runner shown in FIG. 4,
 FIG. 8 is a top plan view of a third embodiment of a table cover runner showing my new design, the third embodiment being red with white trim;
 FIG. 9 is a front elevation view of the table cover runner shown in FIG. 8, the back elevation view being identical thereto;
 FIG. 10 is a left elevation view of the table cover runner shown in FIG. 8, the right elevation view being identical thereto; and,
 FIG. 11 is a bottom view of the table cover runner shown in FIG. 8.

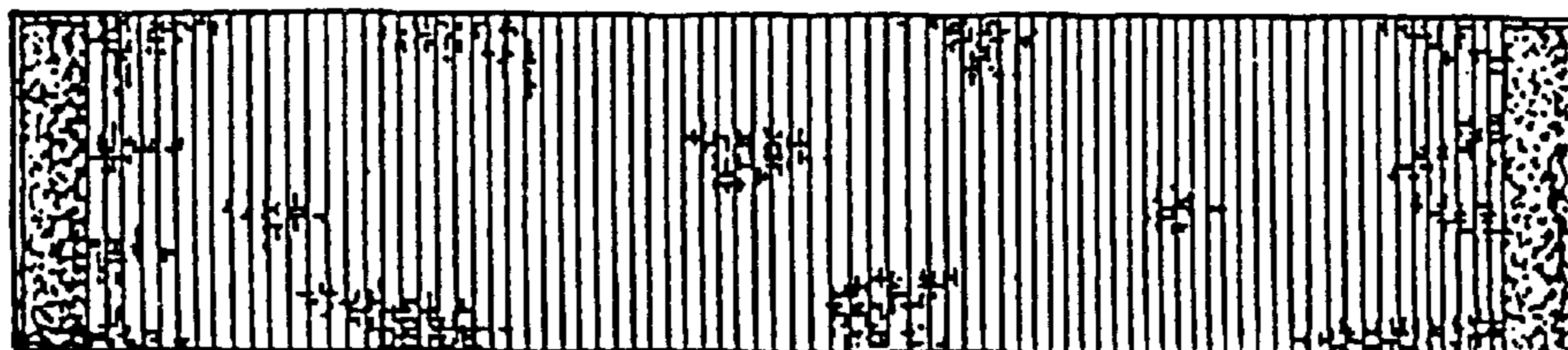
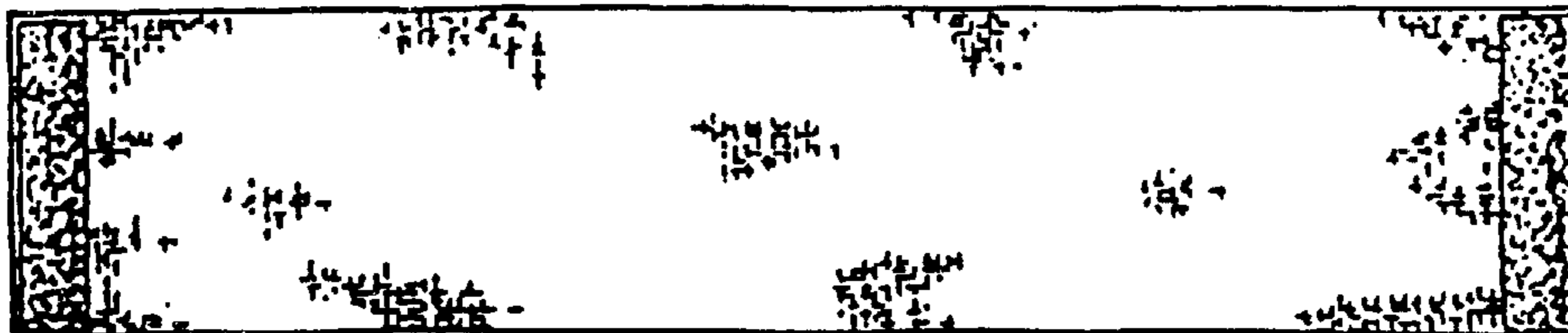

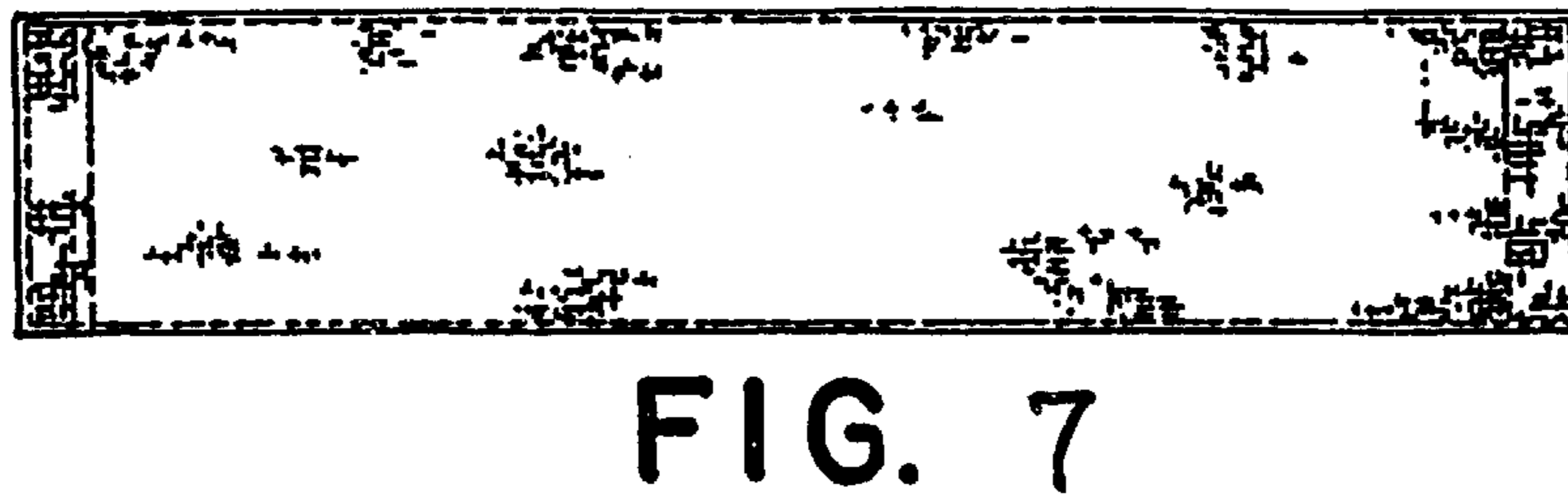
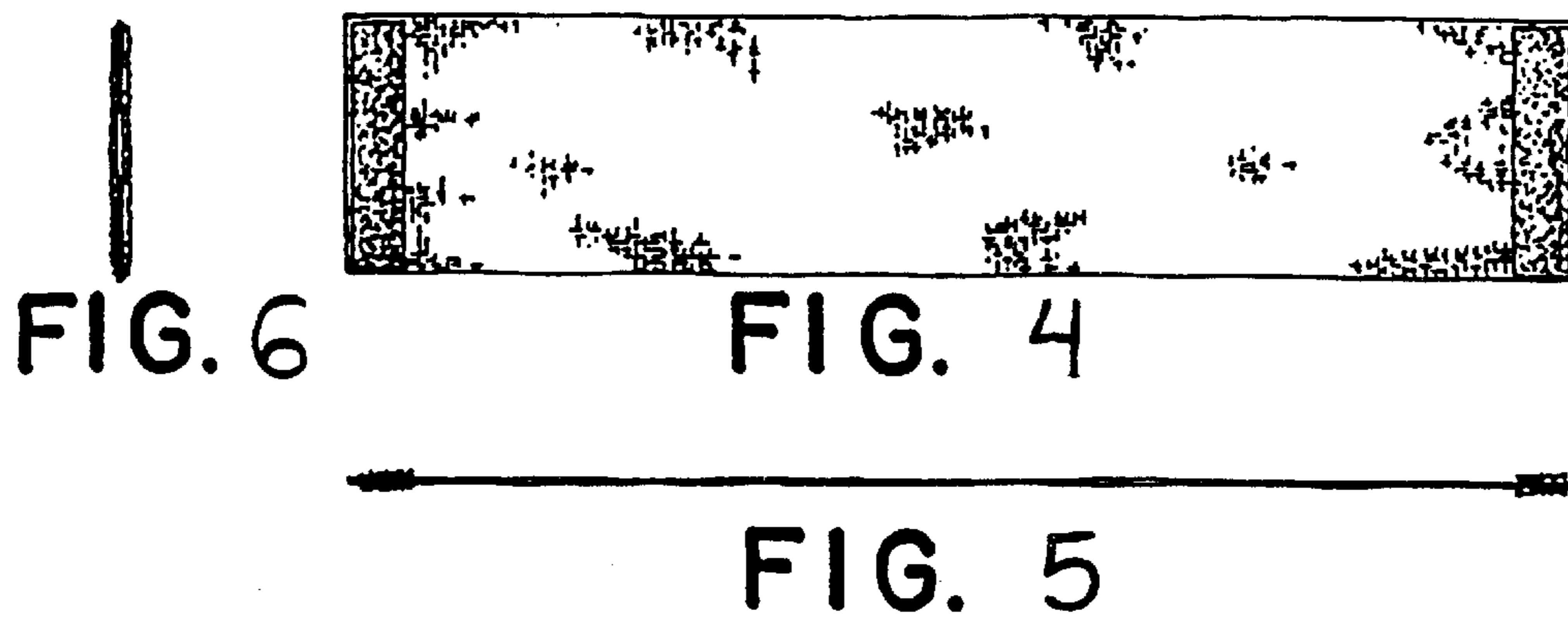
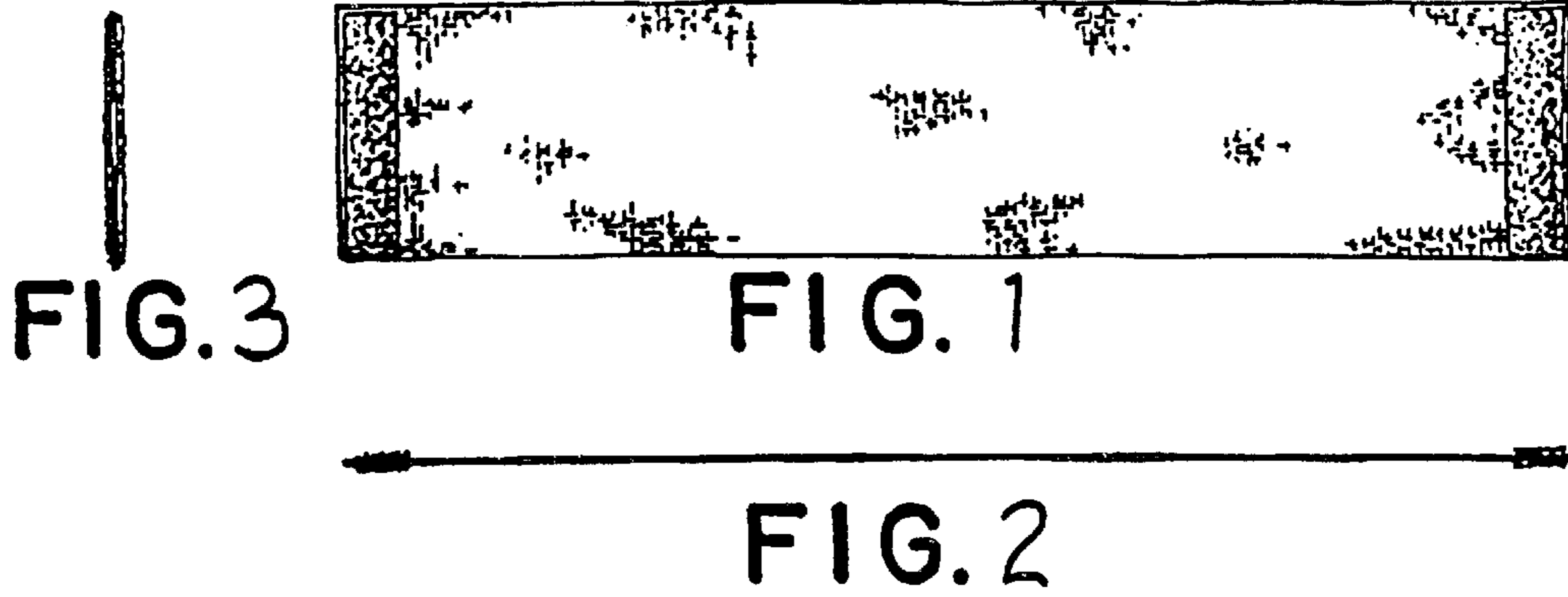

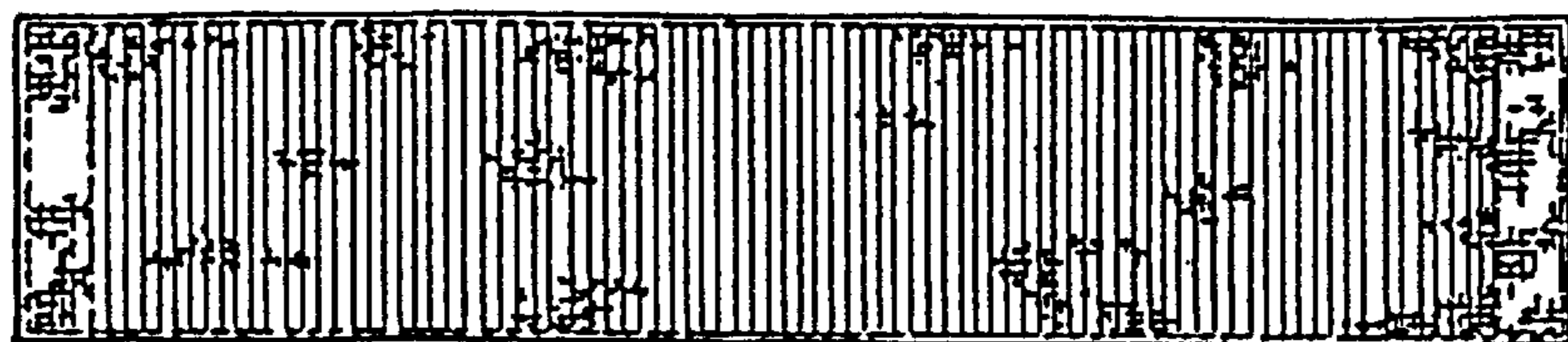
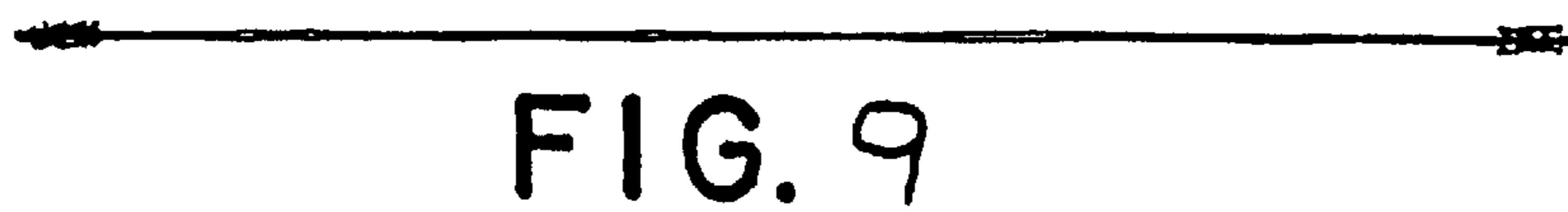
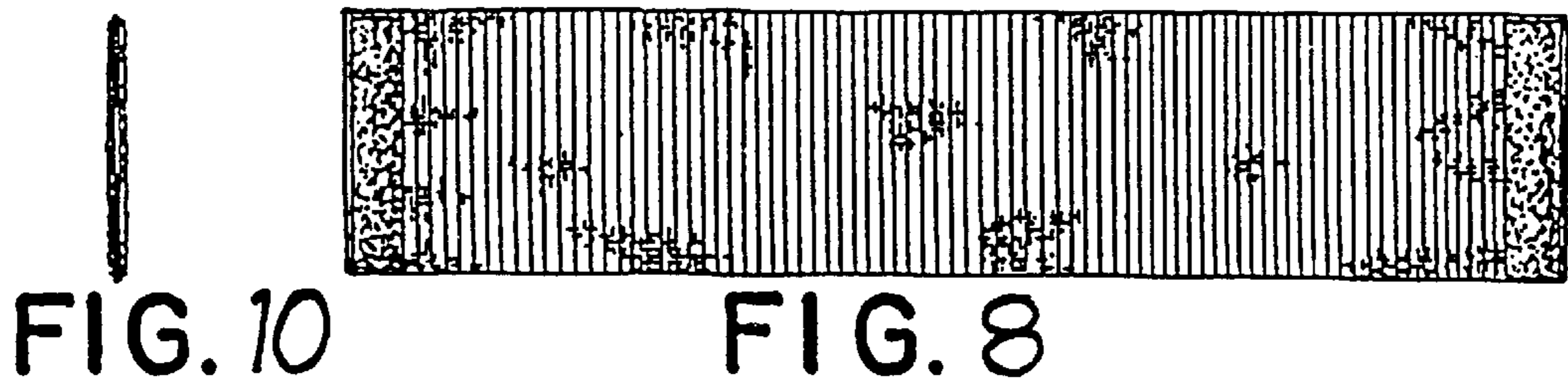
