The ornamental design for bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bottle with a colored label;

FIG. 2 is a rear elevational view of the bottle;

FIG. 3 is a side elevational view of the bottle;

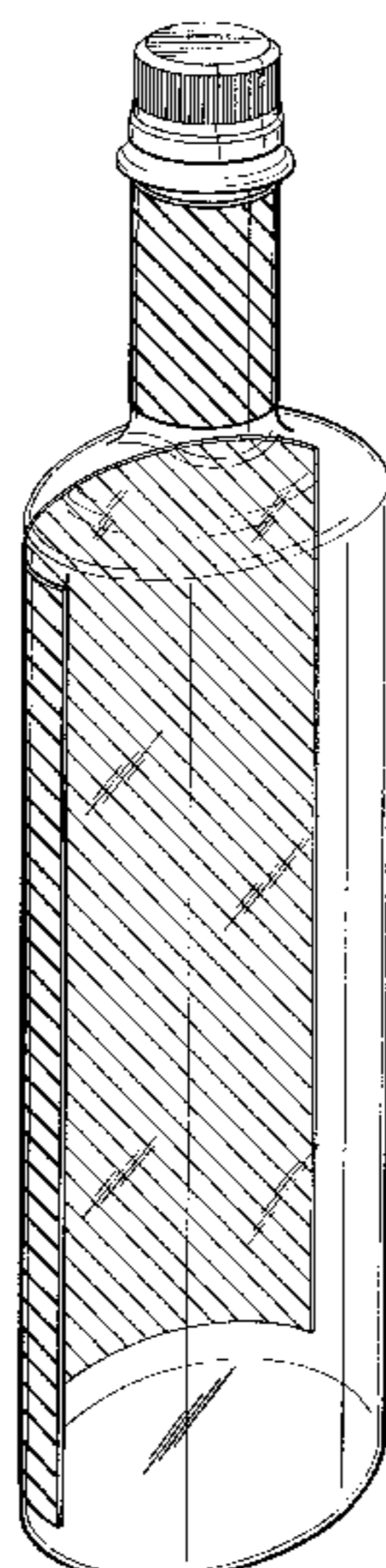
FIG. 4 is the top plan view of the bottle, shown up in a large scale of the bottle of FIG. 1.

FIG. 5 is a bottom plan view of the bottle, shown up in a large scale of the bottle of FIG. 1.

FIG. 6 is a front elevational view of the bottle, shown at the same scale as the bottle of FIG. 1; and,

FIG. 7 is a side elevational view of the bottle from the opposite side to FIG. 3 shown at the same scale as the bottle of FIG. 1.

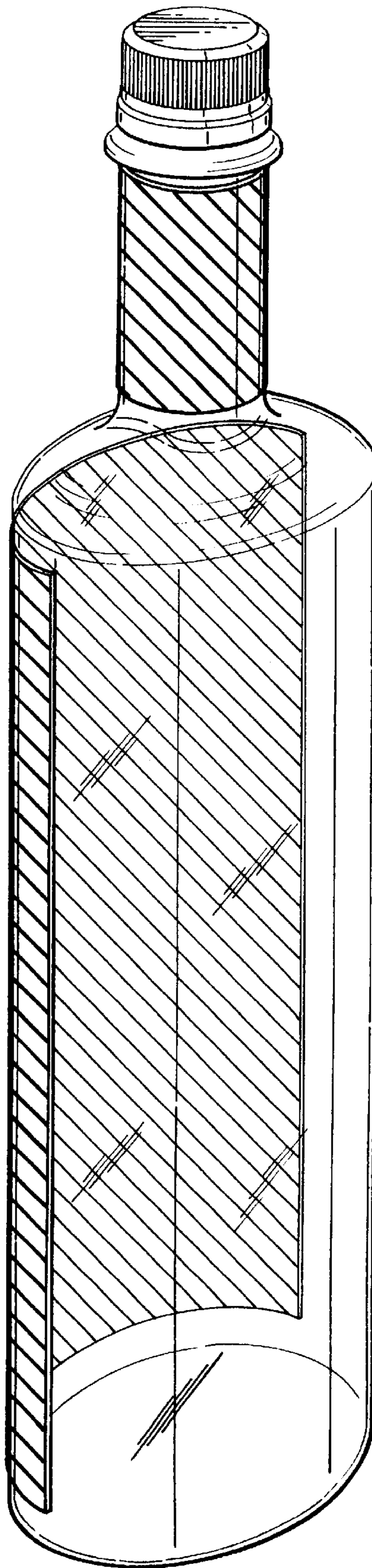

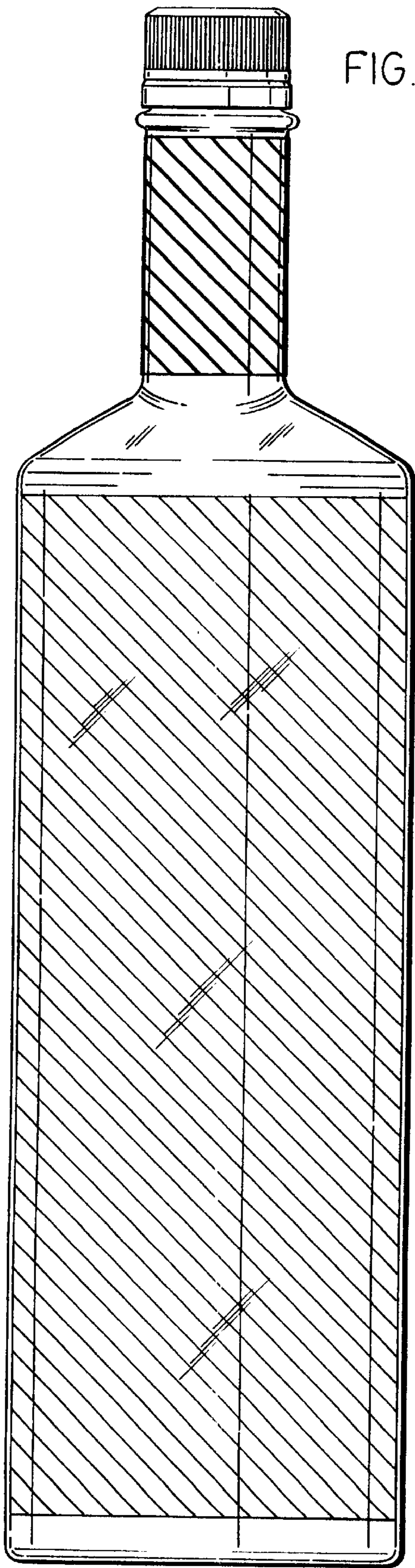

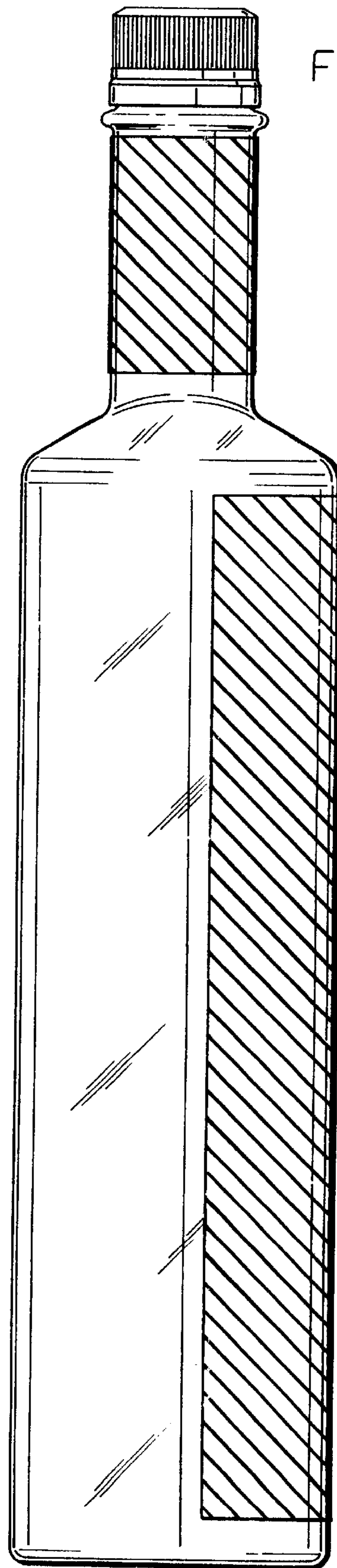

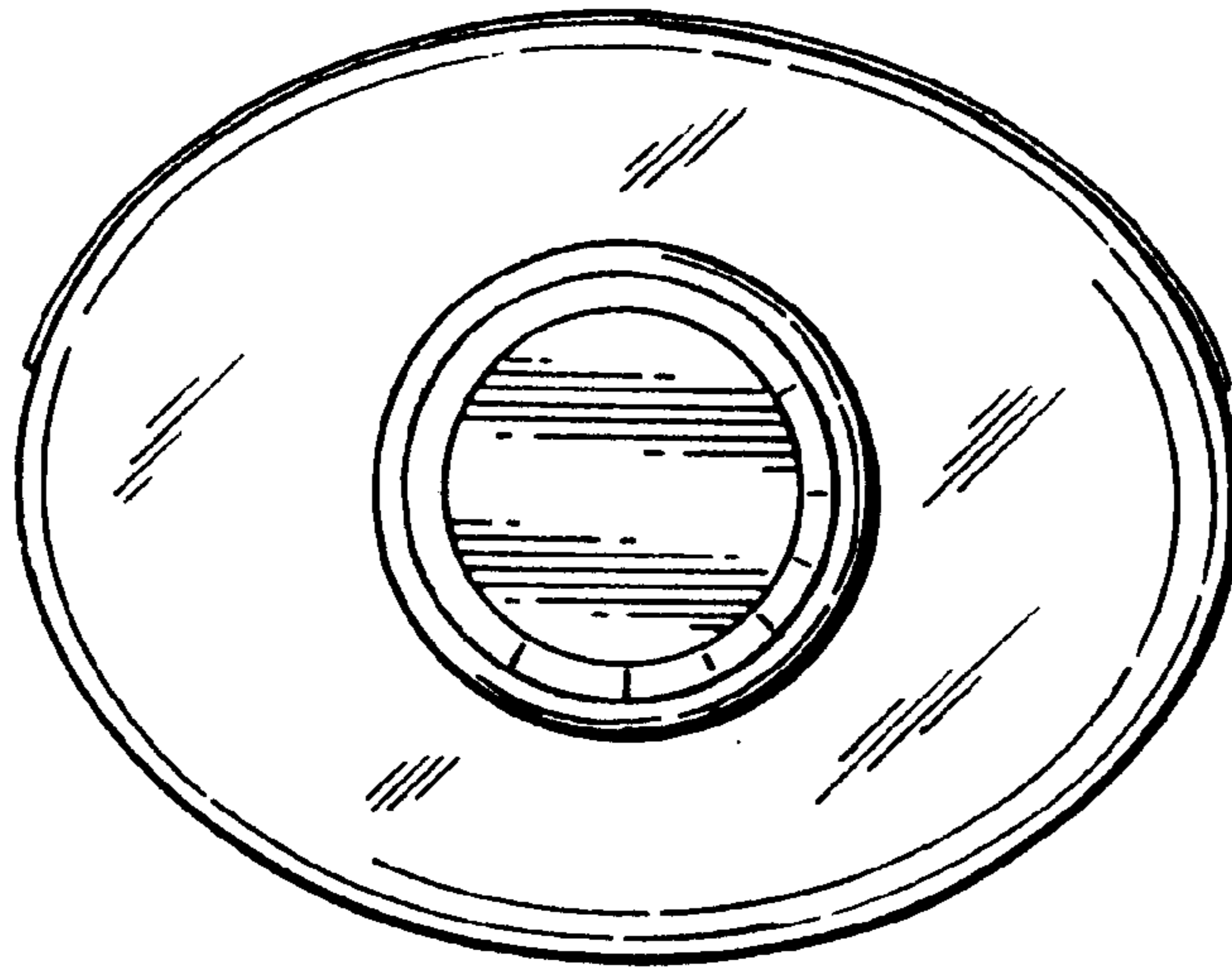

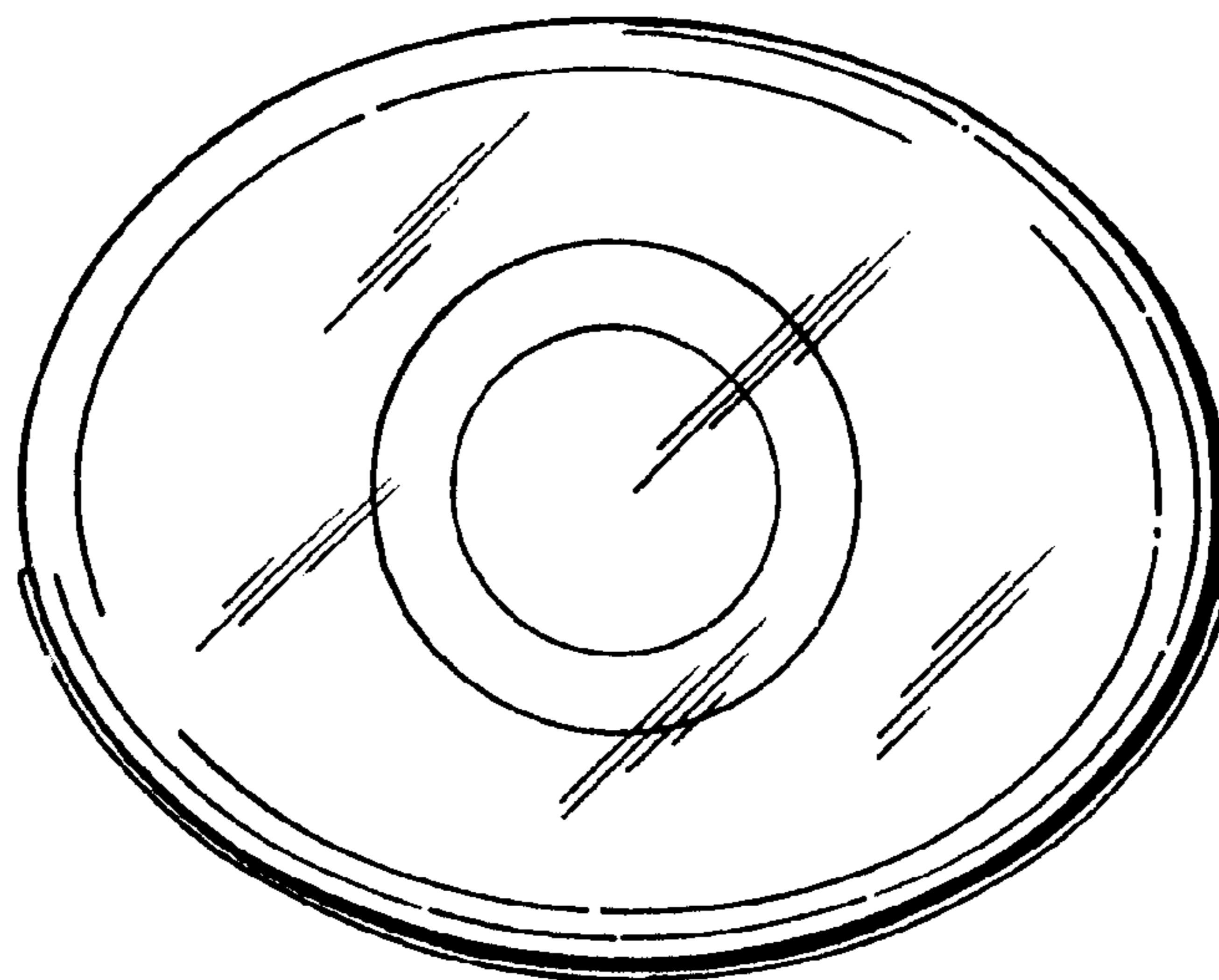

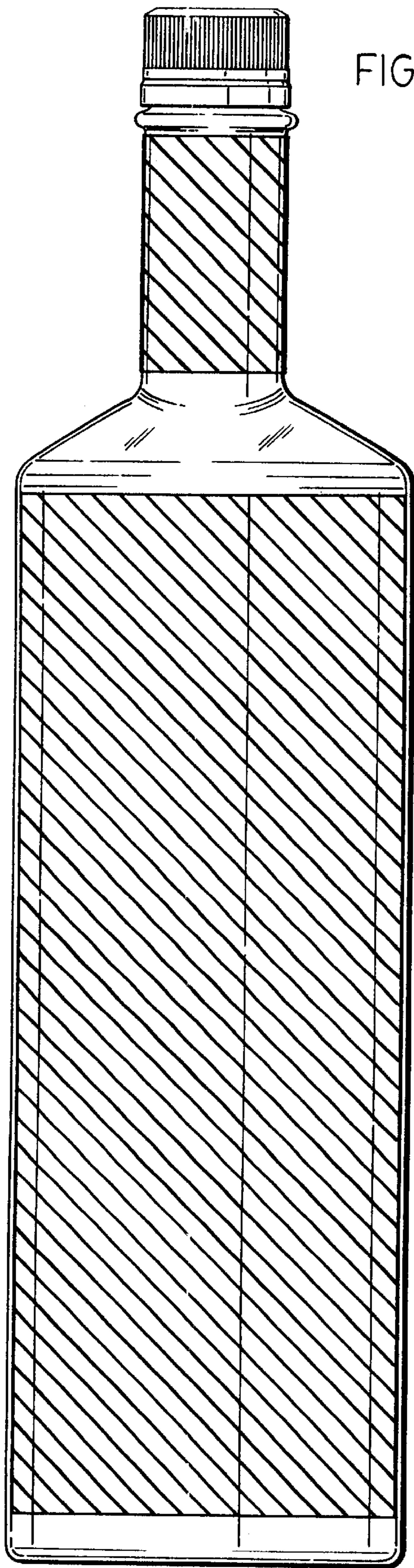

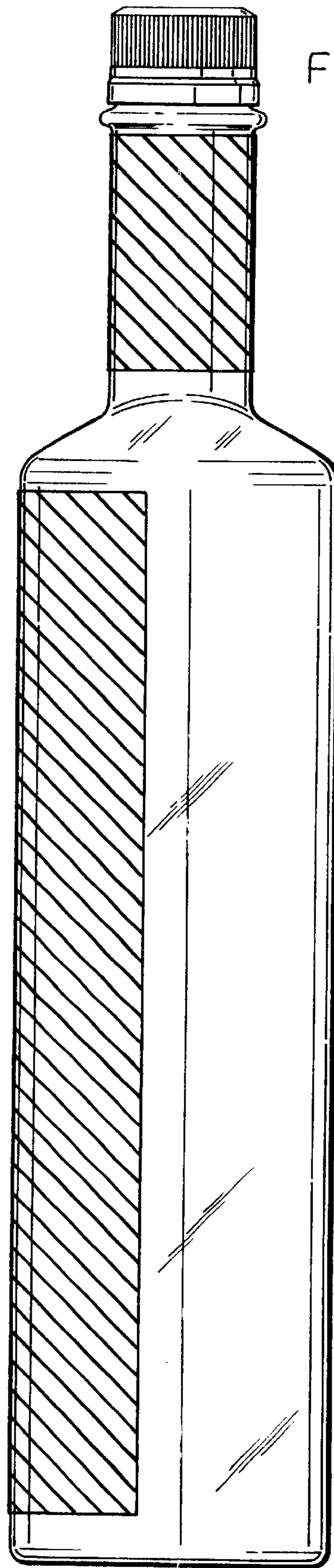
