(57) **CLAIM**

The ornamental design for a suspension fork for cycles, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the suspension fork for cycles;

FIG. 2 is an enlarged front elevation view of FIG. 1;

FIG. 3 is an enlarged rear elevation view of FIG. 1;

FIG. 4 is an enlarged right side elevation view of FIG. 1;

FIG. 5 is an enlarged left side elevation view of FIG. 1;

FIG. 6 is an enlarged top plan view of FIG. 1;

FIG. 7 is an enlarged bottom plan view of FIG. 1;

FIG. 8 is a front perspective view of a second embodiment of the suspension fork for cycles;

FIG. 9 is an enlarged front elevation view of FIG. 8;

FIG. 10 is an enlarged rear elevation view of FIG. 8;

FIG. 11 is an enlarged right side elevation view of FIG. 8;

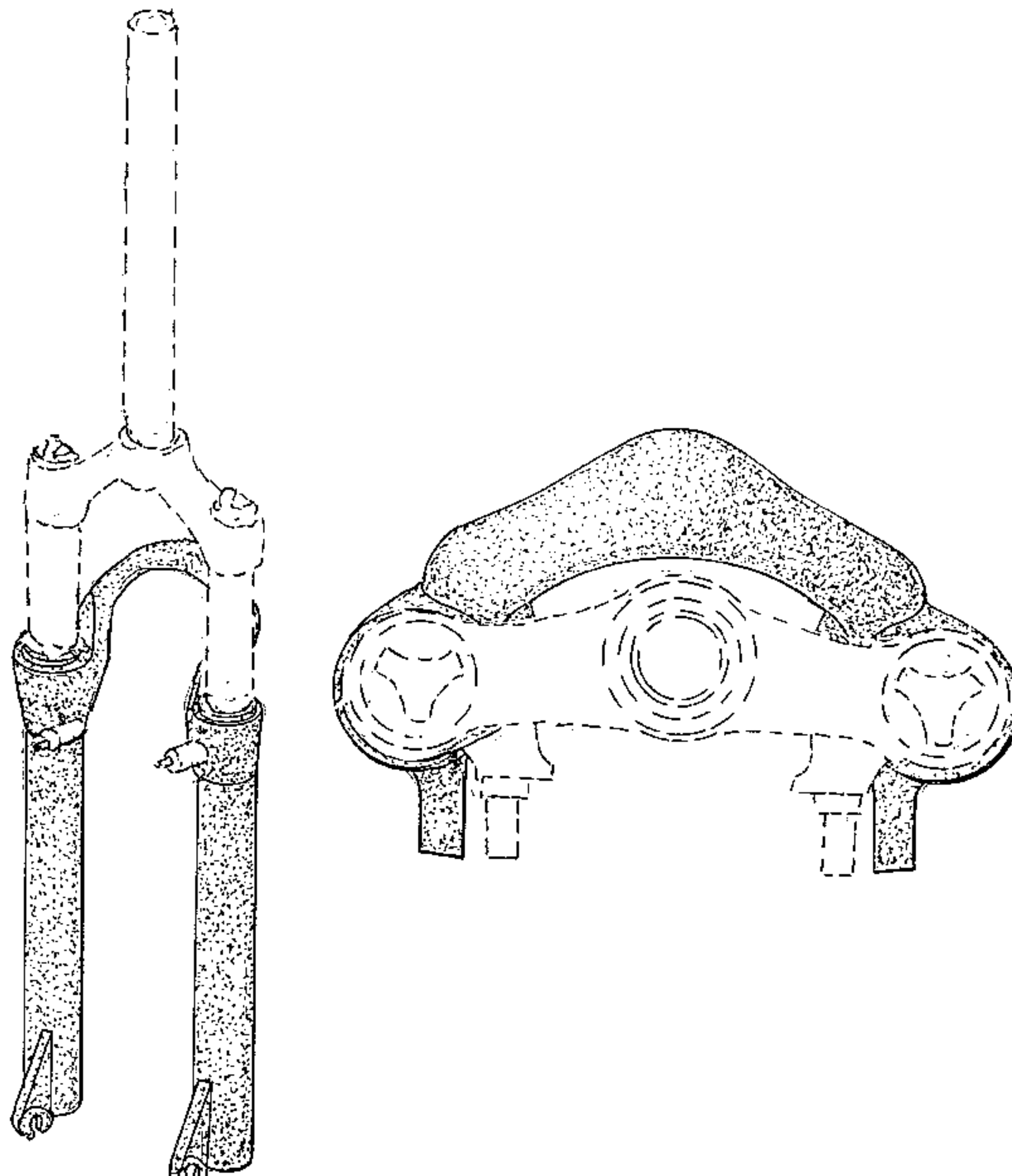
FIG. 12 is an enlarged left side elevation view of FIG. 8;

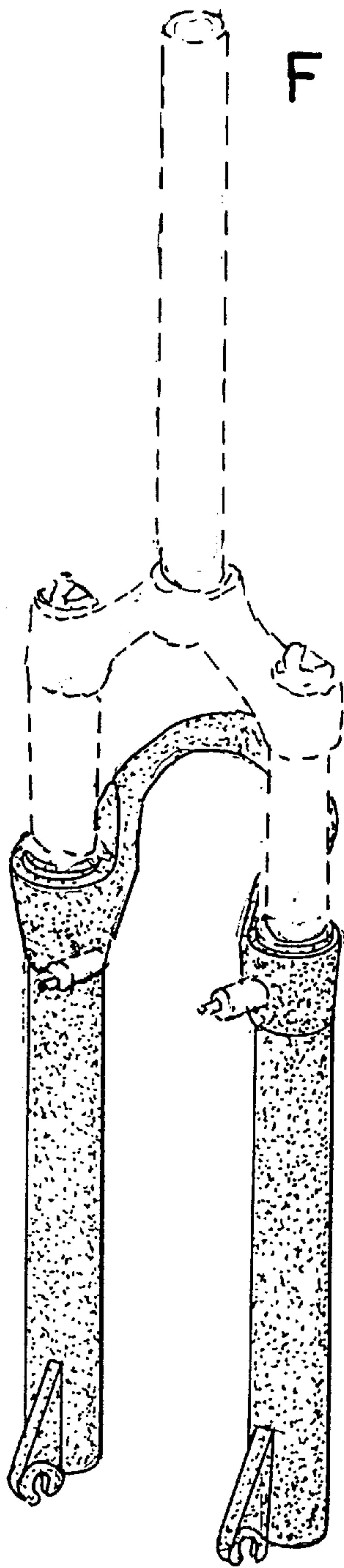

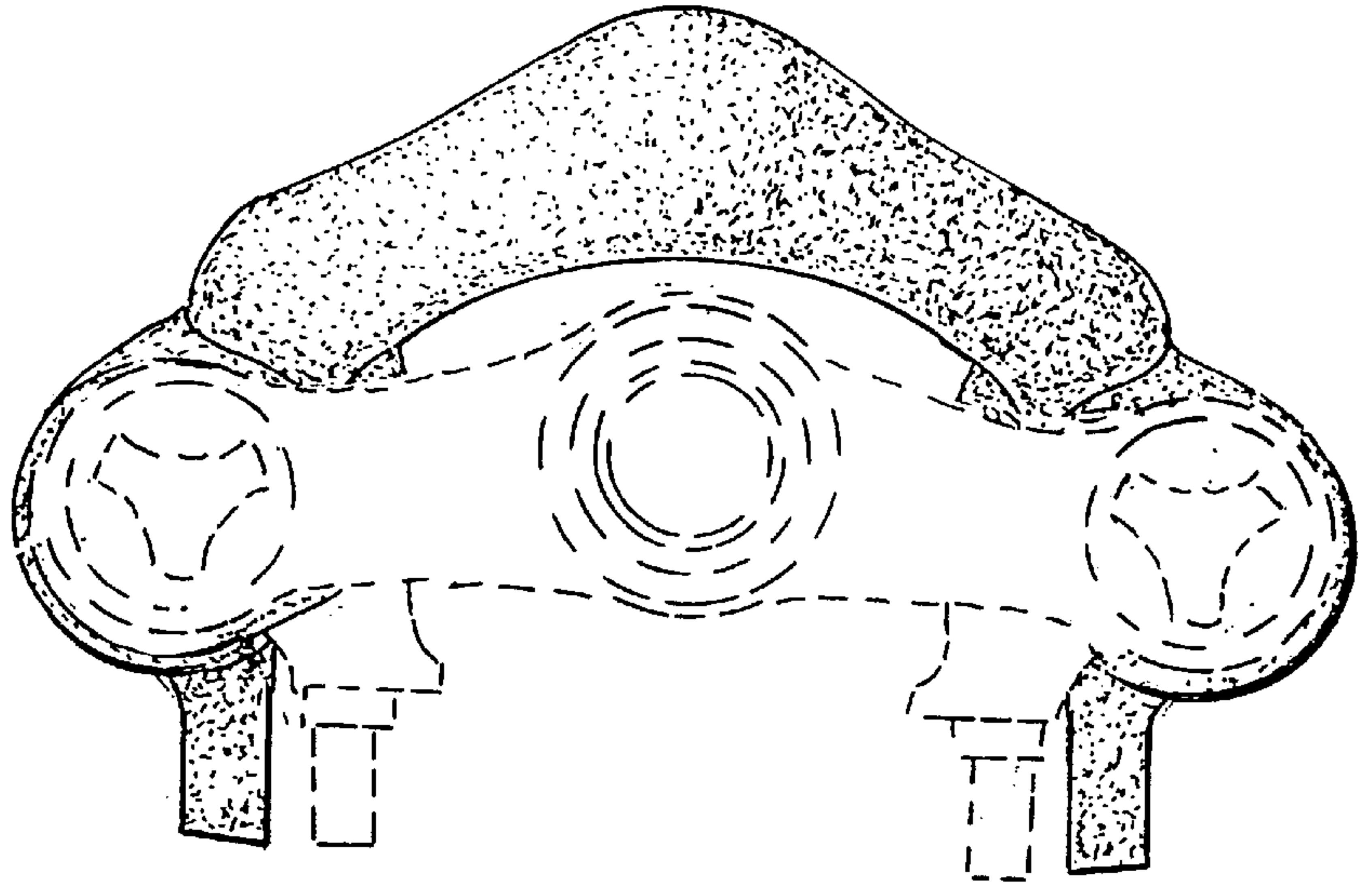

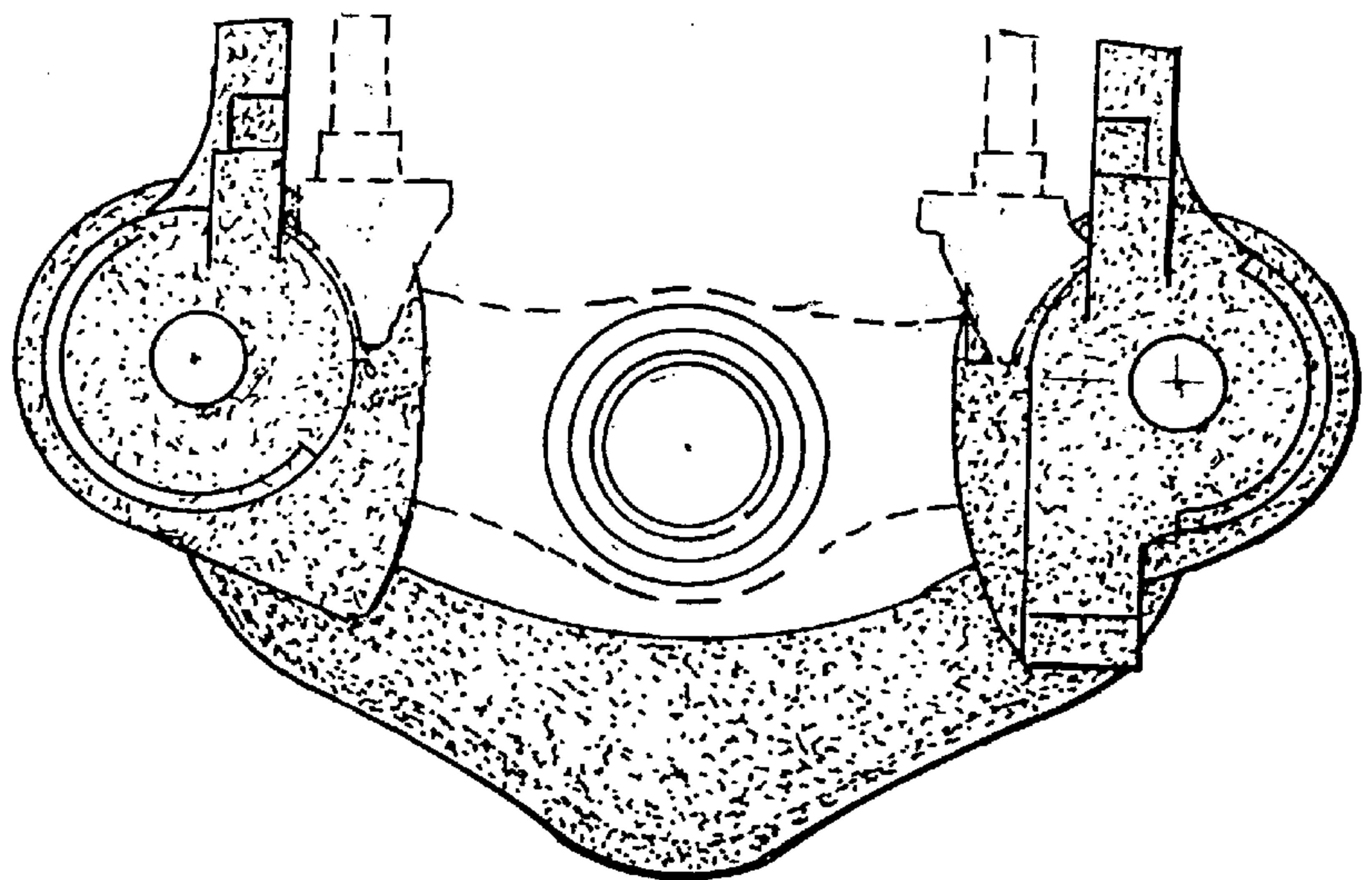

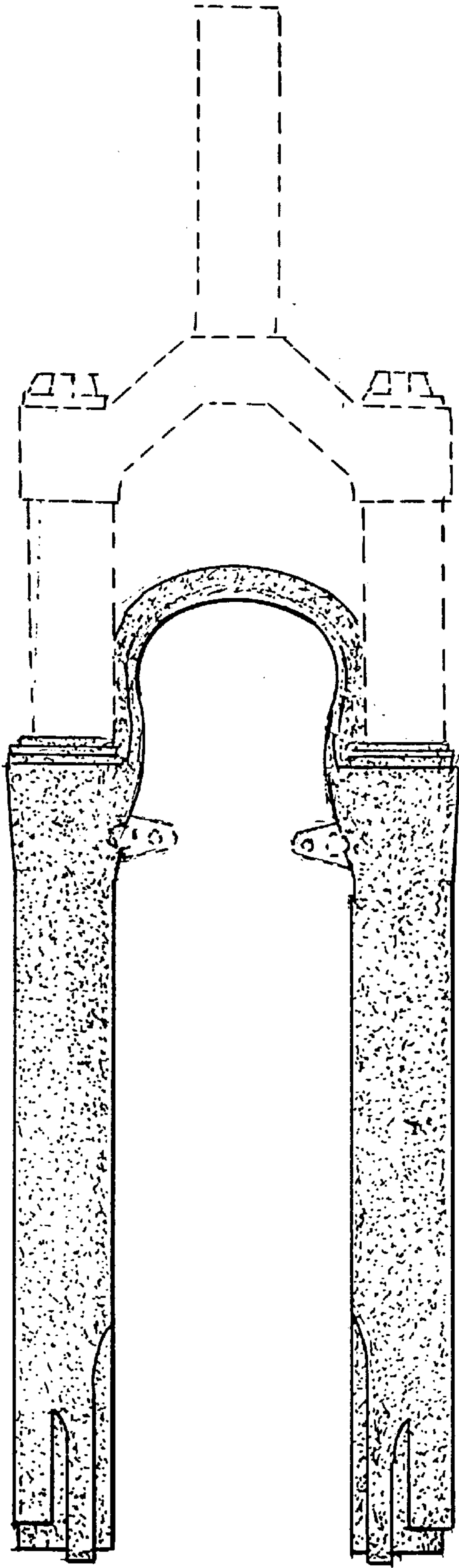

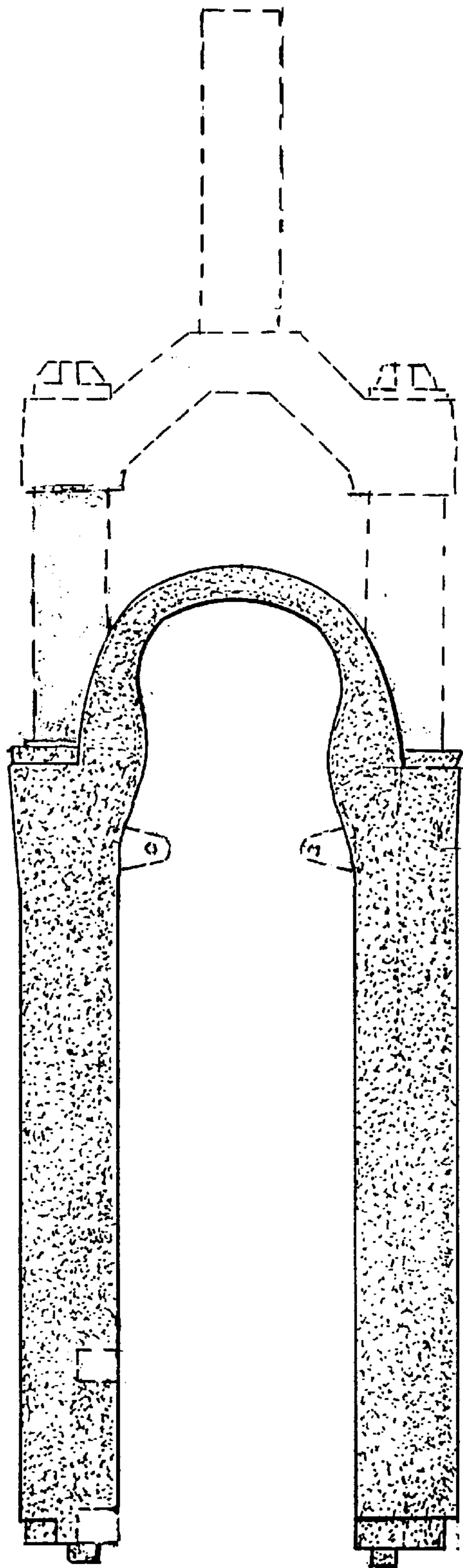

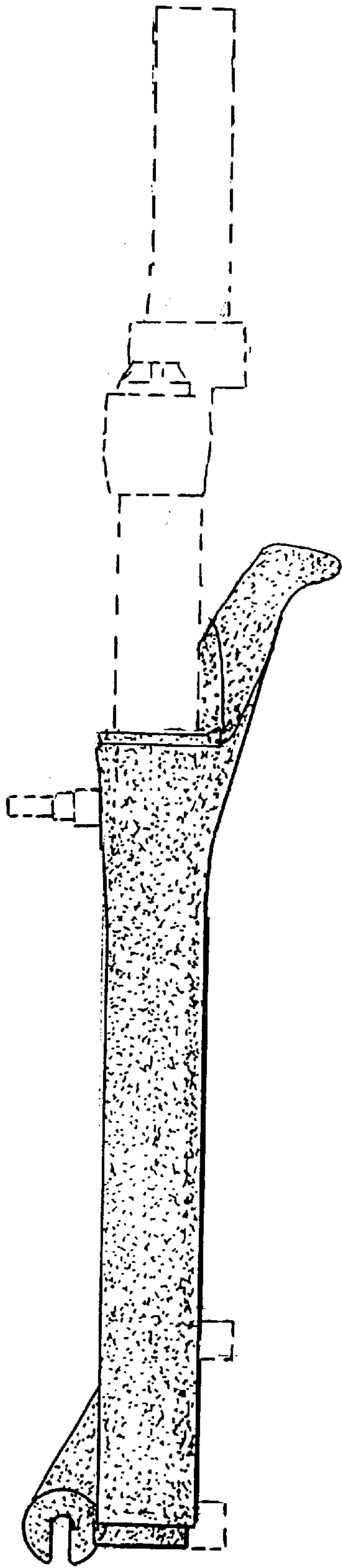

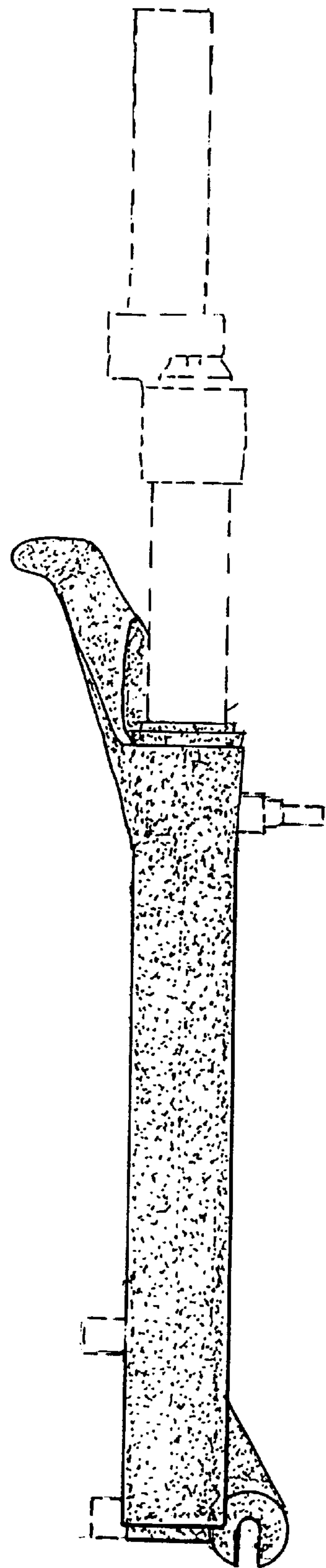

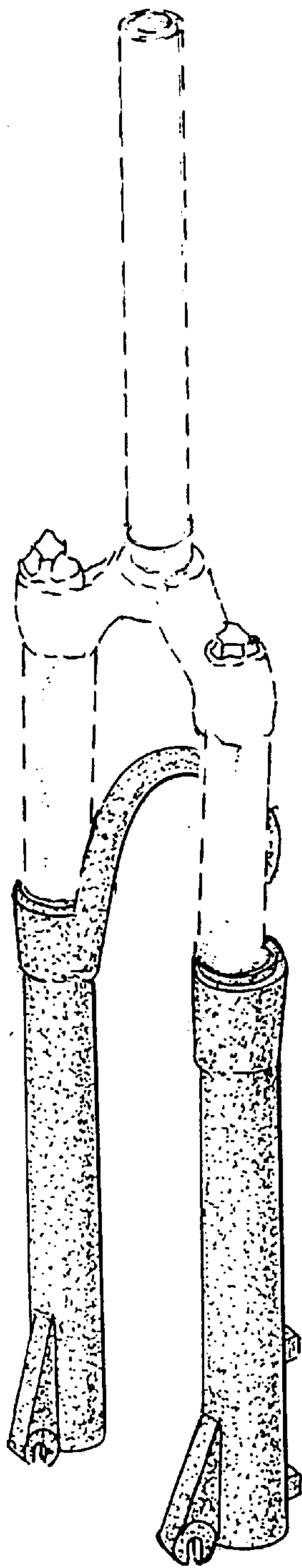
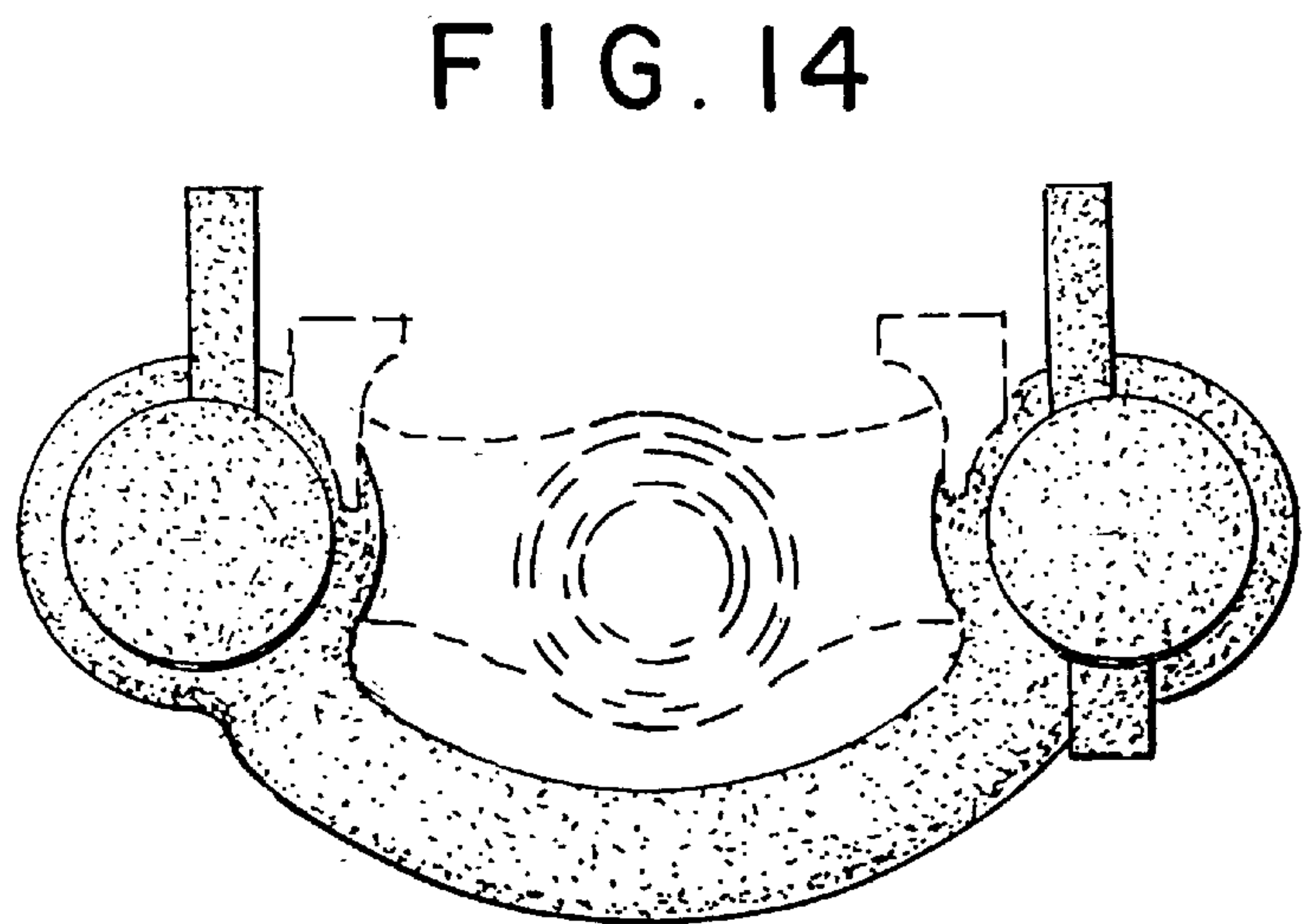
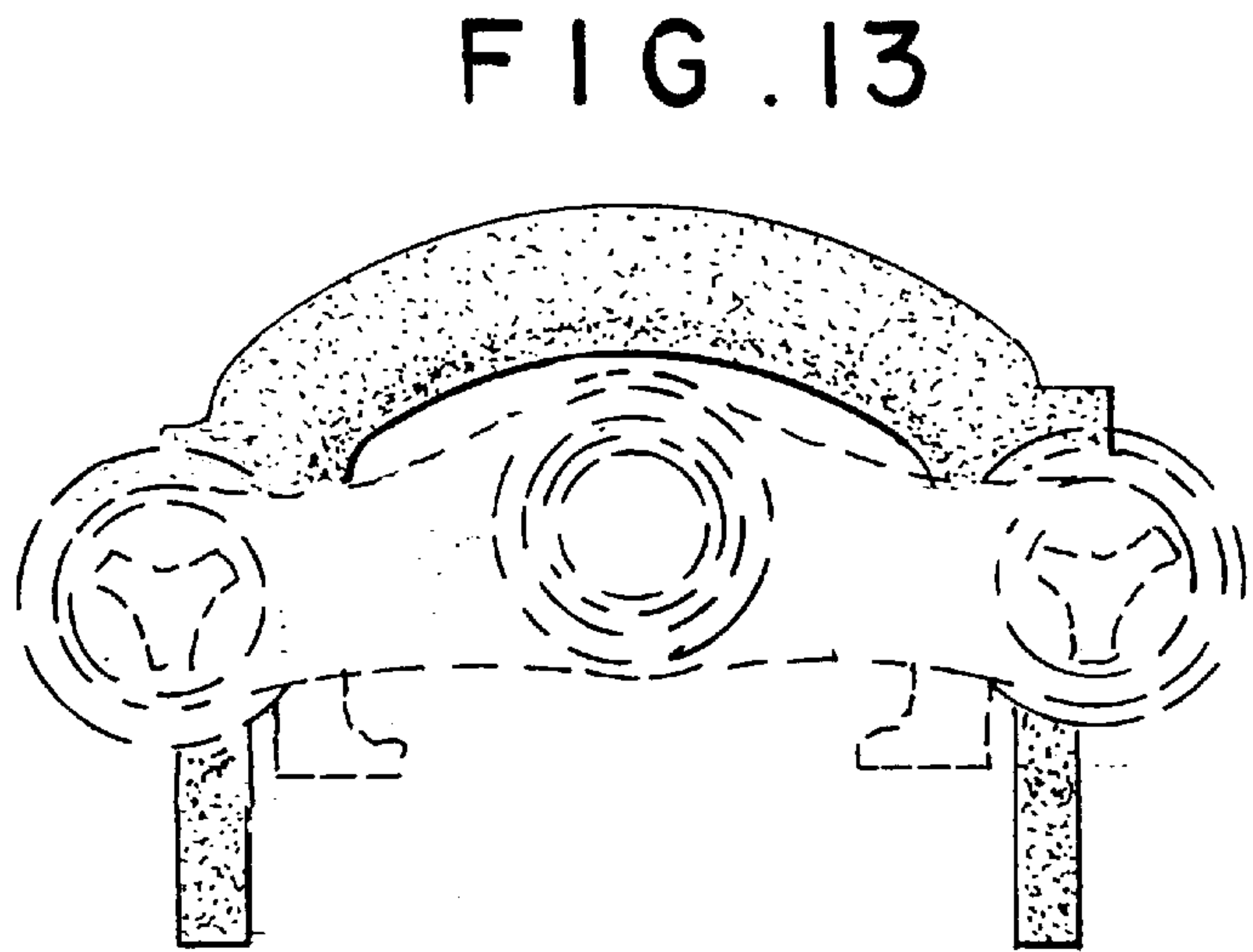

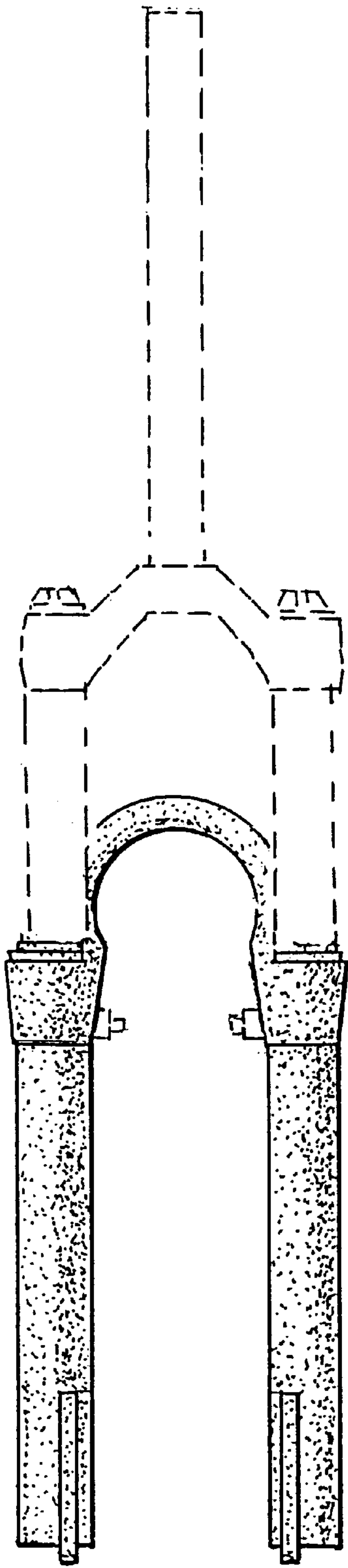

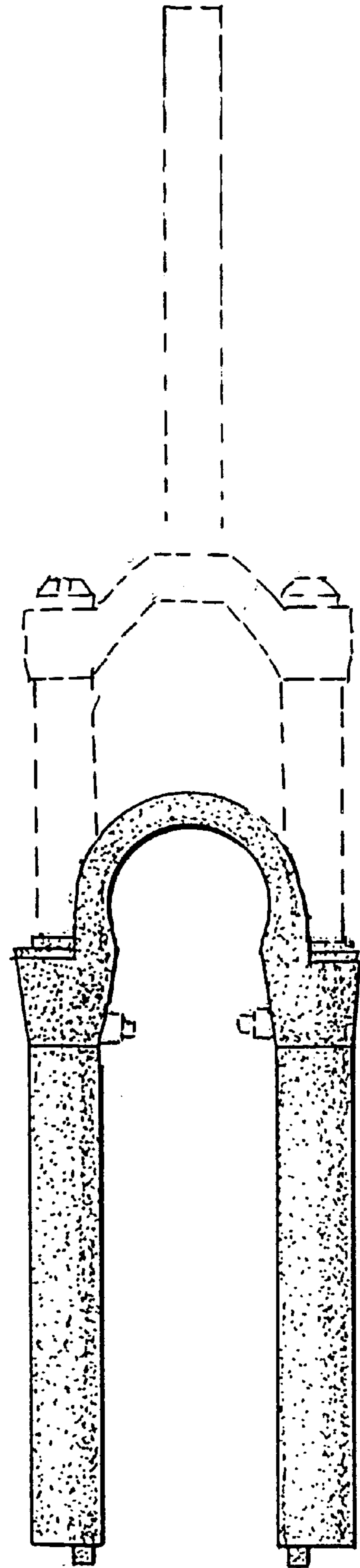

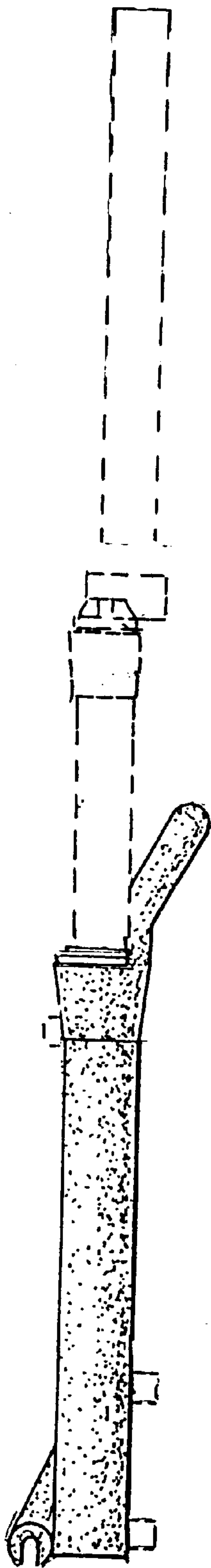

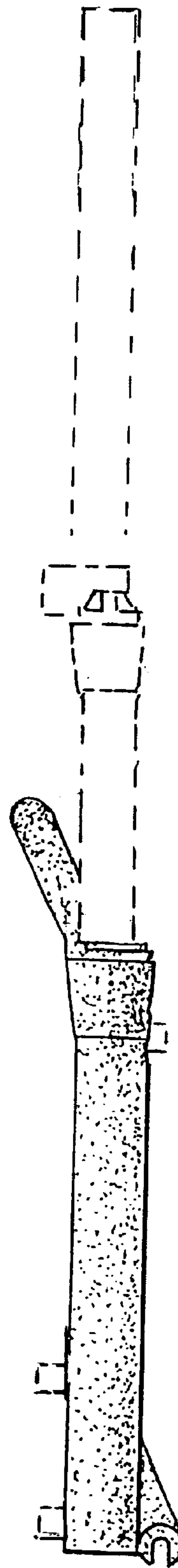
