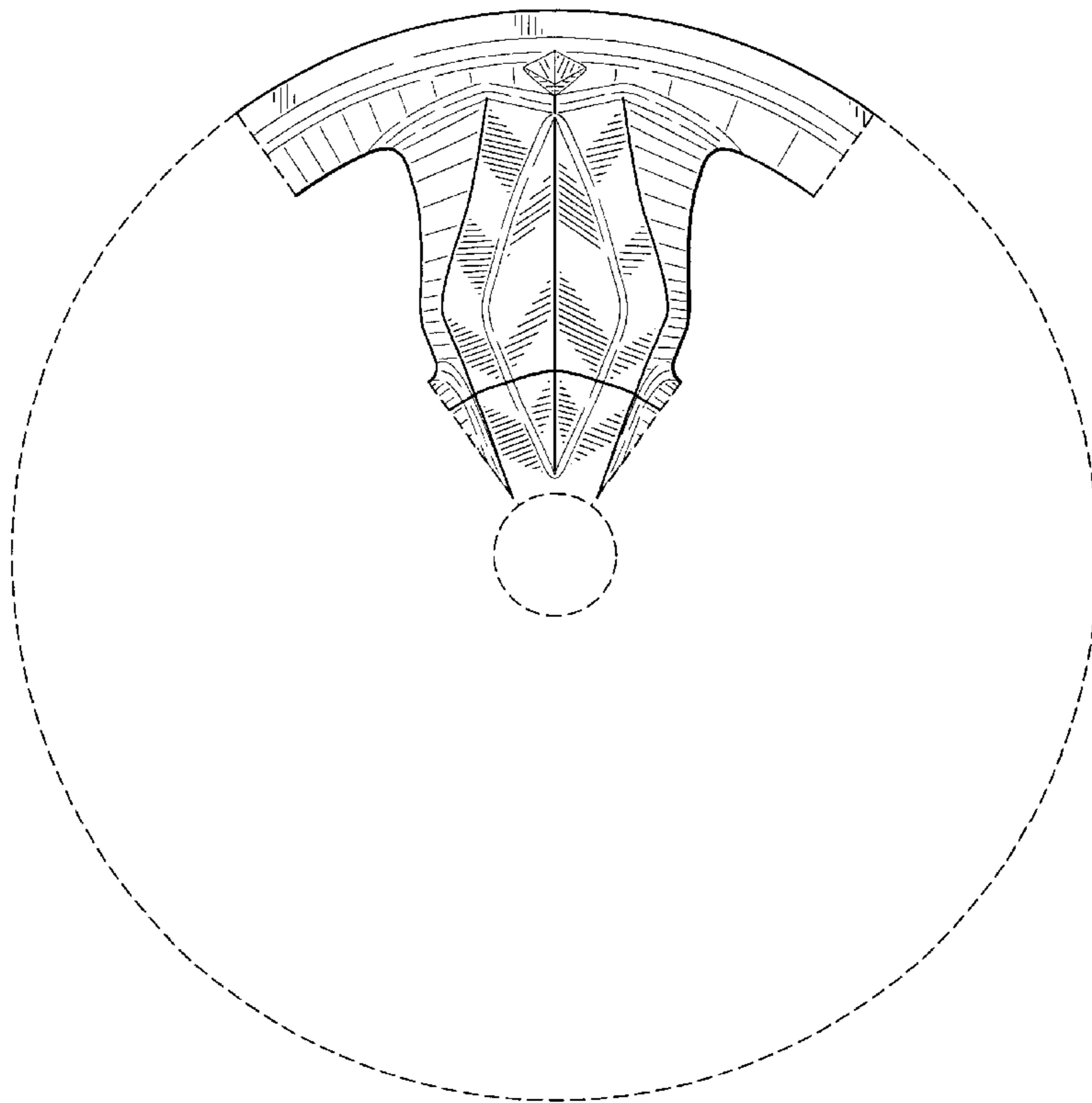
The ornamental design for a spoke for a vehicle wheel, as shown and described.

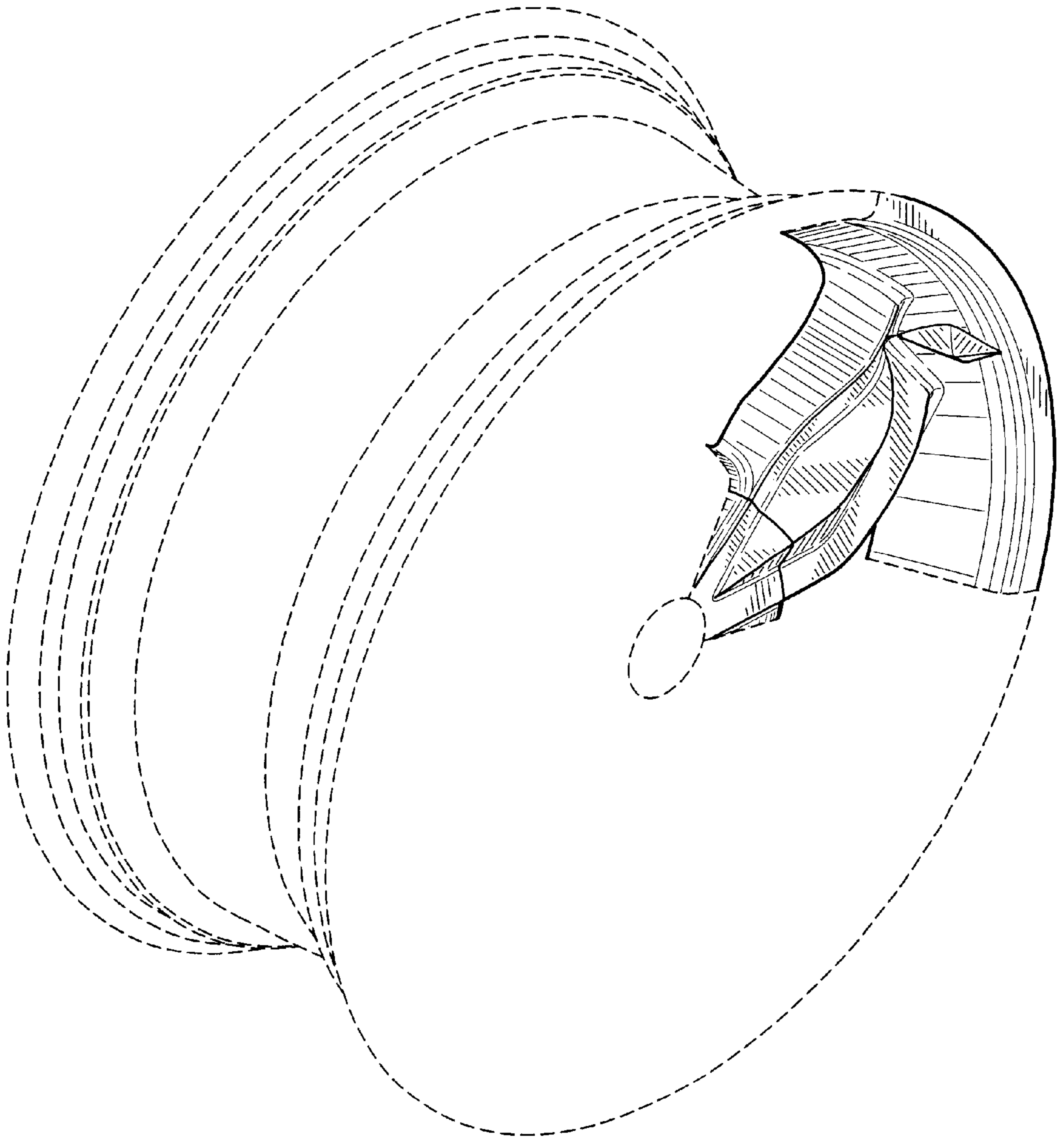

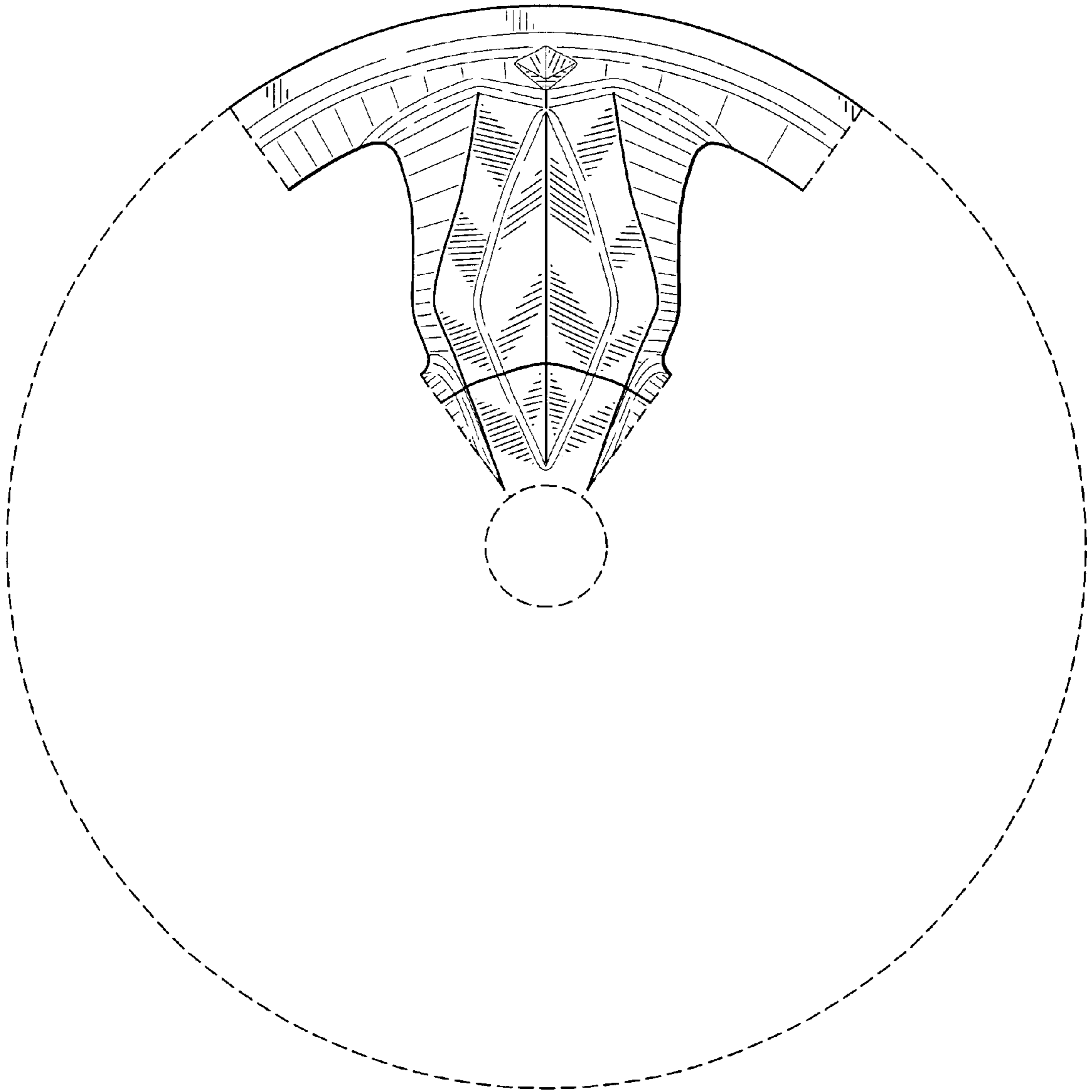
