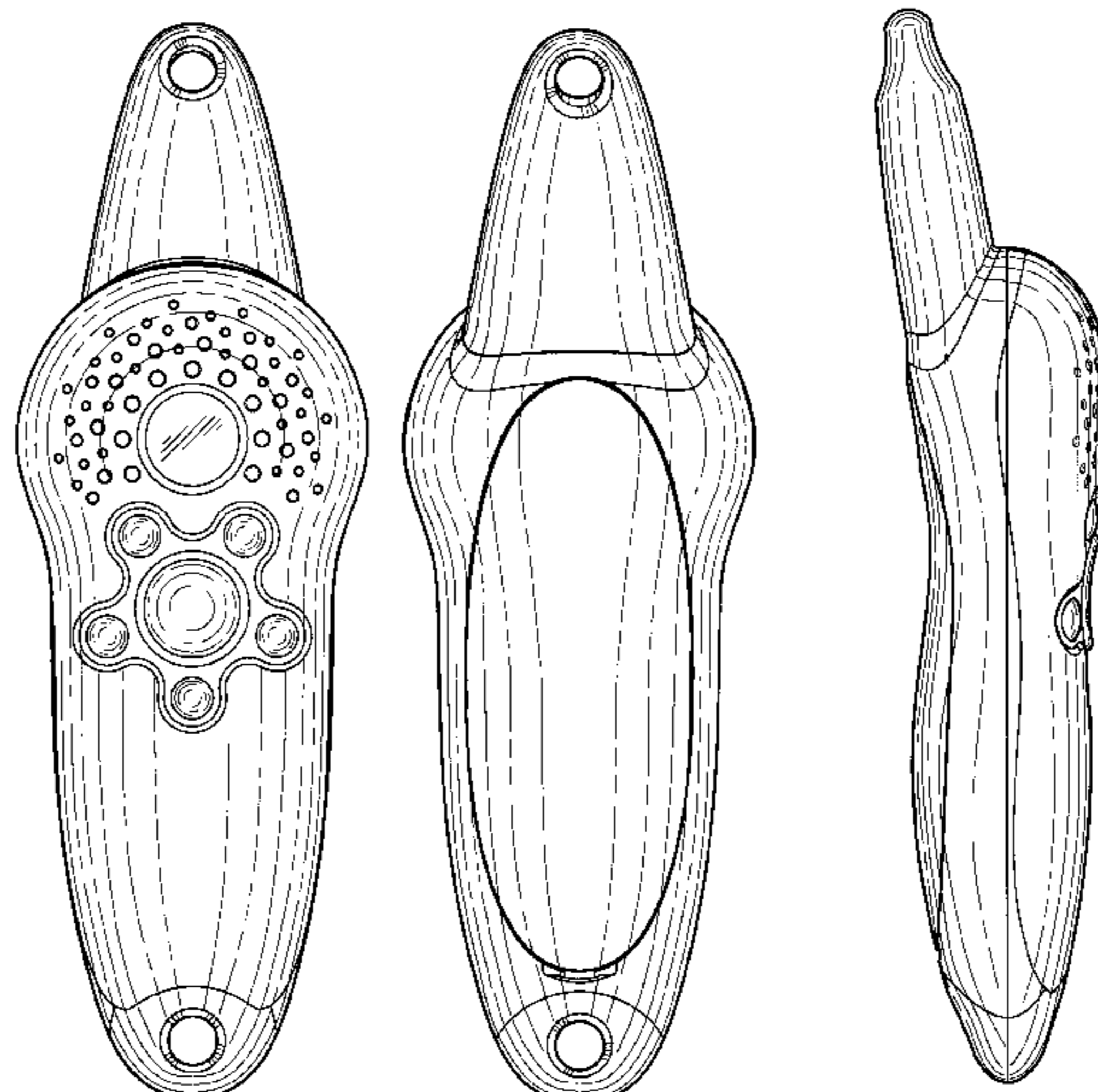
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front orthographic view of one embodiment of a portable communication device showing our new design; FIG. 2 is a rear orthographic view thereof; FIG. 3 is a left side orthographic view thereof; FIG. 4 is a right side orthographic view thereof; FIG. 5 is a top orthographic view thereof; FIG. 6 is a bottom orthographic view thereof; and, FIG. 7 is a perspective view thereof.

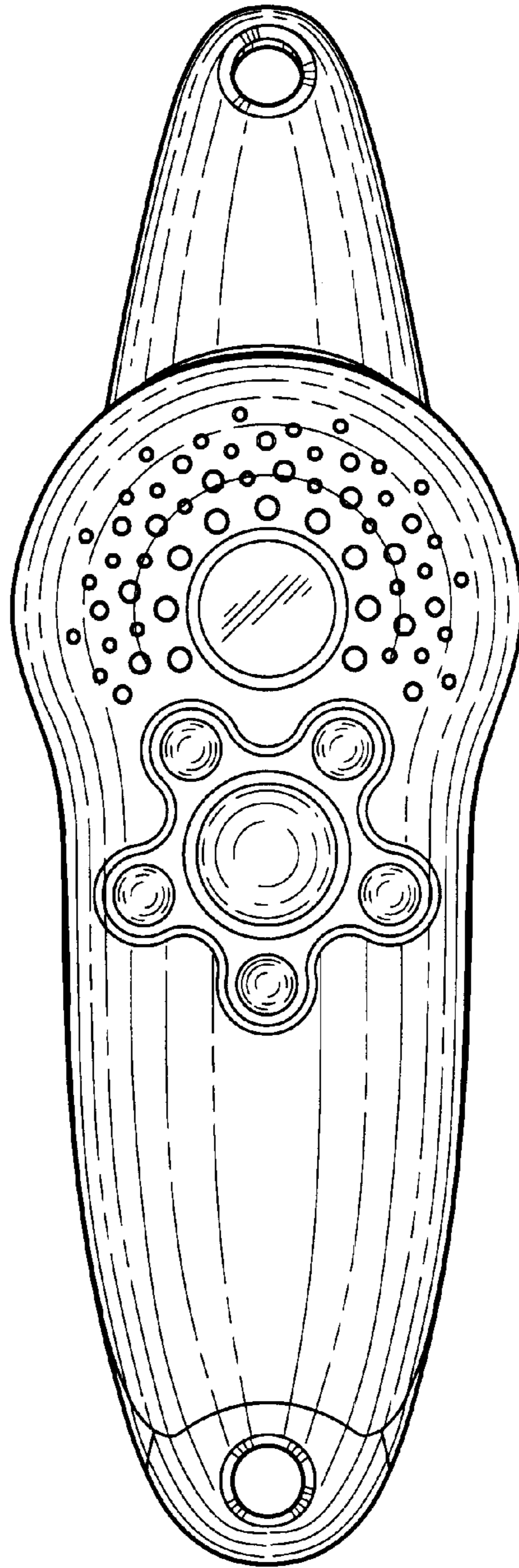

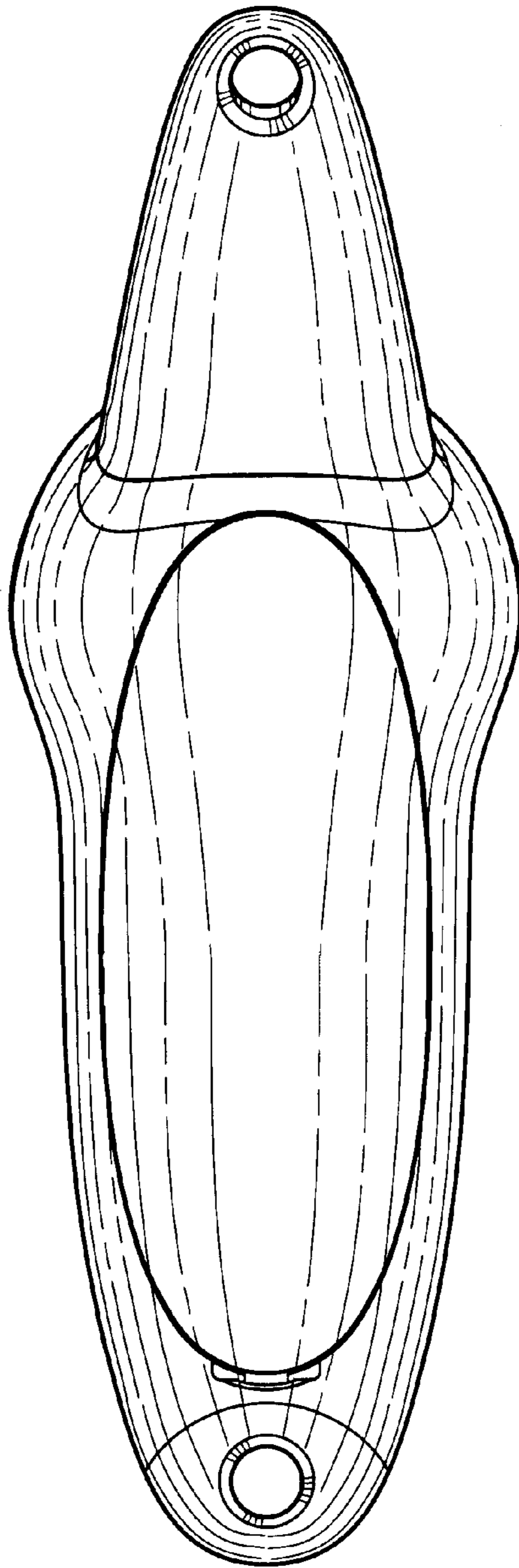

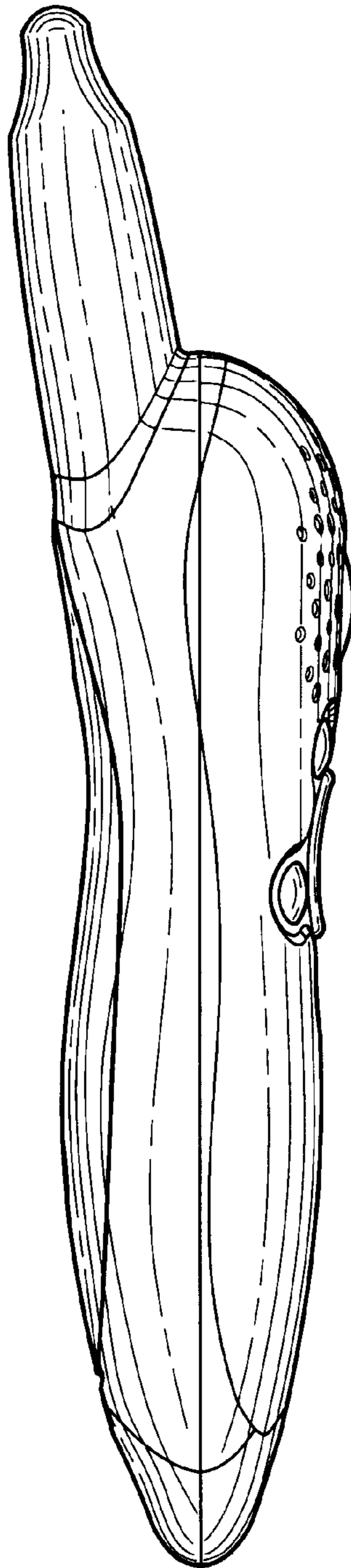

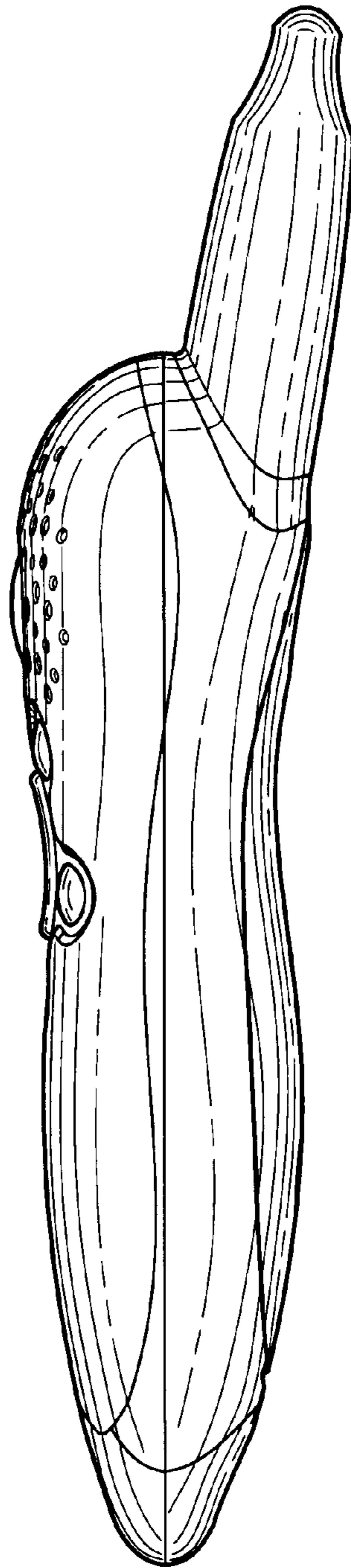

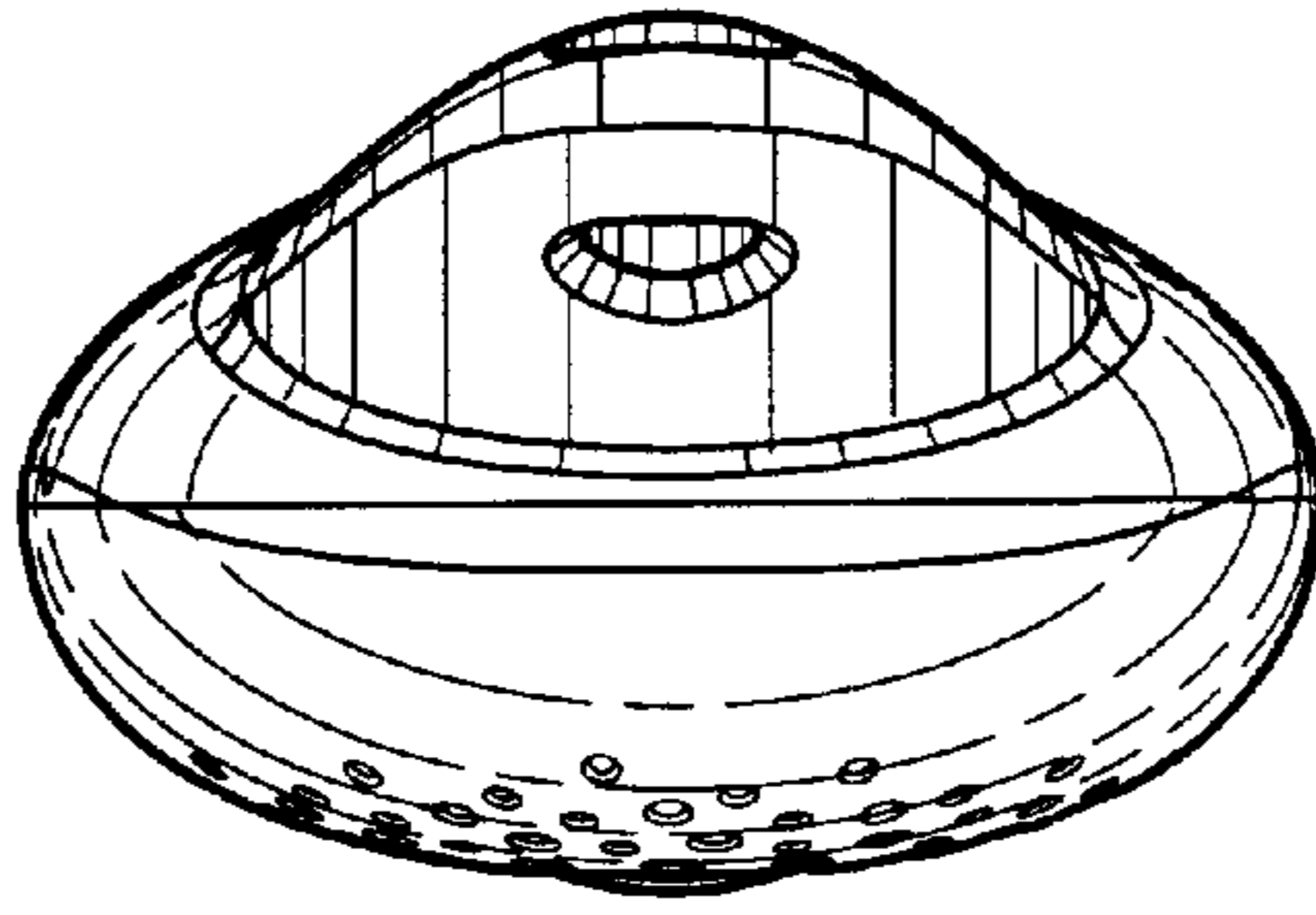

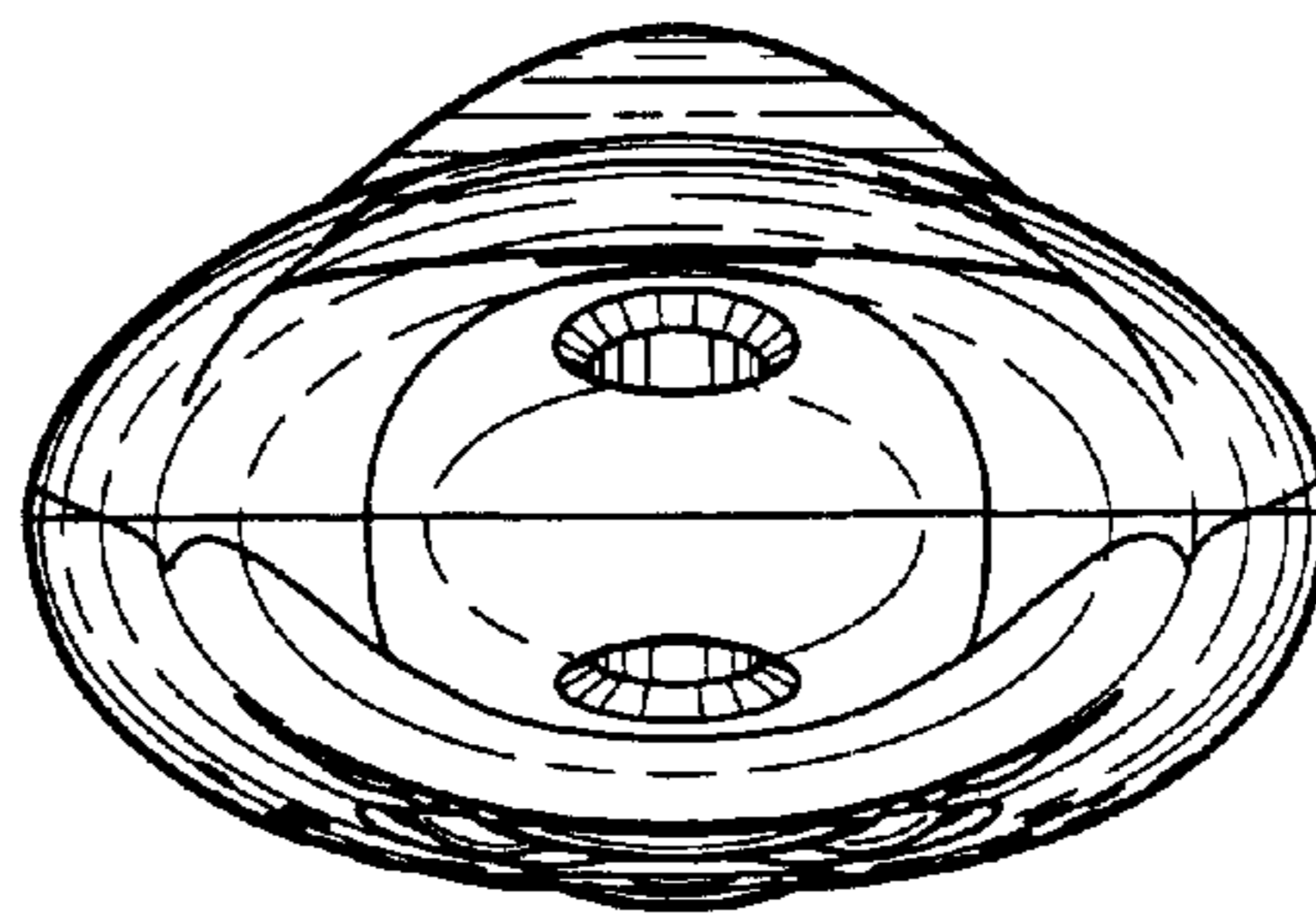

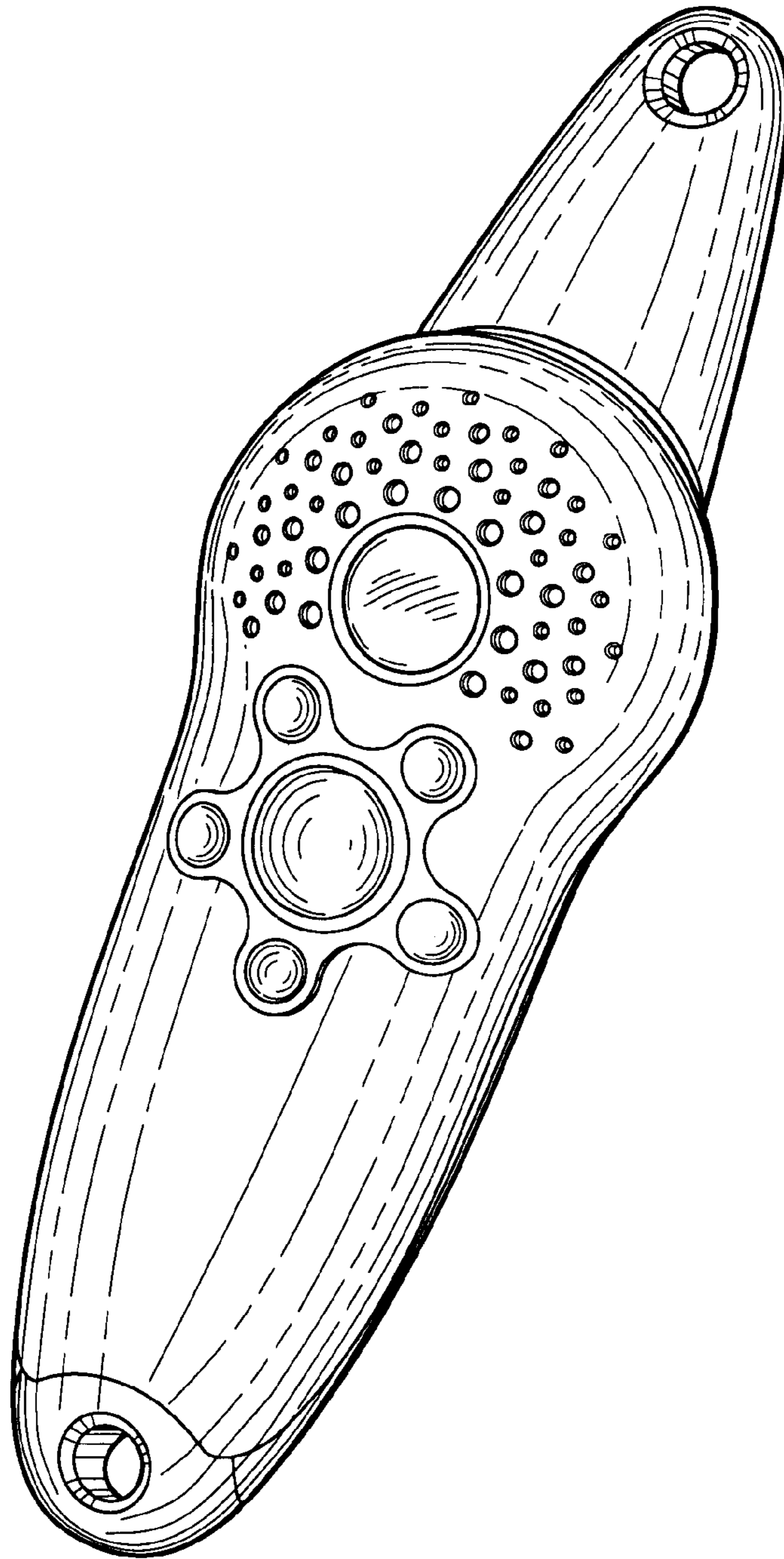
