(57) **CLAIM**

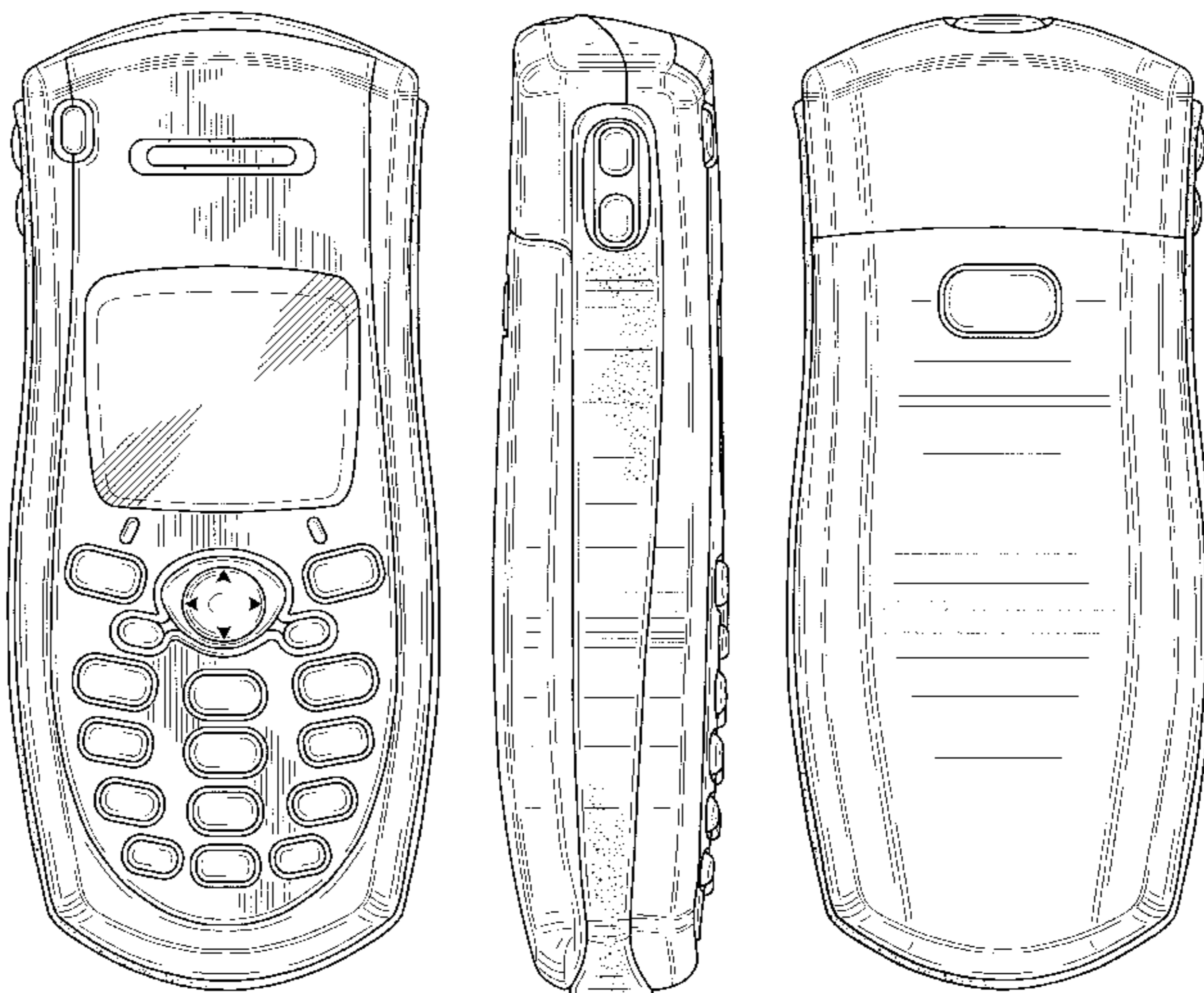
The ornamental design for a portable communications device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the portable communications device showing my design; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof; FIG. 4 is an opposing side view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The broken lines shown herein are for illustrative purposes only and form no part of the claimed design. In certain embodiments of the design, the slightly protruding central portion of the outer surface of the sides and bottom of the device may be formed from and elastomeric material forming a visually contrasting ornamental surface relative to adjacent portions of the device as shown by the shaded texture contrast on the surfaces thereof. The illustrated device is not limited to the scale shown.

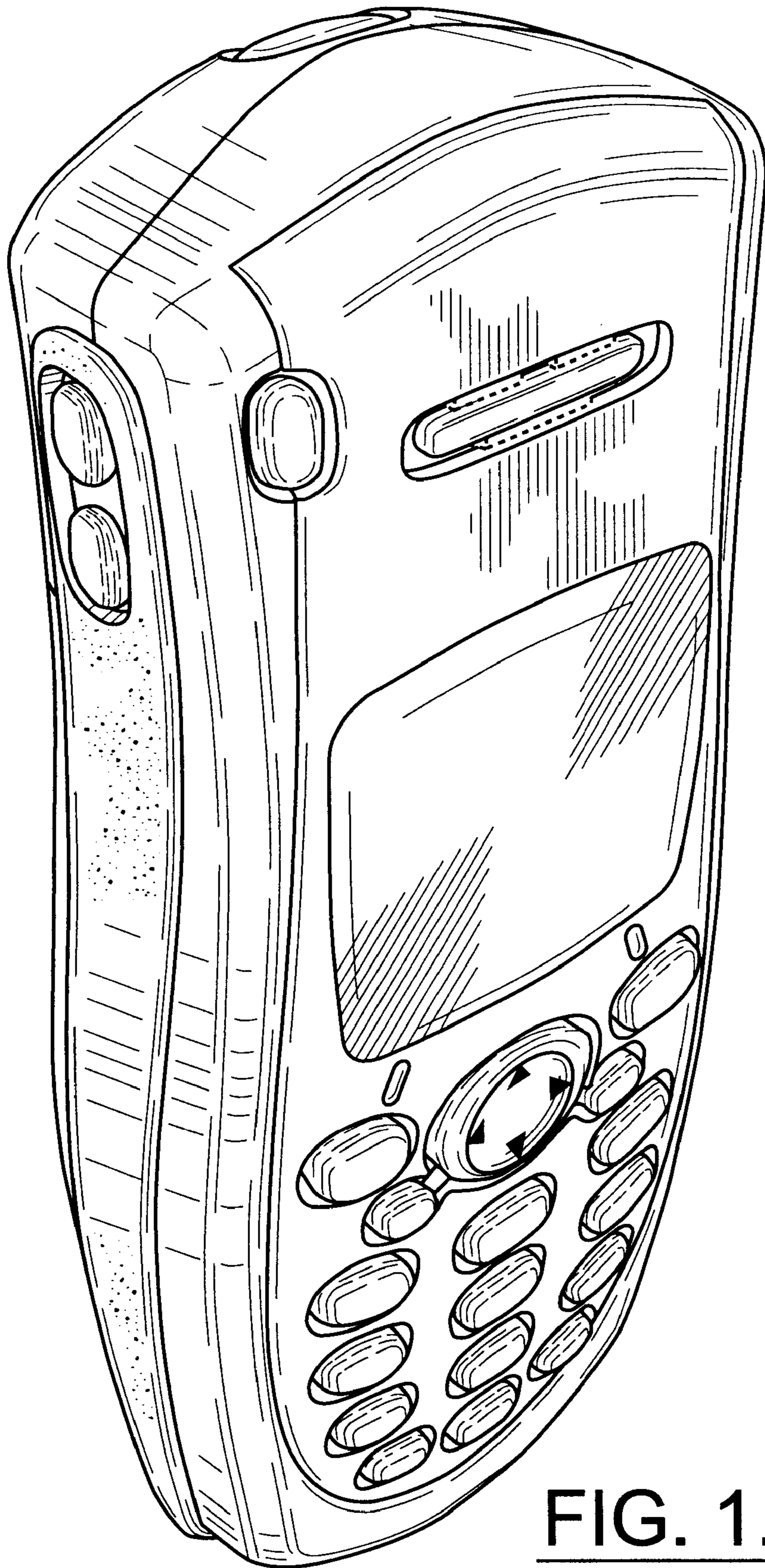

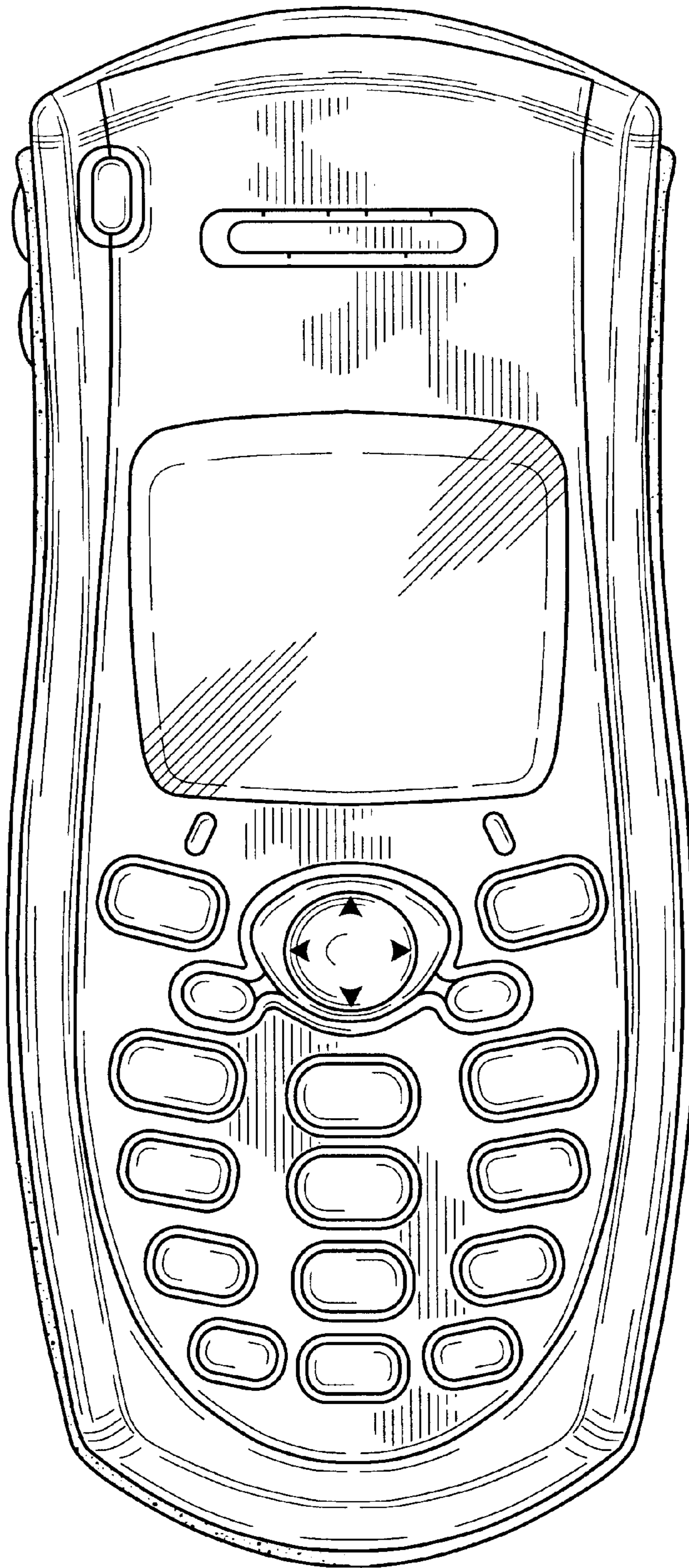

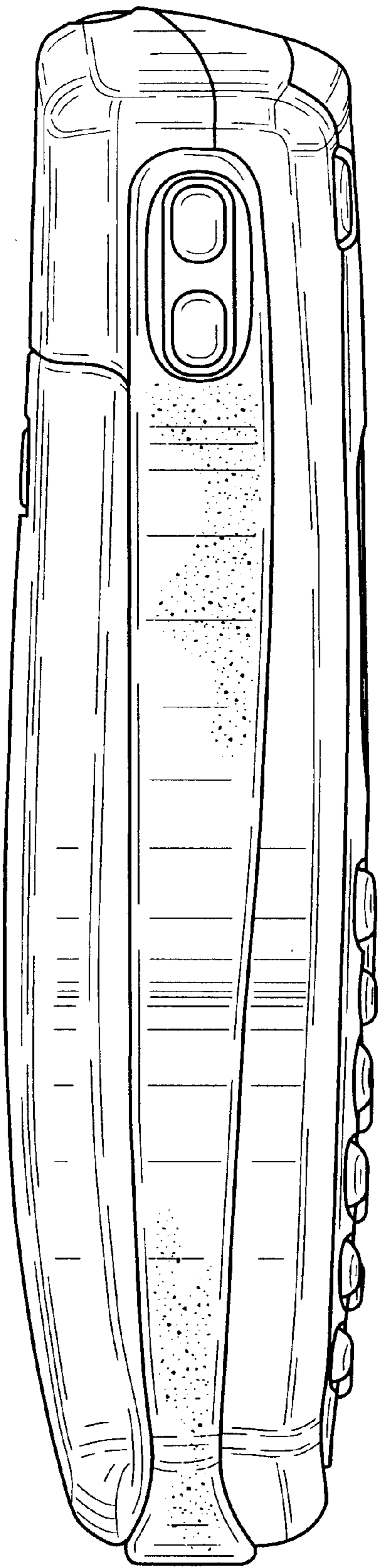

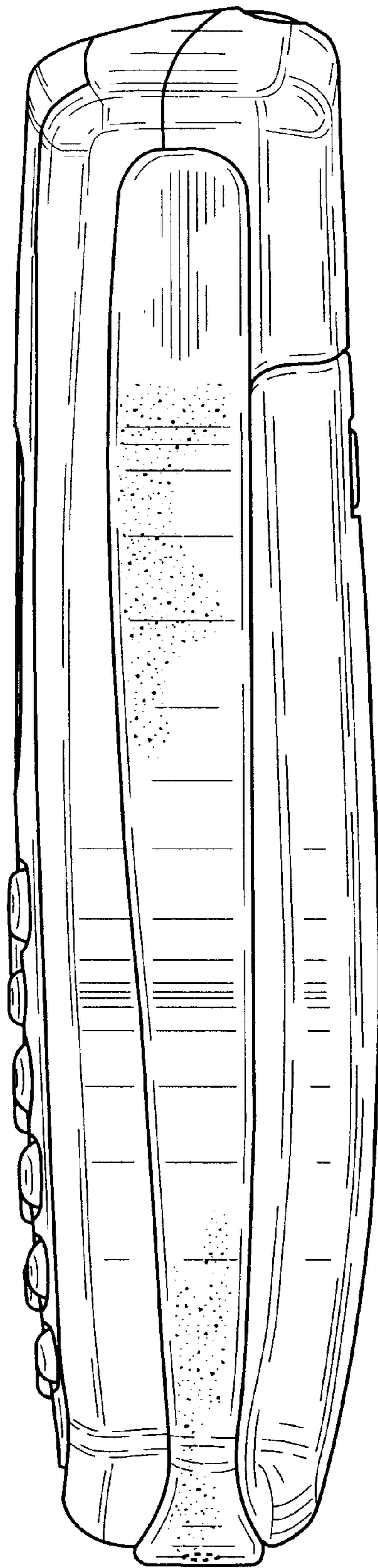

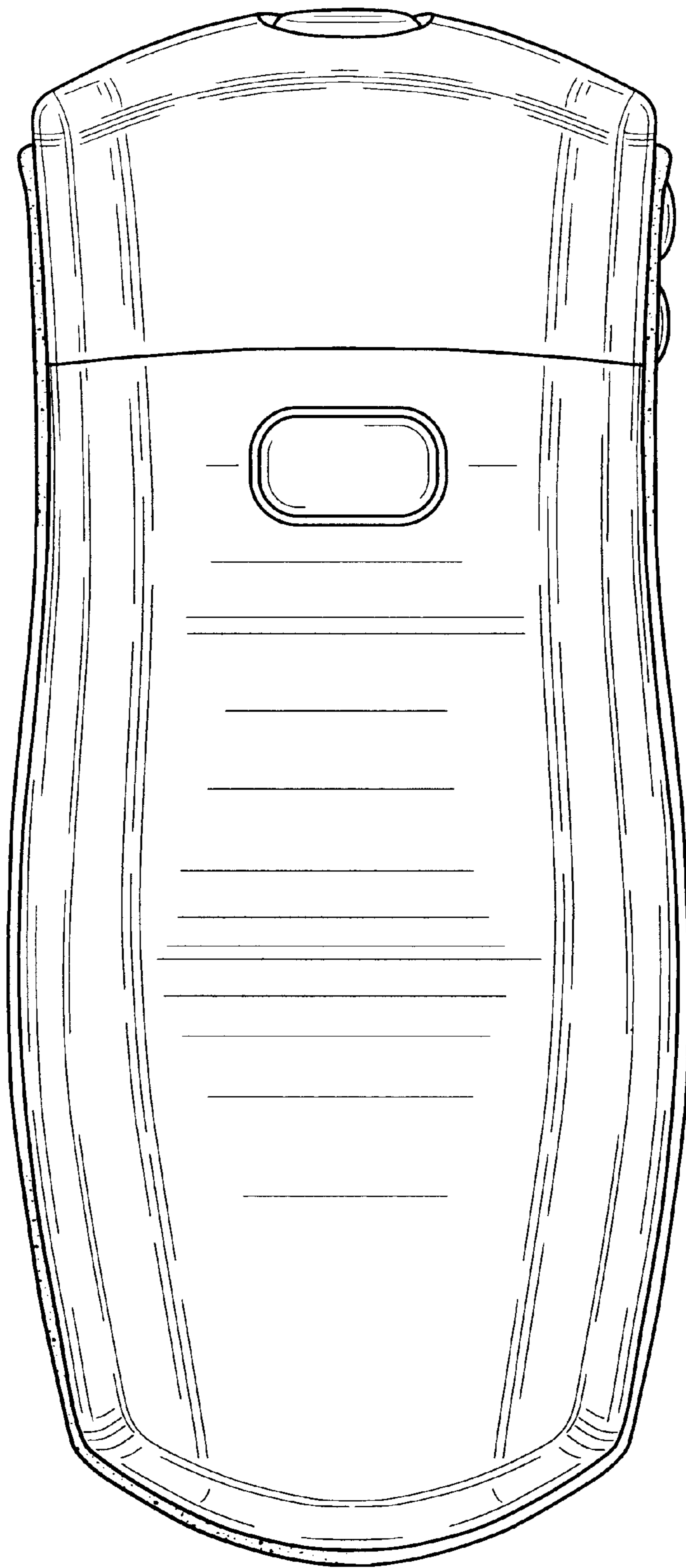

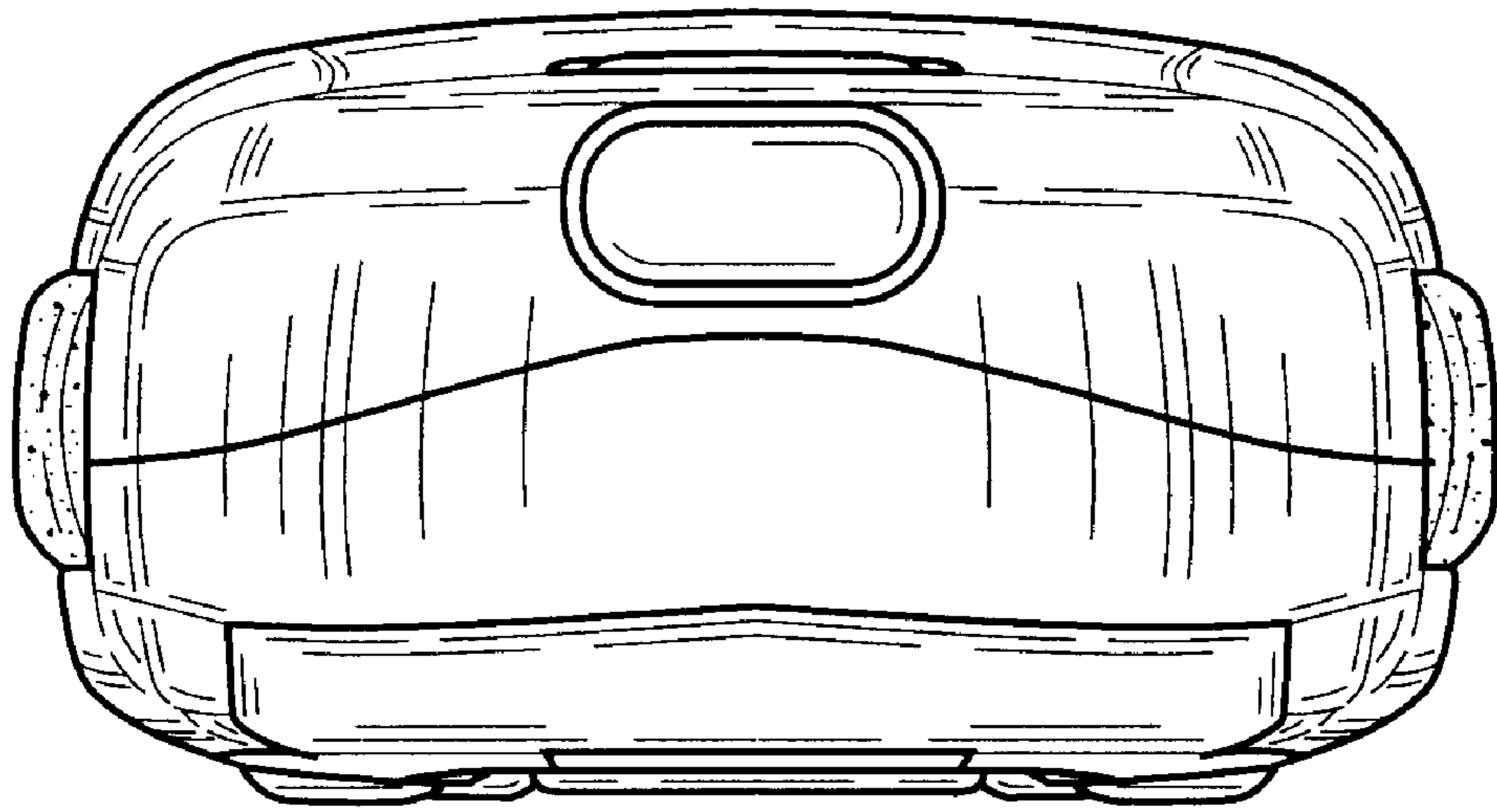

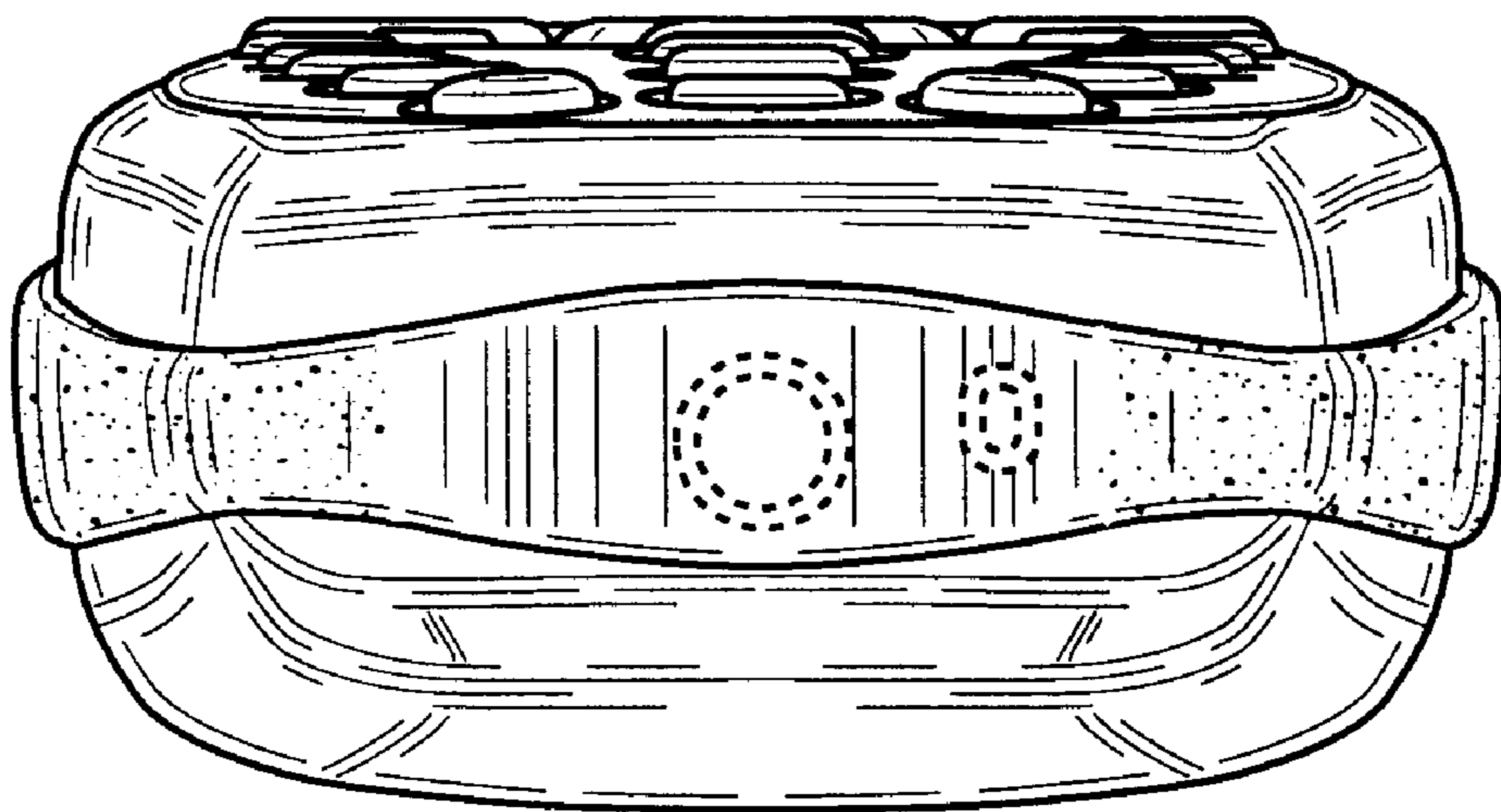
