DESCRIPTION

FIG. 1 is a front view of a medicament delivery device with a cap on the device;

FIG. 2 is a rear view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a front view thereof with the cap removed from the device;

FIG. 8 is a rear view thereof with the cap removed from the device;

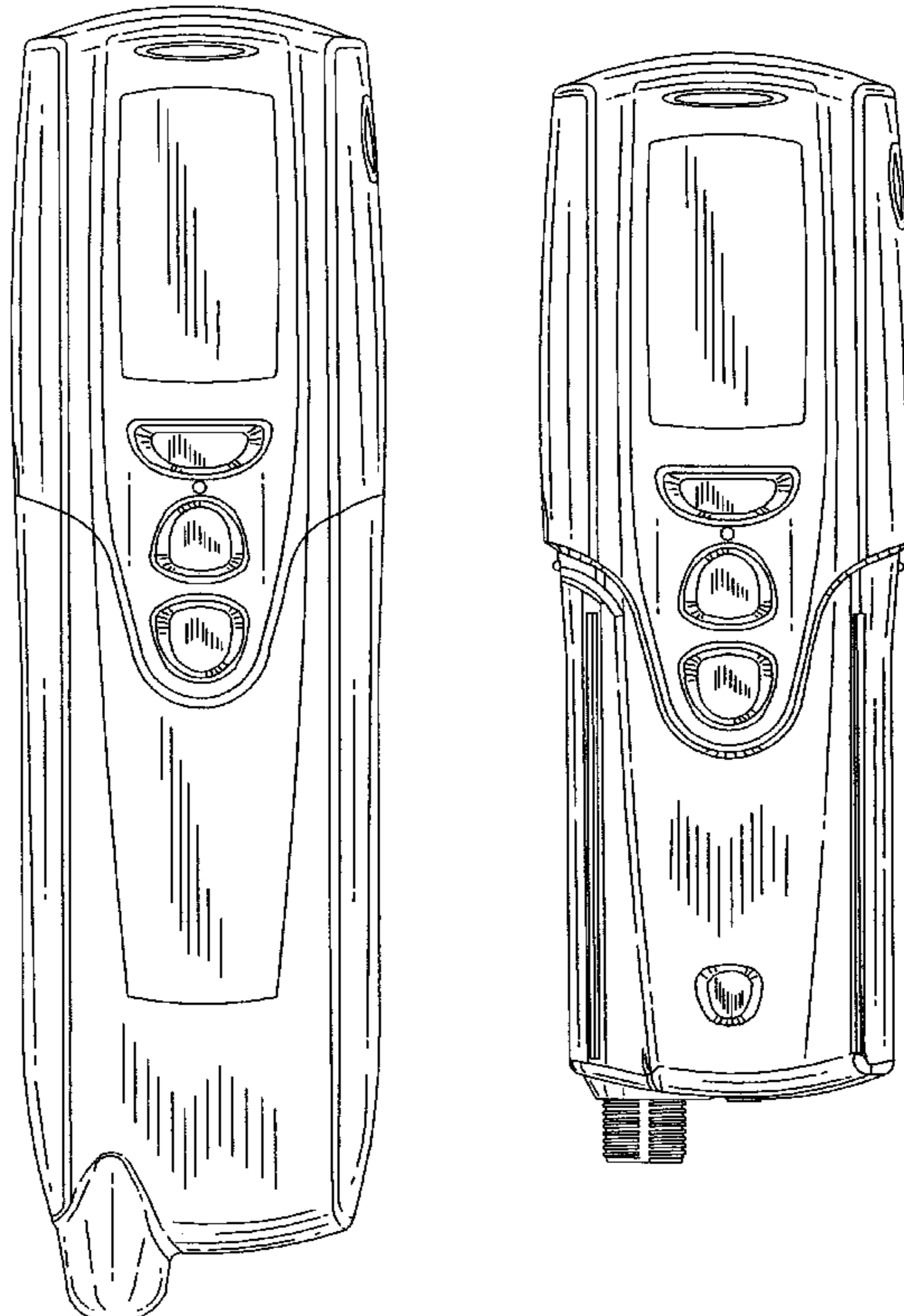
FIG. 9 is a left-side view thereof with the cap removed from the device;

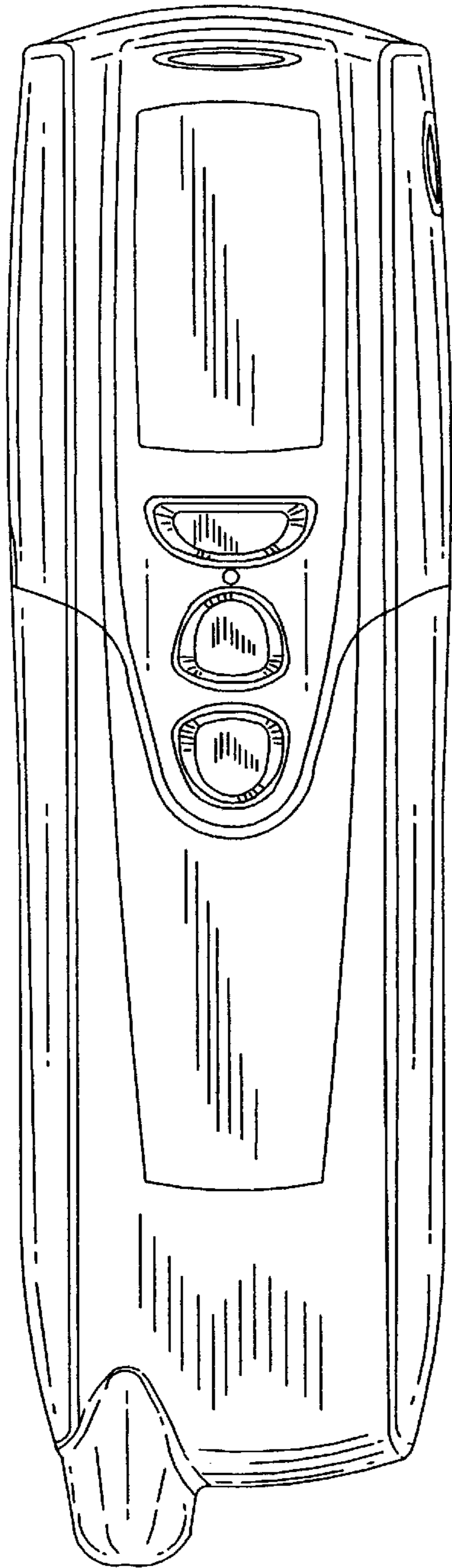

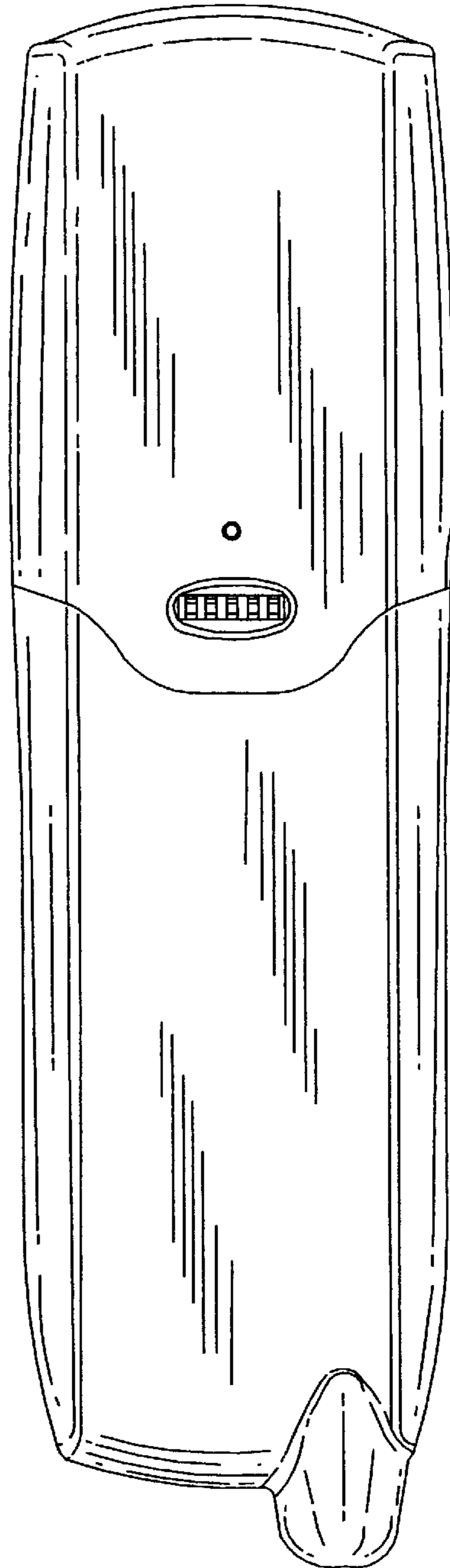

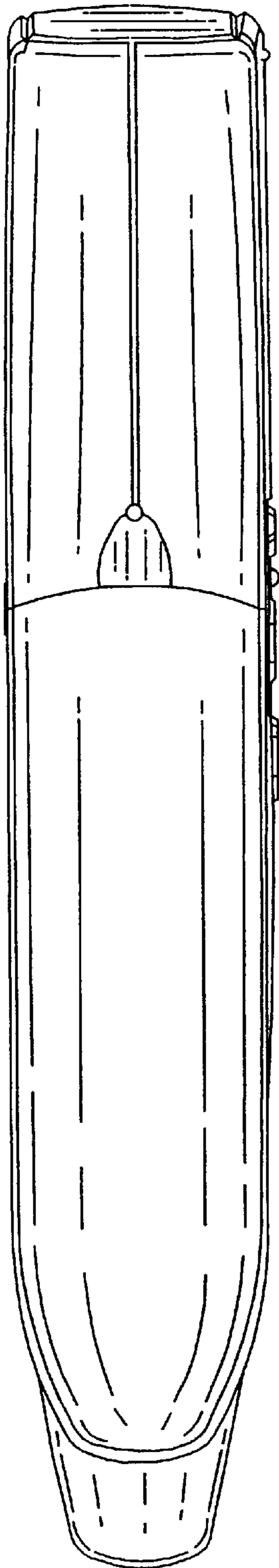

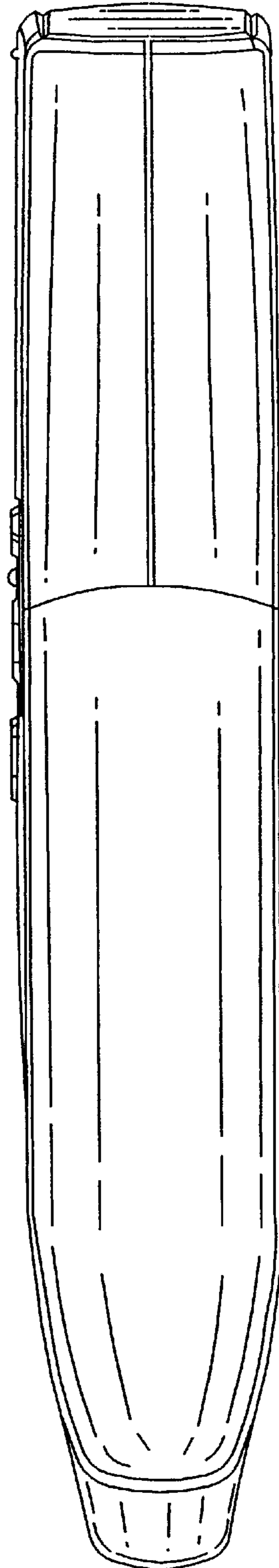

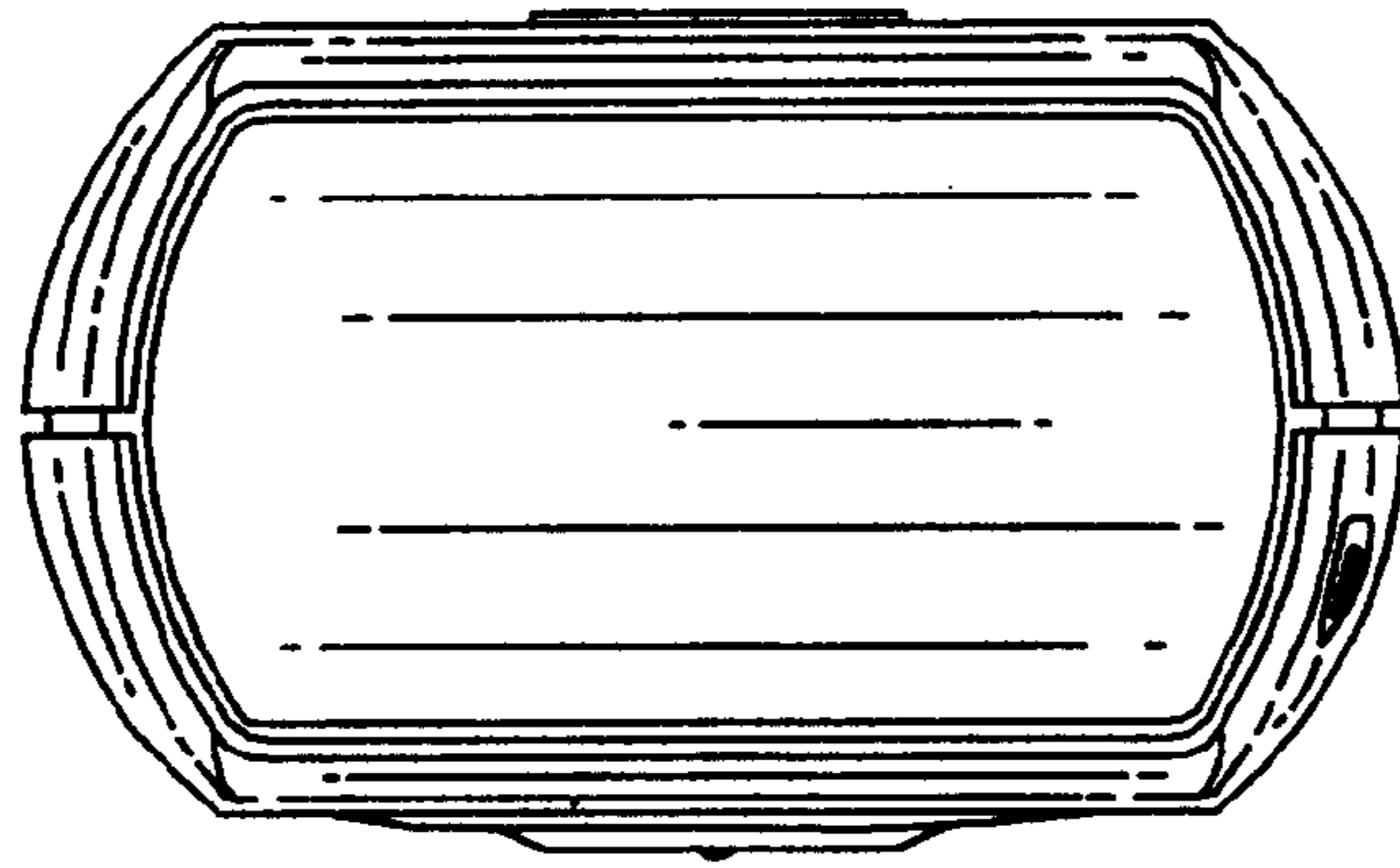

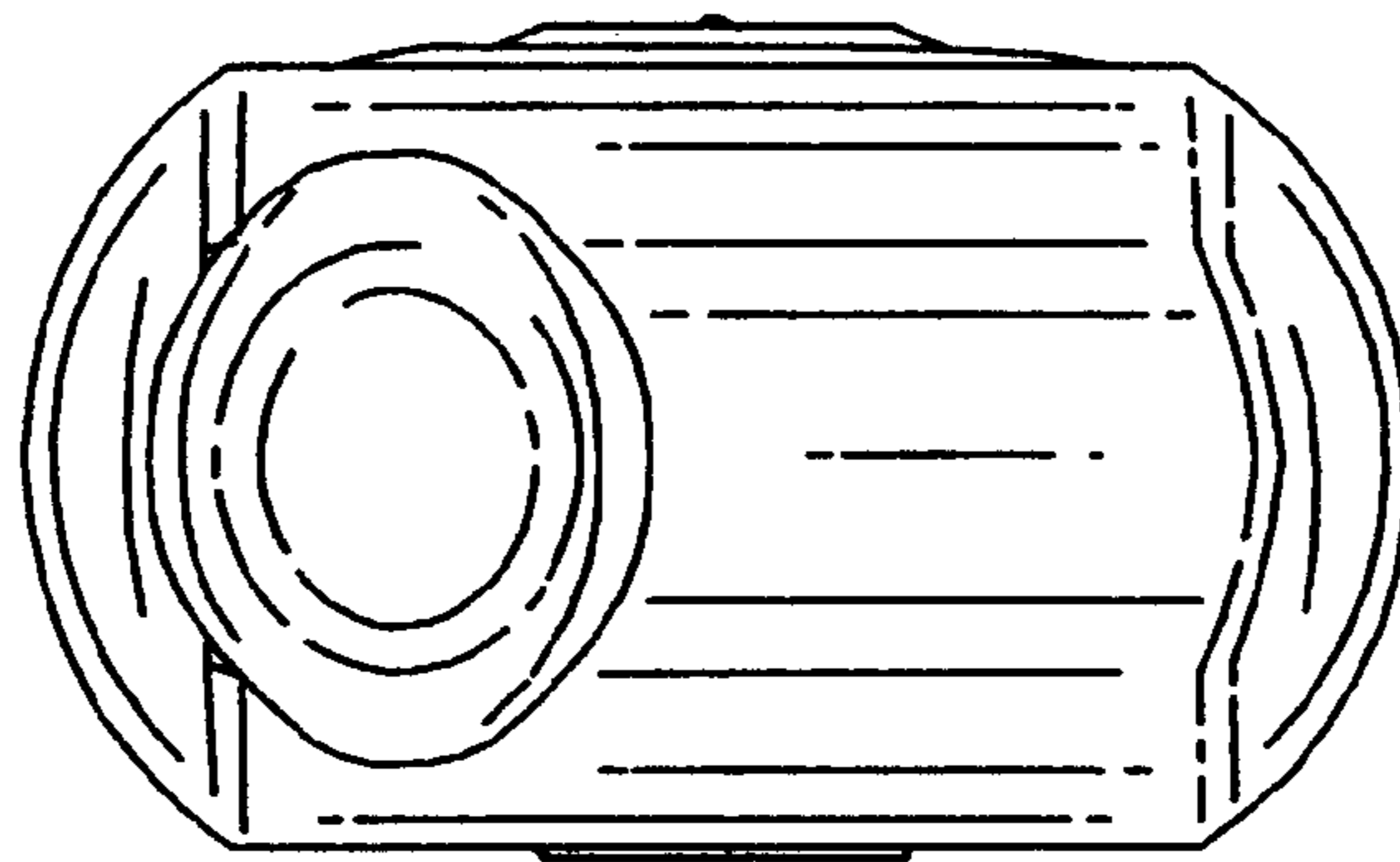

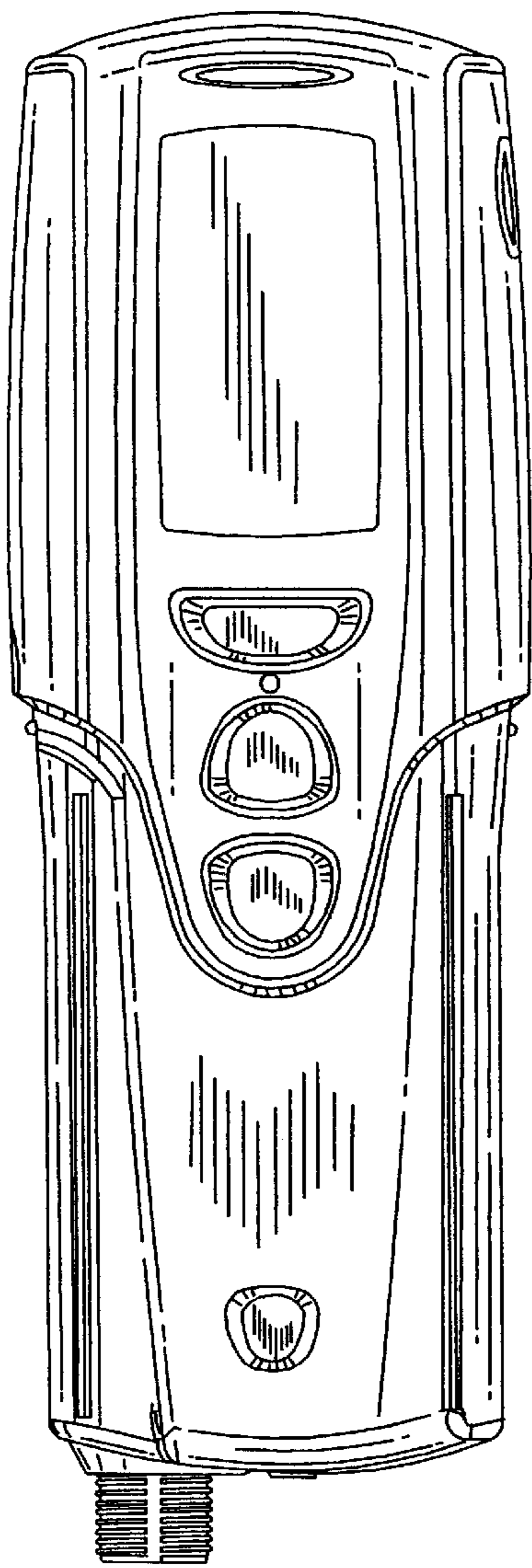

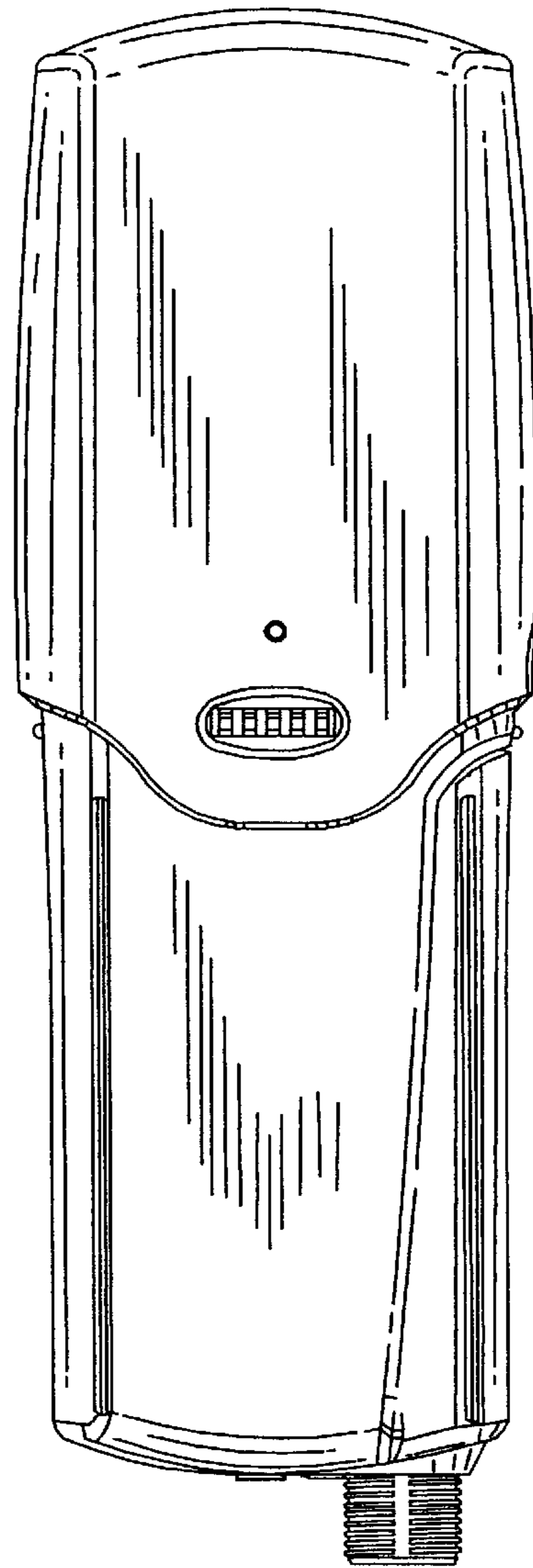

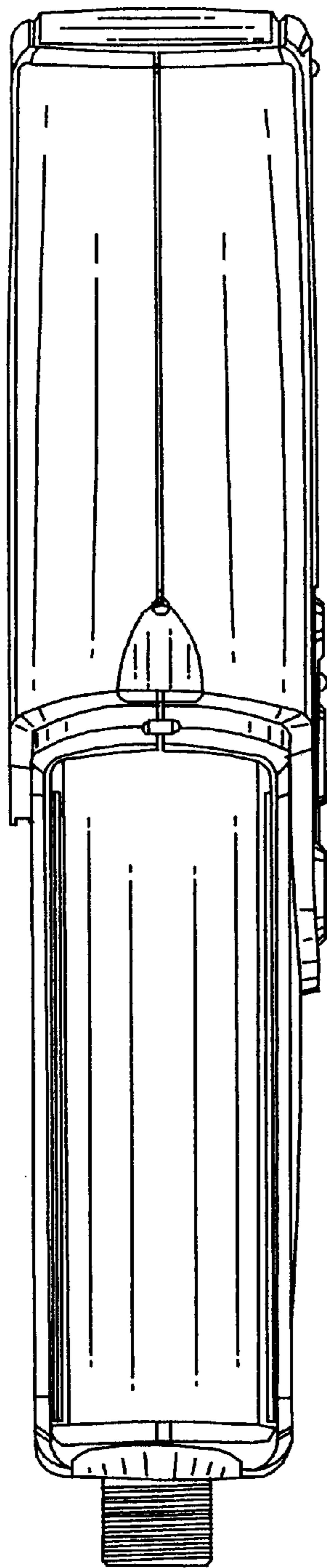

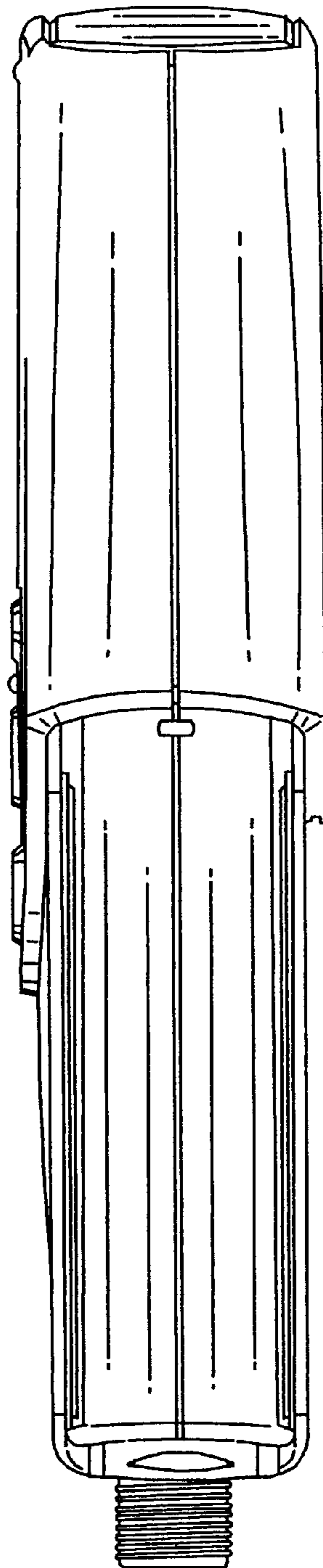

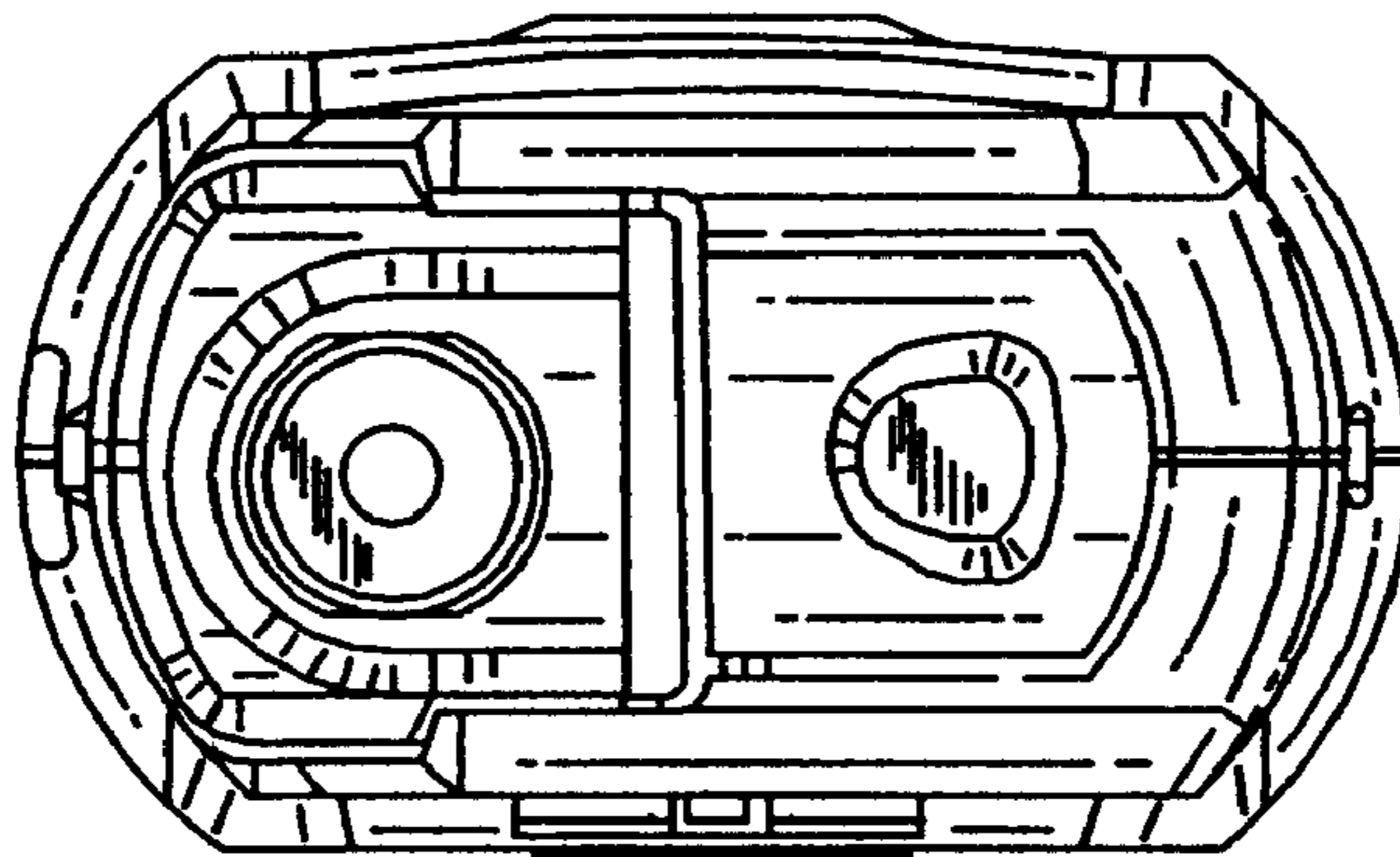
