(57) **CLAIM**

The ornamental design for a cigarette pack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and left side view of a cigarette pack according to a first embodiment showing our new design;

FIG. 2 is a perspective view similar to FIG. 1 with the cover in the cover in the open position;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a top plan view thereof, the bottom plan view being identical thereto,

FIG. 8 is a perspective view of the top, front and left side of a cigarette pack according to a second embodiment;

FIG. 9 is a perspective view similar to FIG. 8 with the cover in the open position;

FIG. 10 is a left side elevational view thereof;

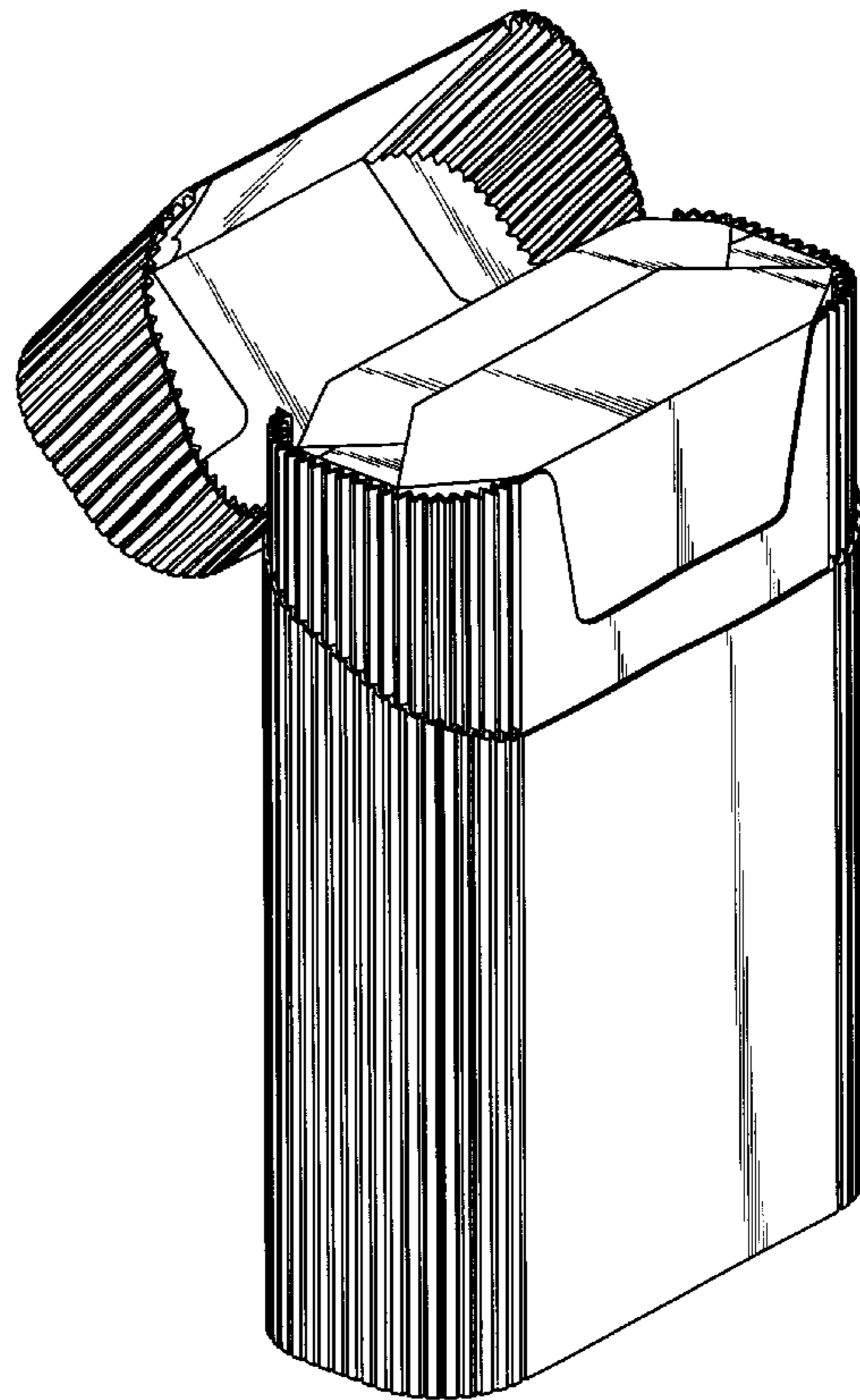
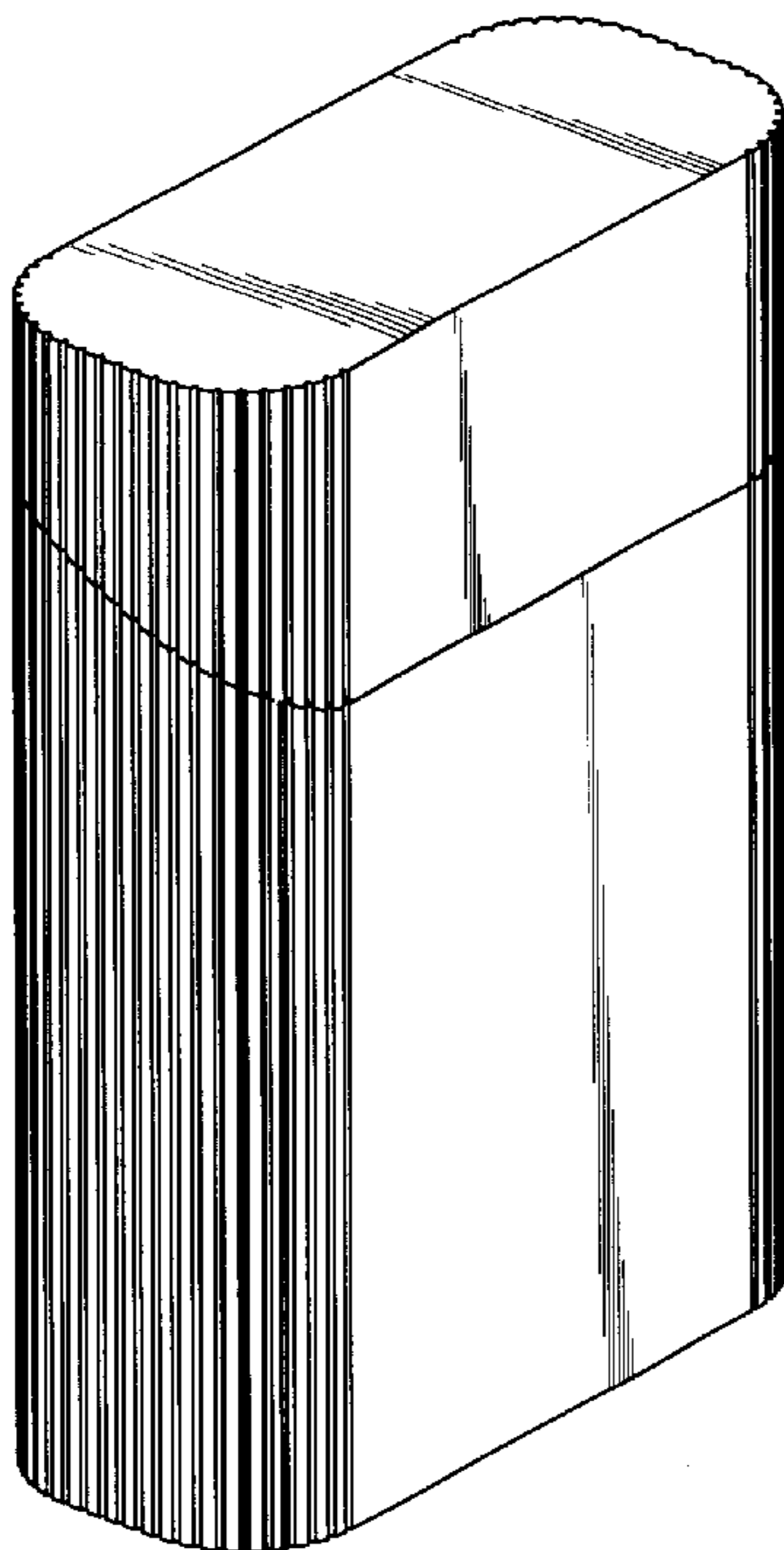
FIG. 11 is a right side elevational view thereof;

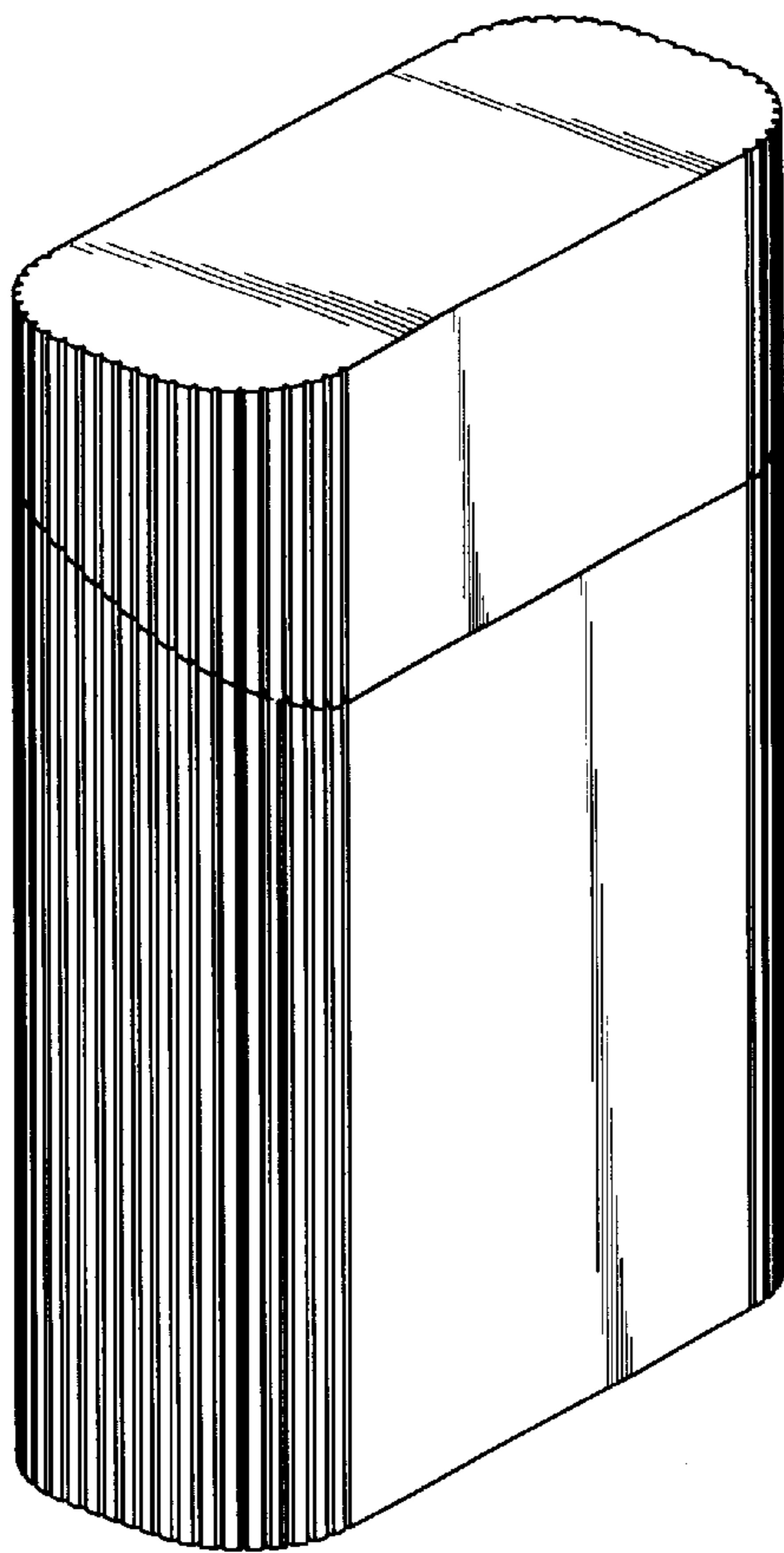

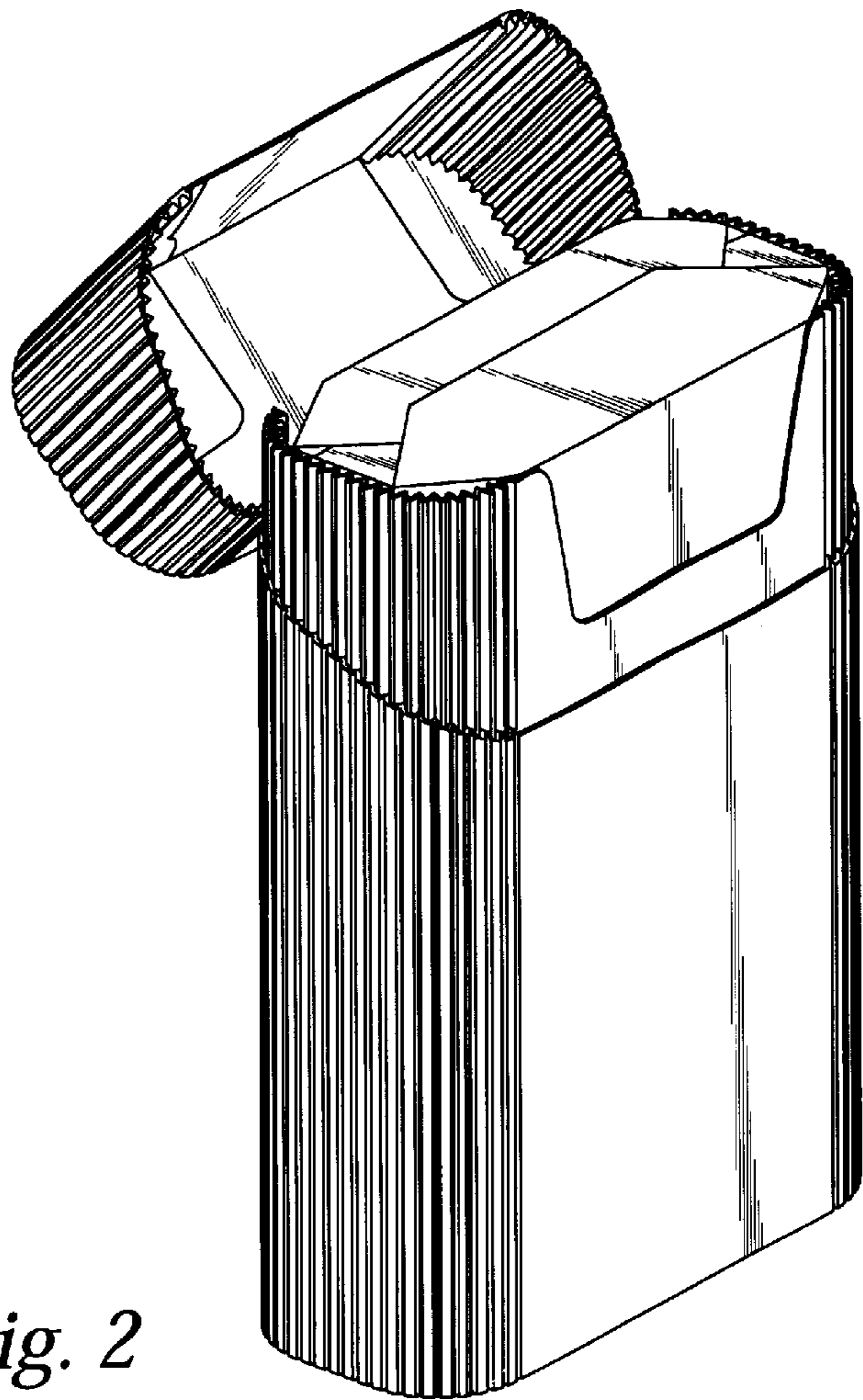

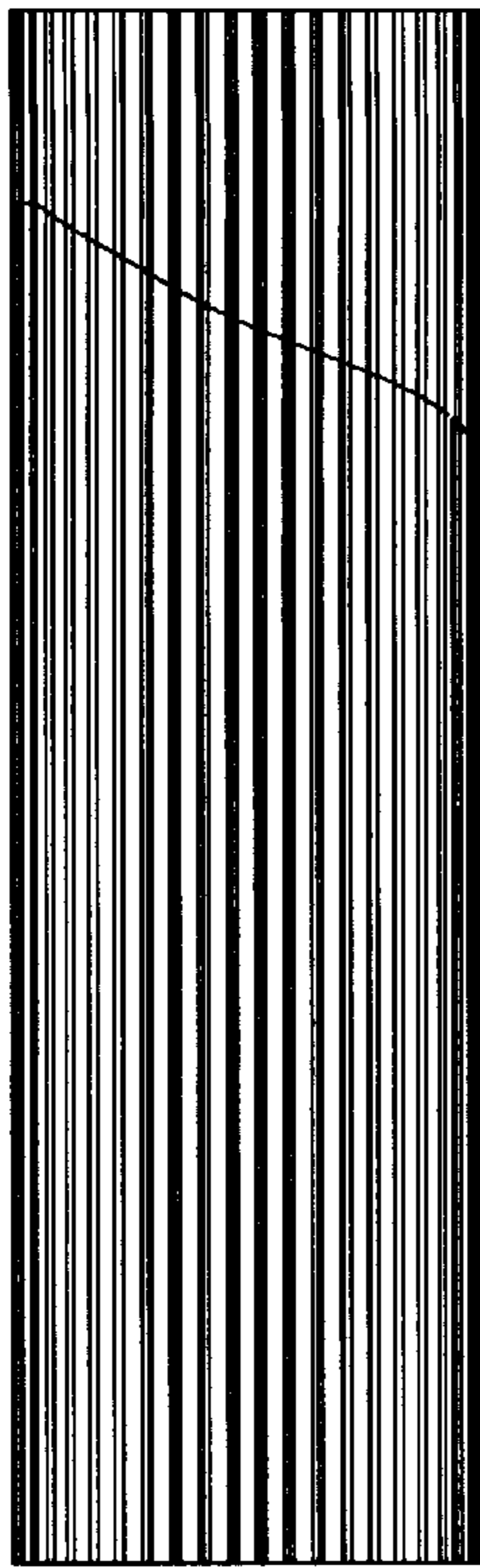

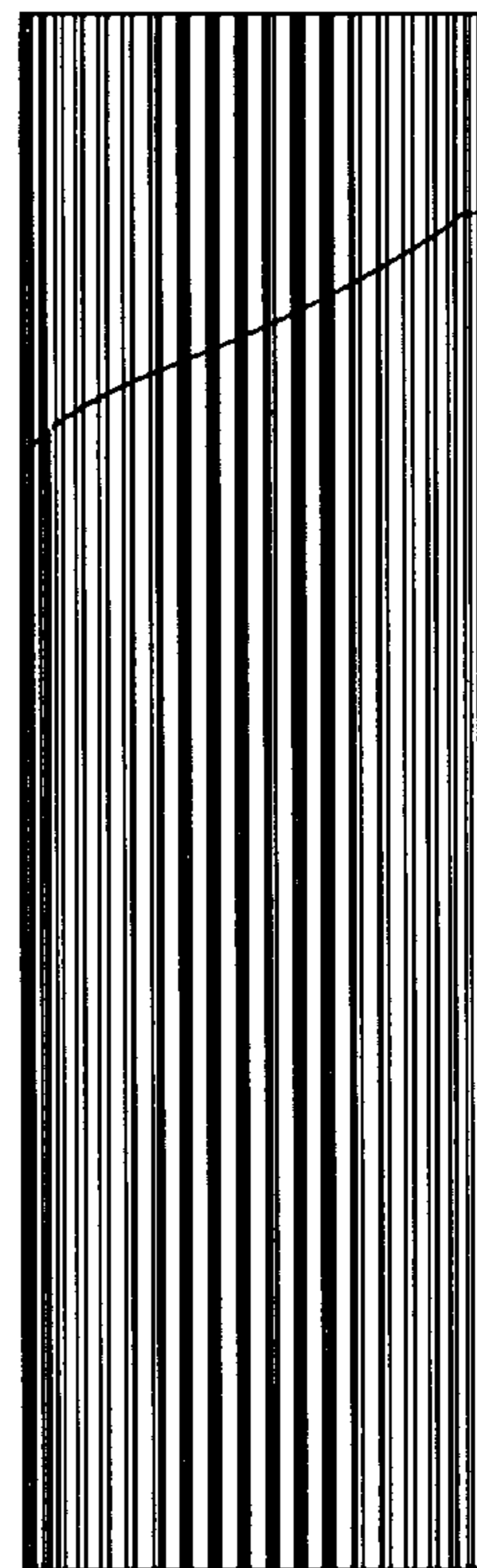

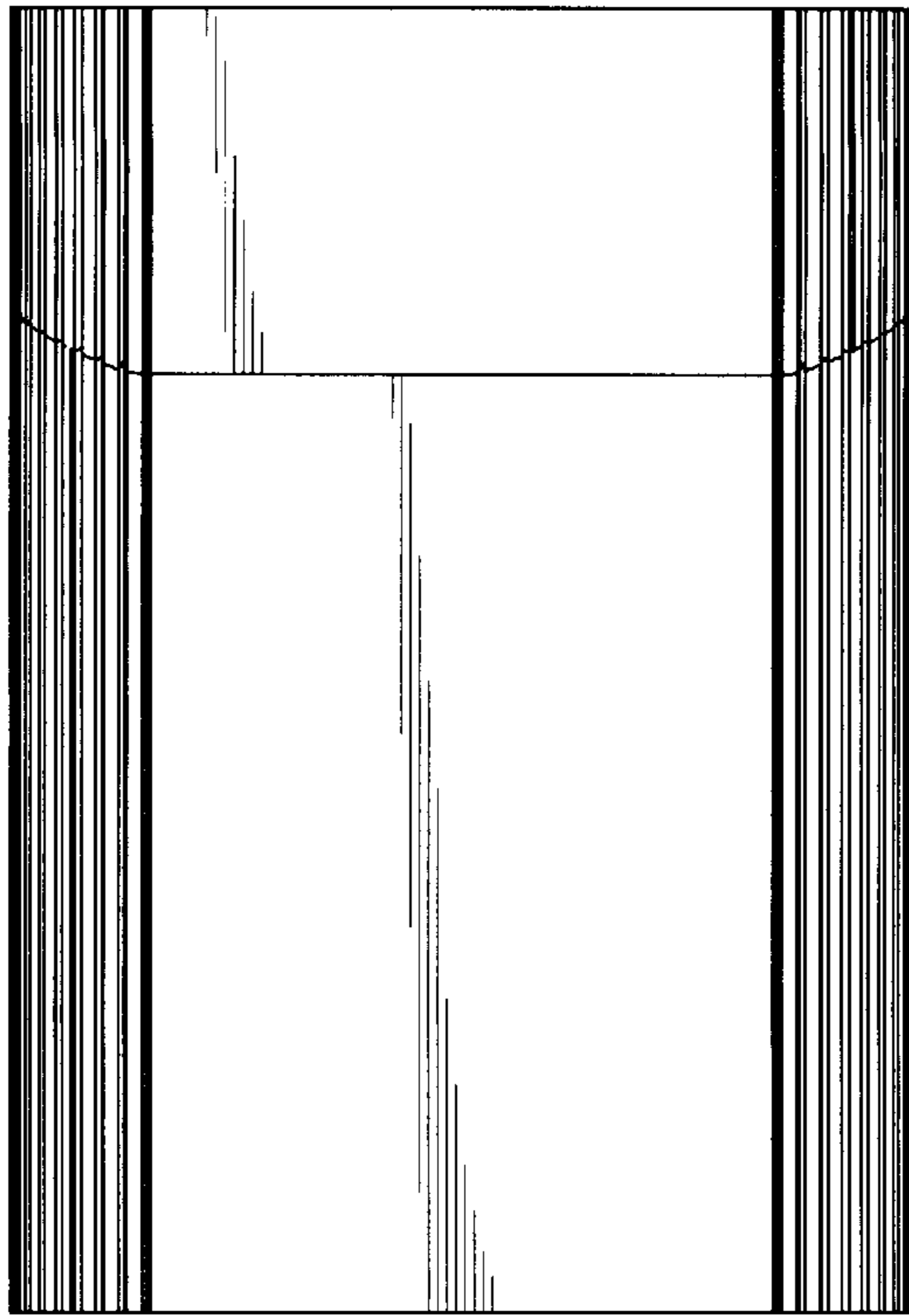

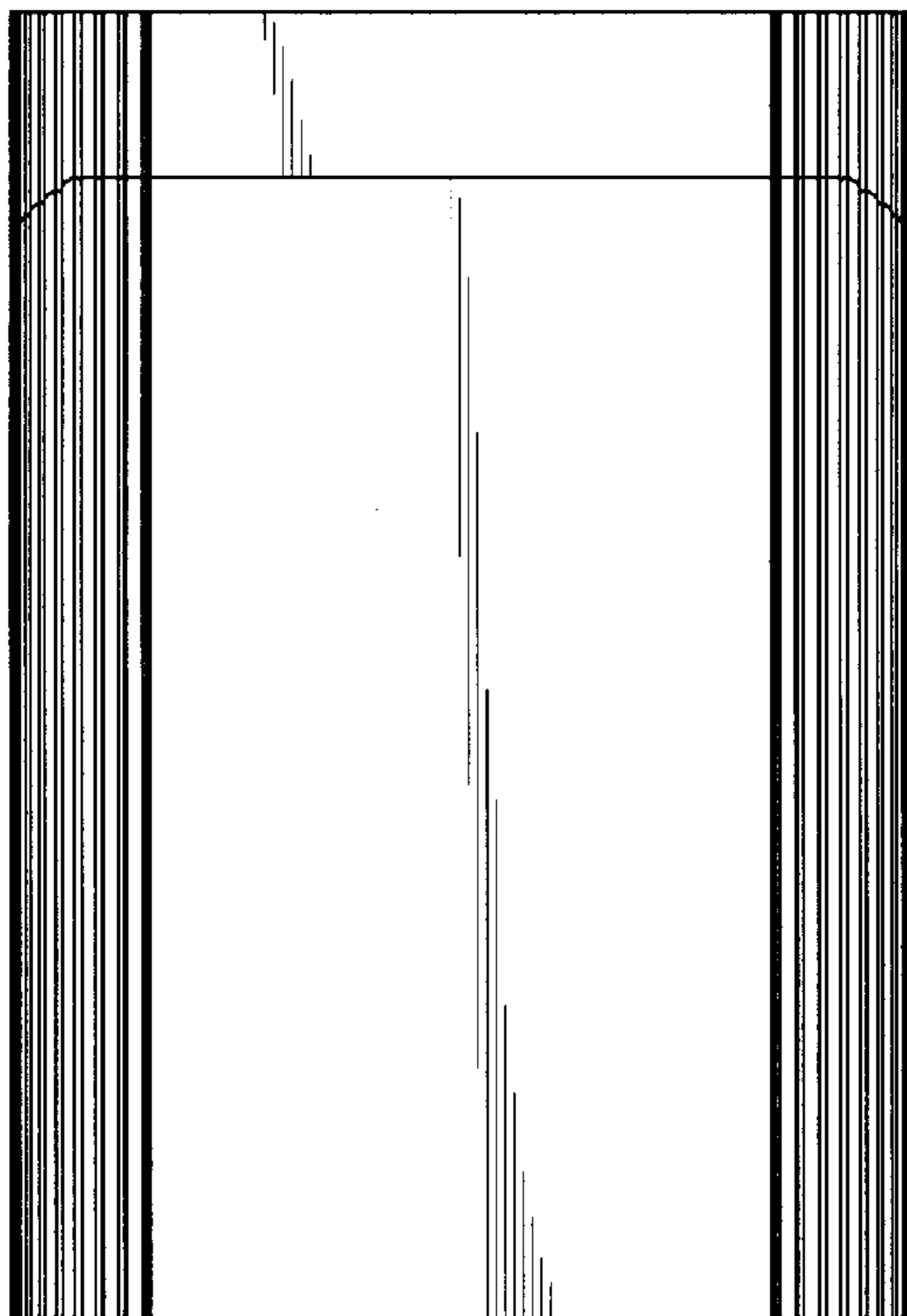

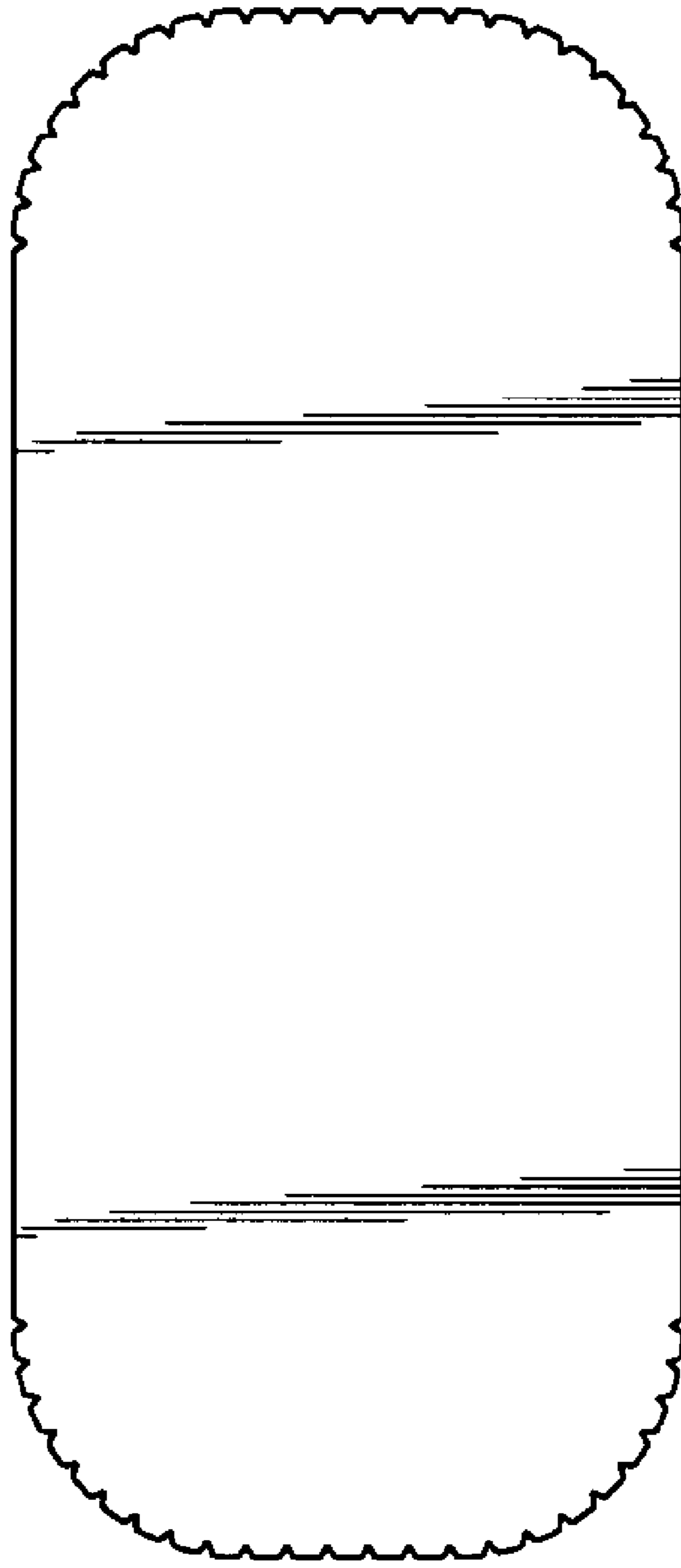

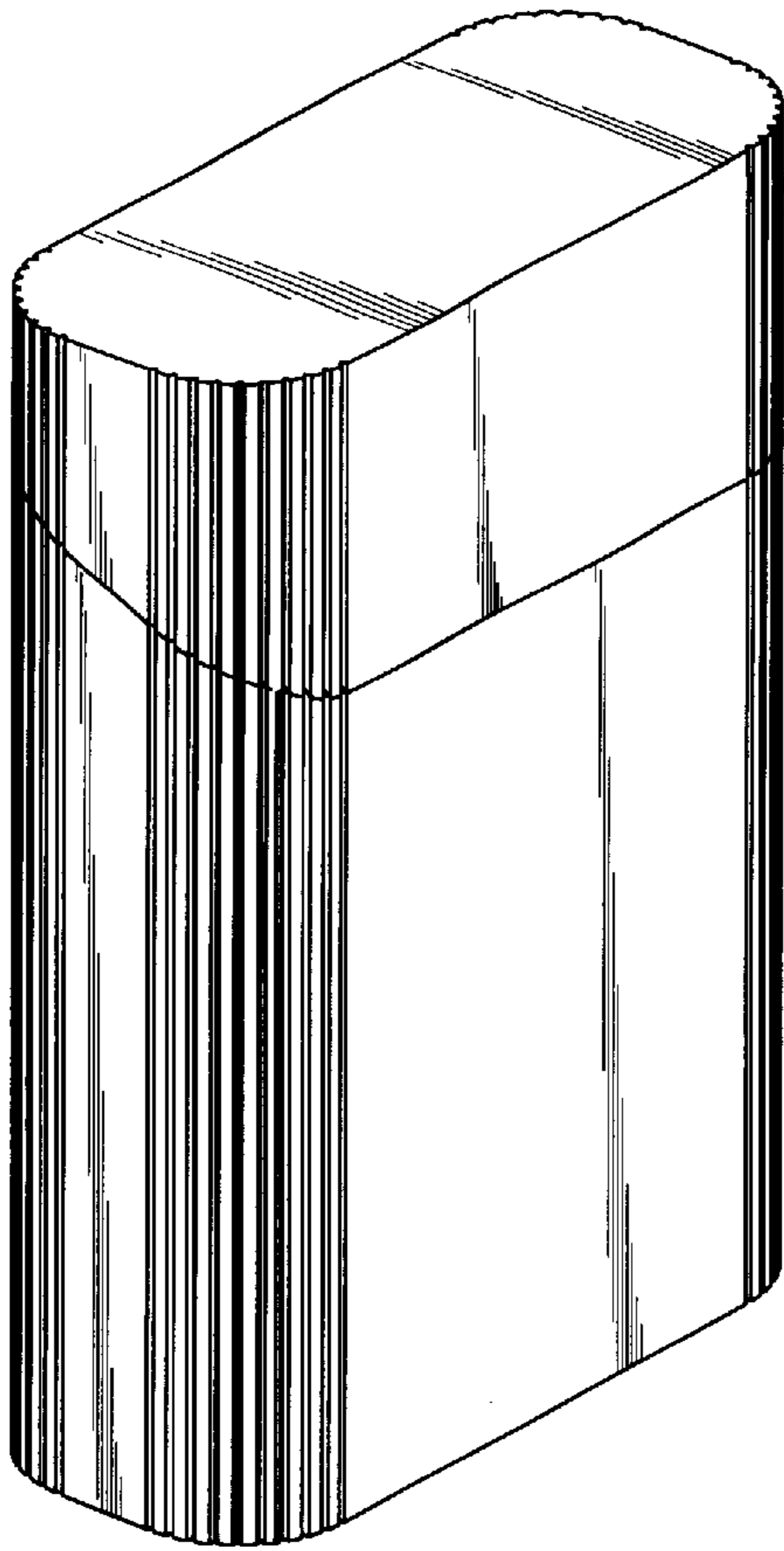

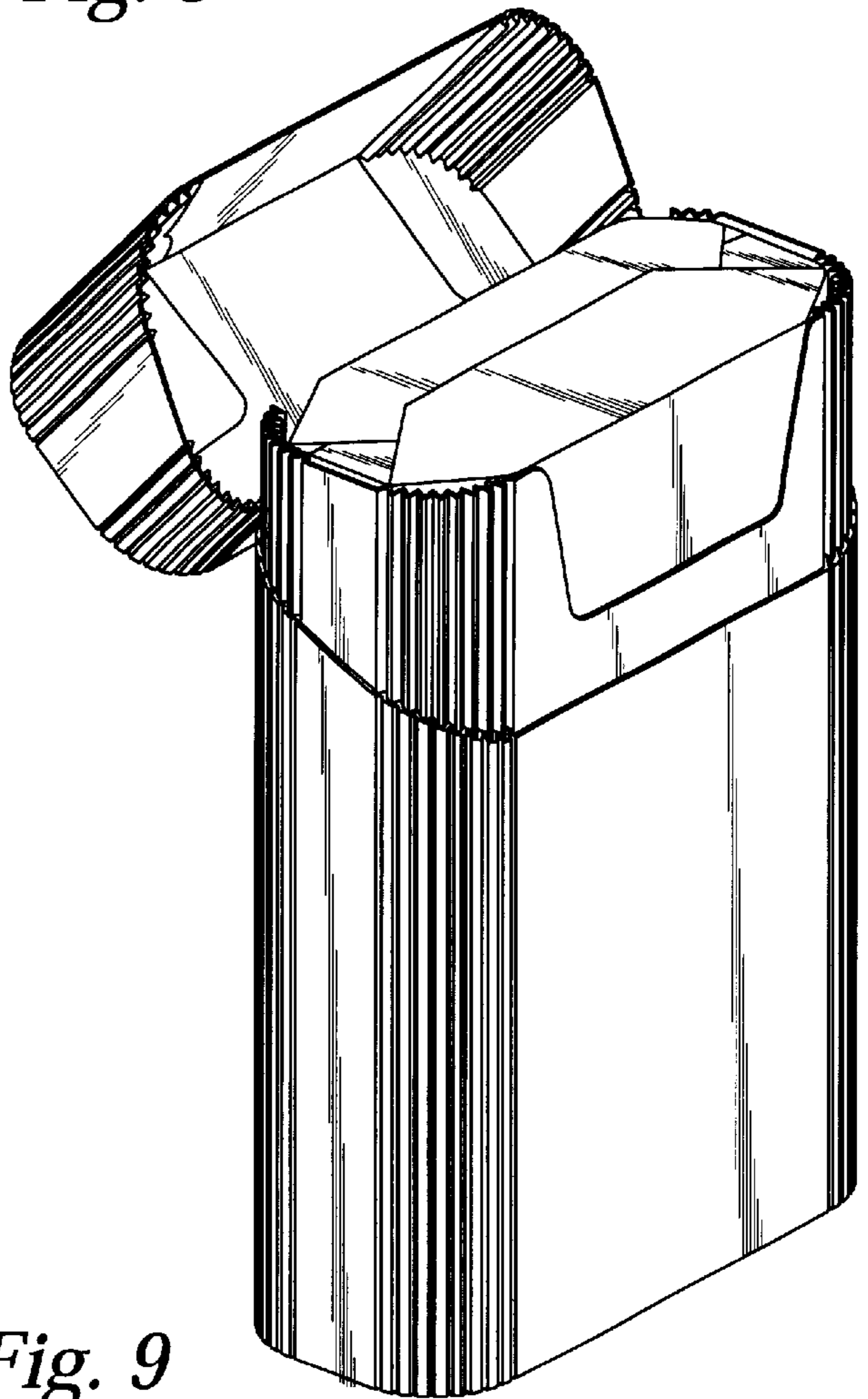

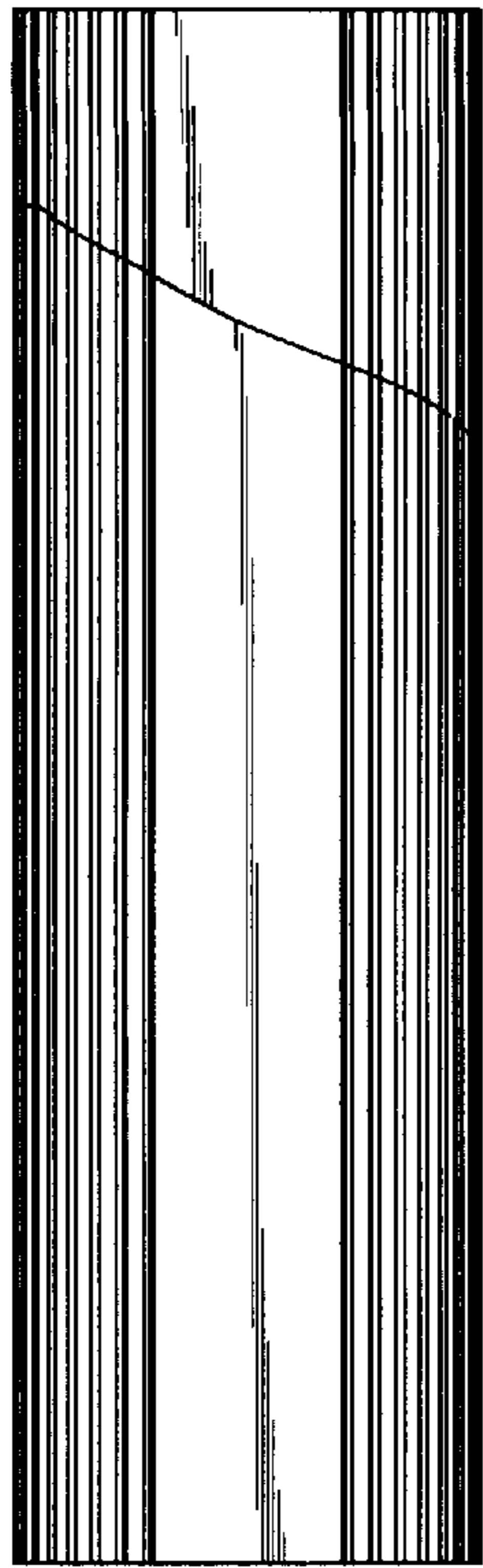

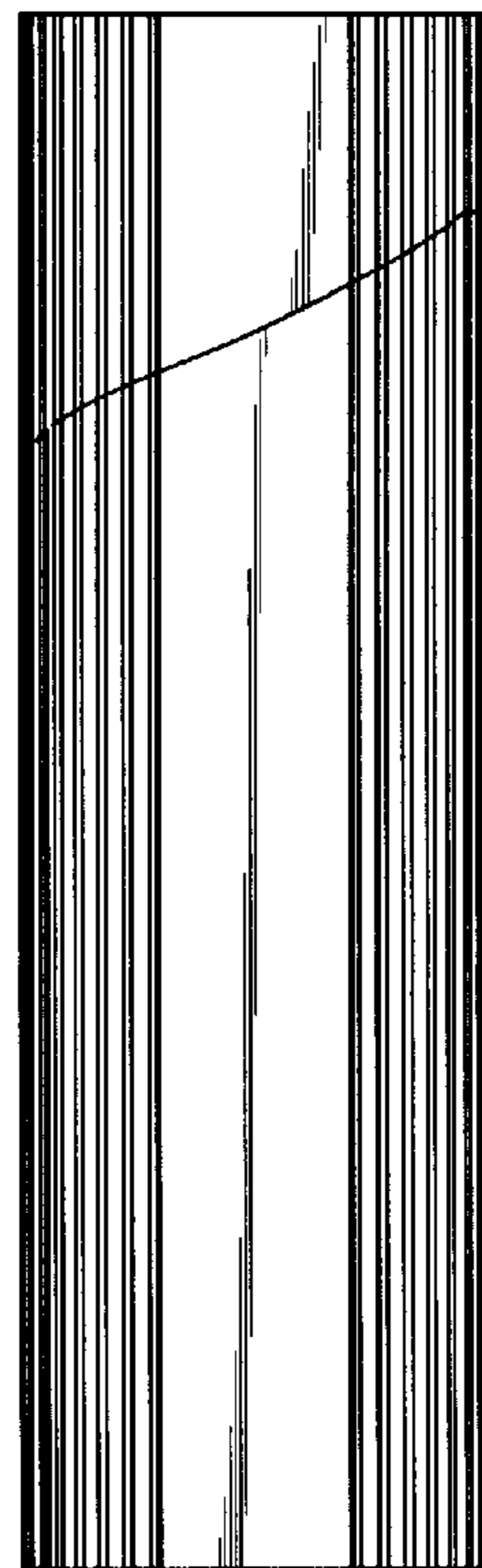

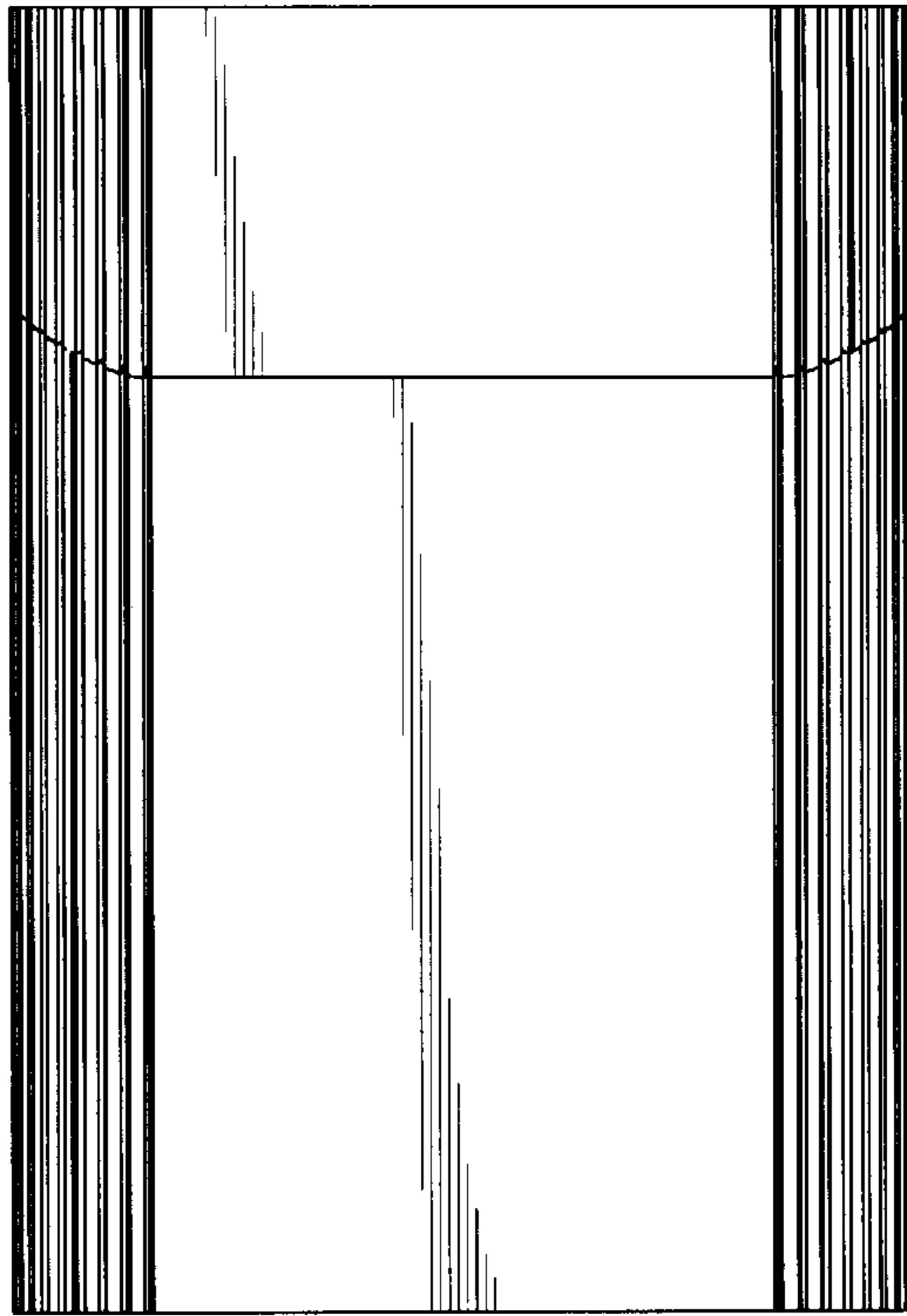

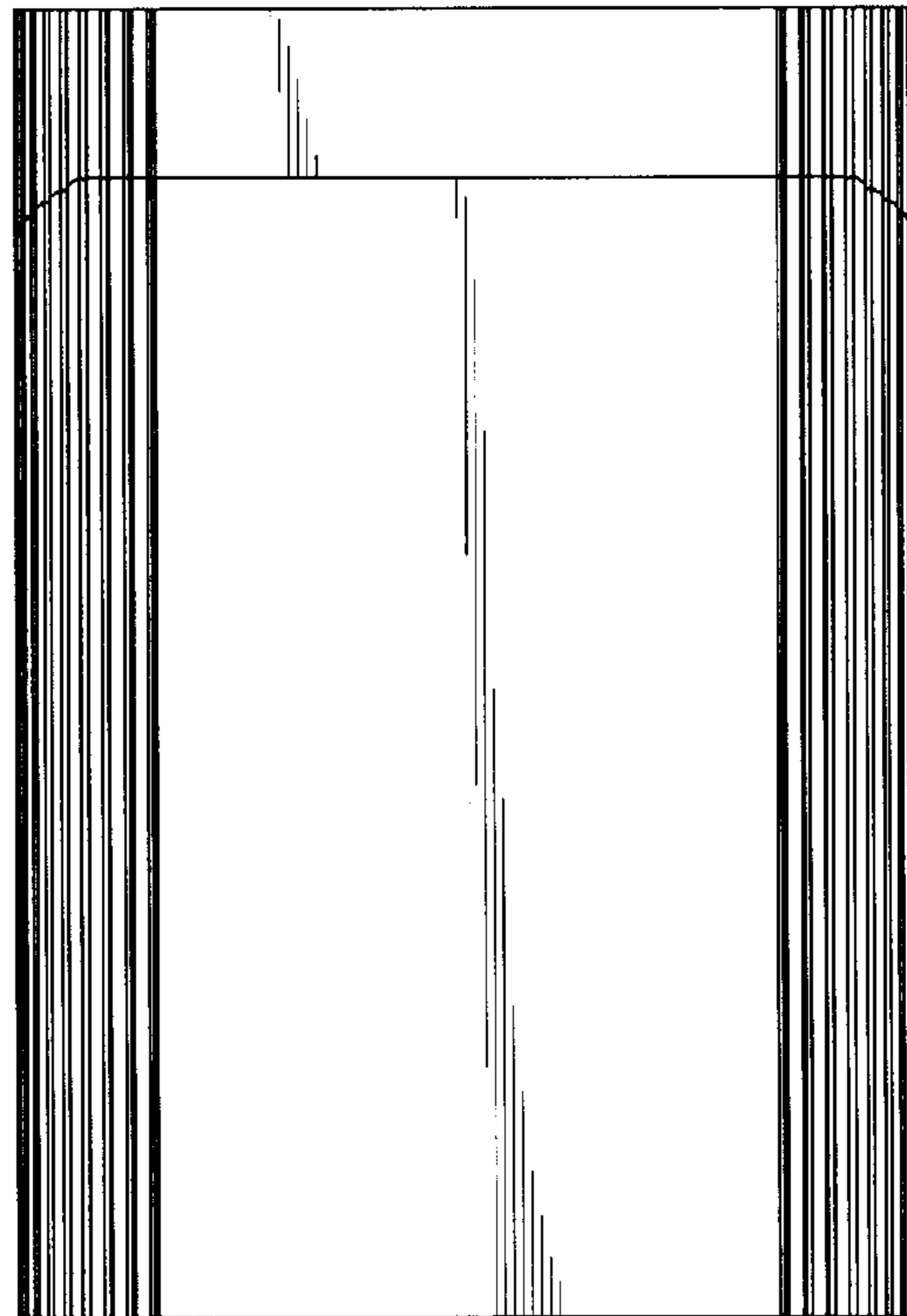

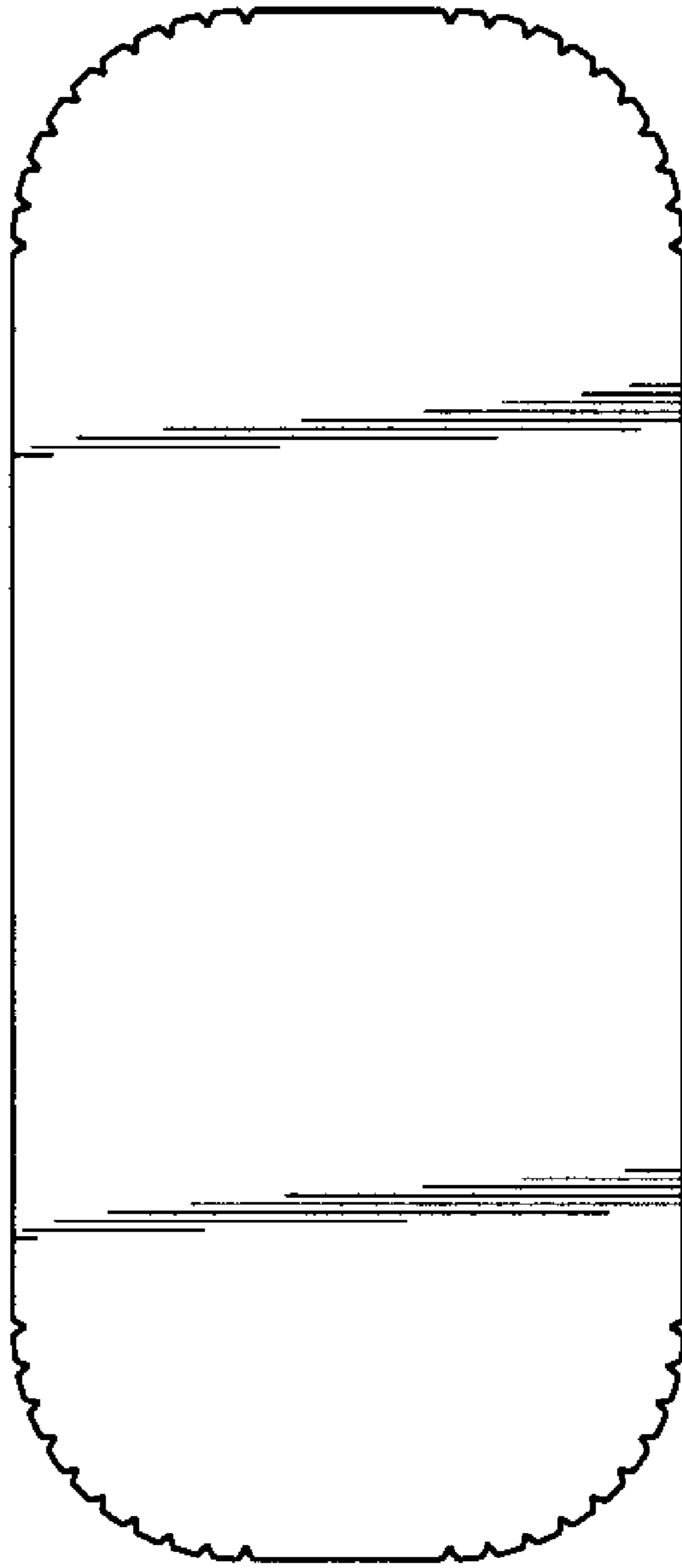
