(57) **CLAIM**

The ornamental design for a house shaped litter box with removable peak roof, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment with the roof;

FIG. 2 is a front elevational view of the first and third embodiment;

FIG. 3 is a side view of the first embodiment;

FIG. 4 is a top plan view of all embodiments;

FIG. 5 is a rear view of all embodiments;

FIG. 6 is a bottom plan view of all embodiments;

FIG. 7 is a front view of the removed roof;

FIG. 8 is a perspective bottom inside view of the removed roof;

FIG. 9 is an underside plan view of the roof;

FIG. 10 is a left perspective view of the first embodiment without the roof, the right perspective view being a mirror image thereof;

FIG. 11 is the top plan view of the first and third embodiments with the roof removed;

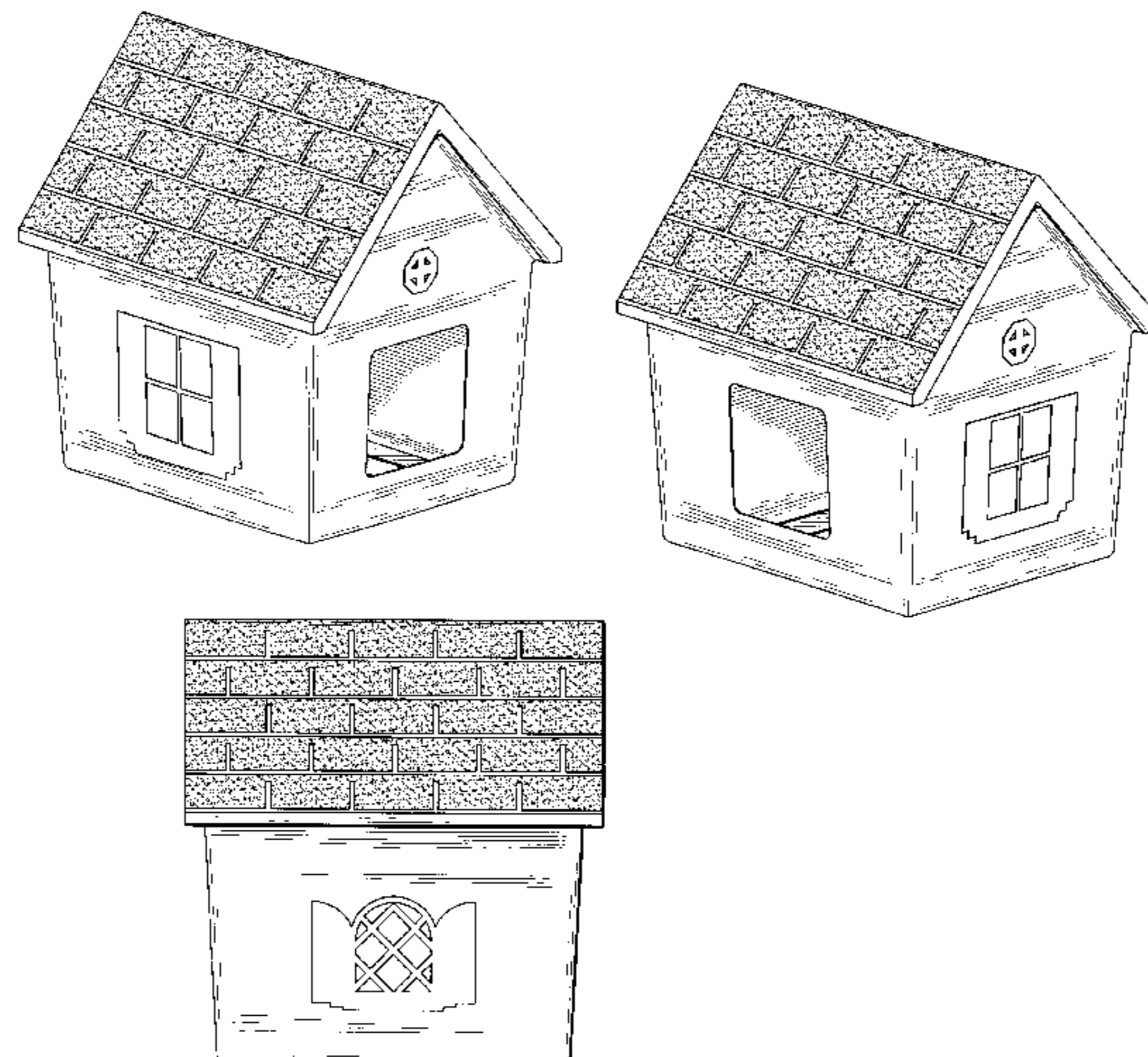
FIG. 12 is a right side front perspective view of the second embodiment;

FIG. 13 is an elevational view of the left right side of the third embodiment;

FIG. 14 is a left side elevational view of the second embodiment; and,

FIG. 15 is a top plan view of the second embodiment with the roof removed.

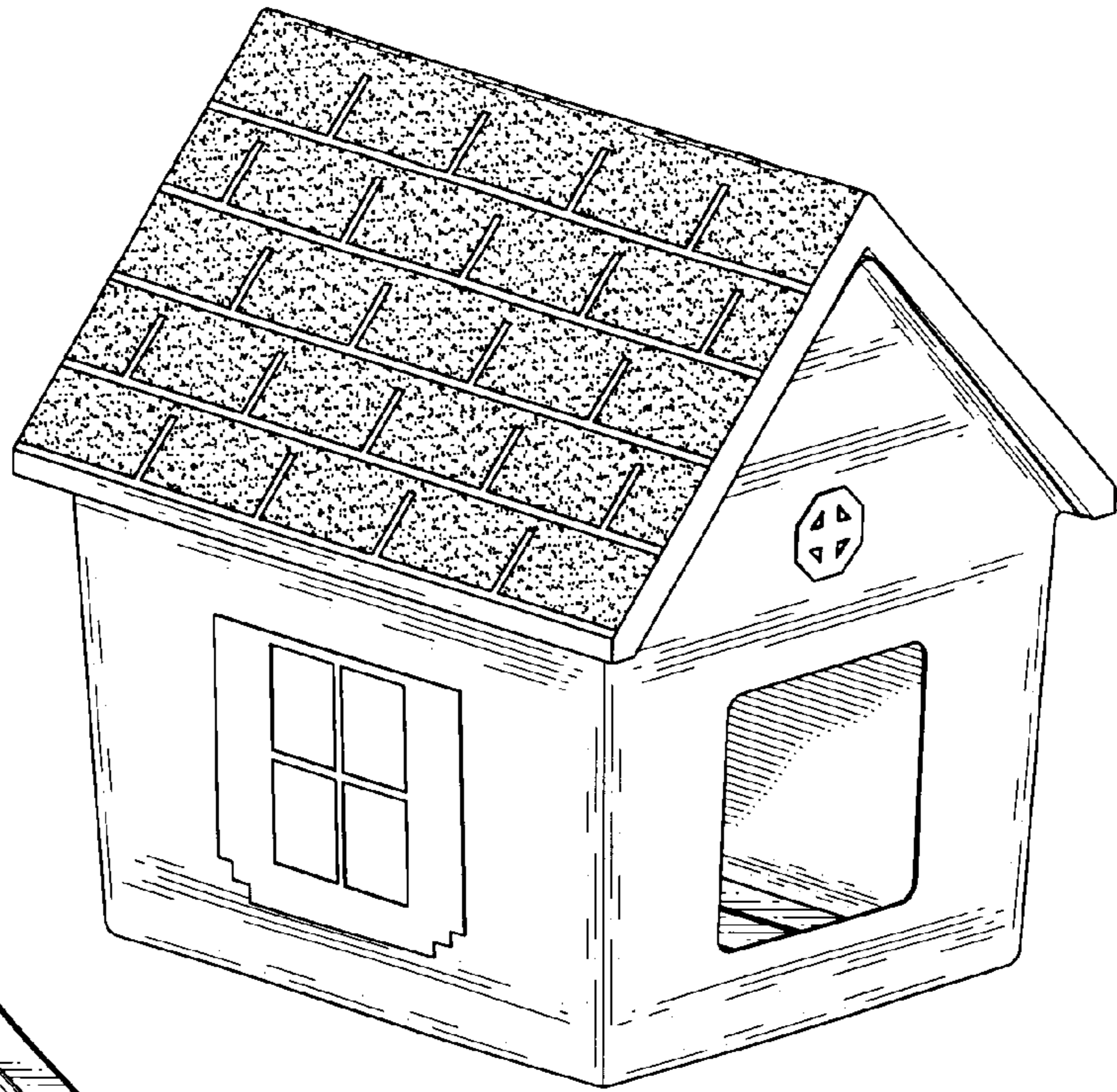

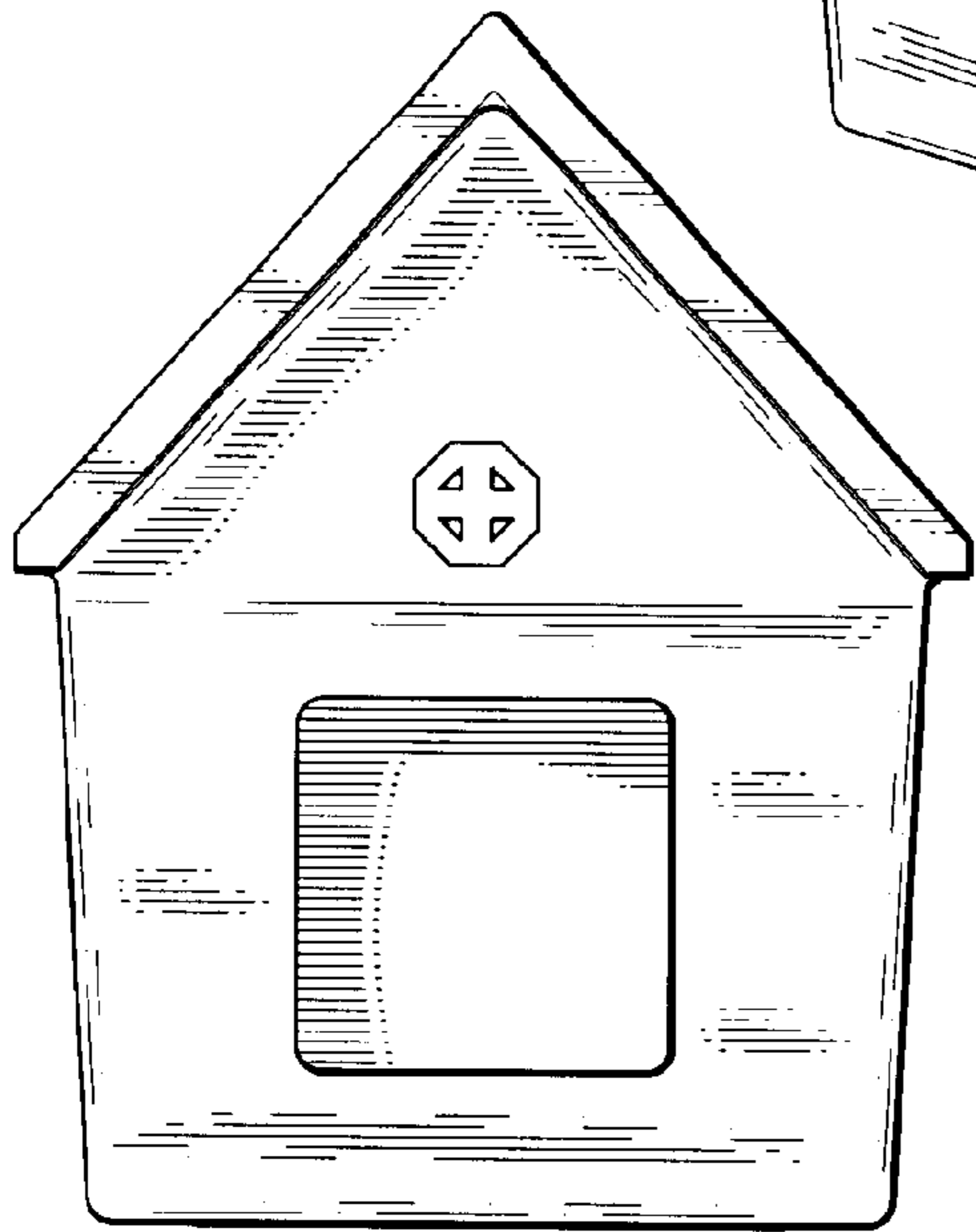

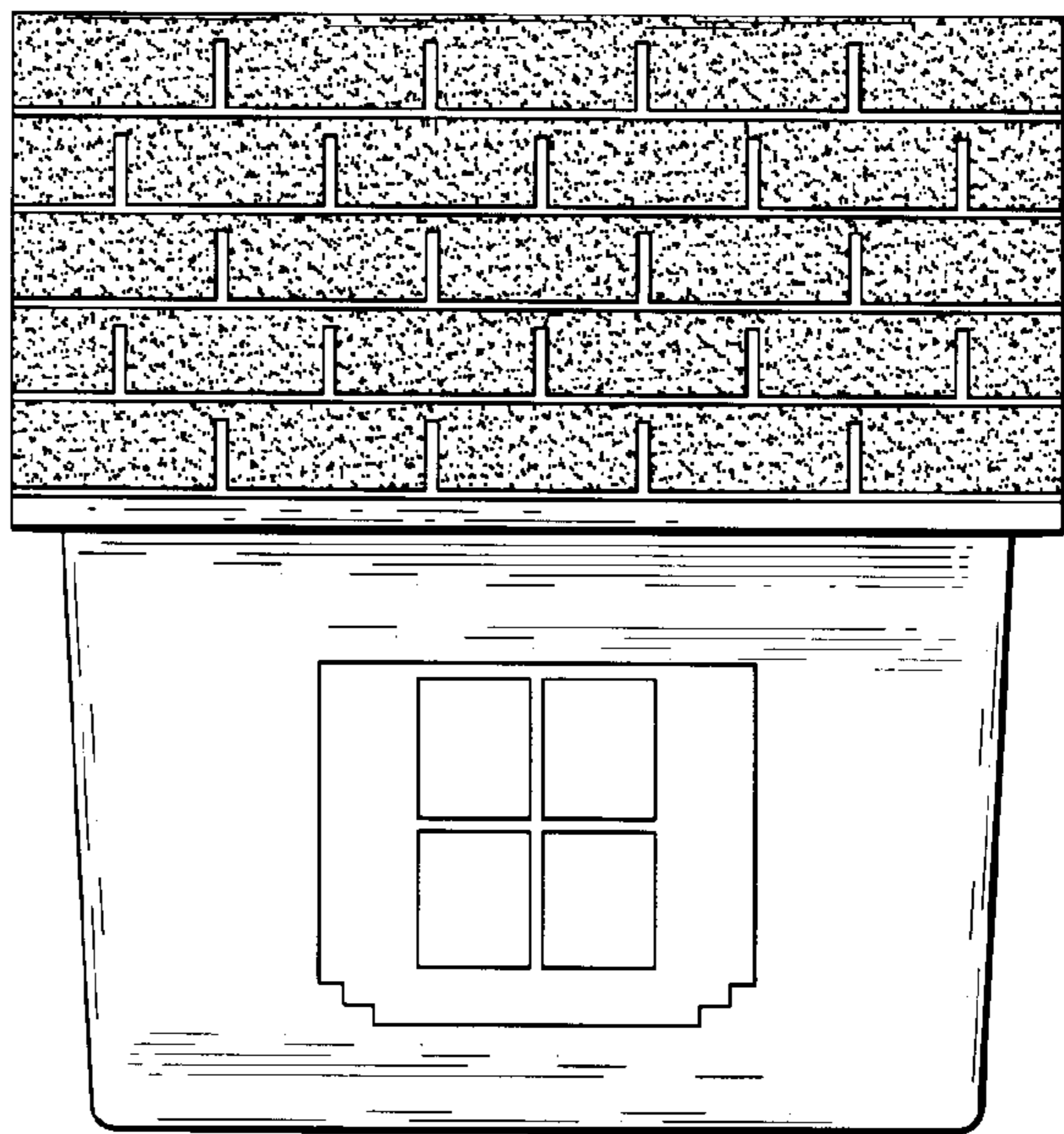

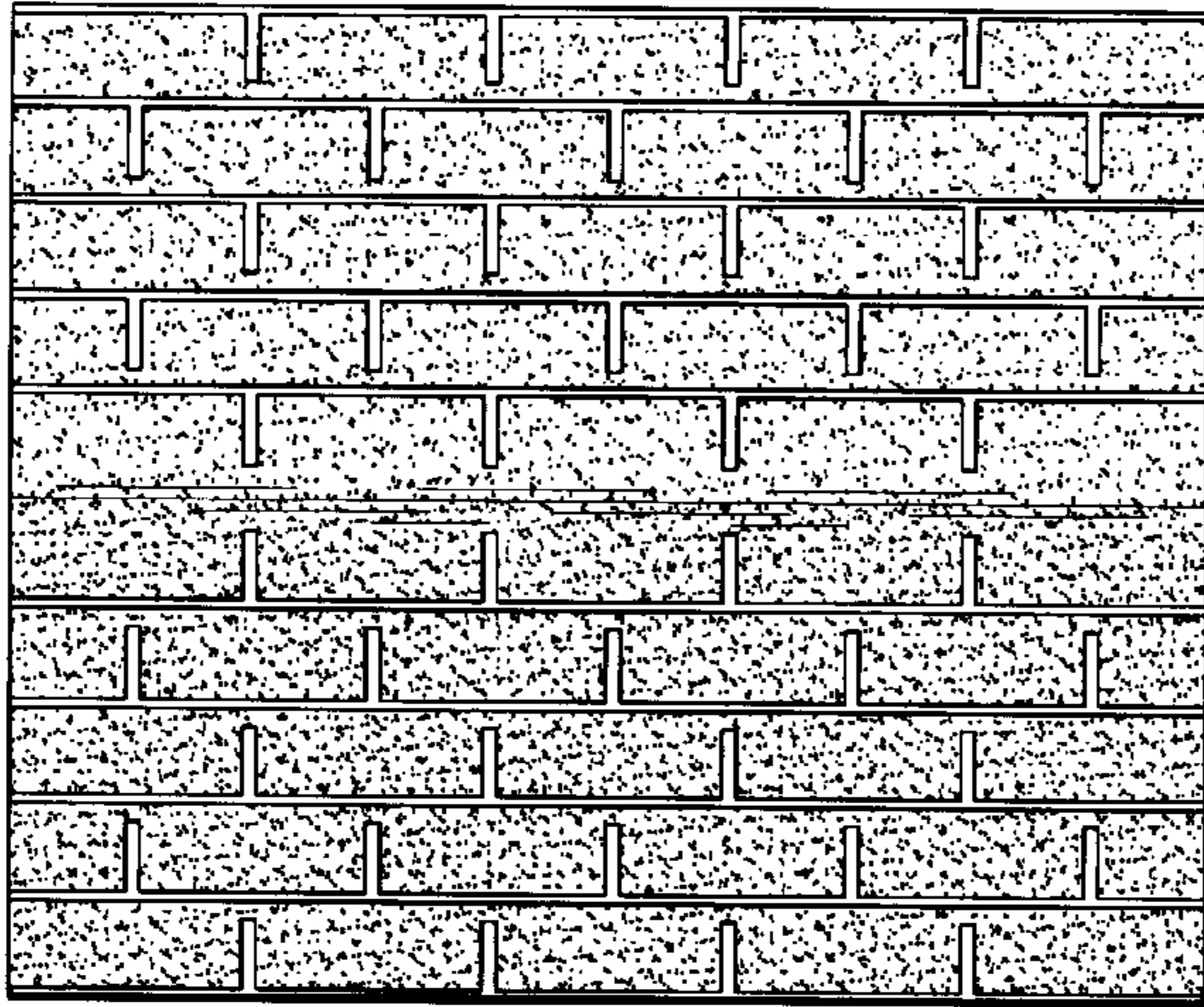

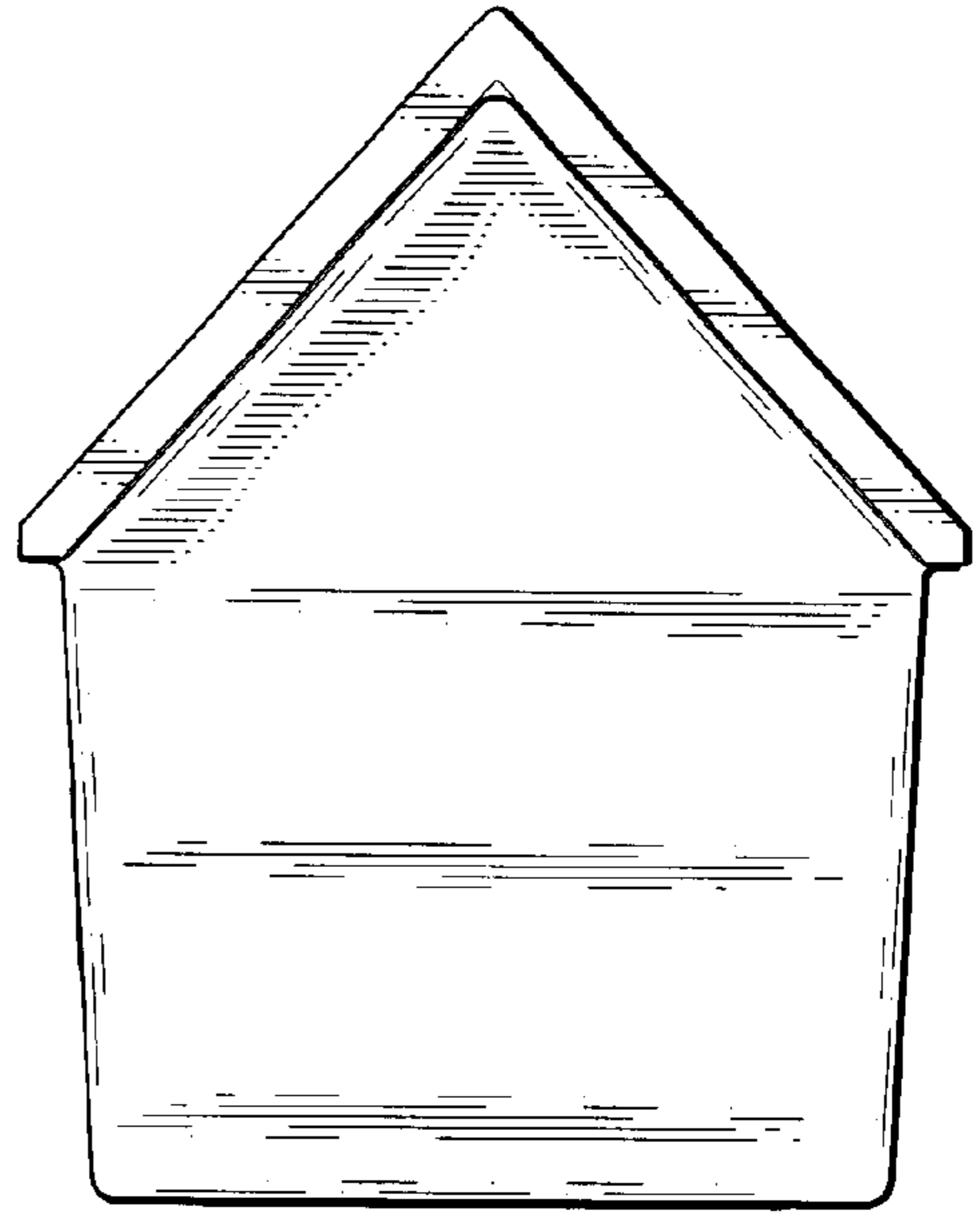

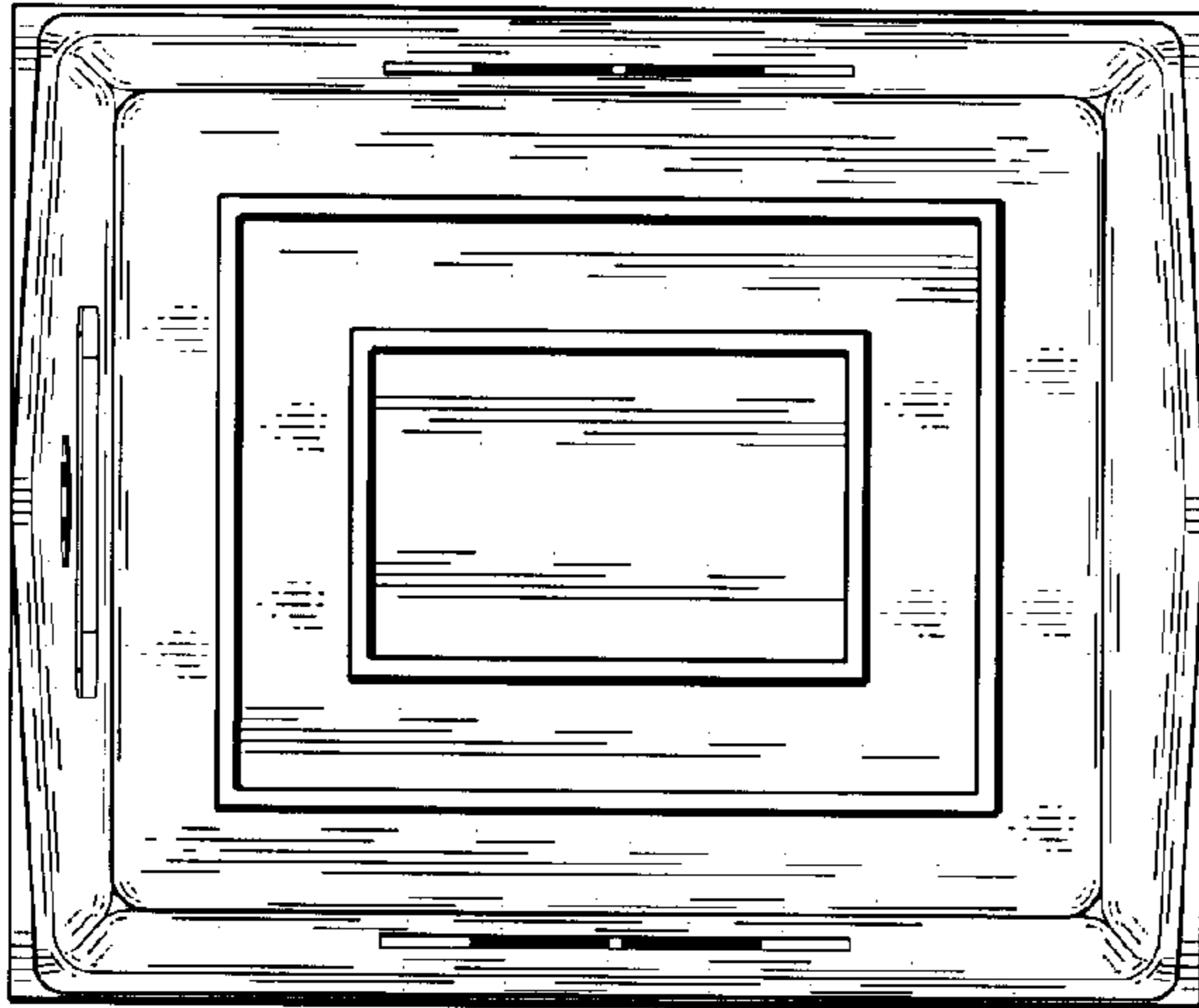

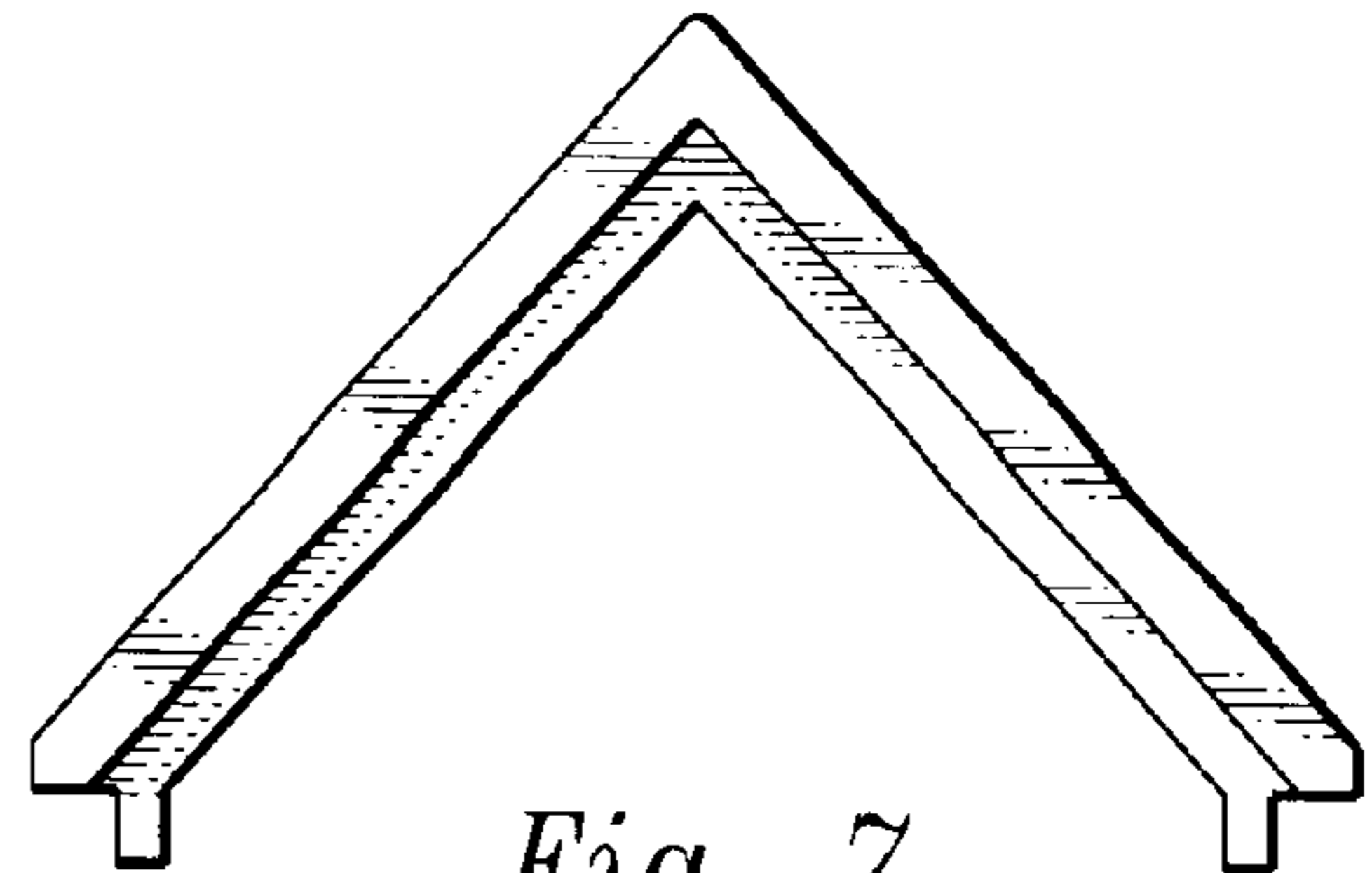

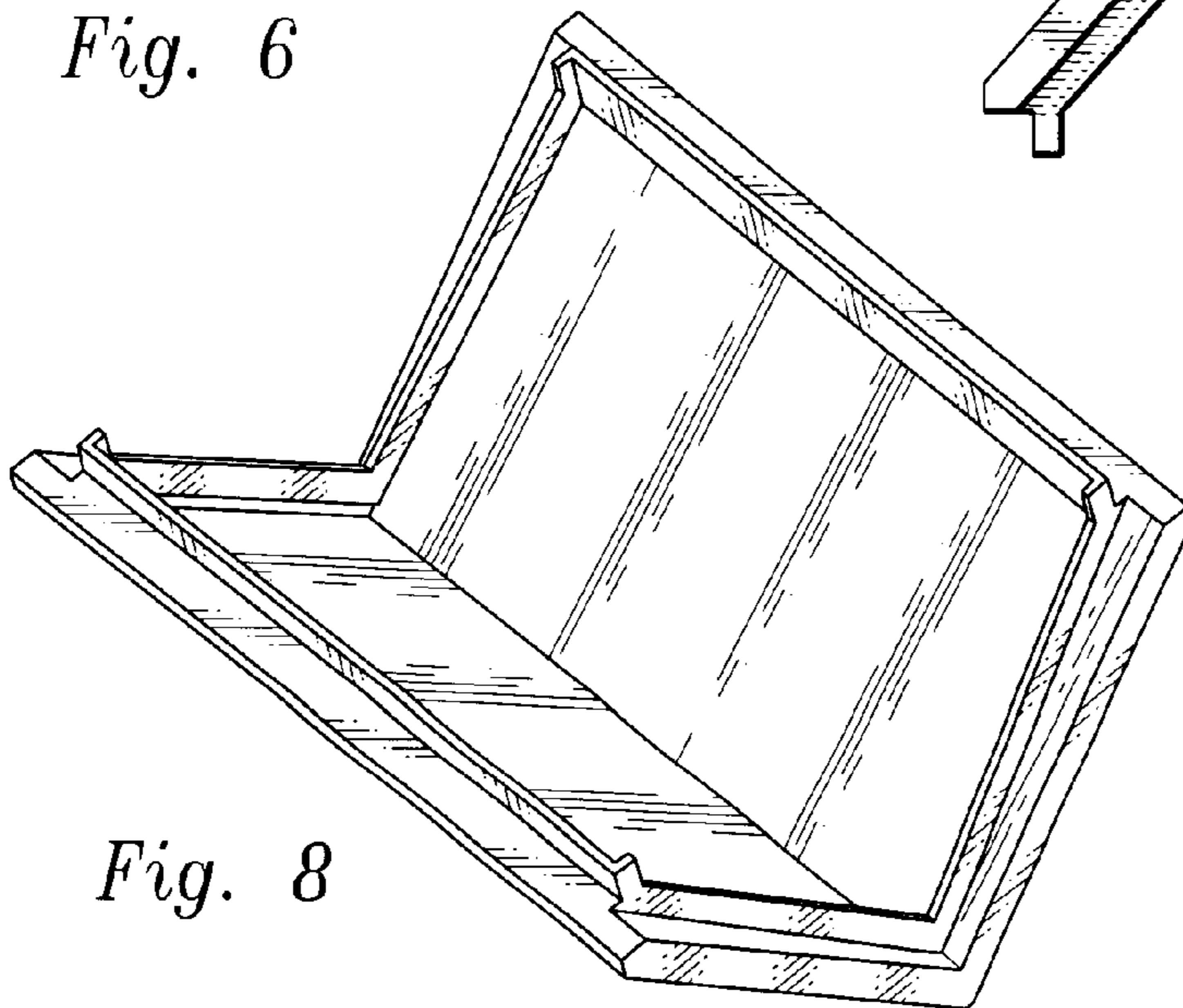

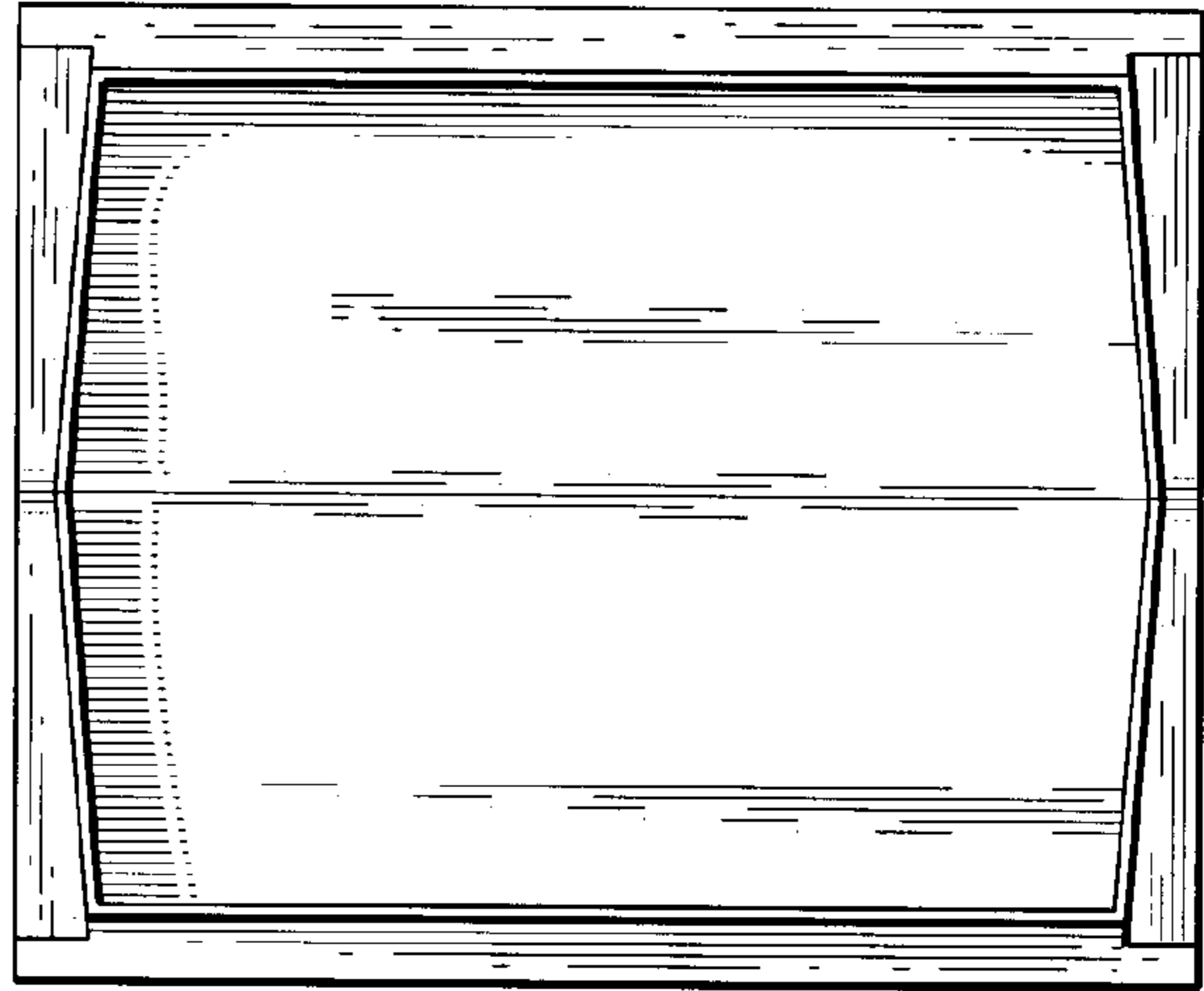

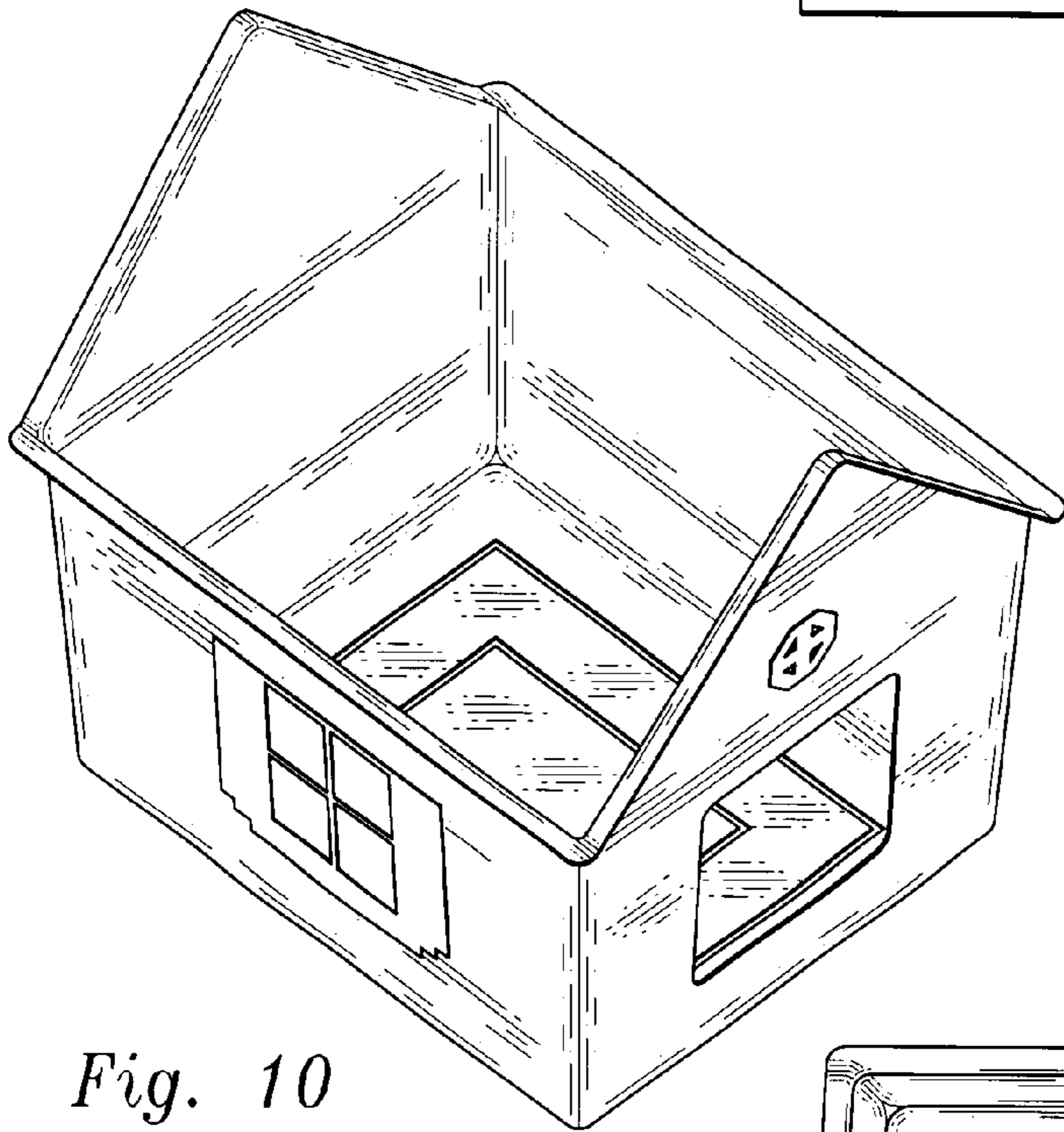

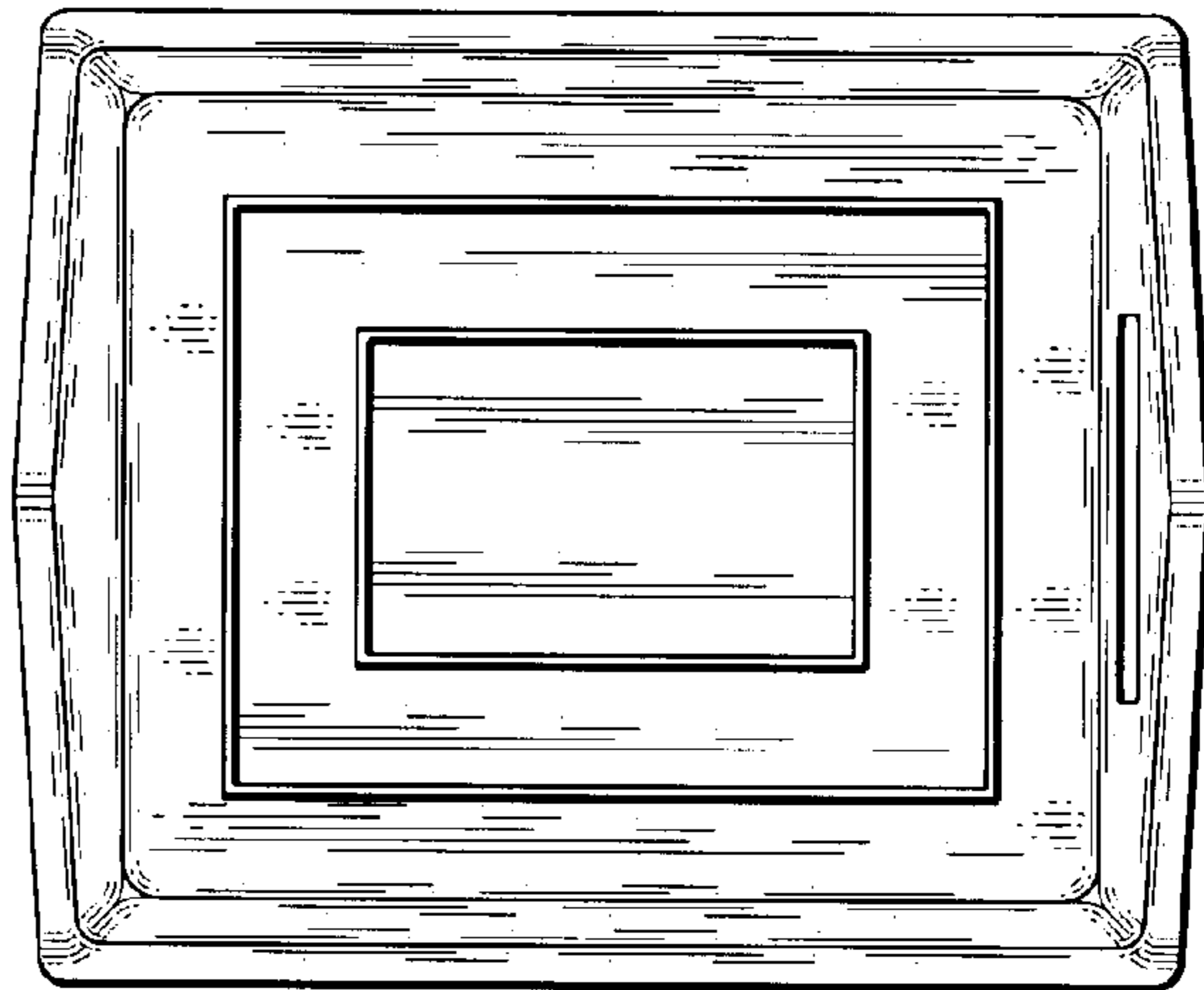

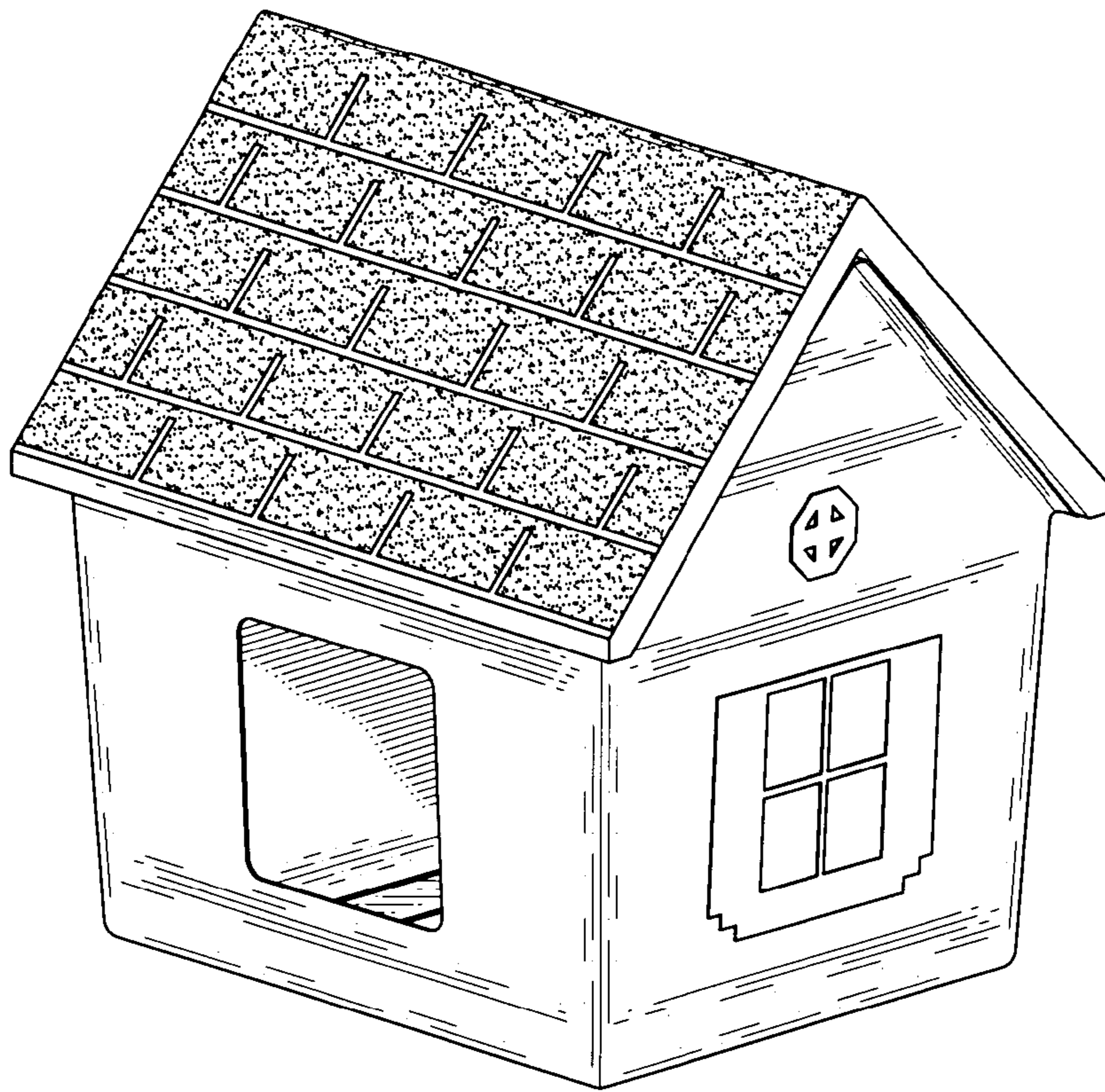

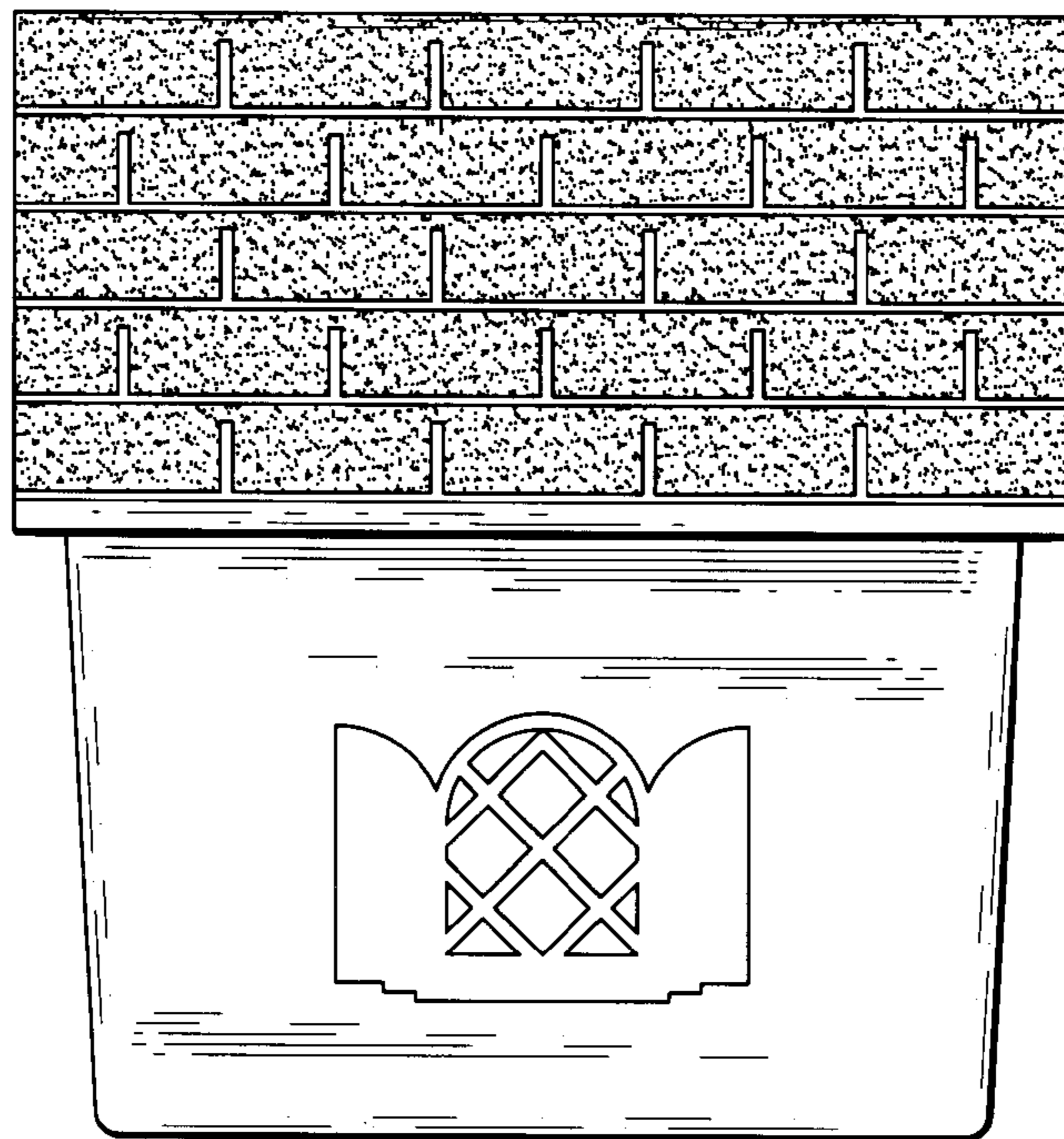

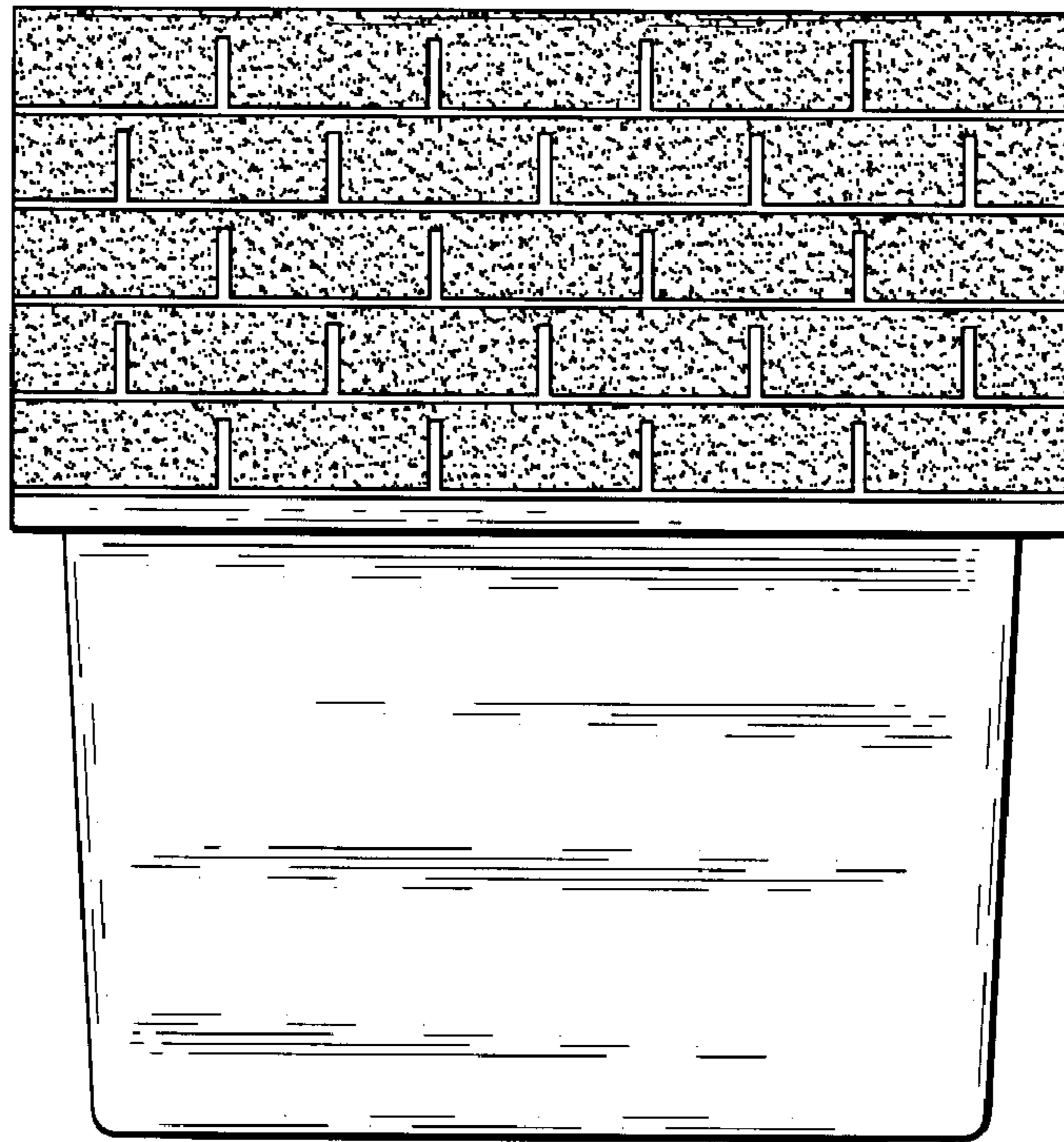

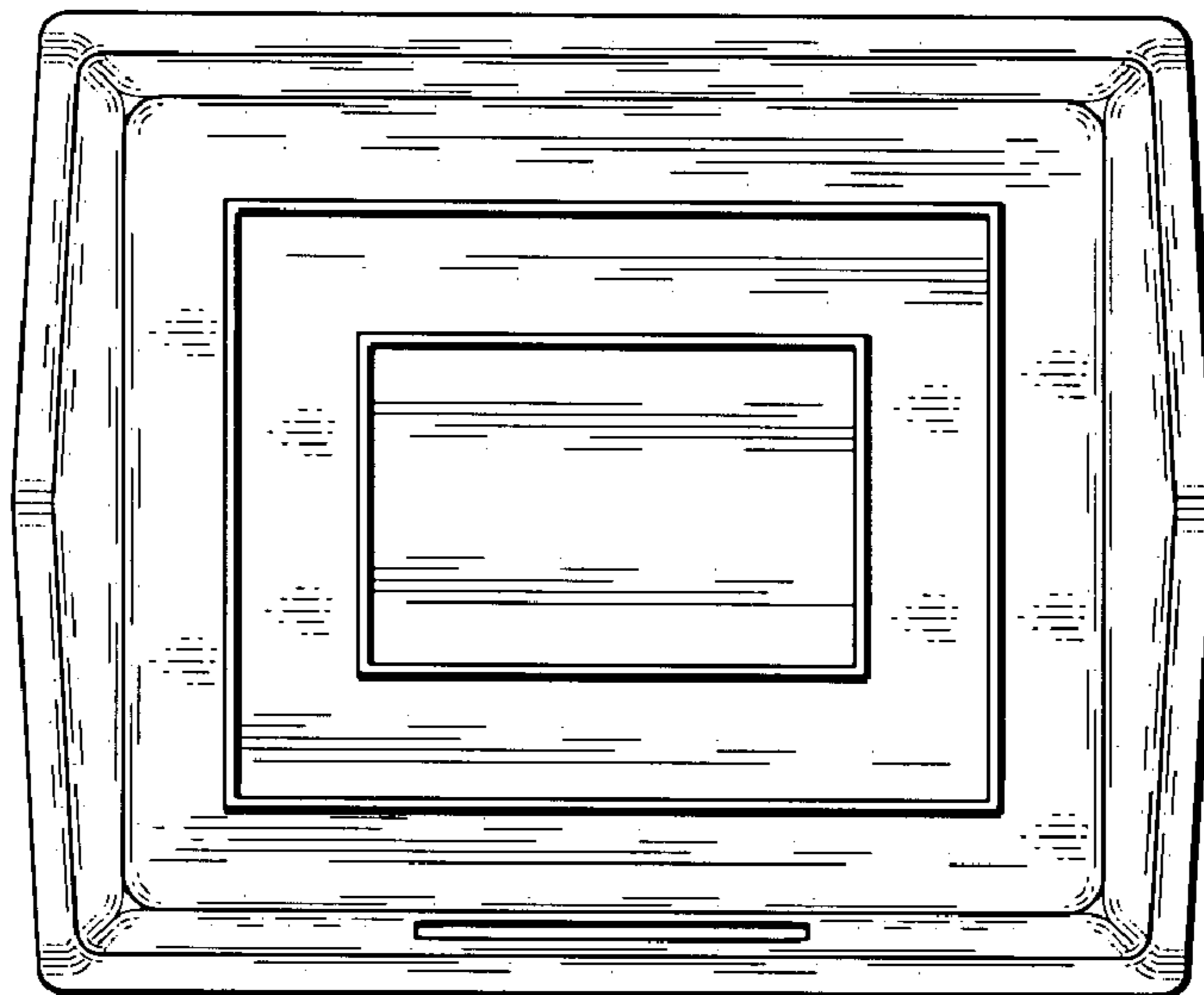
