(57) **CLAIM**

The ornamental design for a shark tooth shaped suede shoe brush, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of the shark tooth shaped suede shoe brush.

FIG. 2 is a right side view of the shark tooth shaped suede shoe brush.

FIG. 3 is a front view of the shark tooth shaped suede shoe brush.

FIG. 4 is a rear view of the shark tooth shaped suede shoe brush.

FIG. 5 is a bottom view of the shark tooth shaped suede shoe brush.

FIG. 6 is a top view of the shark tooth shaped suede shoe brush.

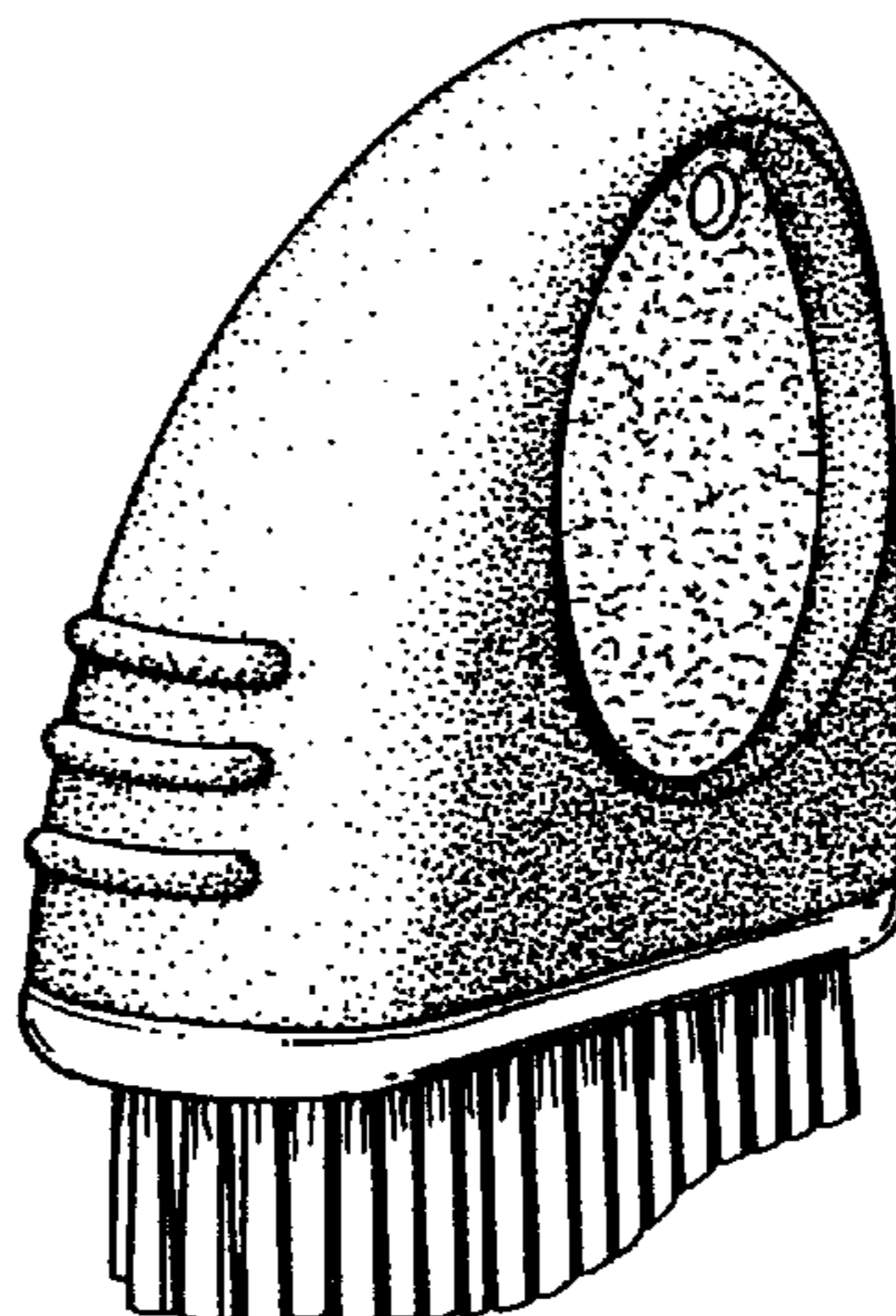
FIG. 7 is an exploded view of the shark tooth shaped suede shoe brush showing the manner in which an erasing, cleaning sleeve fits on and off of the remainder of the shark tooth shaped suede shoe brush.

FIG. 8 is a rear view of the shark tooth shaped suede shoe brush with the erasing sleeve removed; and,

FIG. 9 is a bottom view of the erasing sleeve.

The brush and erasing sleeve are shown separately in FIGS. 8 and 9 respectively for clarity of illustration.

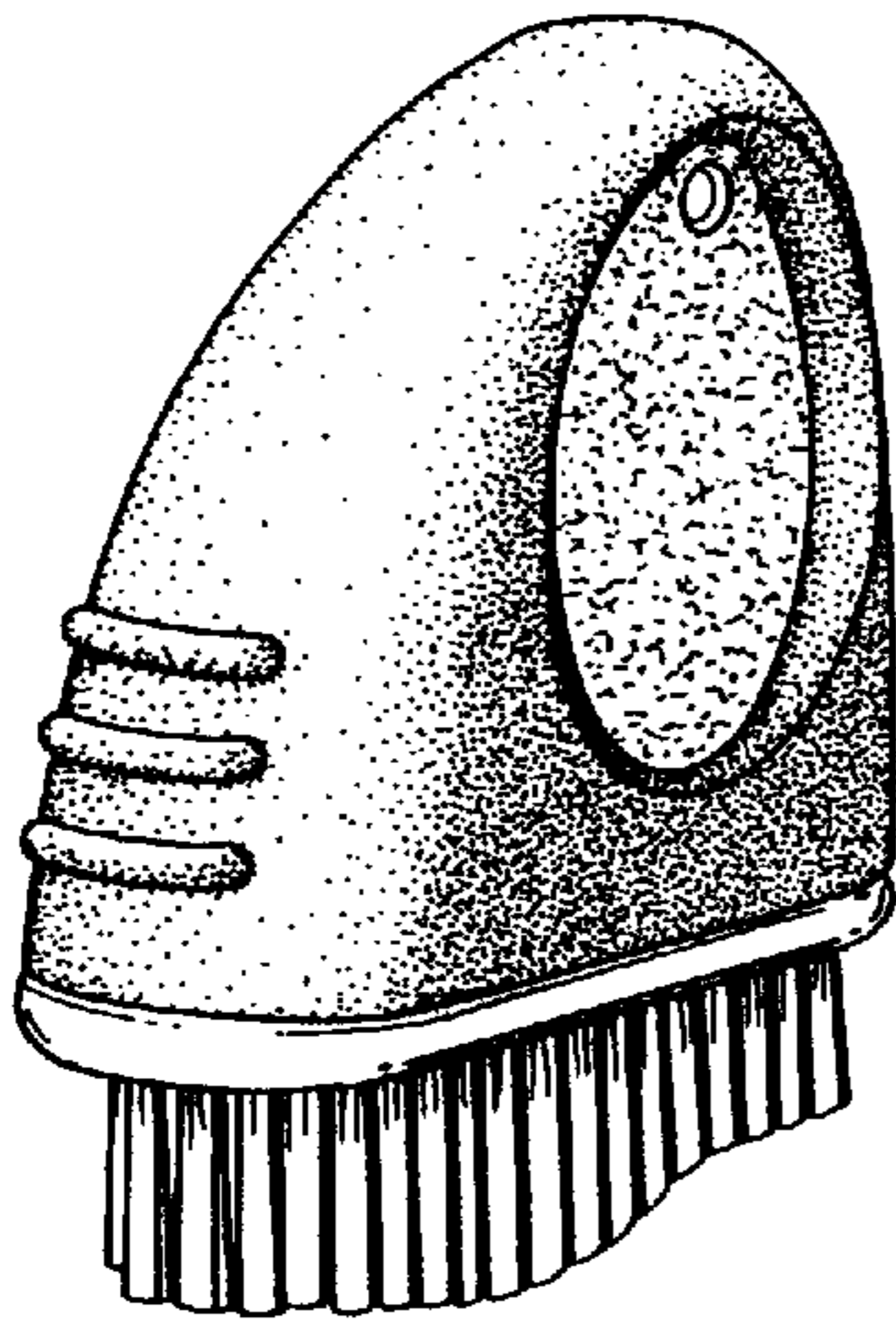

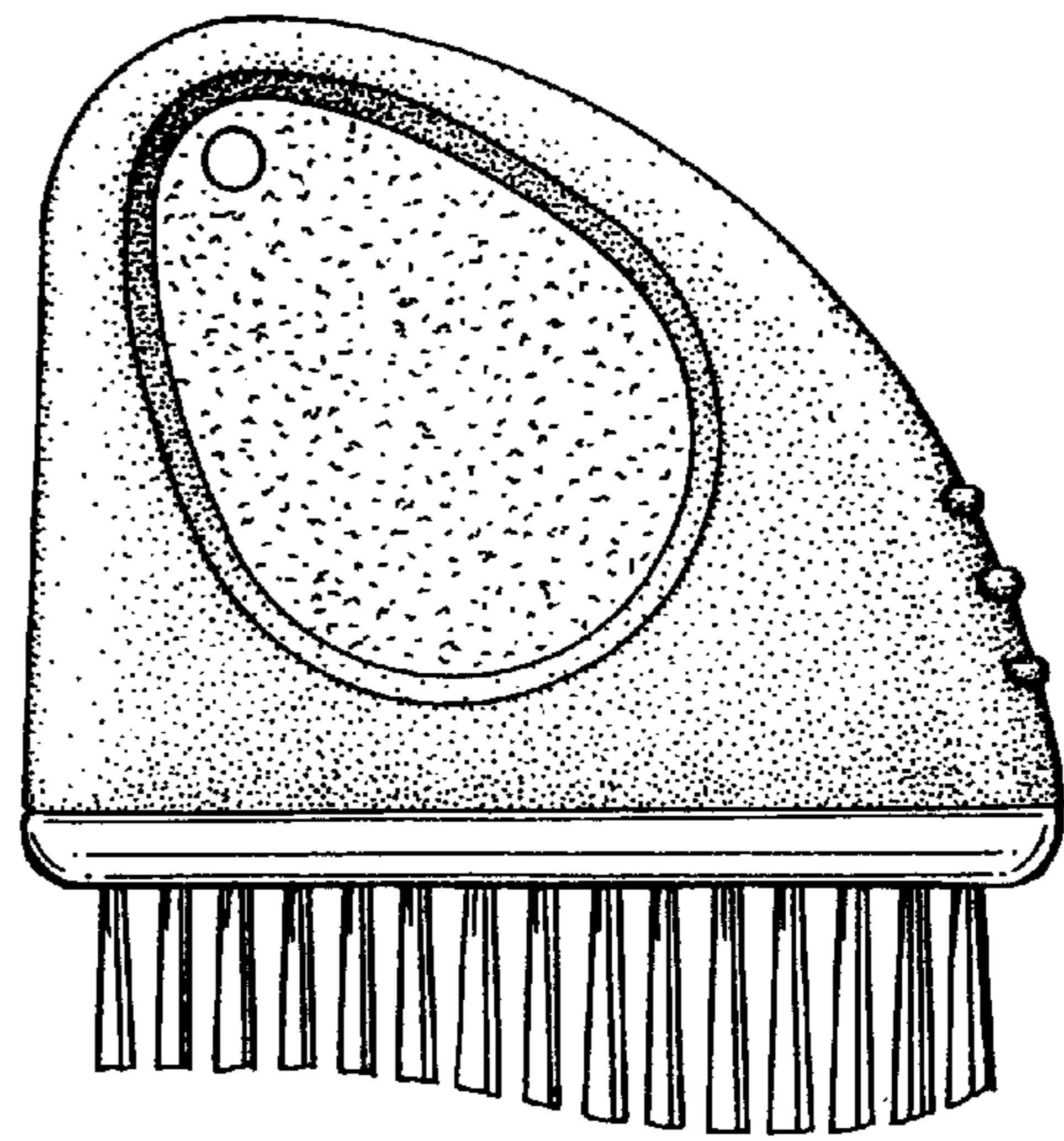

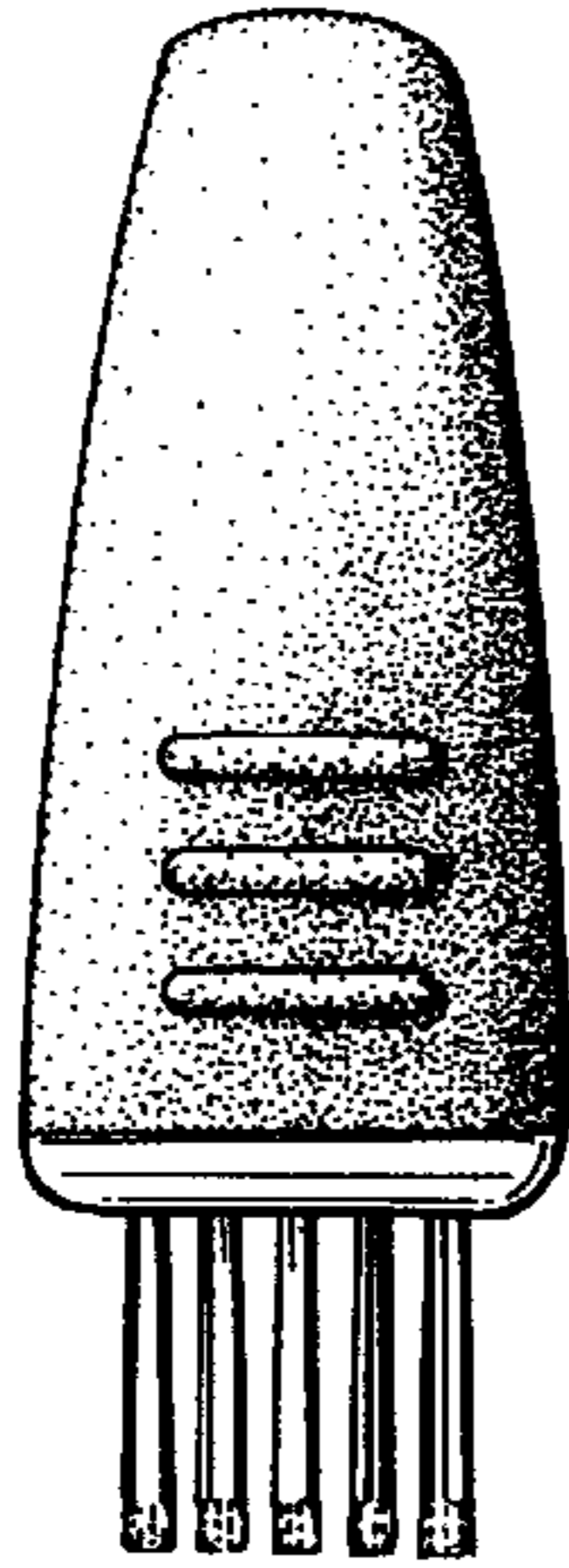

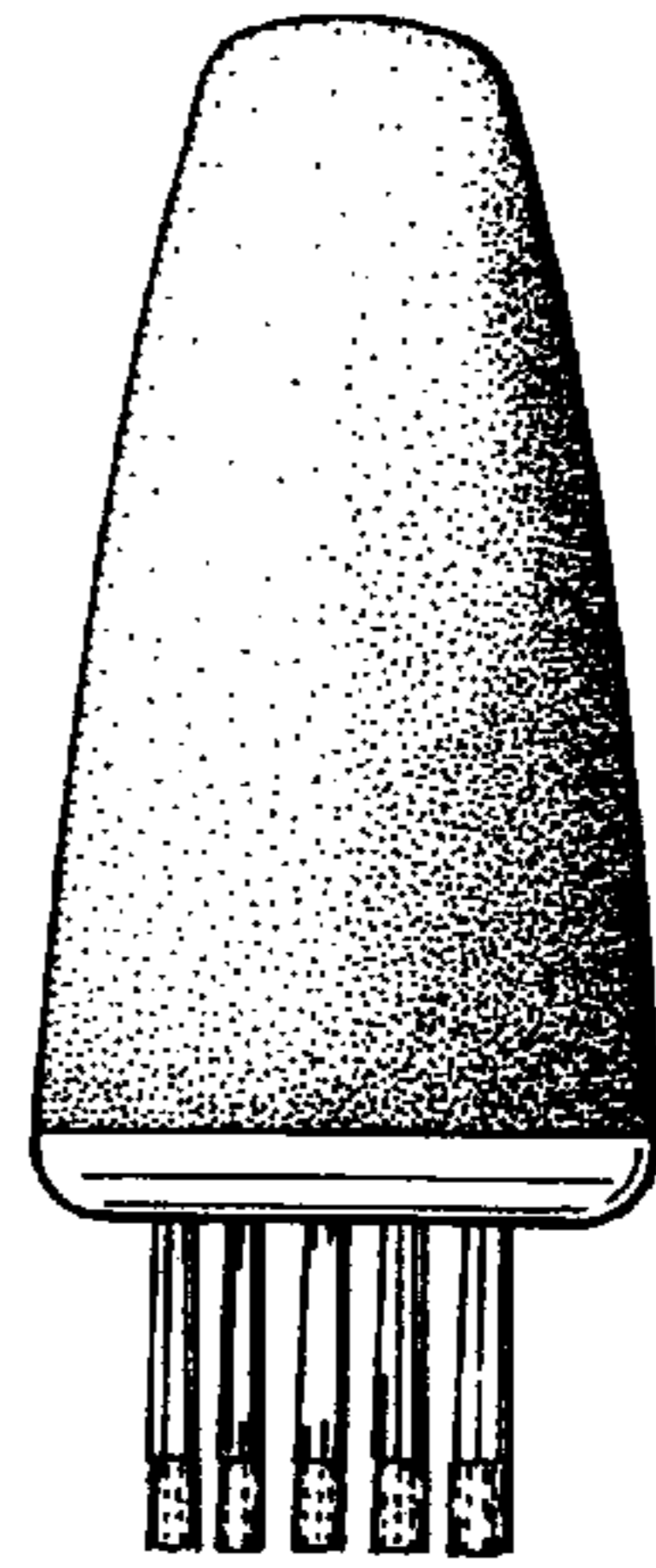

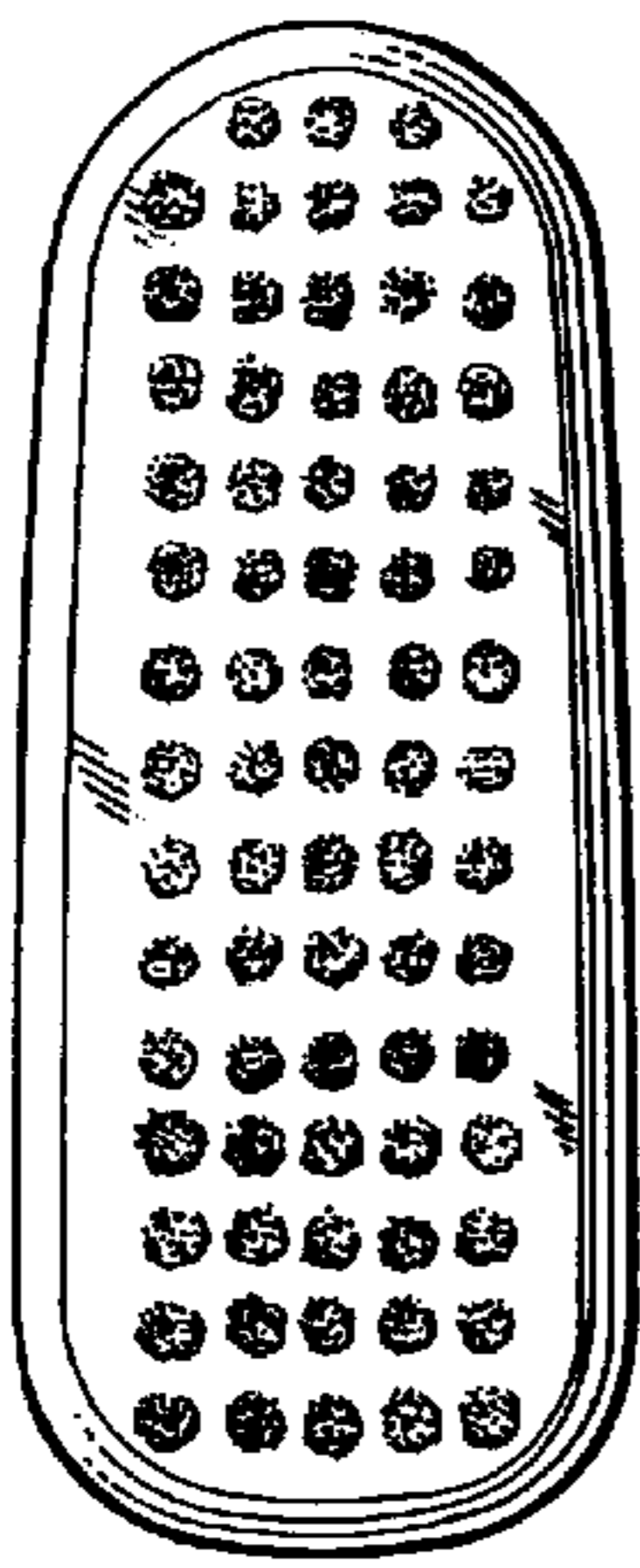

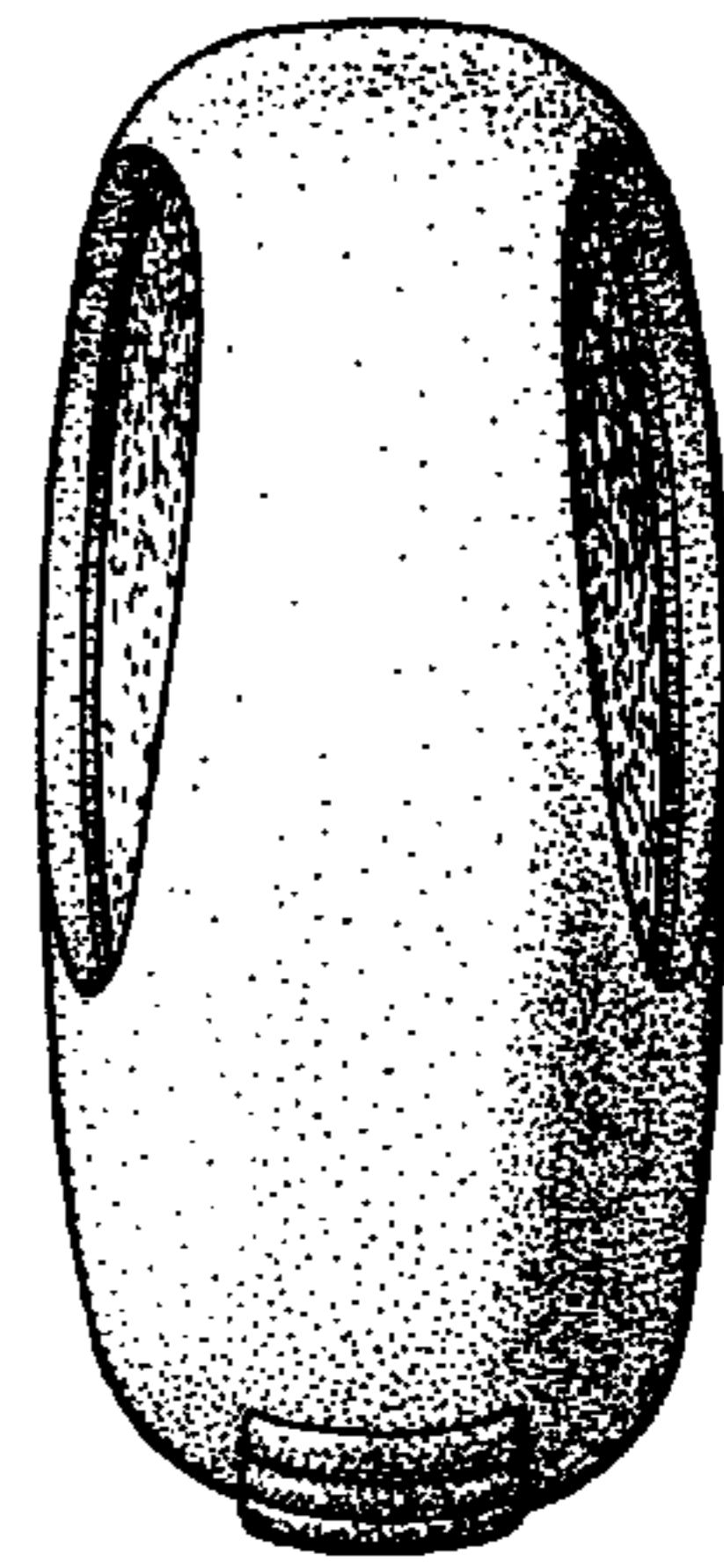

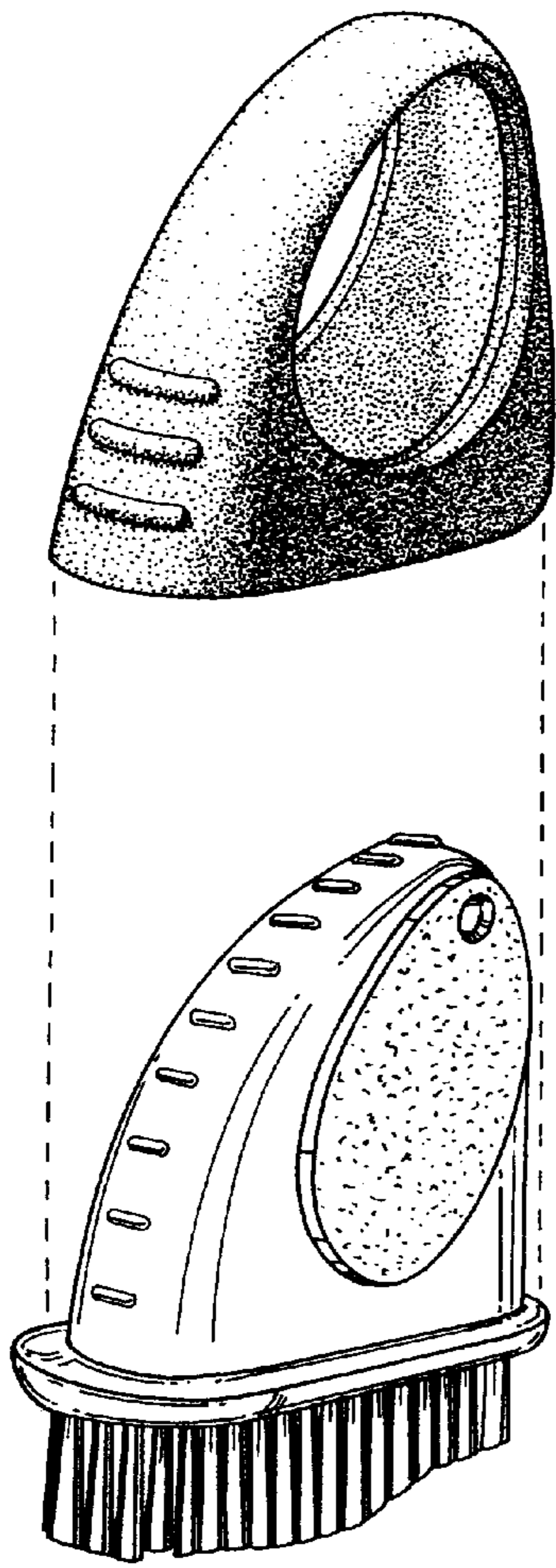

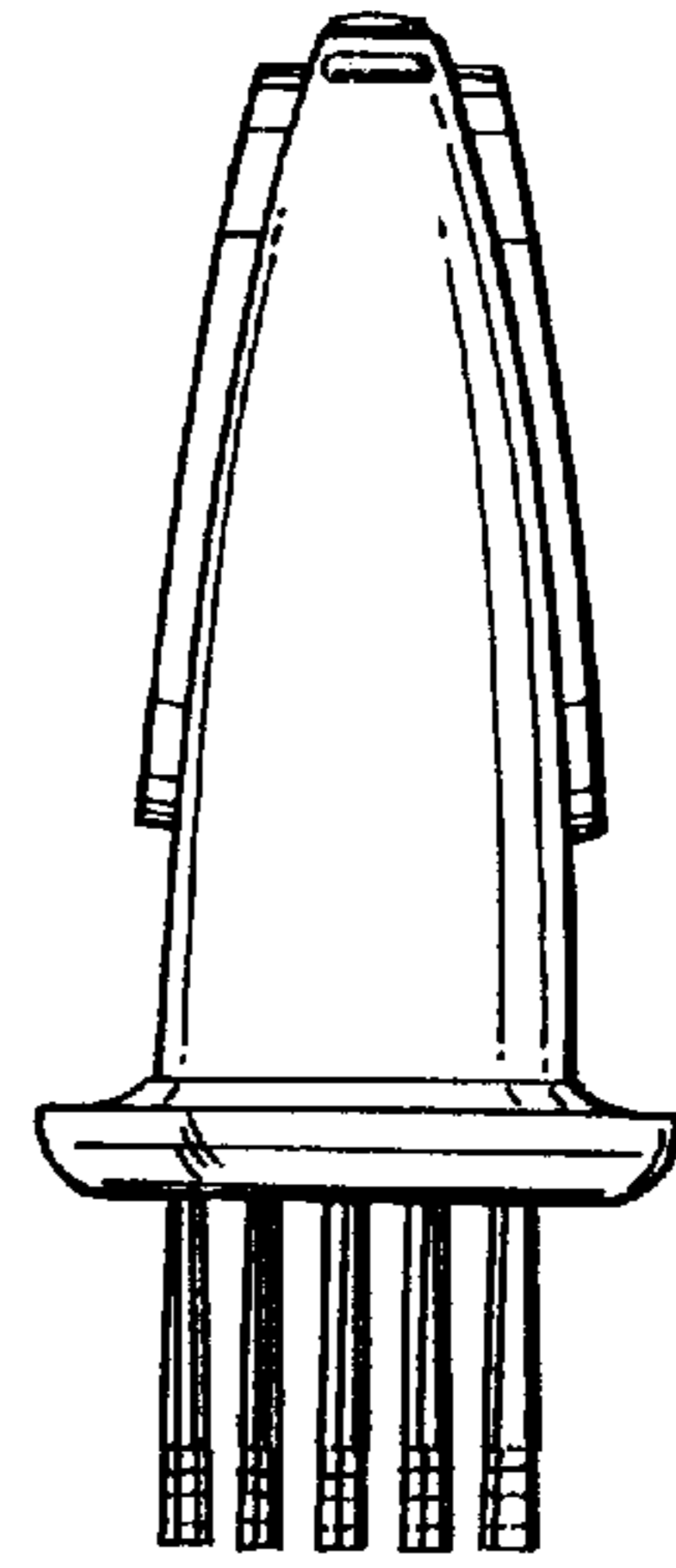

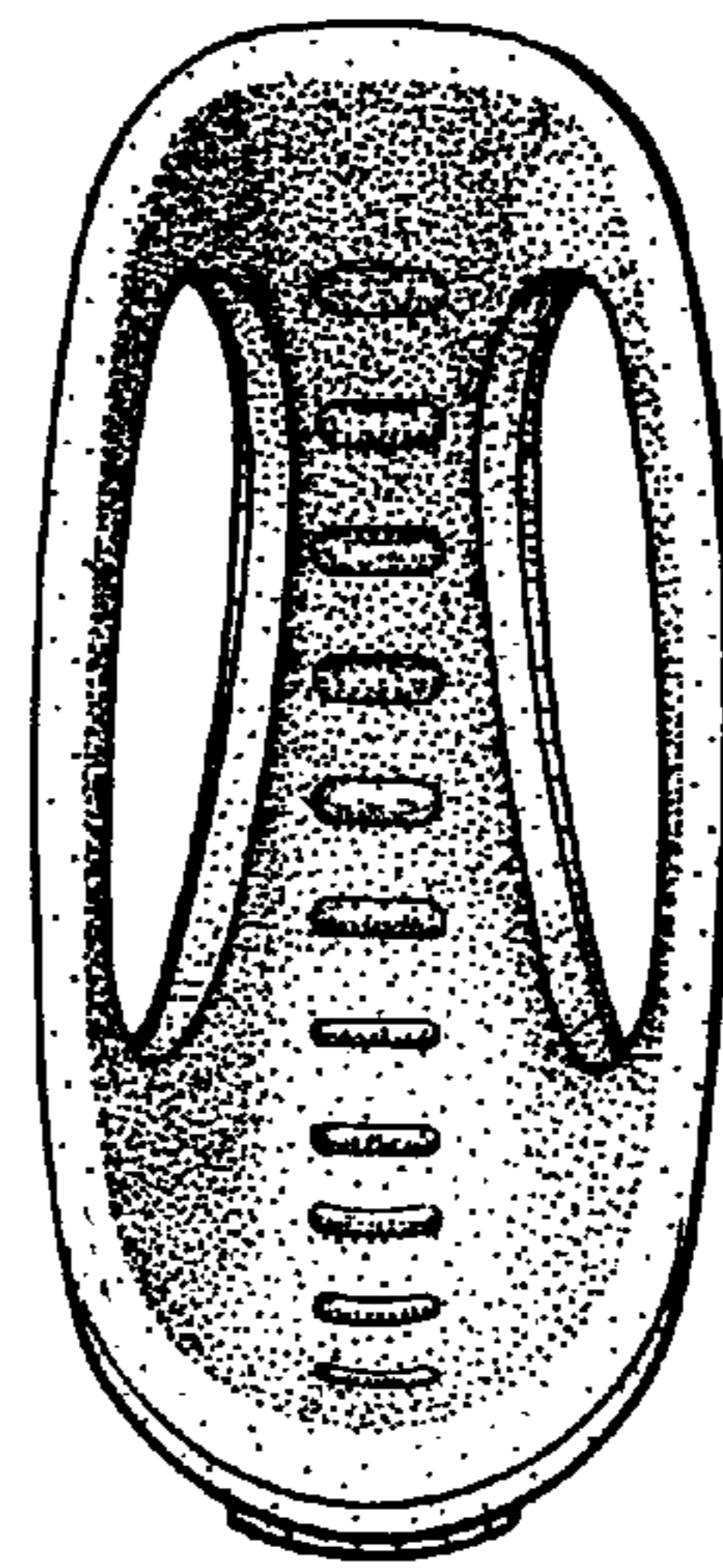
