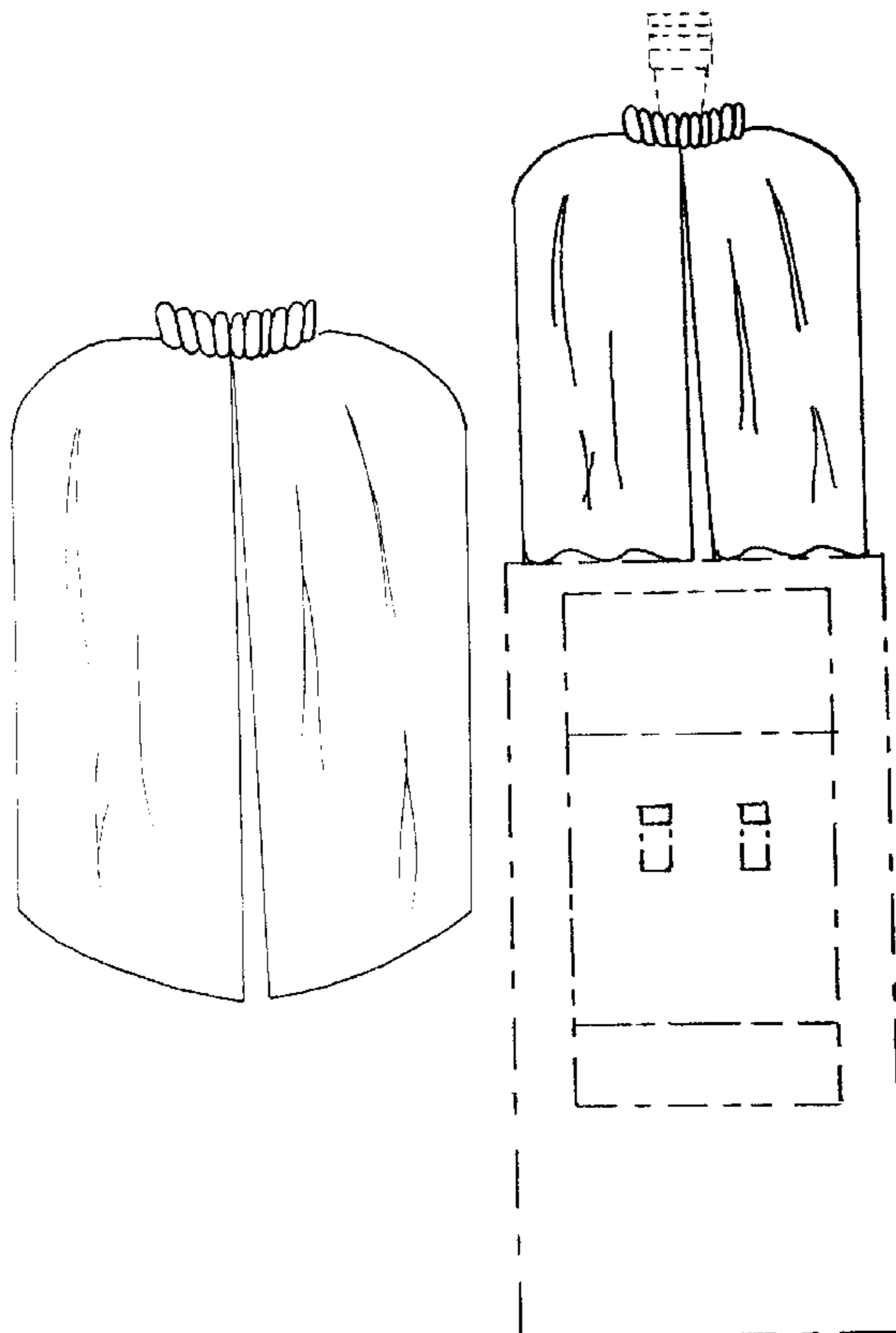

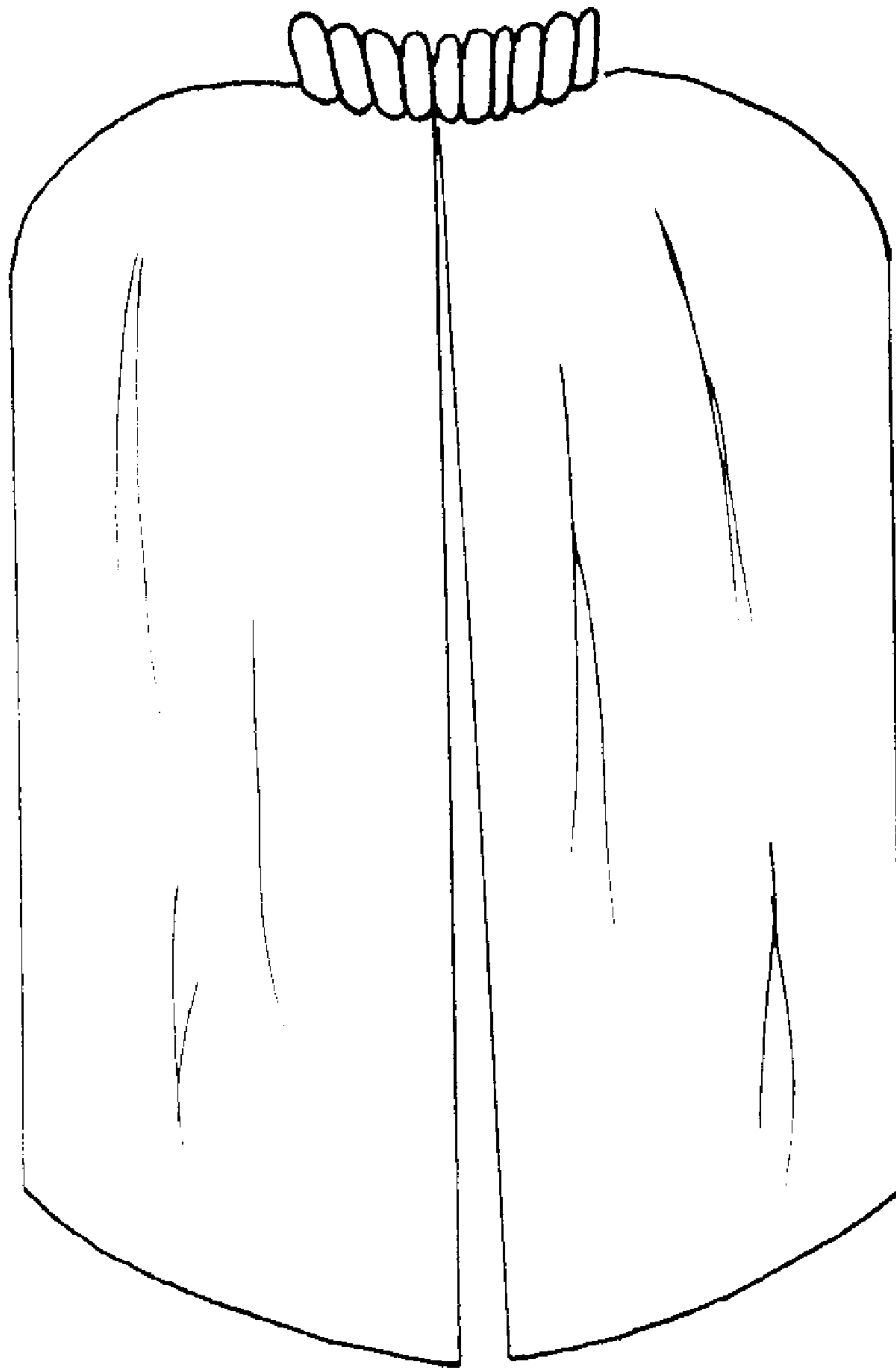
The ornamental design for a water cooler bottle cover, as shown and described.

**DESCRIPTION**

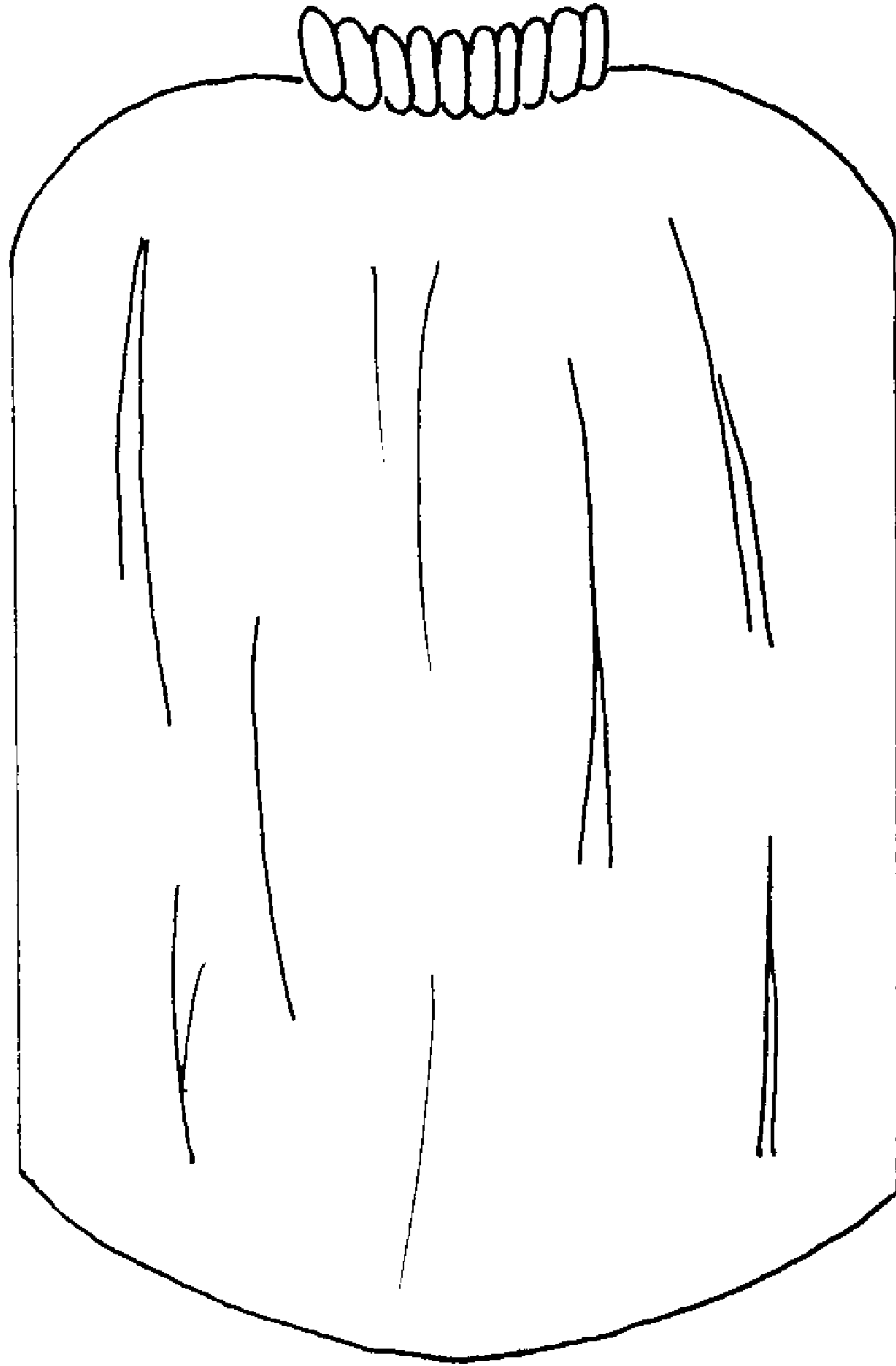
FIG. 1 is a front view of a water cooler bottle cover showing my new design;

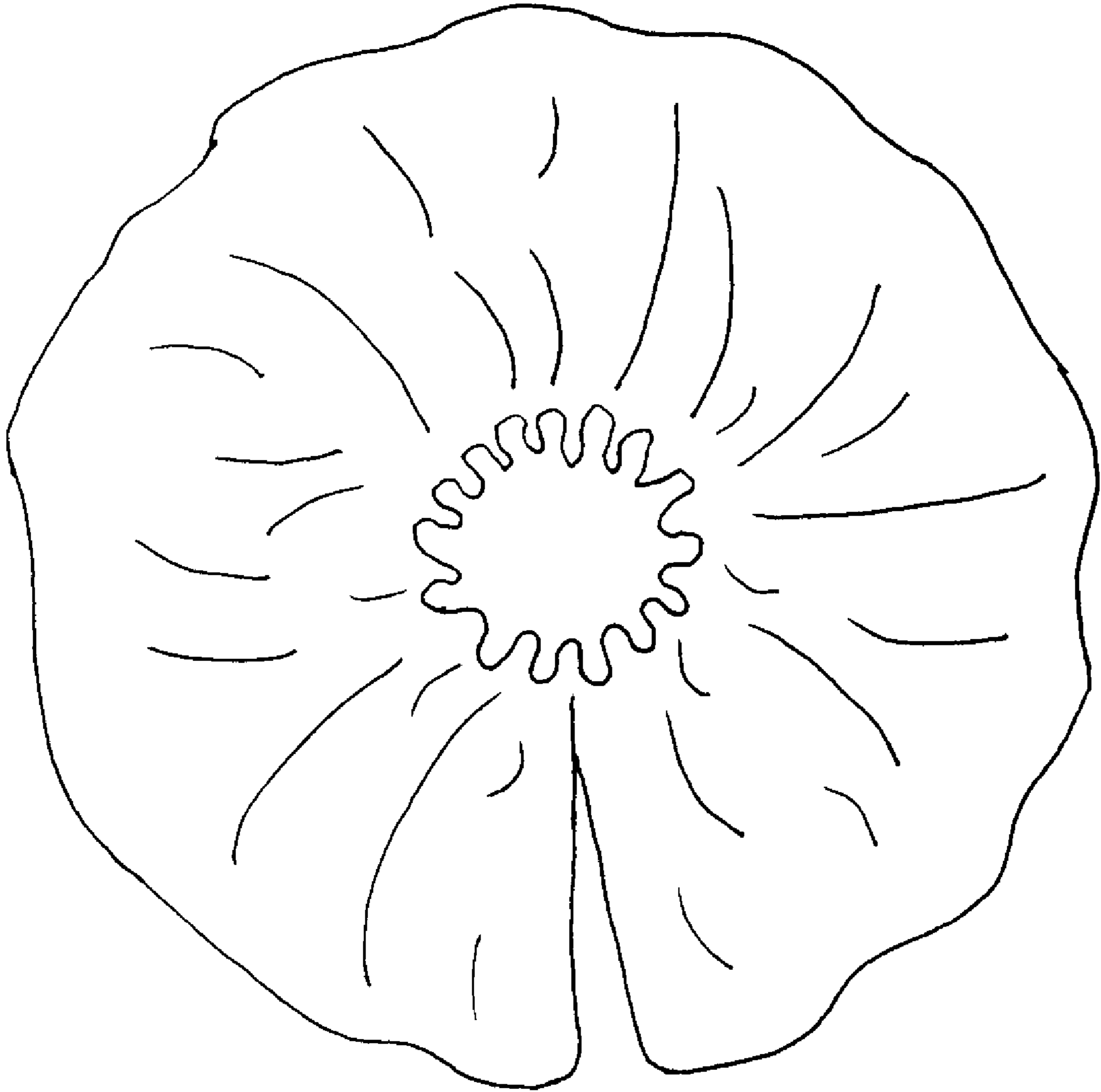




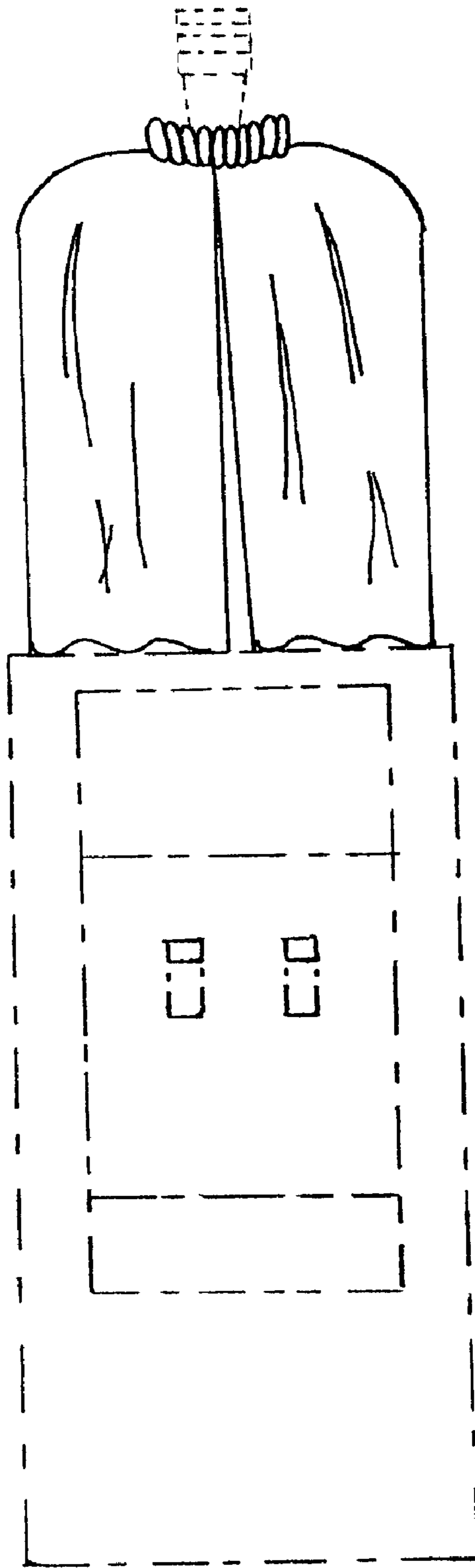
